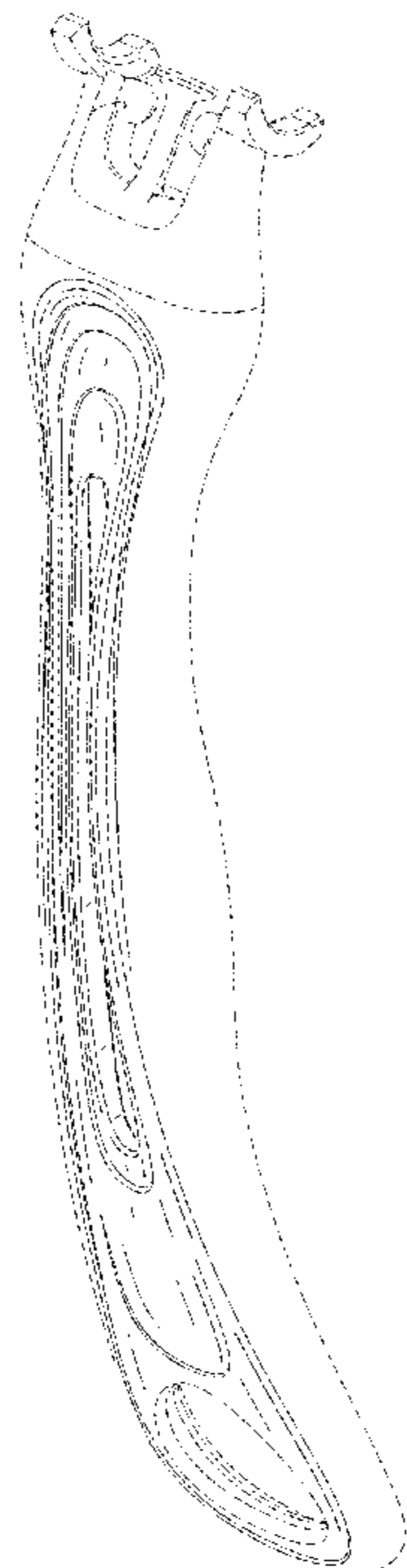
The ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a razor handle showing my new design;

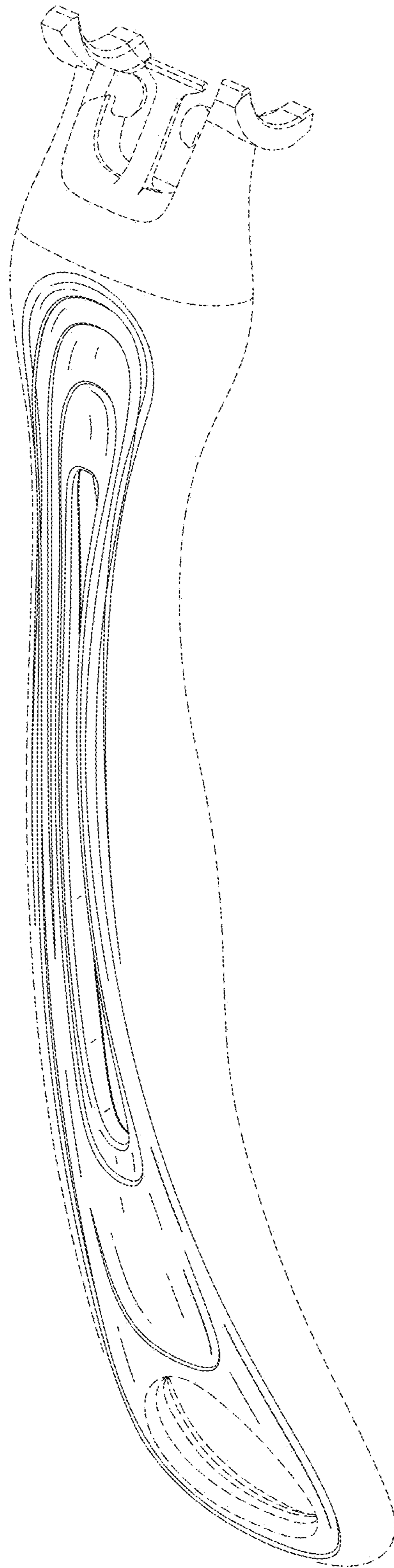

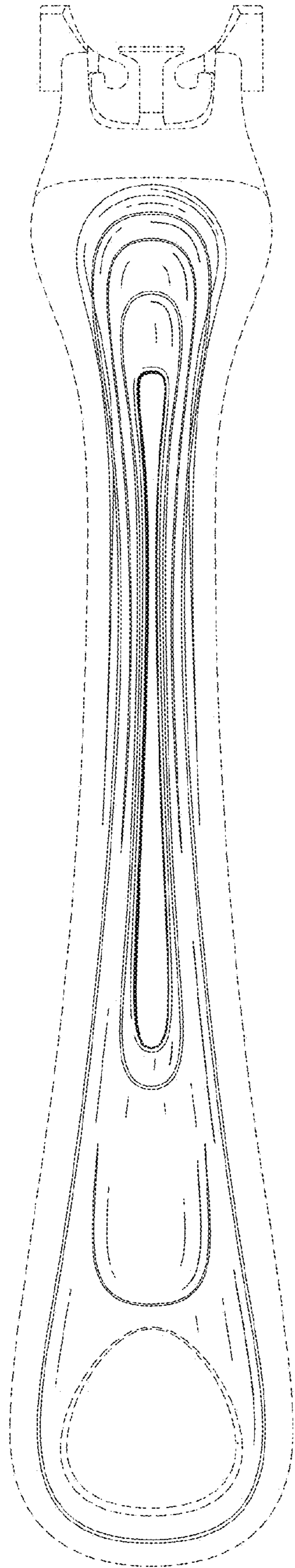

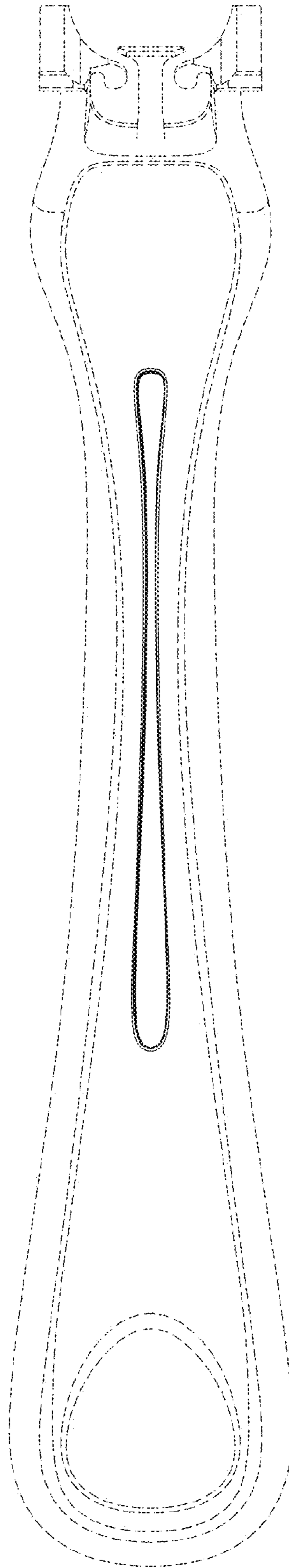

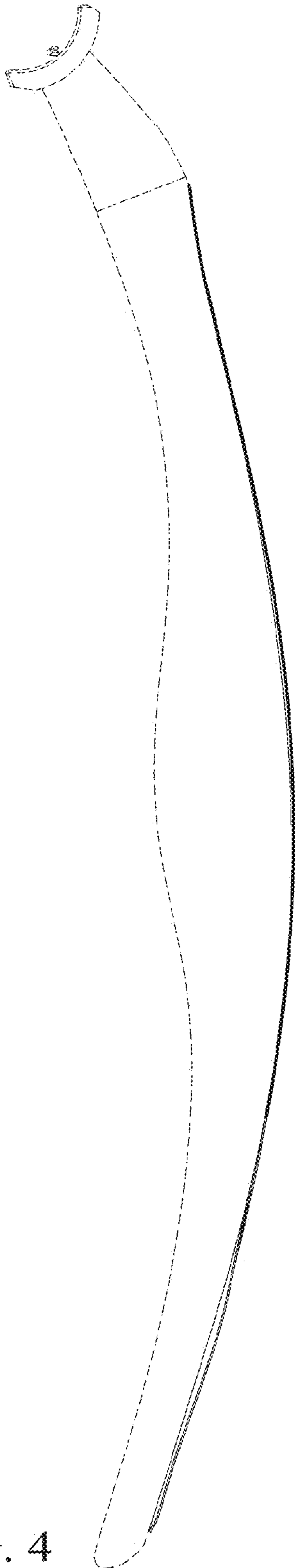

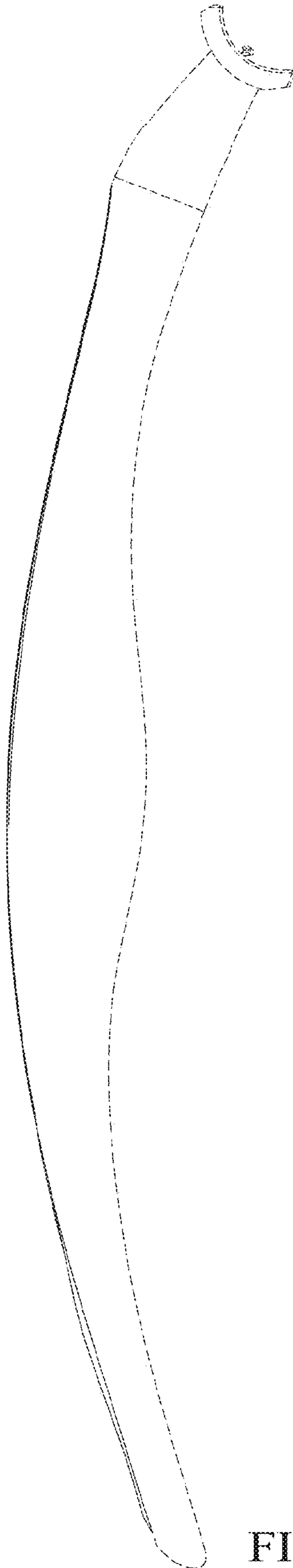

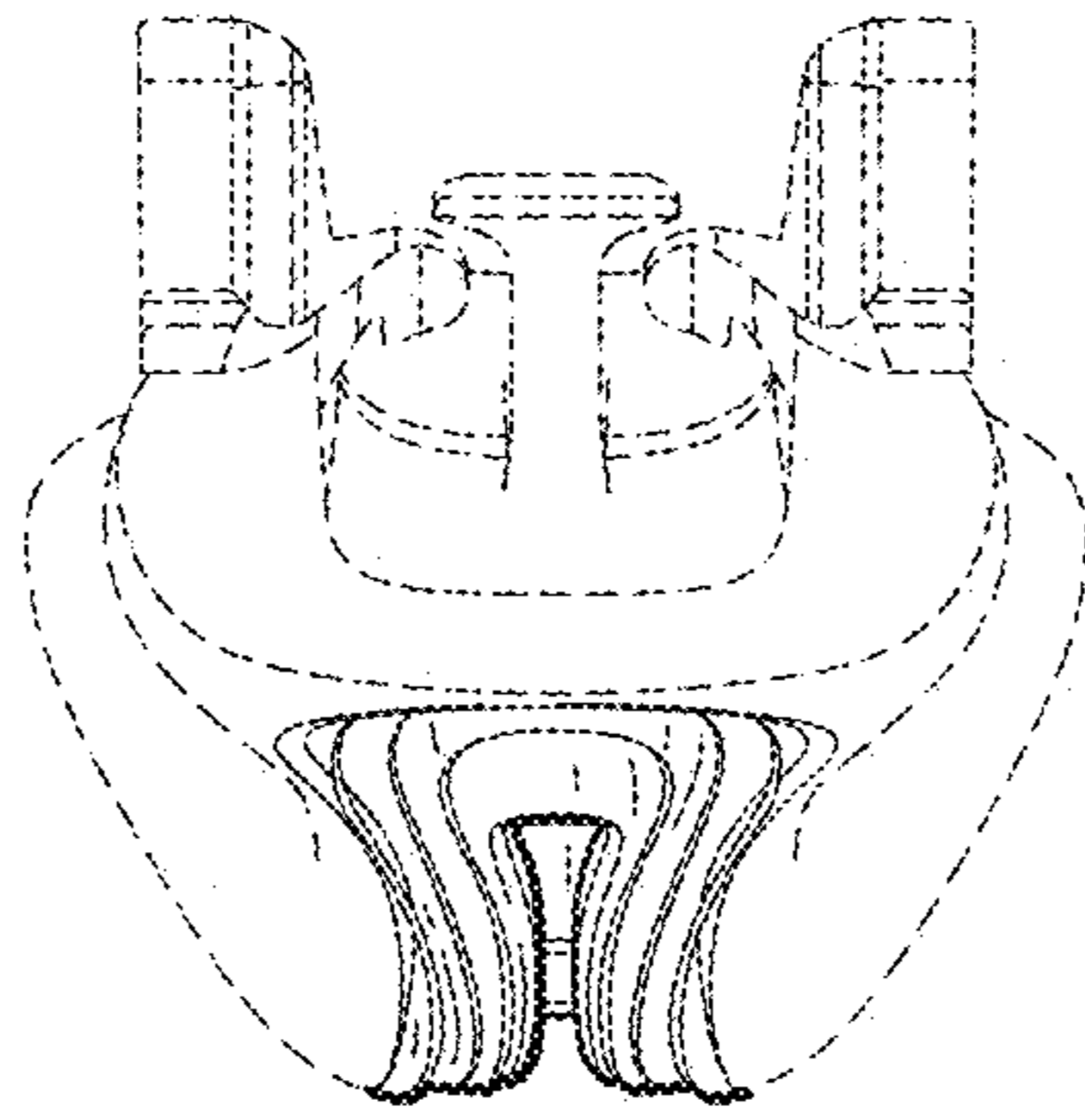

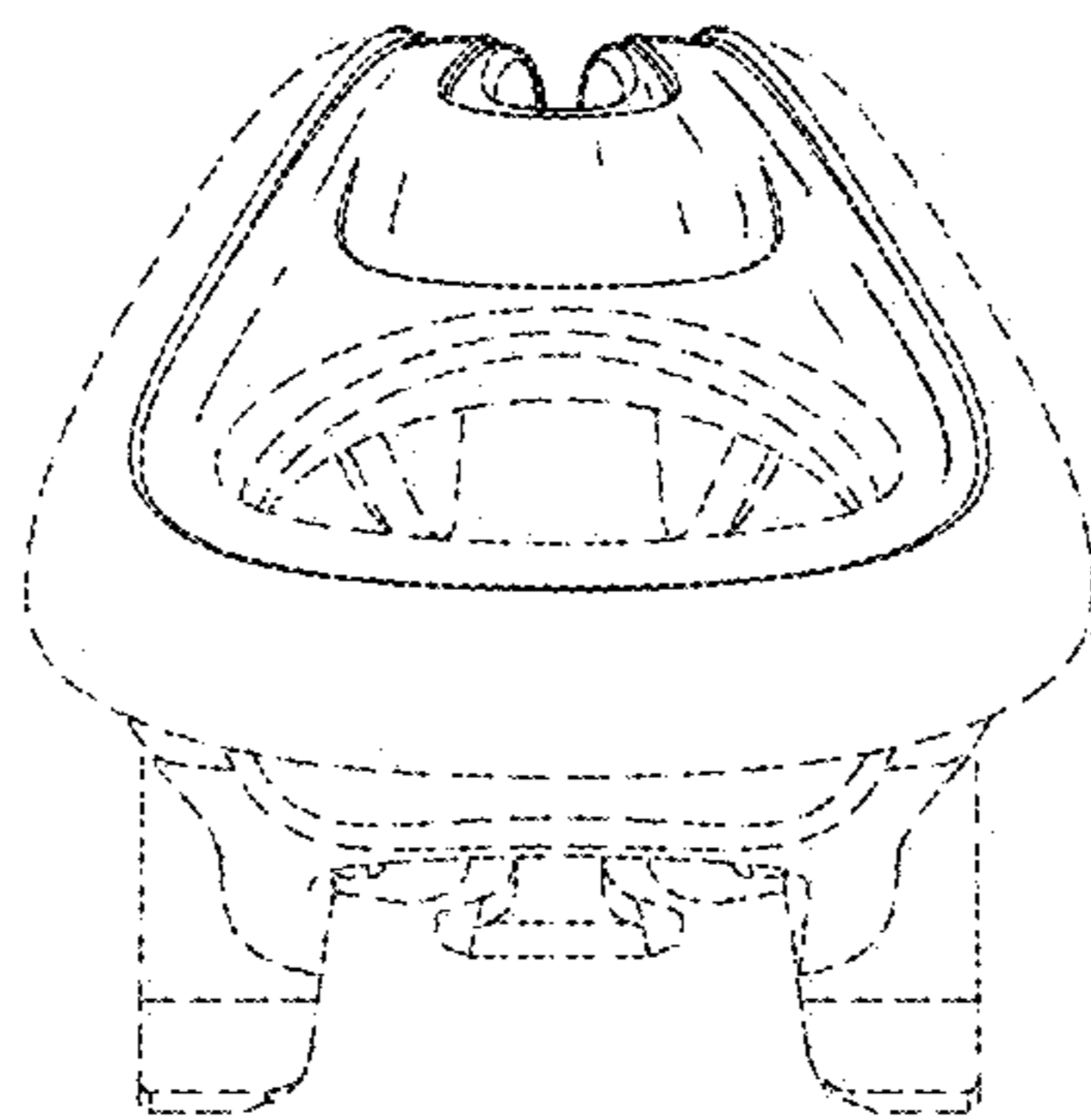

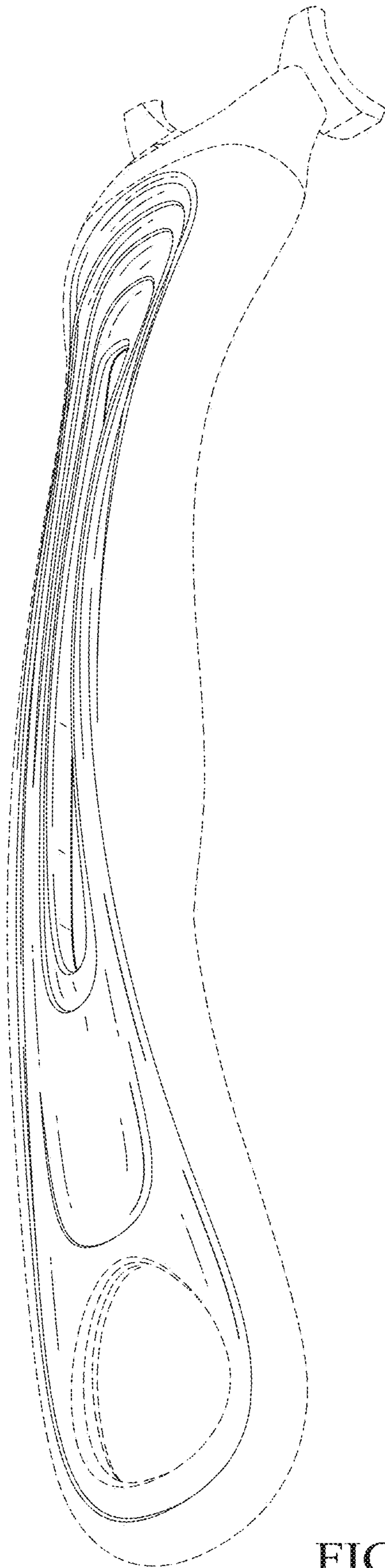
