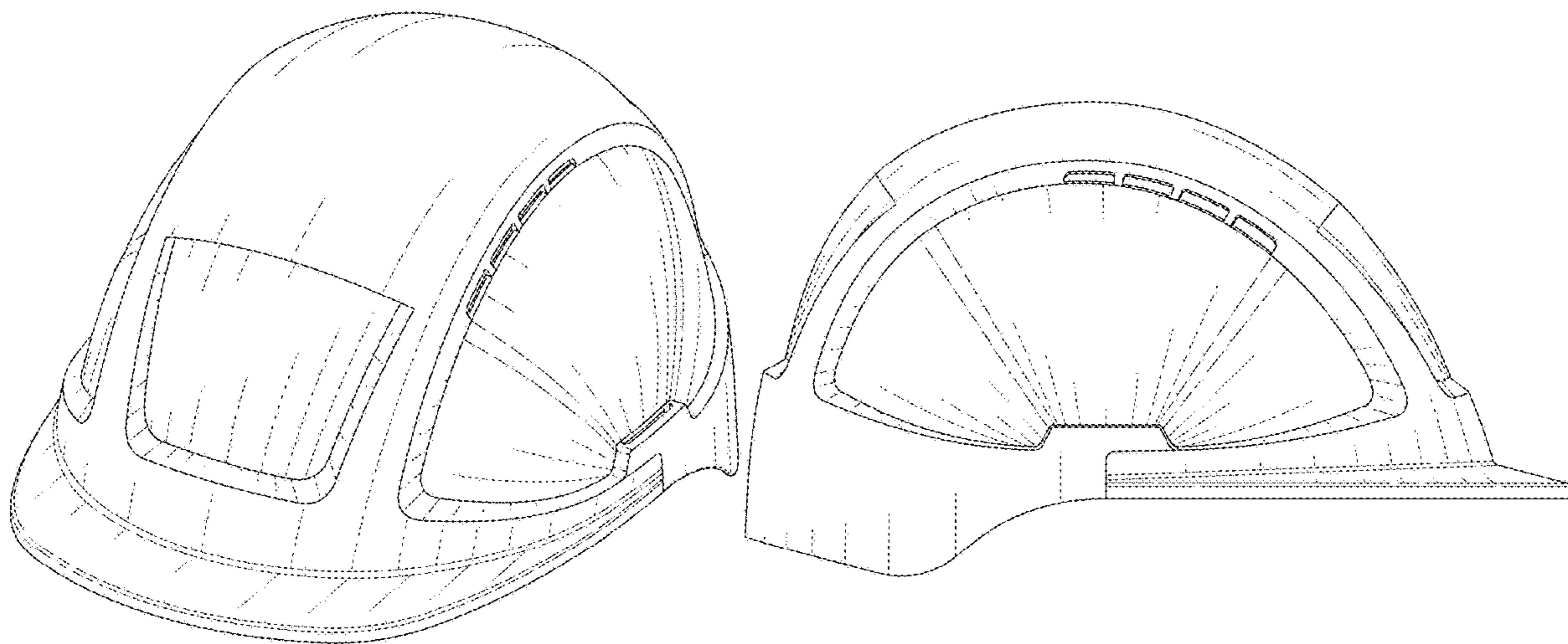
The ornamental design for a helmet, as shown and described.

DESCRIPTION

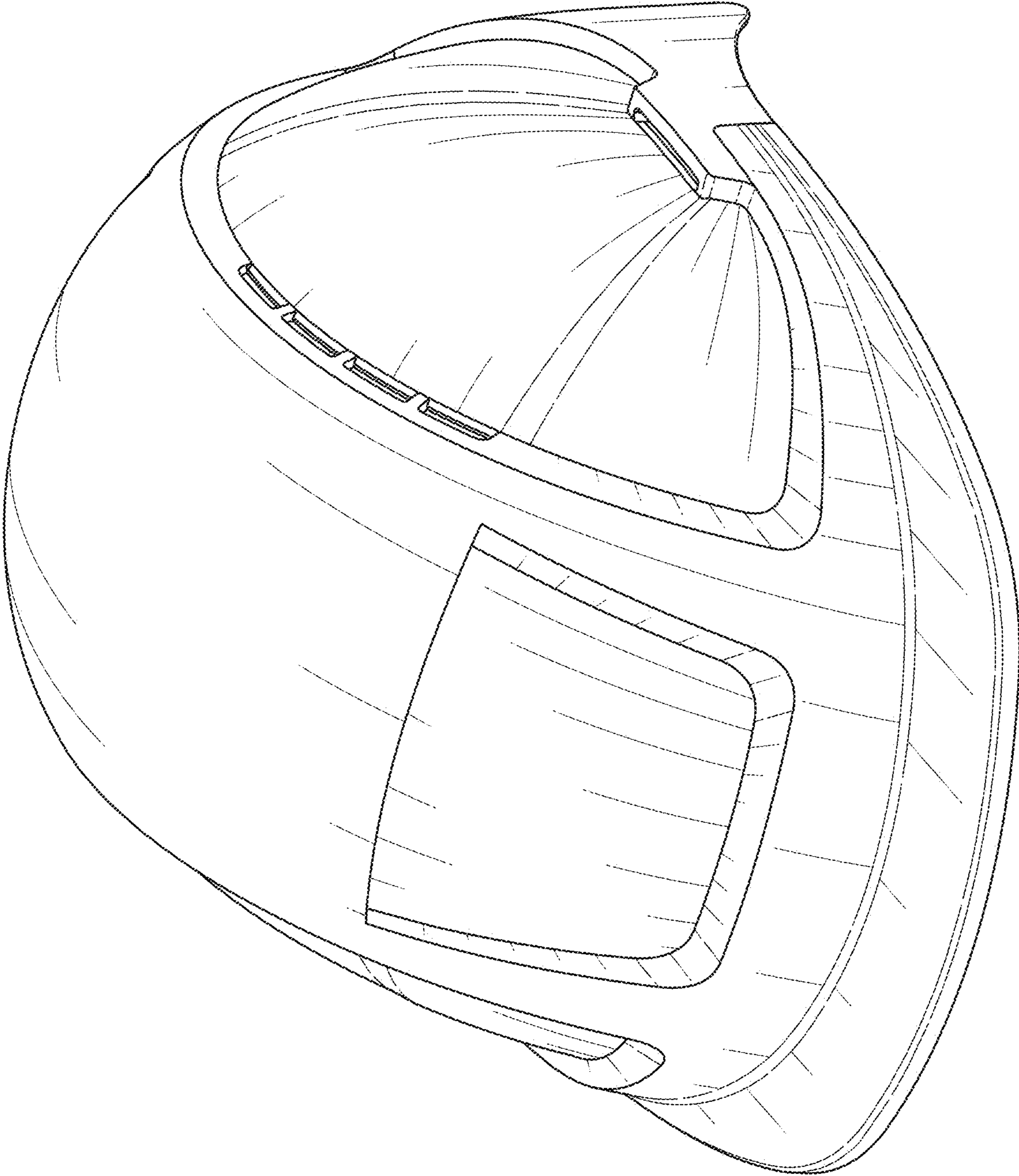

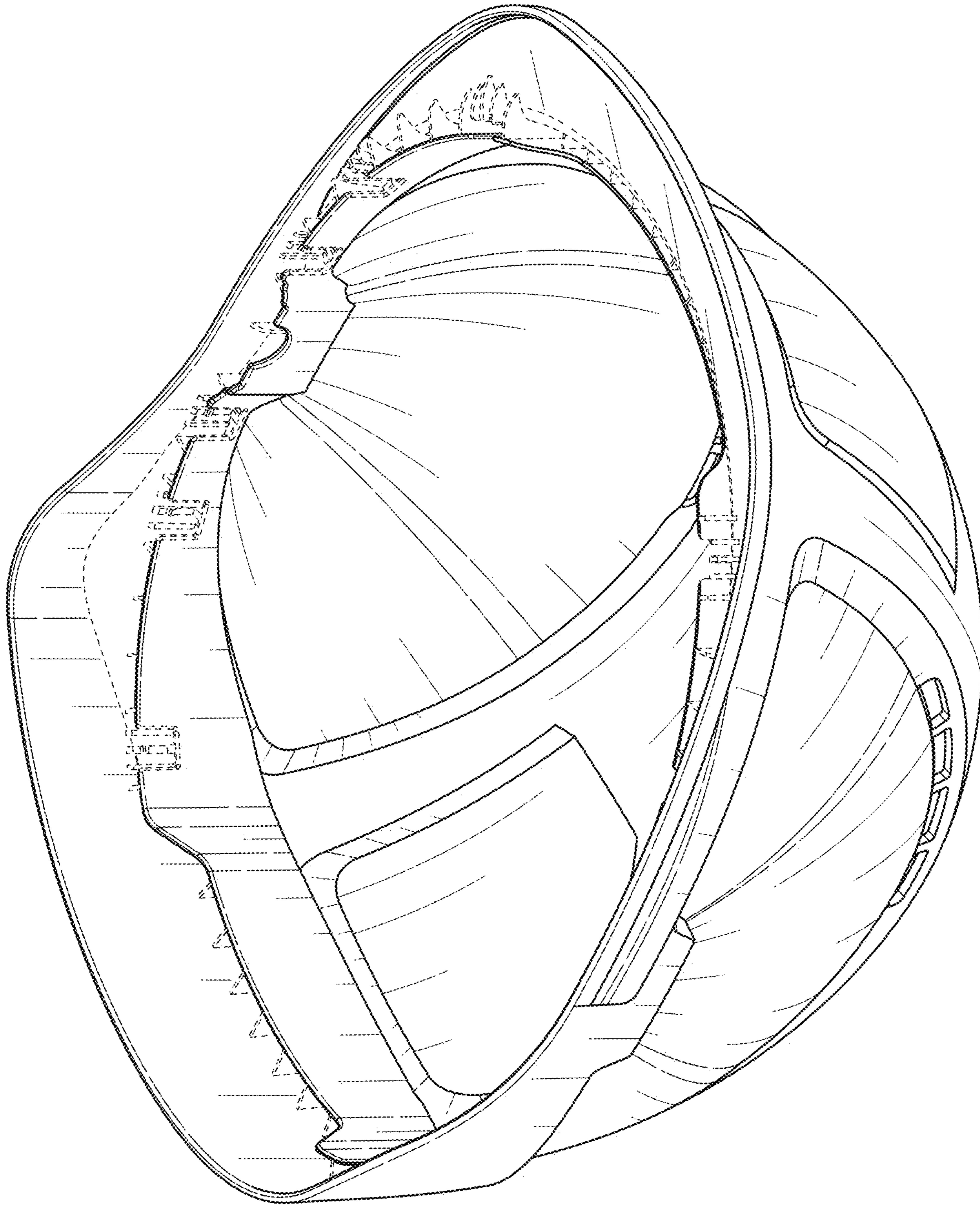

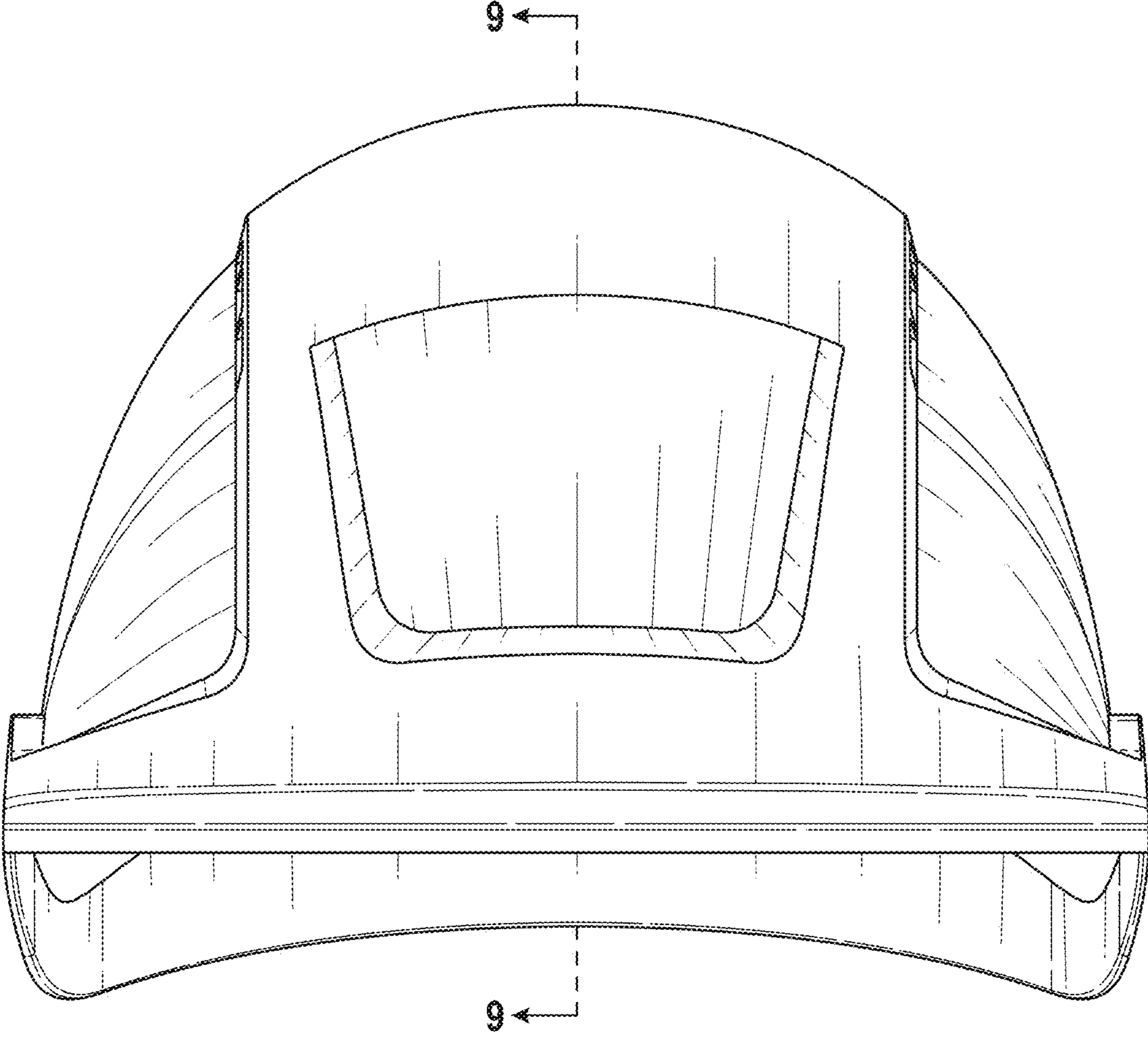

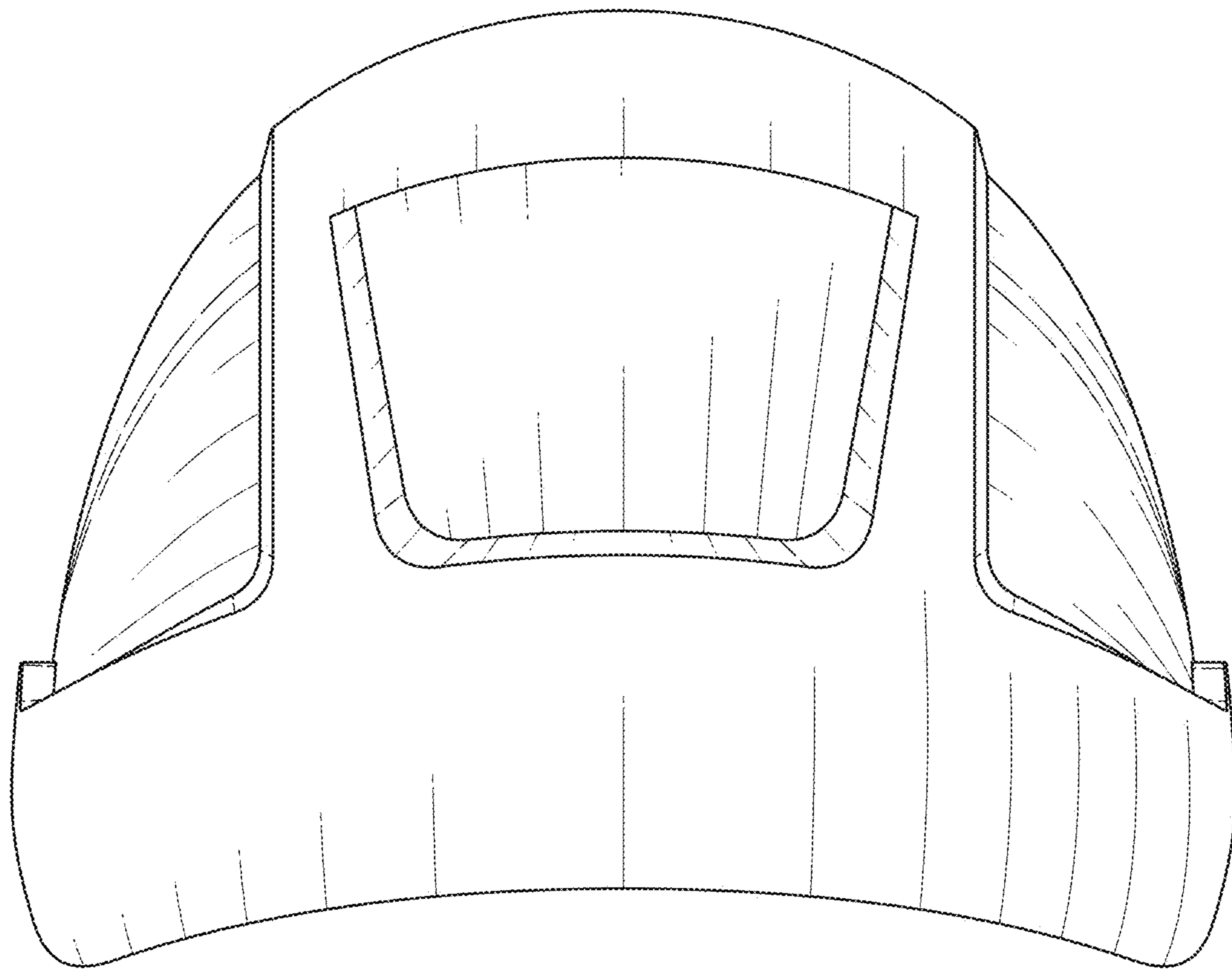

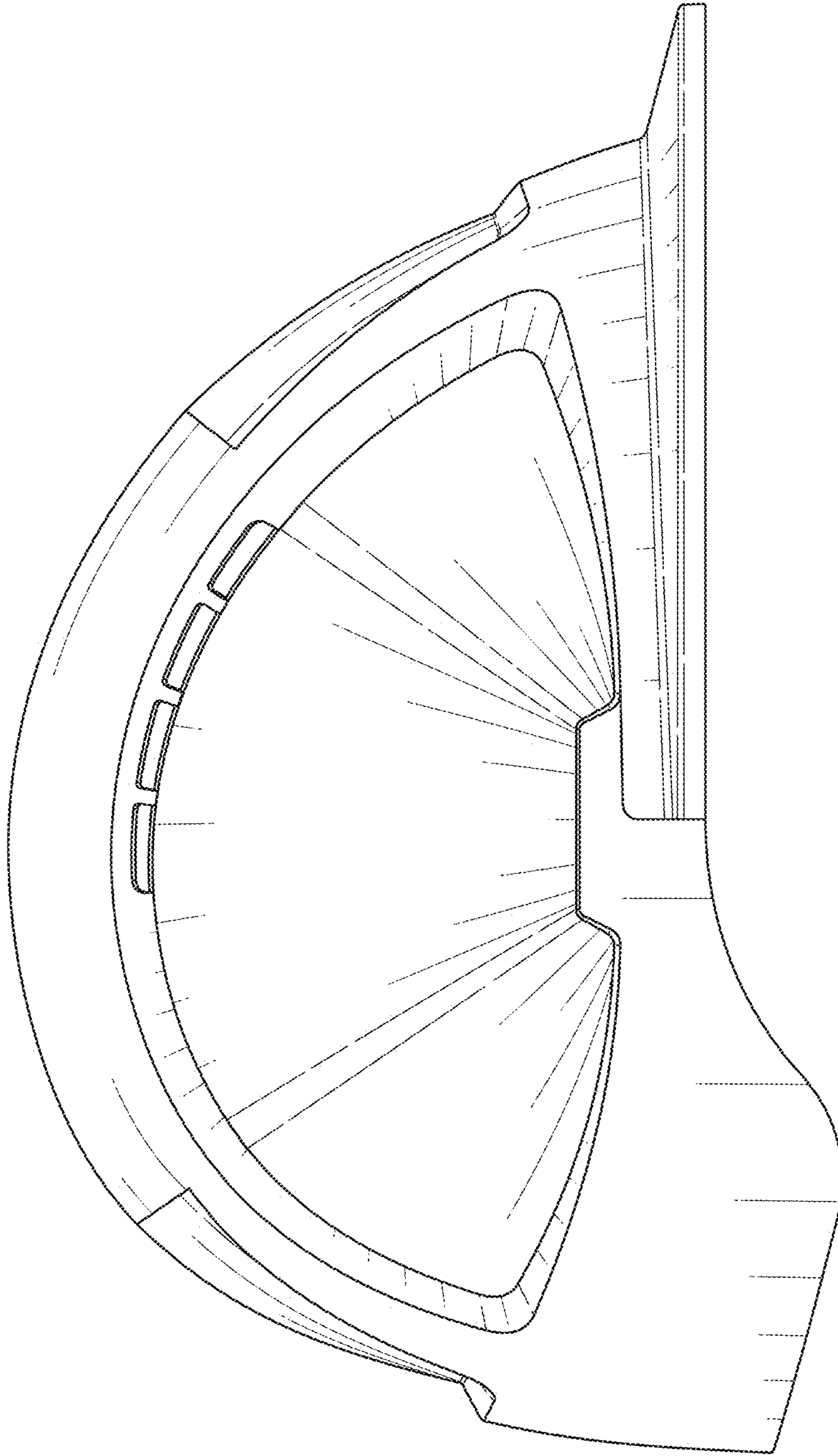

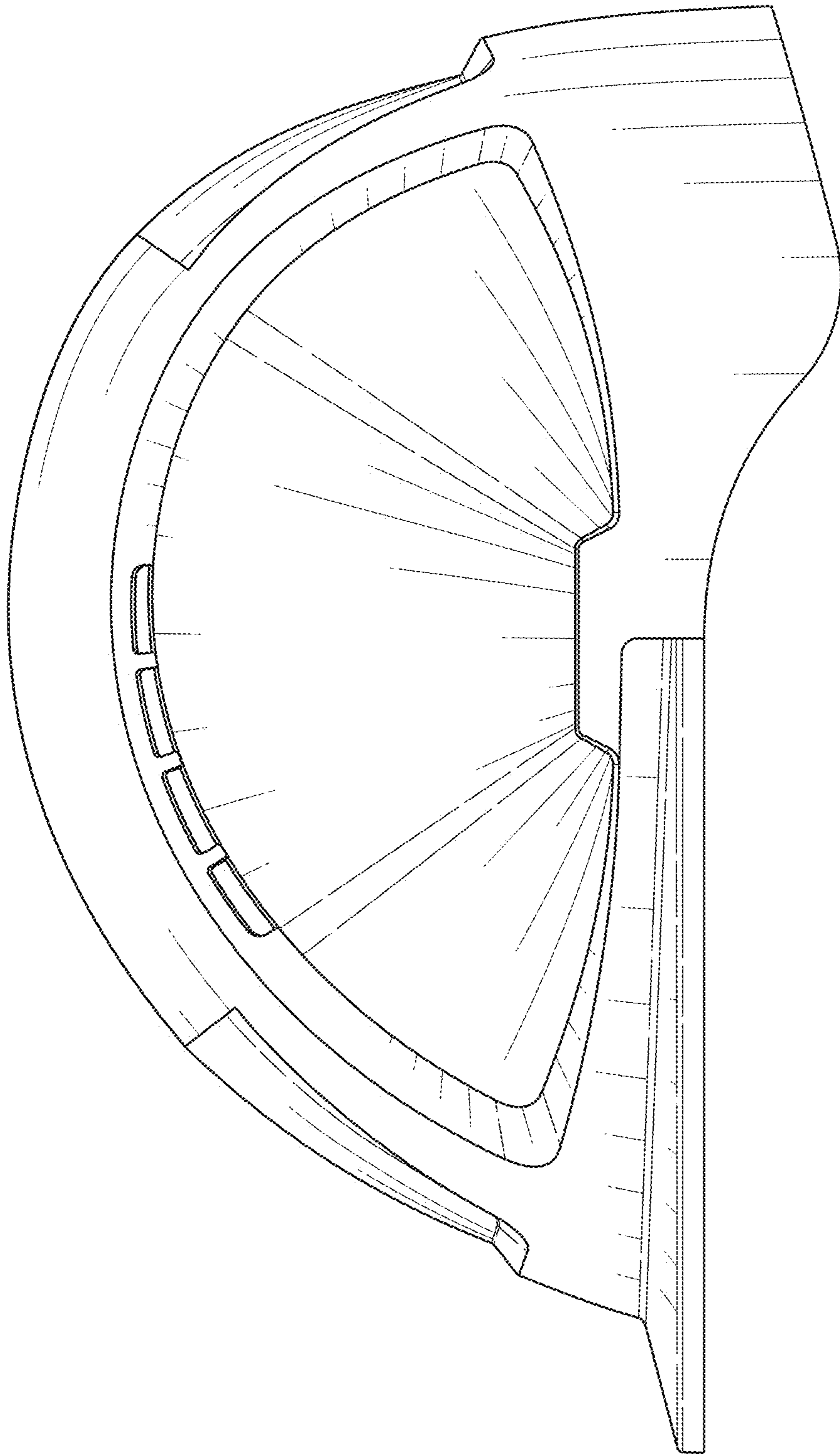

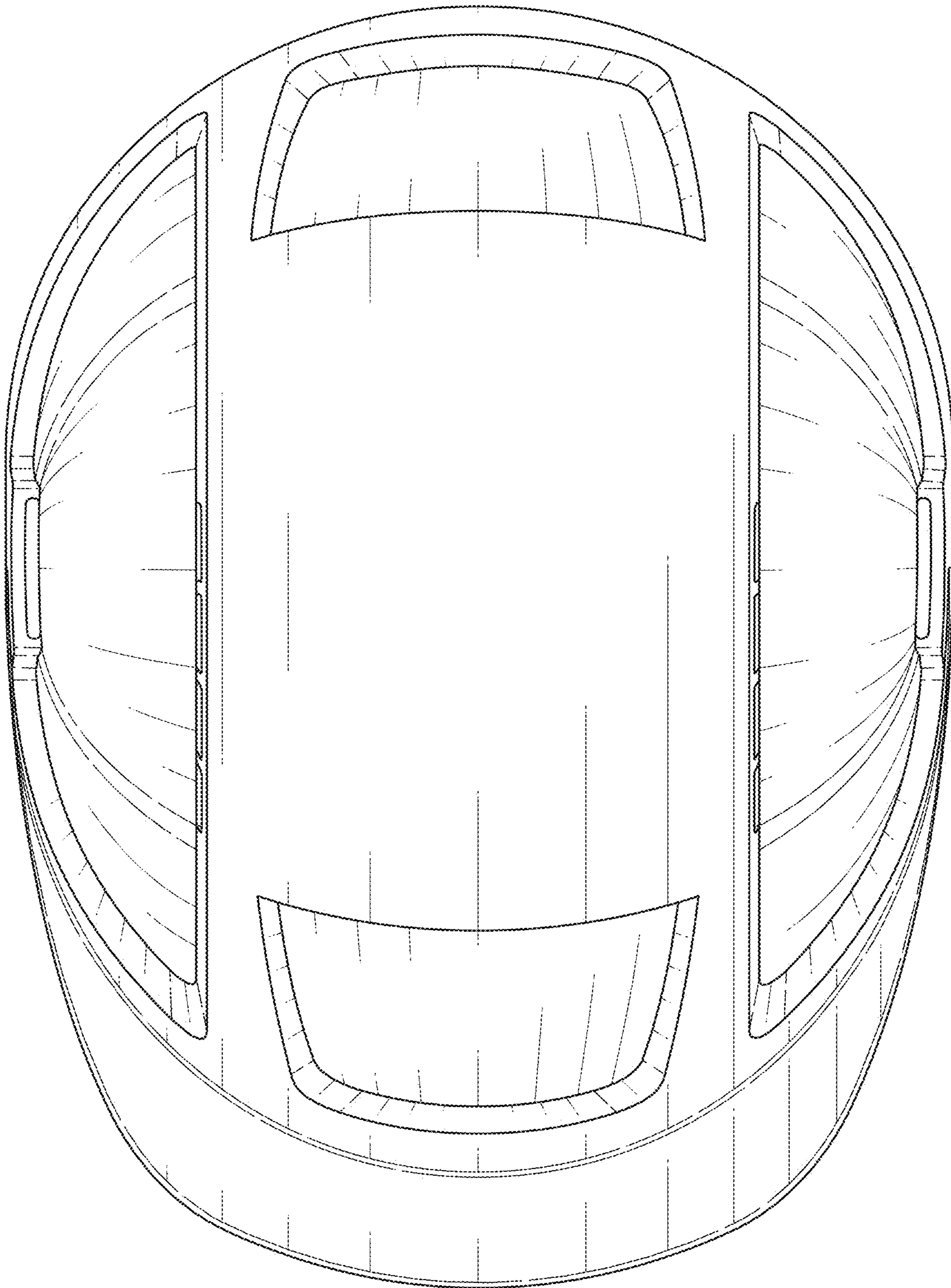

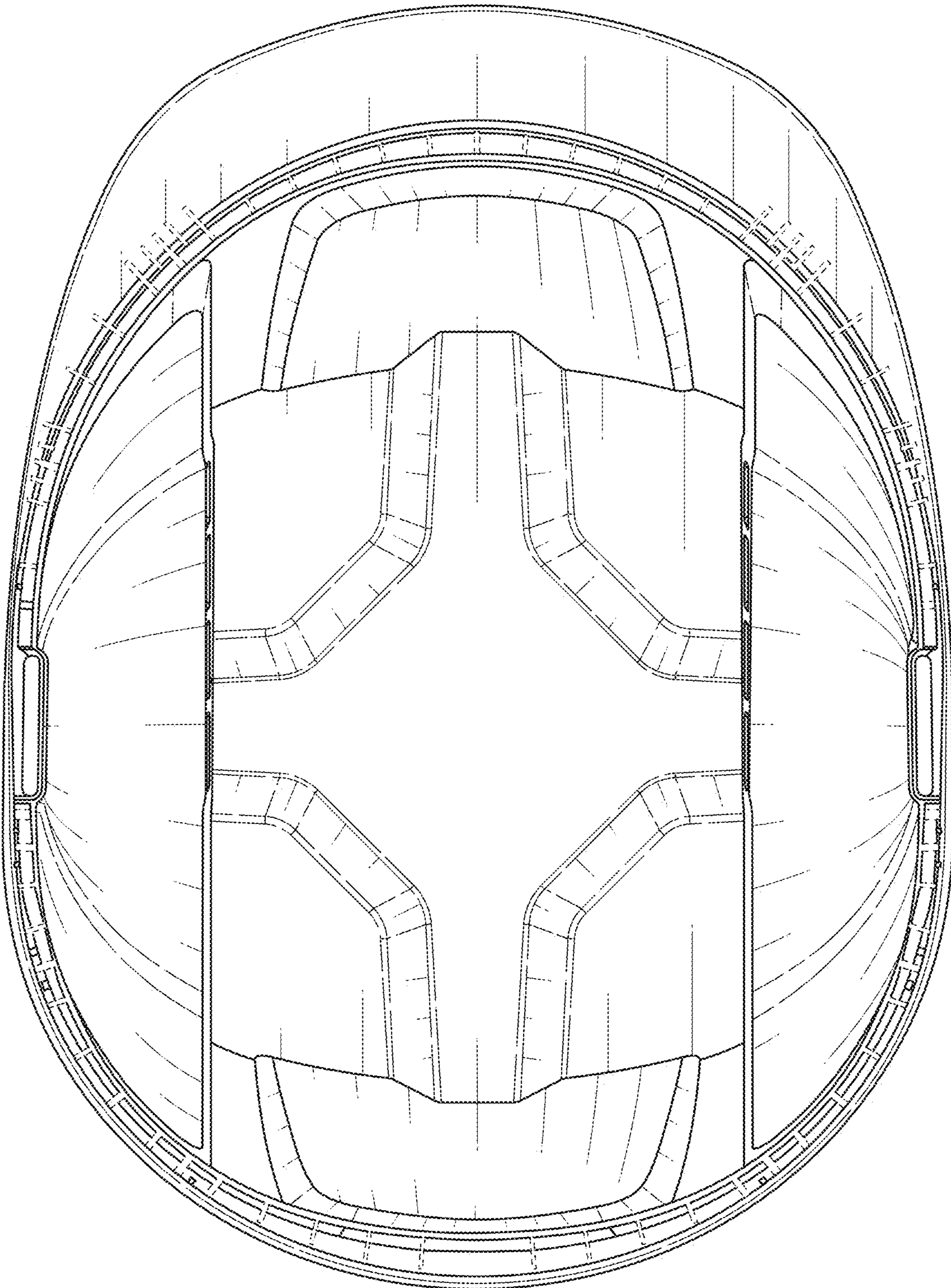

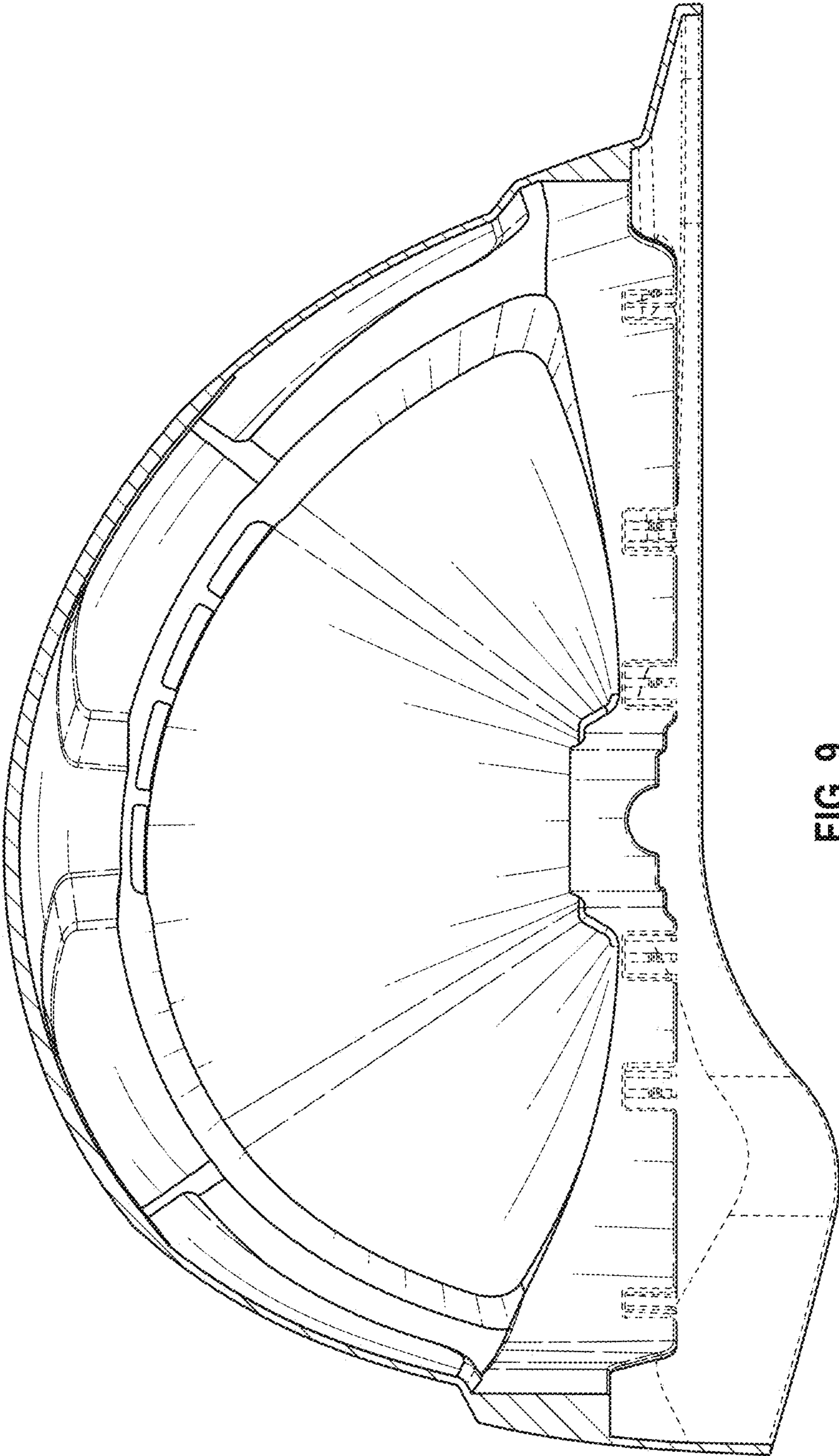

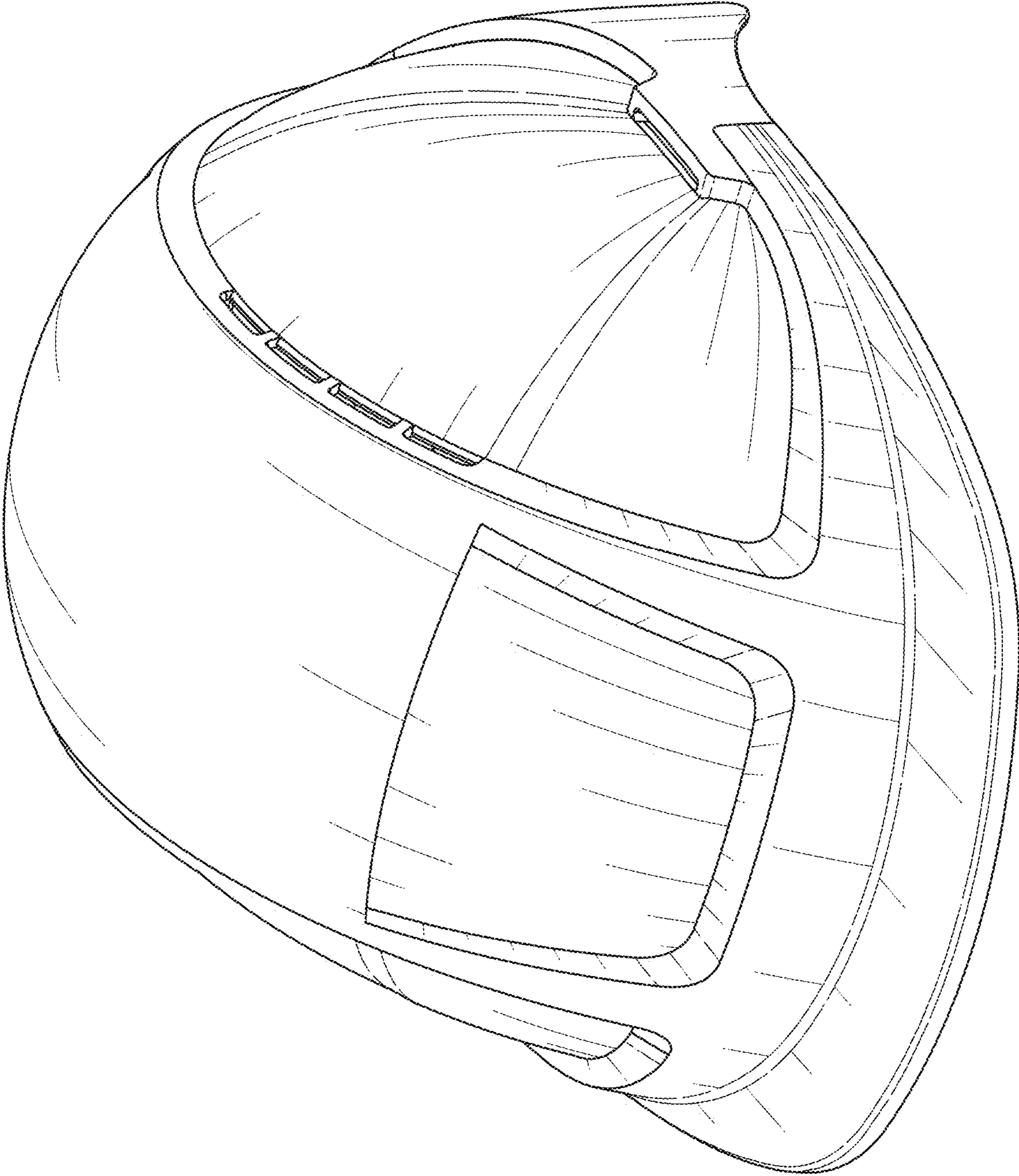

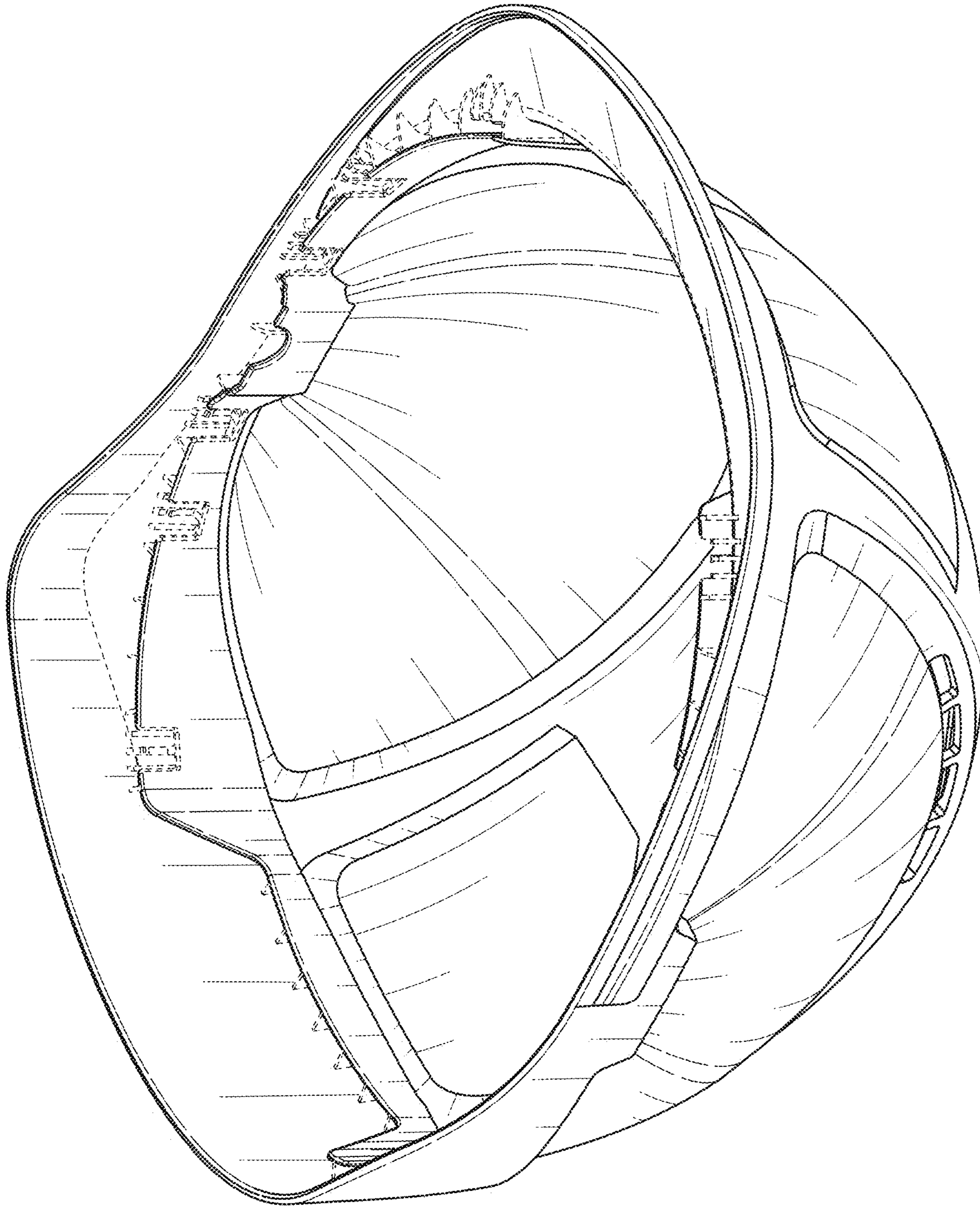

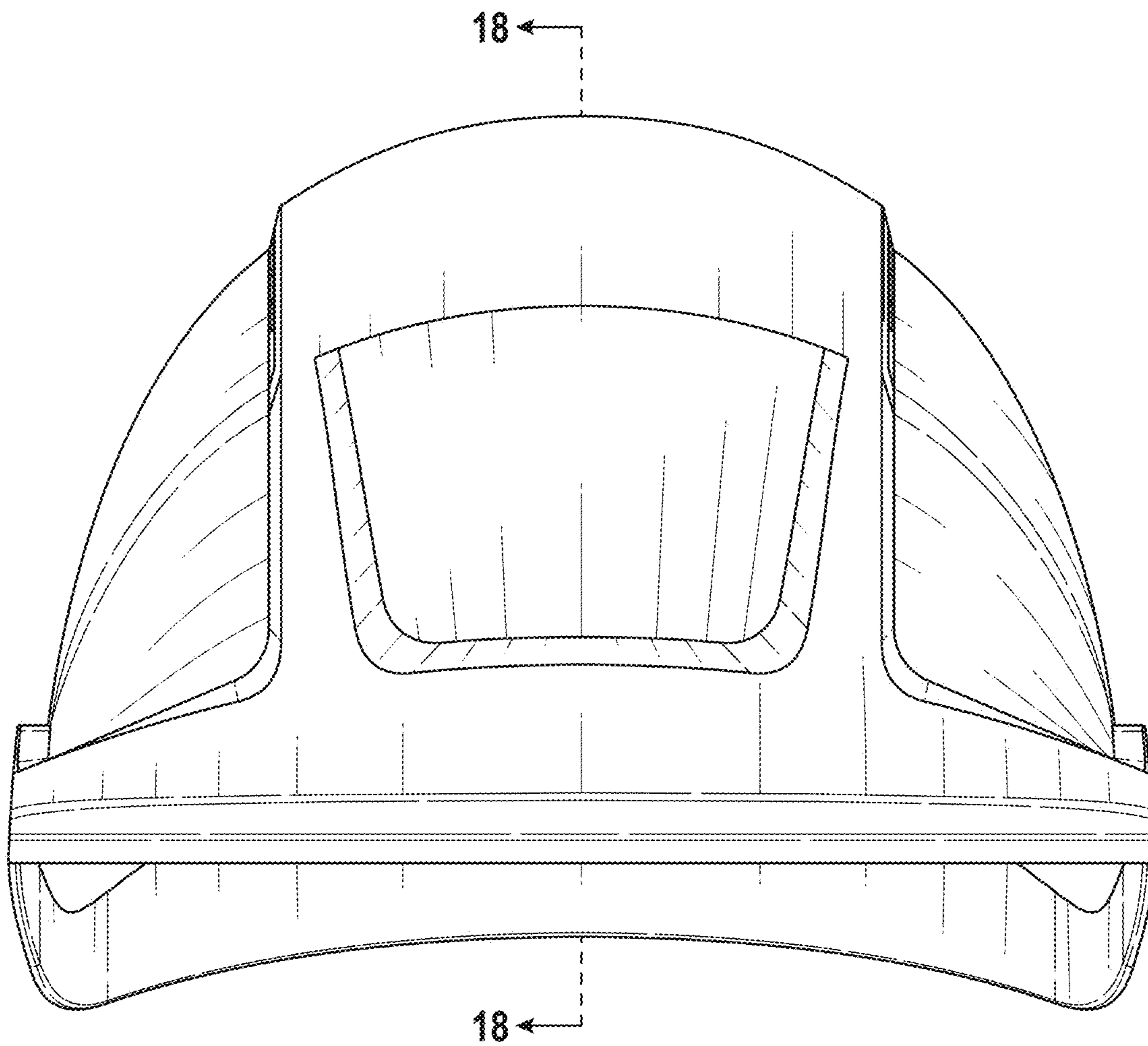

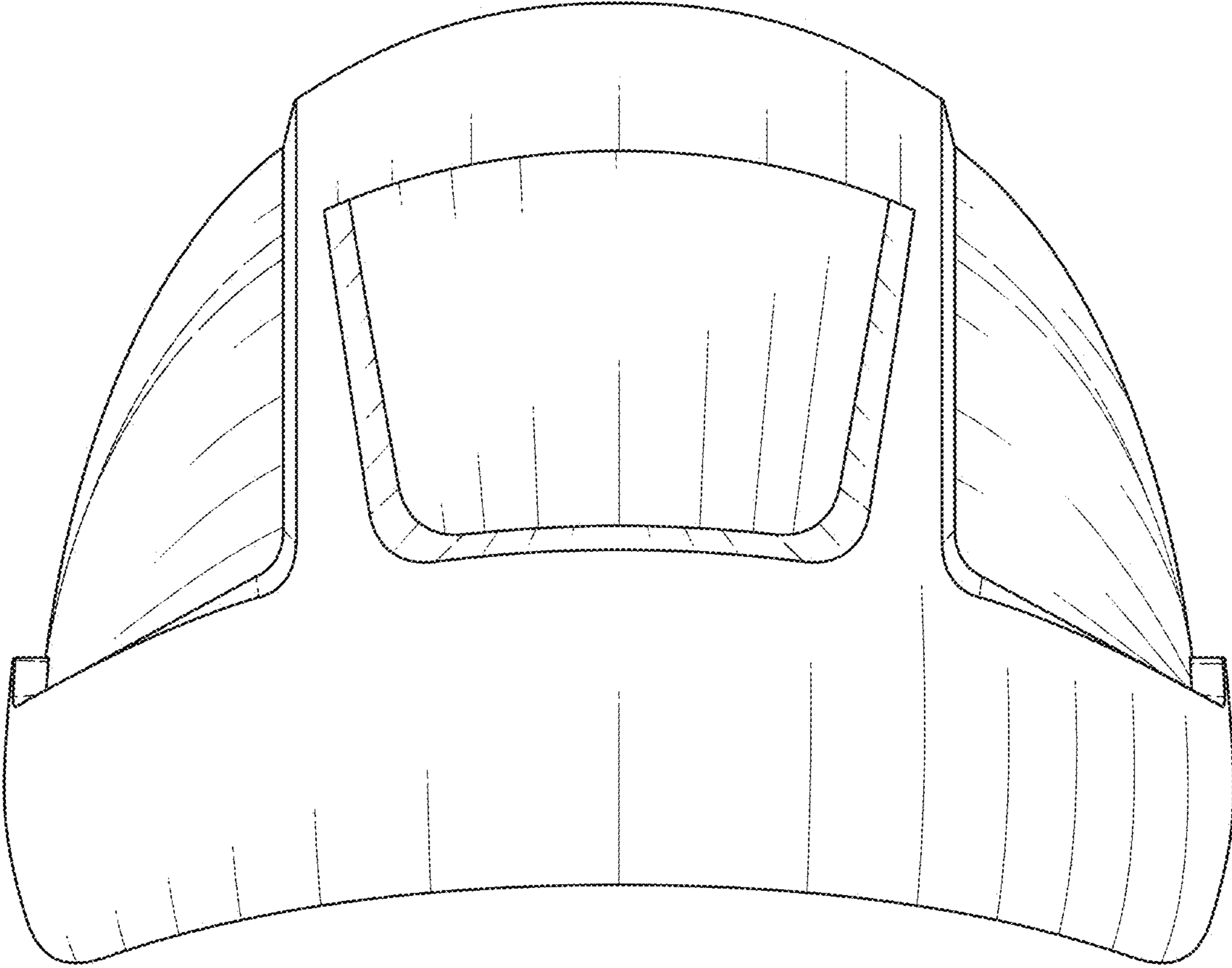

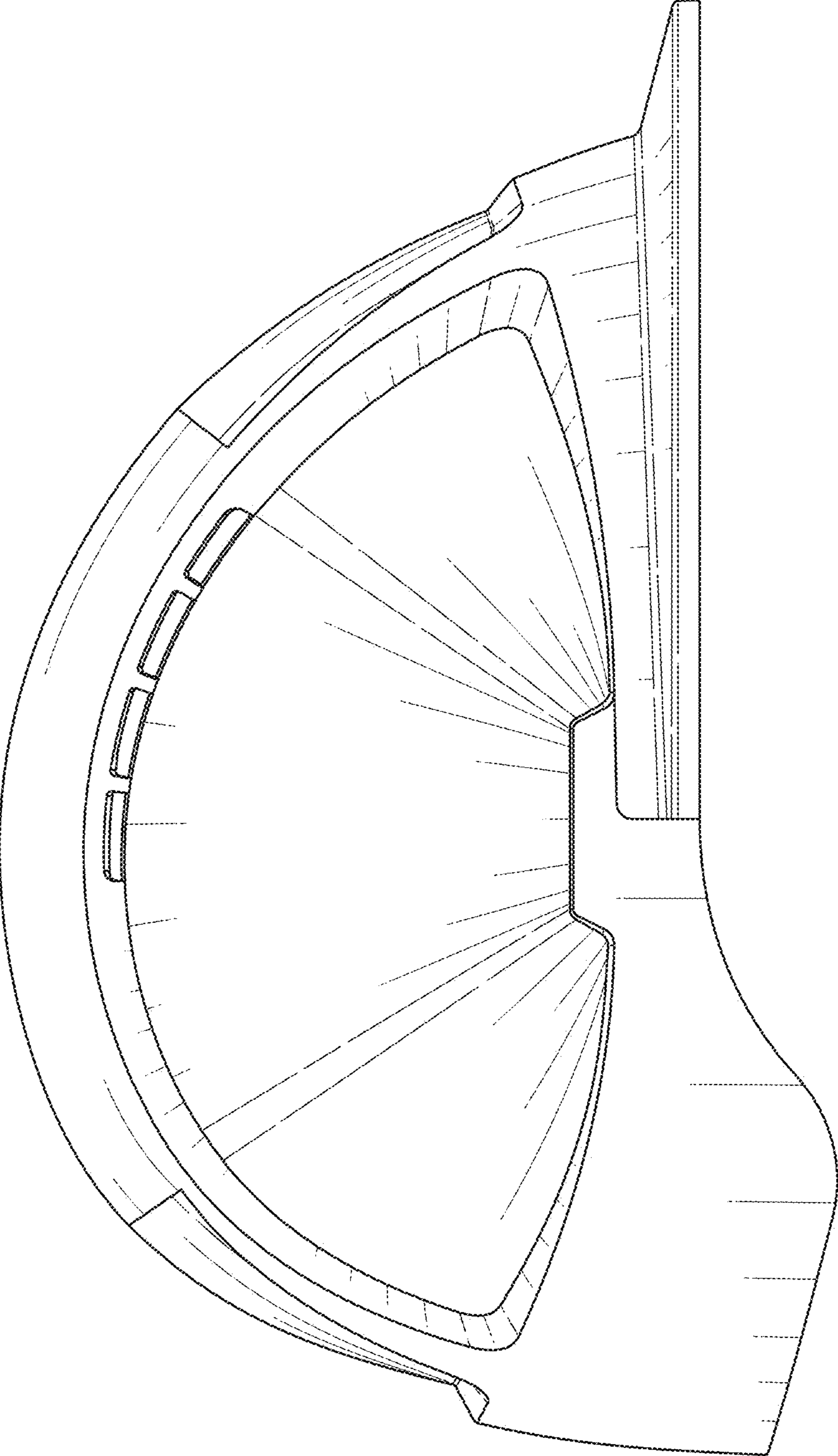

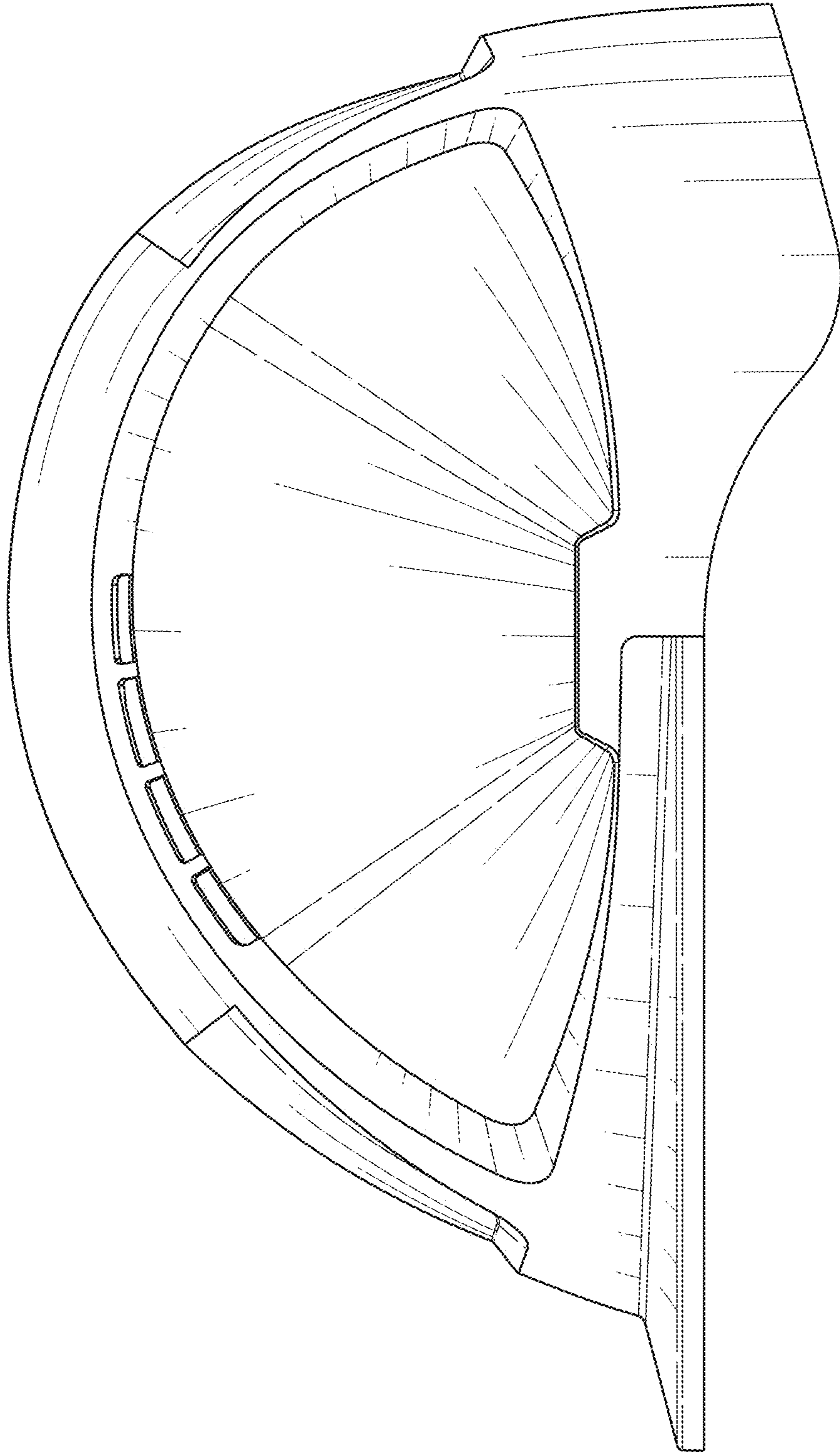

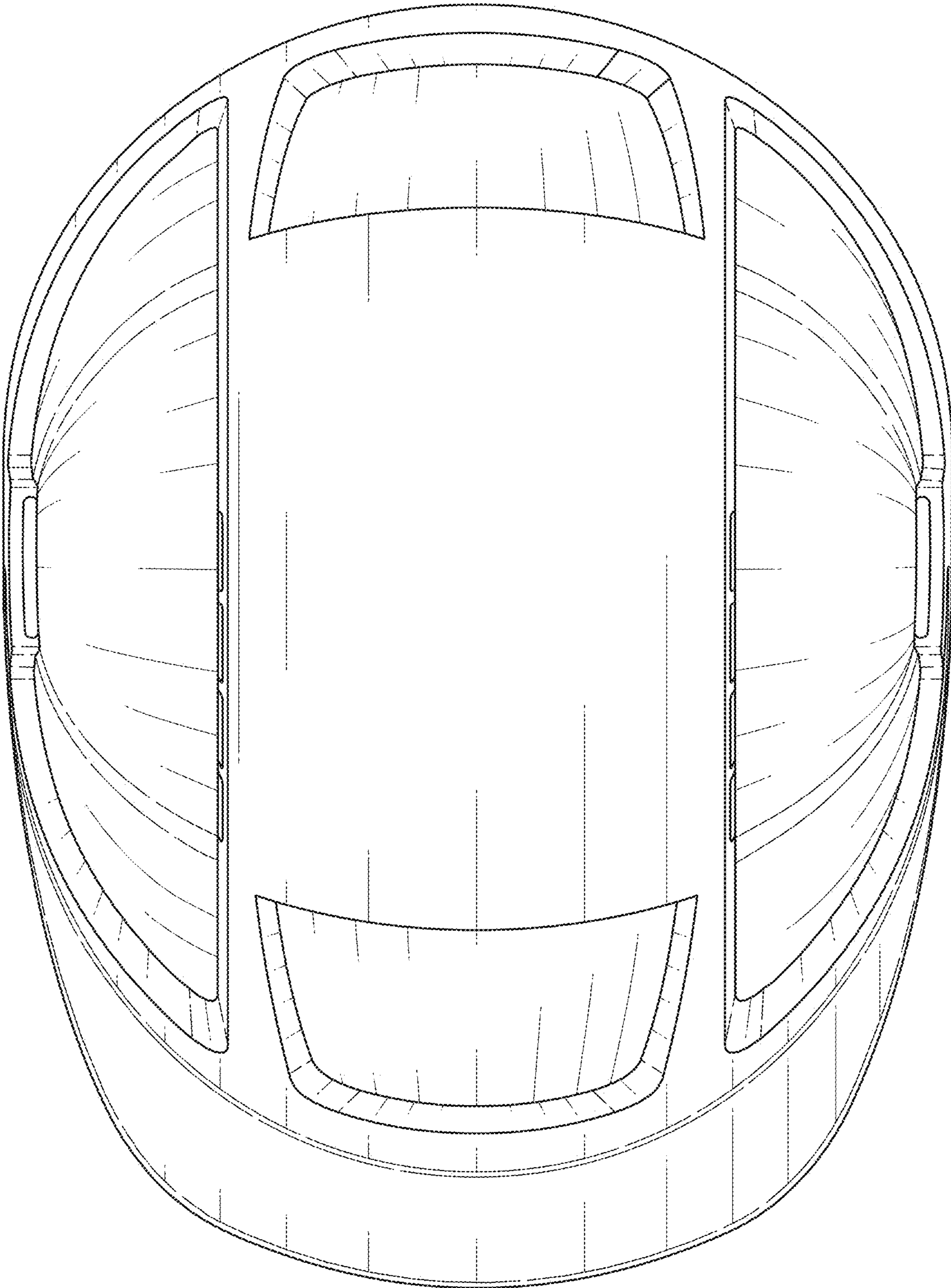

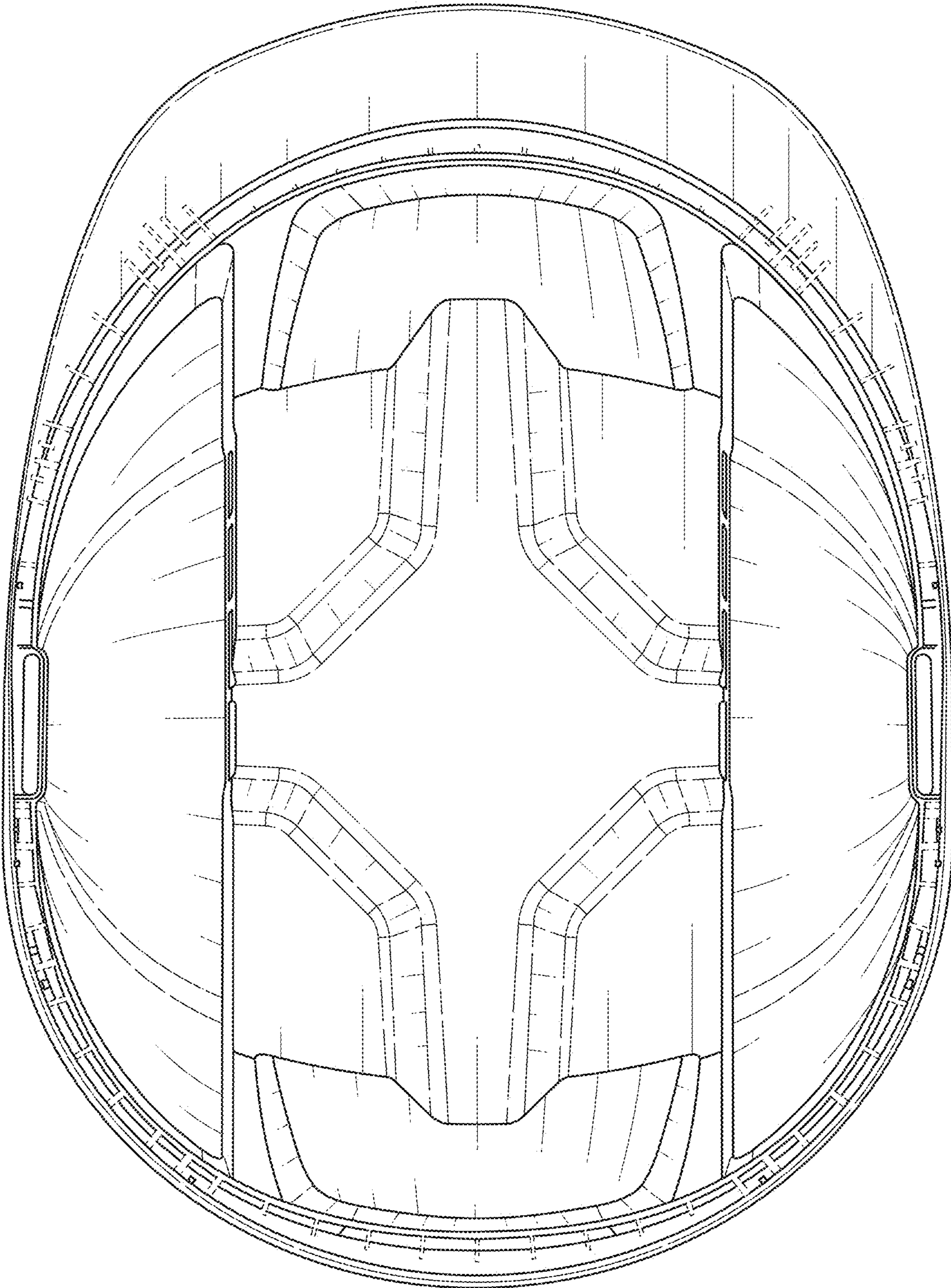

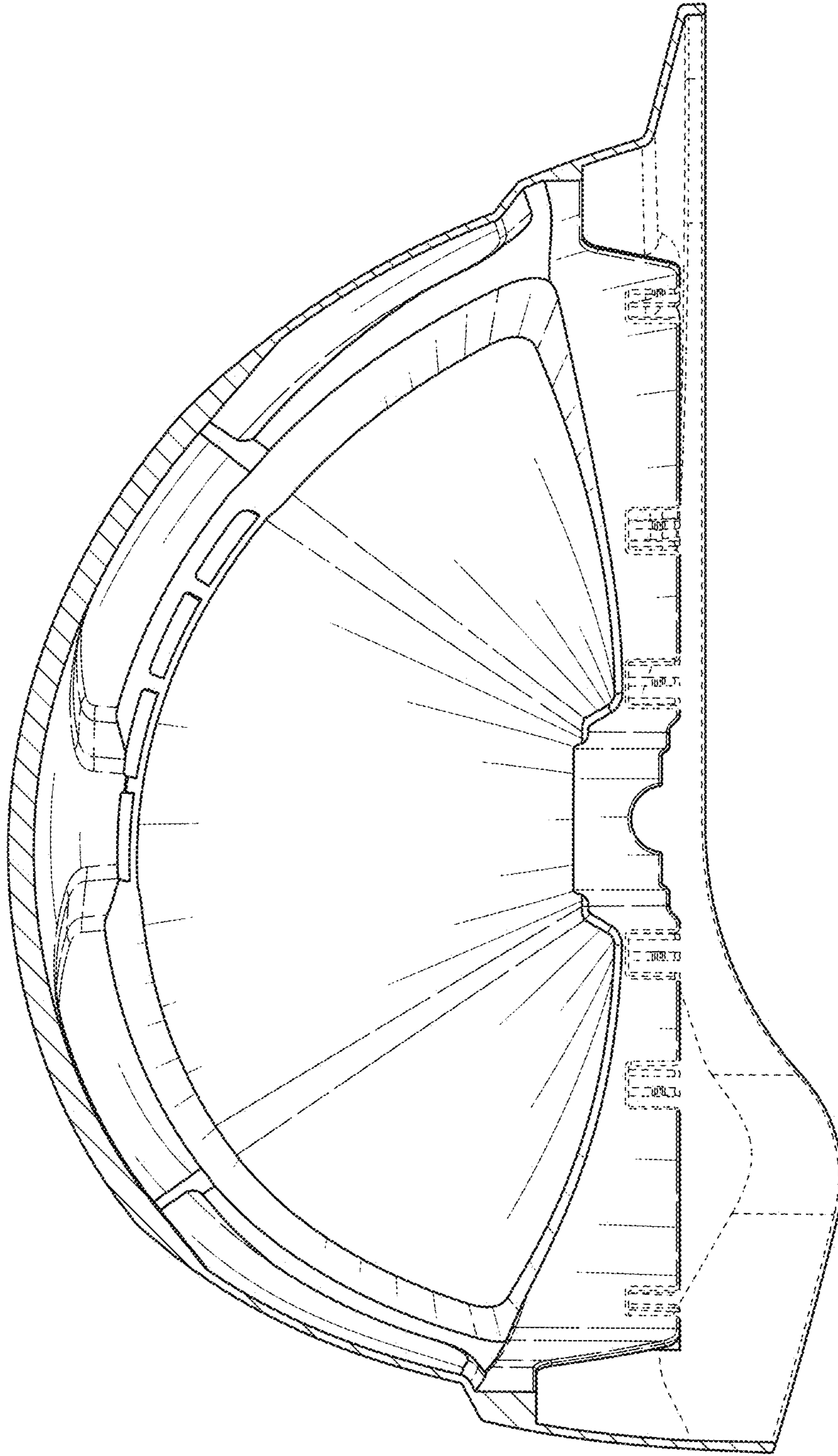
