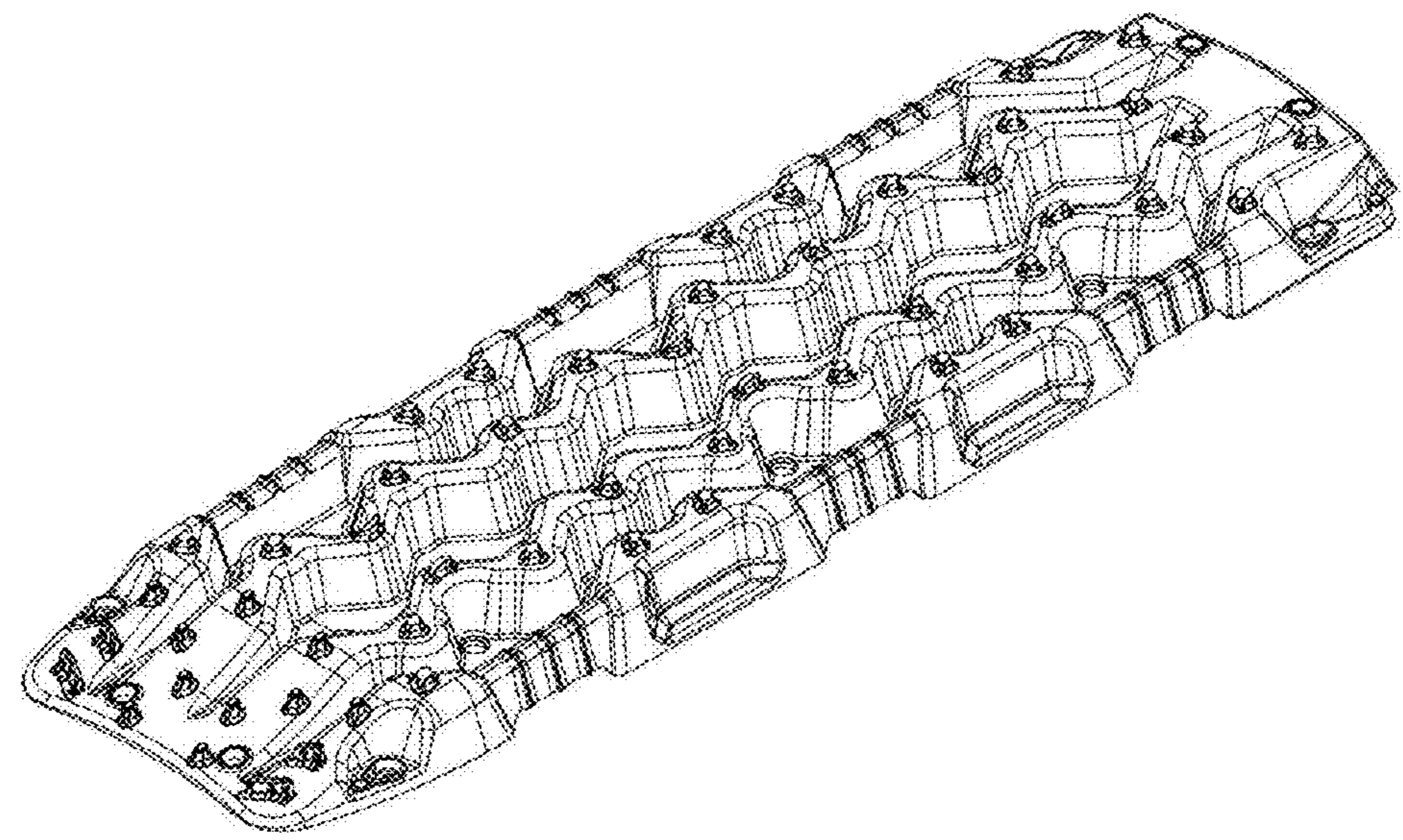
(57) **CLAIM**

The ornamental design for a vehicular ramp, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevation view of a vehicular ramp embodying our new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a top perspective view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a top plan view thereof; and,

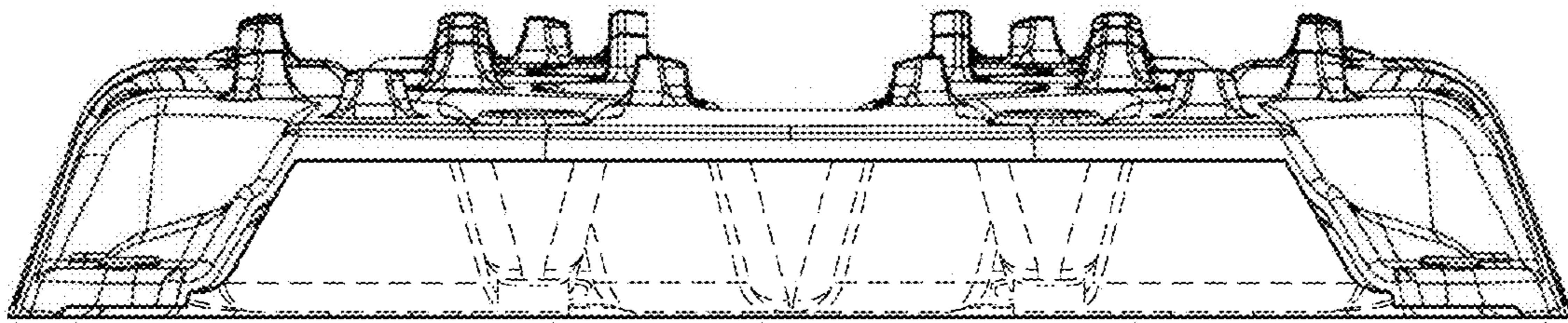

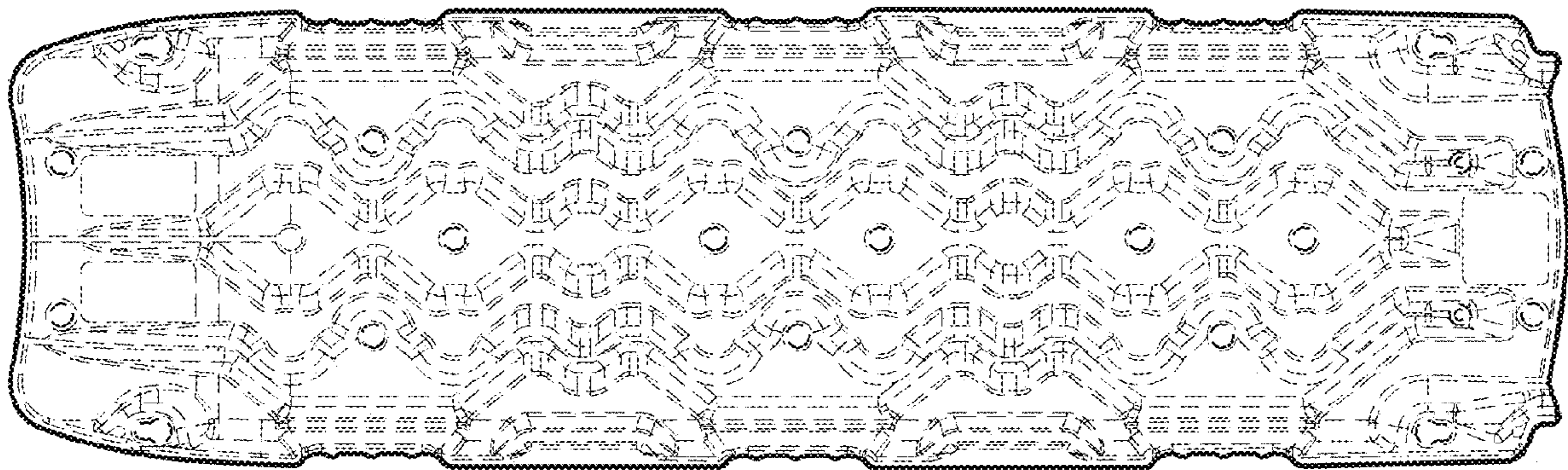

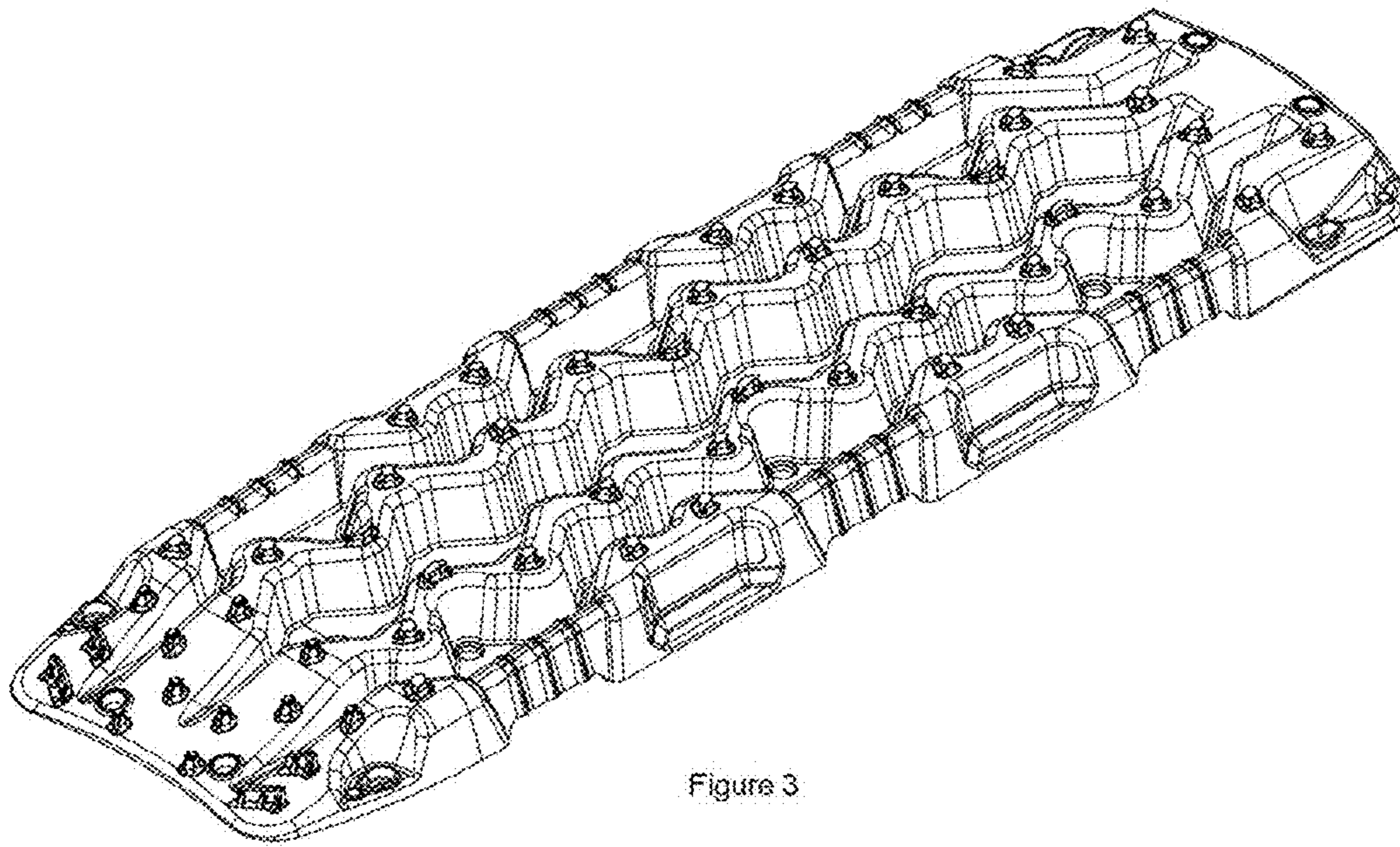

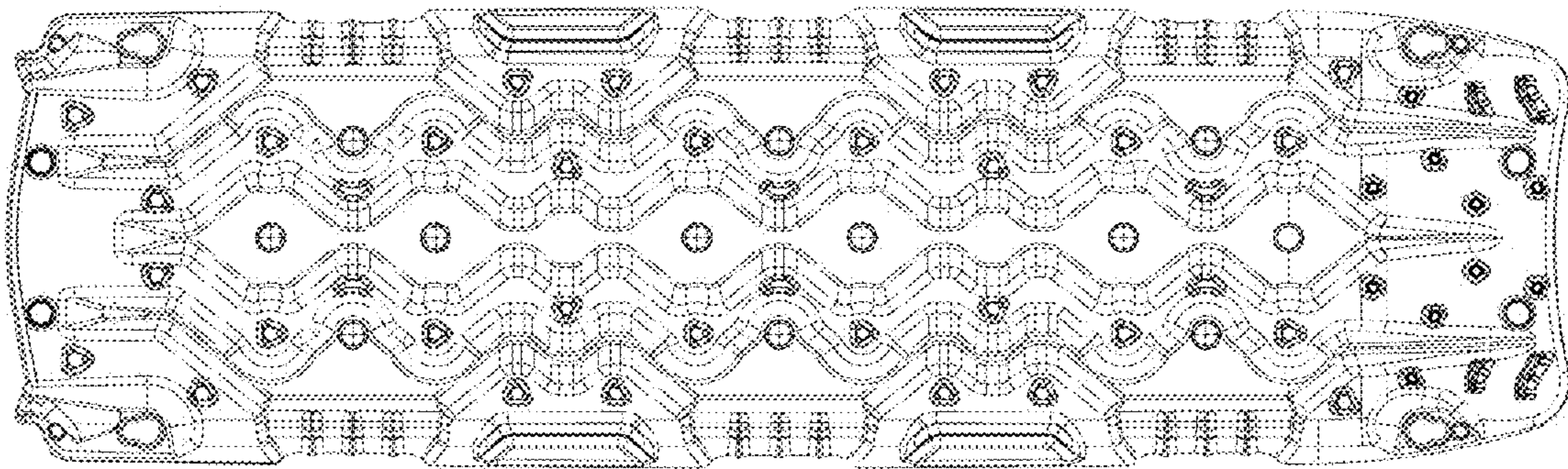
