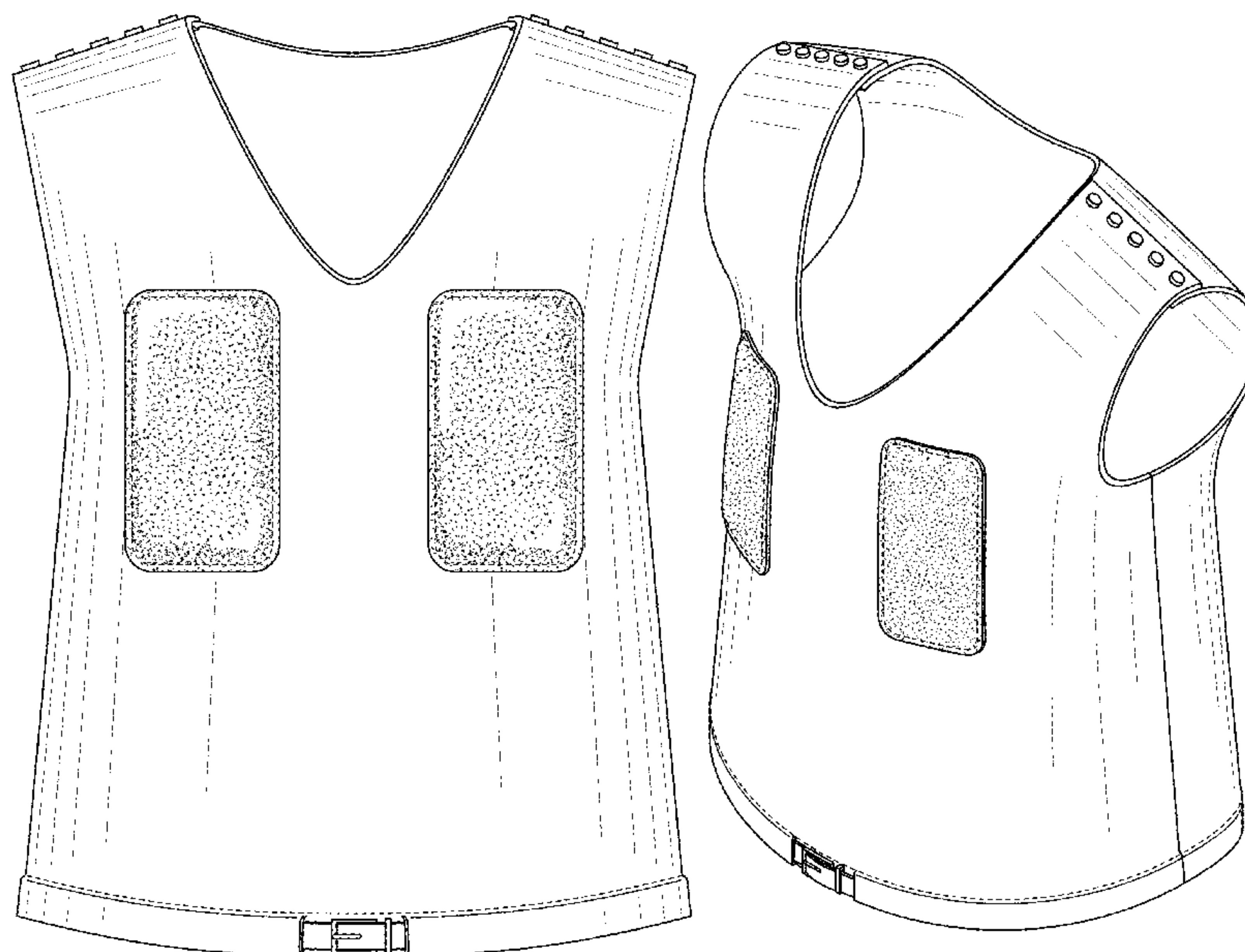
(57) **CLAIM**

The ornamental design for a medical patient garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a medical patient garment showing my new design;  
FIG. 2 is a rear view of the medical patient garment;  
FIG. 3 is a right side view of the medical patient garment, a left side being a mirror image thereof;  
FIG. 4 is a top view of the medical patient garment;  
FIG. 5 is a bottom view of the medical patient garment; and,  
FIG. 6 is a top front side perspective view of the medical patient garment.  
The broken lines throughout the drawing figures are illustrative of stitching forming part of the claimed design.

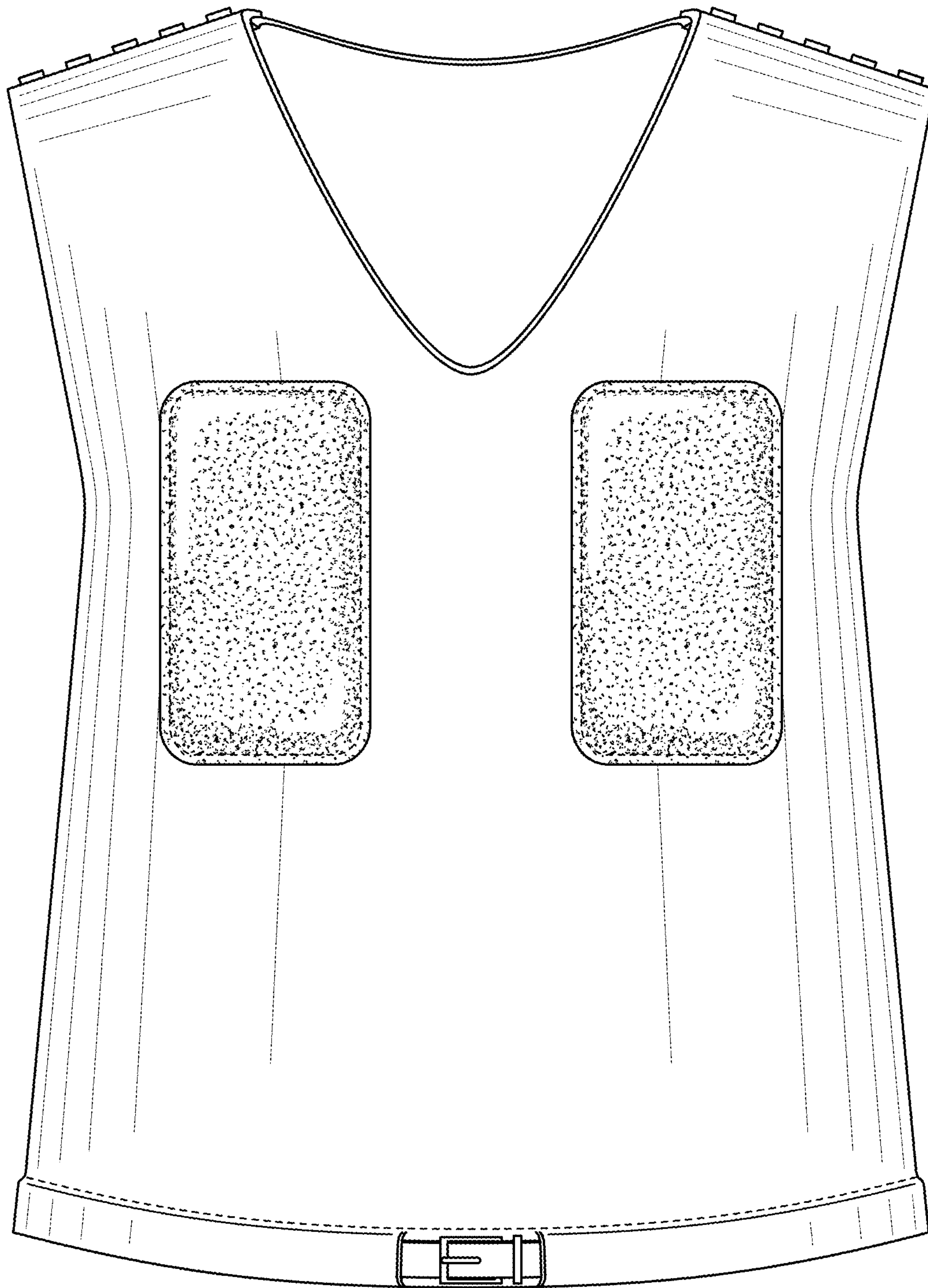

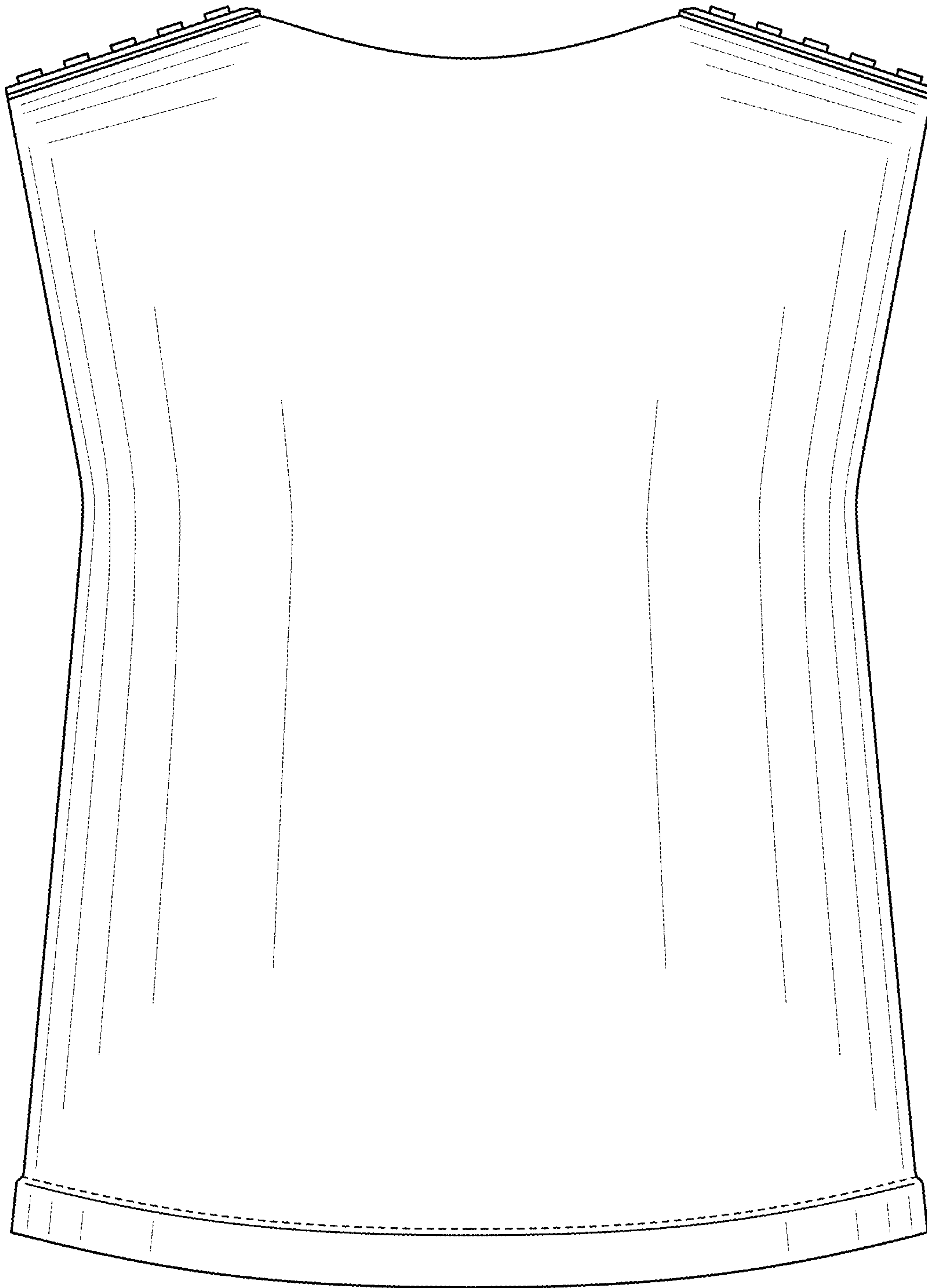

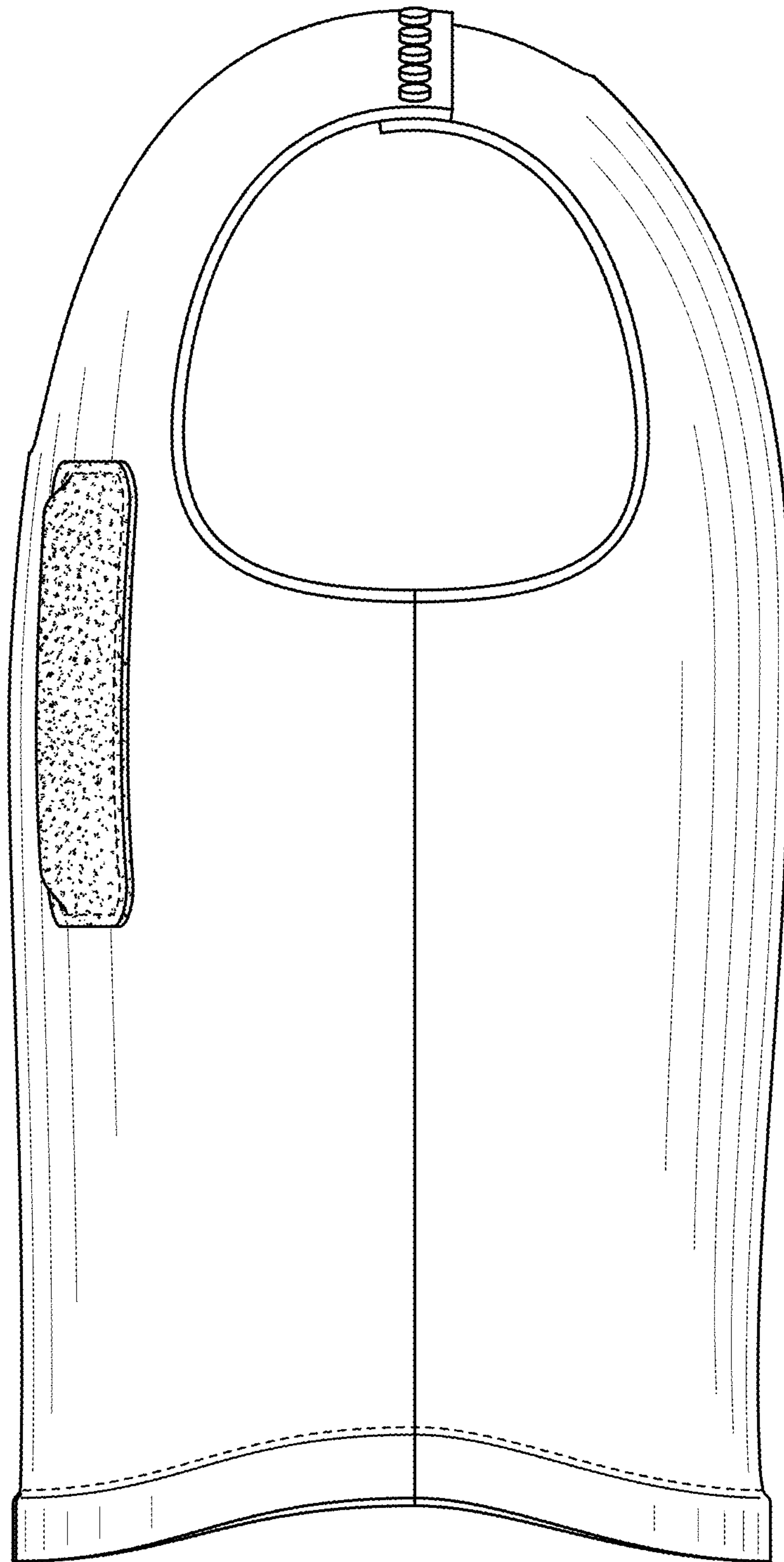

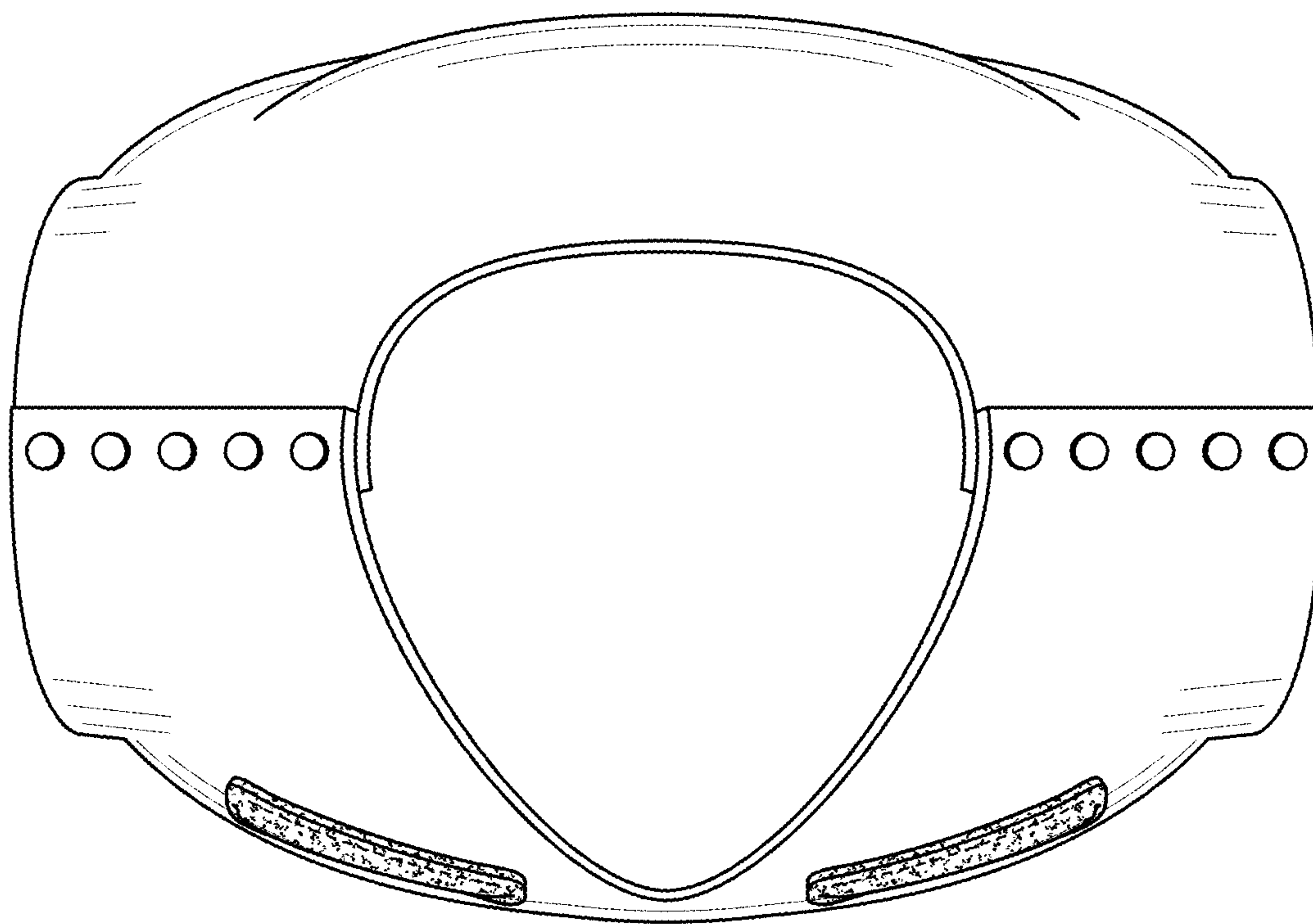

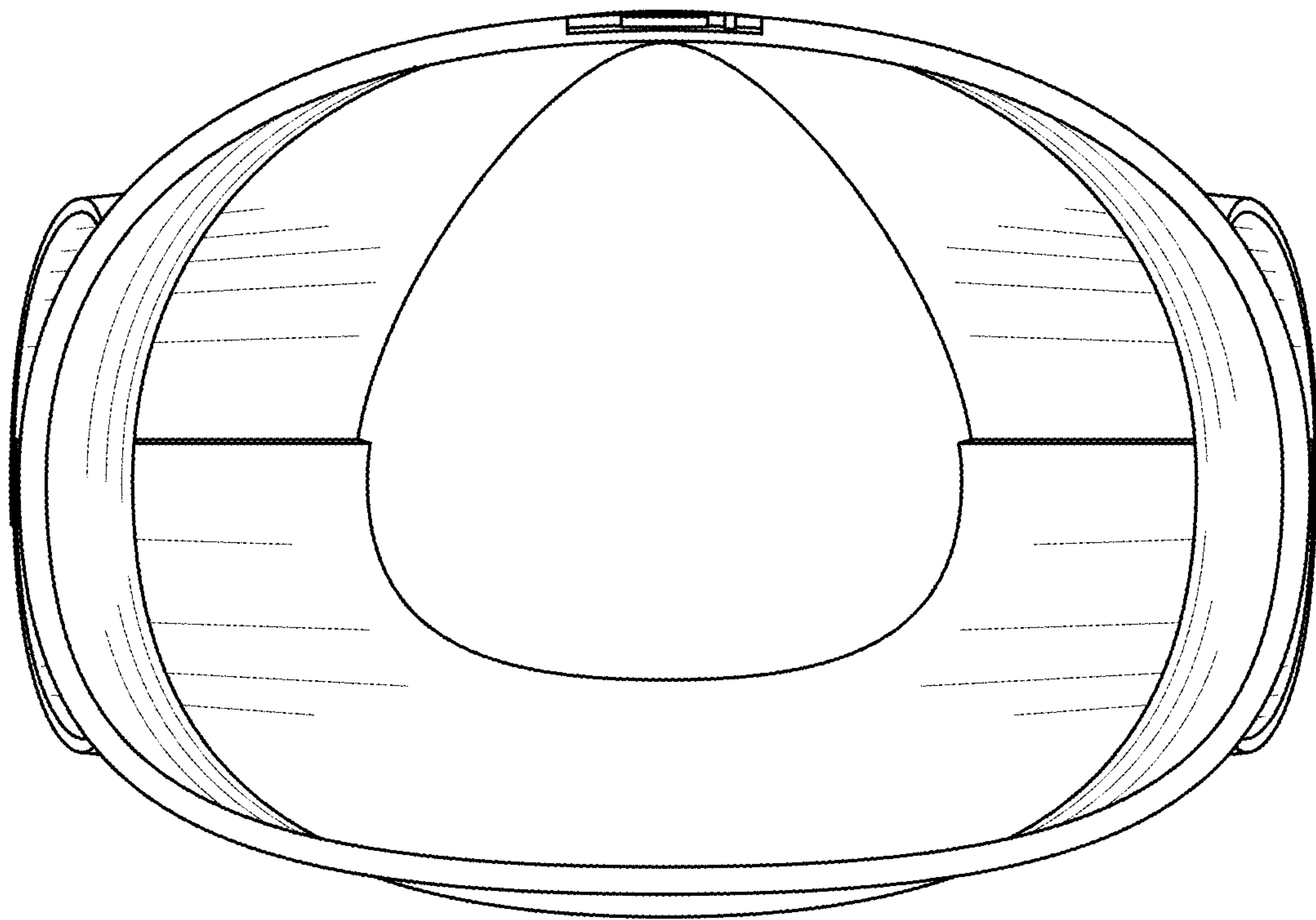

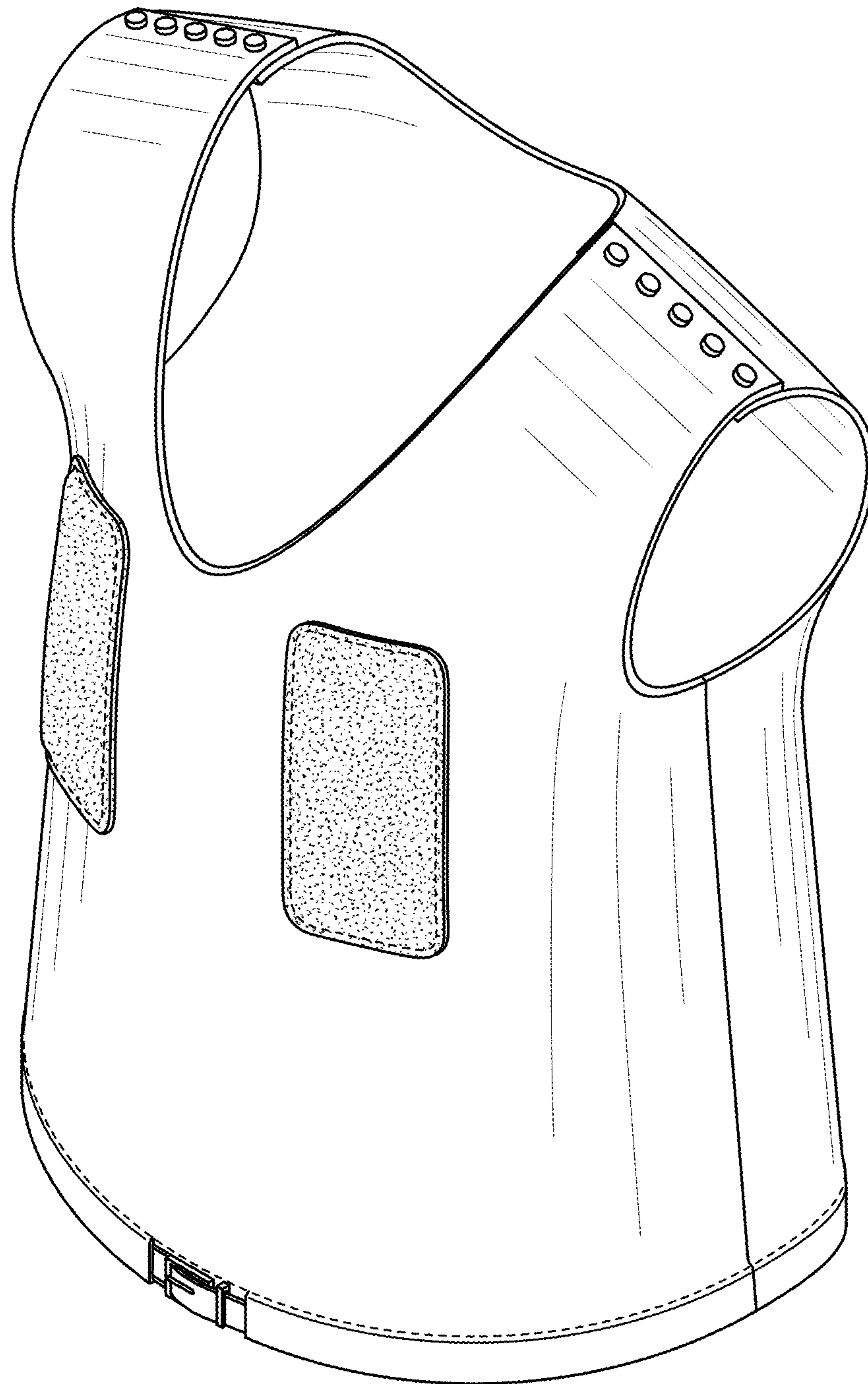
