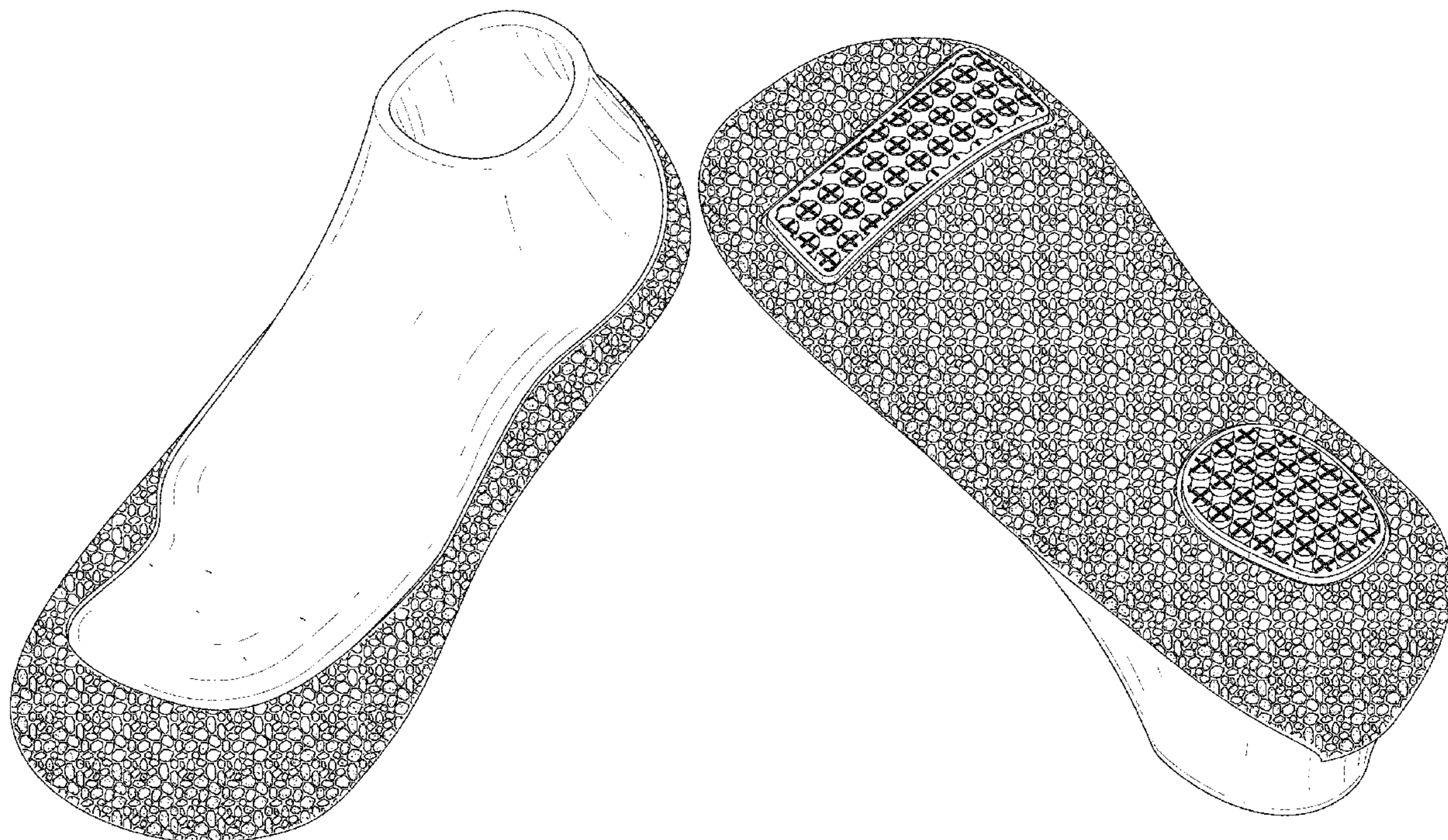
(57) **CLAIM**

The ornamental design for a slipper sock, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a slipper sock showing my new design;
 FIG. 2 is a rear, right side, bottom perspective view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;

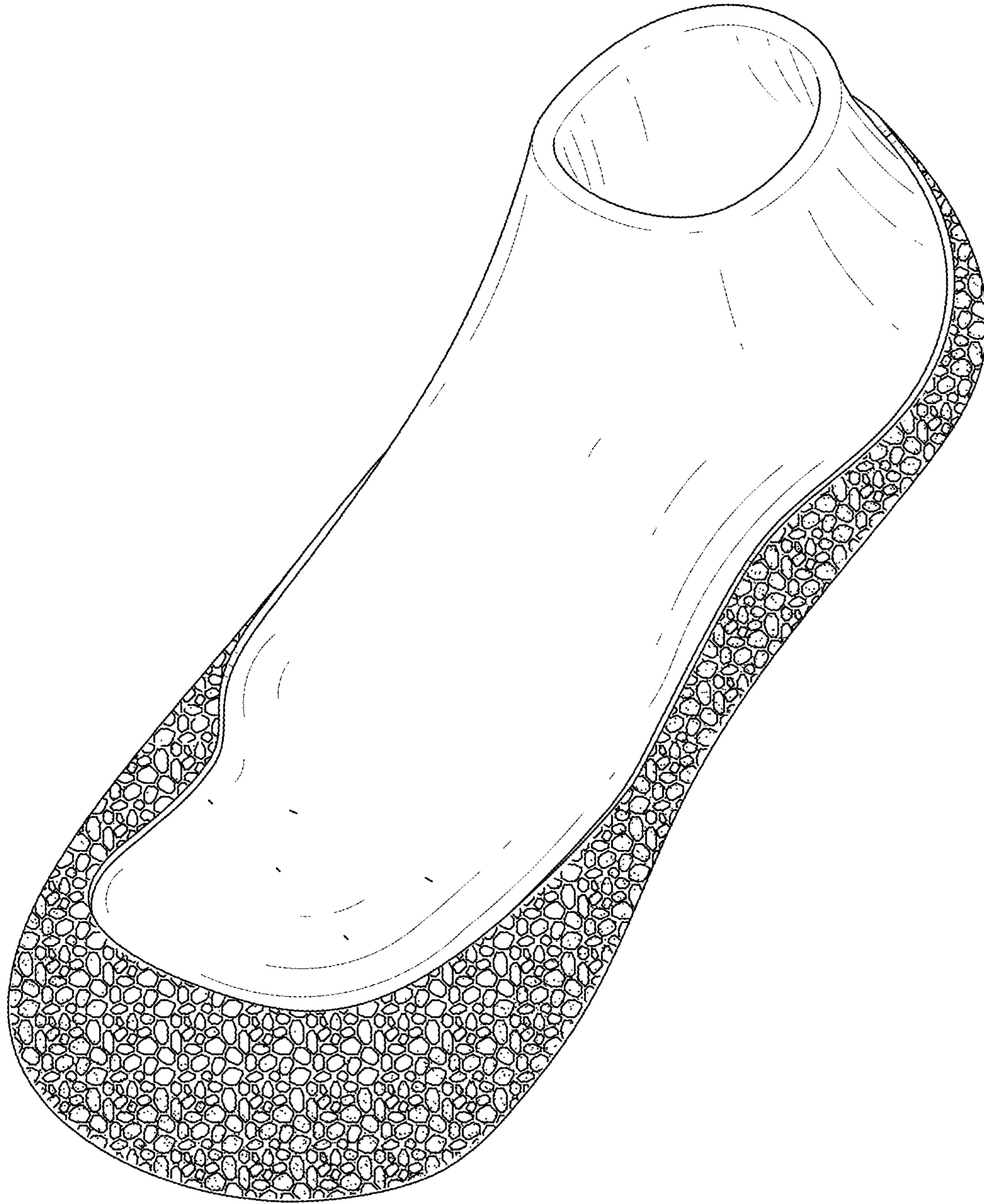

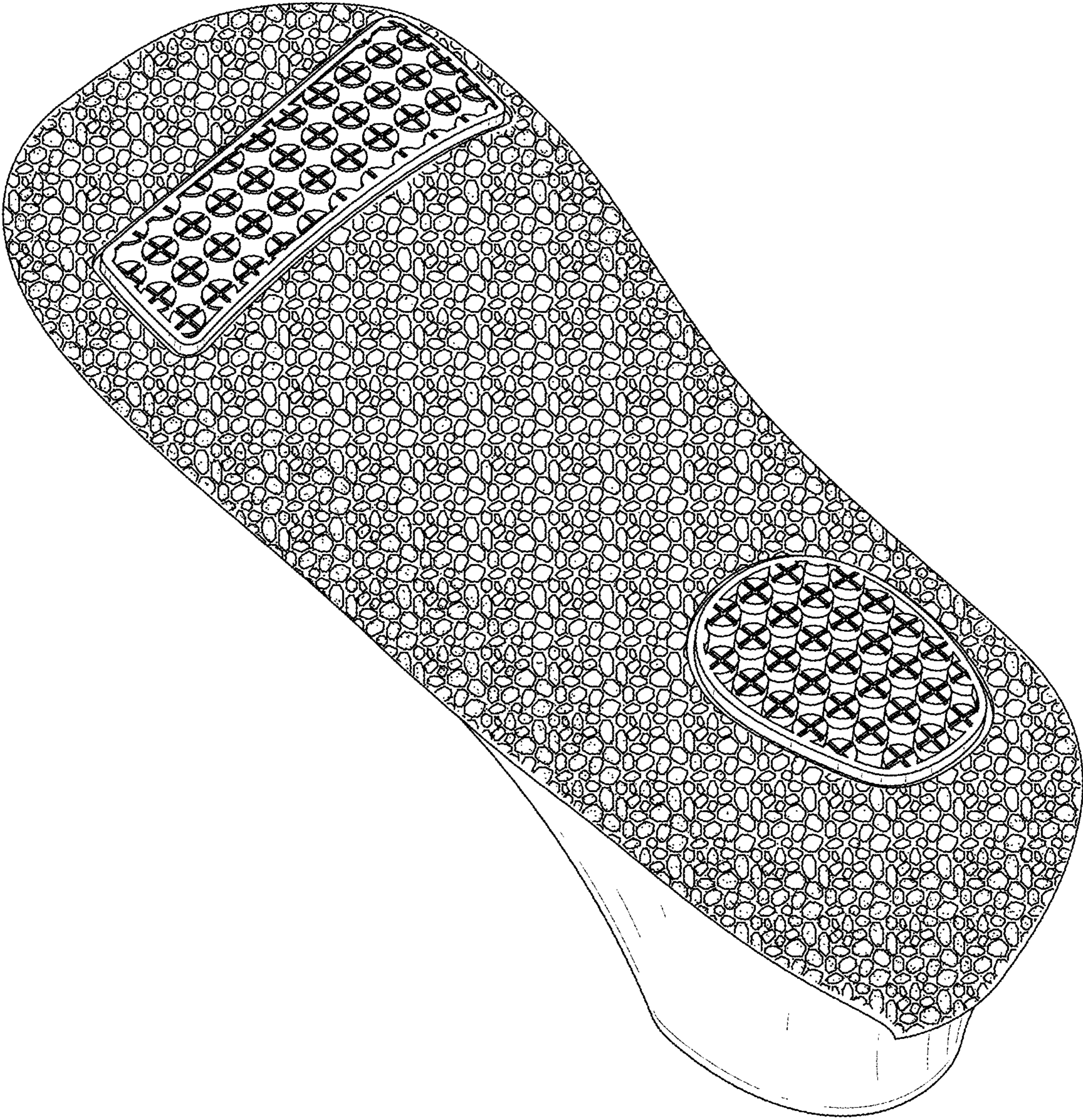

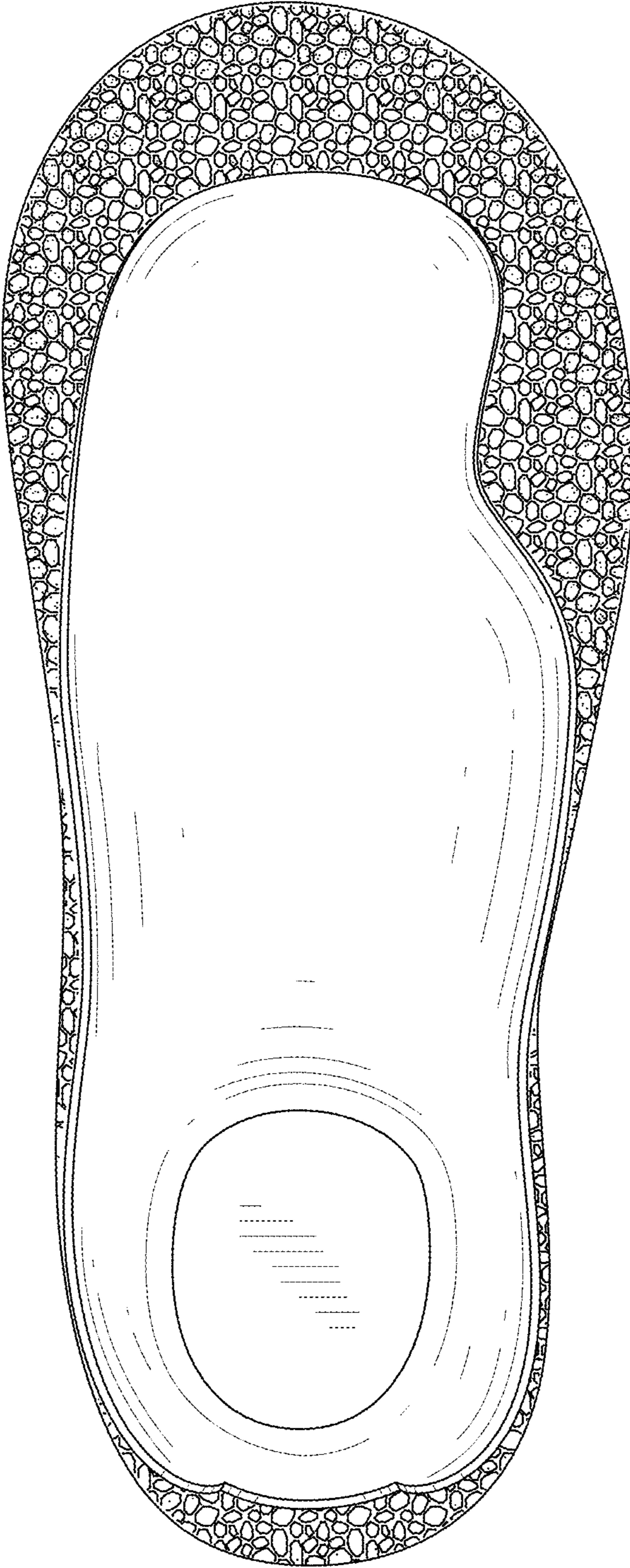

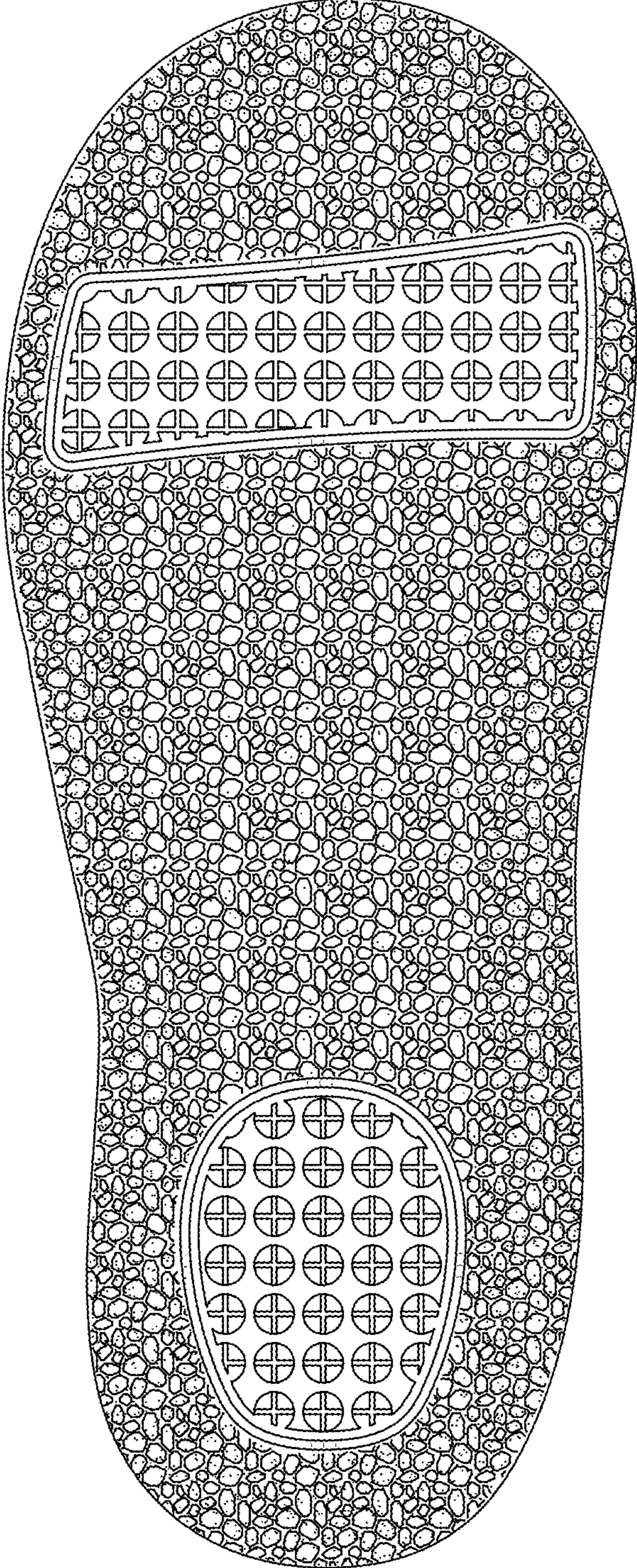

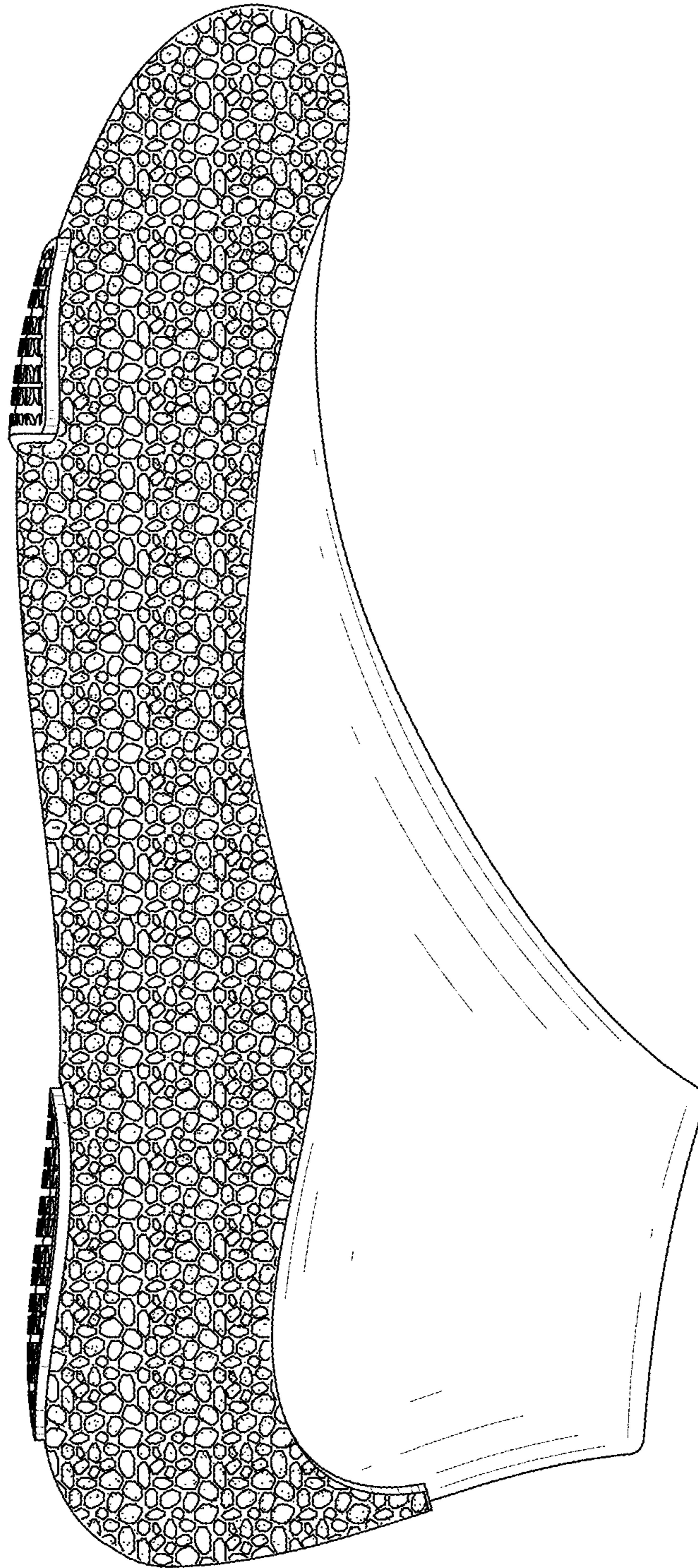

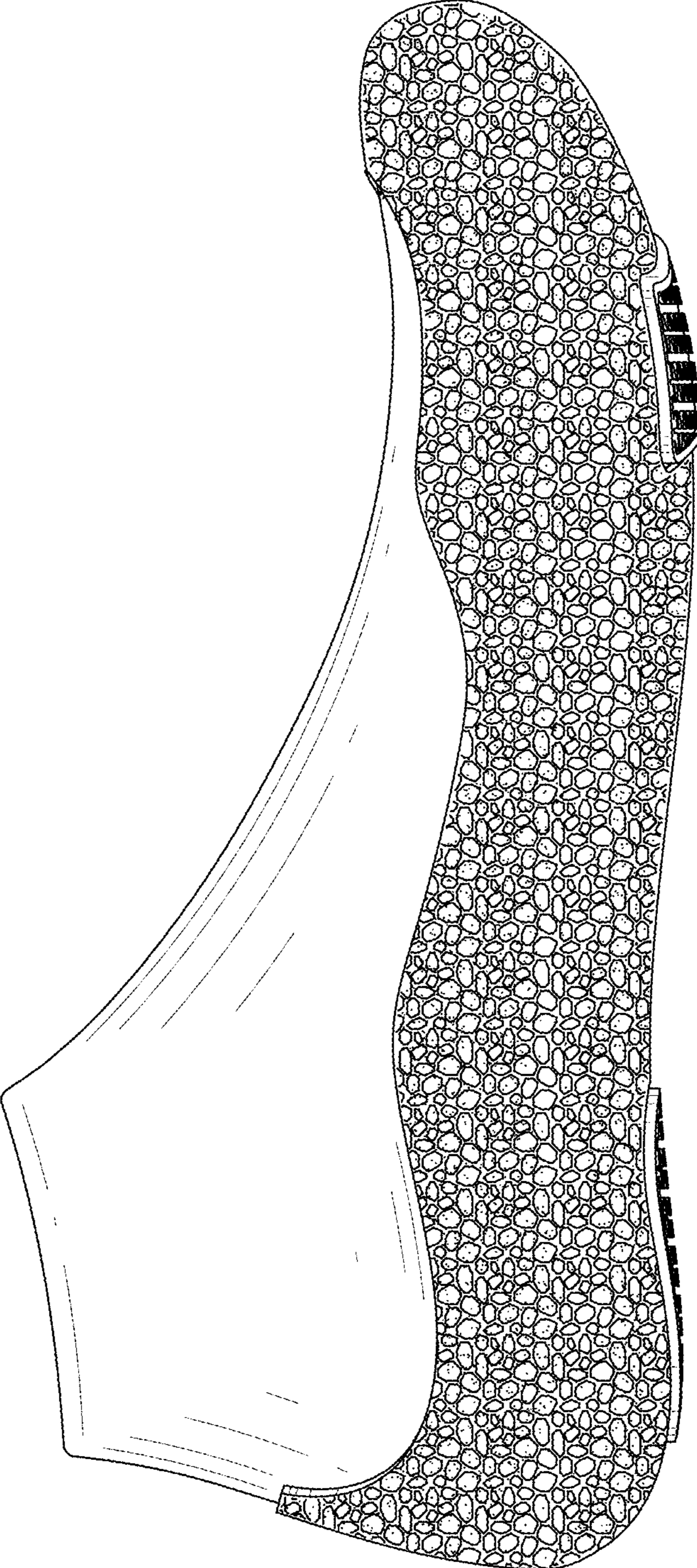

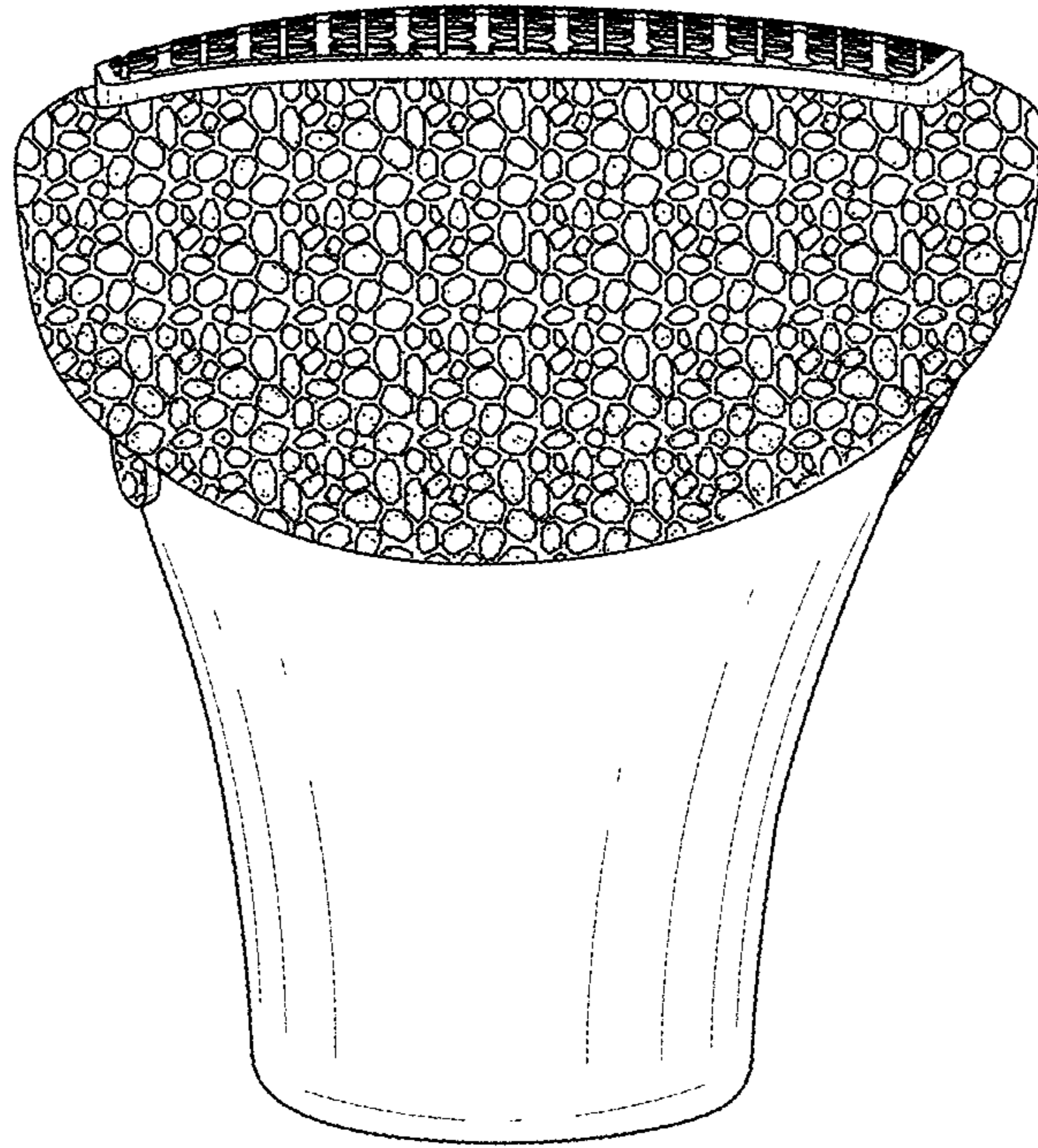

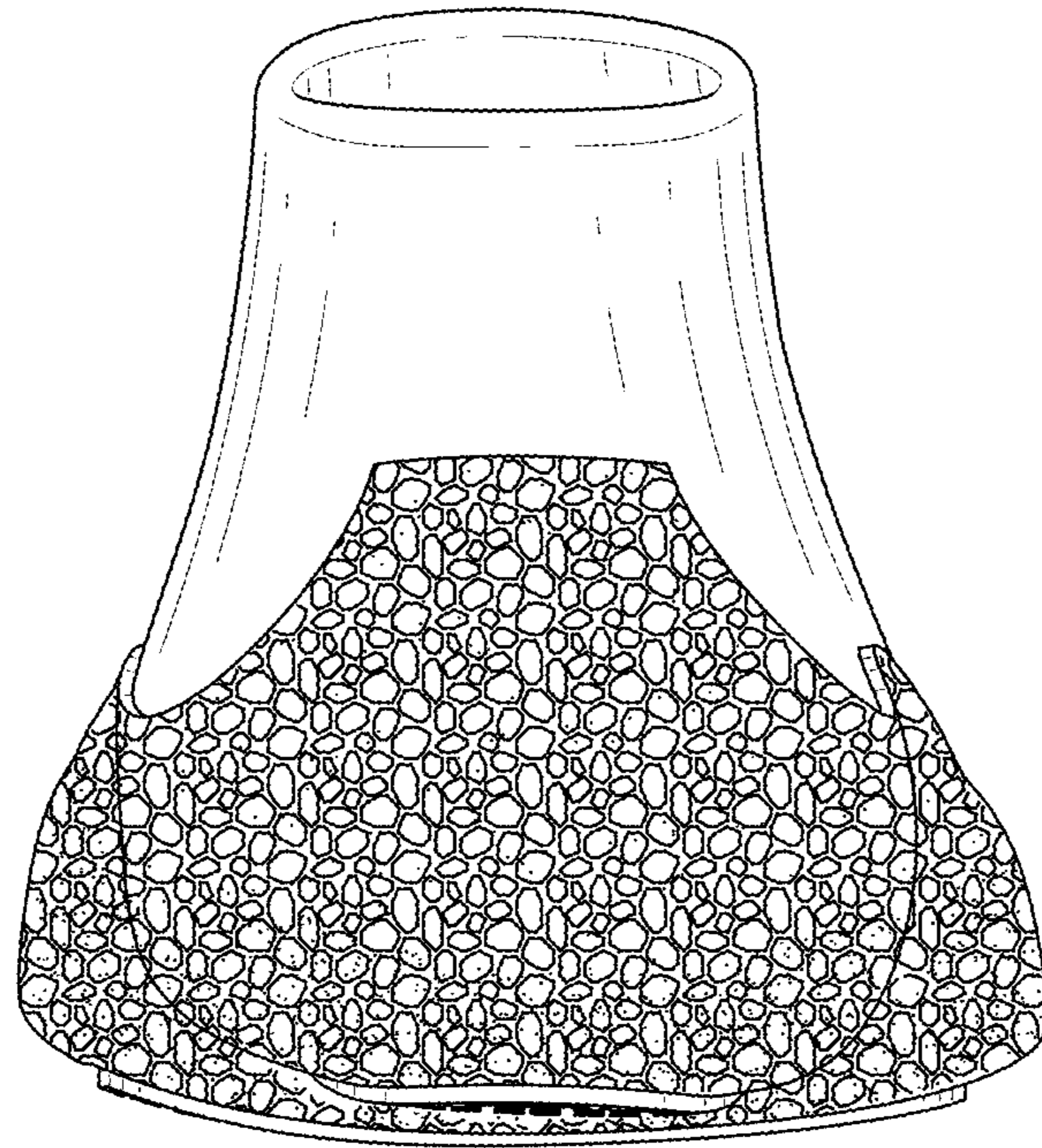
