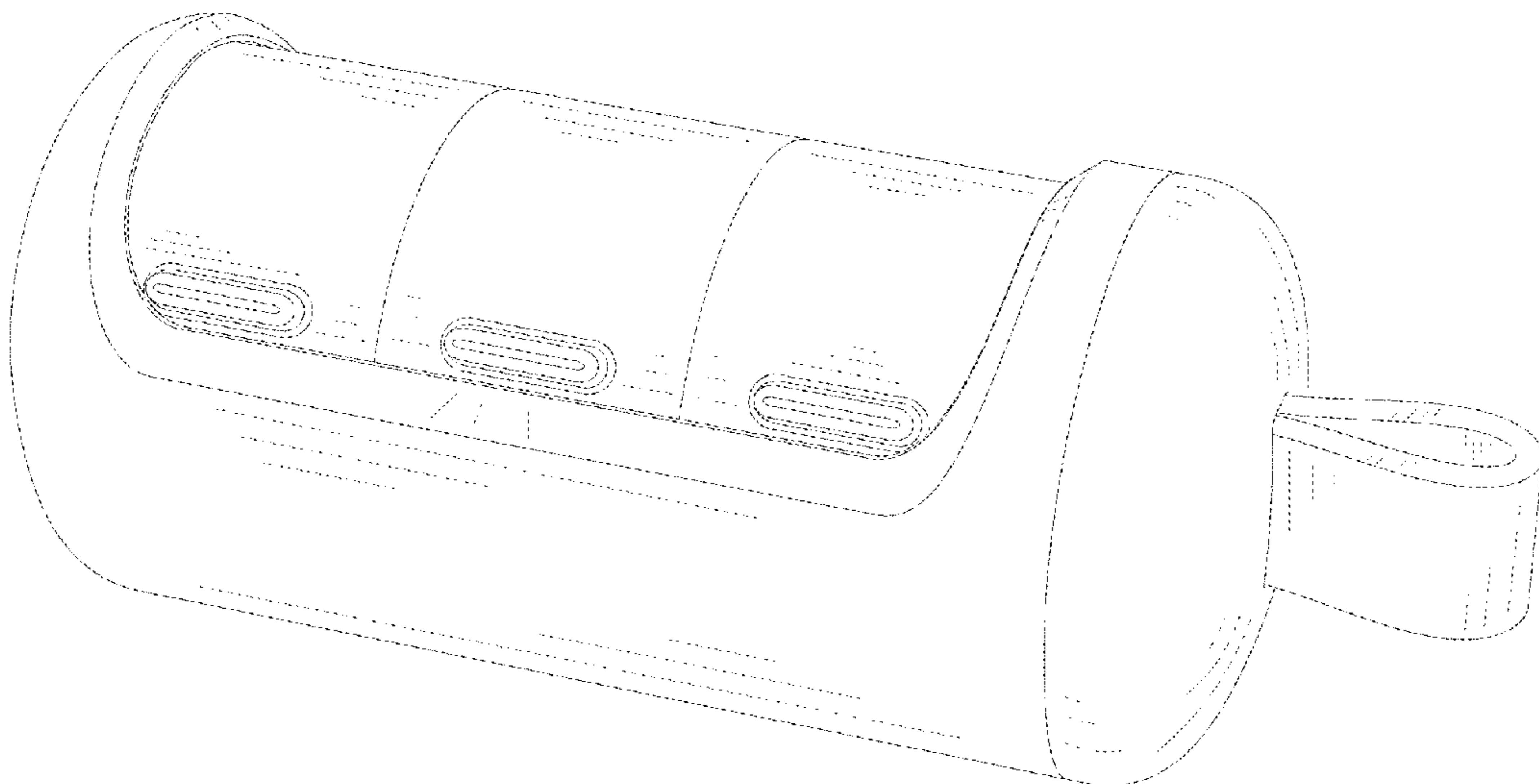
The ornamental design for a portable pill box, as shown and described.

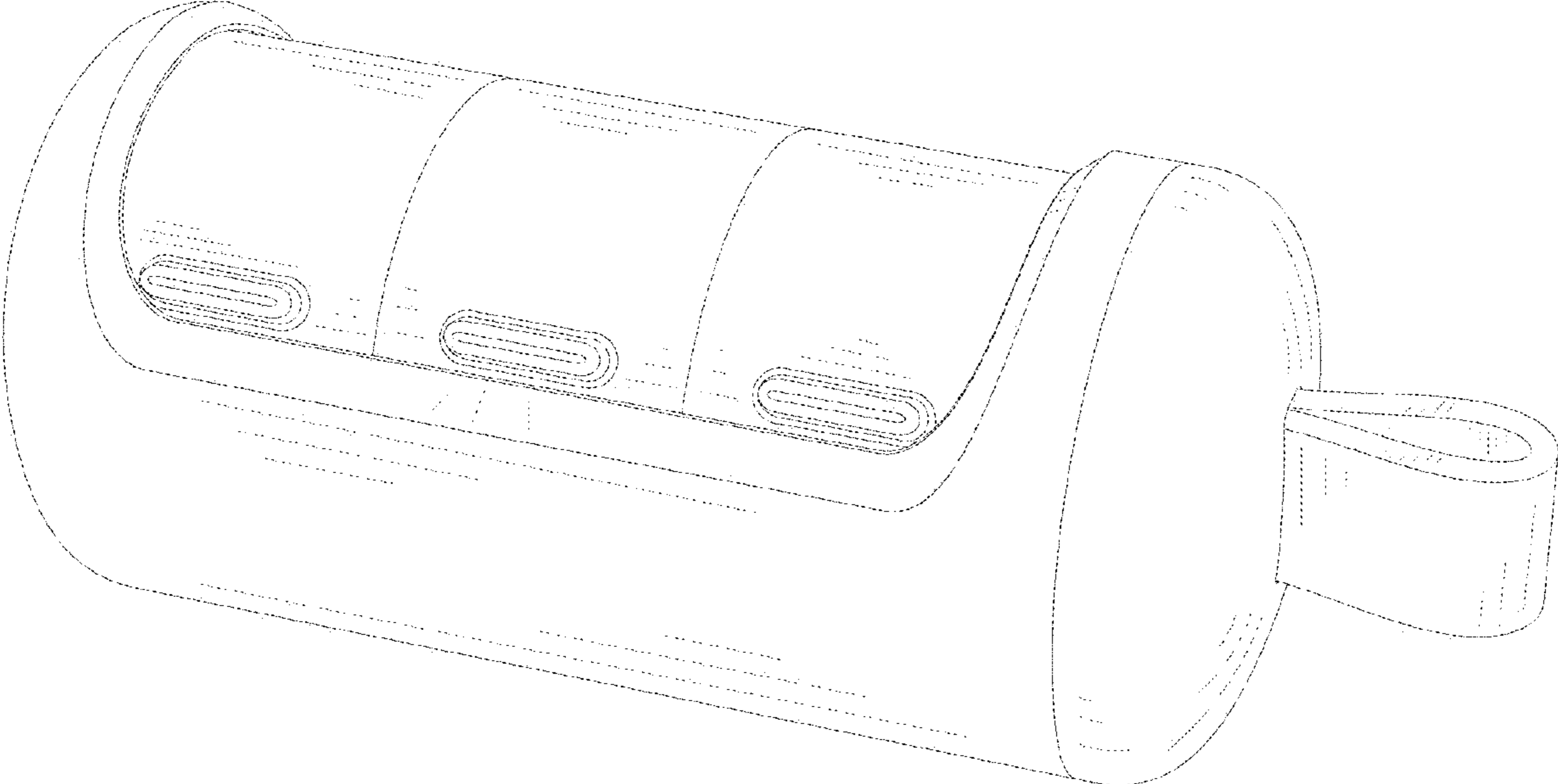

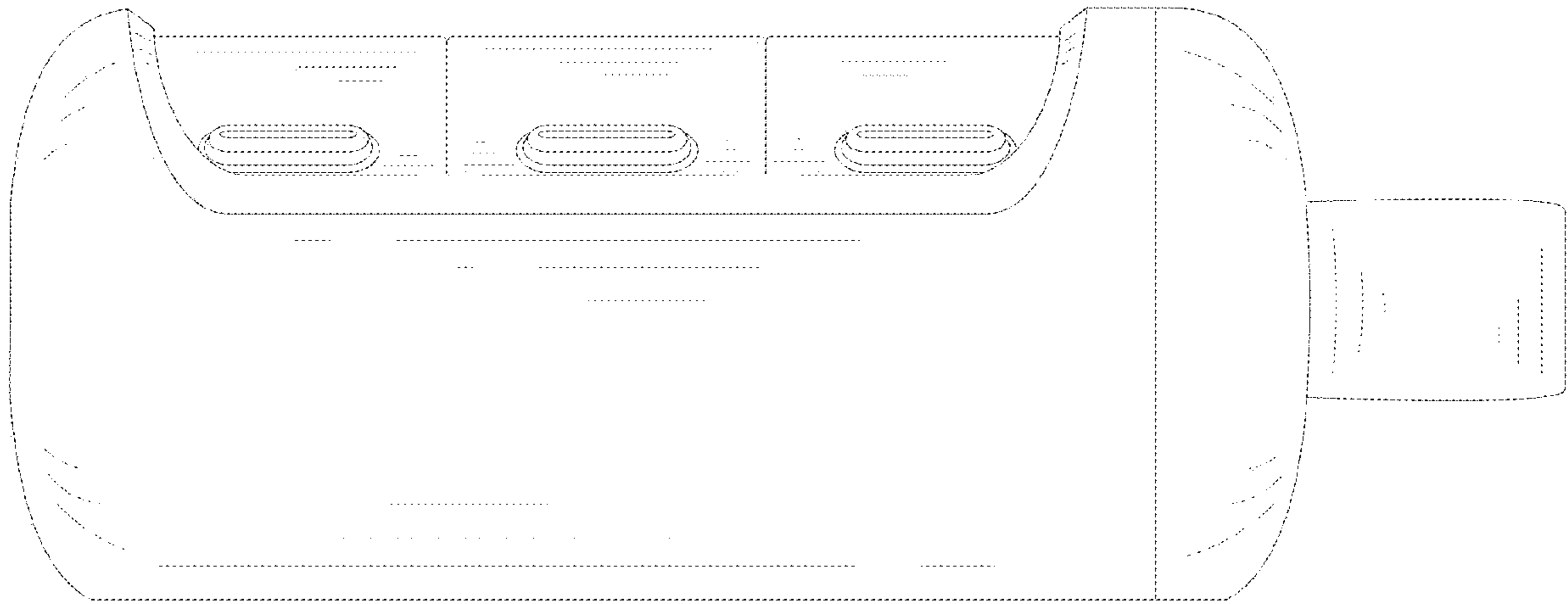

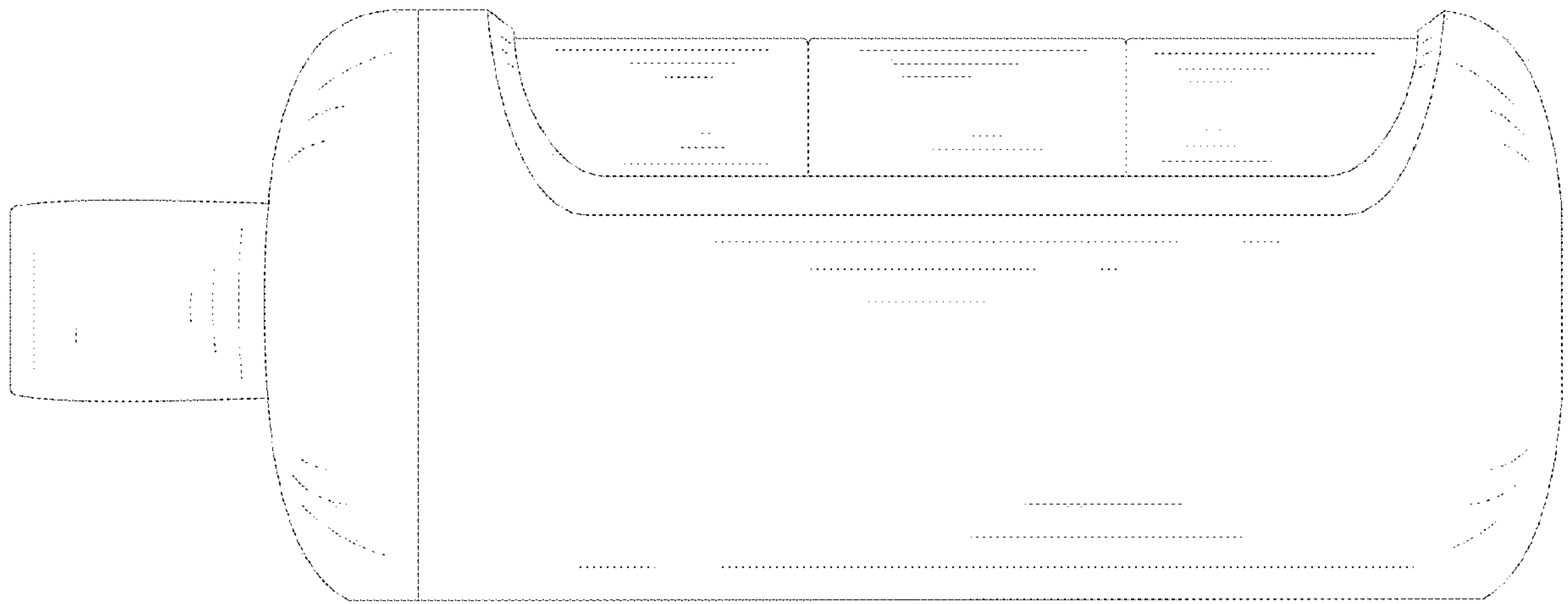

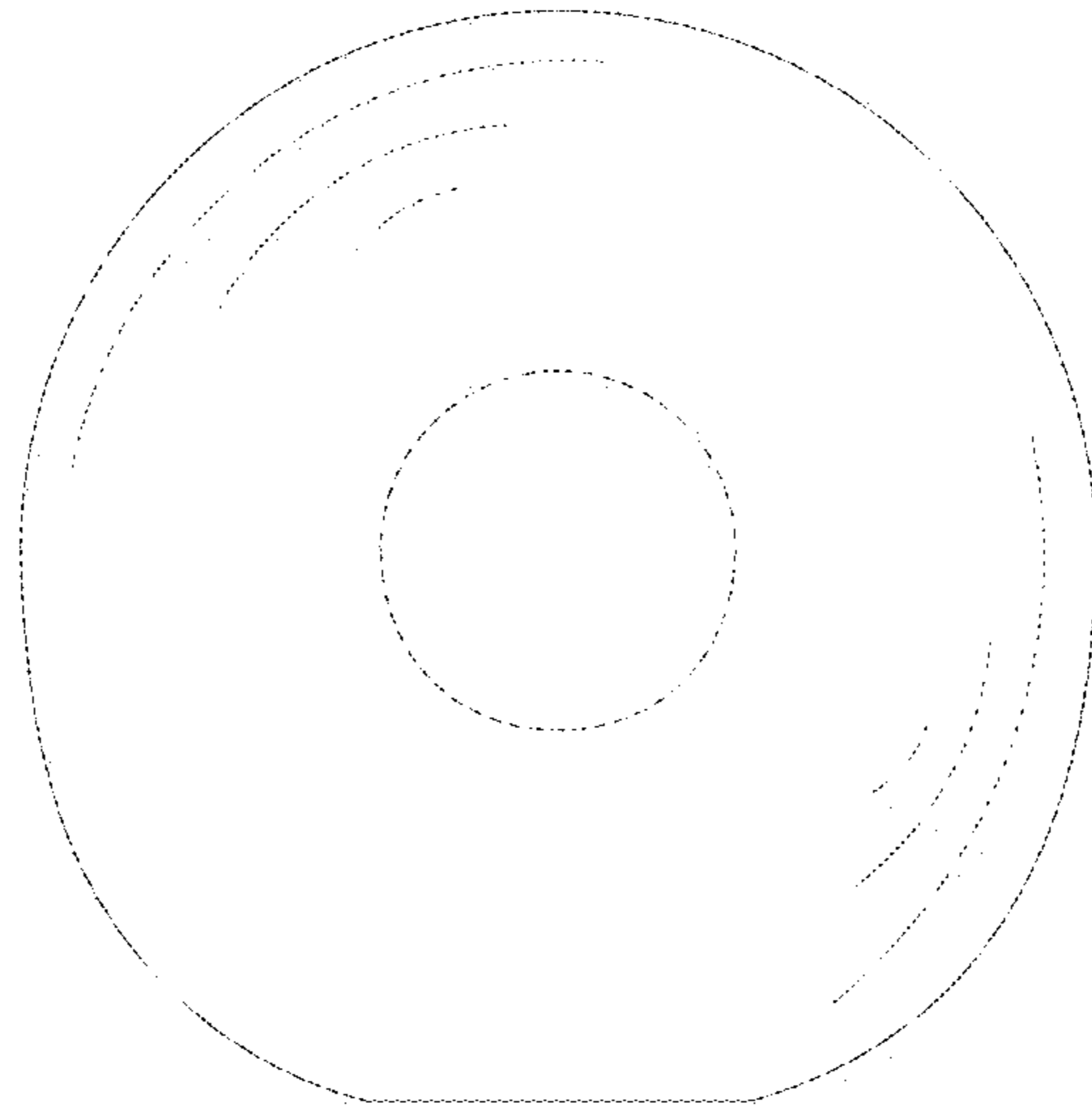

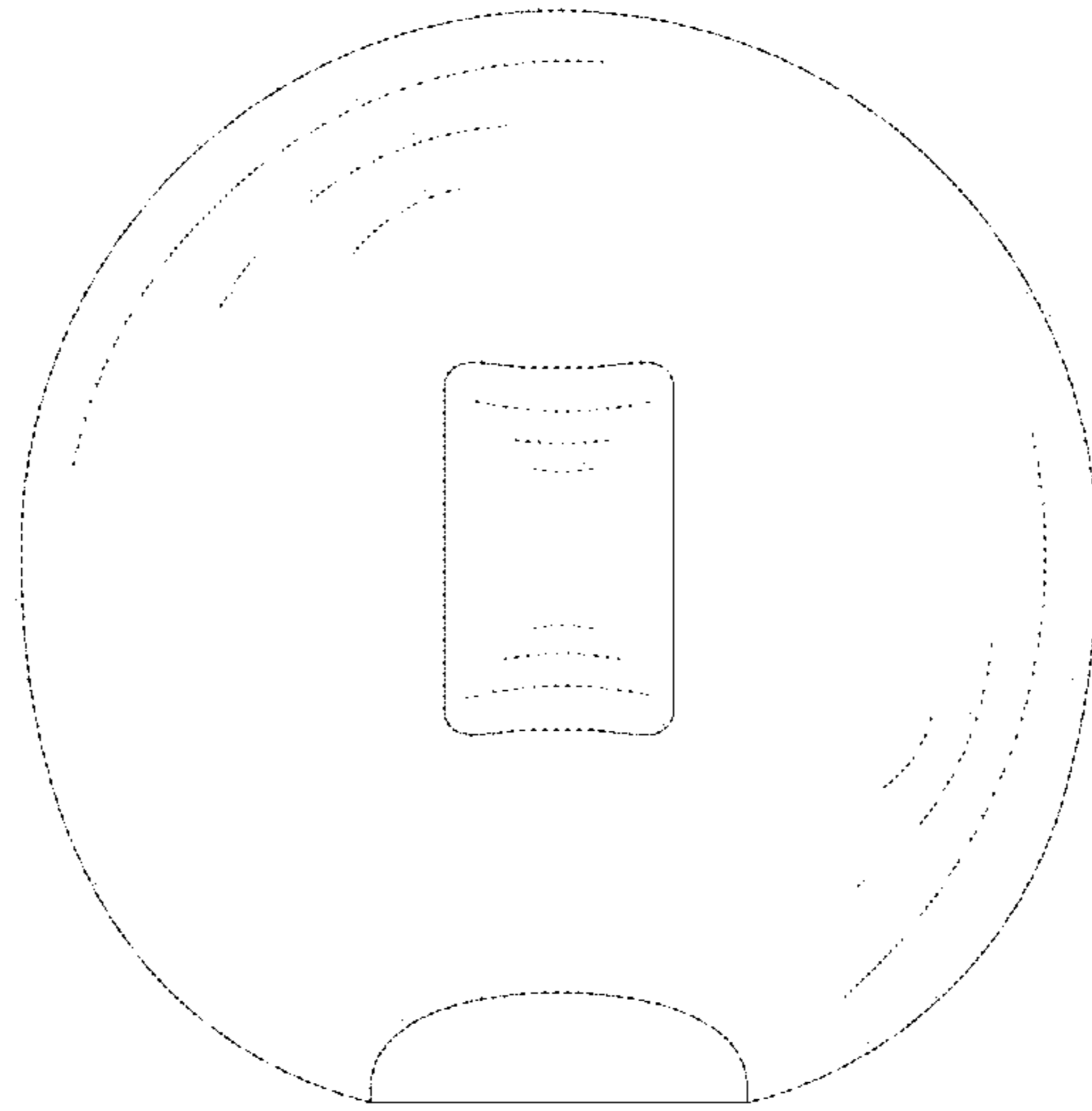

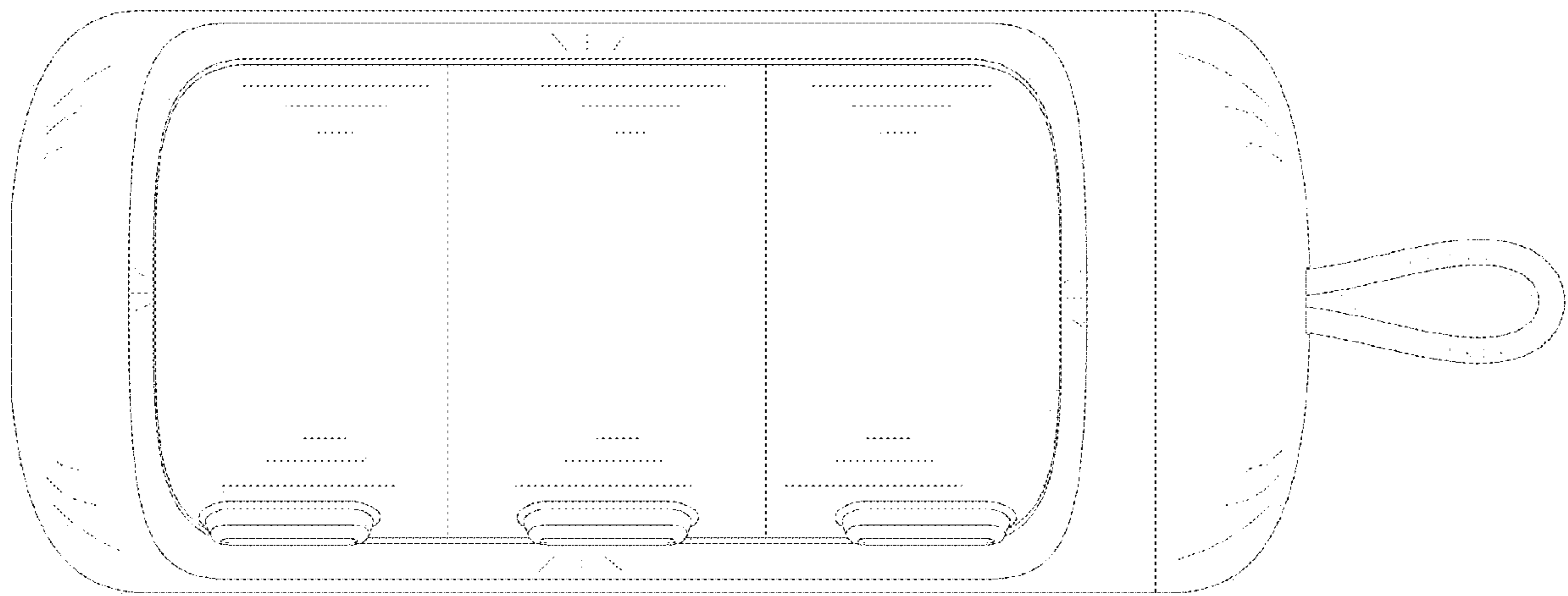

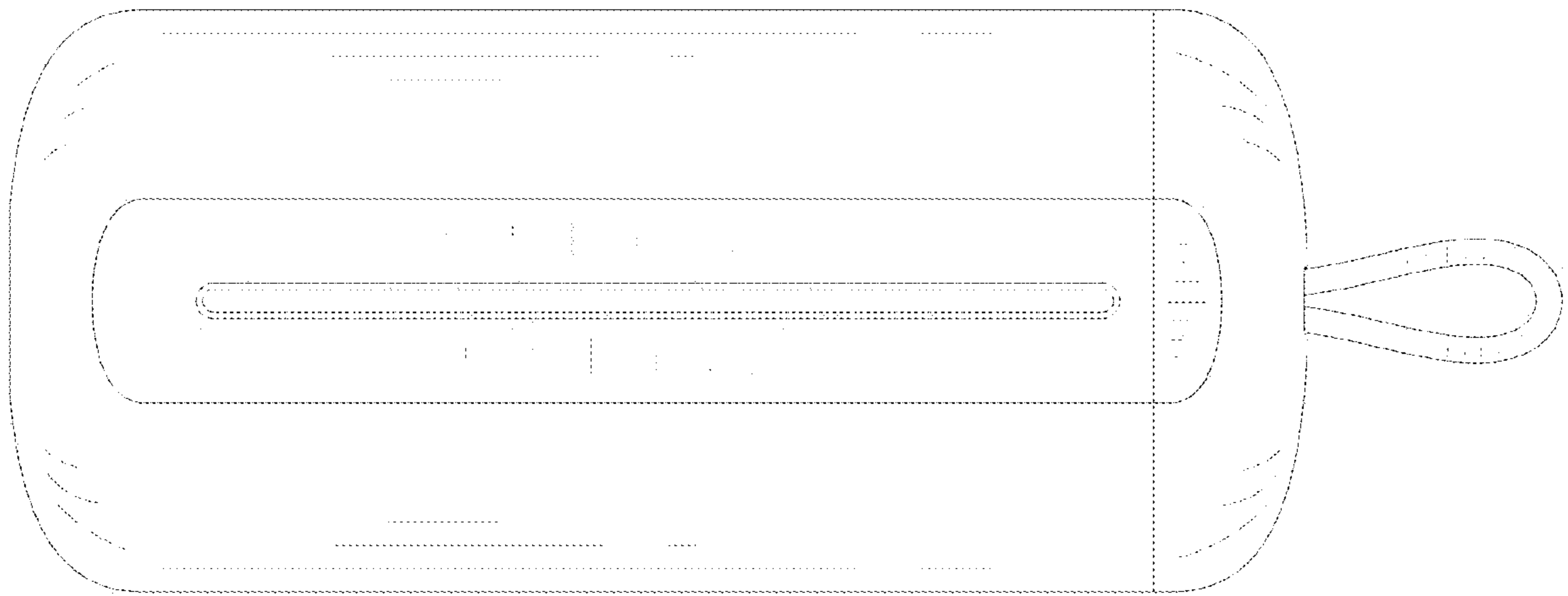
