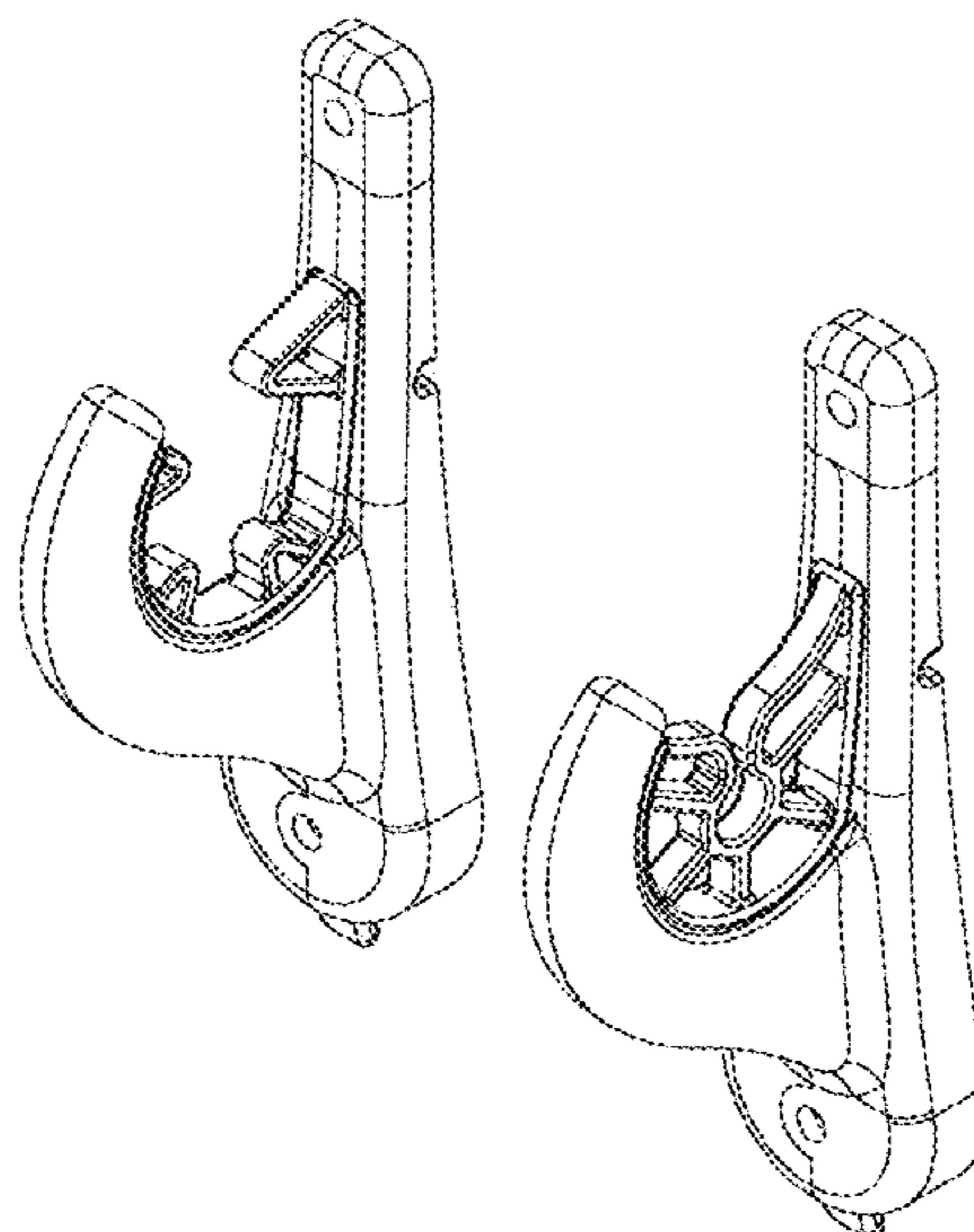
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right isometric view of a rod storage hook set showing our new design;

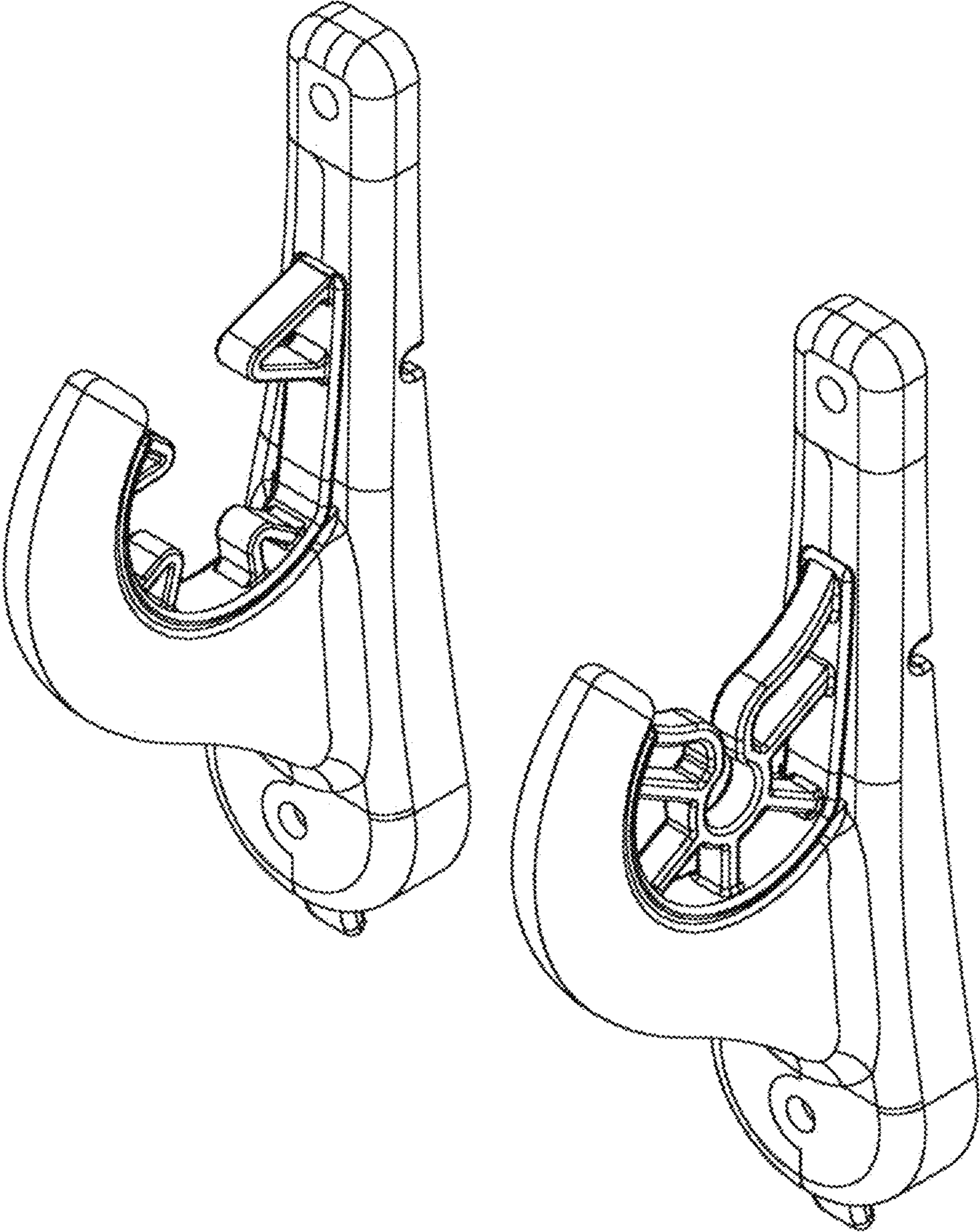

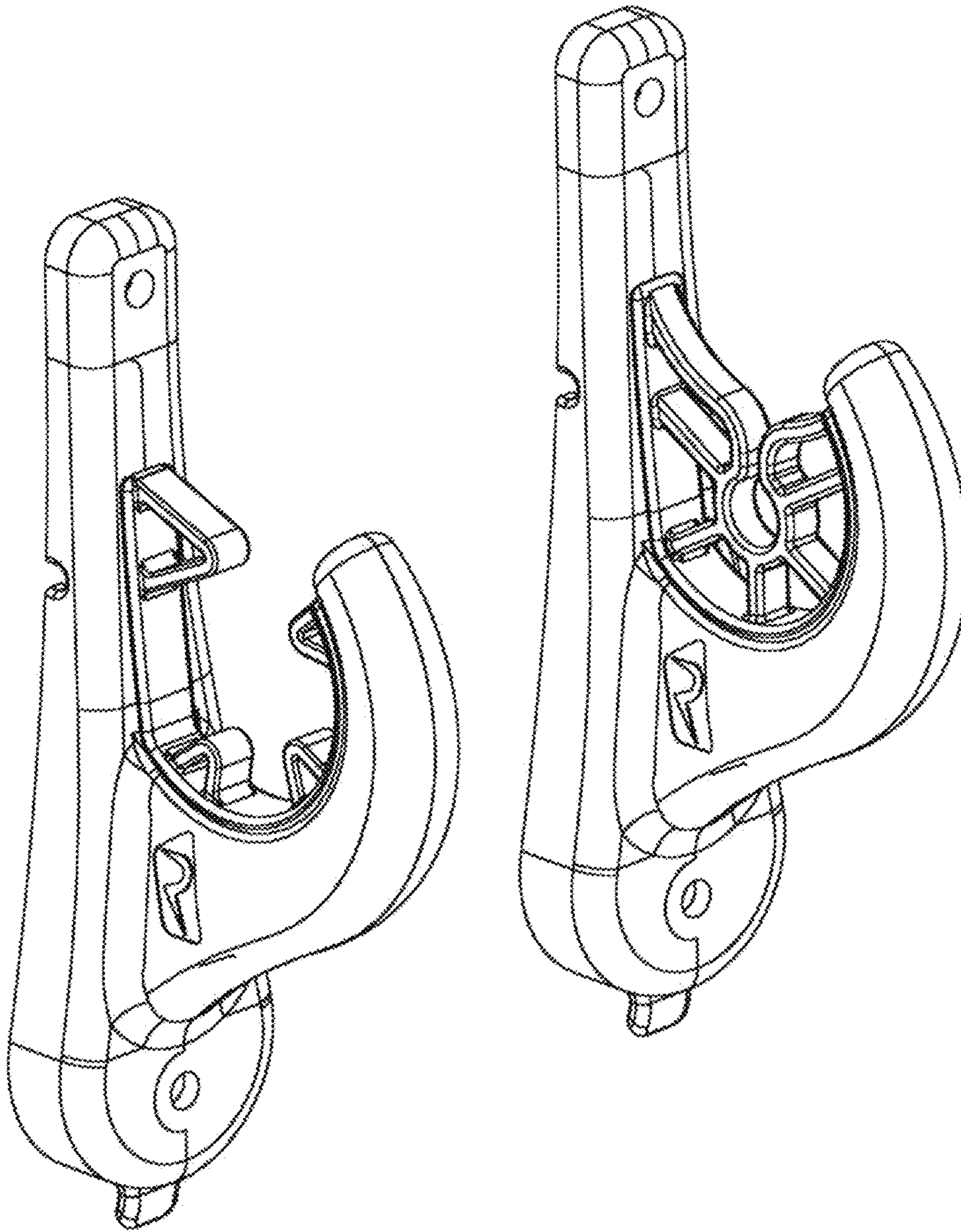

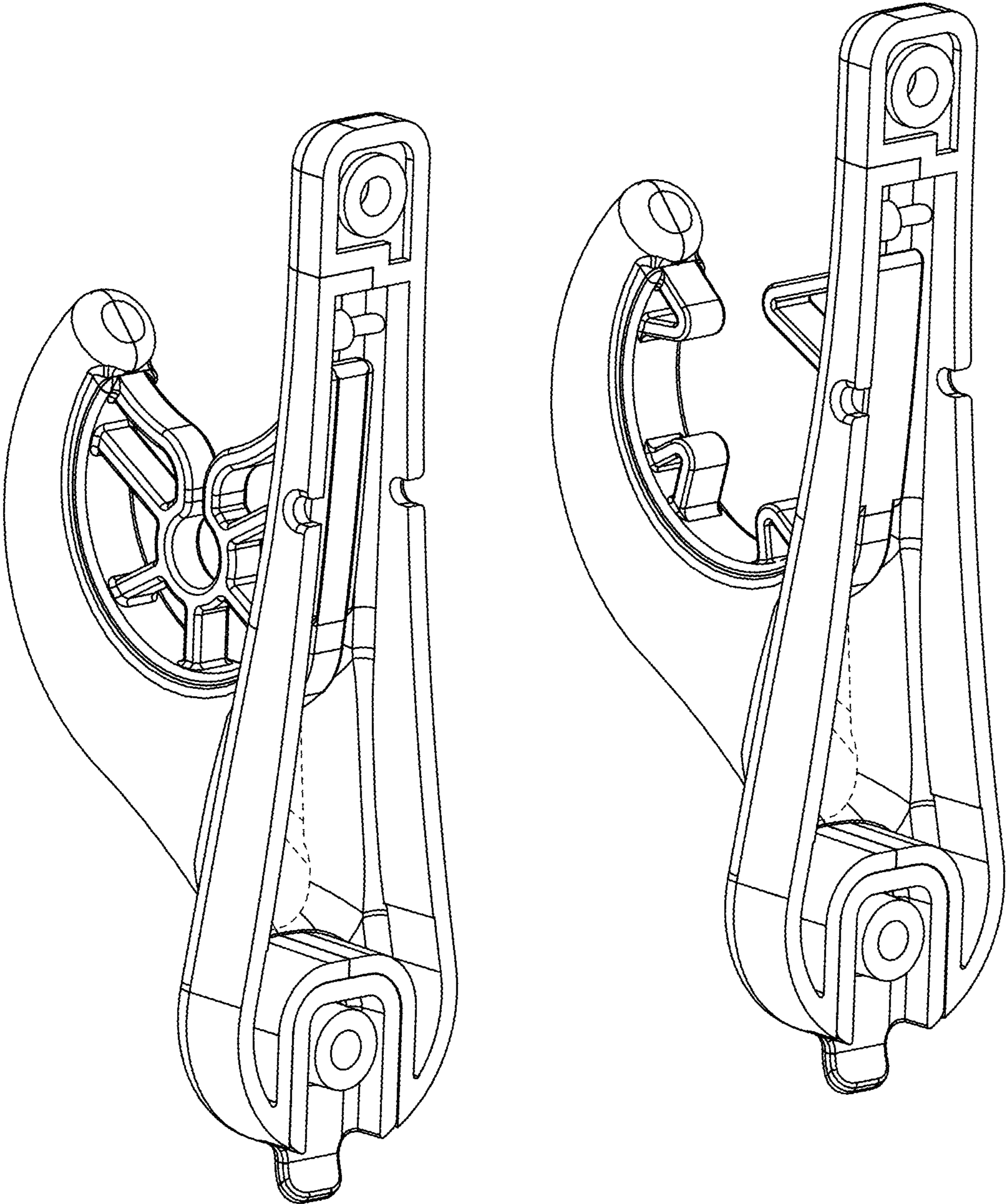

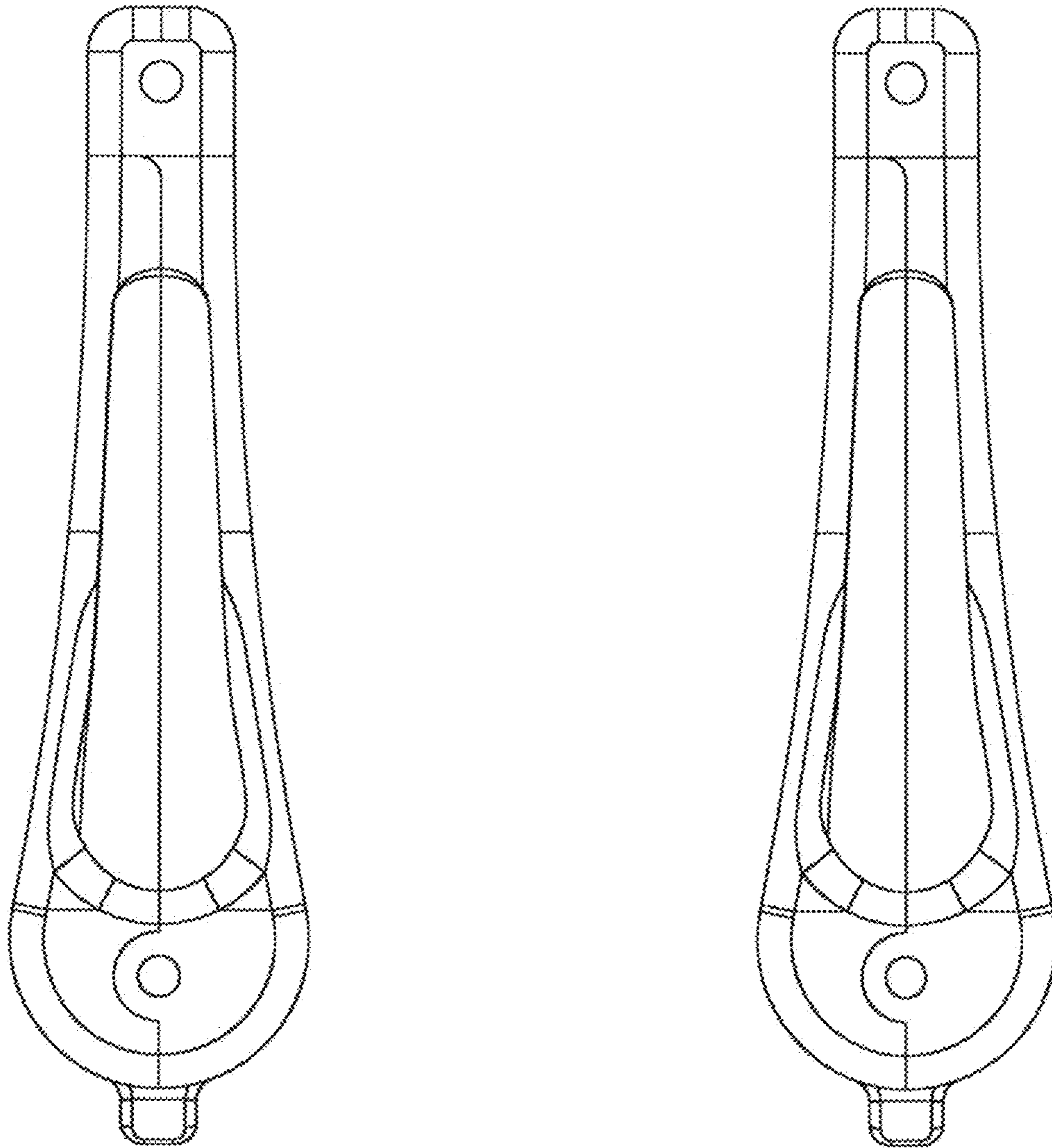

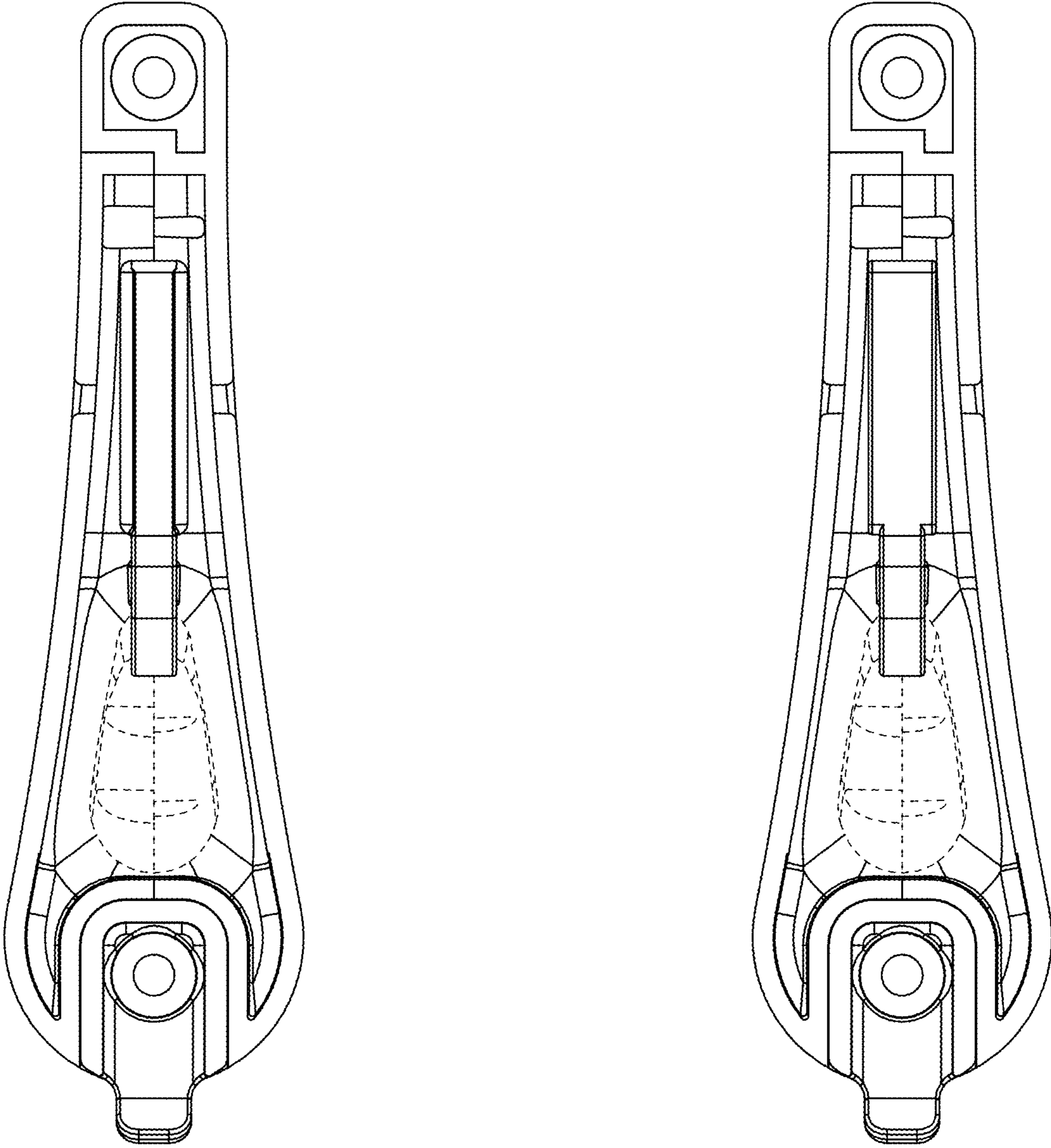

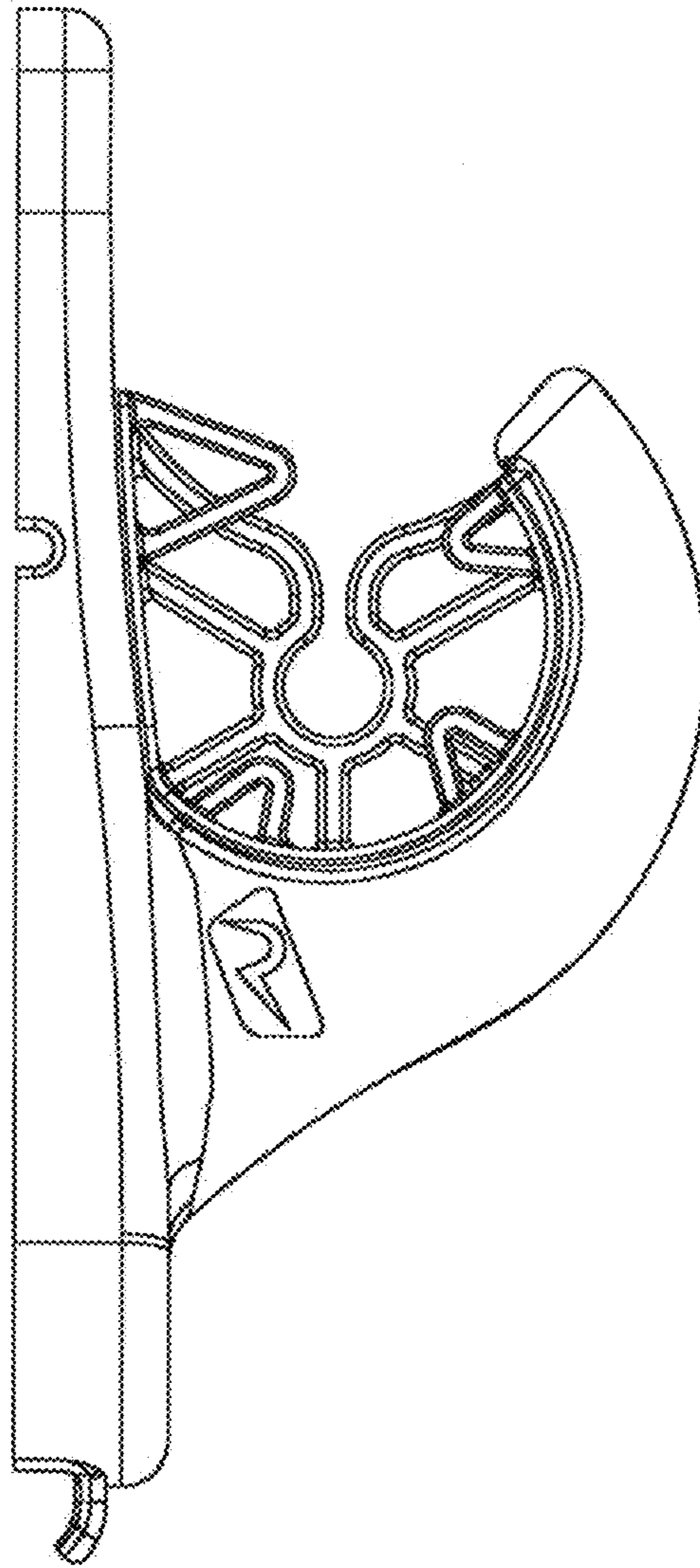

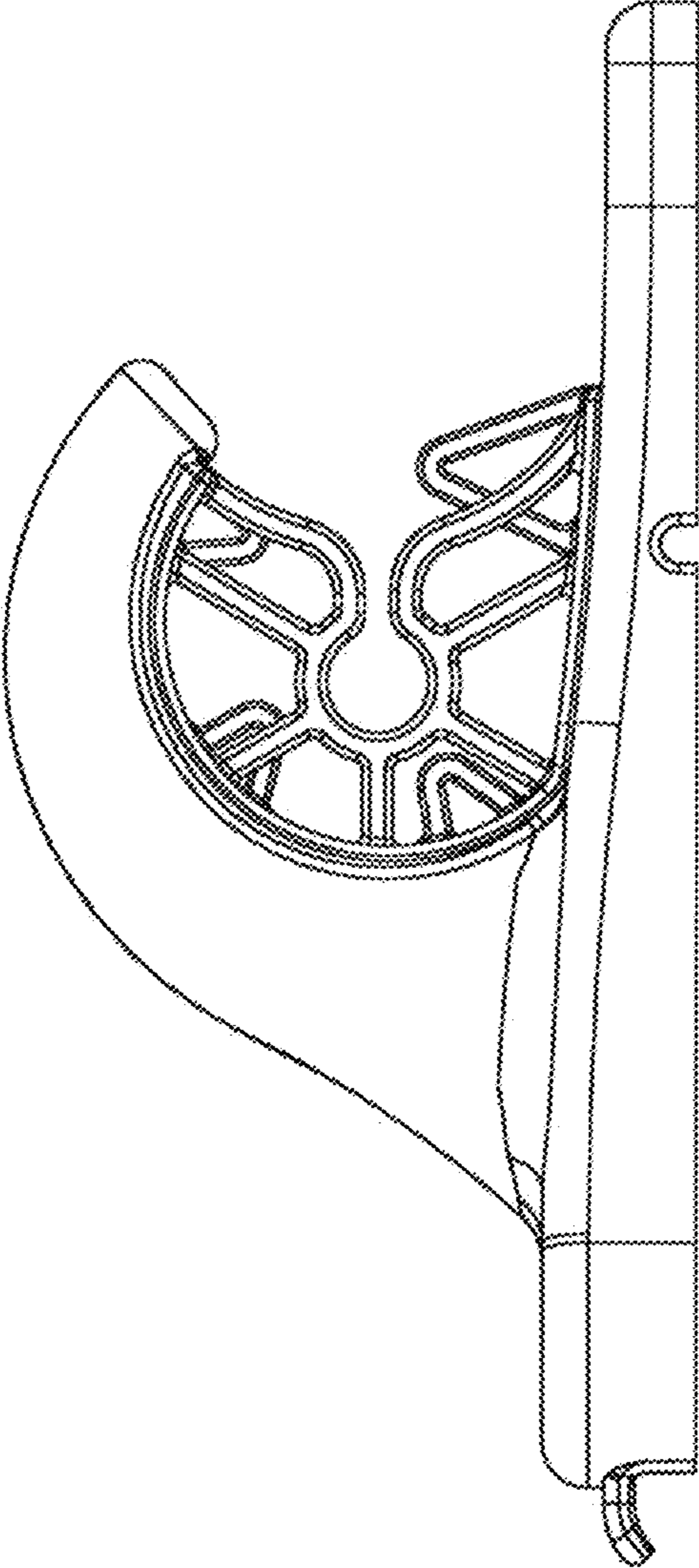

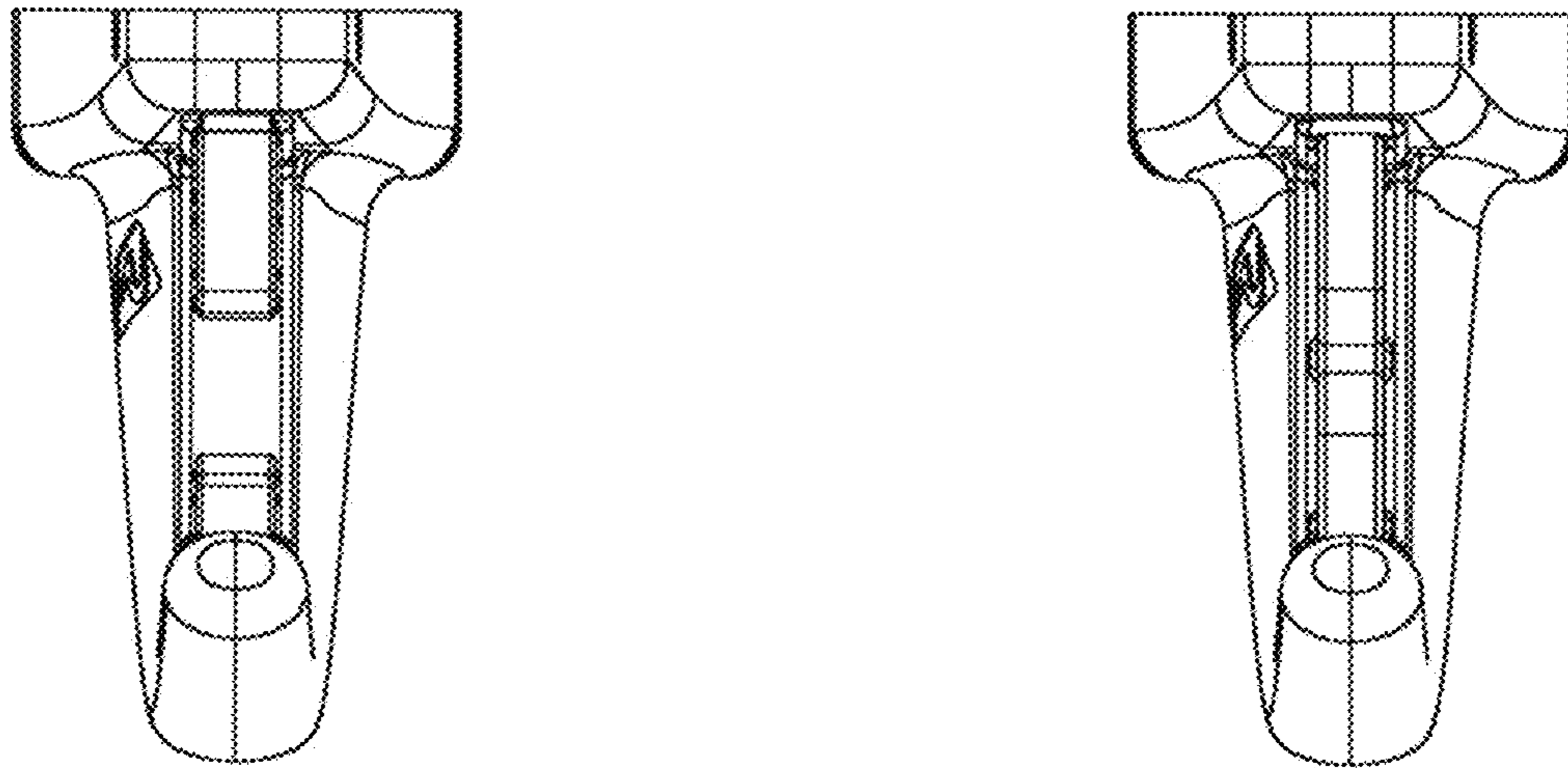

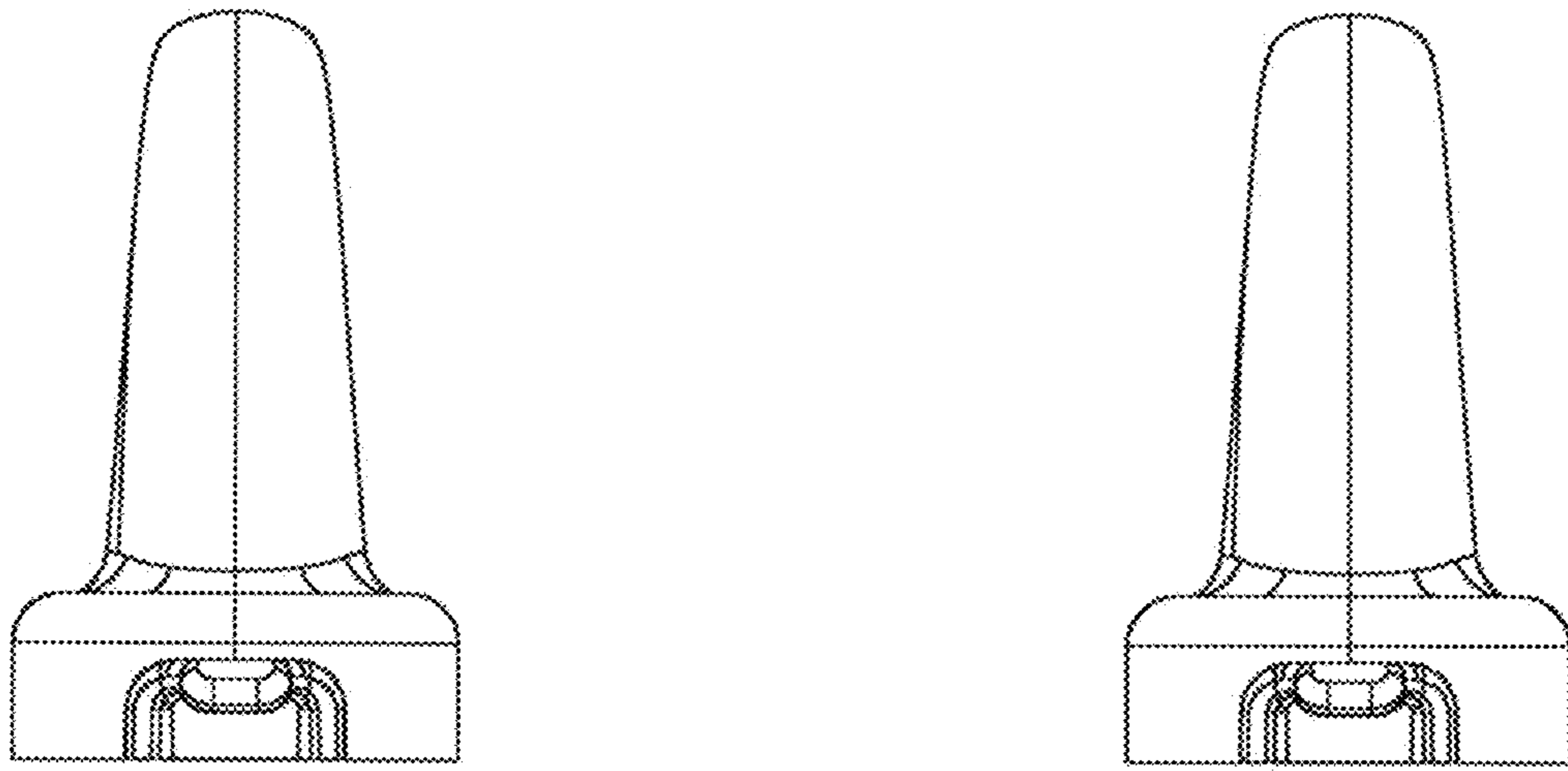
