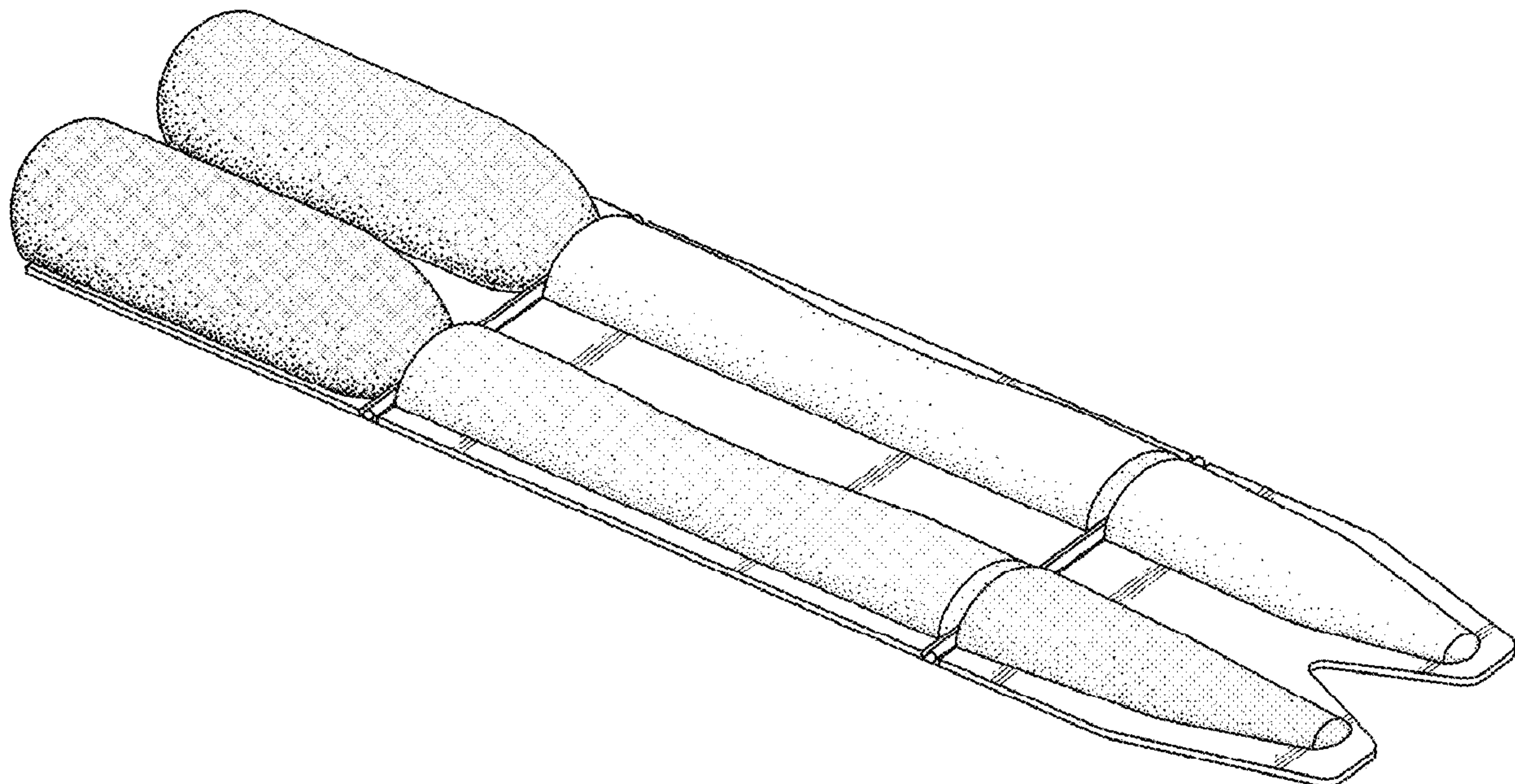
(57) **CLAIM**

The ornamental design for a back and headrest cushion assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the back and headrest cushion assembly;

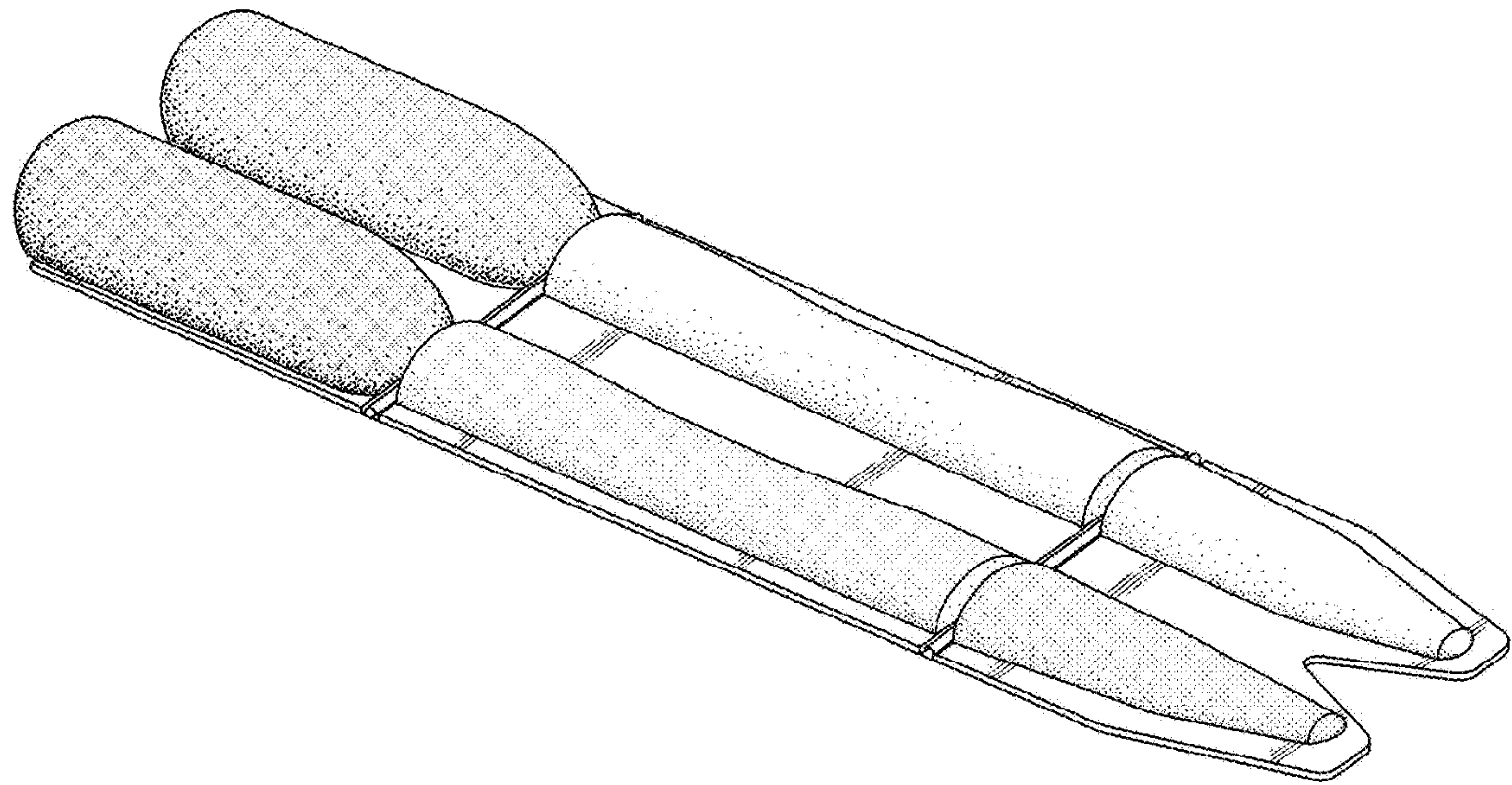

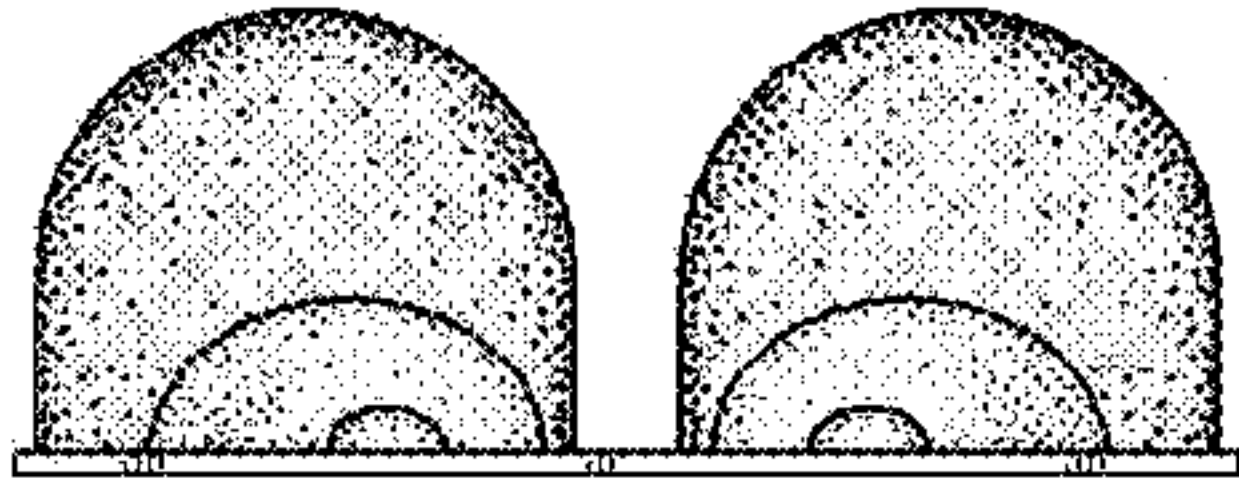

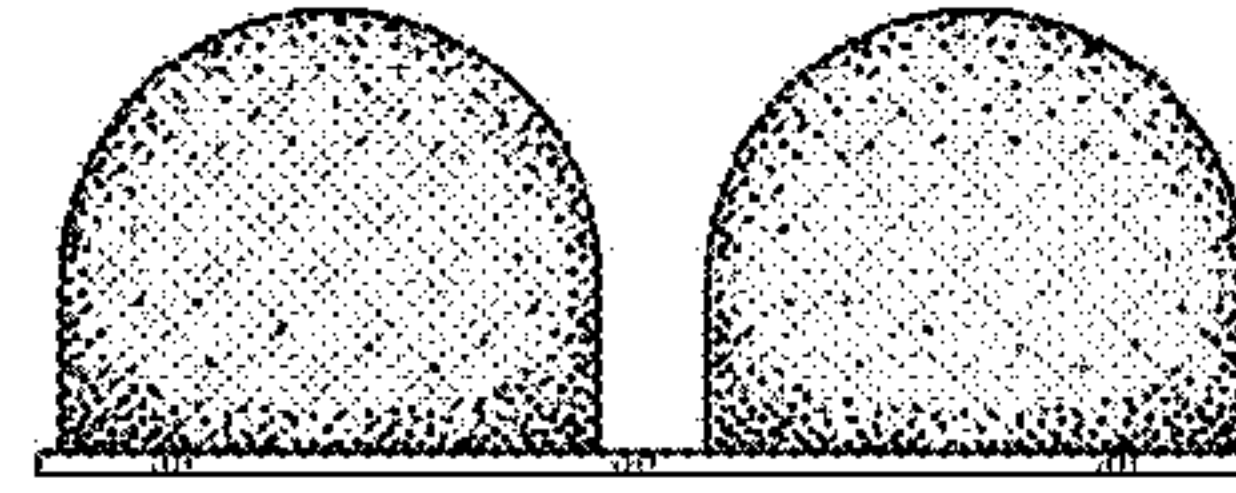

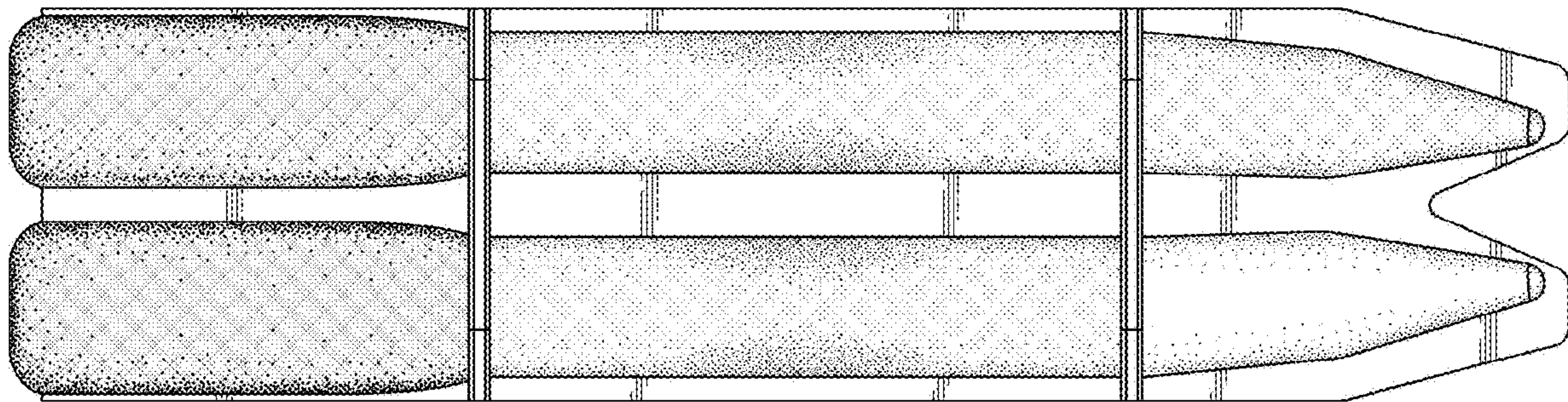

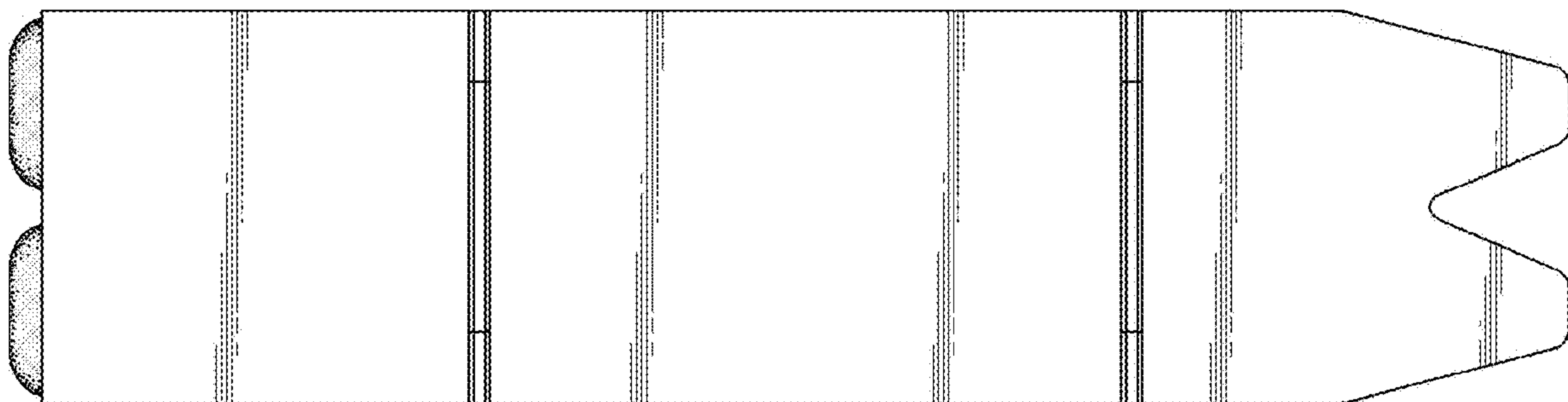

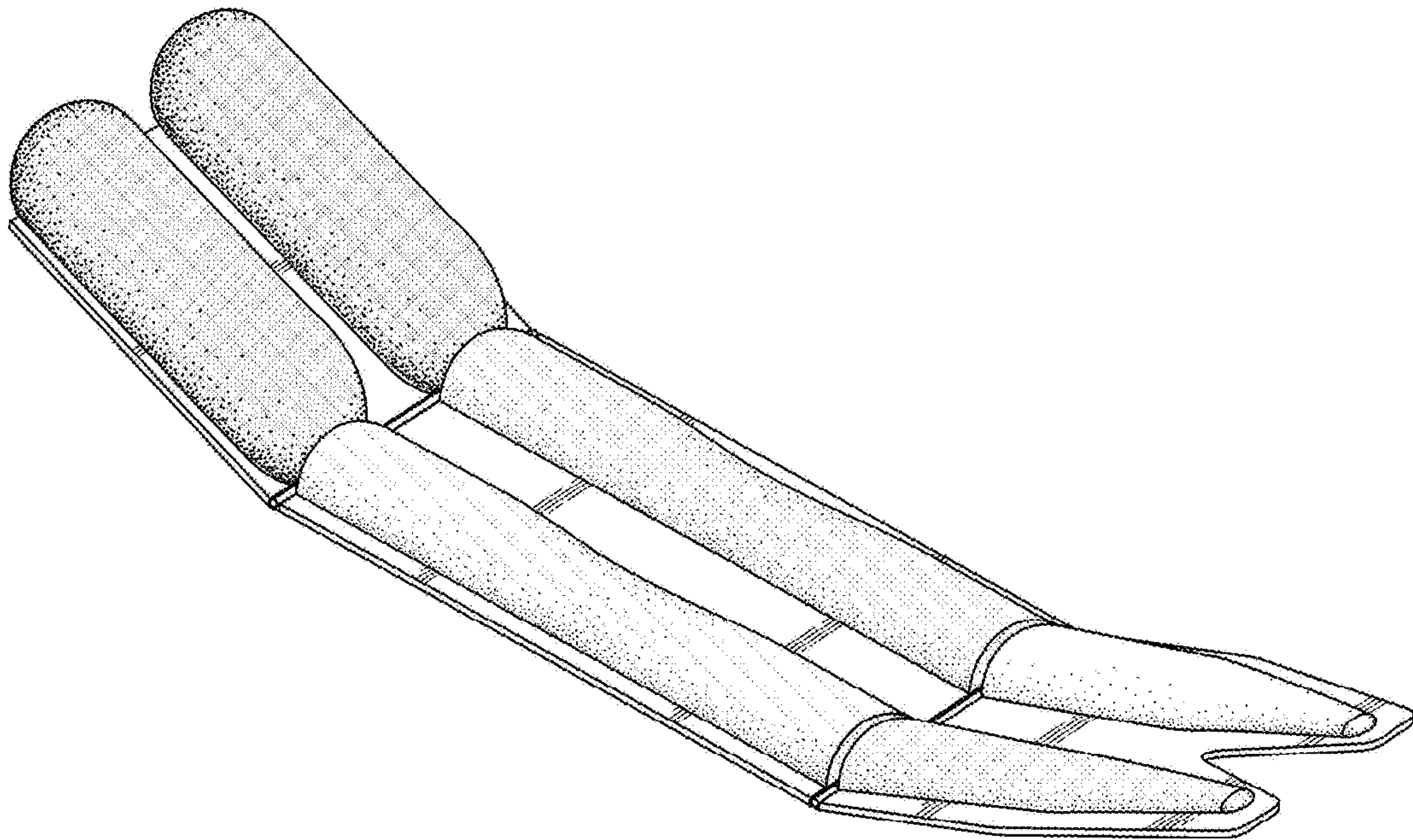
