The ornamental design for a knife, as shown and described.

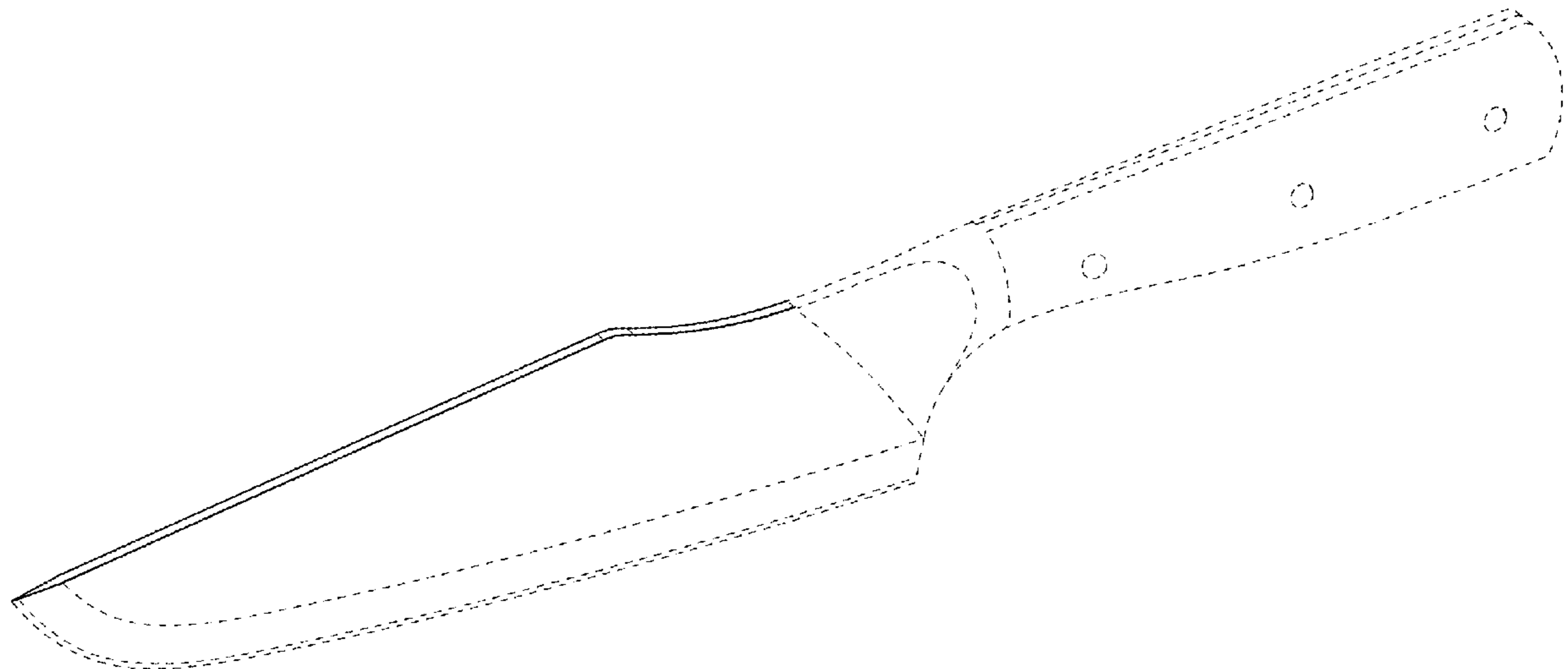
DESCRIPTION

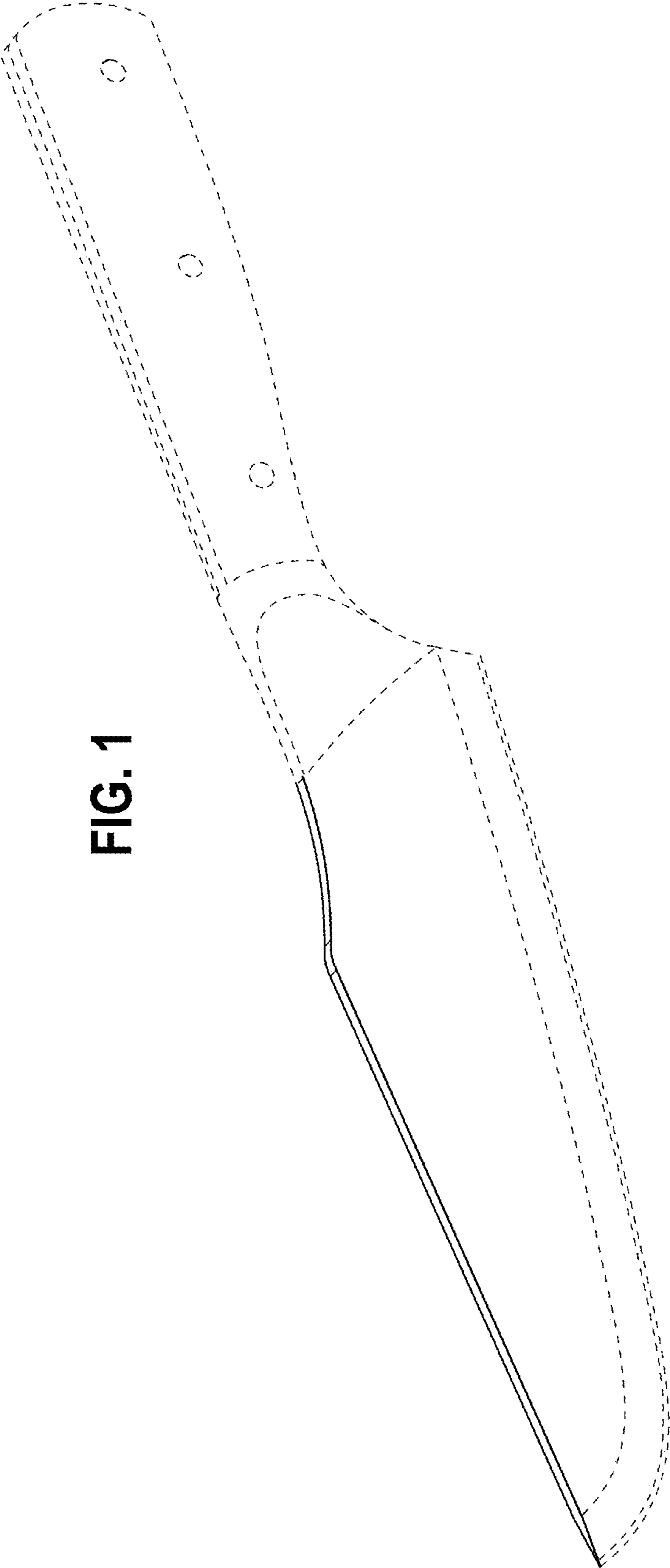

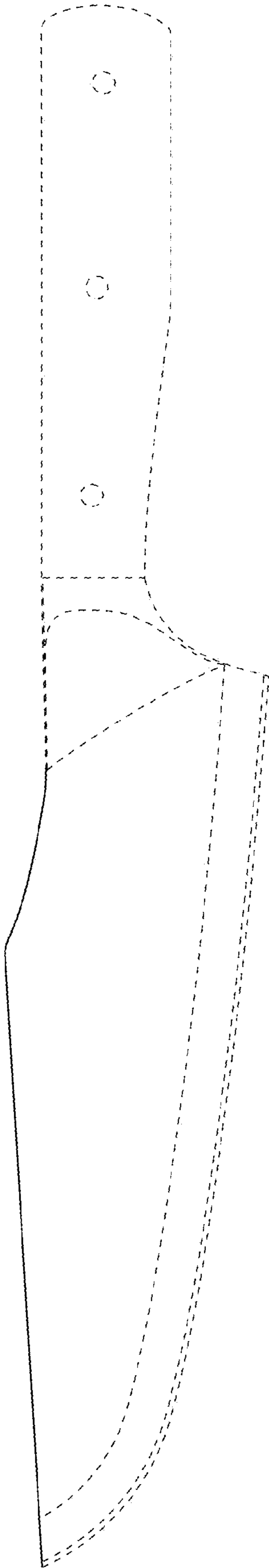

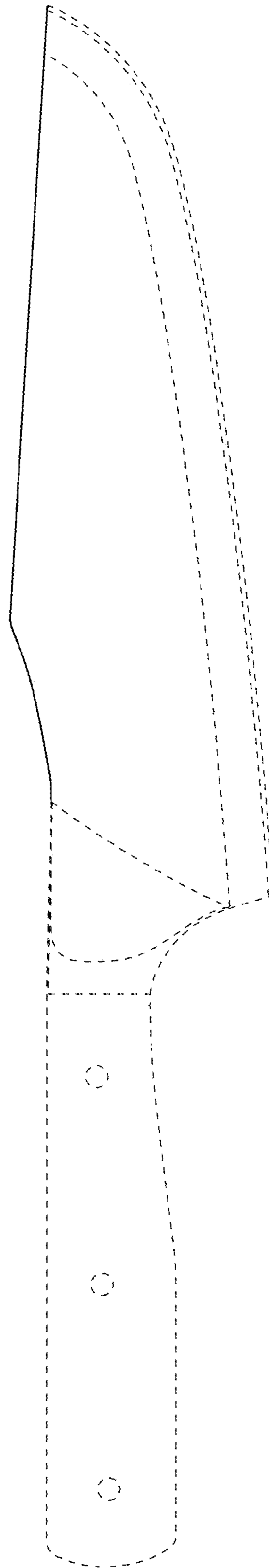

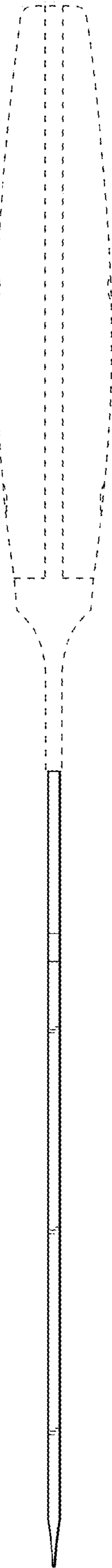

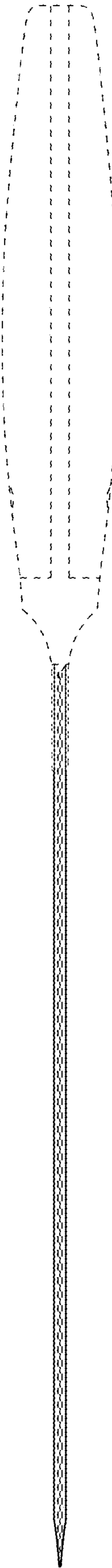

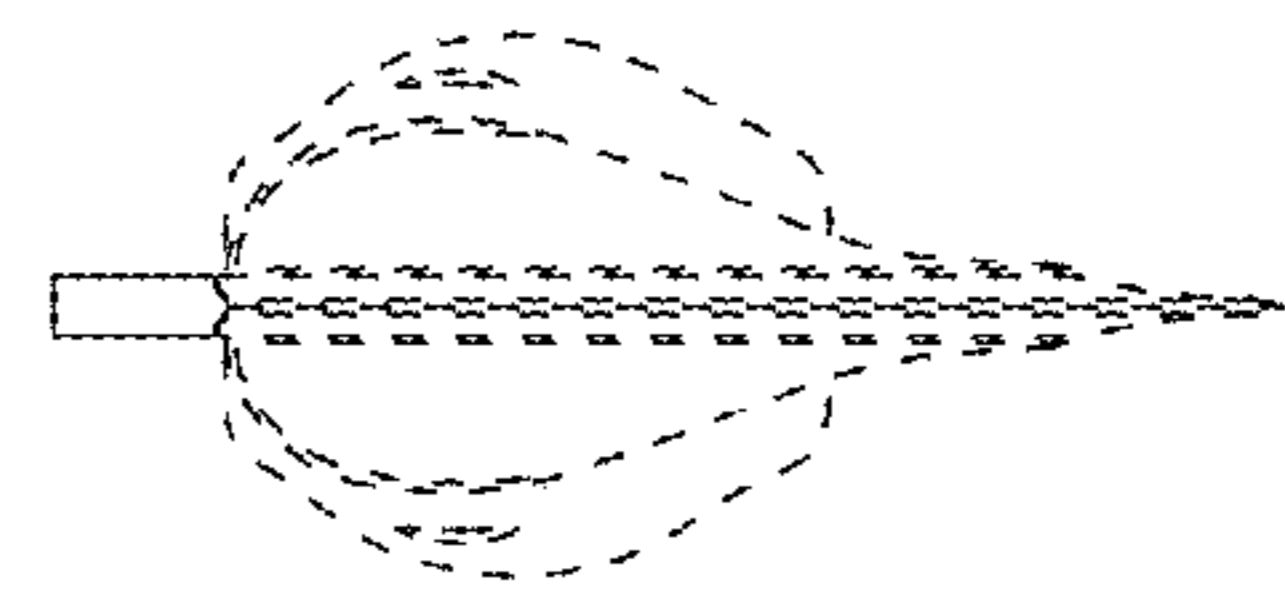
