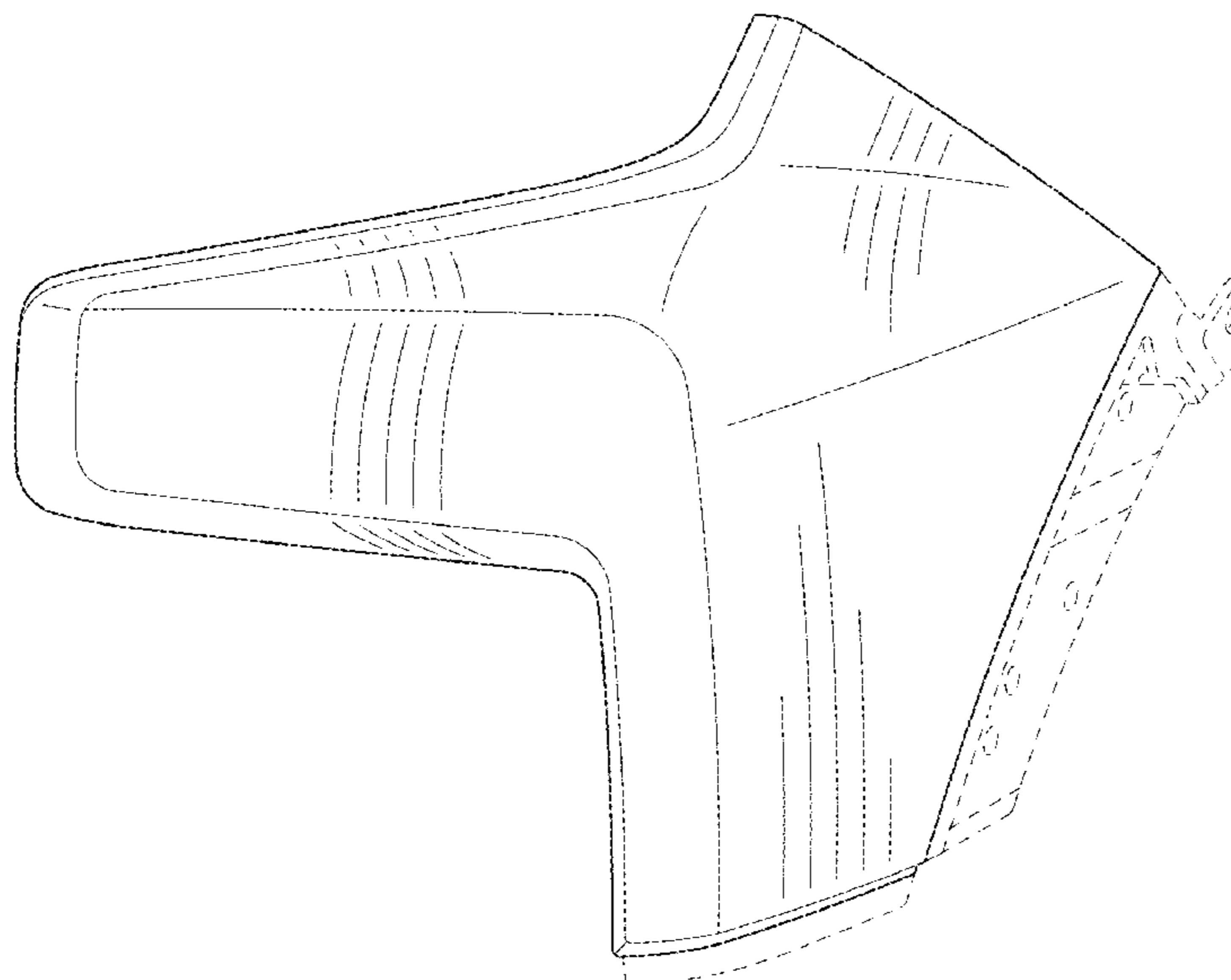
(57) **CLAIM**

The ornamental design for a vehicle front fender segment, as shown and described.

DESCRIPTION

FIG. 1 is a front and right perspective view of a vehicle front fender segment showing my new design; the mirror image of the vehicle front fender segment is claimed, but not shown; FIG. 2 is a front elevation view of the vehicle front fender segment of FIG. 1; FIG. 3 is a left elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a top view thereof; FIG. 6 is a back elevation view thereof; and, FIG. 7 is a bottom view thereof. The broken lines in the drawings depict portions of the vehicle front fender segment that form no part of the claimed design.

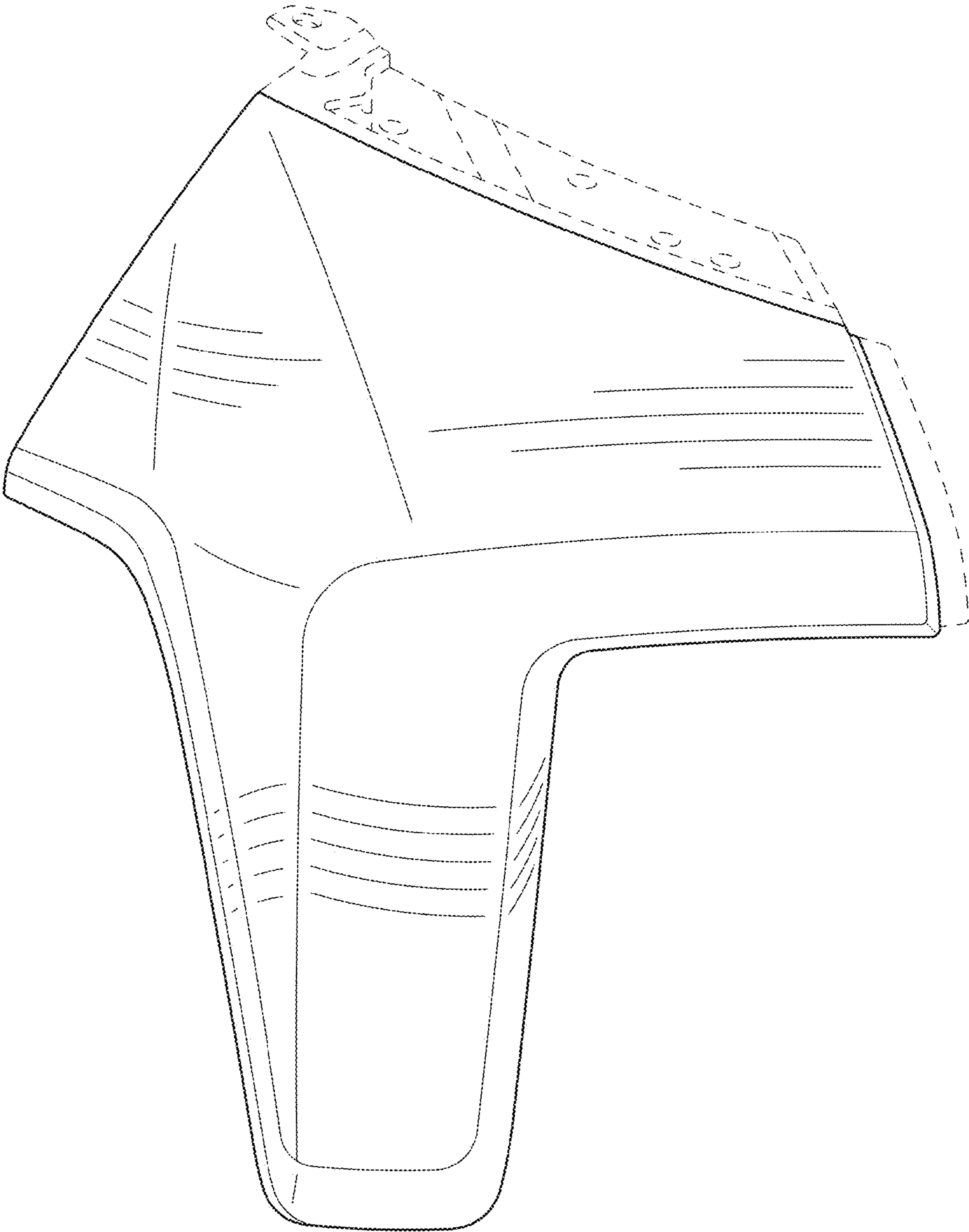

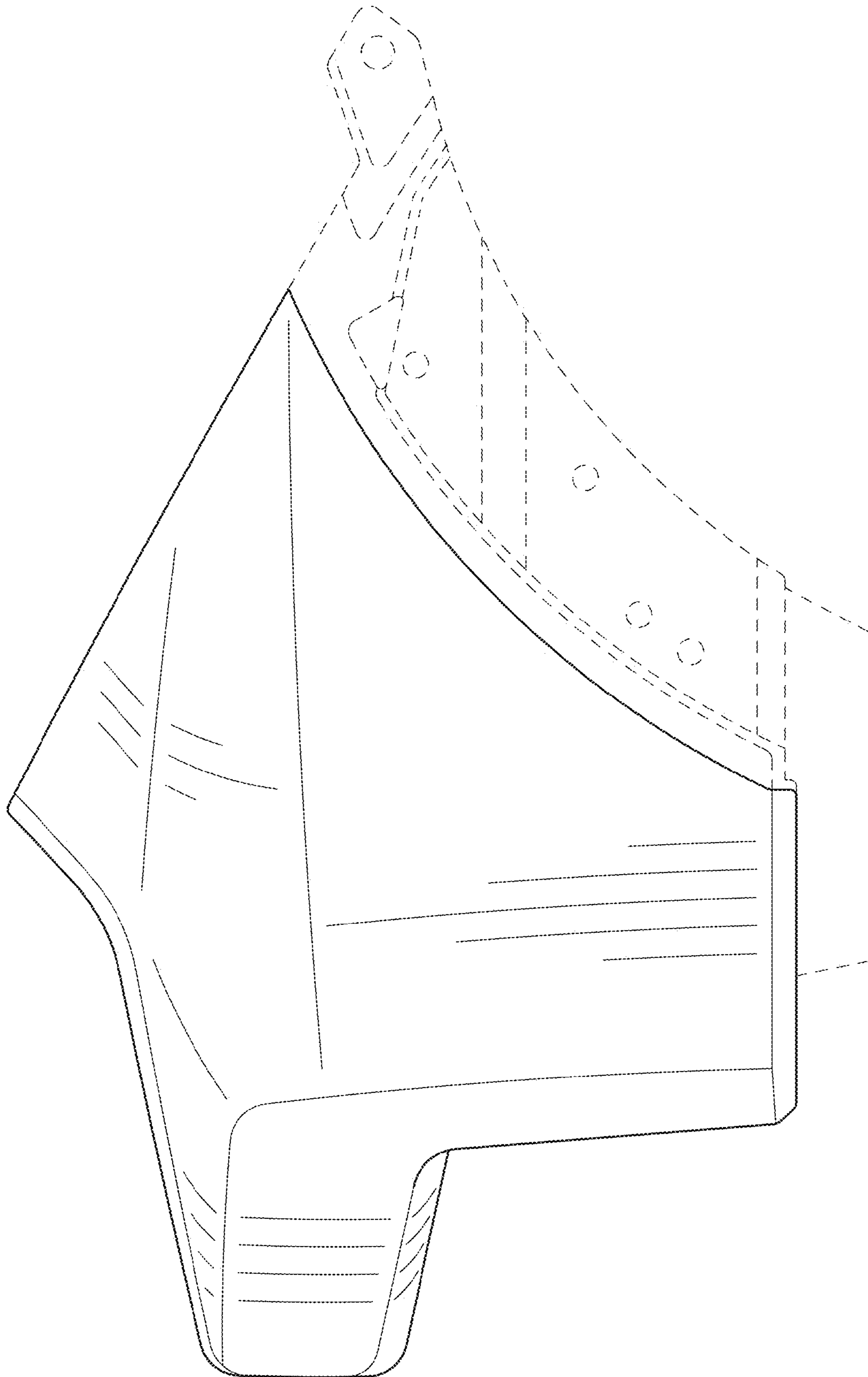

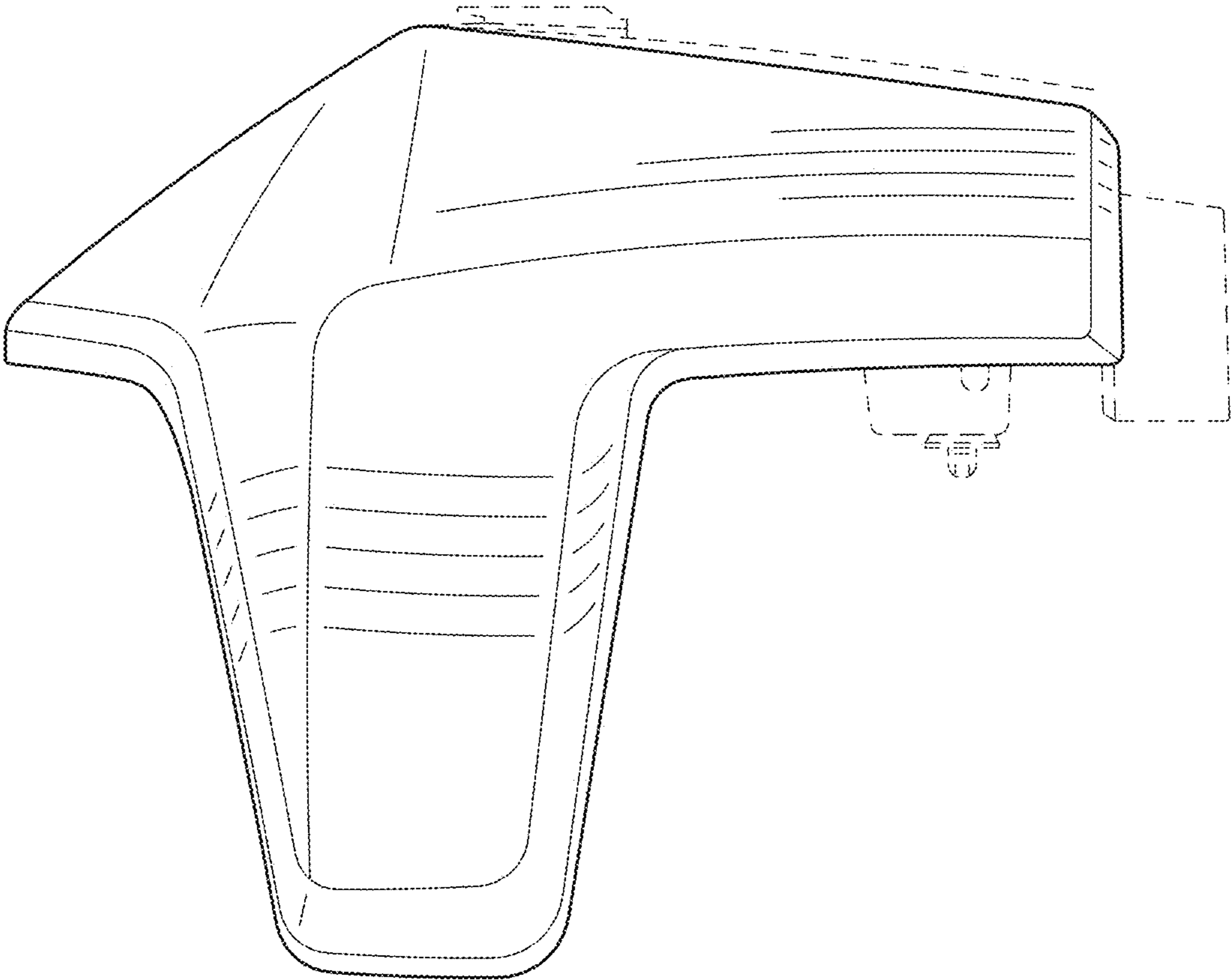

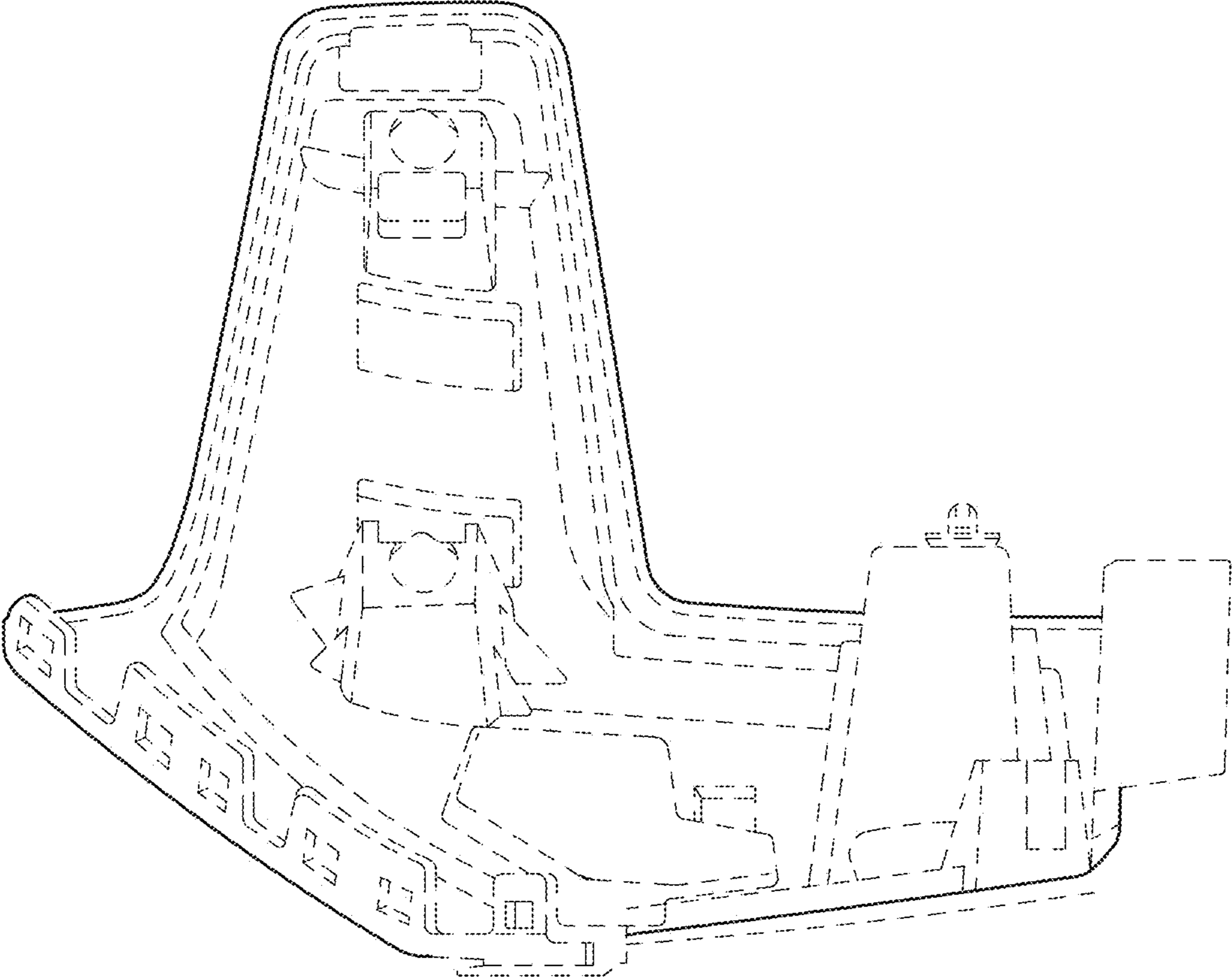

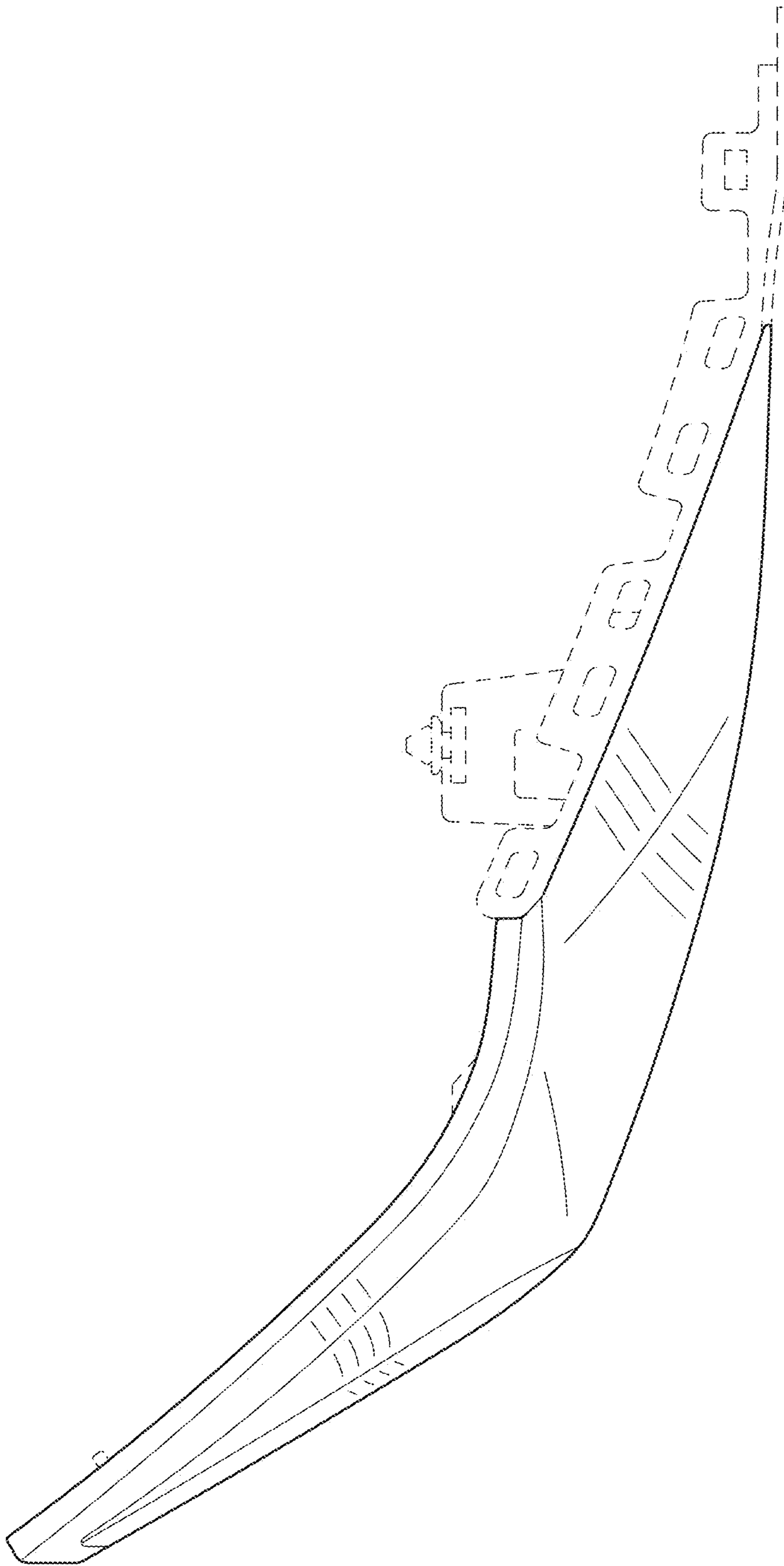

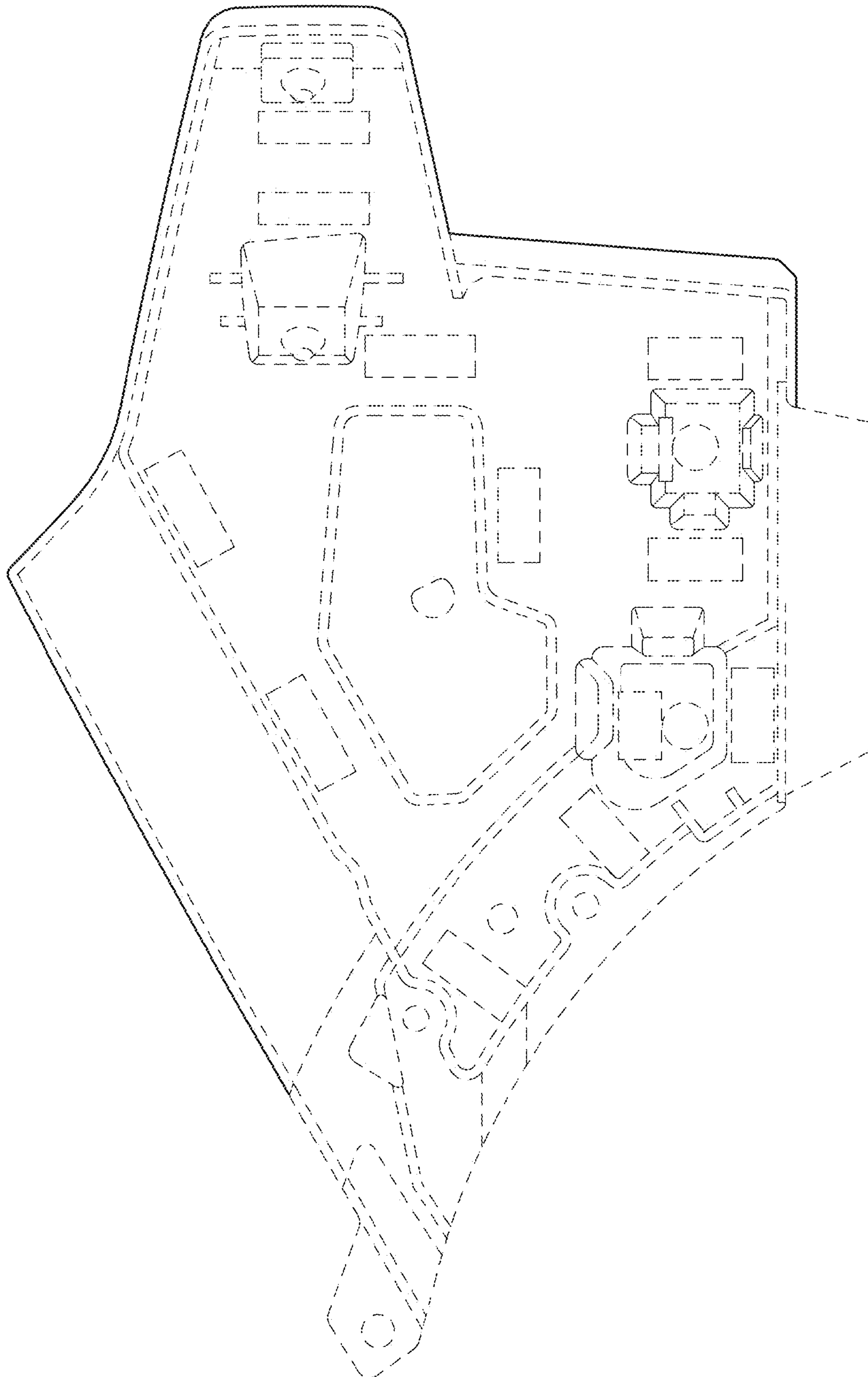

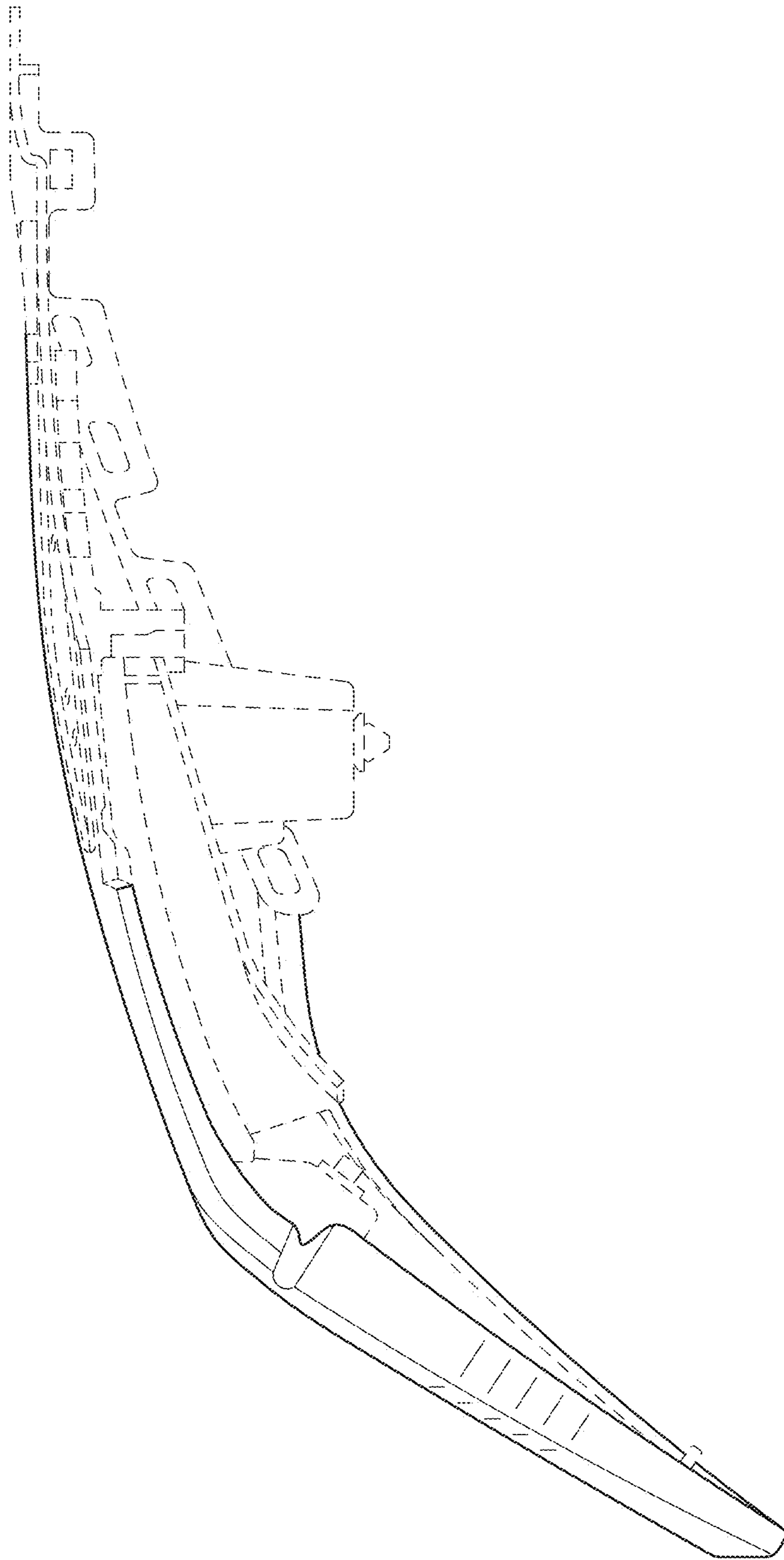
