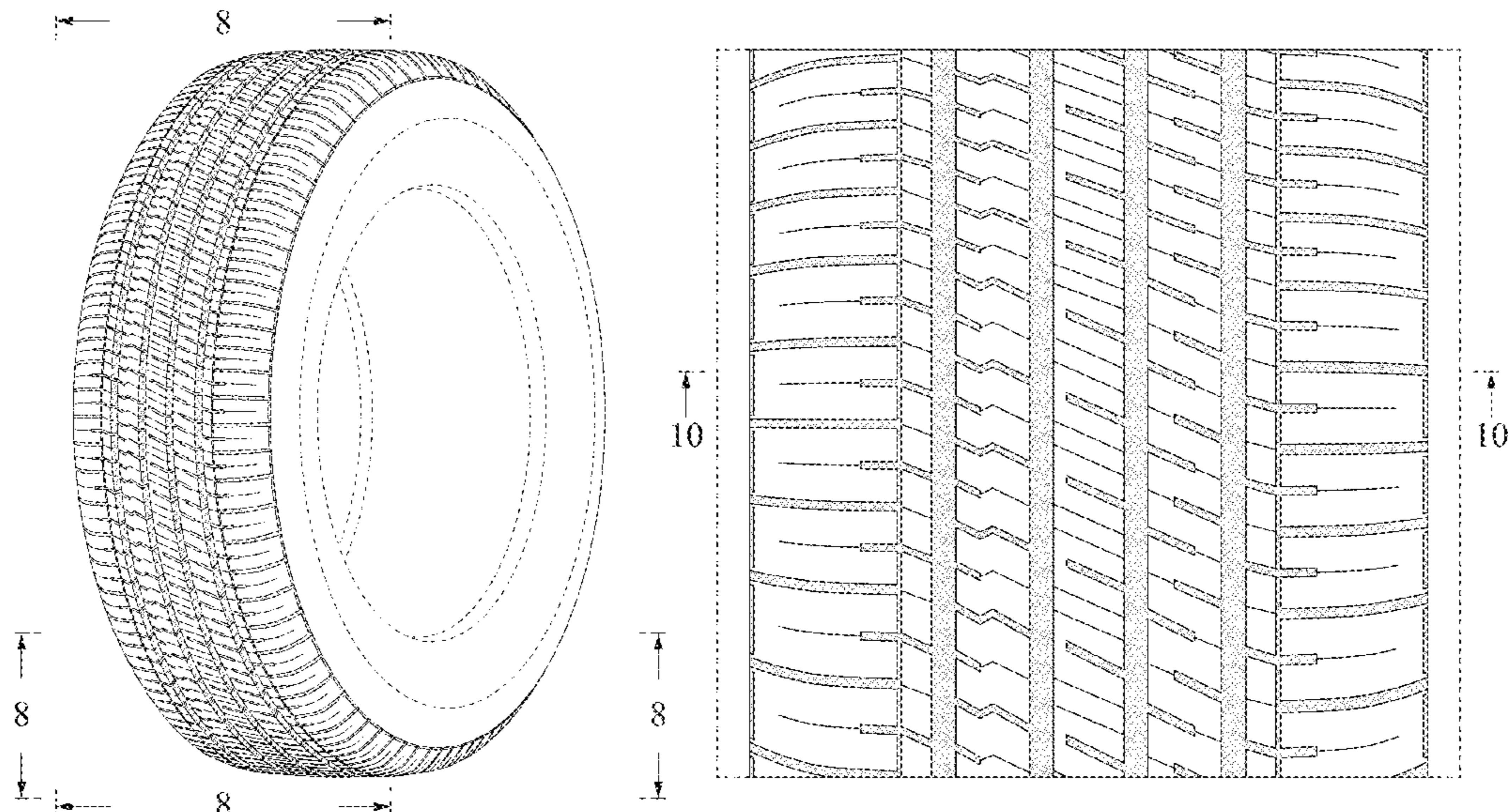

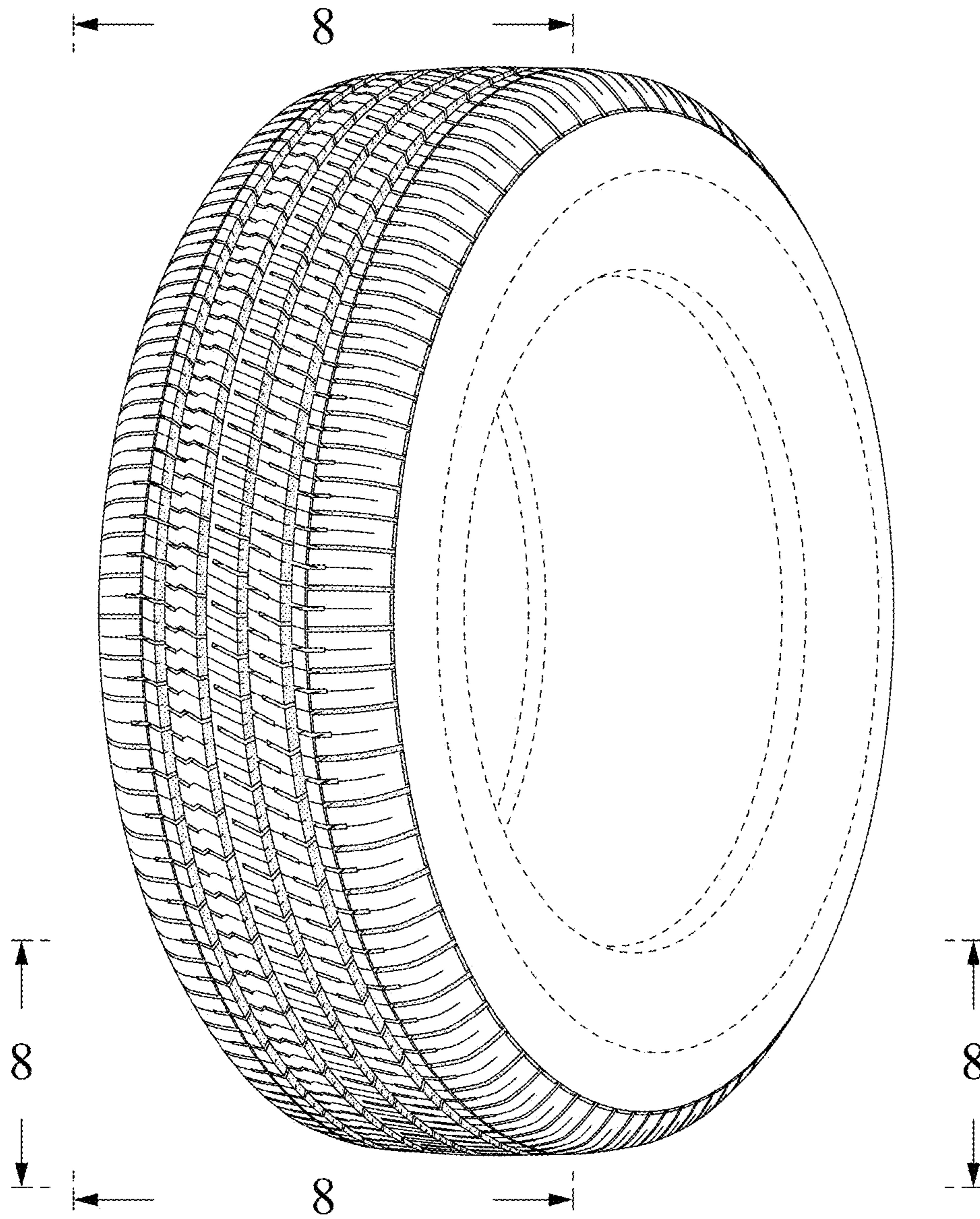
FIG. 1 is a perspective view of an automobile tire showing my design;

In the drawings, the broken lines depict environmental subject matter only and form no part of the claimed design.

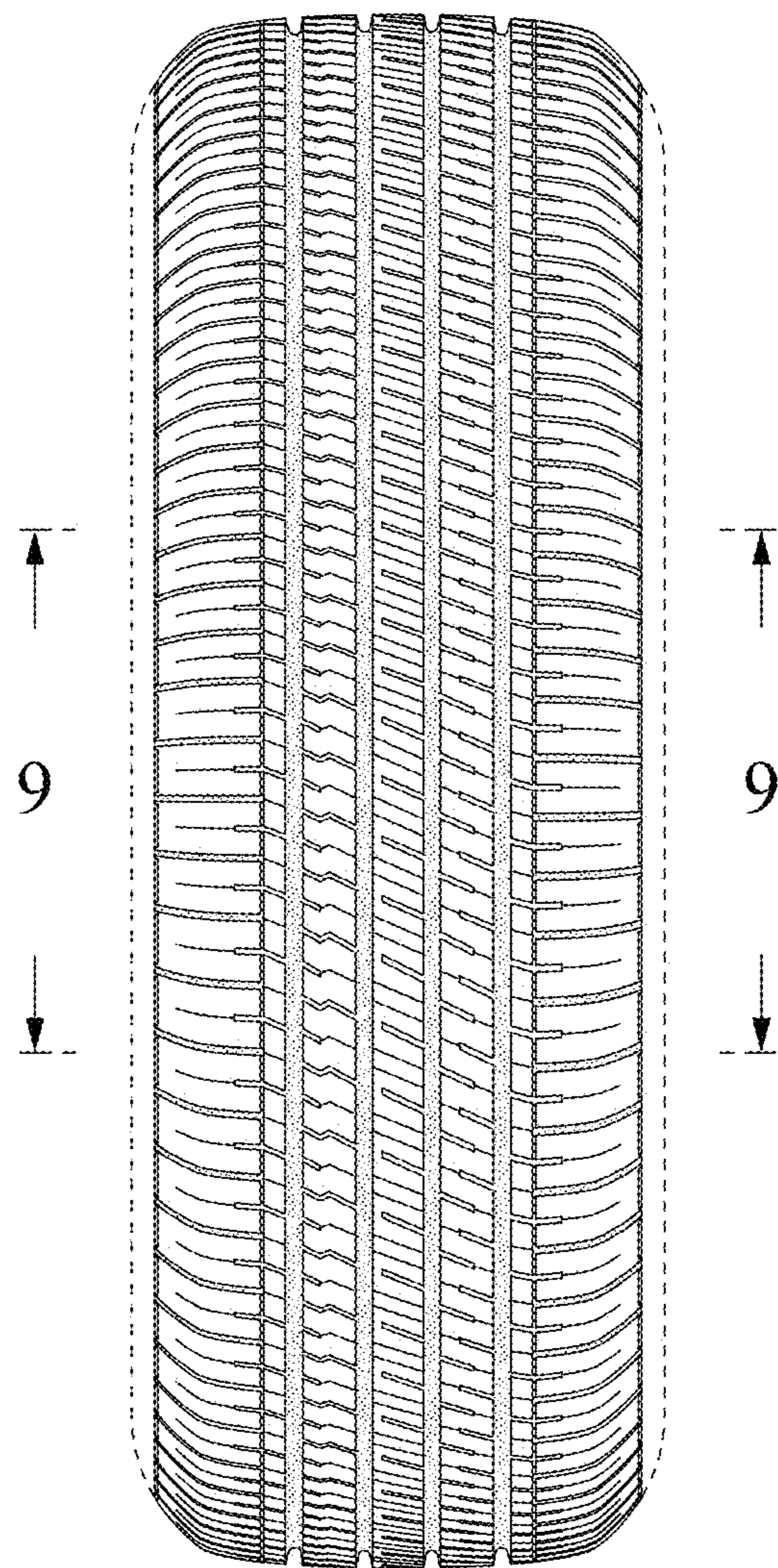

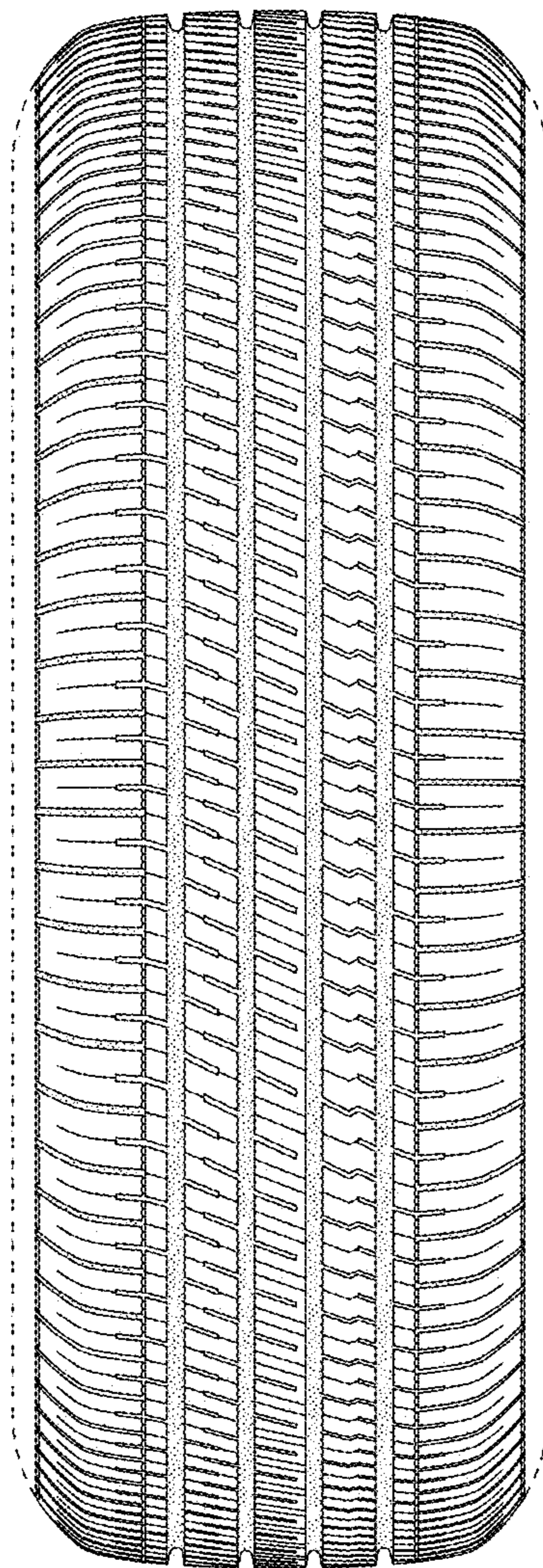

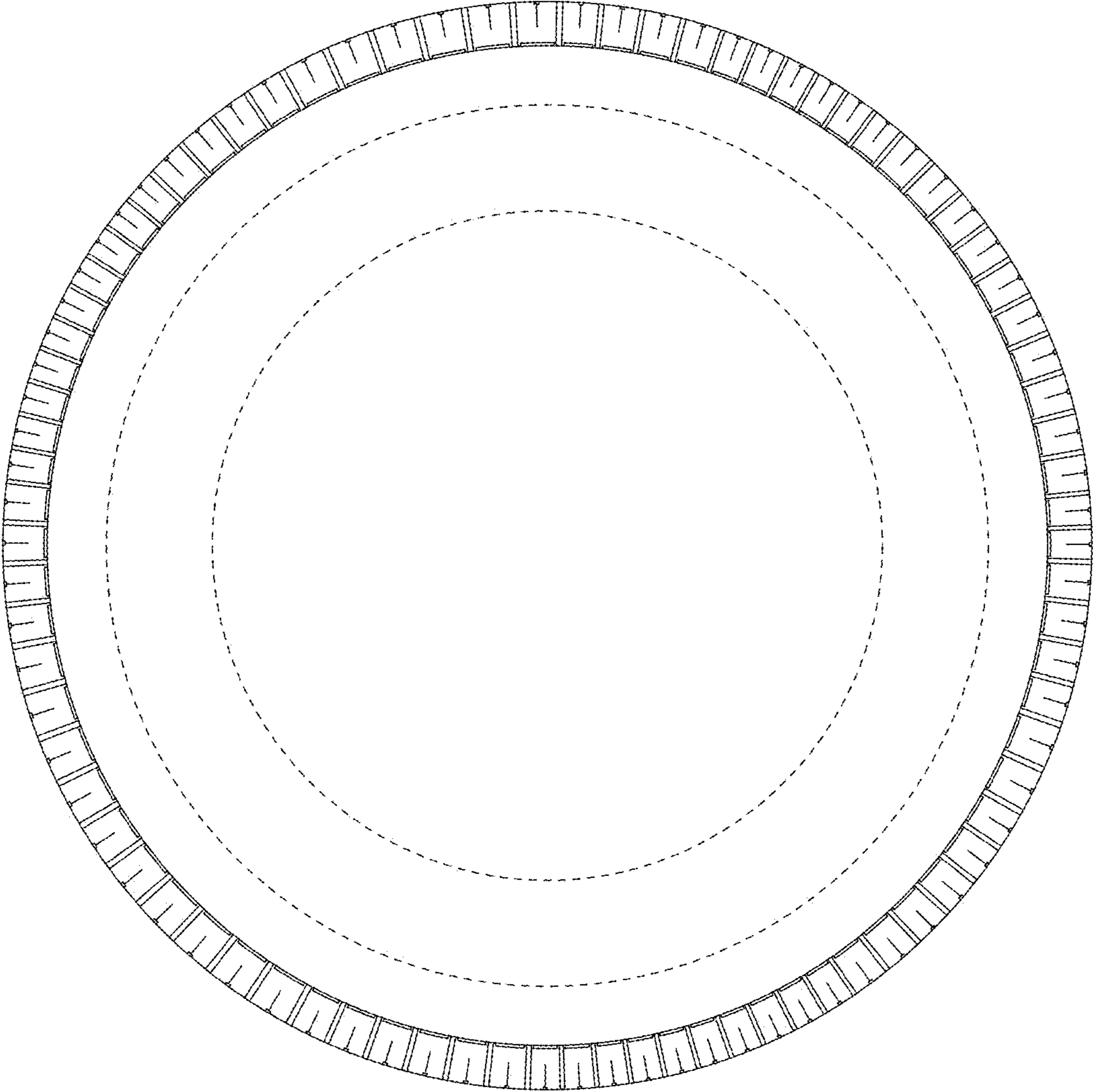

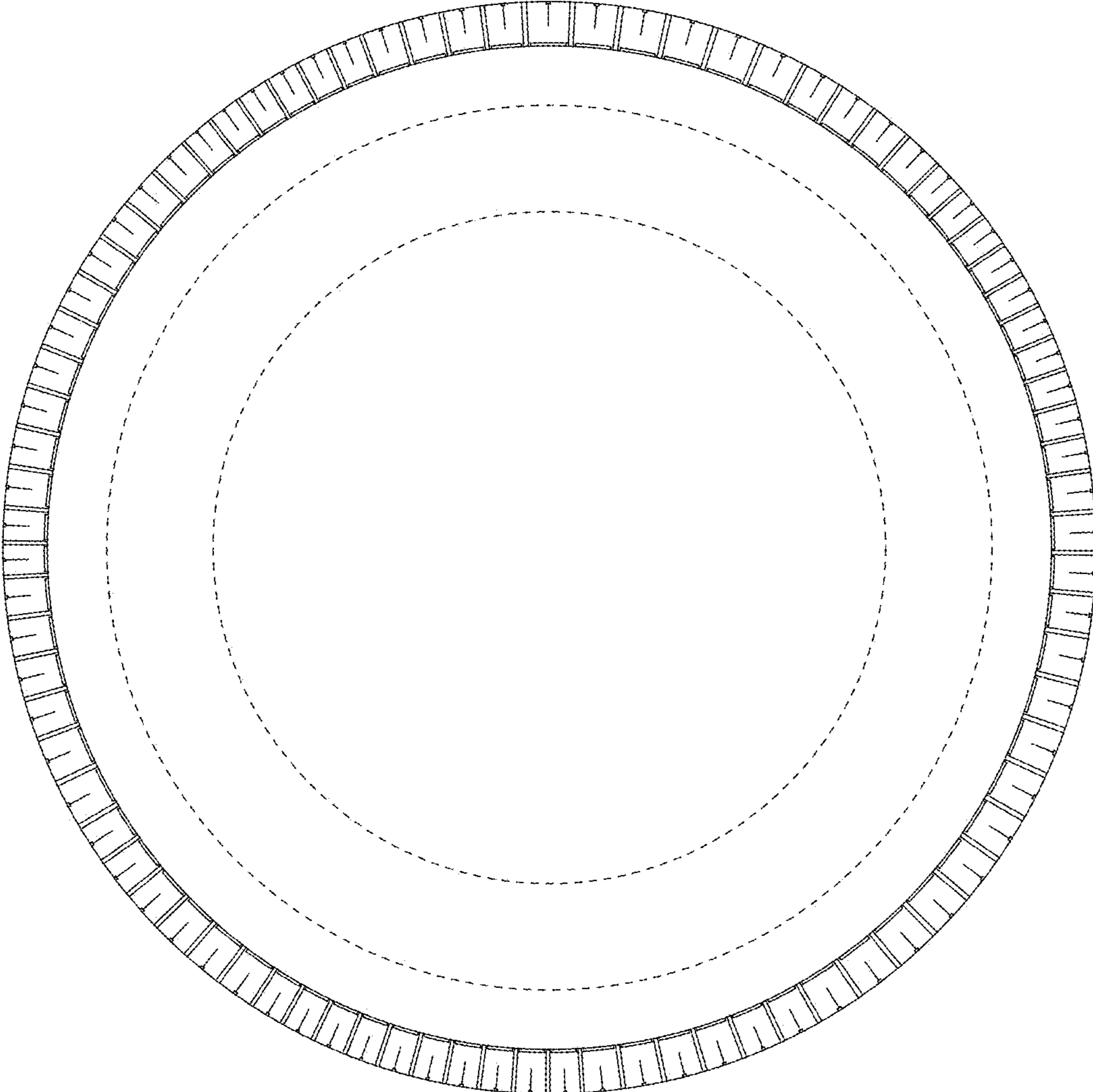

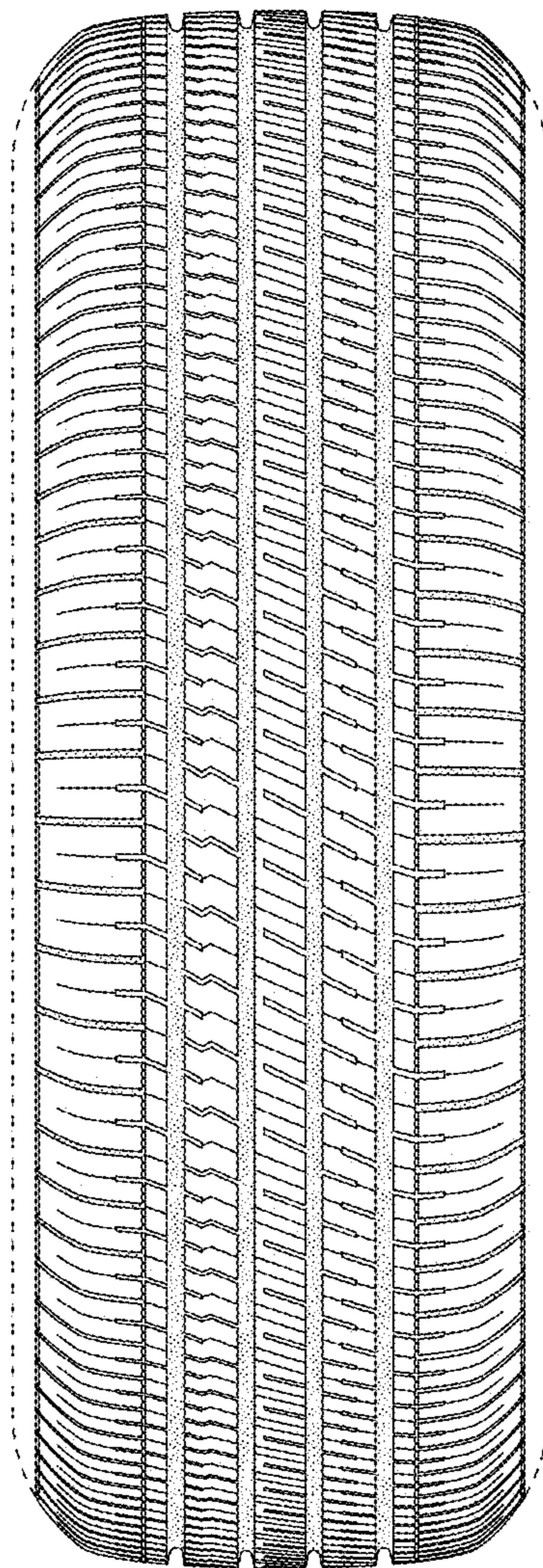

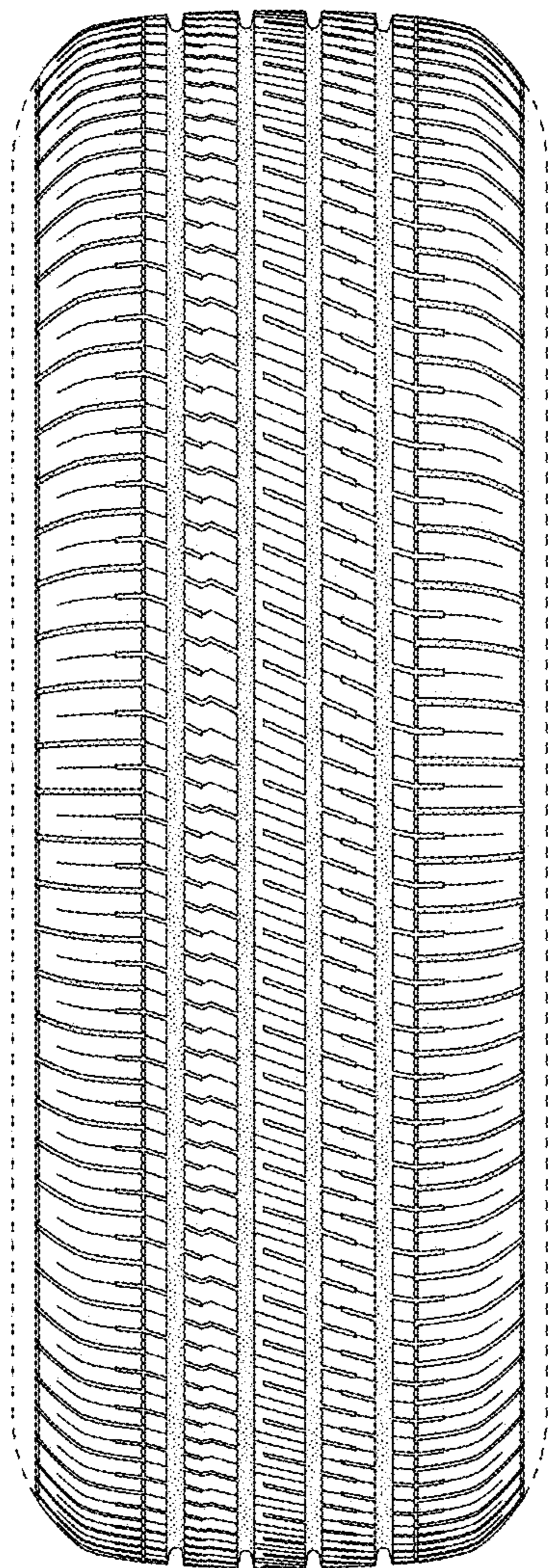

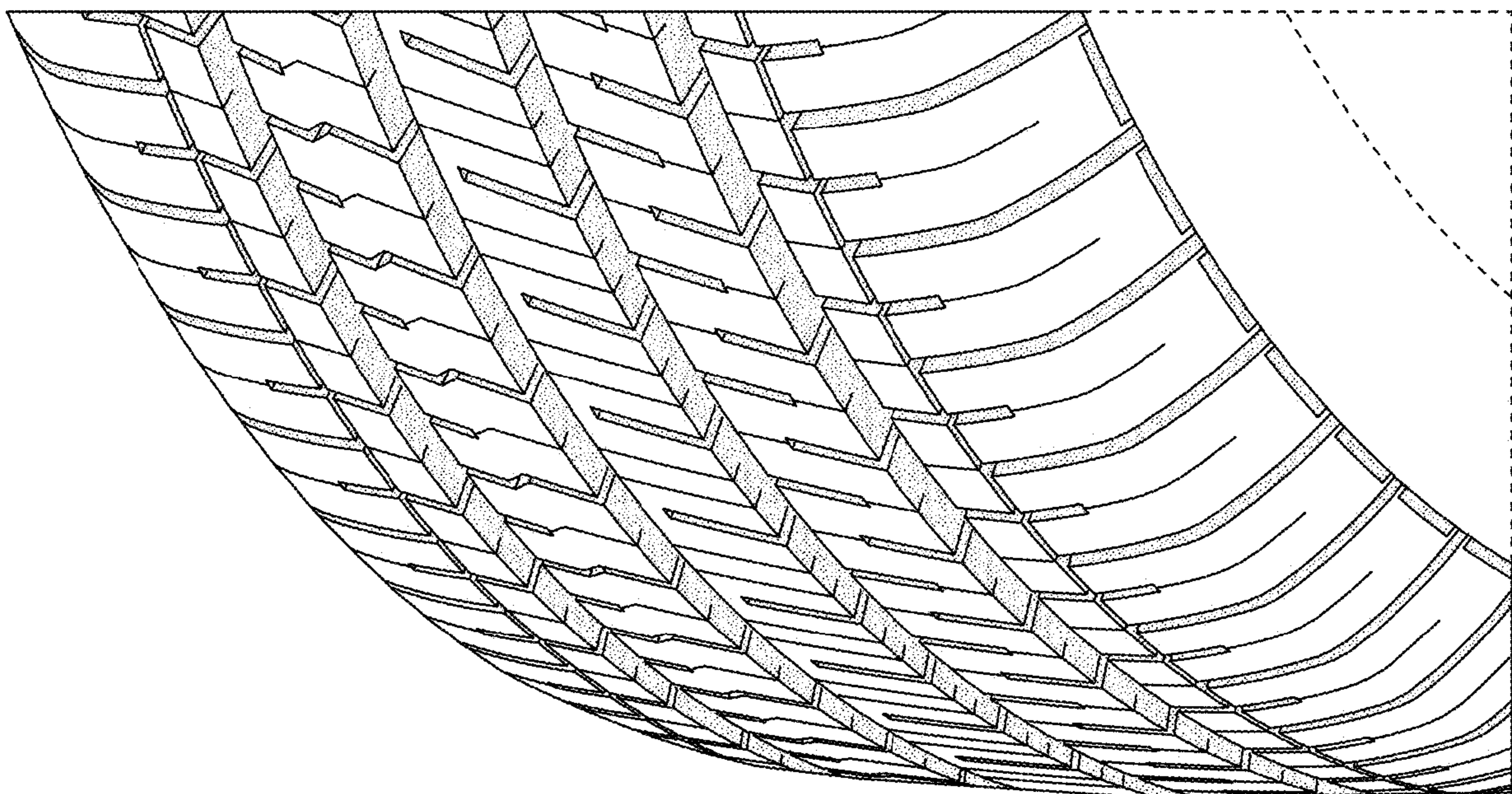
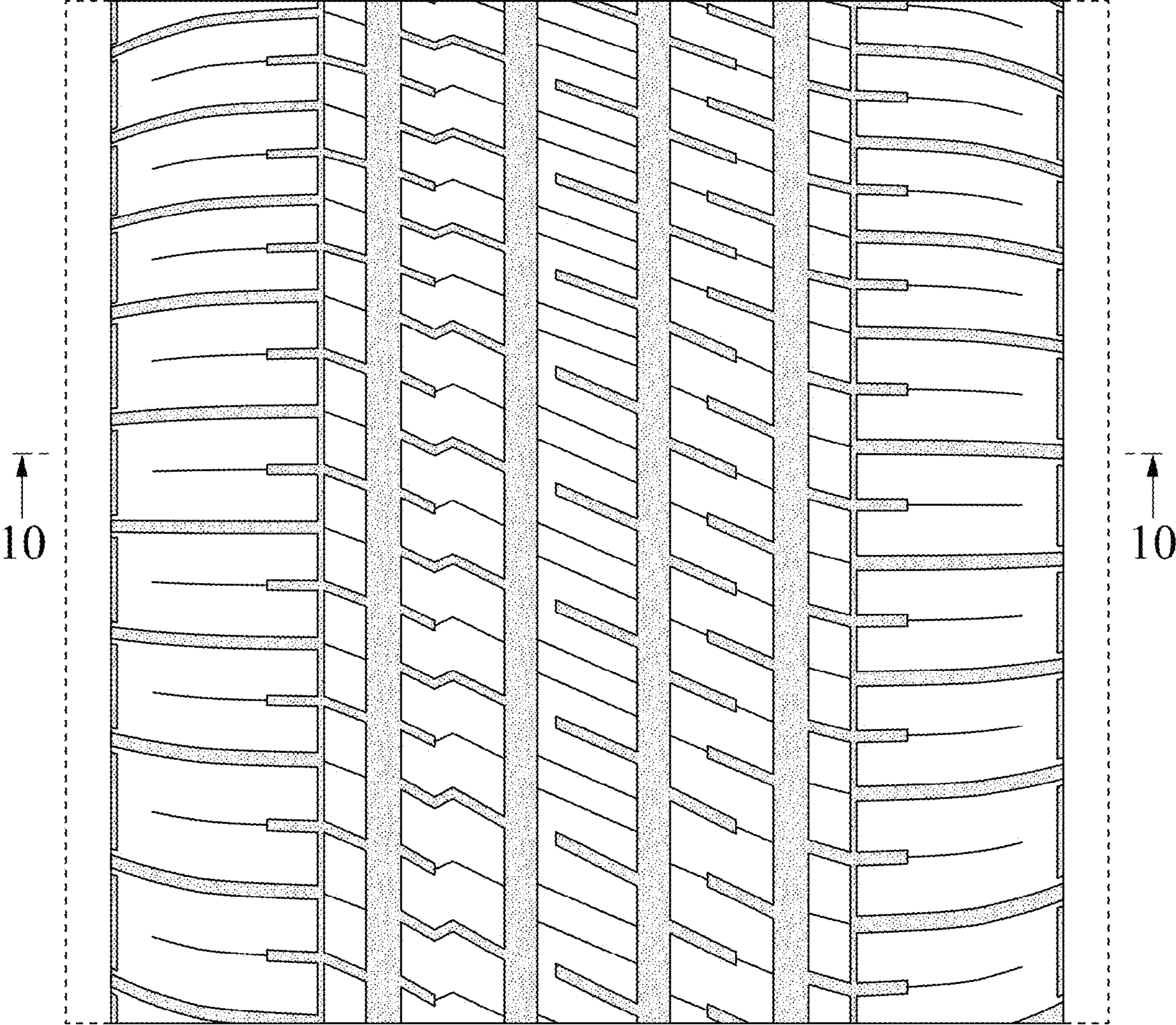
