(57) **CLAIM**

The ornamental design for a rotor of fan motor for air conditioner, as shown and described.

DESCRIPTION

FIG. 1. is a perspective view of the front, right, and top sides of a rotor of fan motor for air conditioner showing our new design;

FIG. 2. is a front view thereof;

FIG. 3. is a rear view thereof;

FIG. 4. is a top plan view thereof;

FIG. 5. is a bottom view thereof,

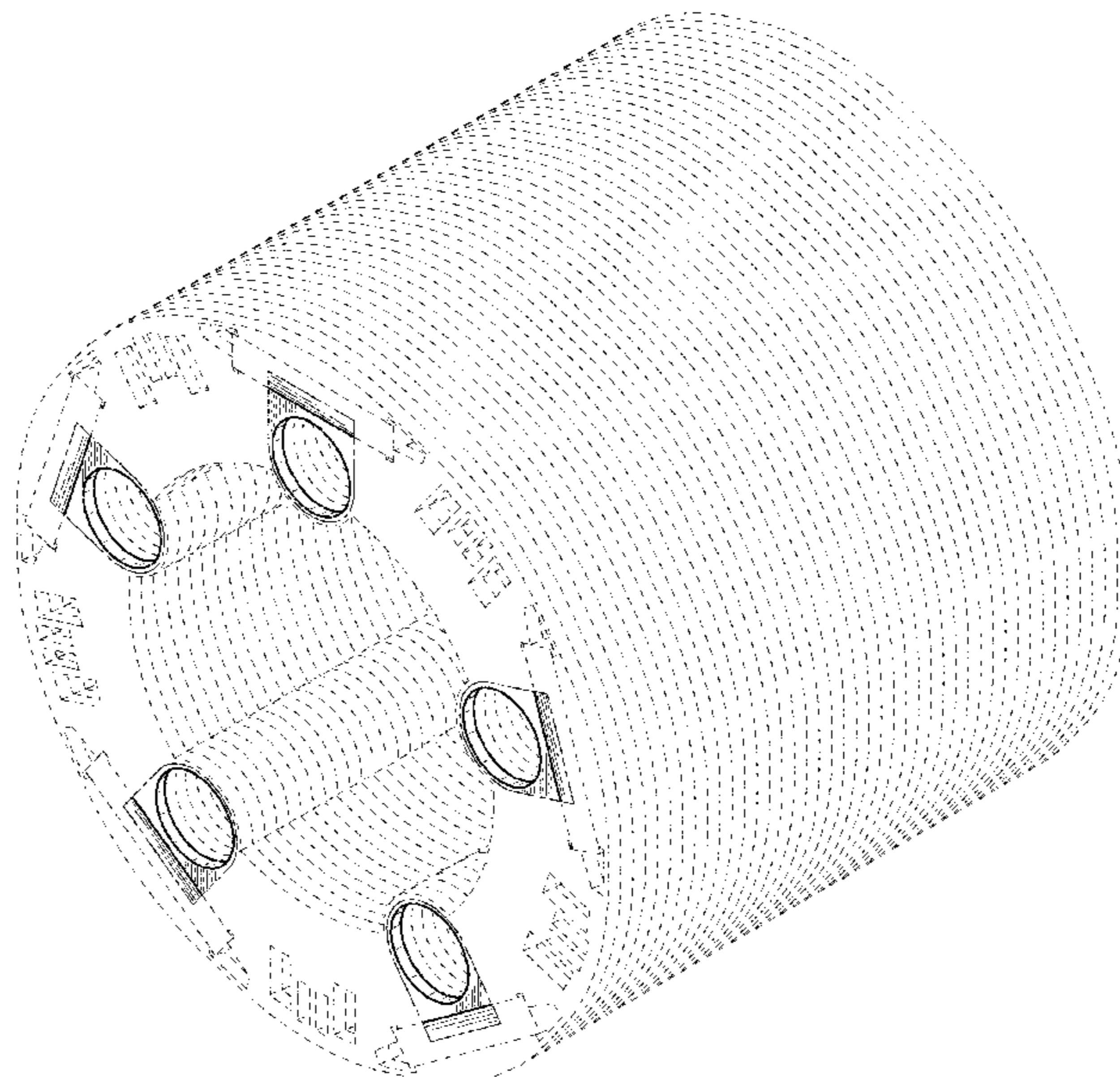
FIG. 6. is a right side view thereof; and,

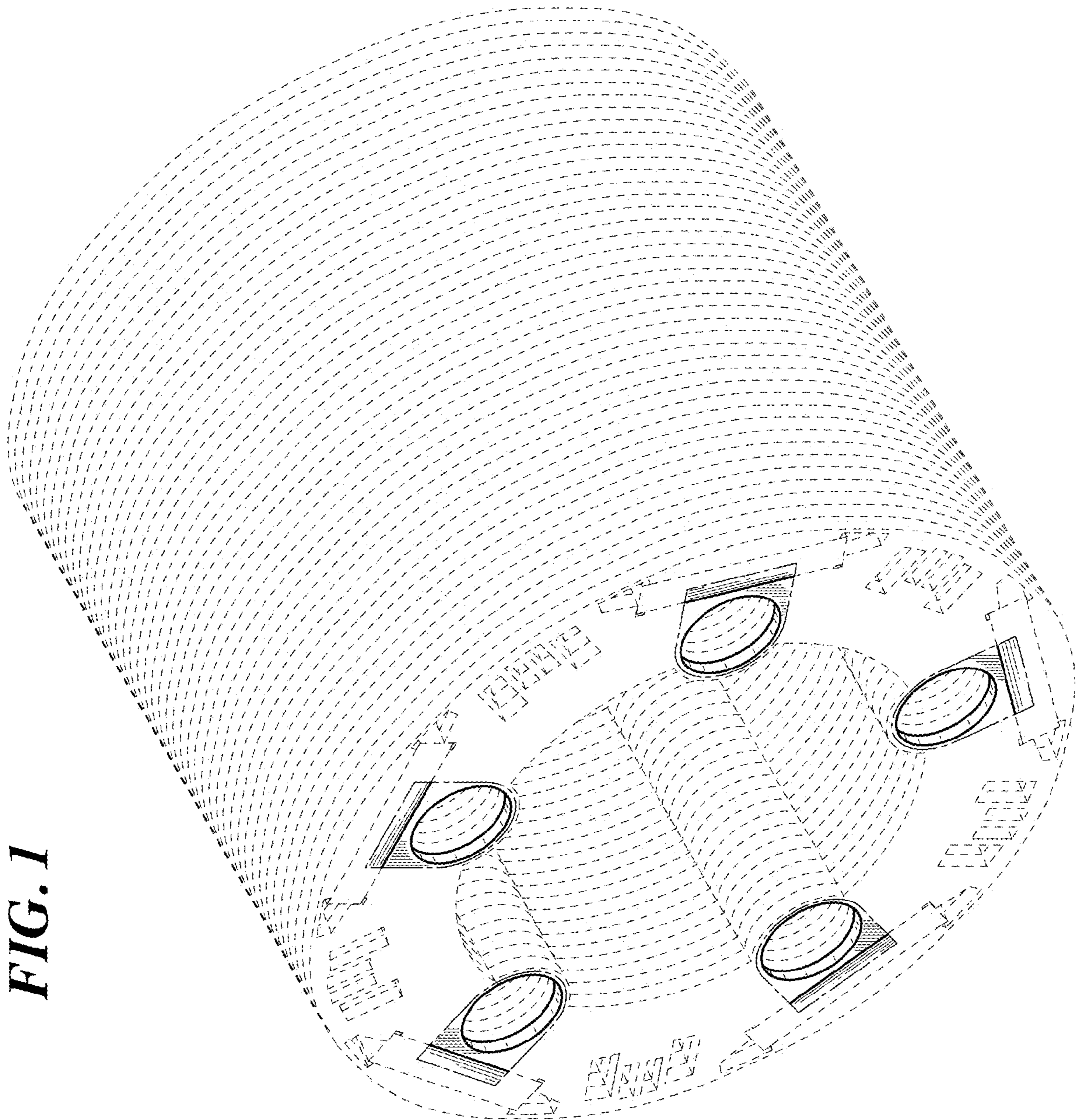

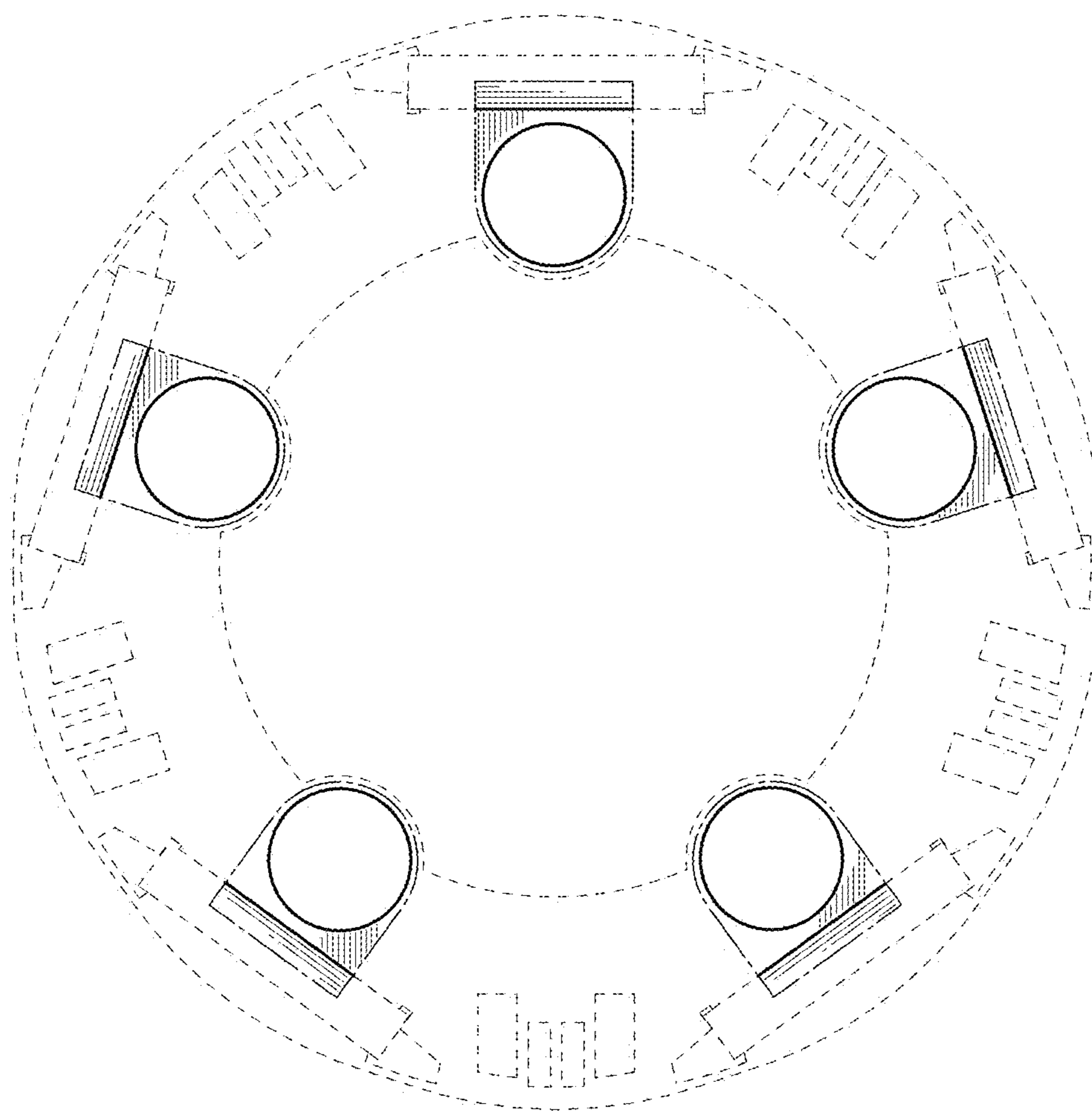

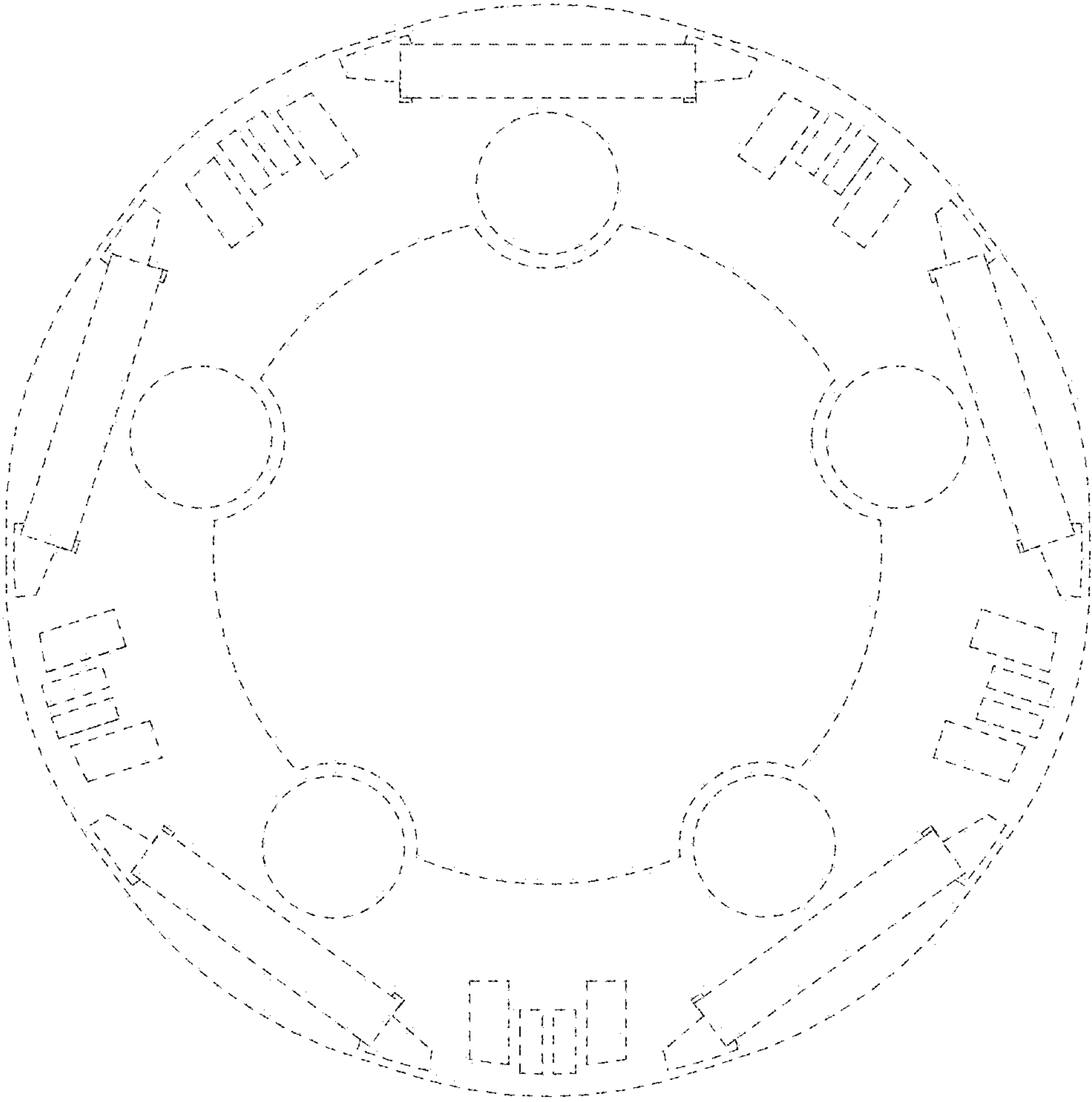

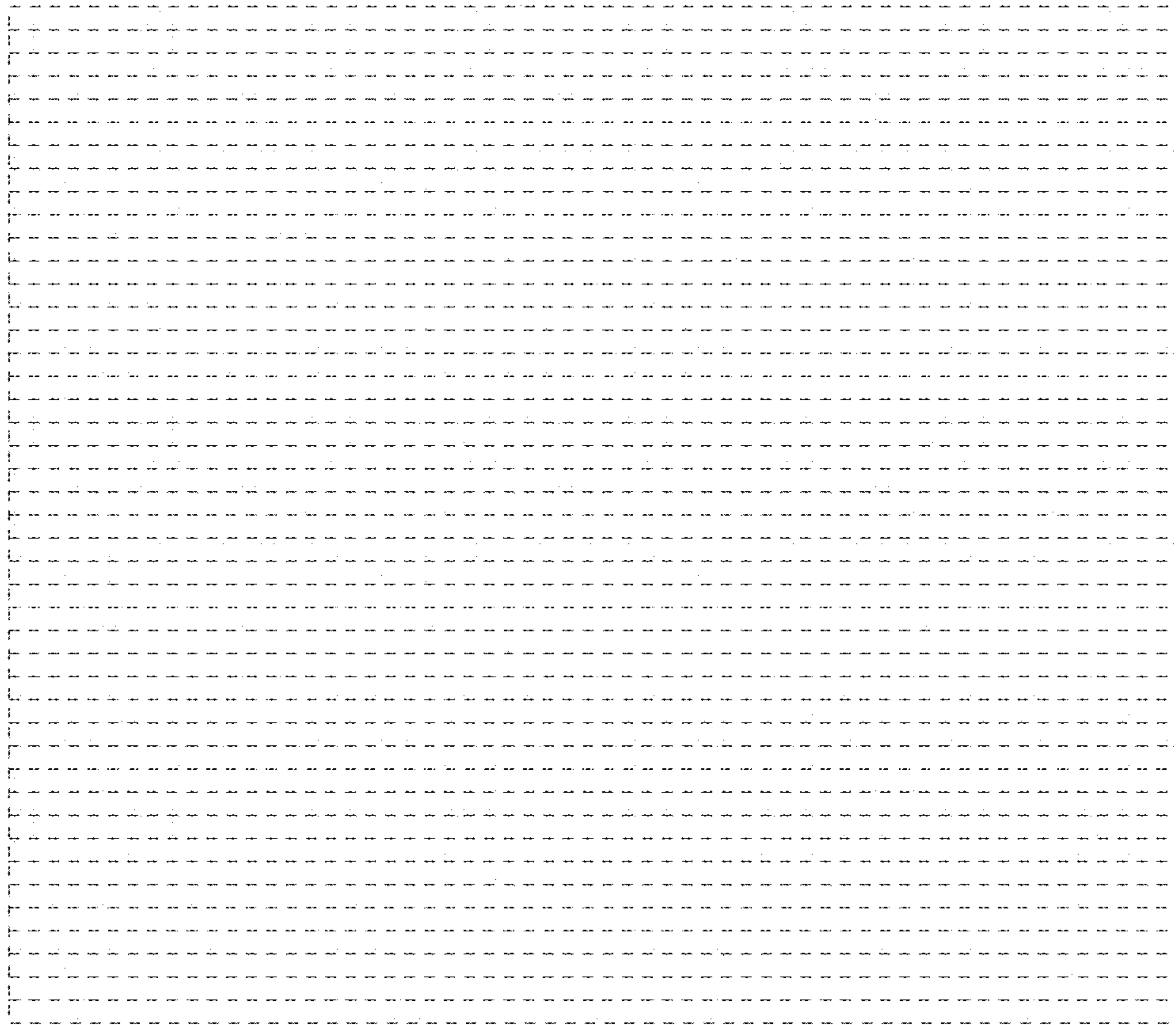

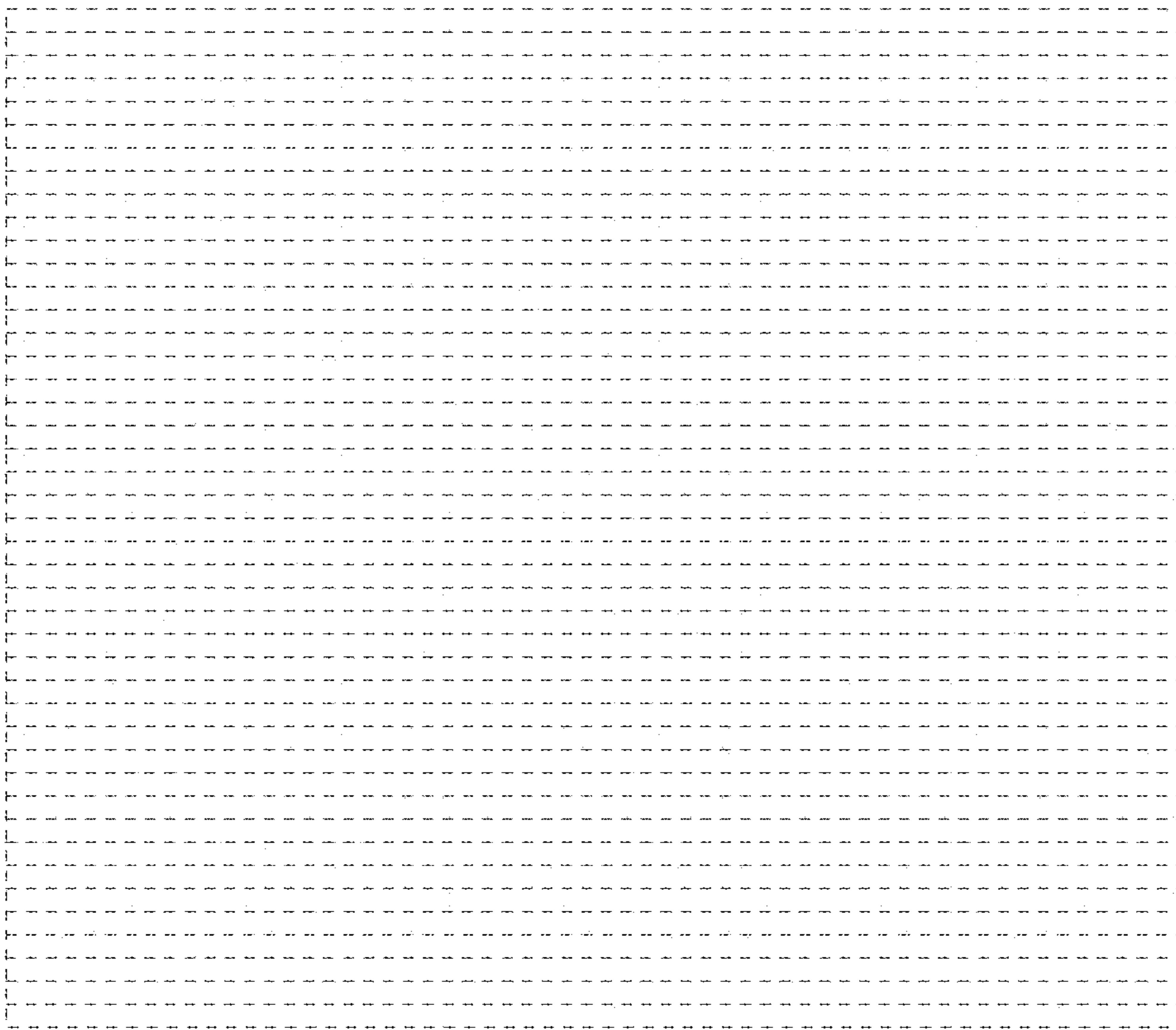

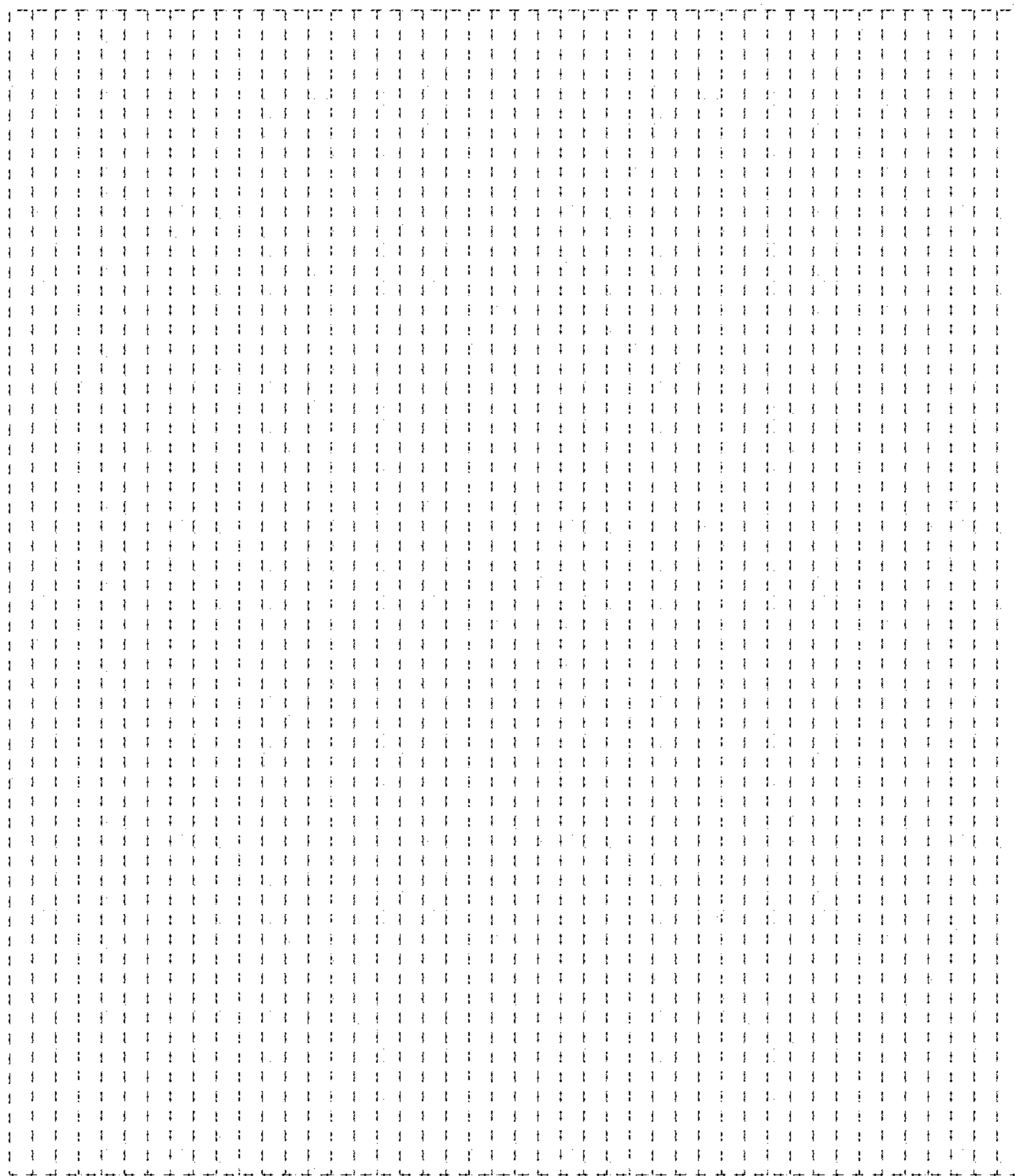
