FIG. 5 is a top view of the combined wristband and wearable device of FIG. 1.

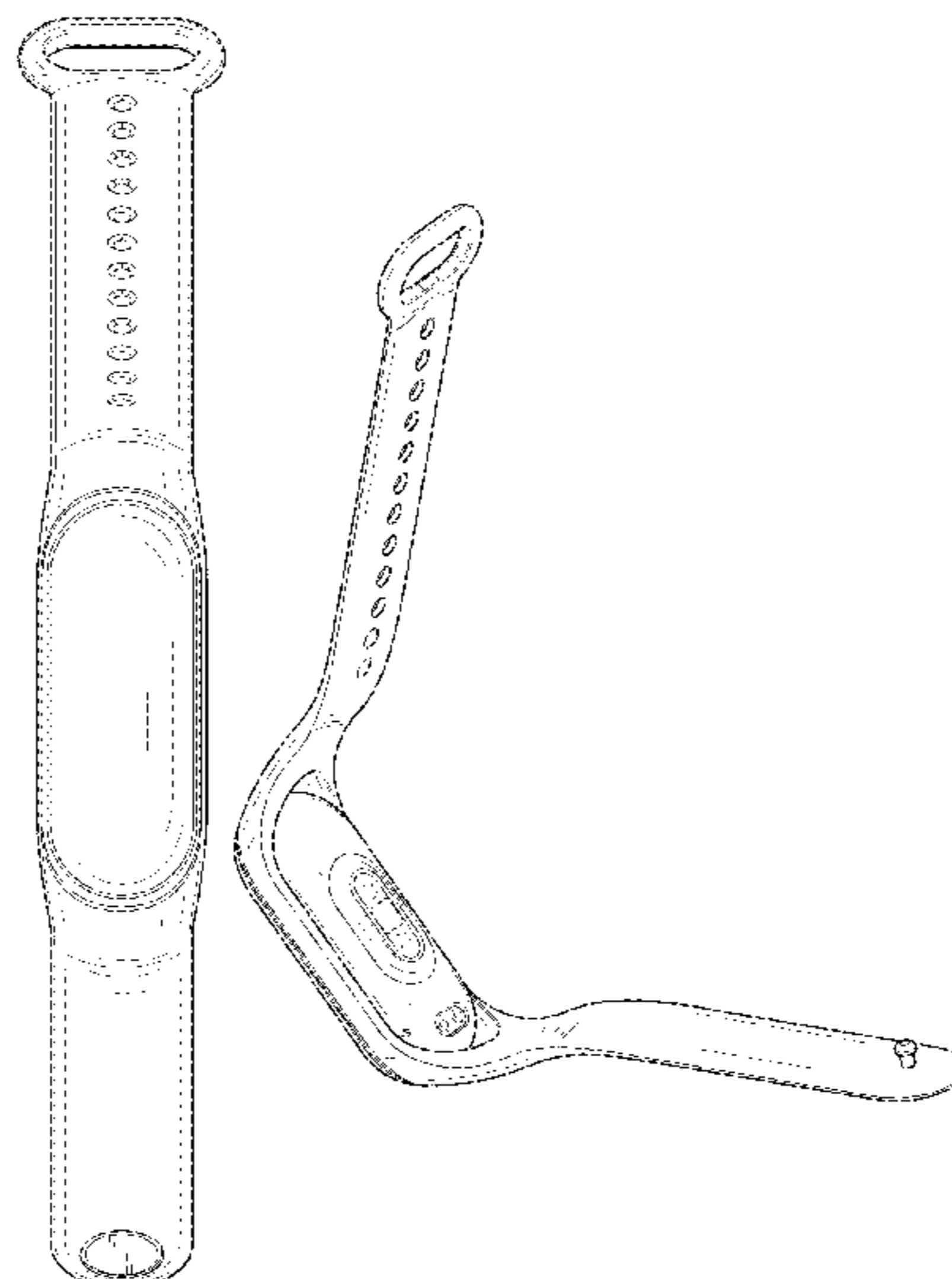
FIG. 6 is a bottom view of the combined wristband and wearable device of FIG. 1.

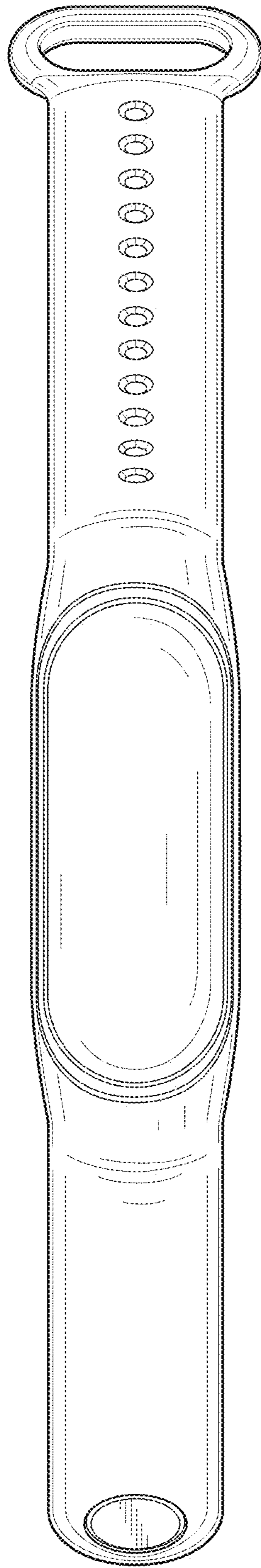

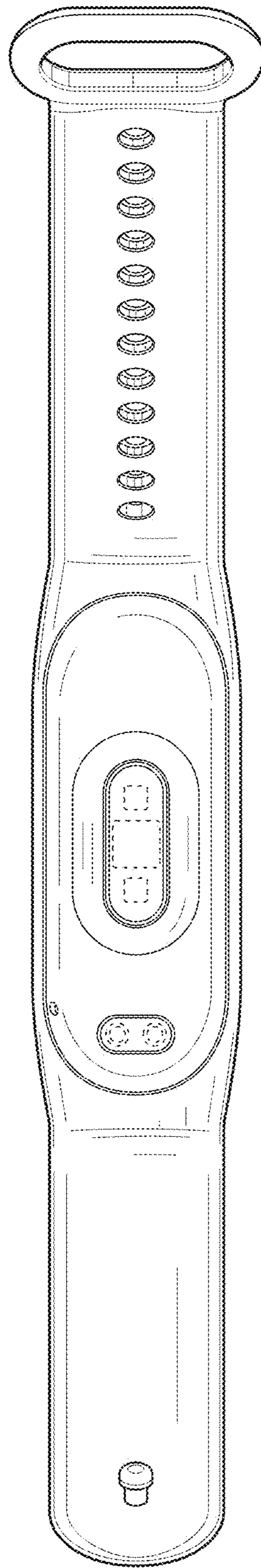

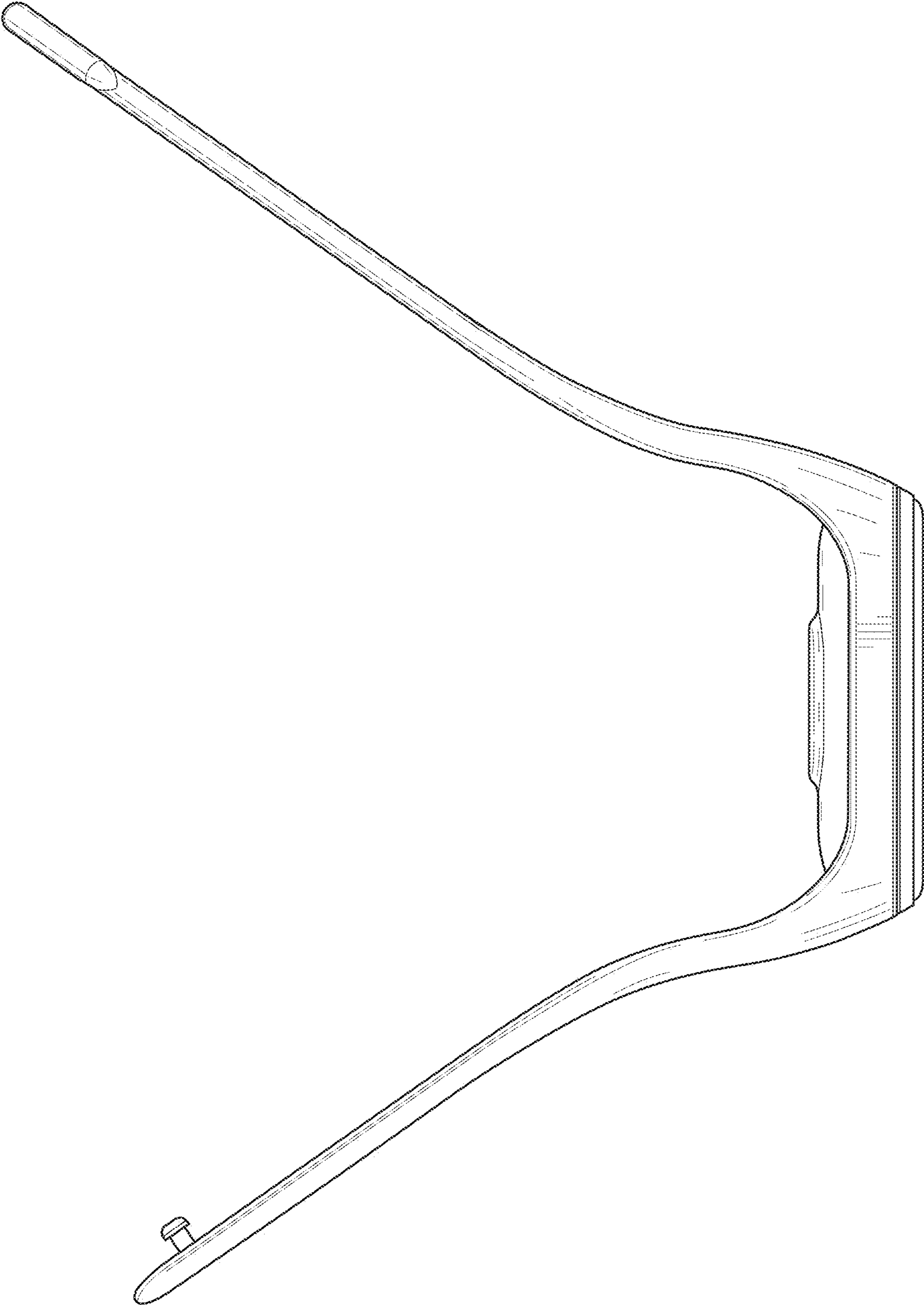

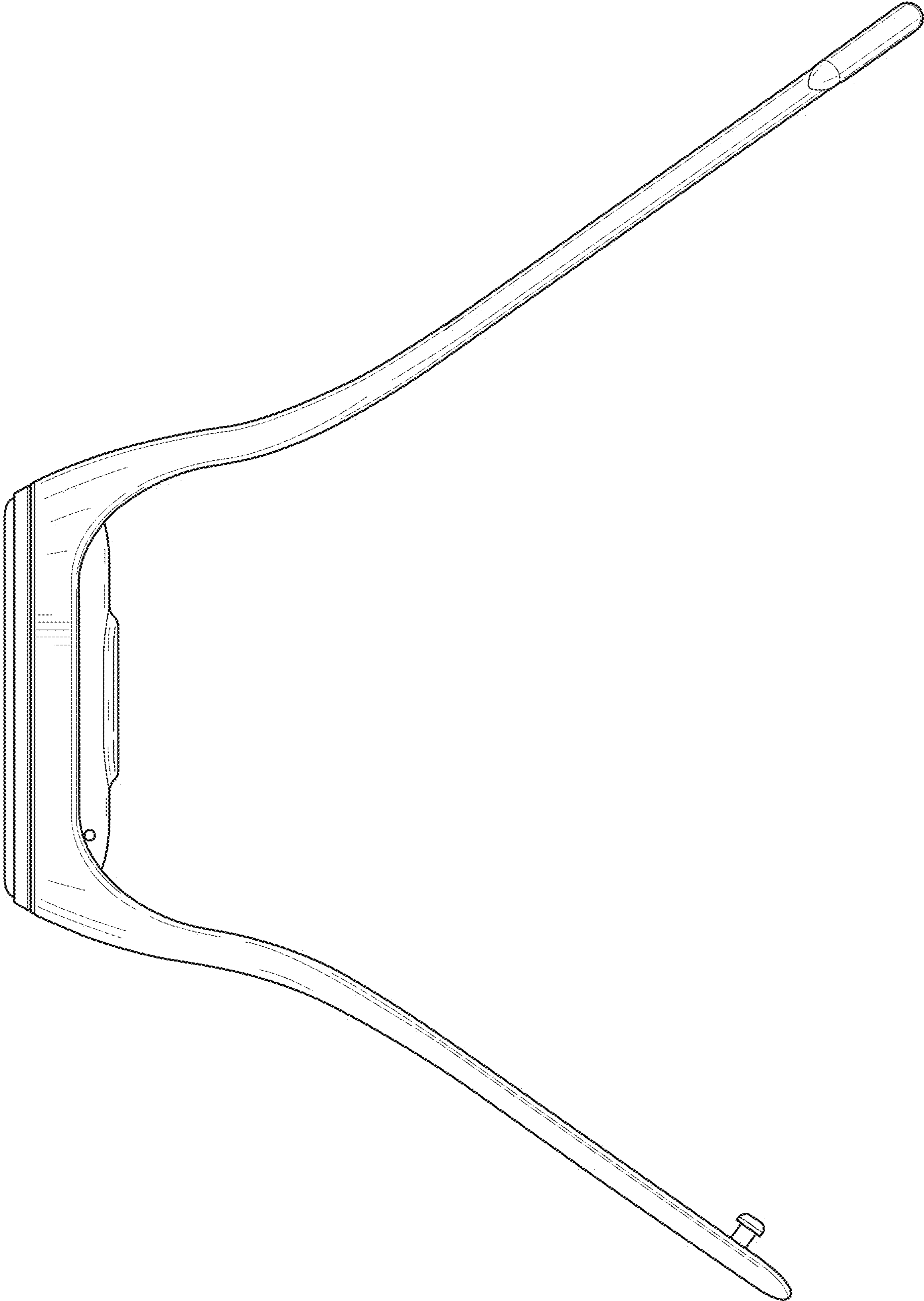

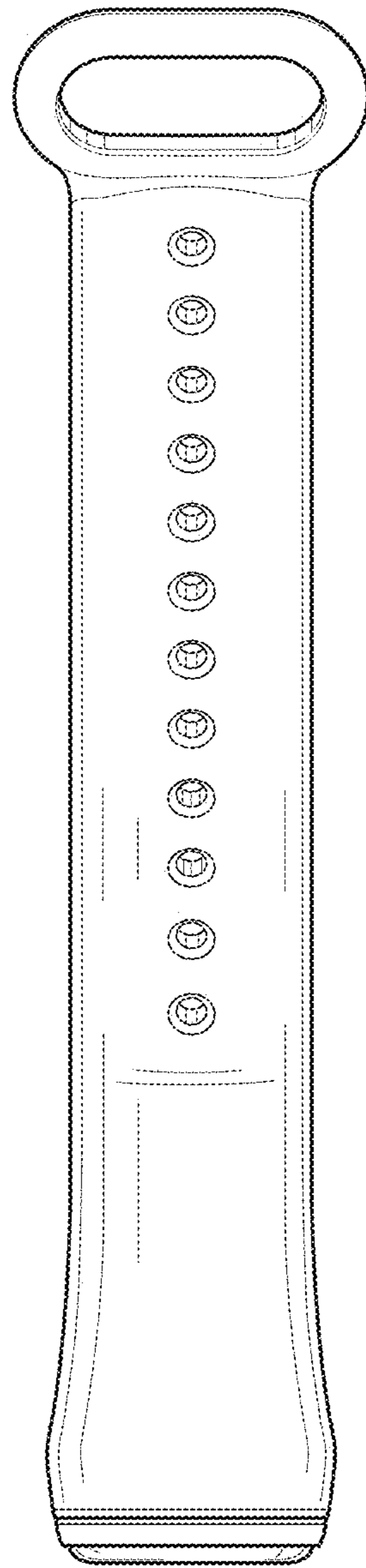

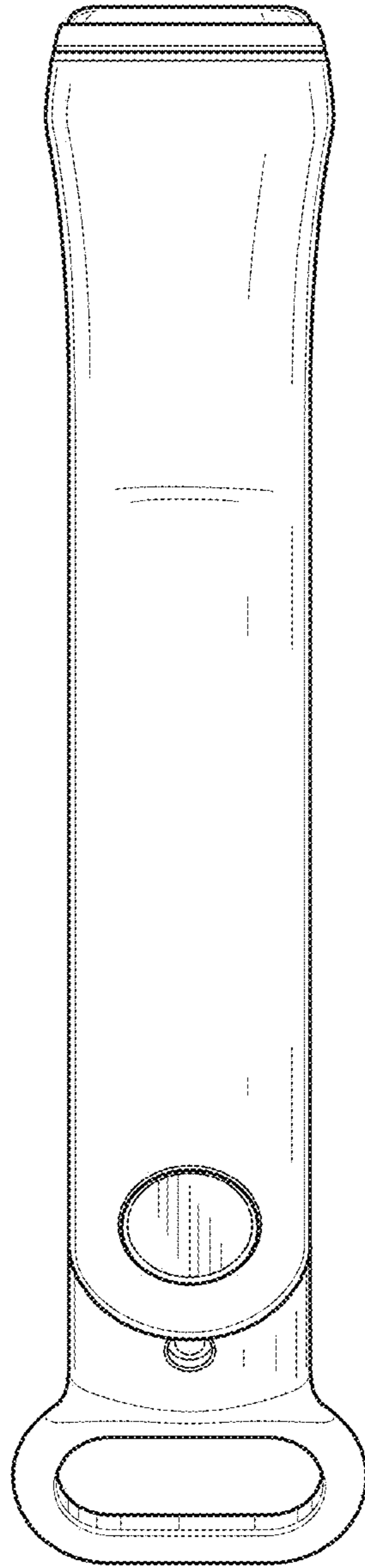

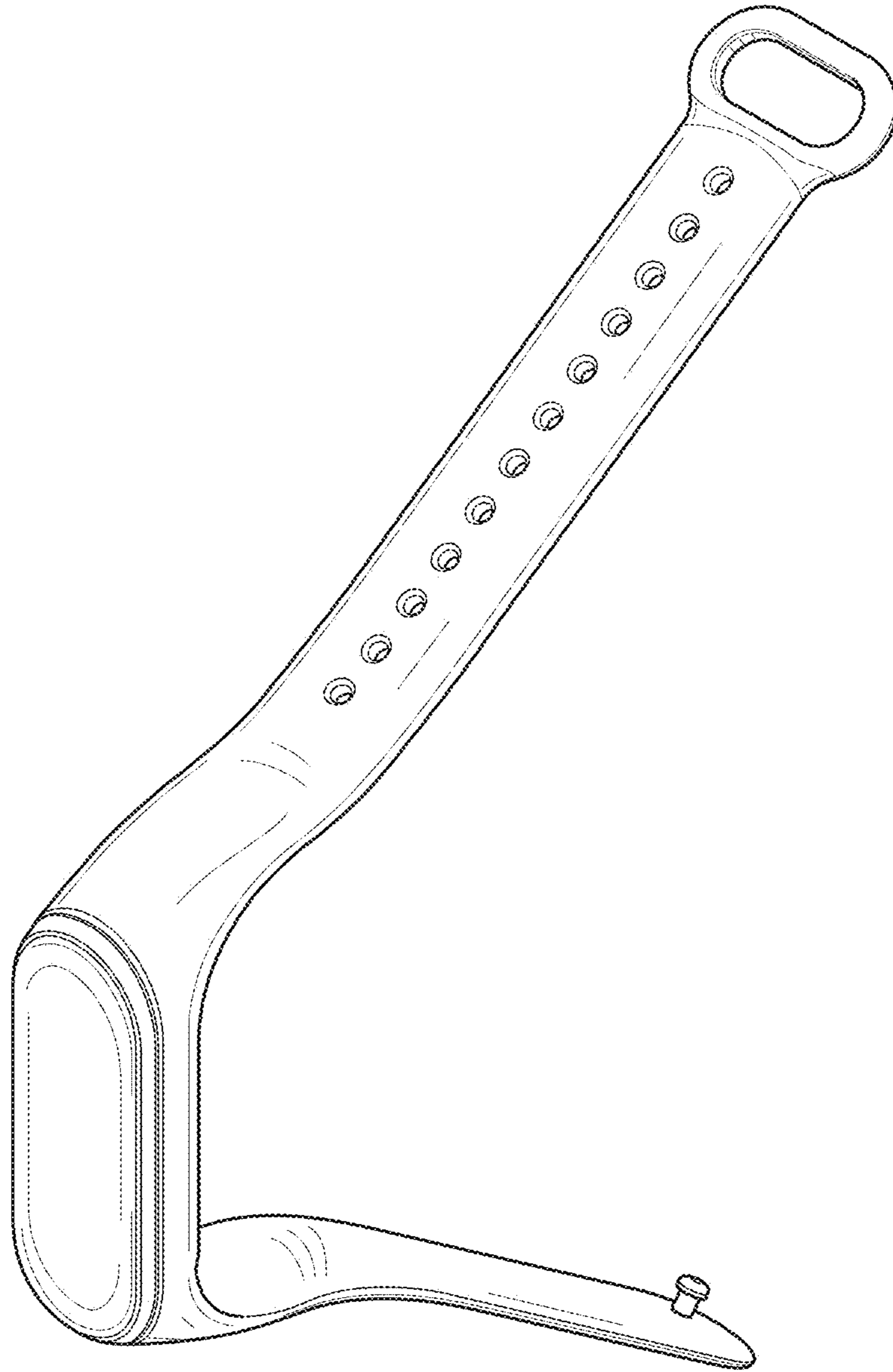

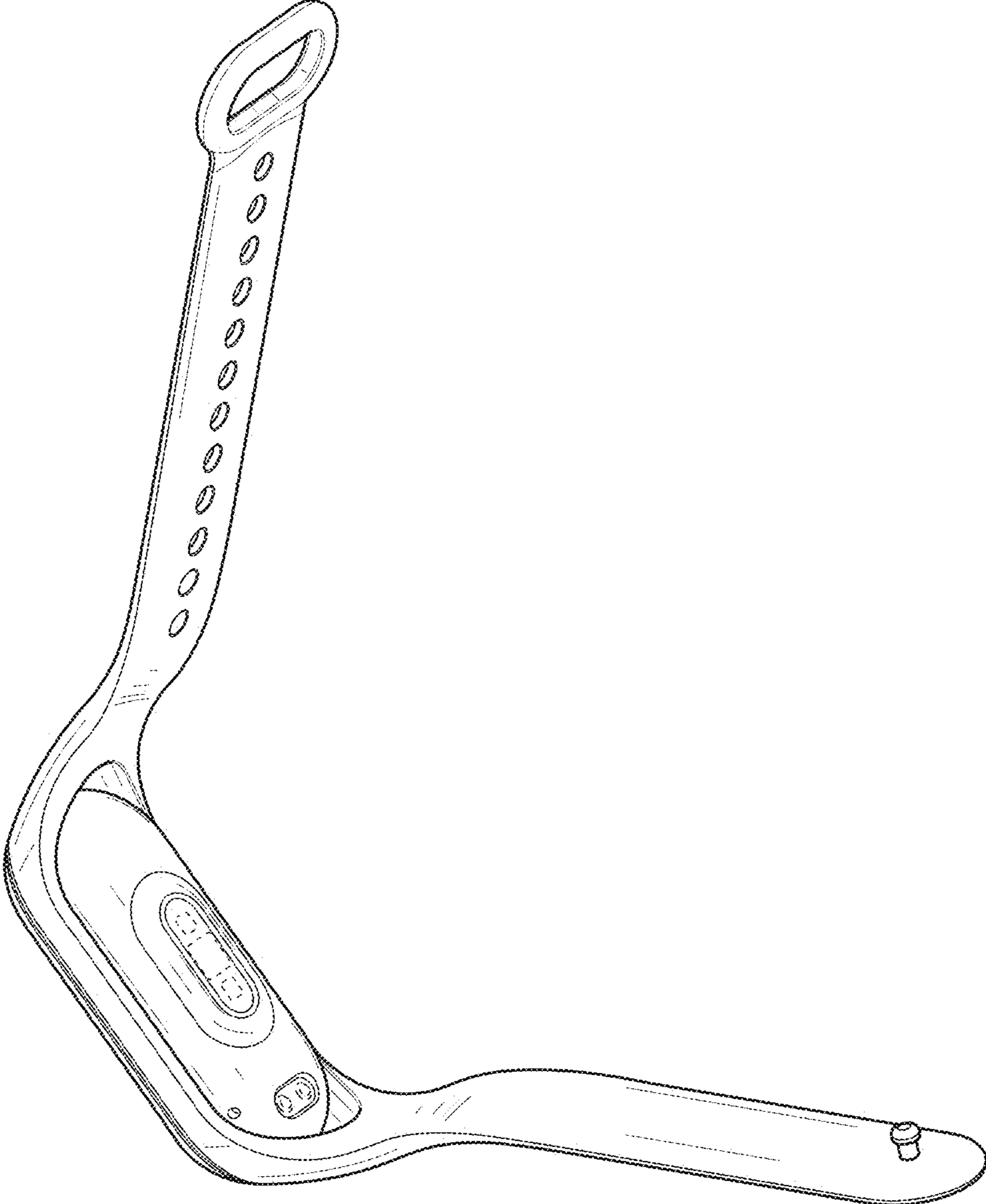
