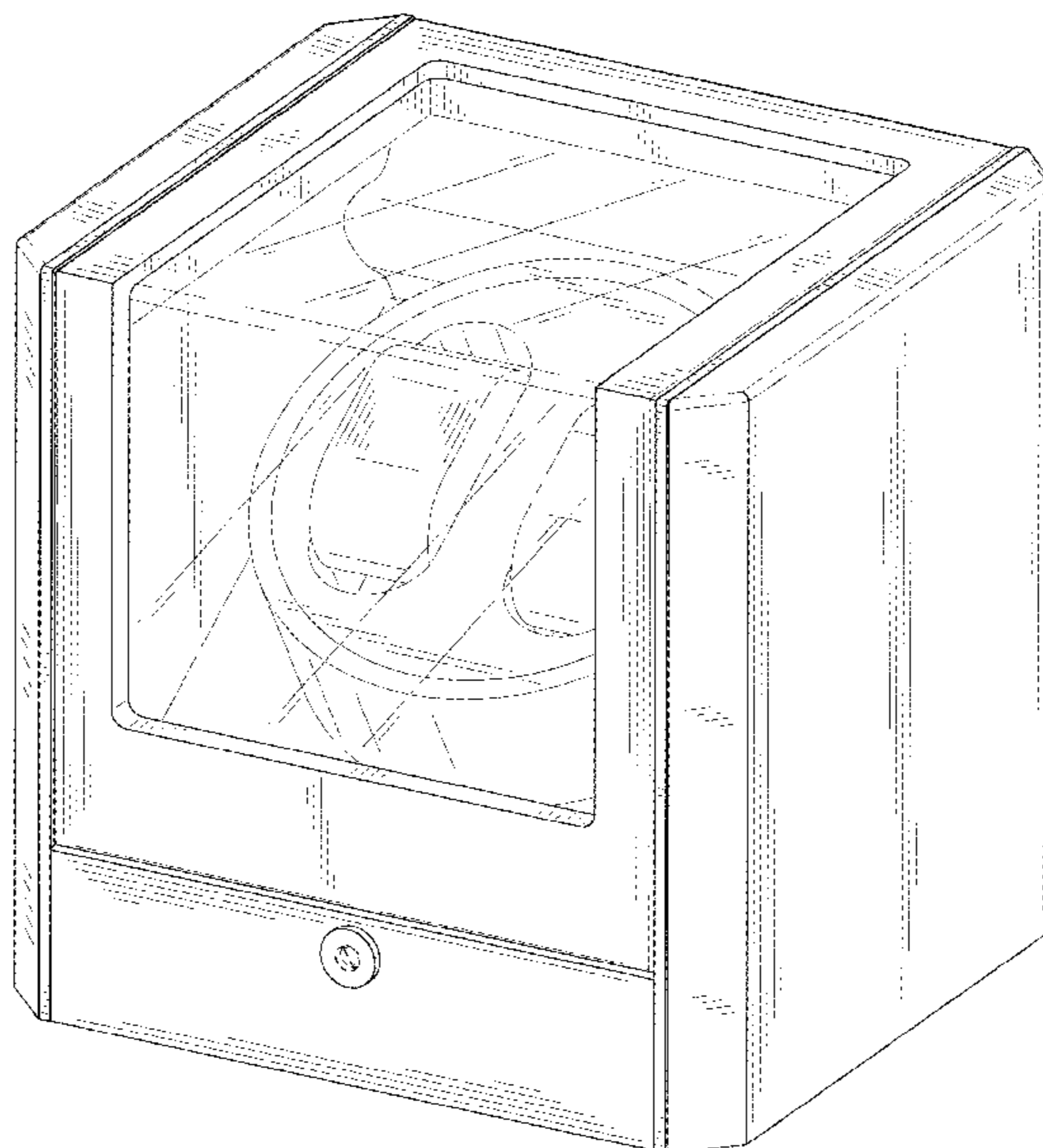
(57) **CLAIM**

The ornamental design for a winder for watch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a winder for watch showing my new design according to a first embodiment; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a perspective view thereof in an open state. The broken lines in the drawings illustrate portions of the winder for watch that form no part of the claimed design.

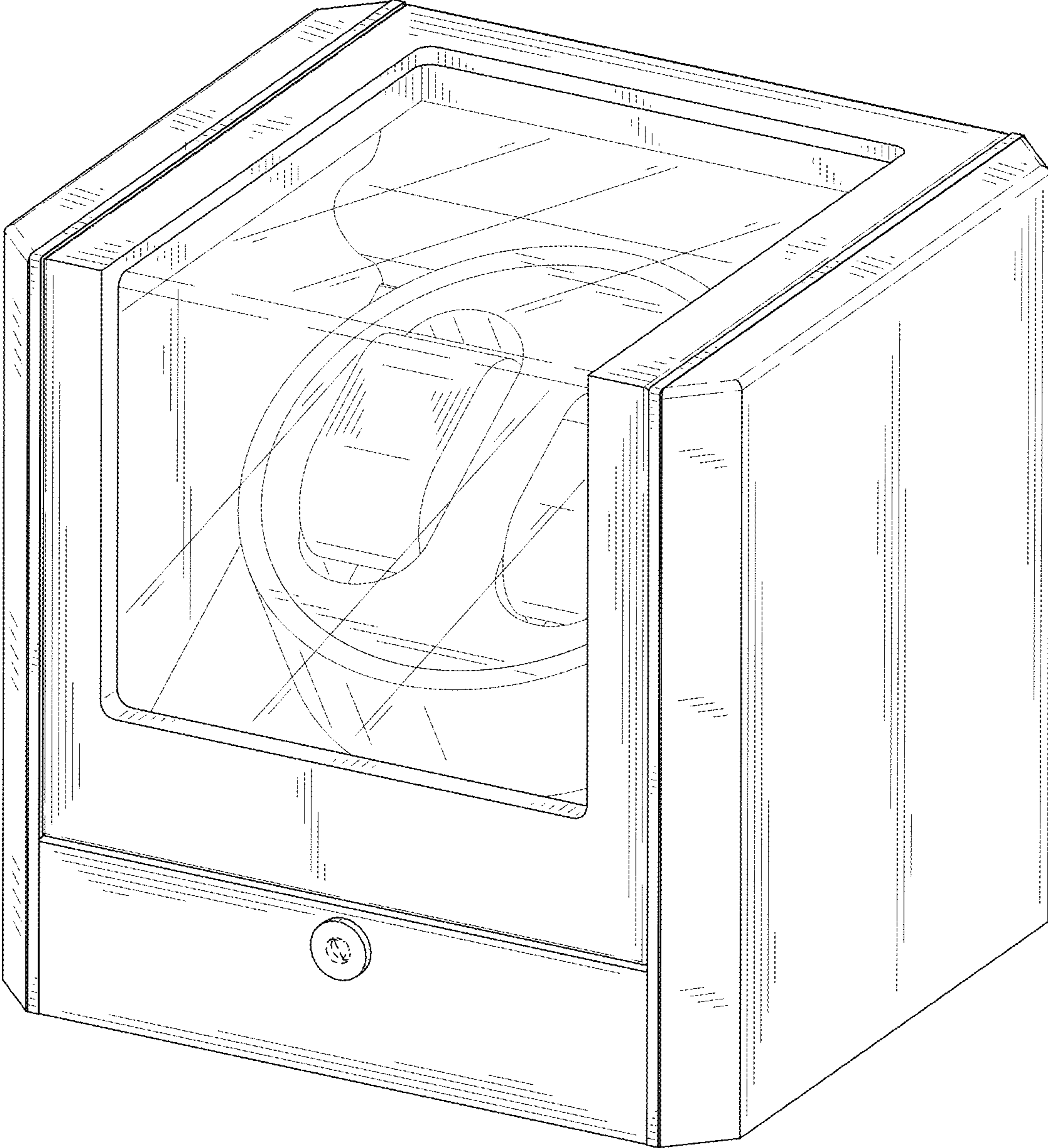

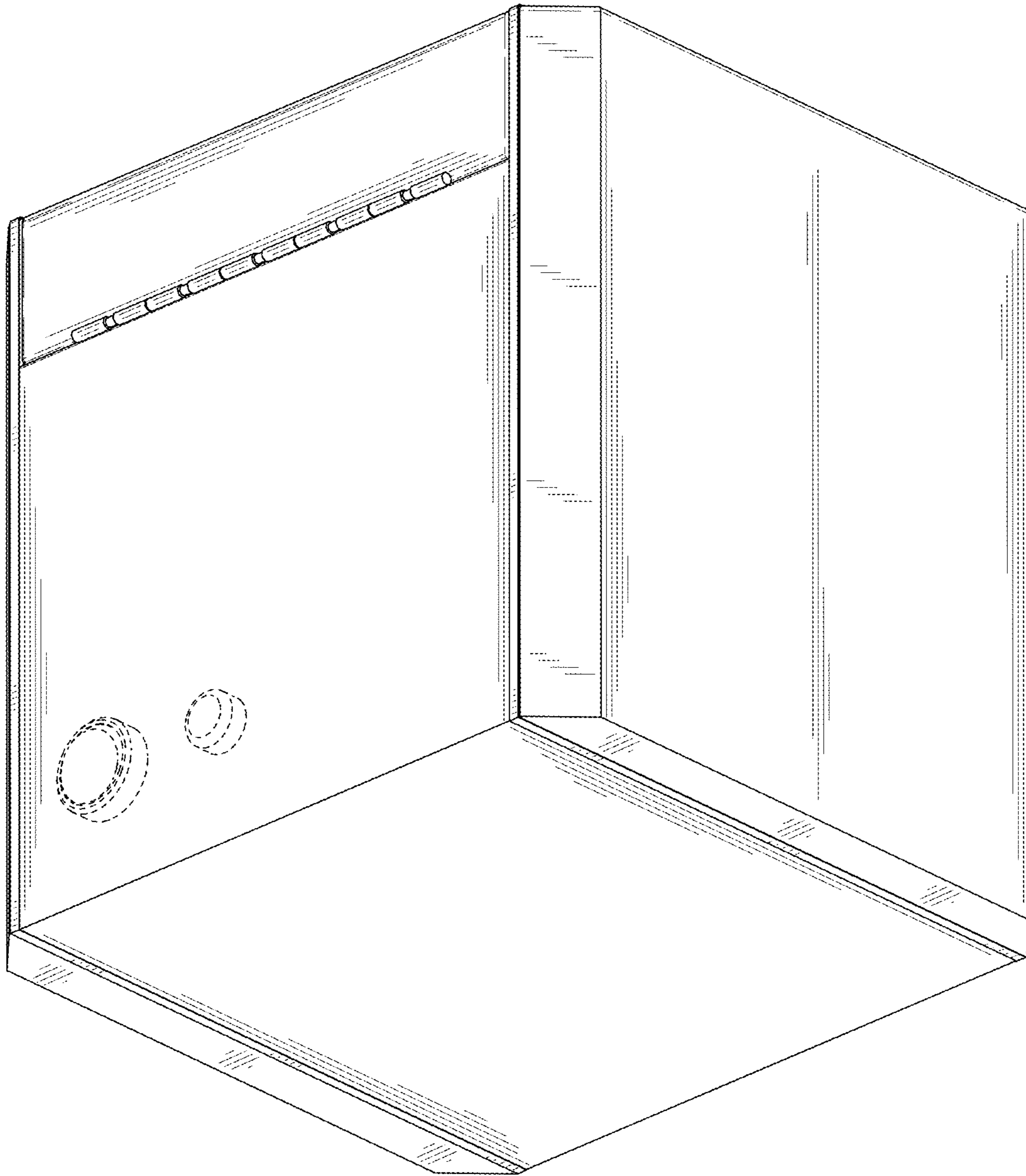

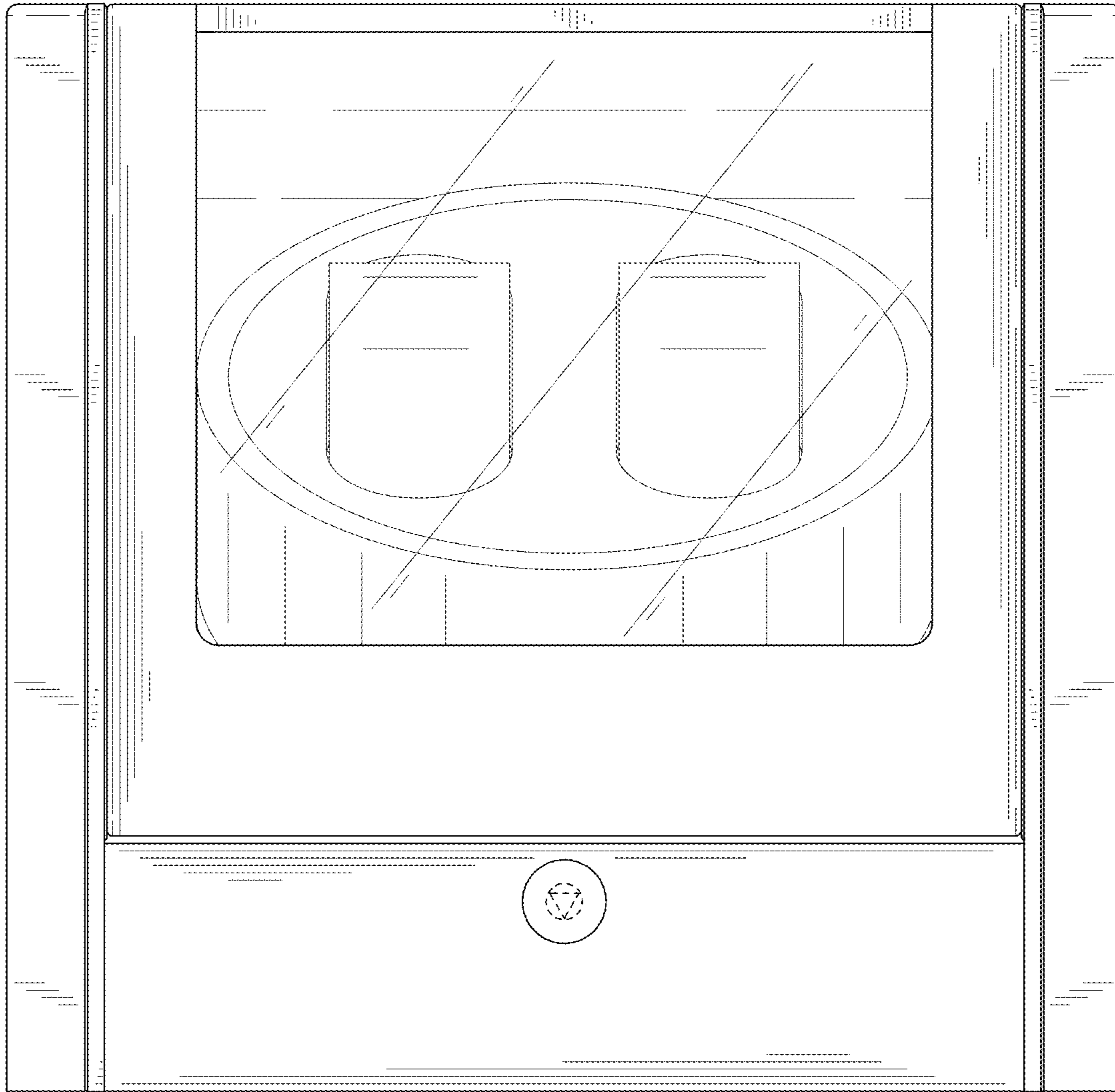

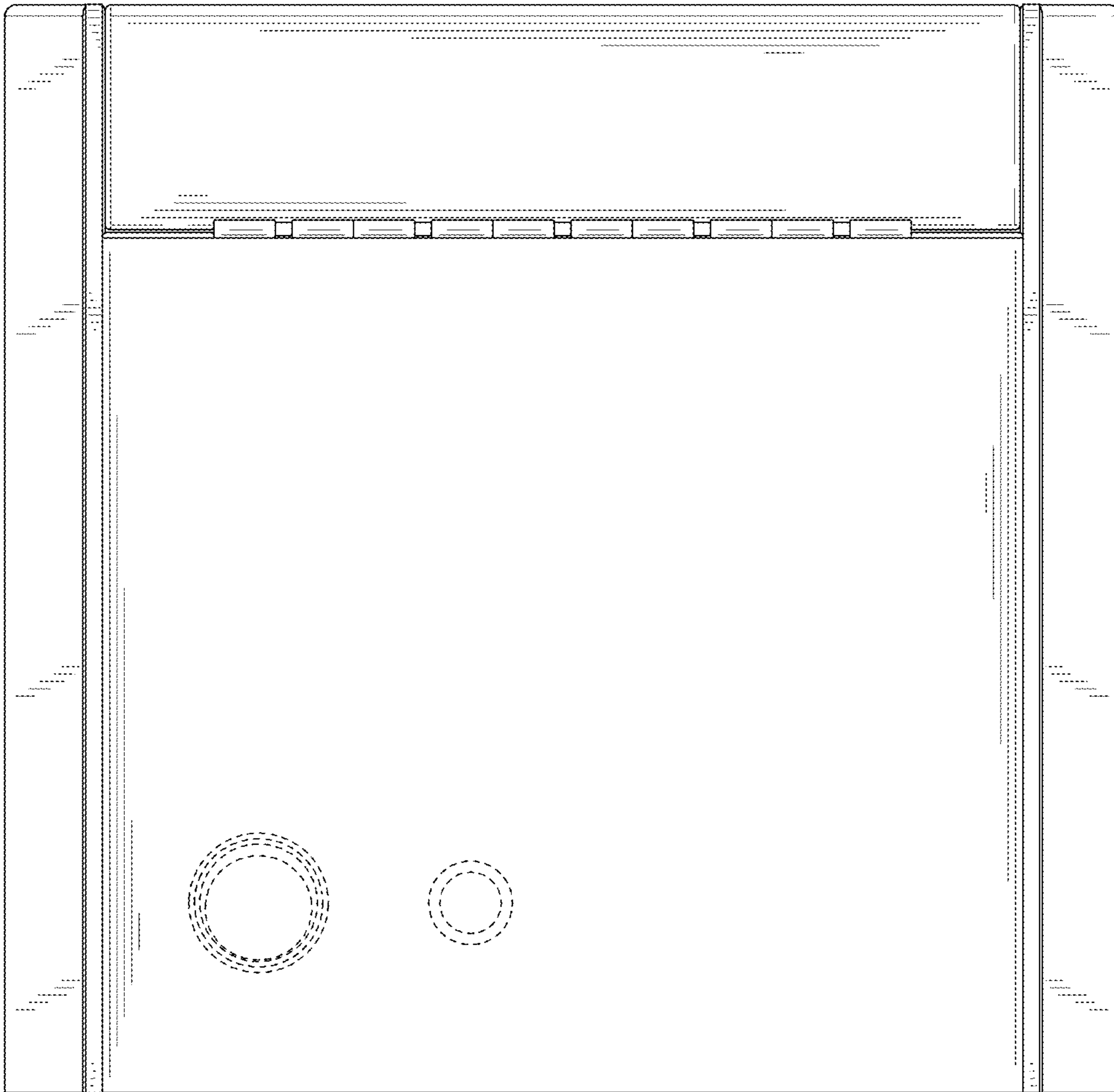

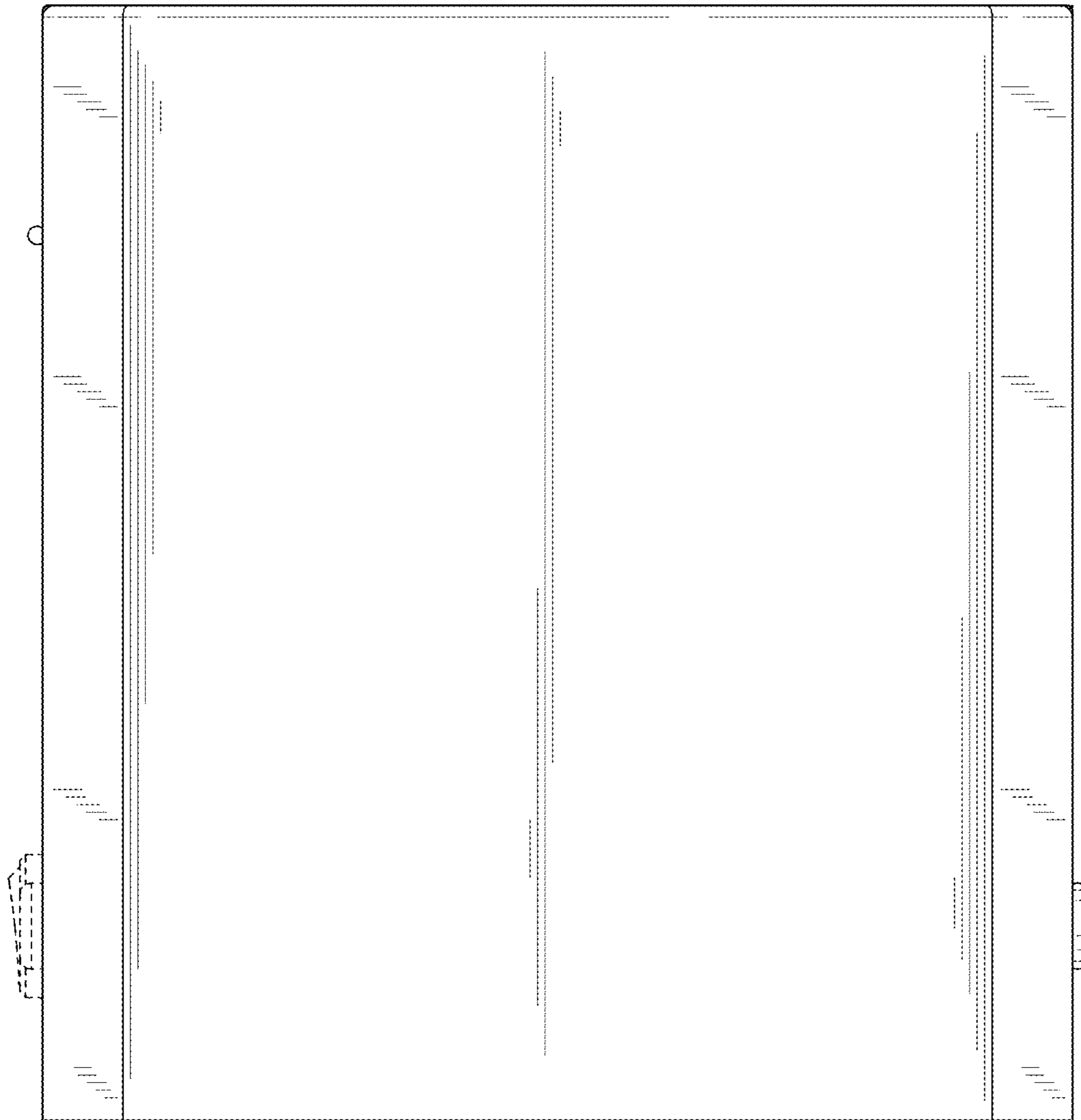

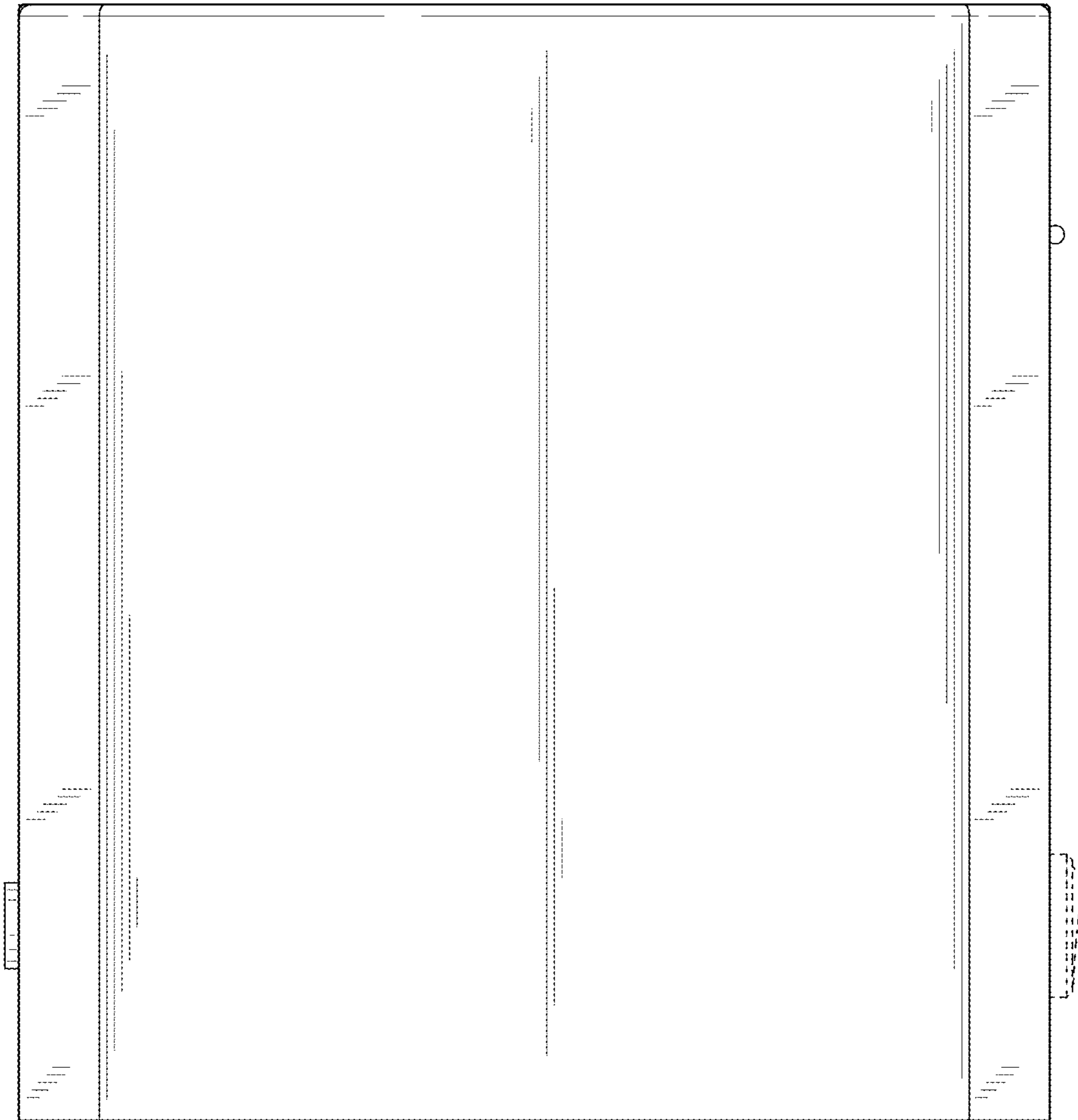

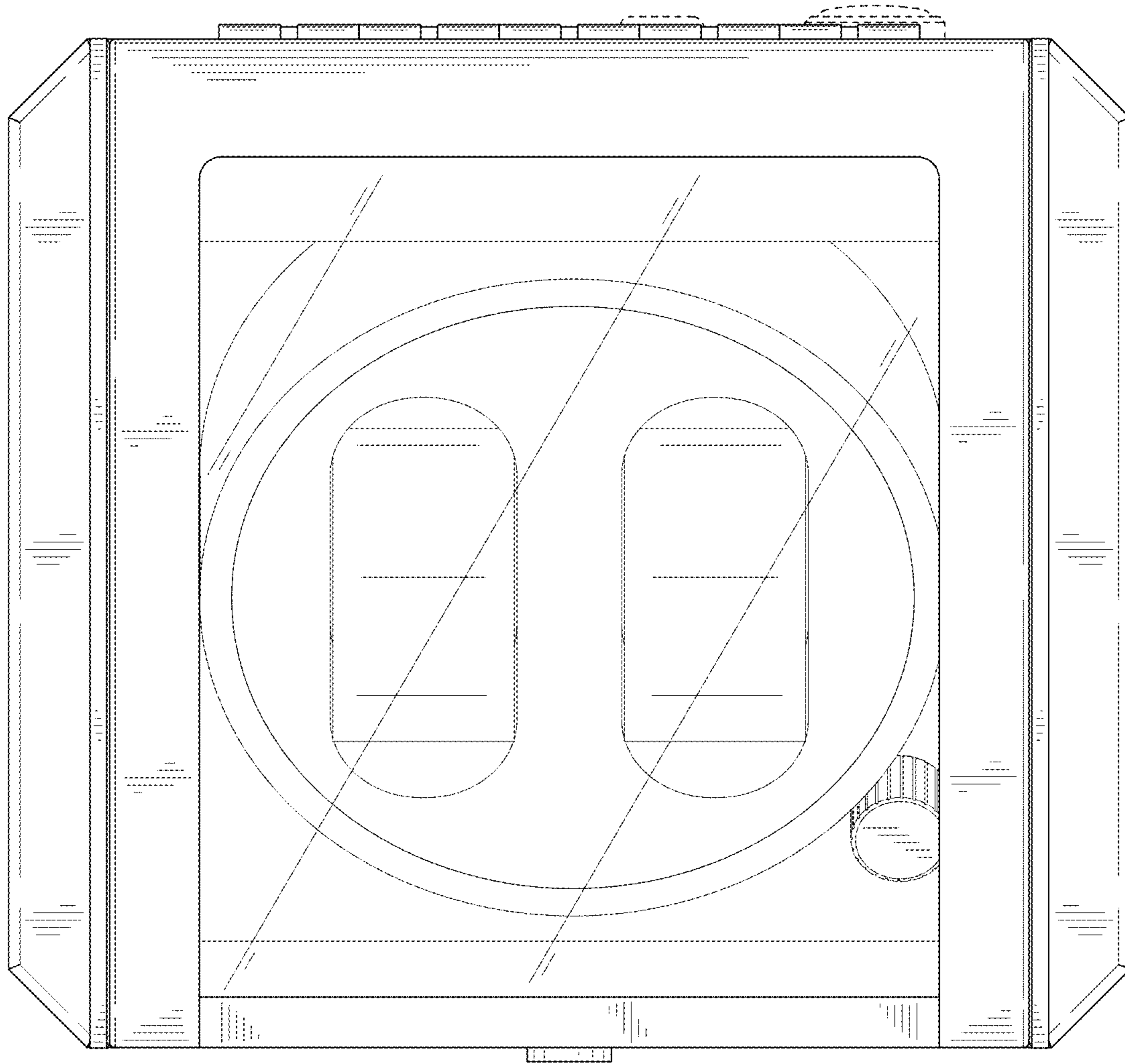

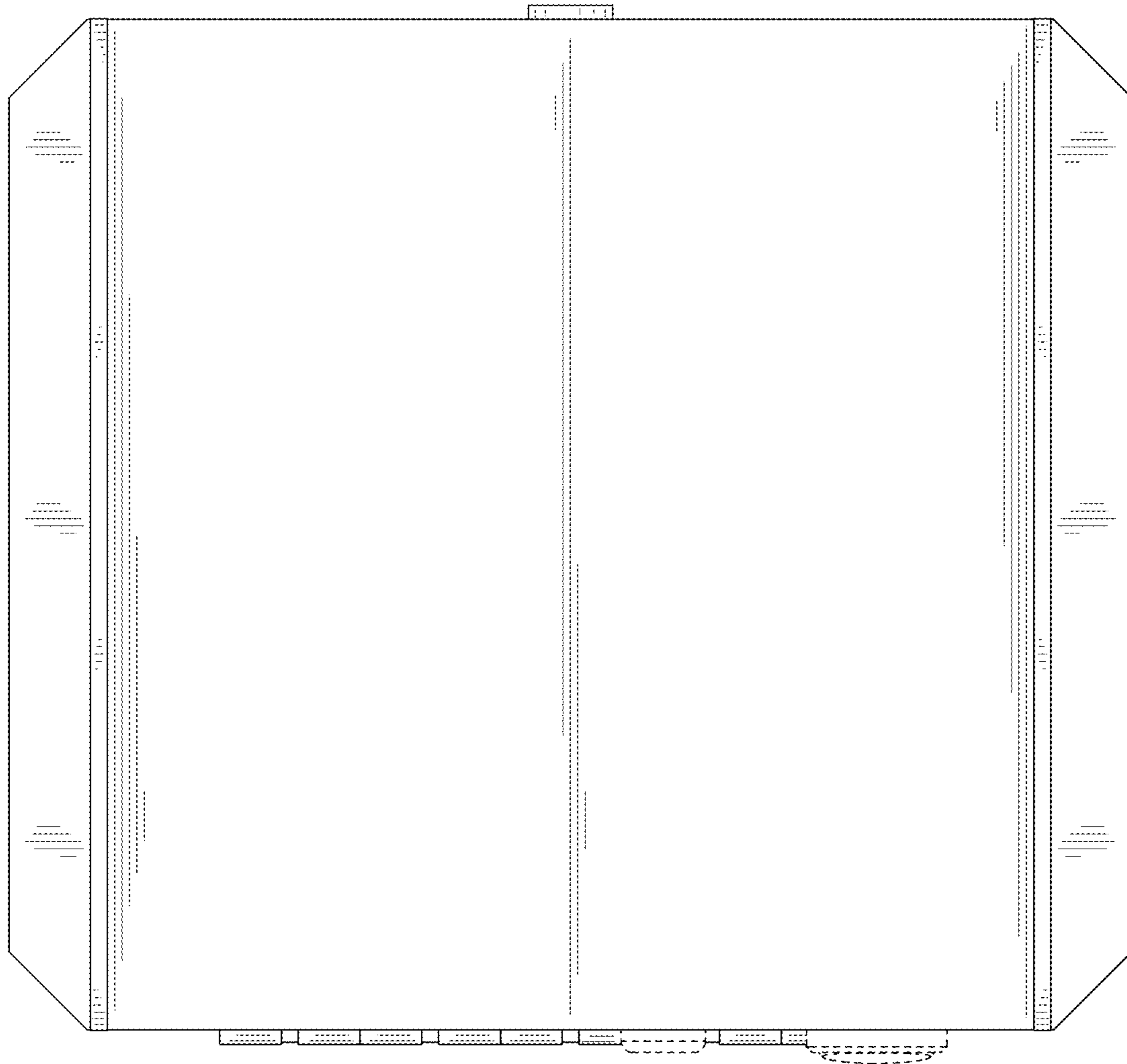

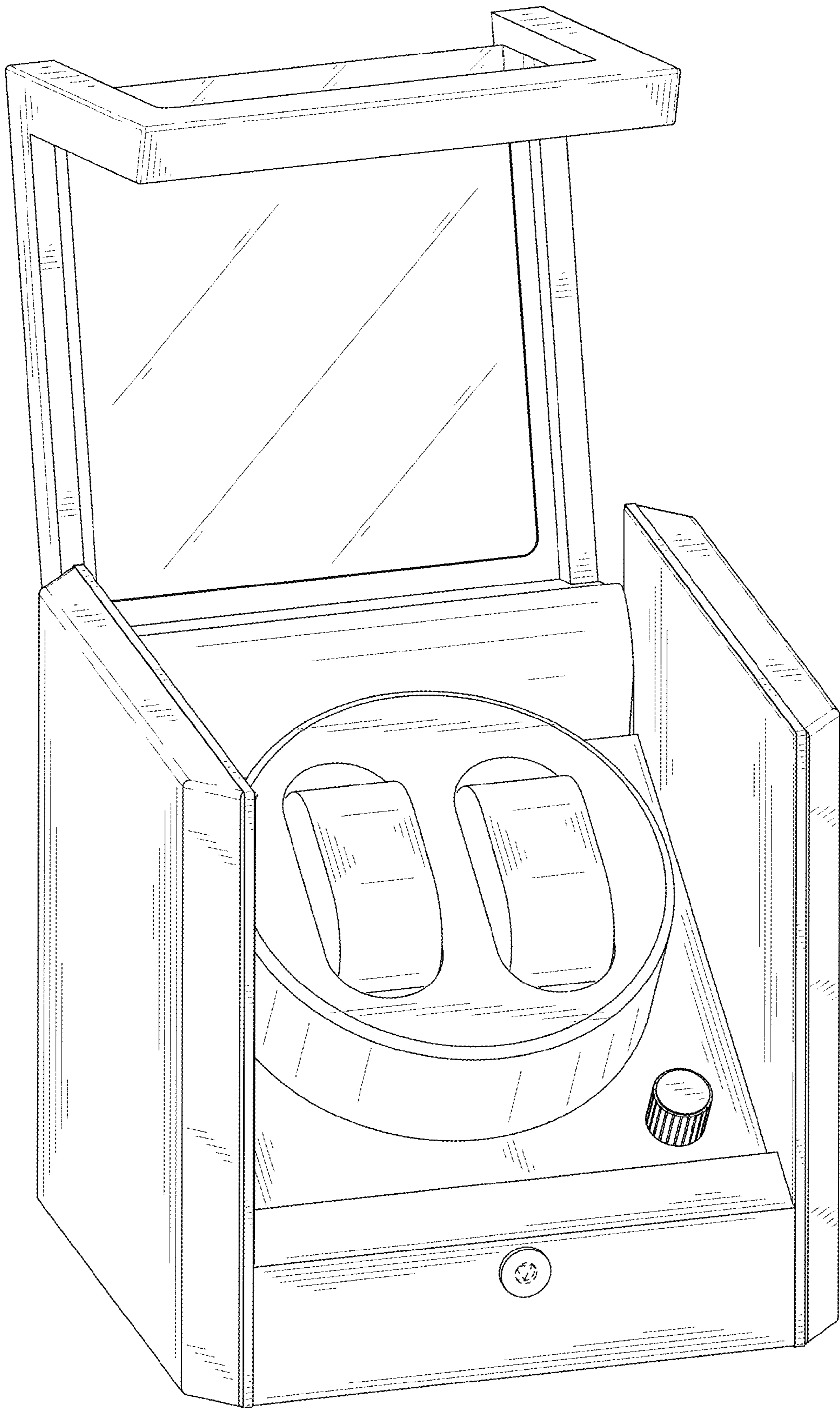
