The ornamental design for a medical implant device, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a medical implant device according to a first embodiment;

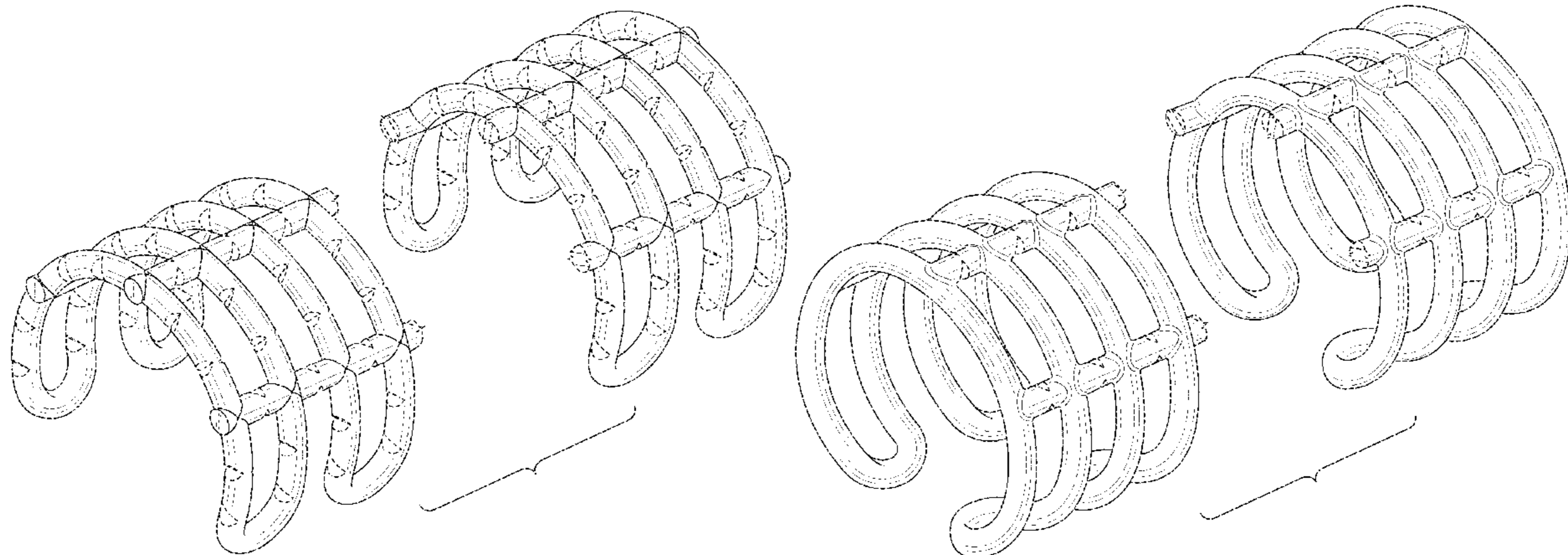




FIG. 31 is a rear elevation view thereof;

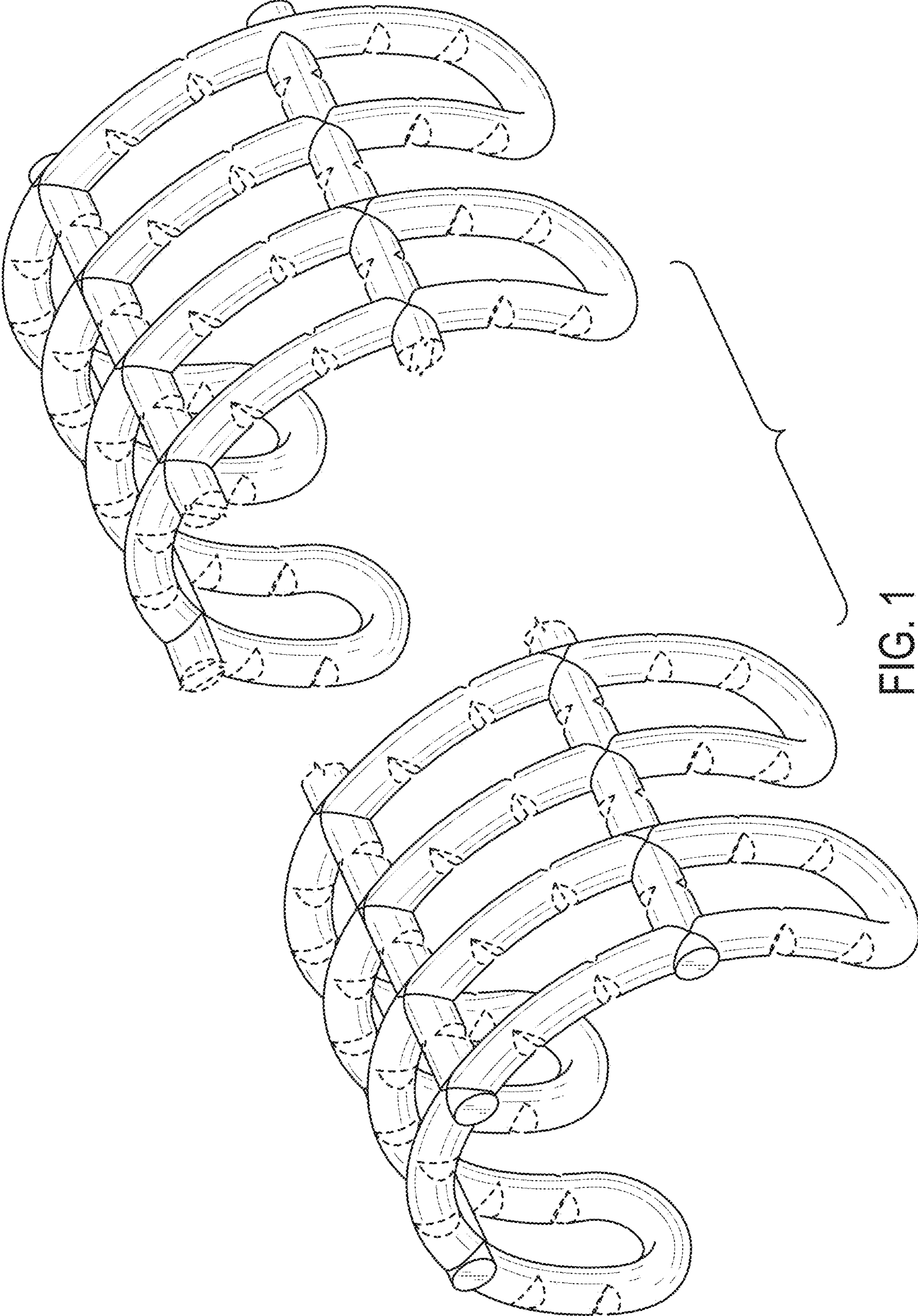

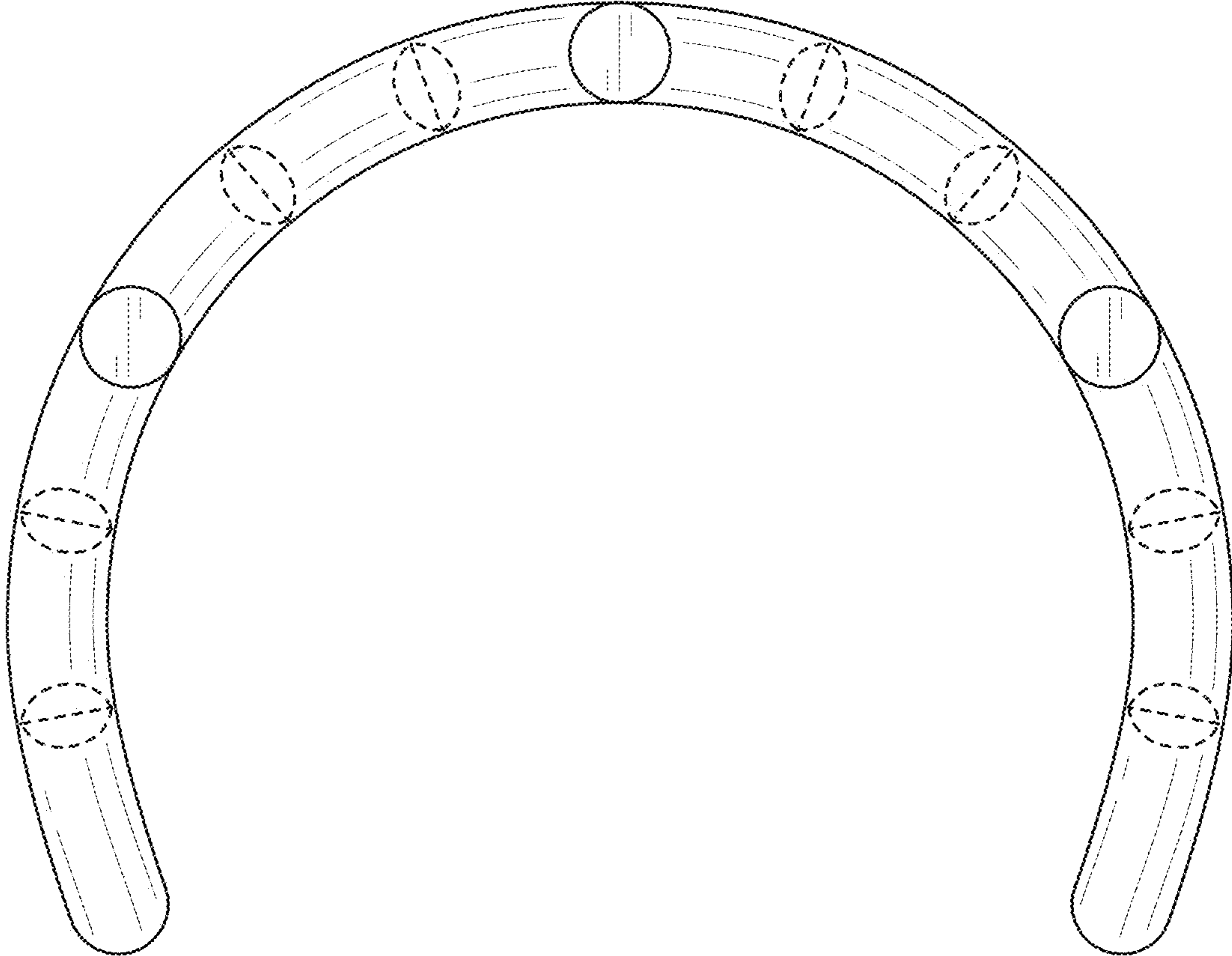

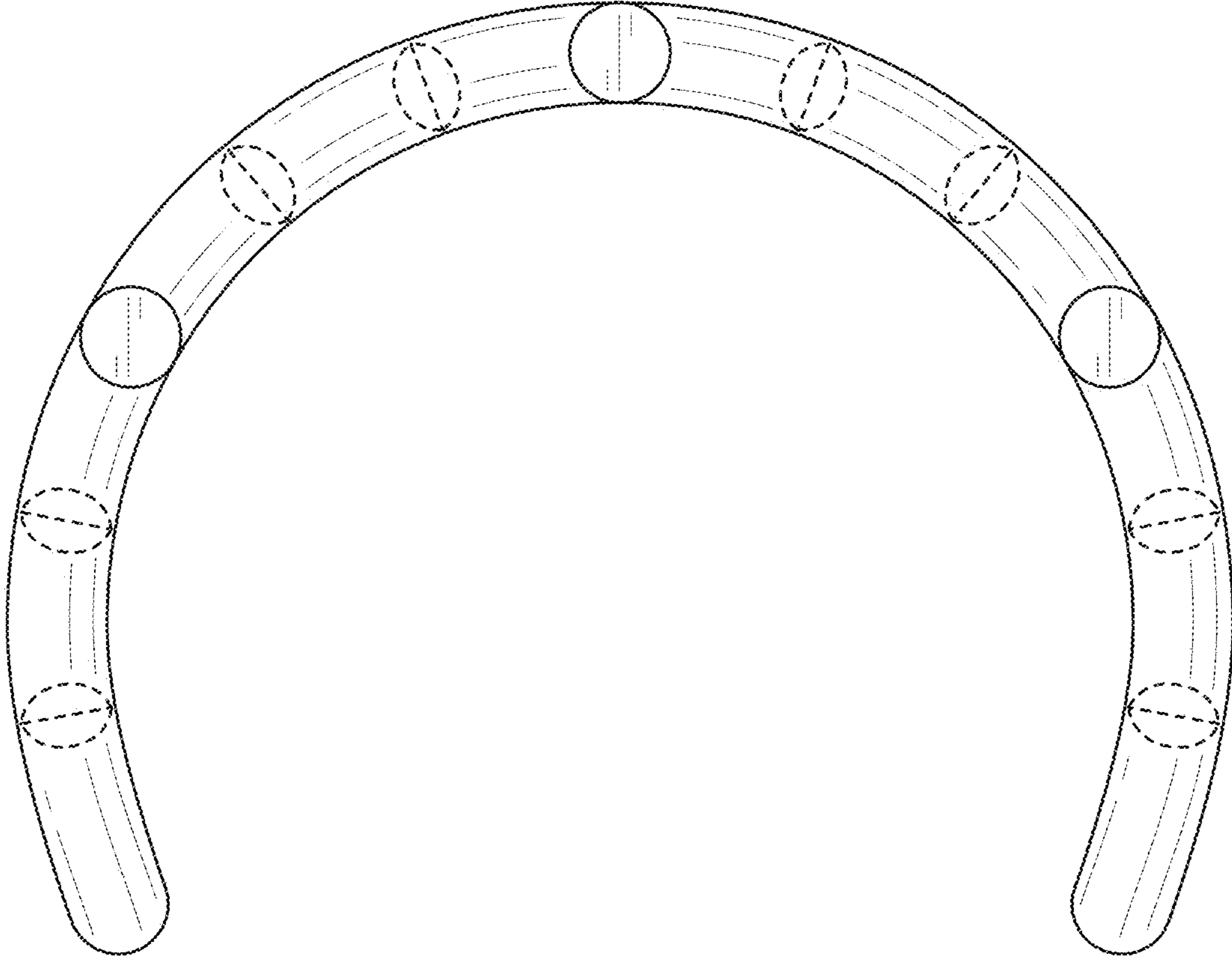

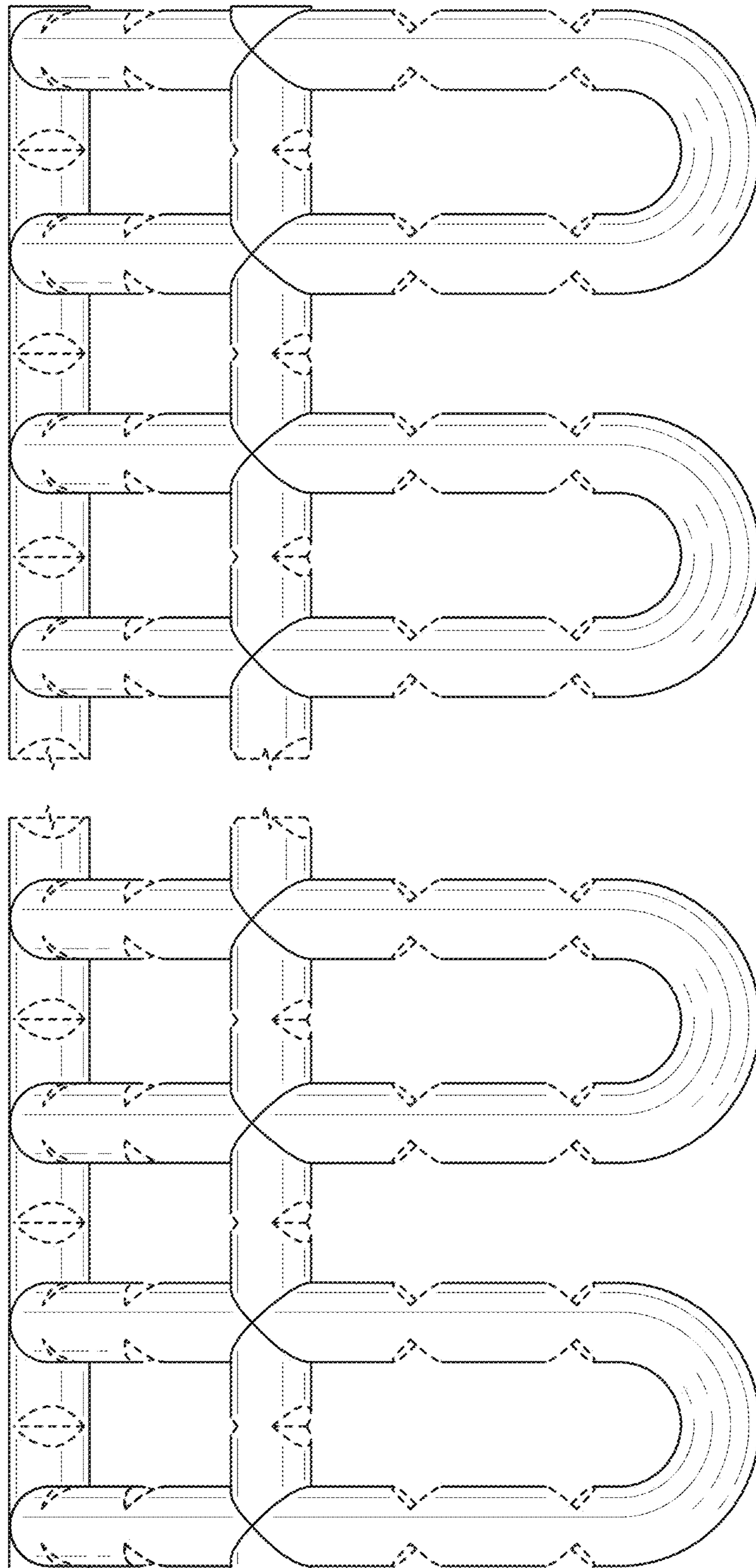

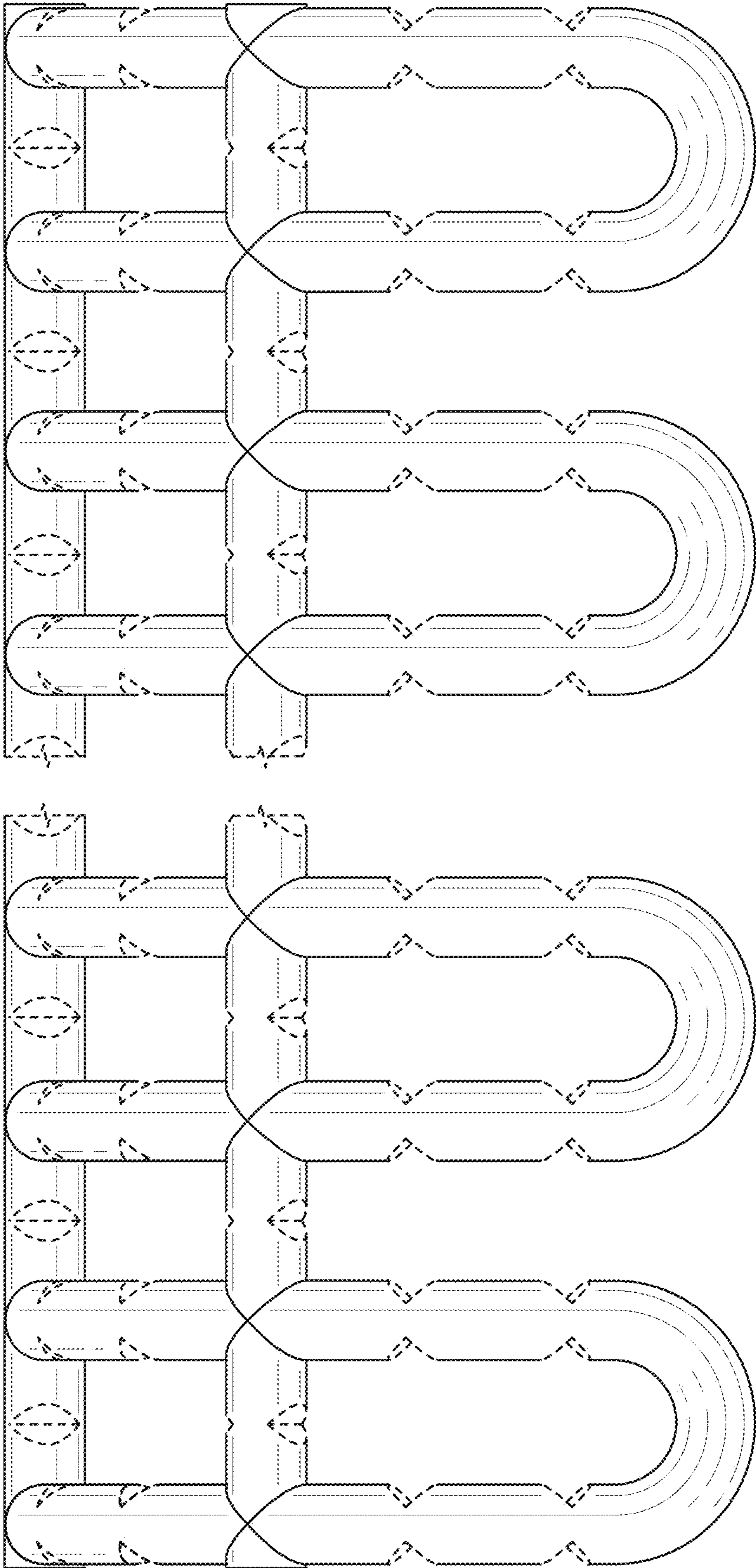

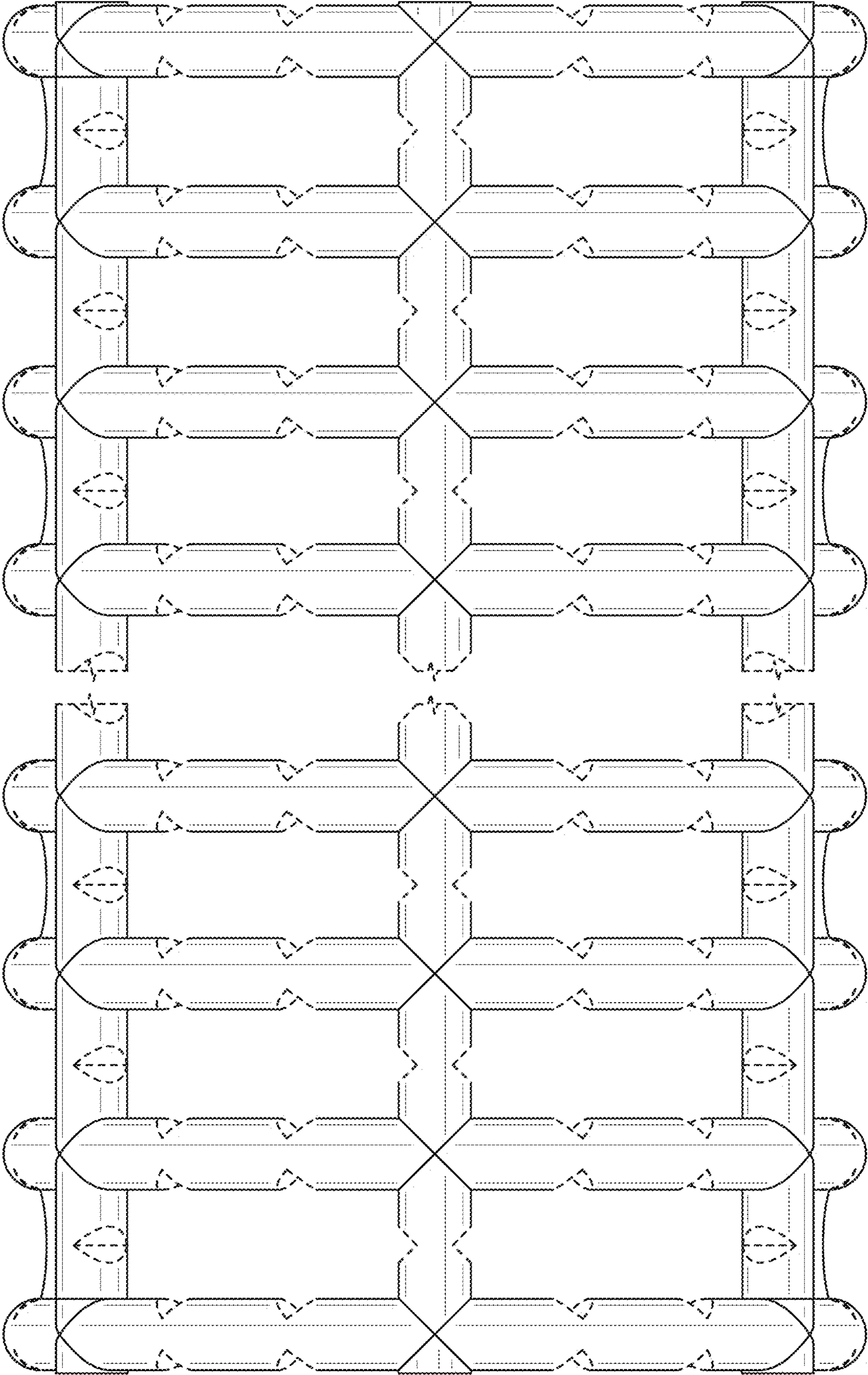

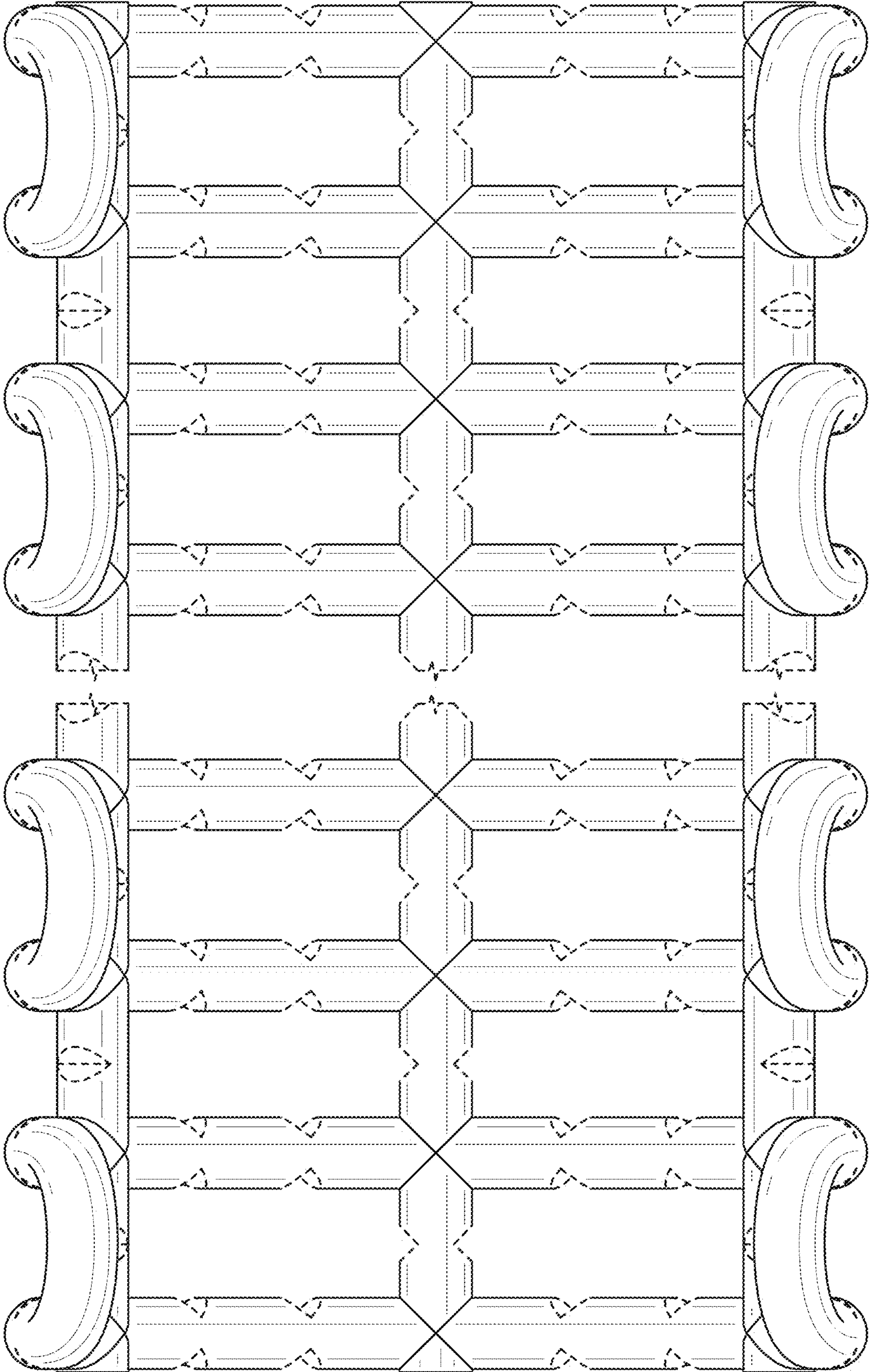

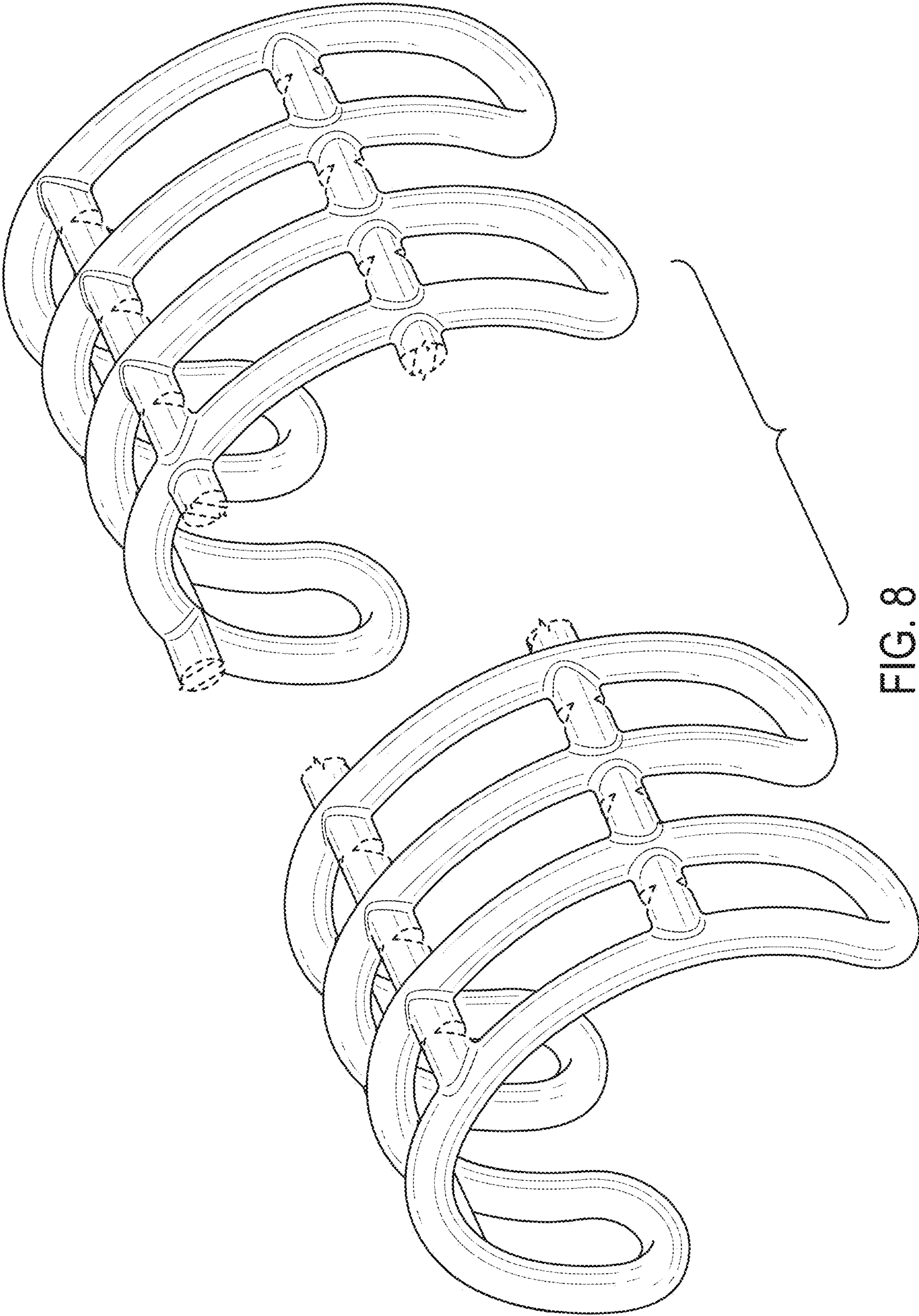

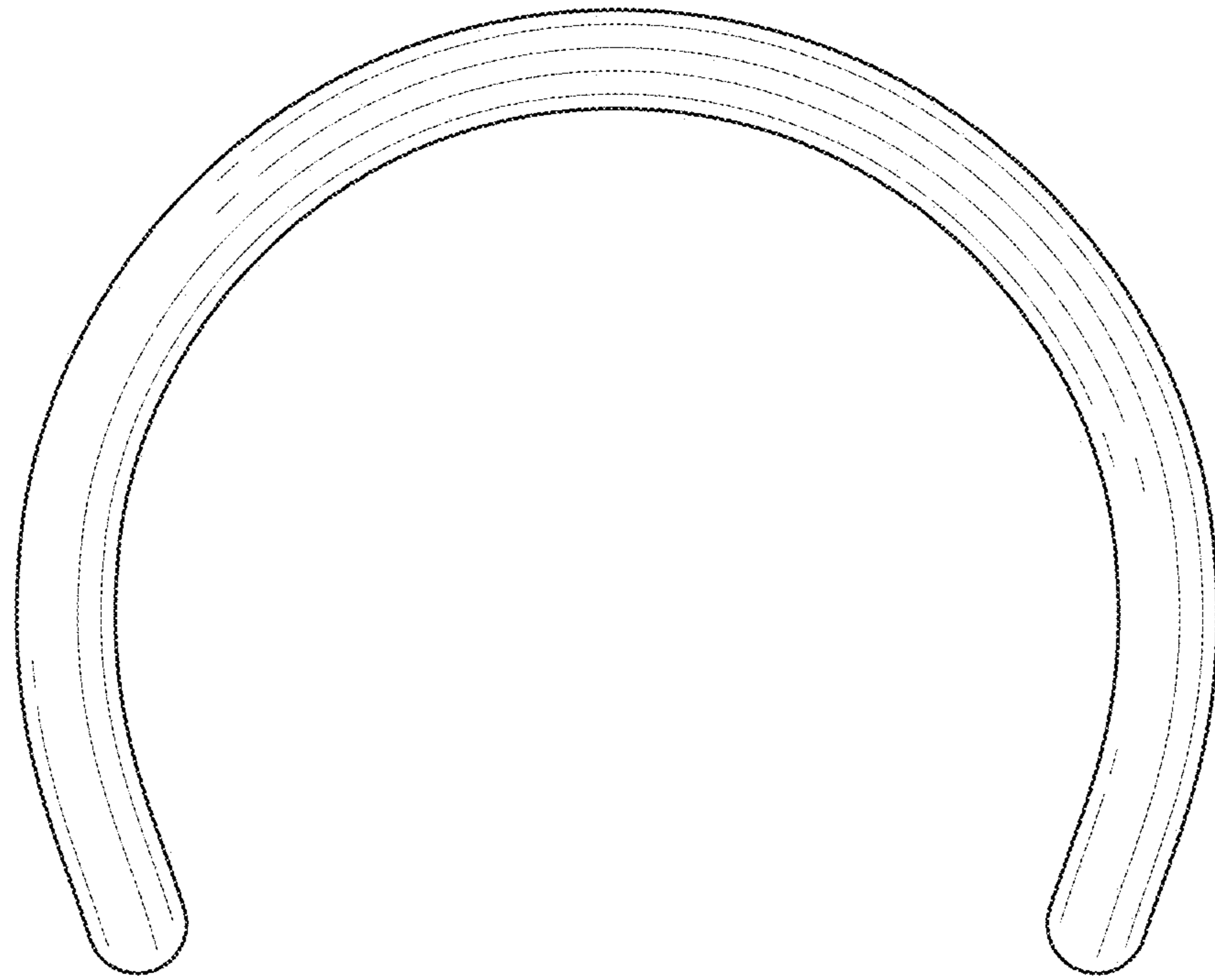

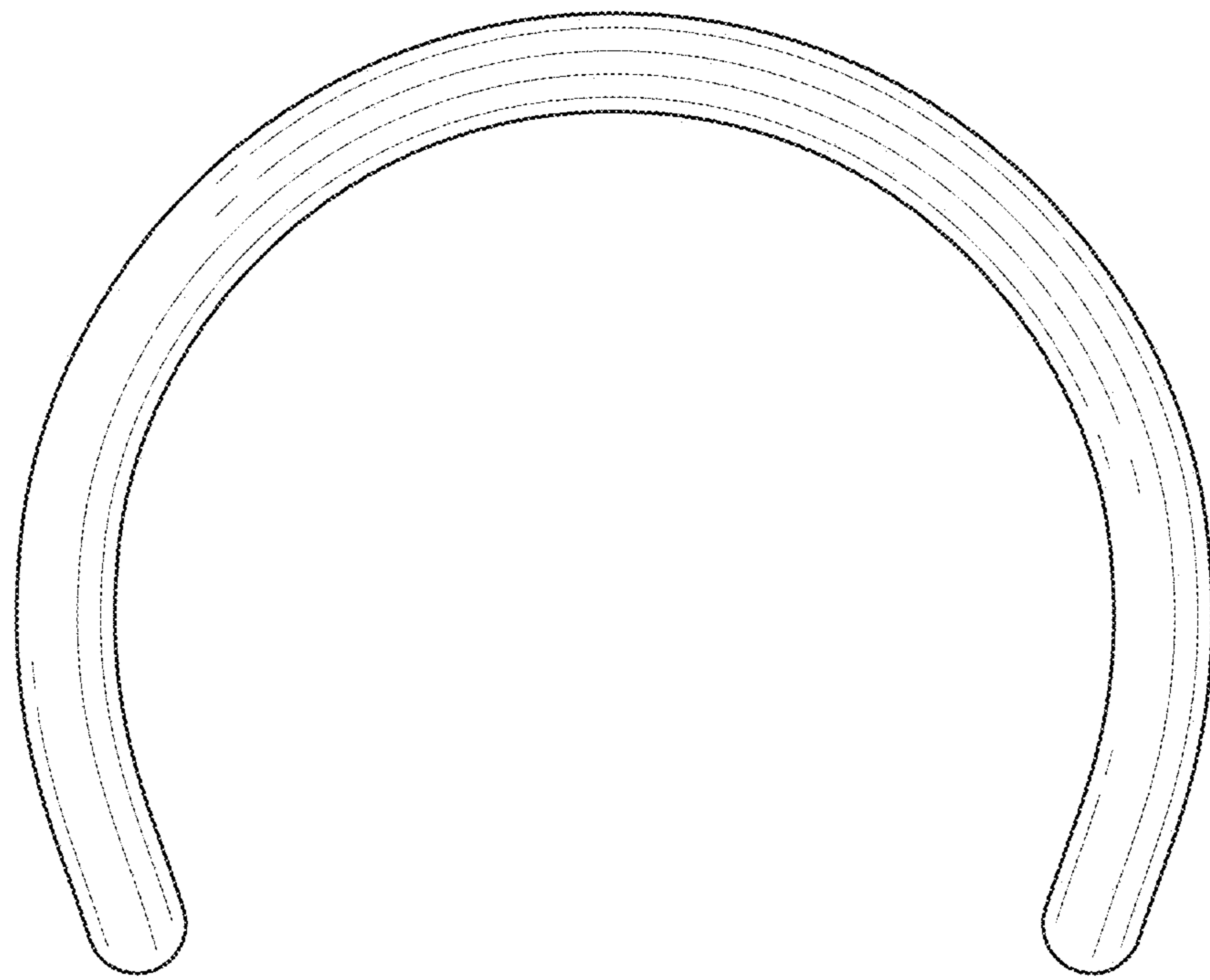

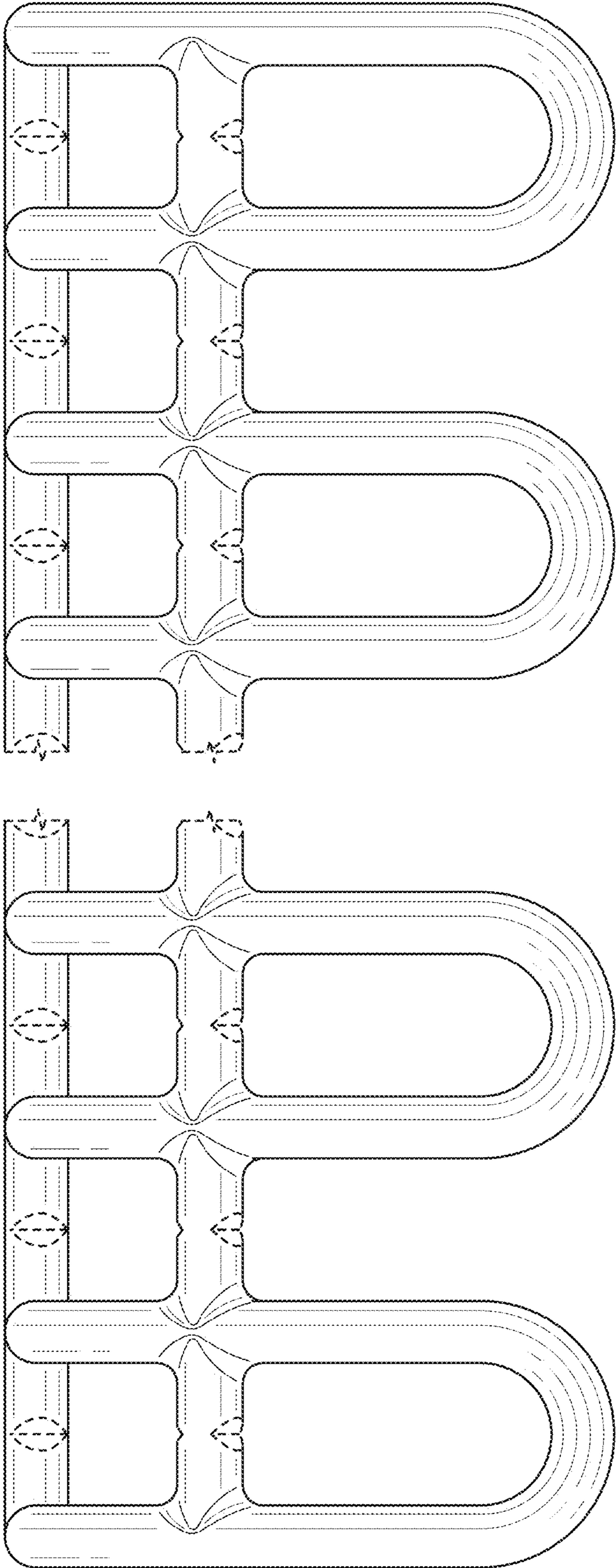

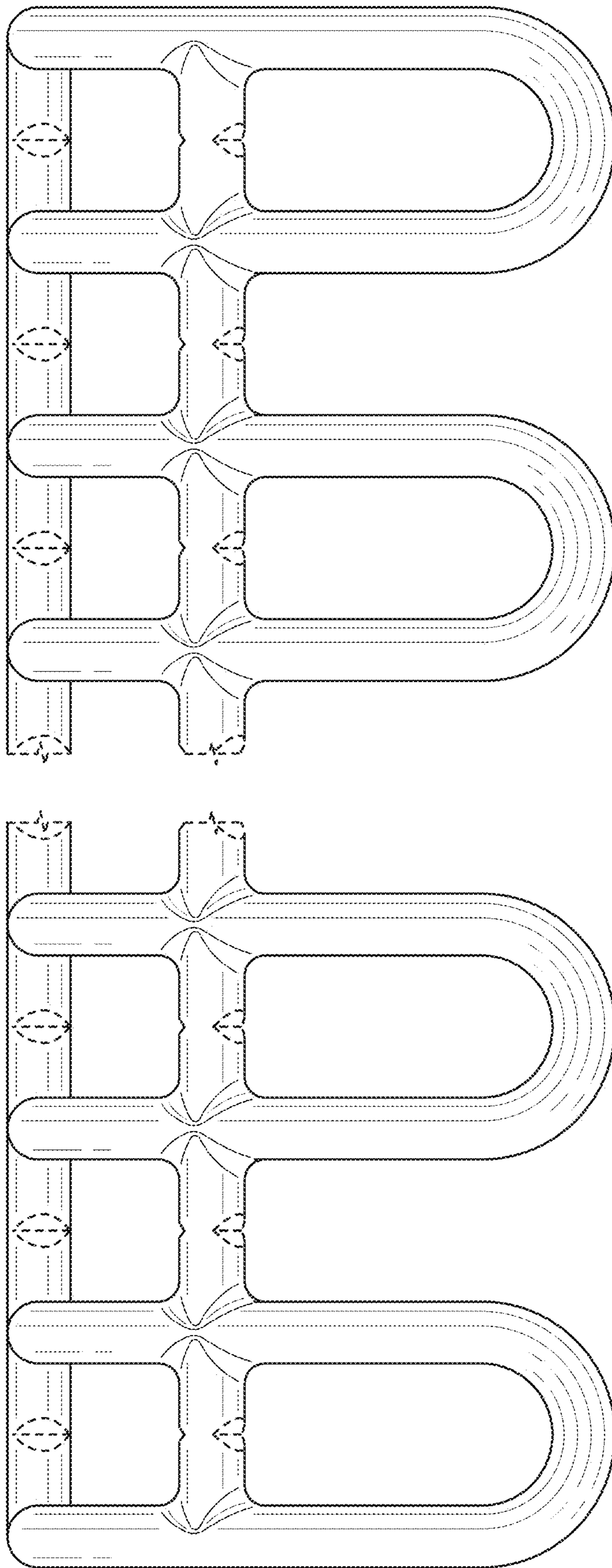

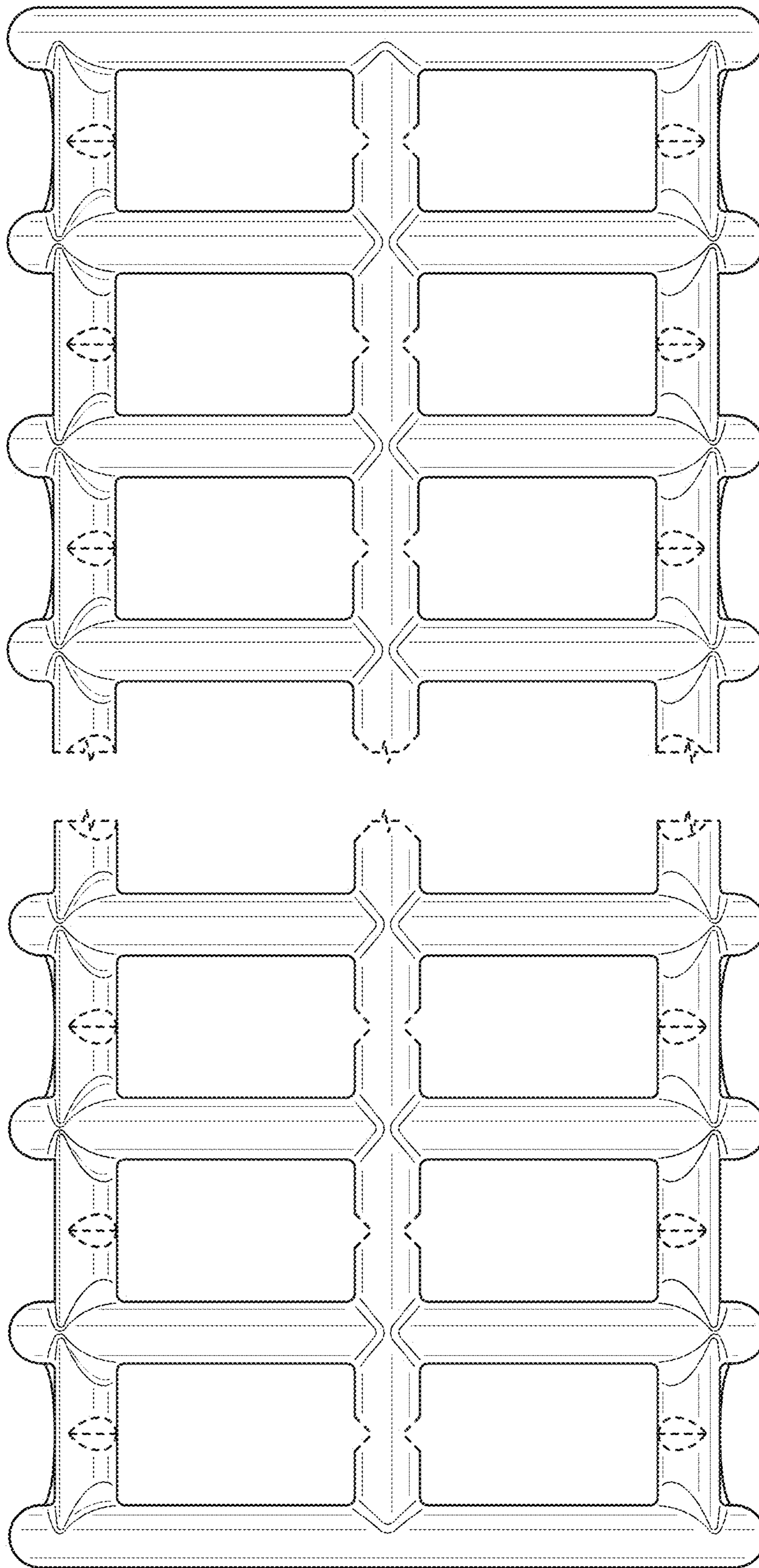

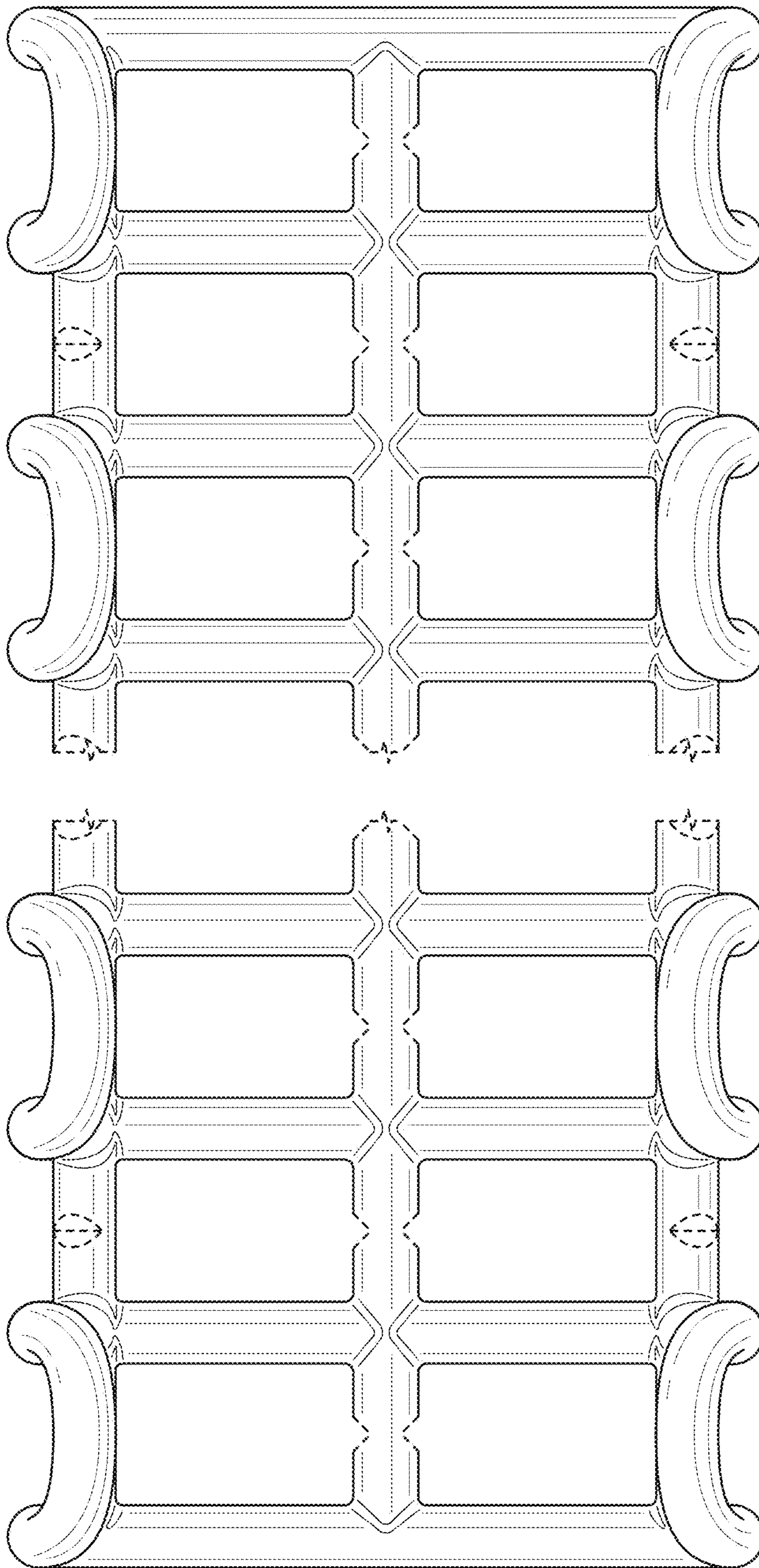

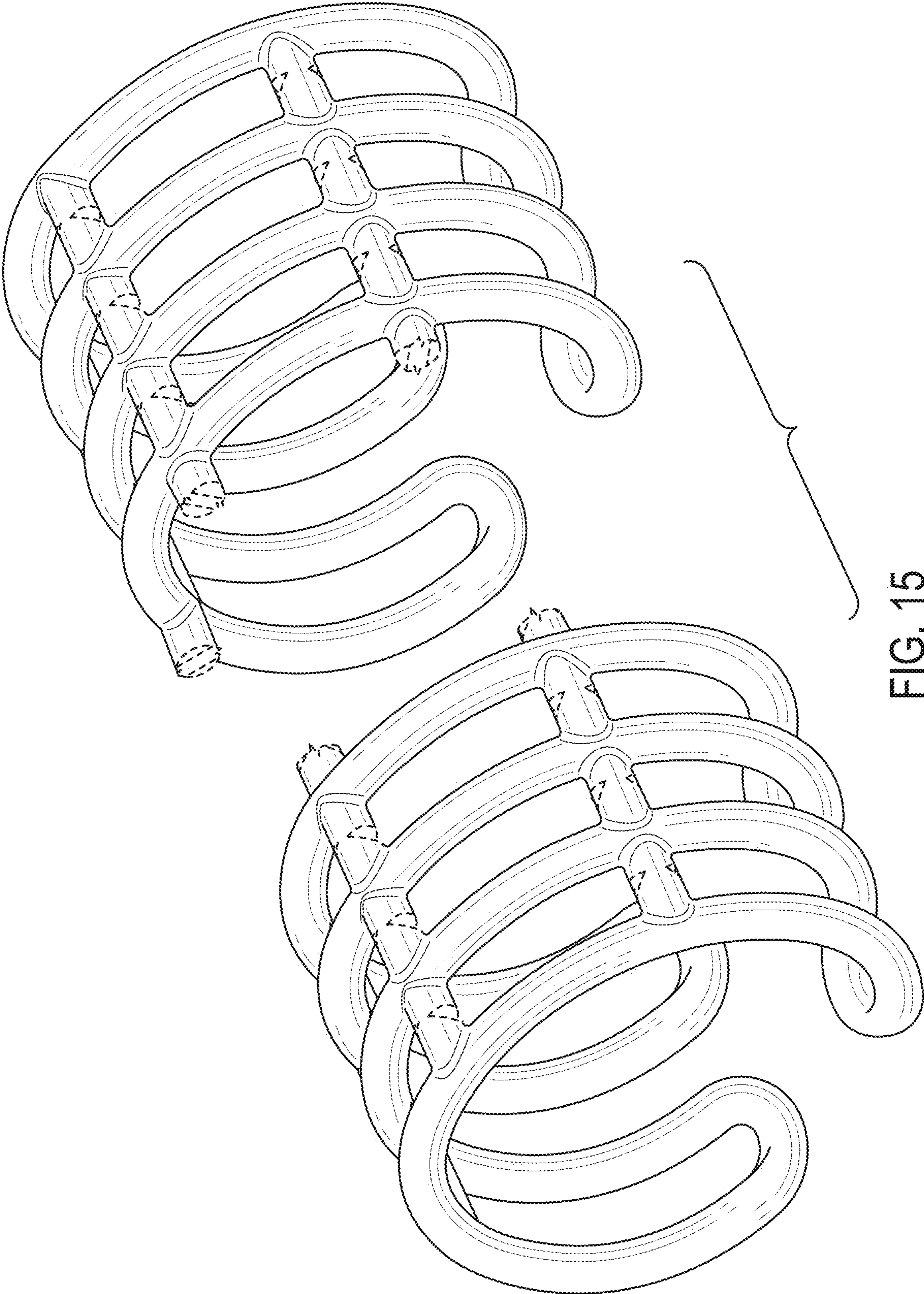

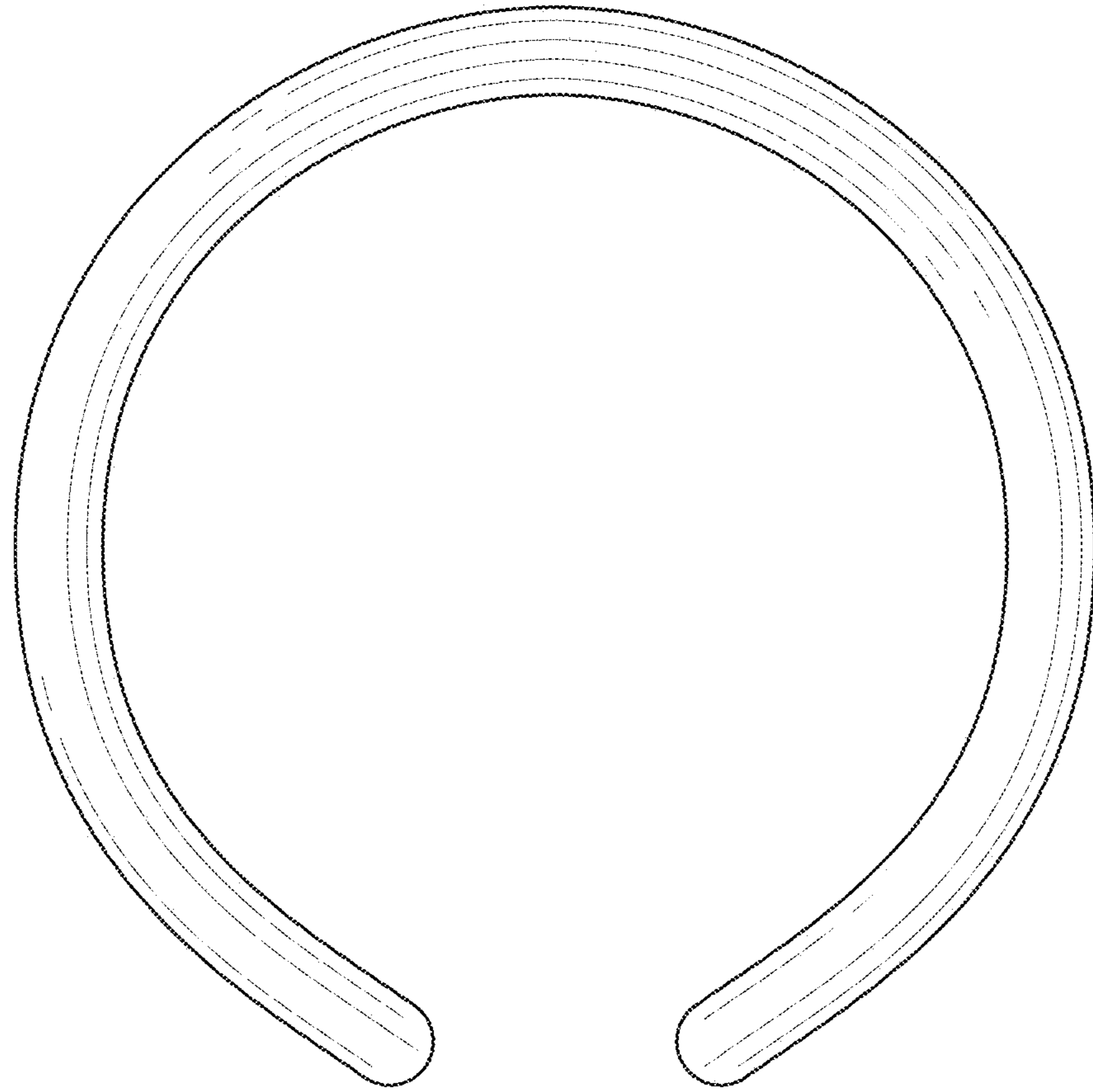

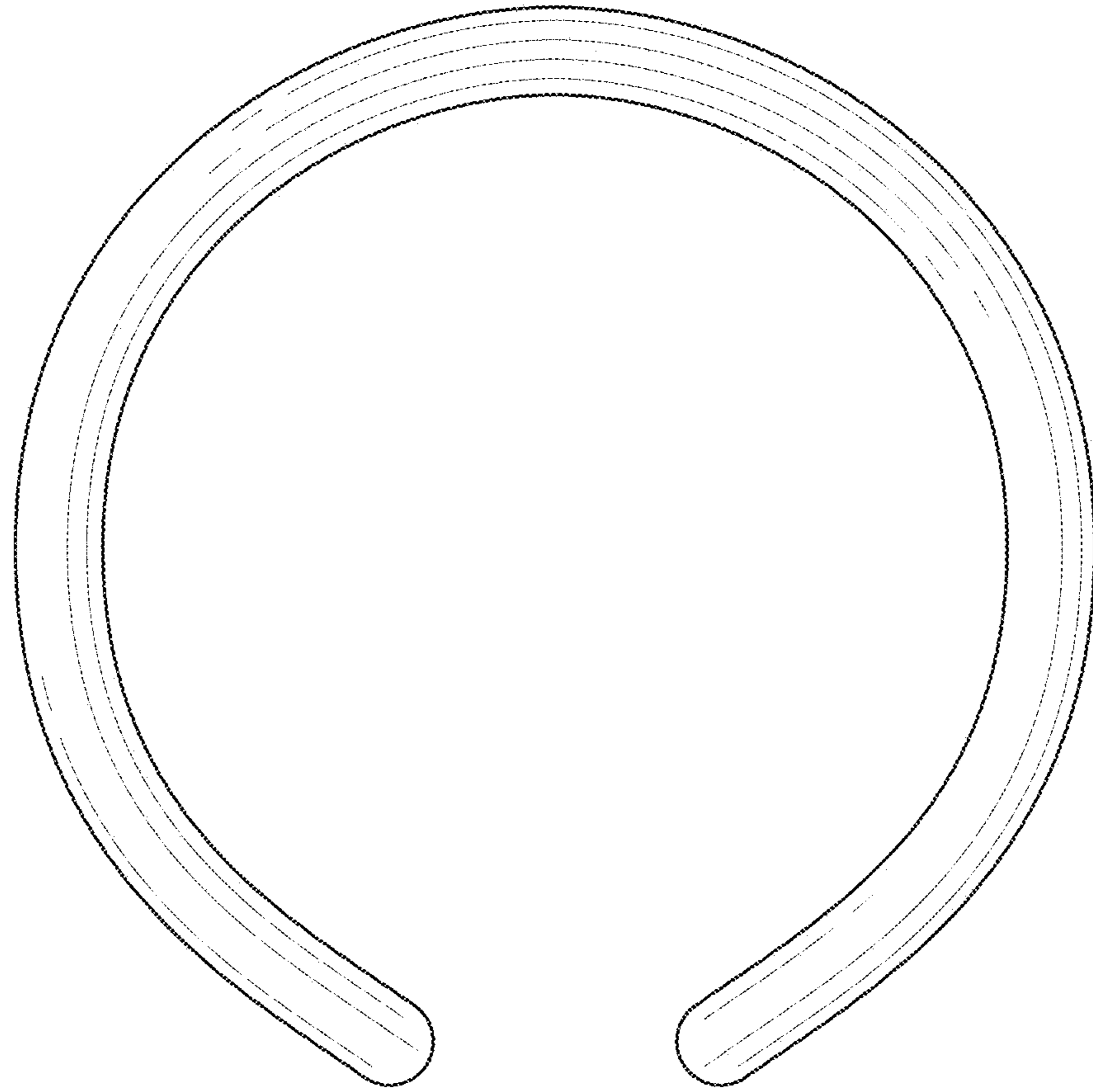

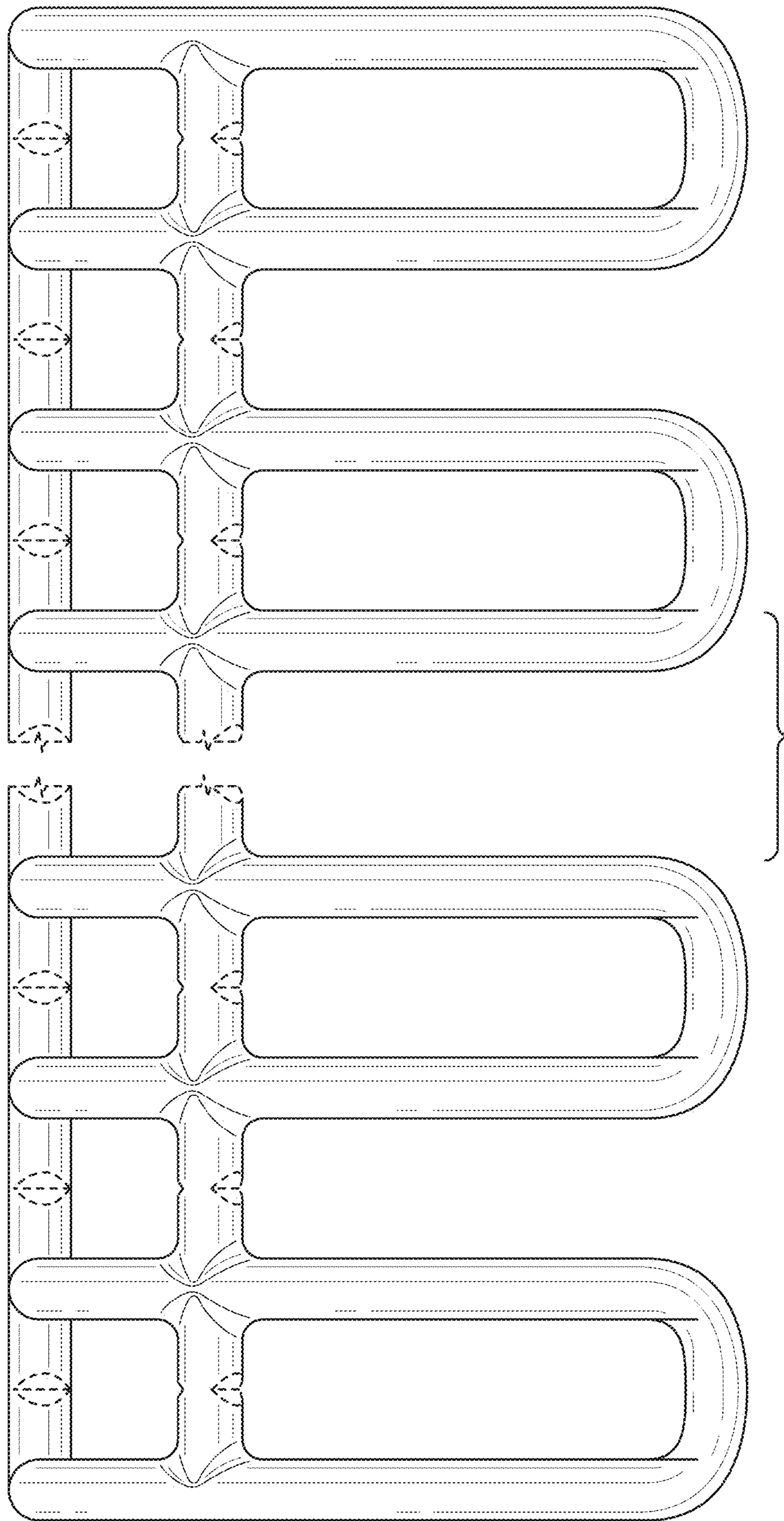

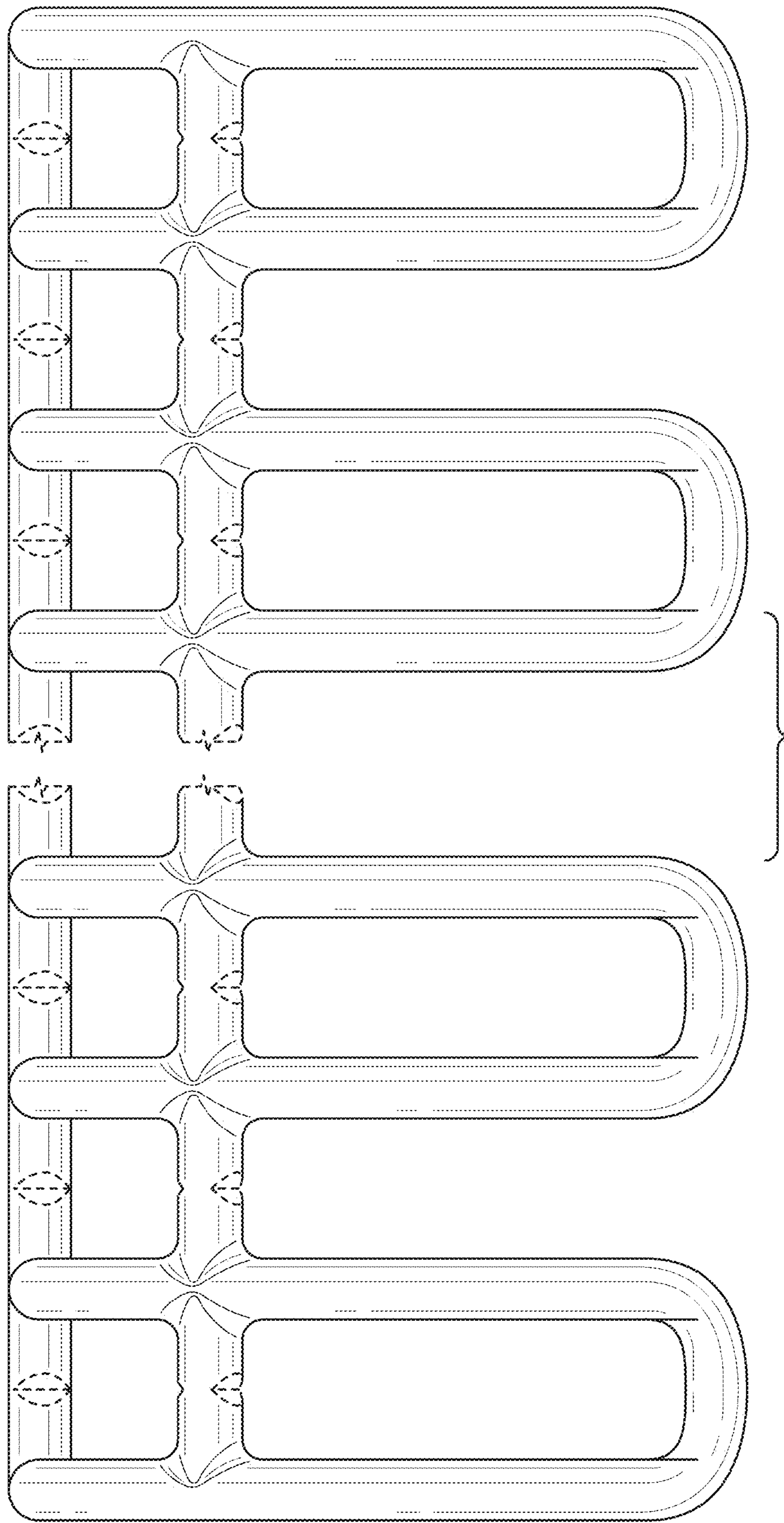

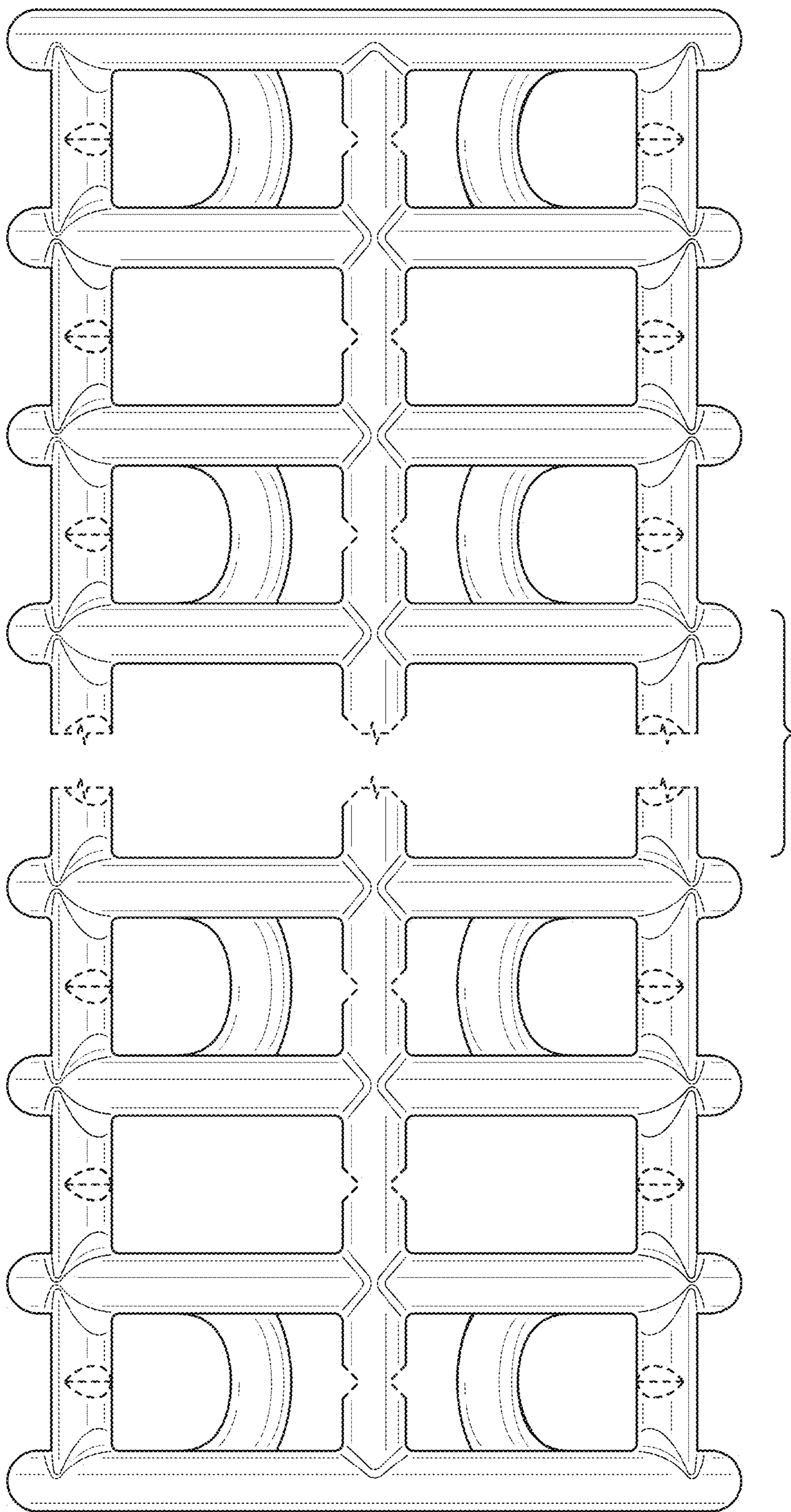

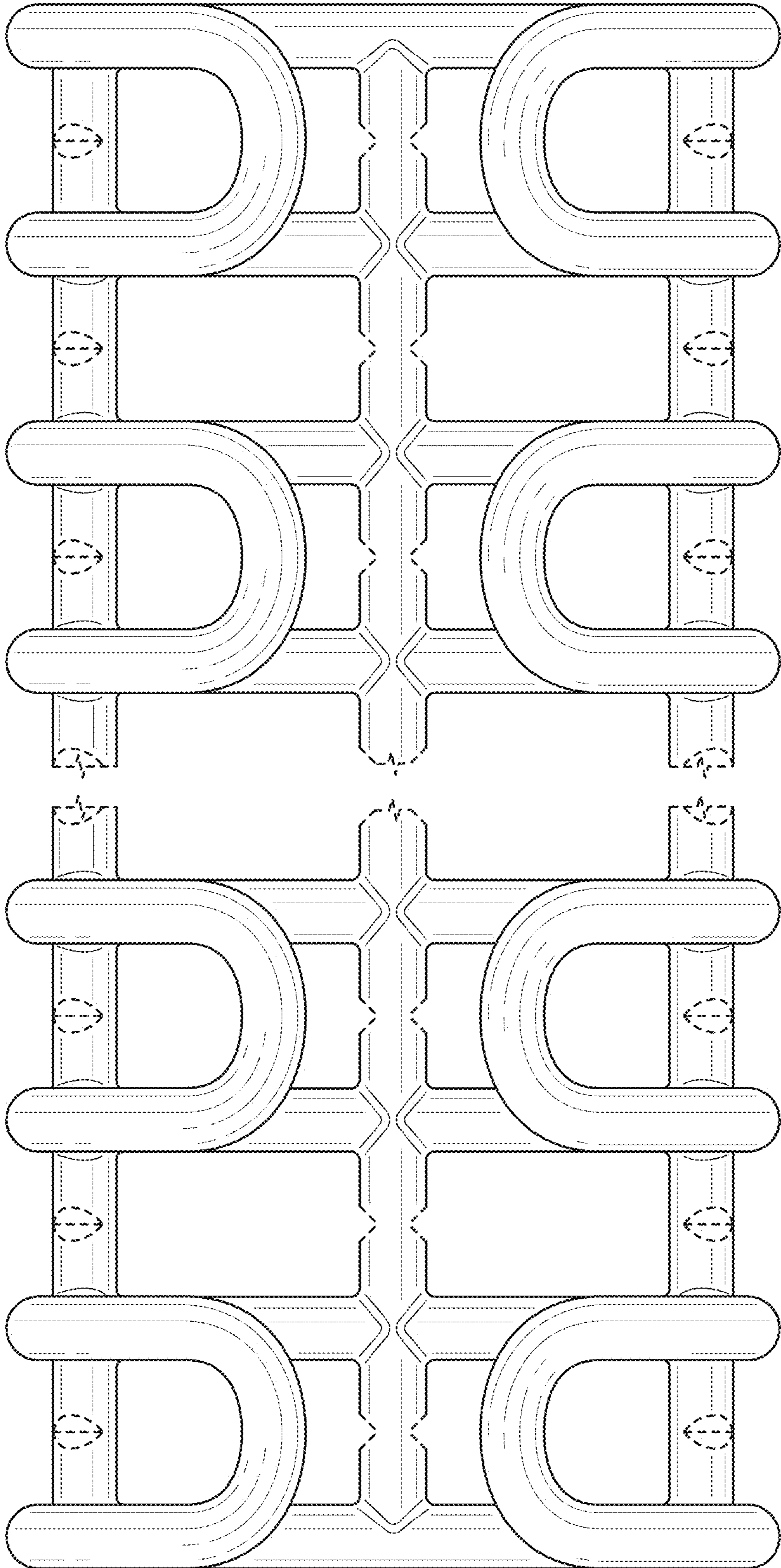

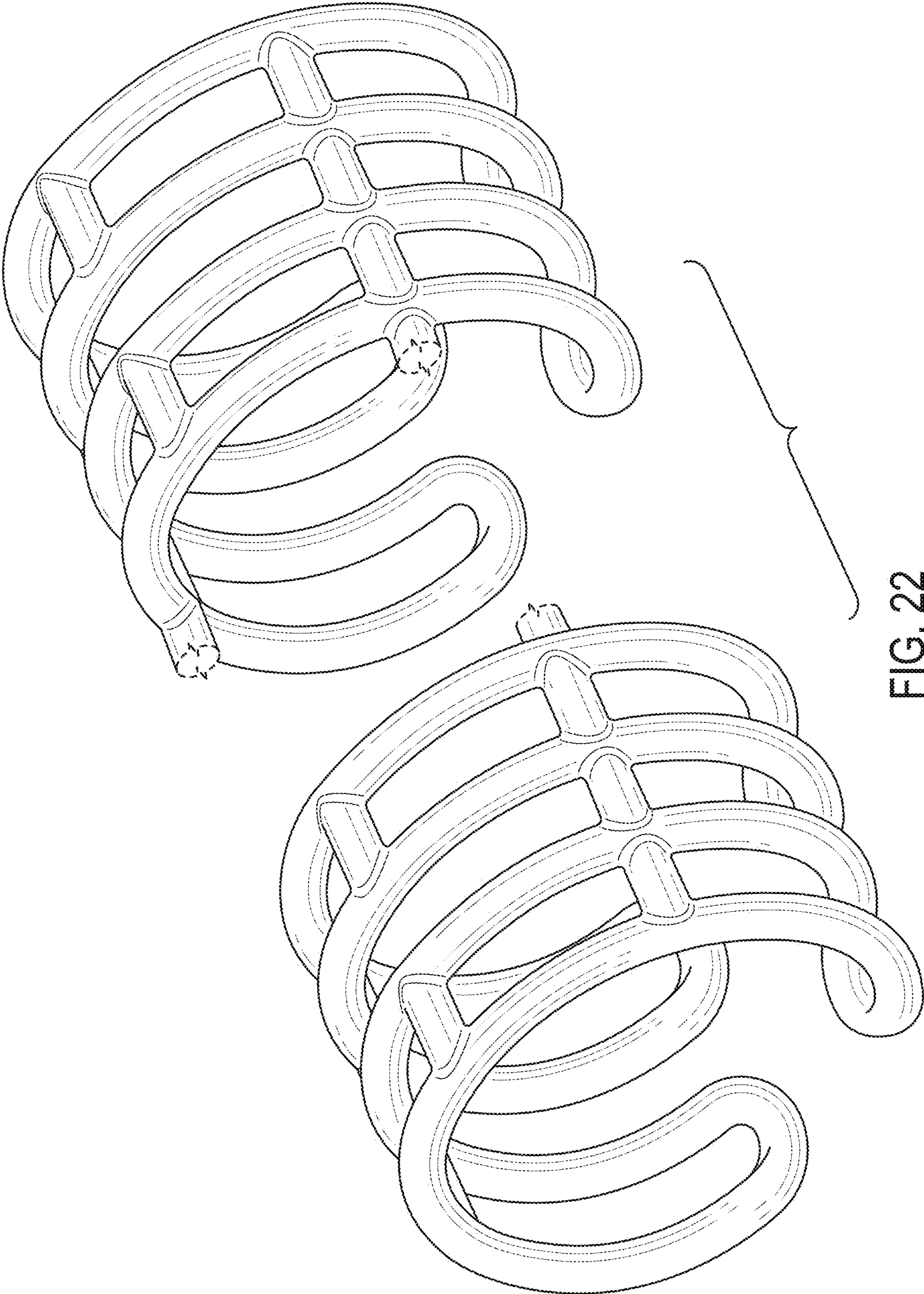

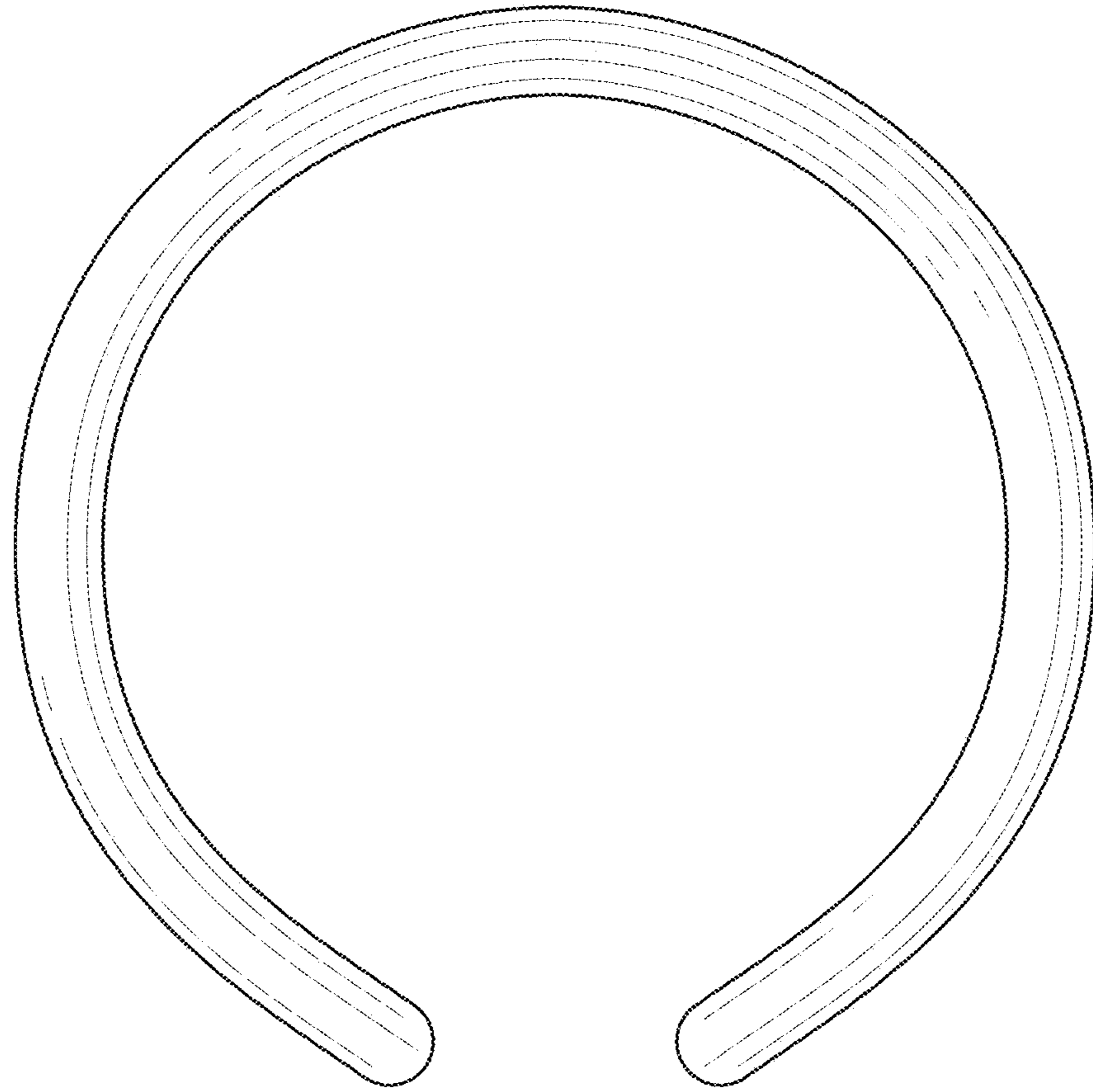

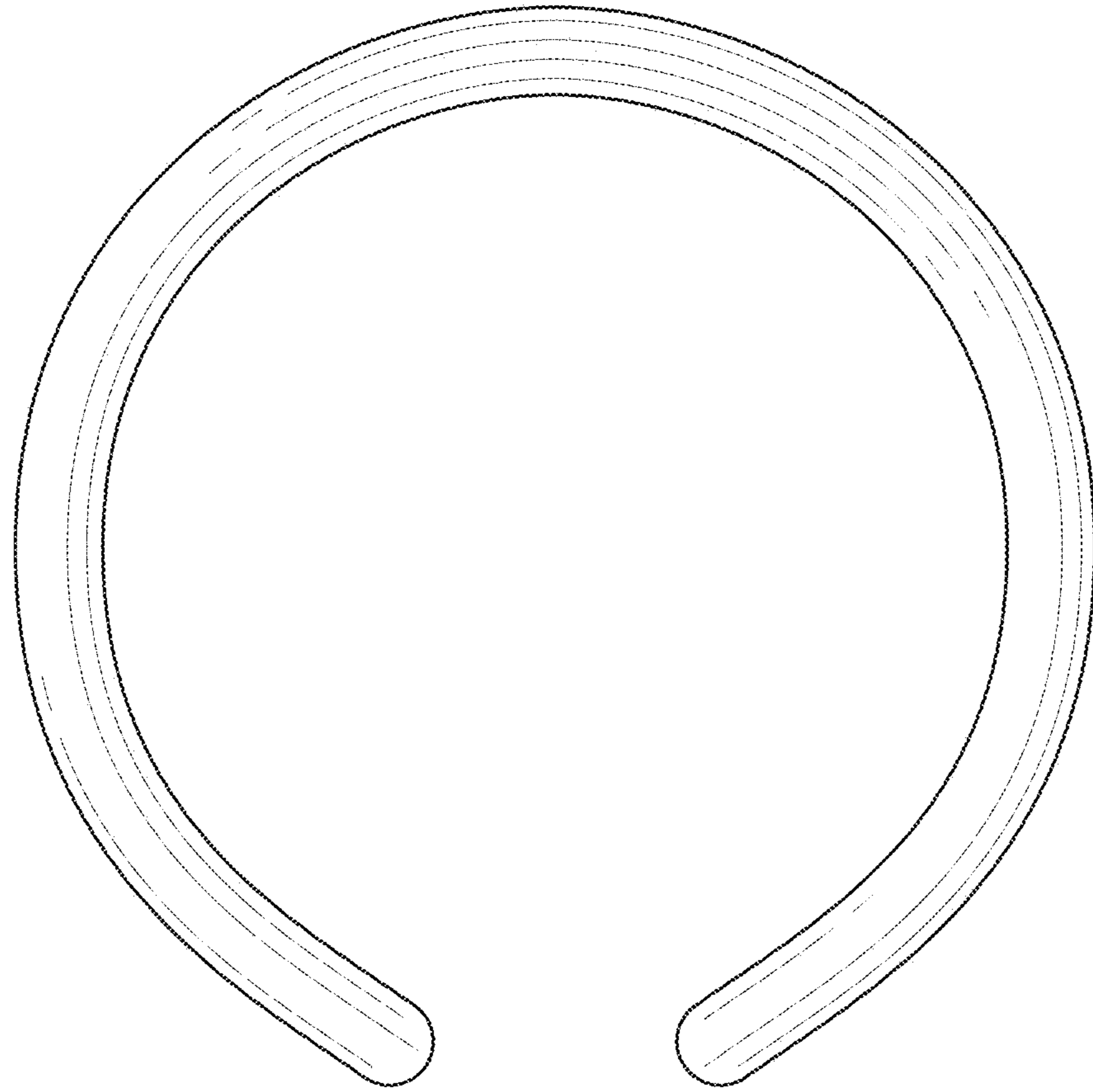

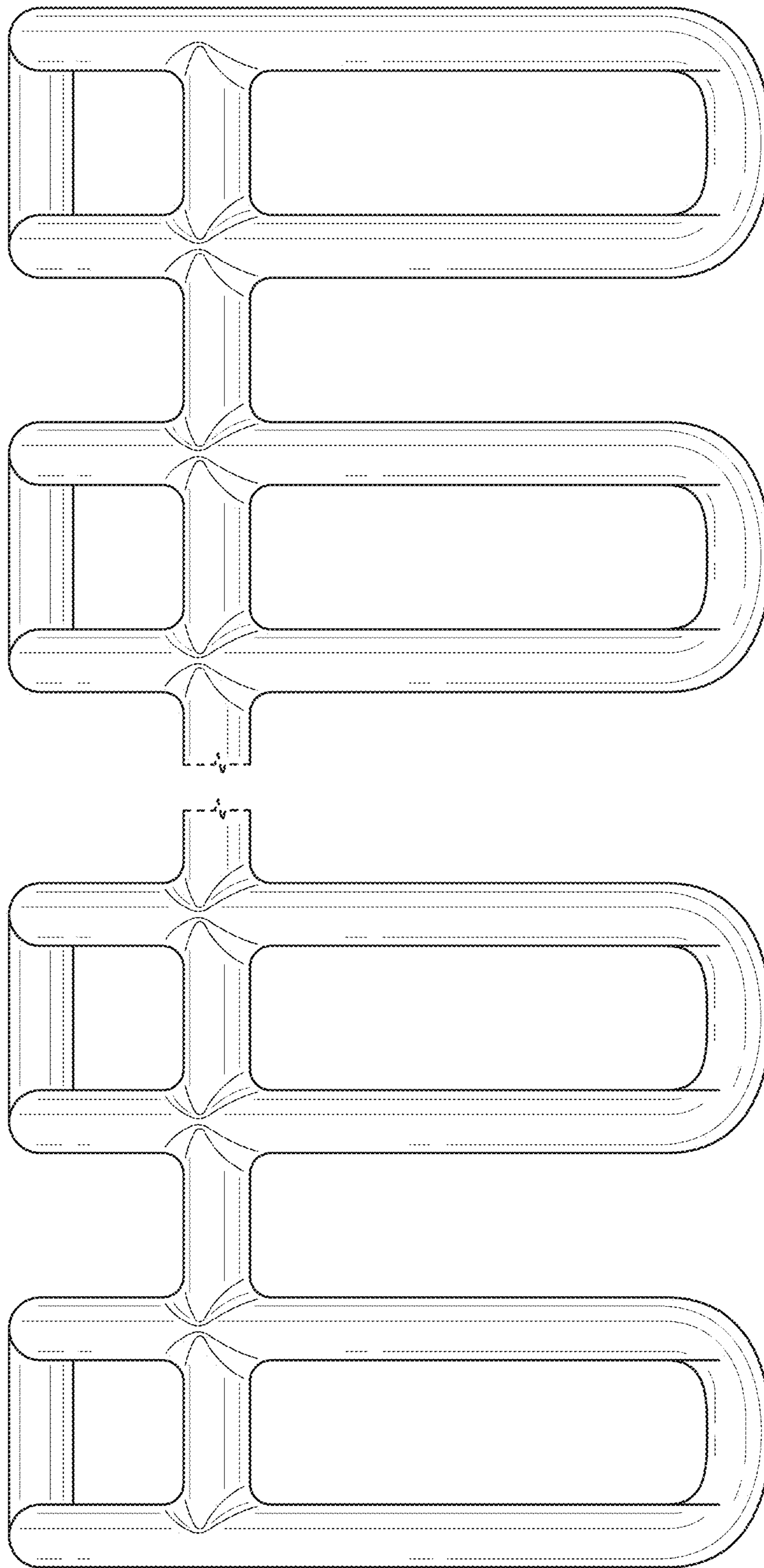

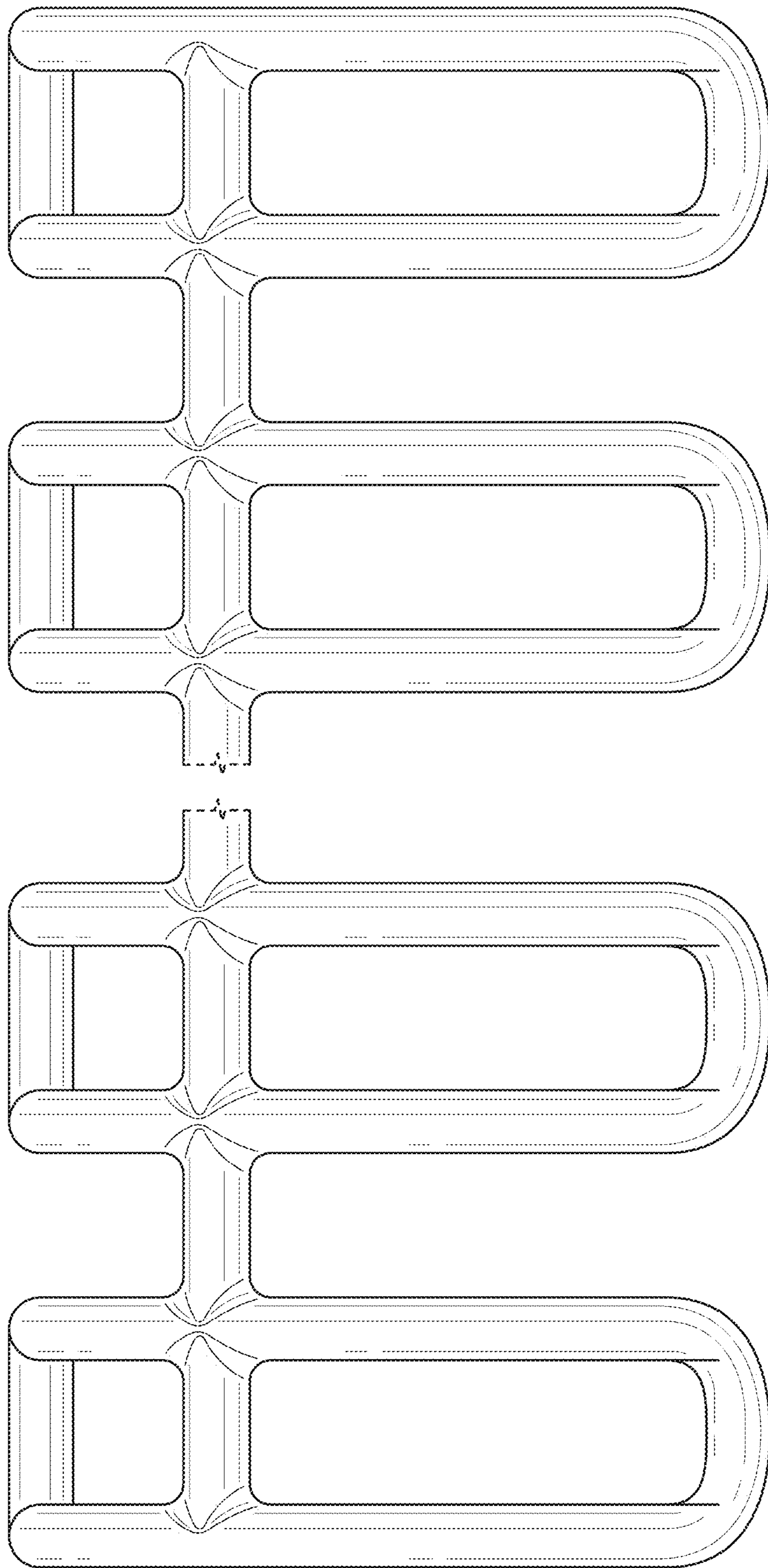

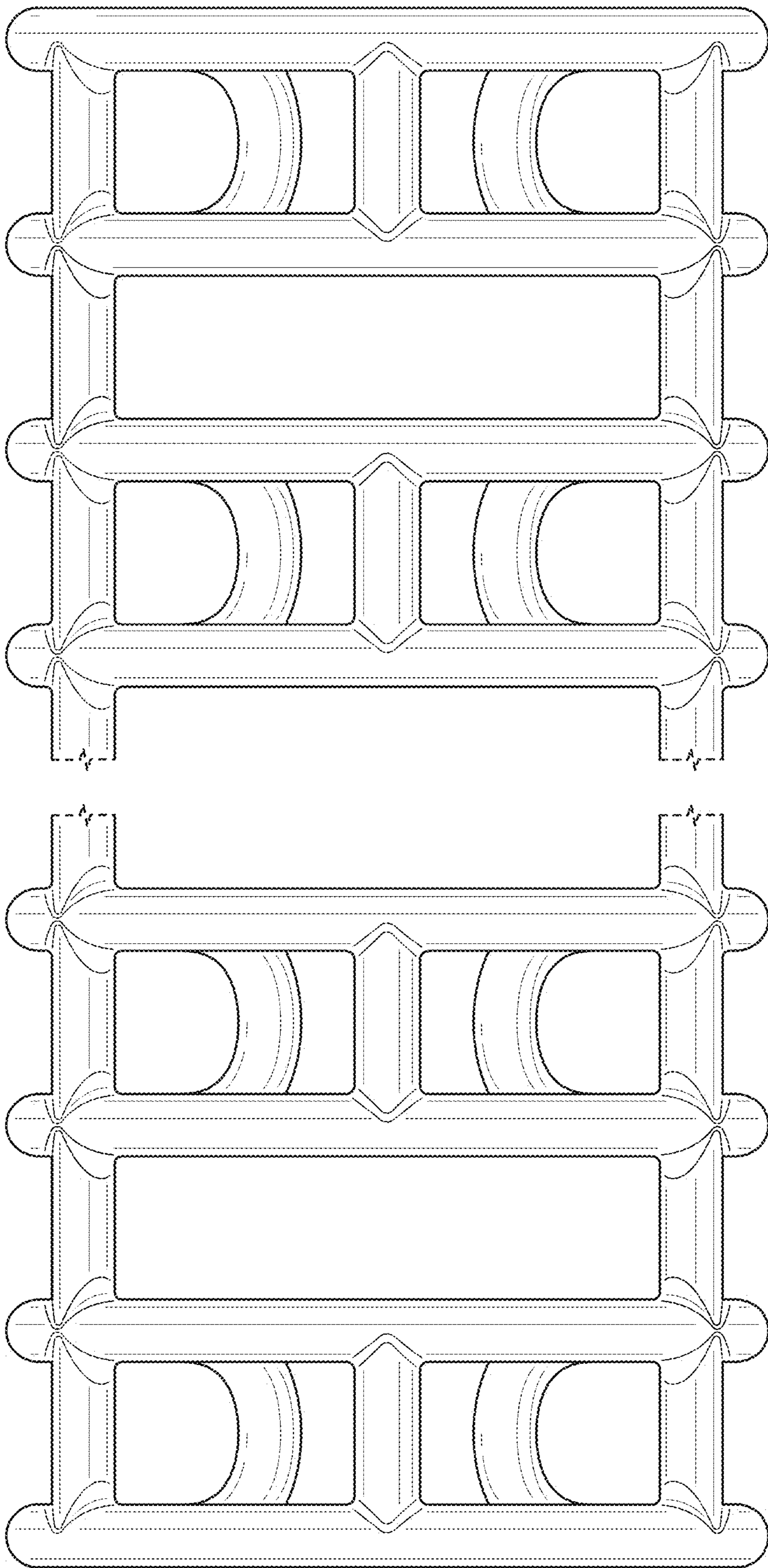

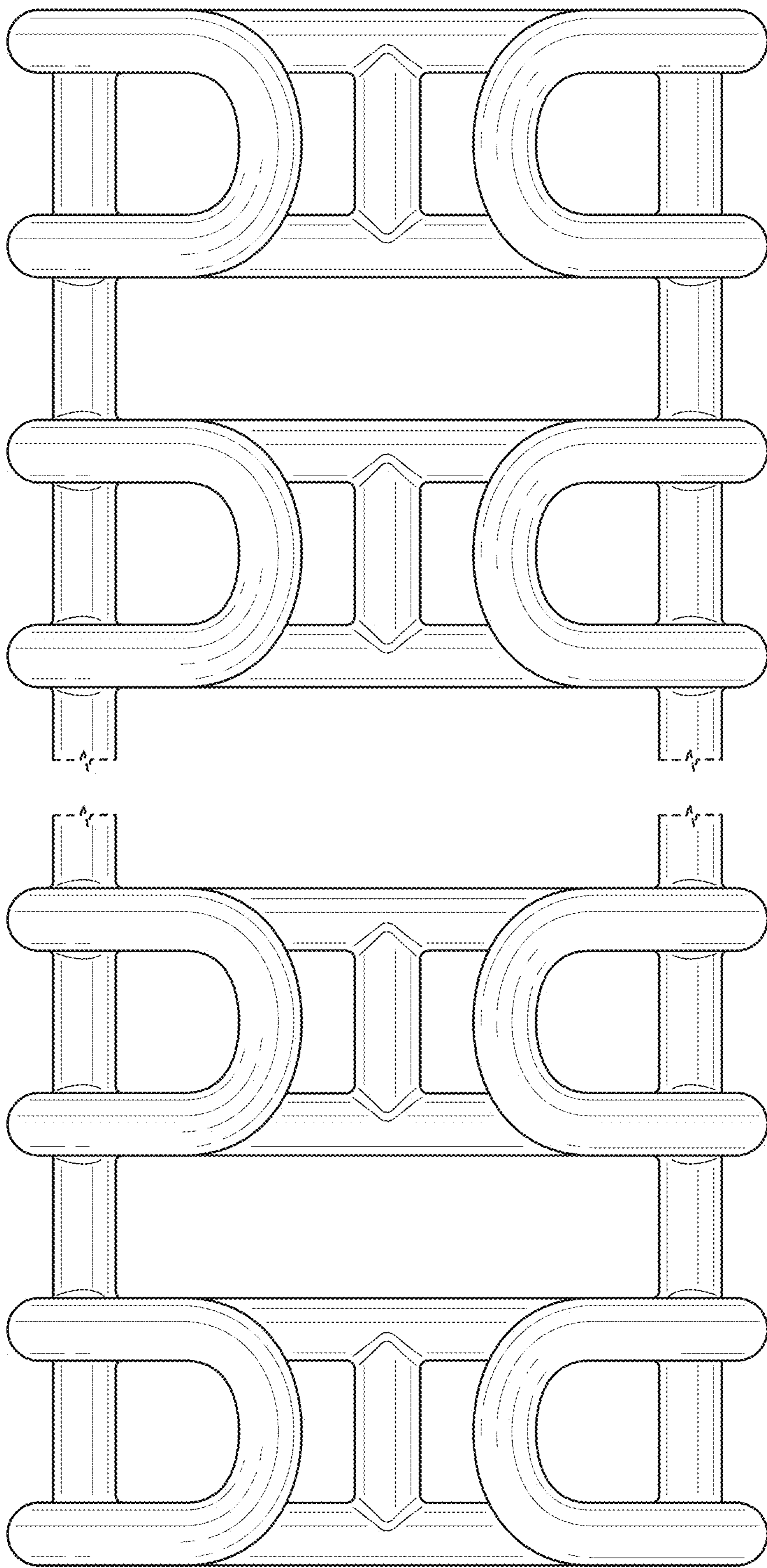

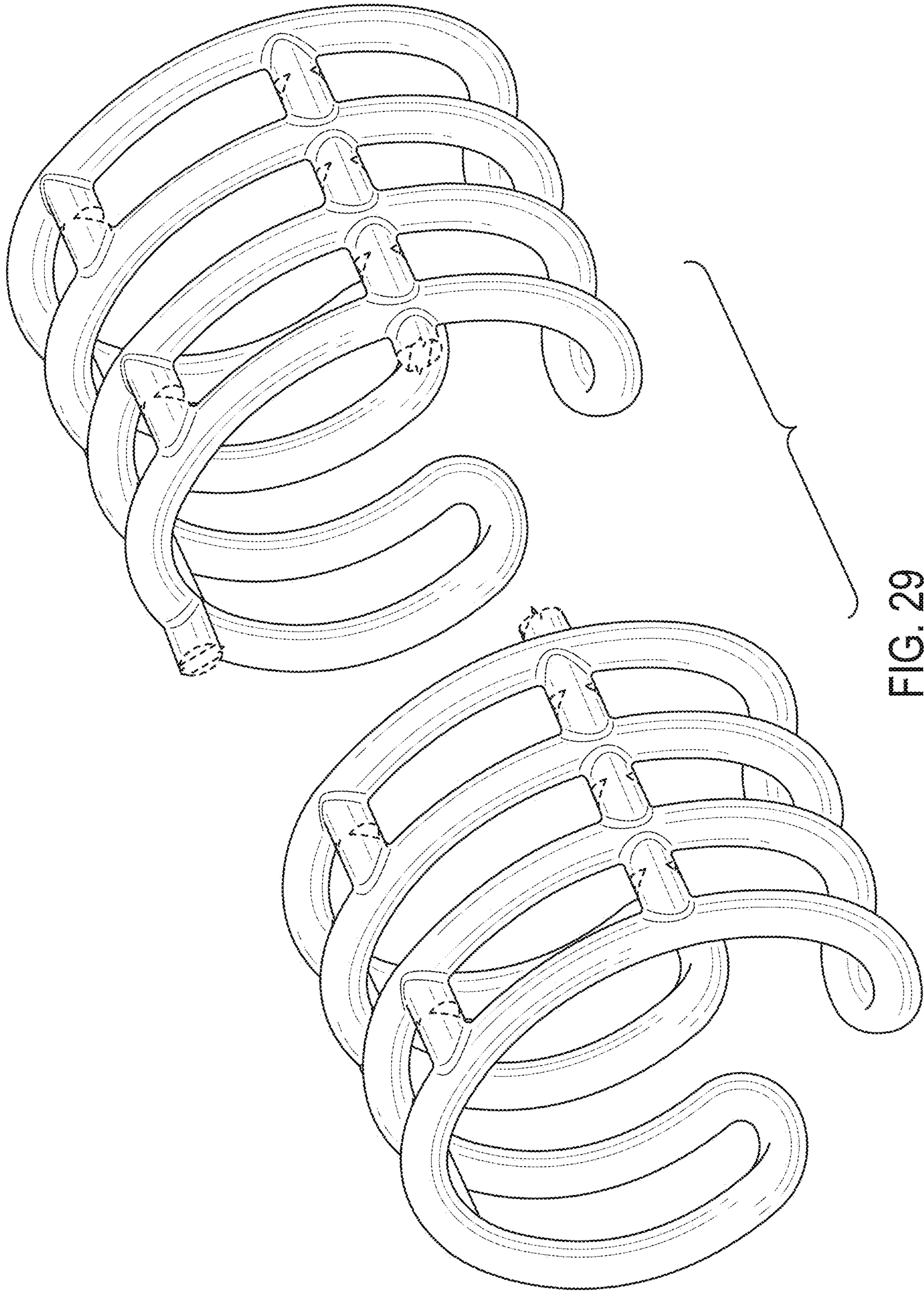

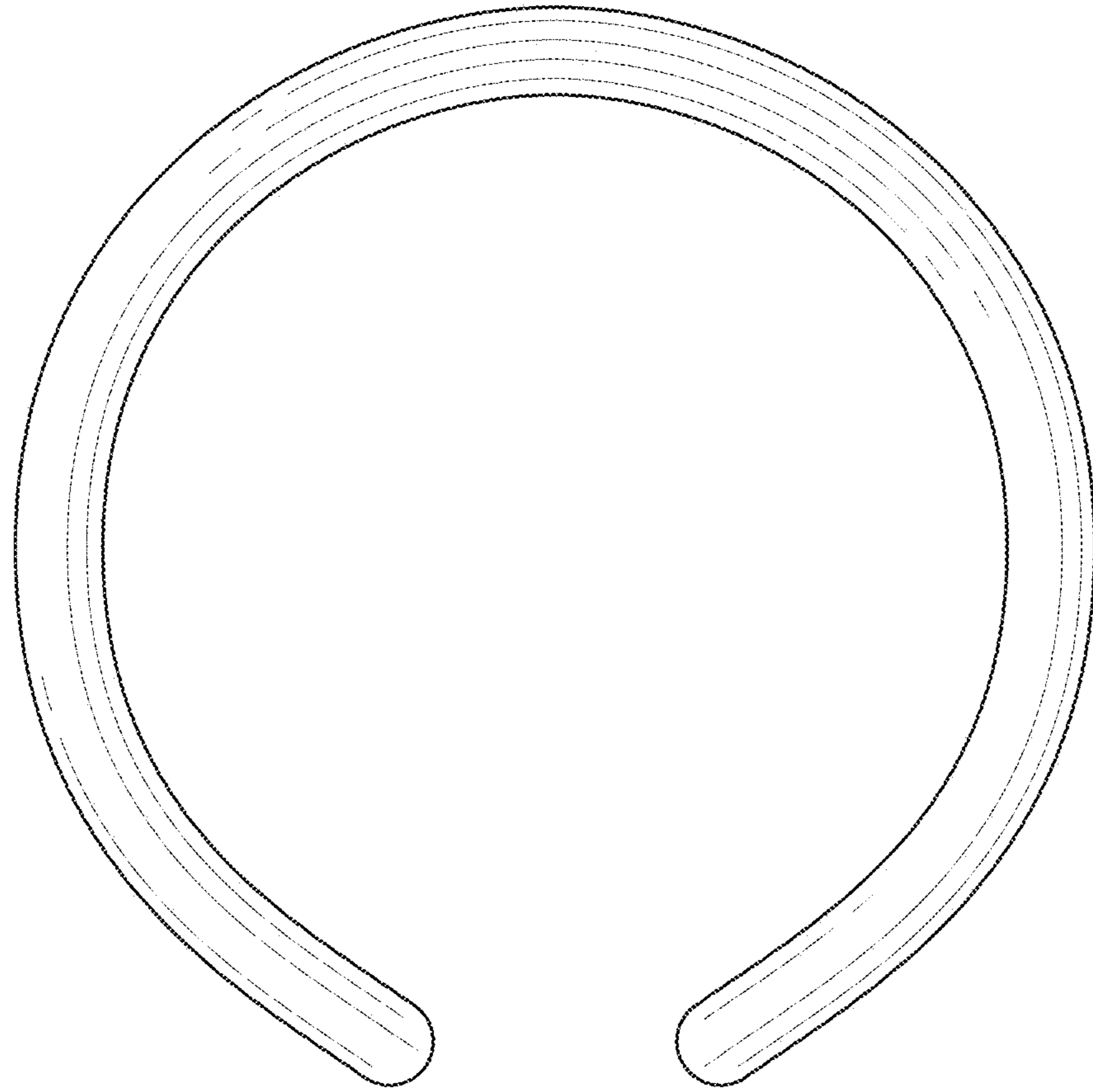

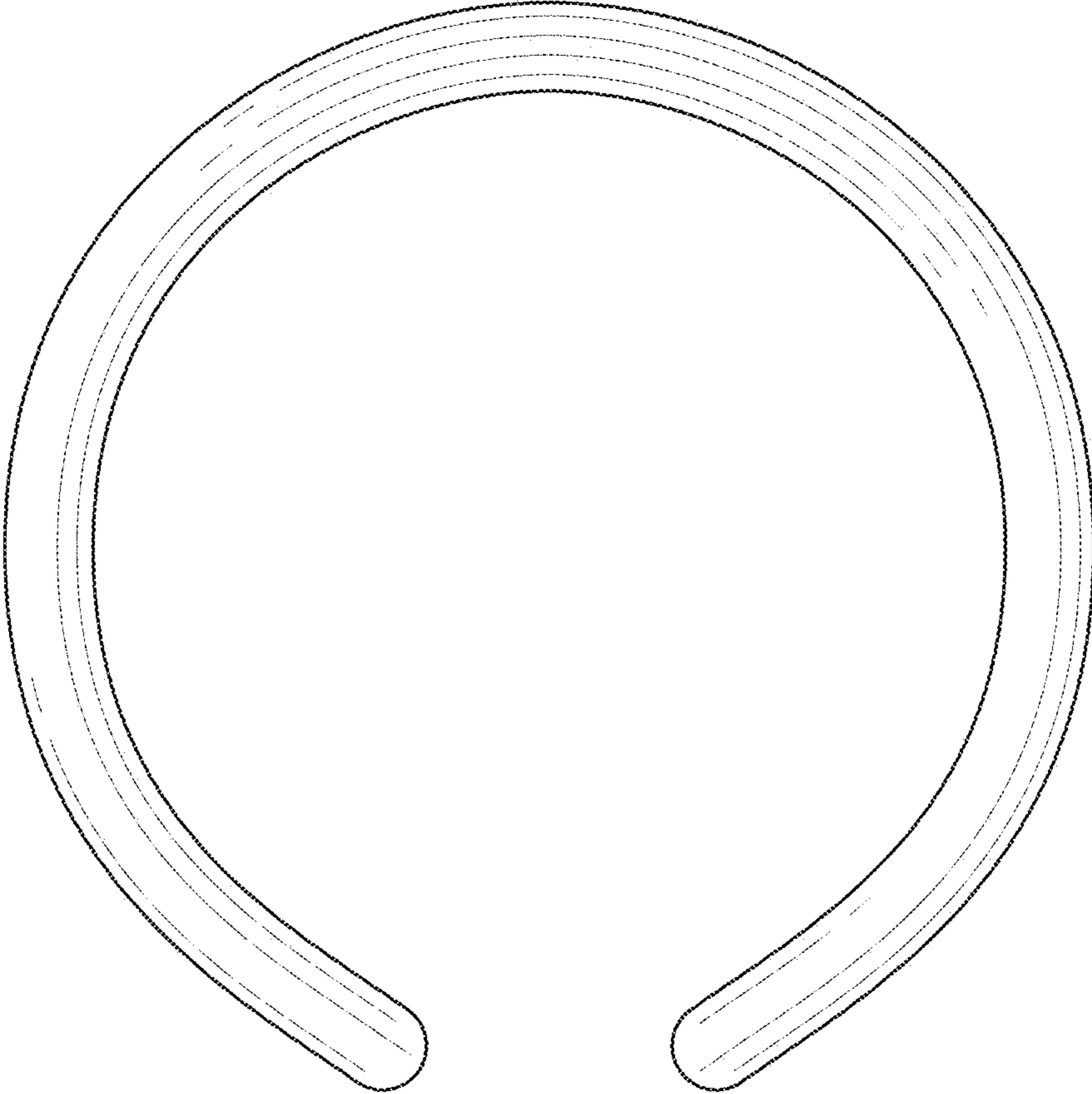

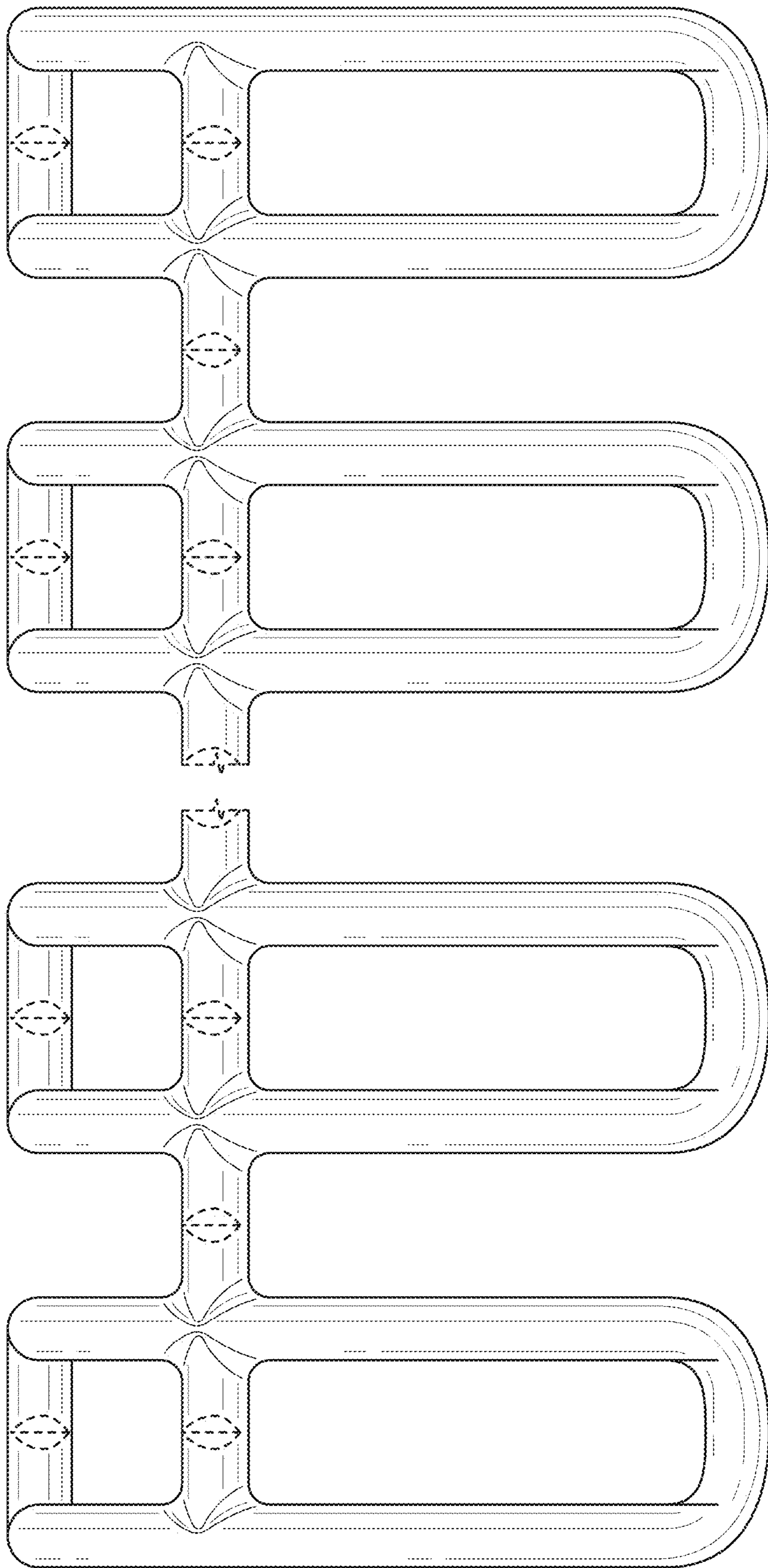

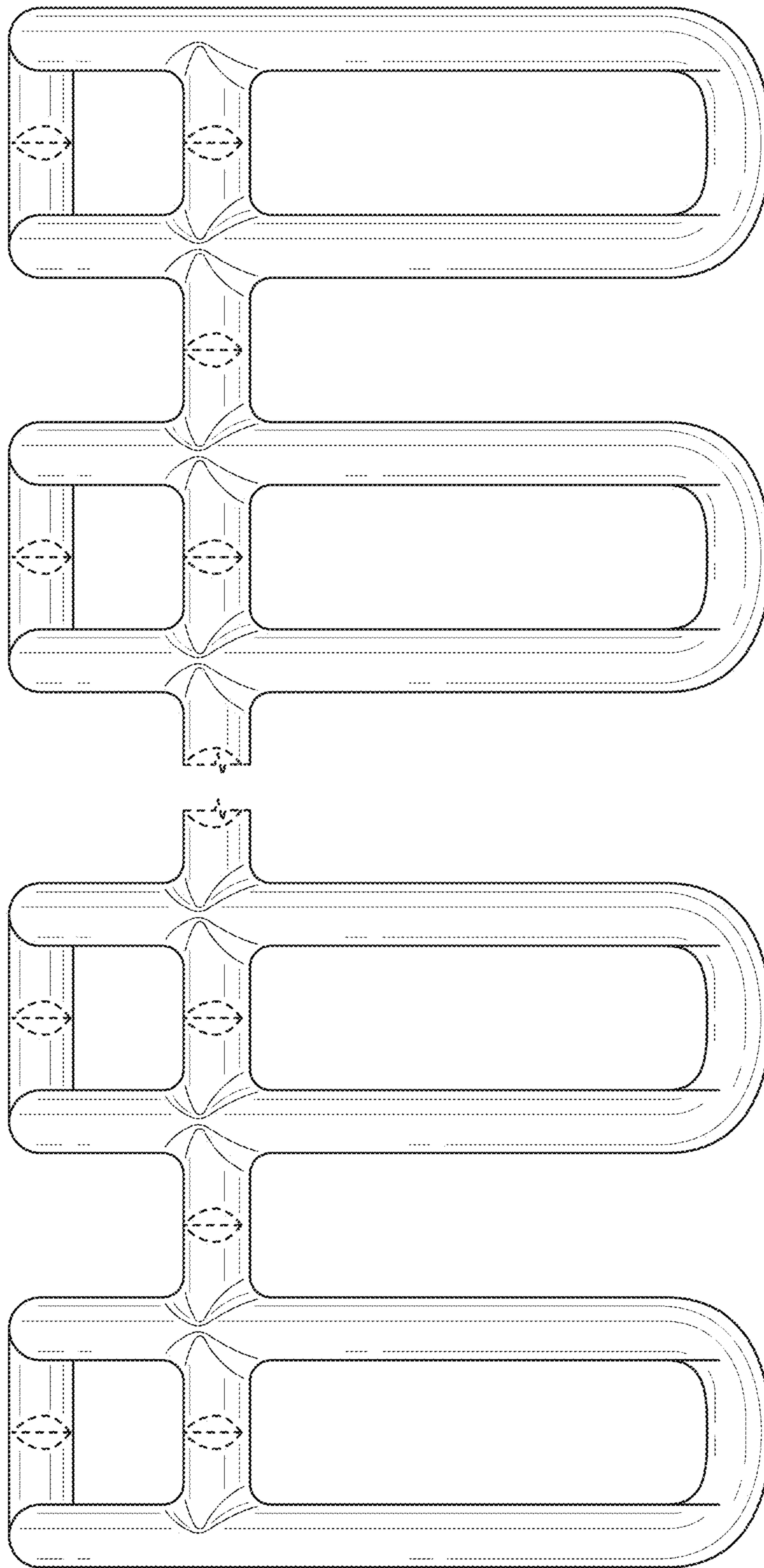

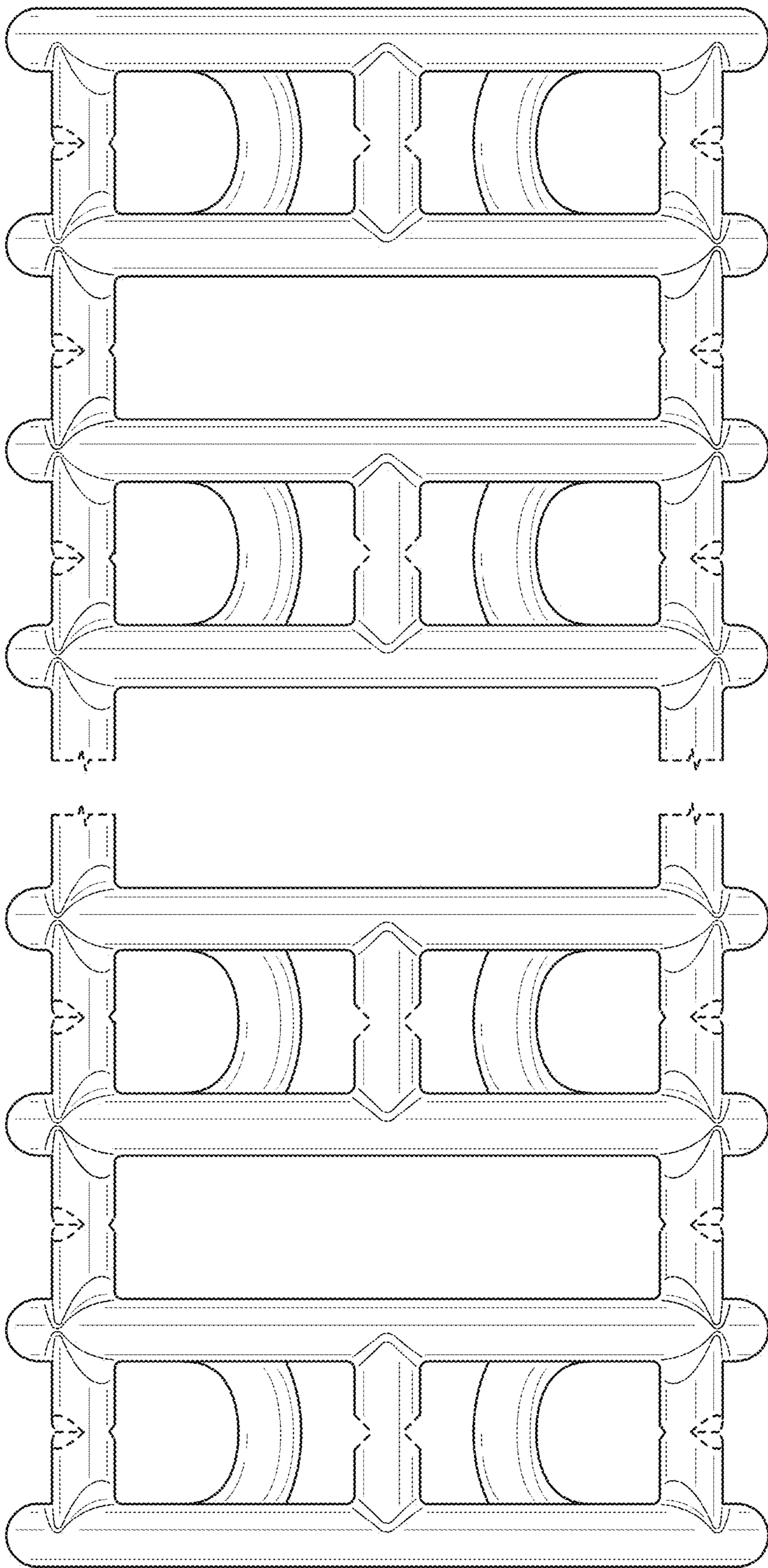

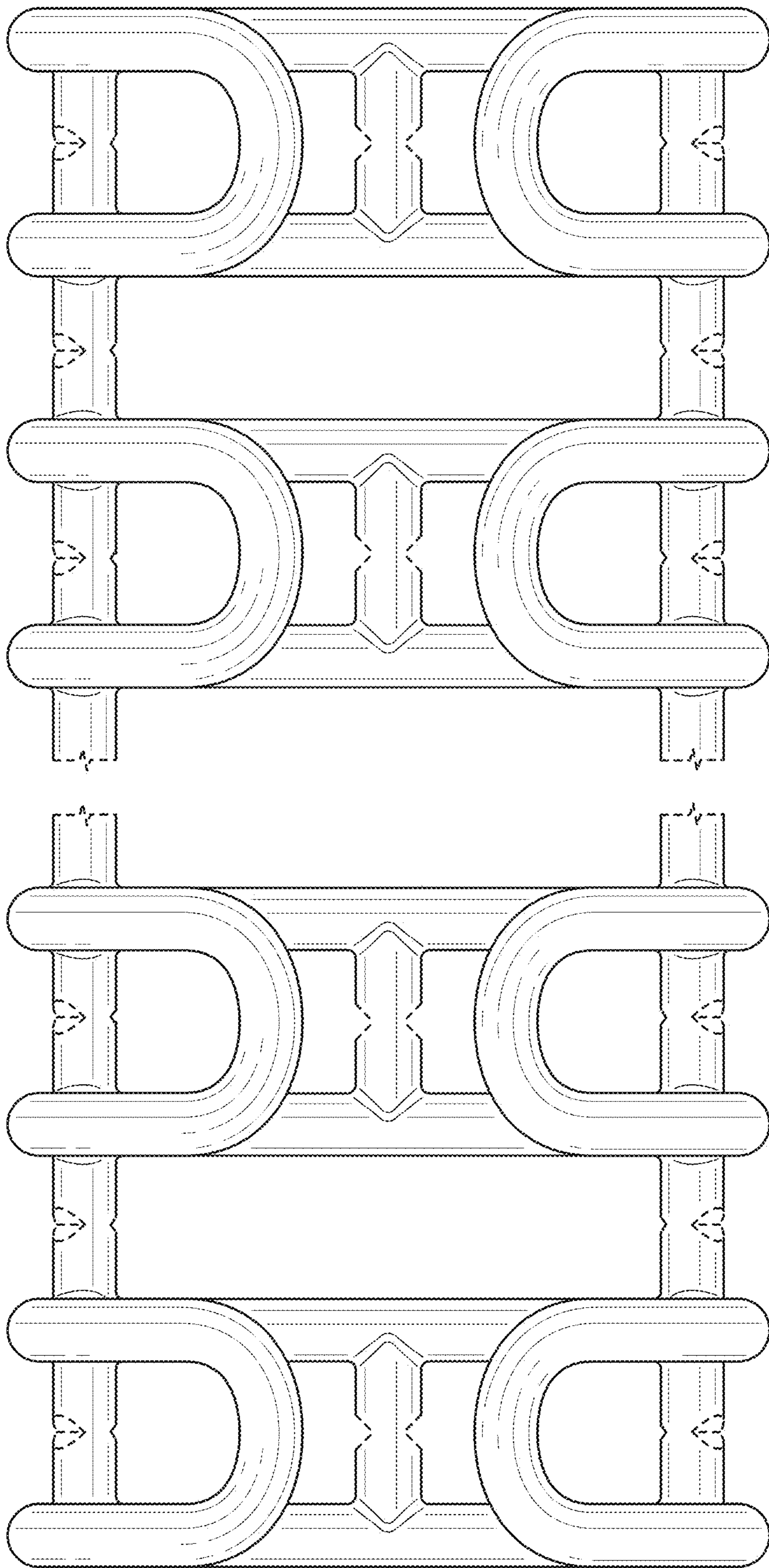
