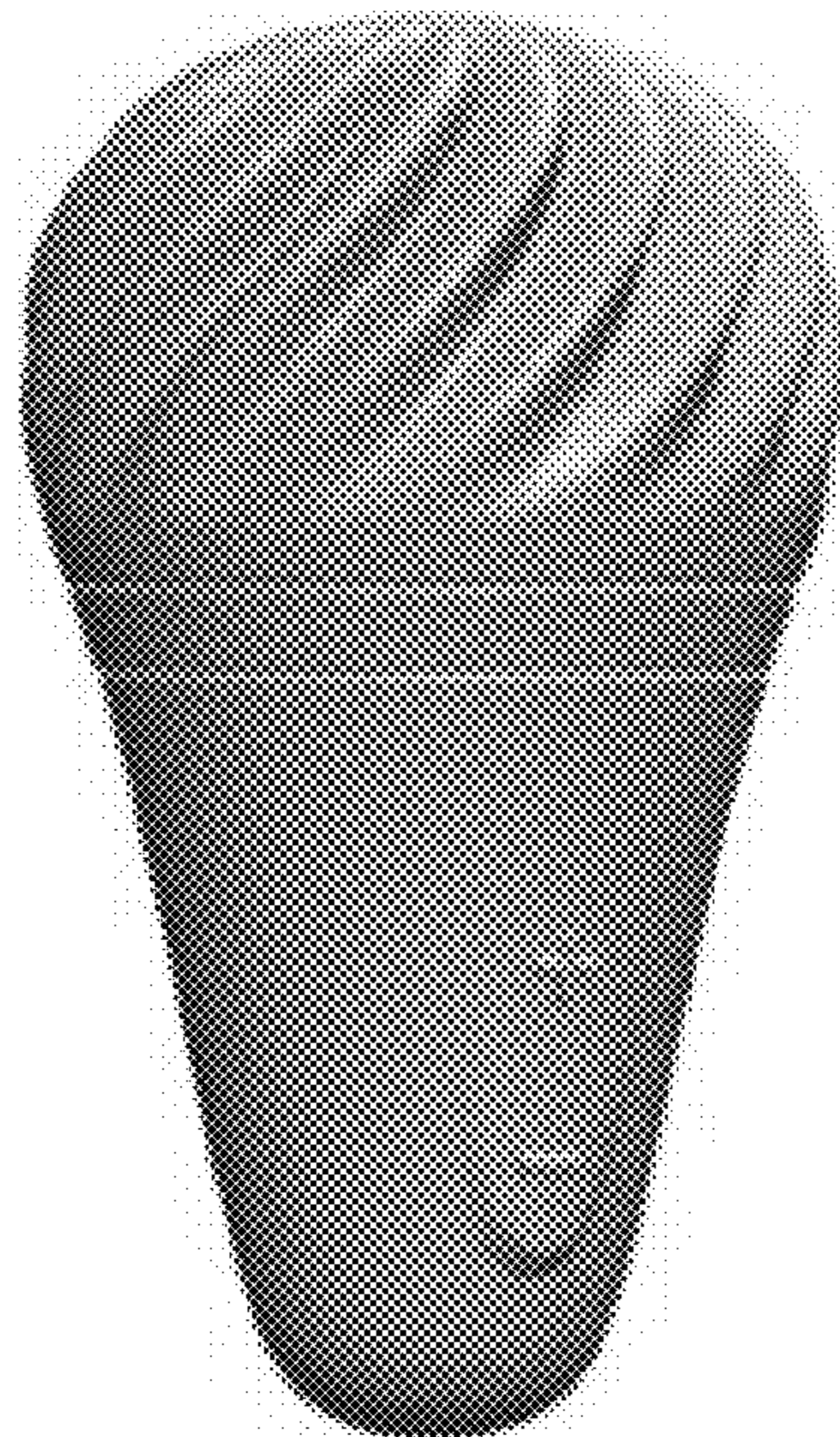
FIG. 1 is a front view of an adult toy;

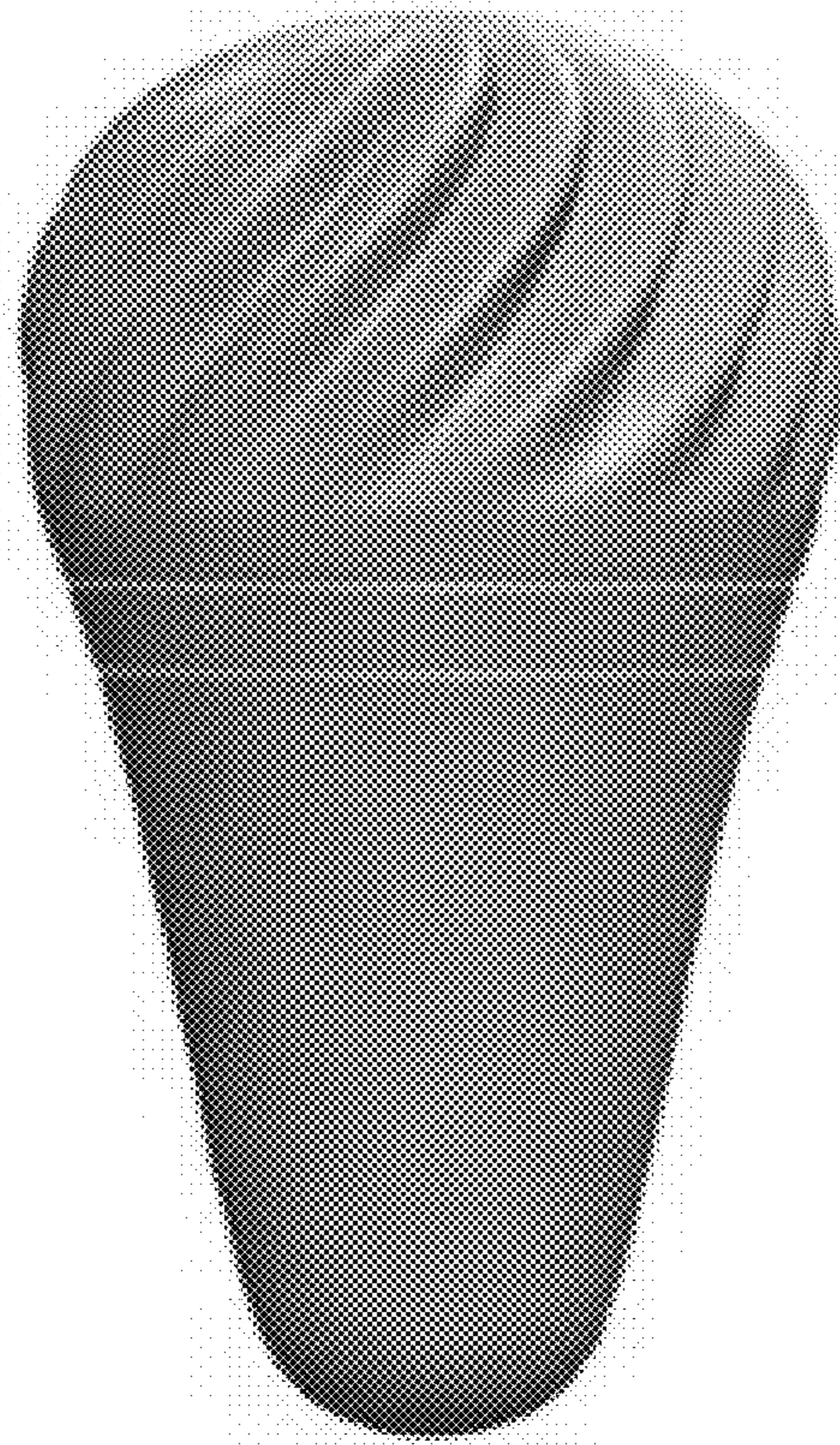

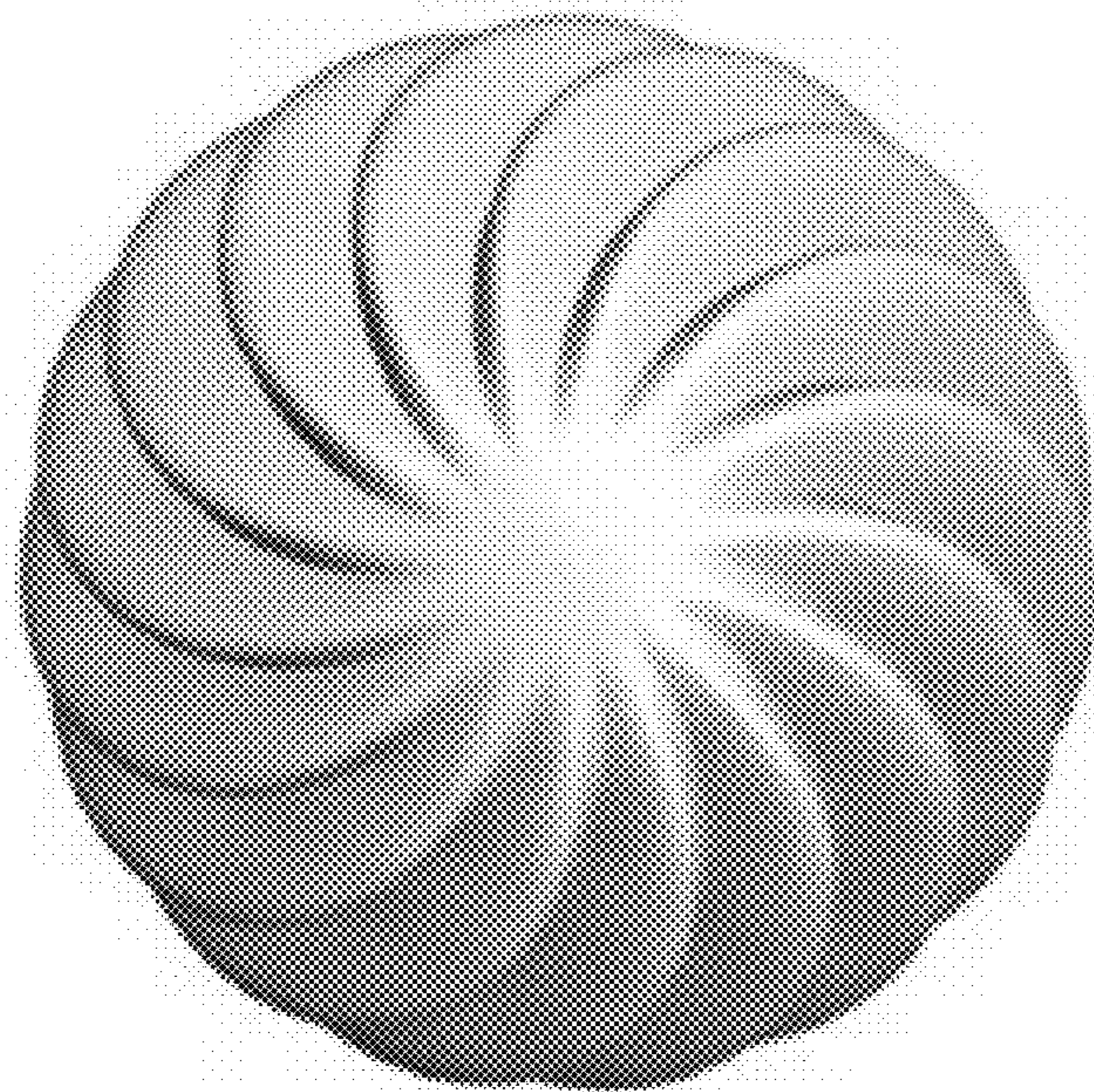

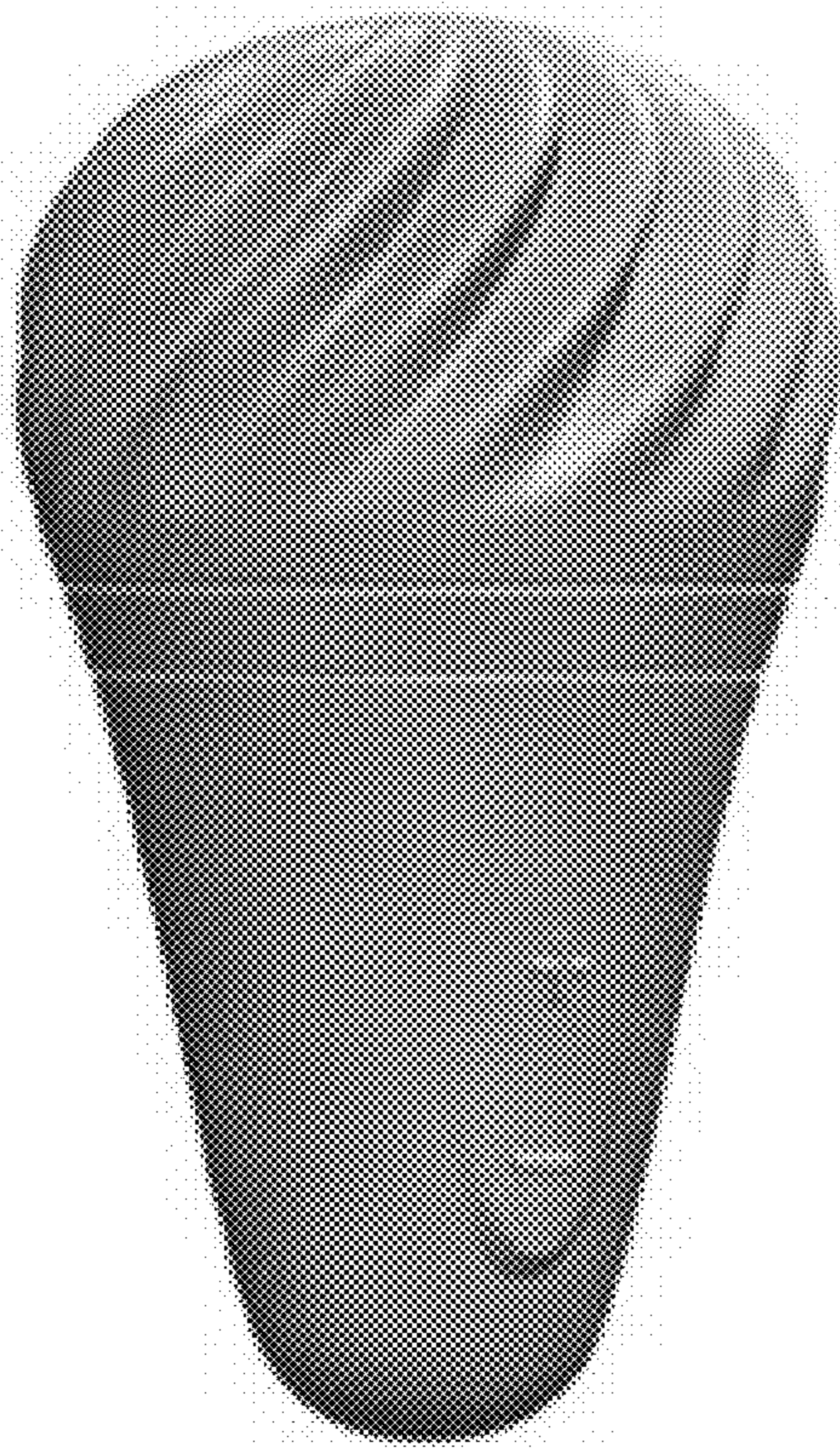

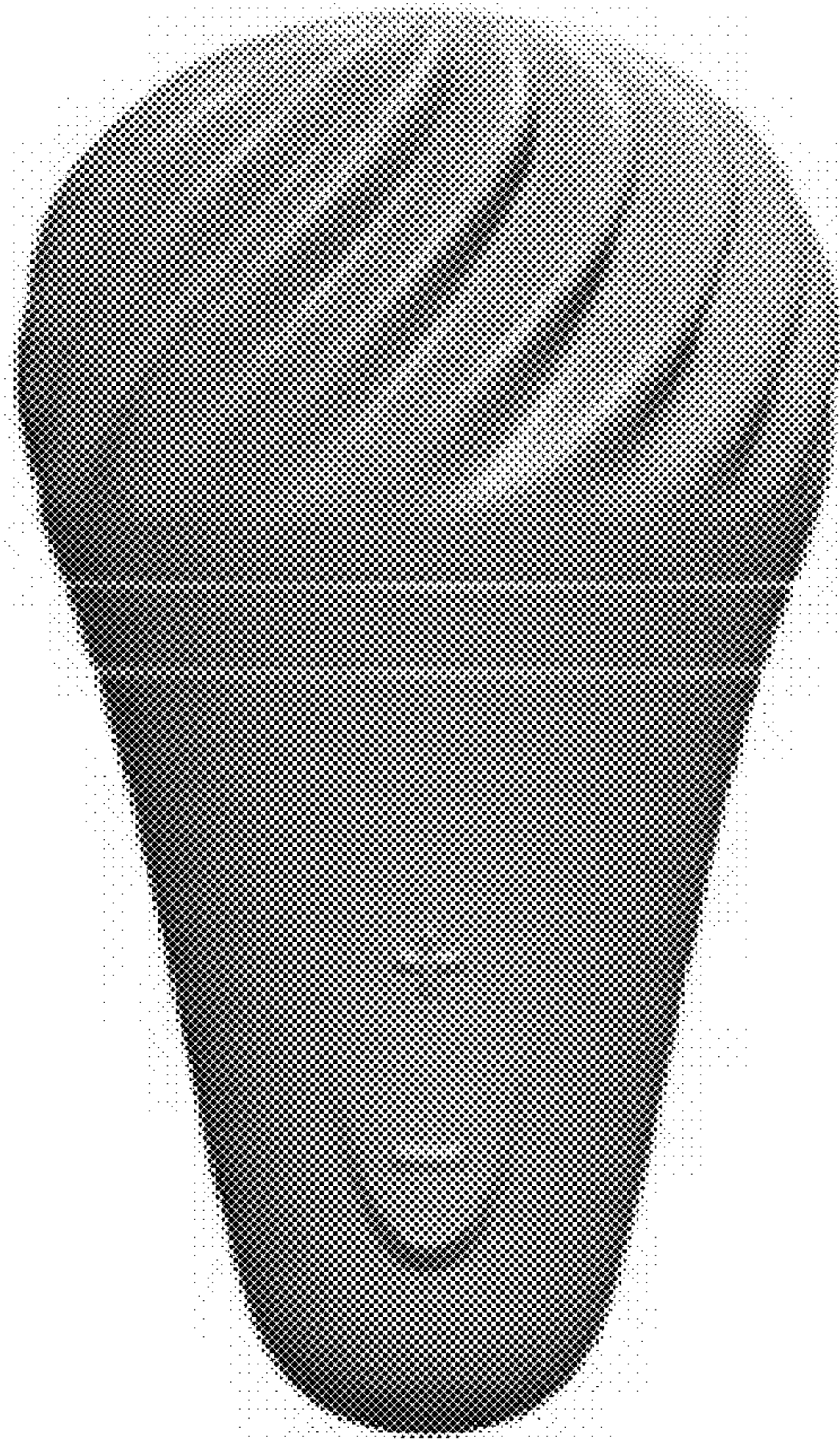

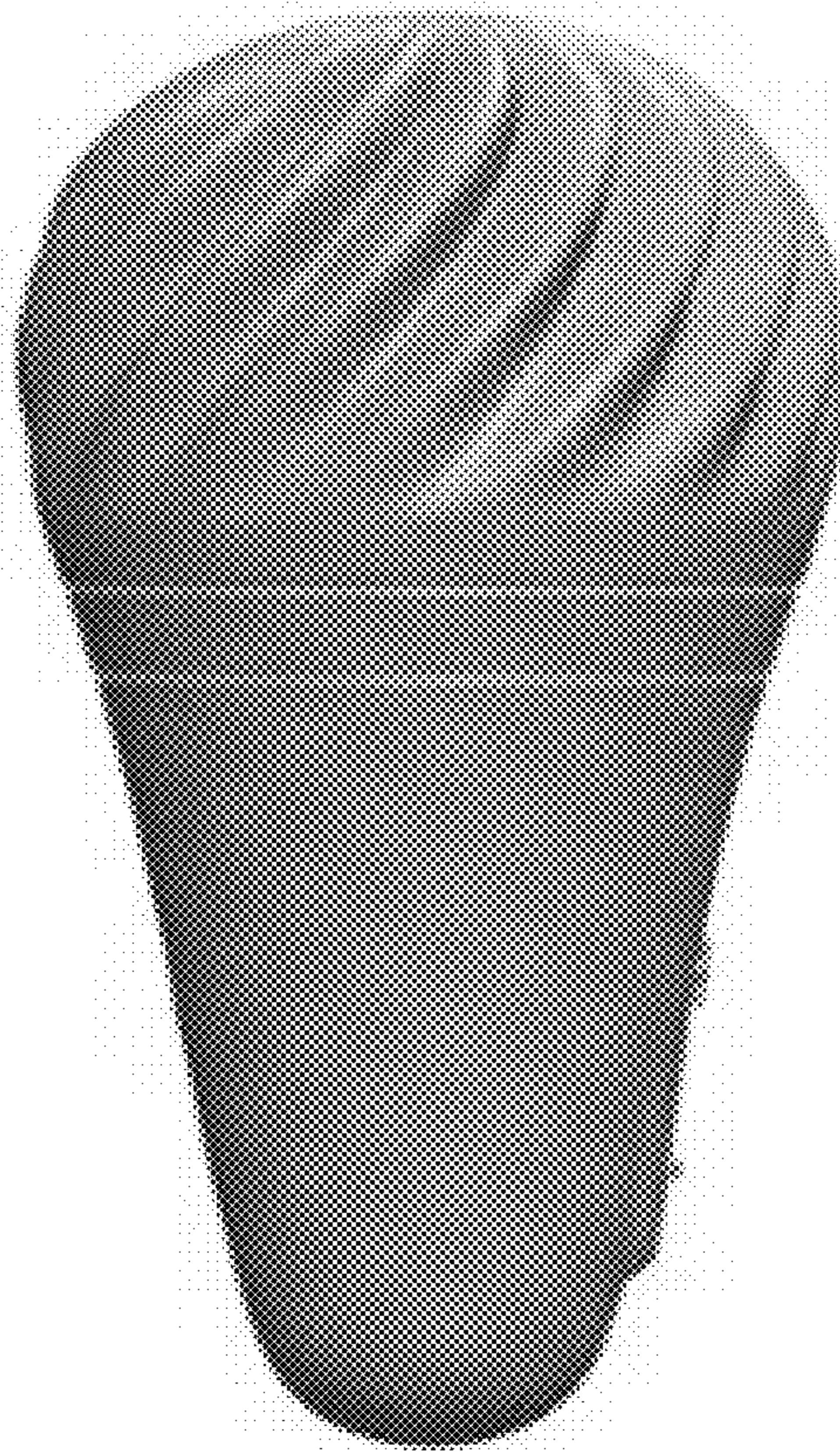
