FIG. 3 is a first perspective view thereof;

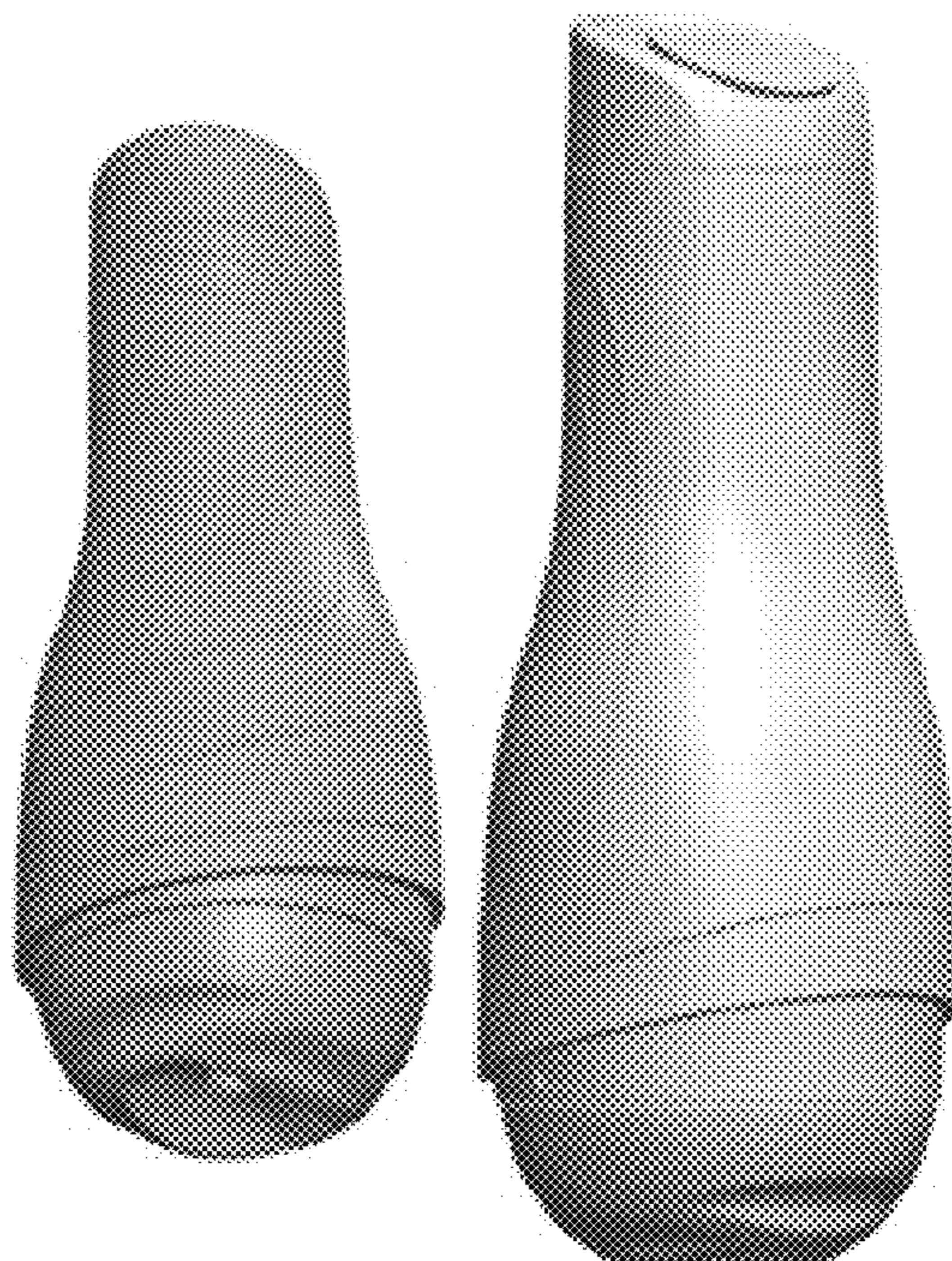
FIG. 4 is a second perspective view thereof;

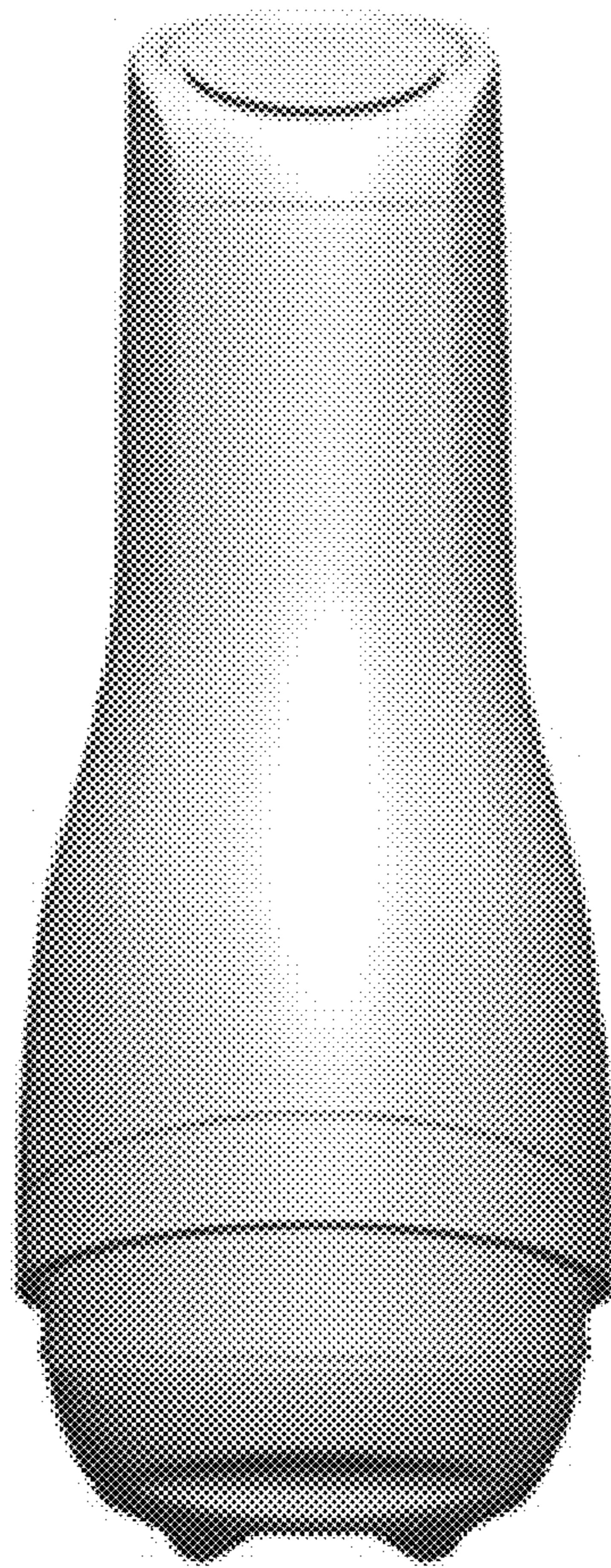

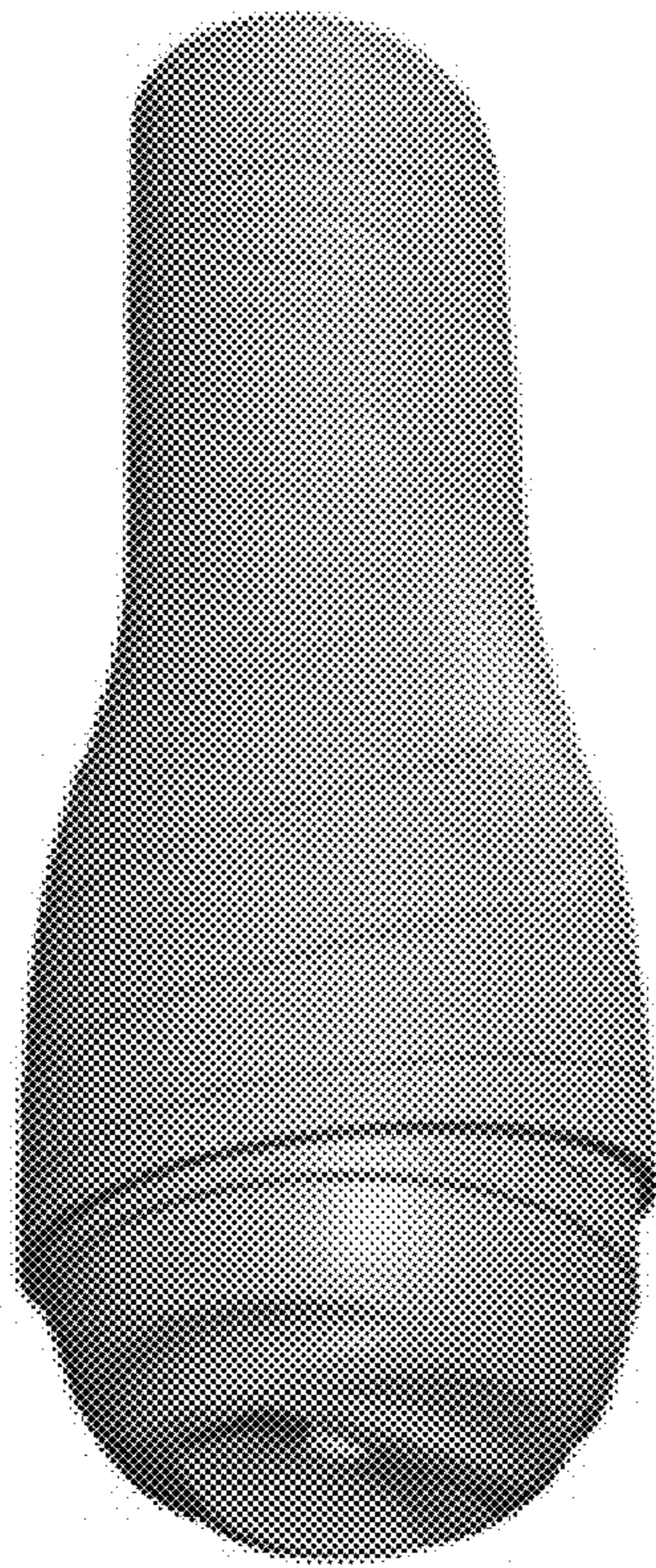

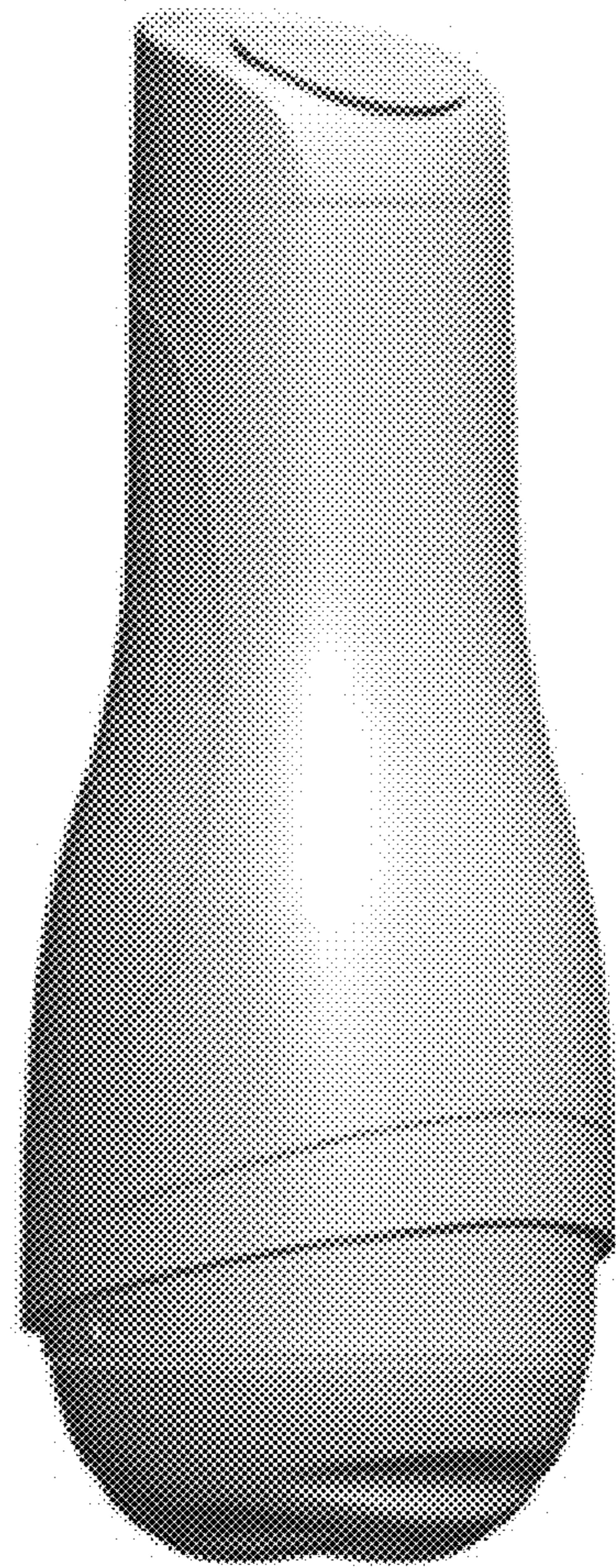

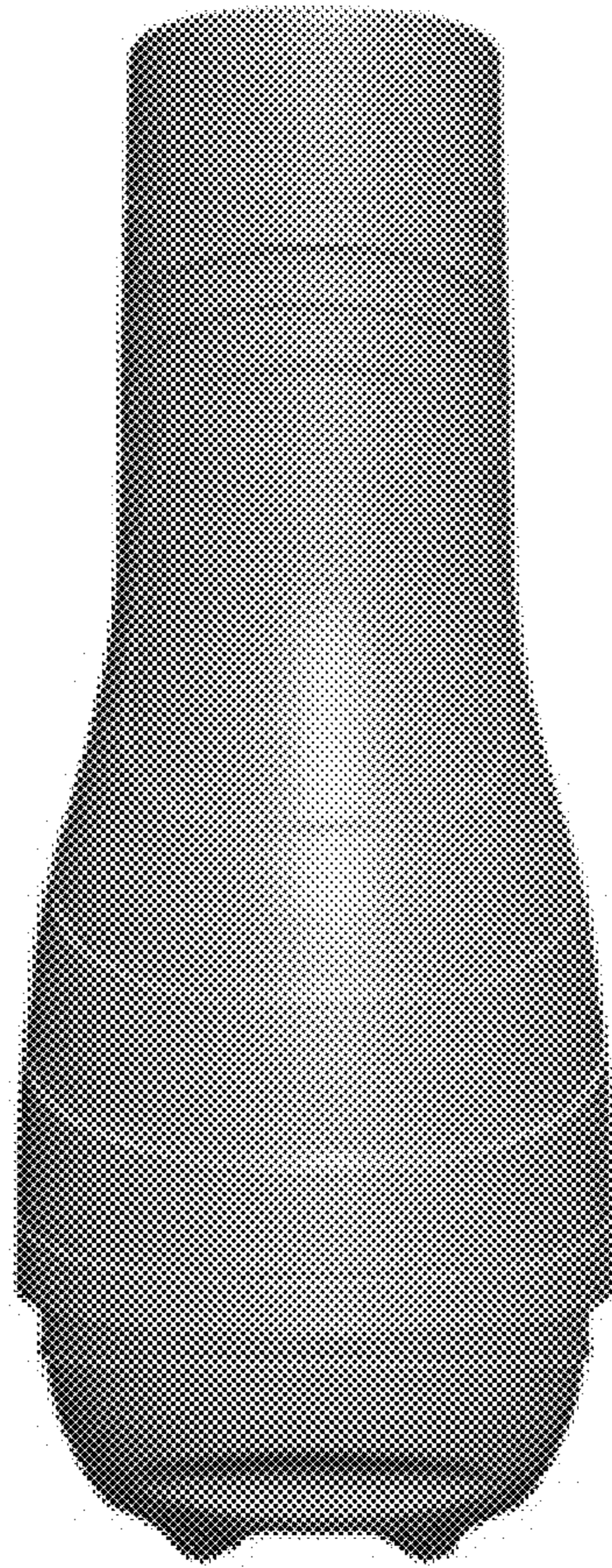

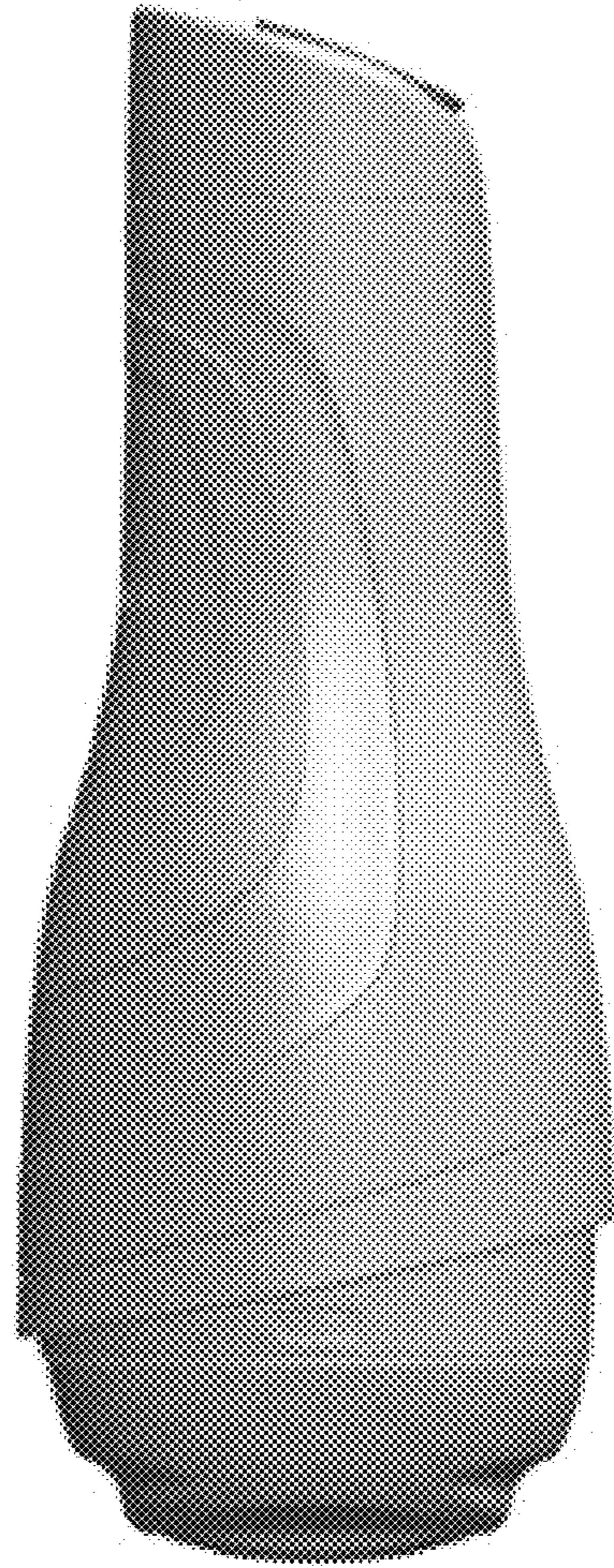
