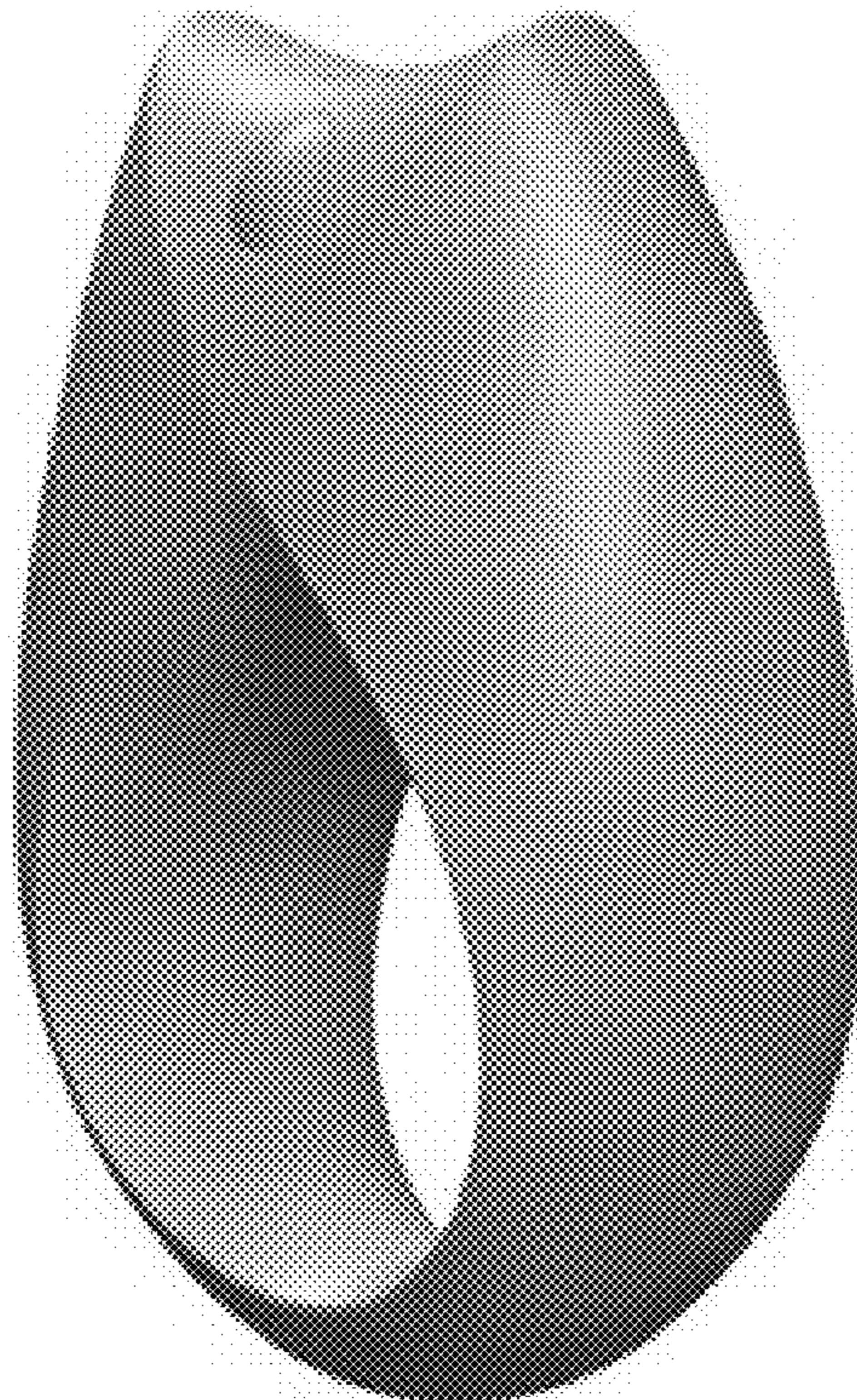
We claim the ornamental design for an adult toy, as shown and described.

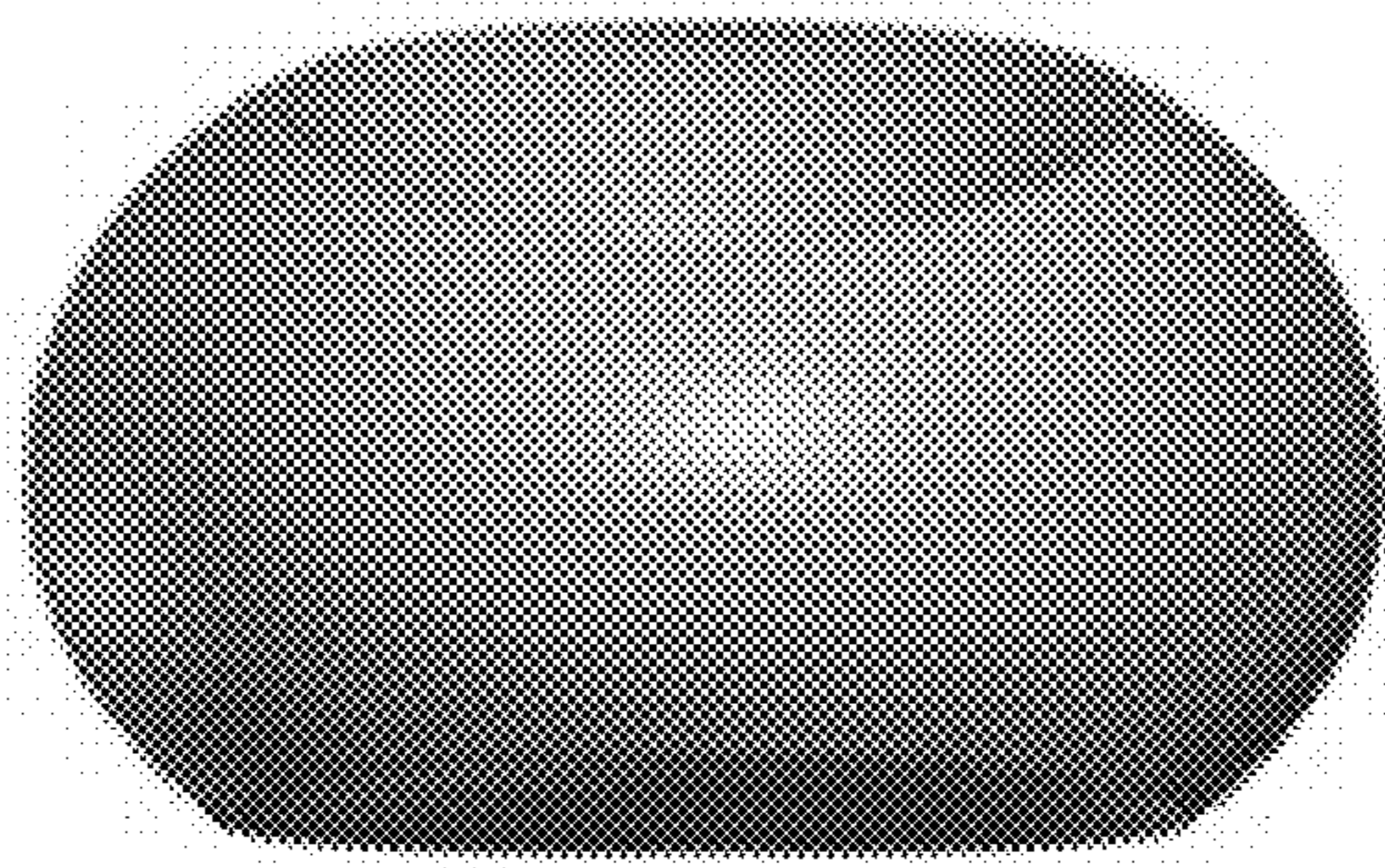

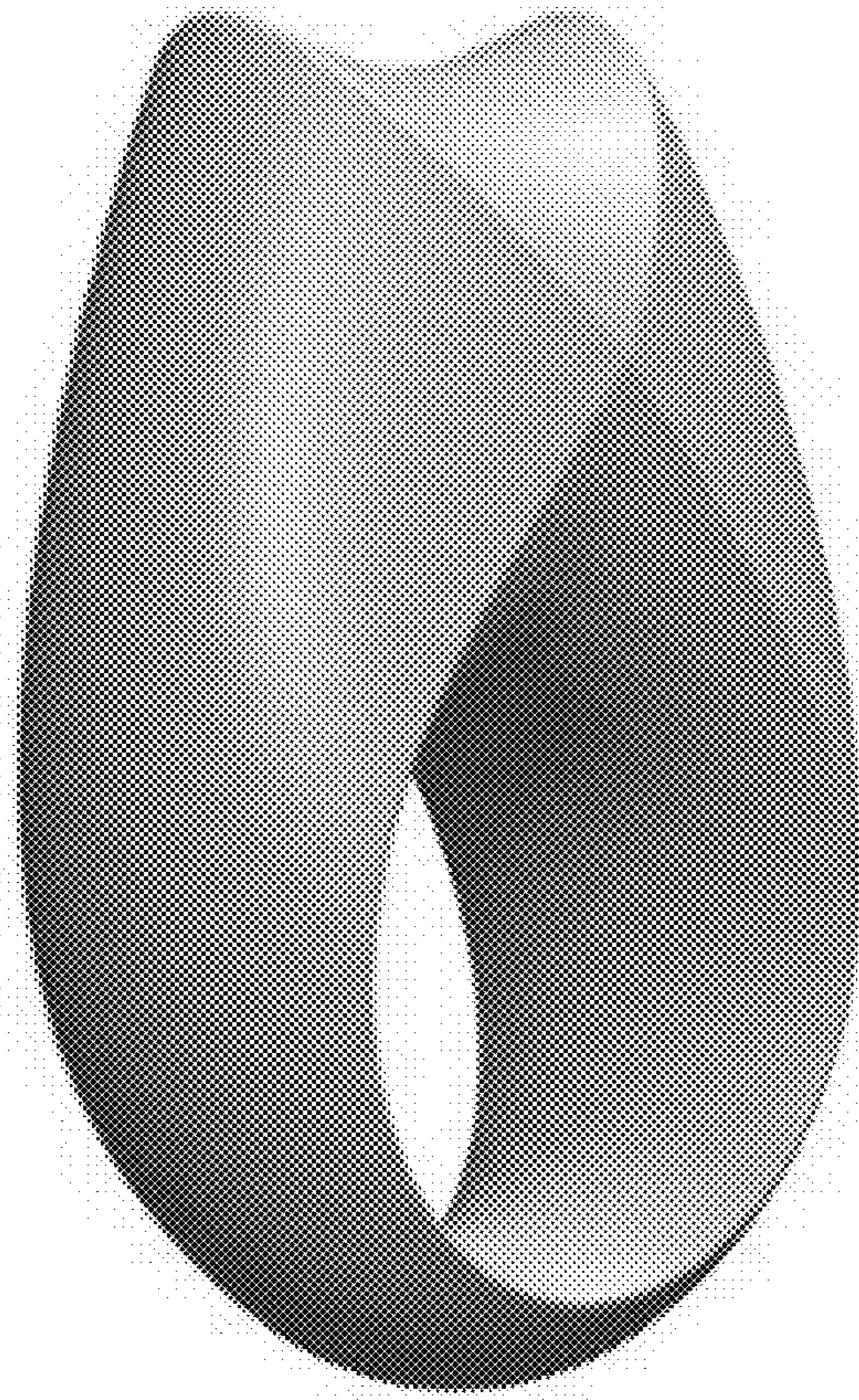

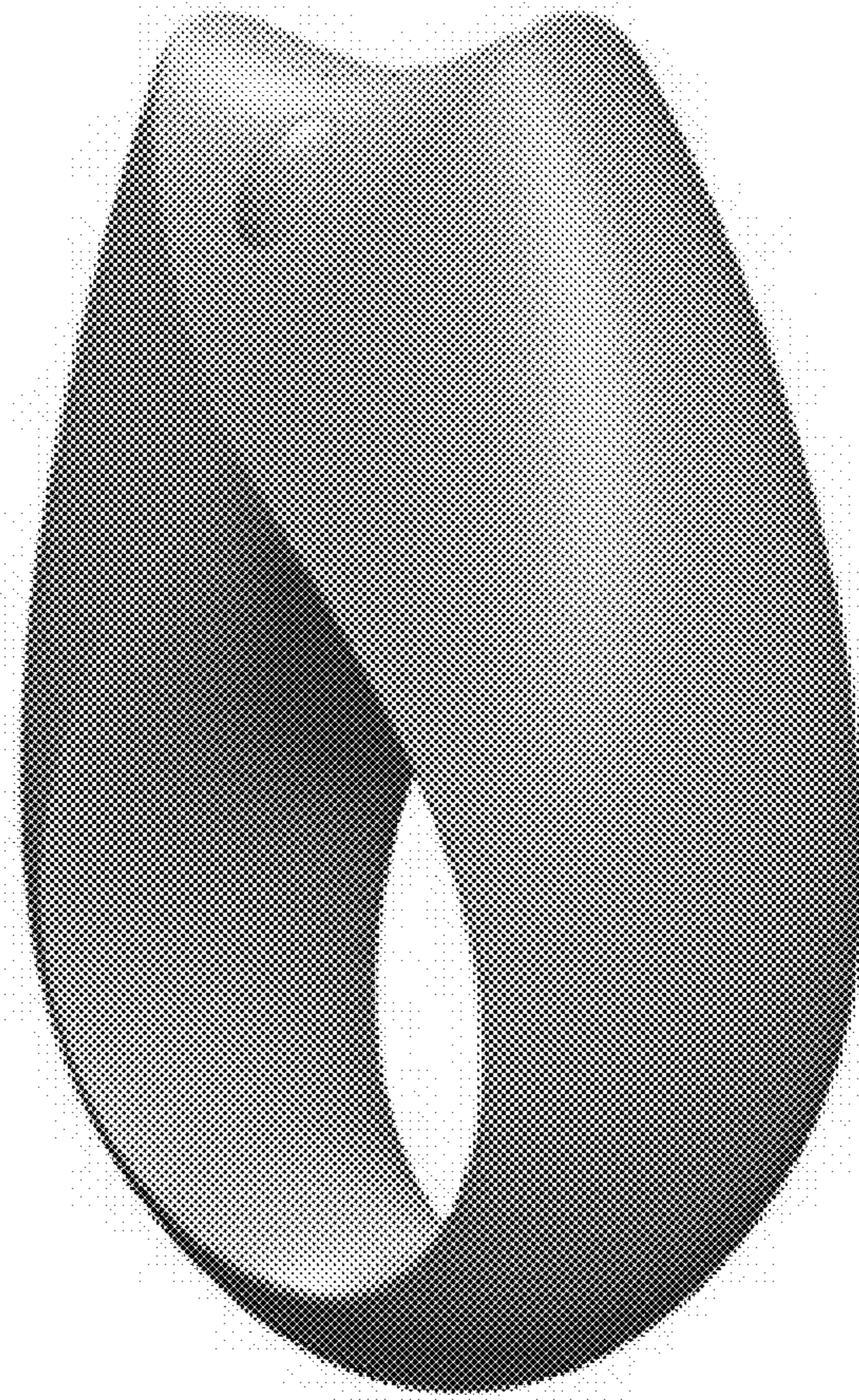

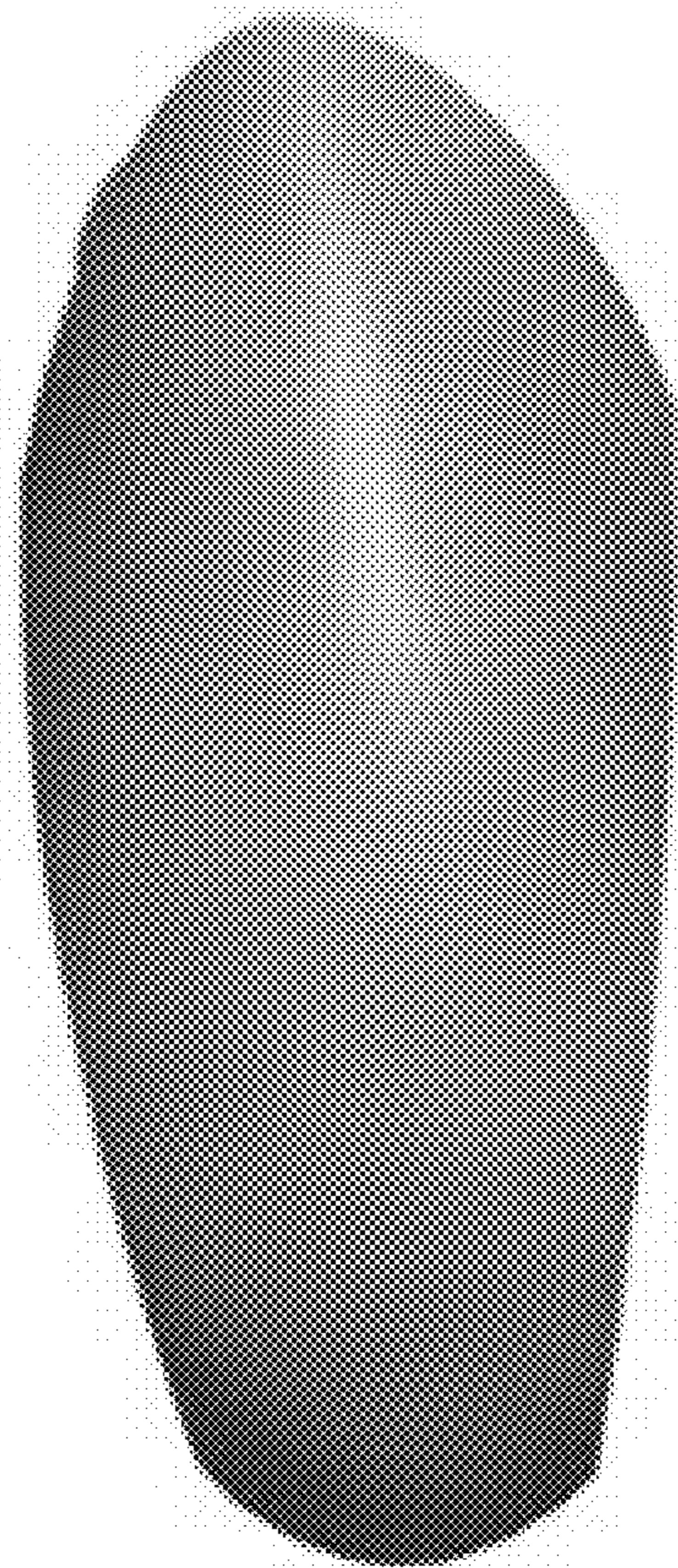

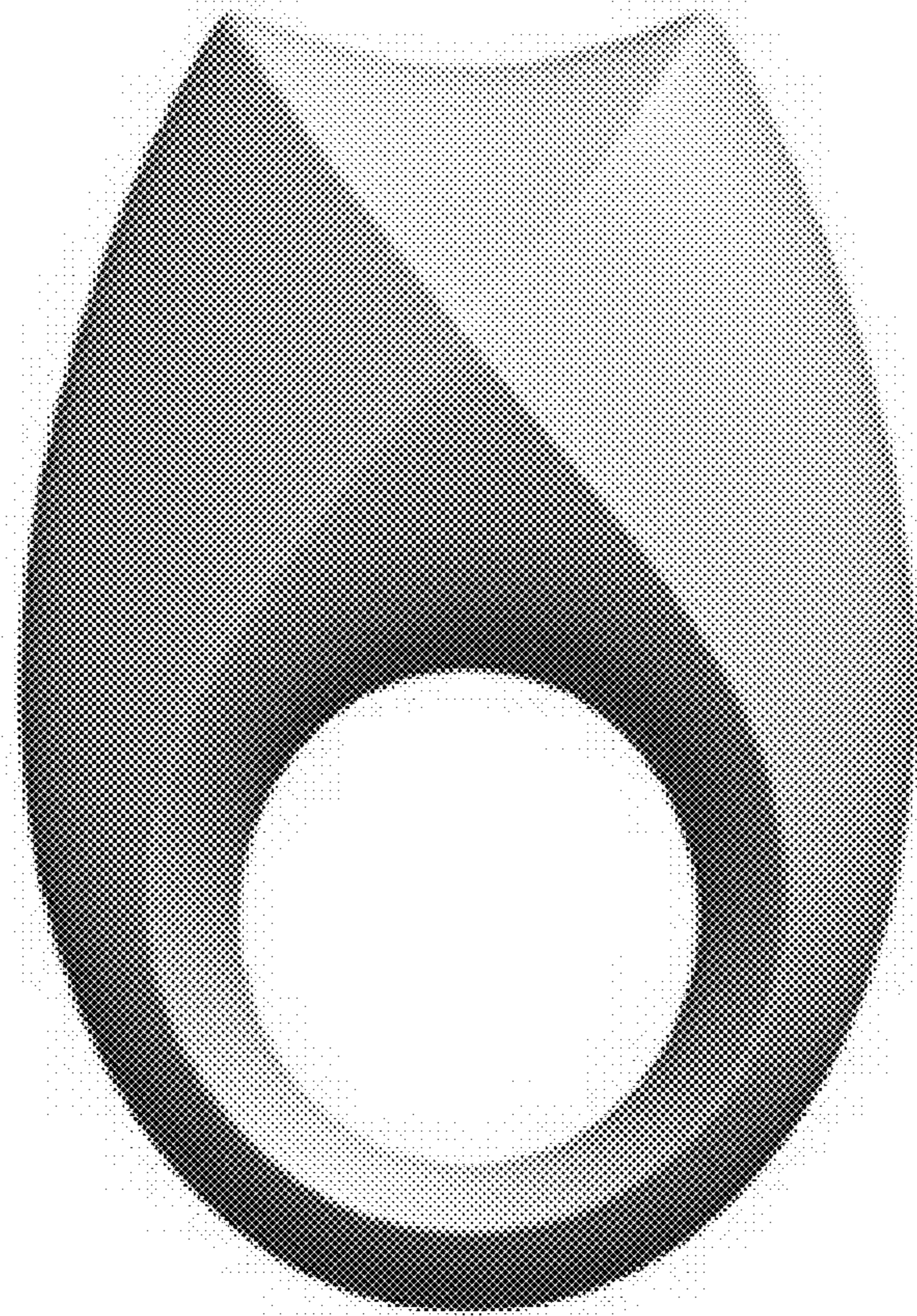

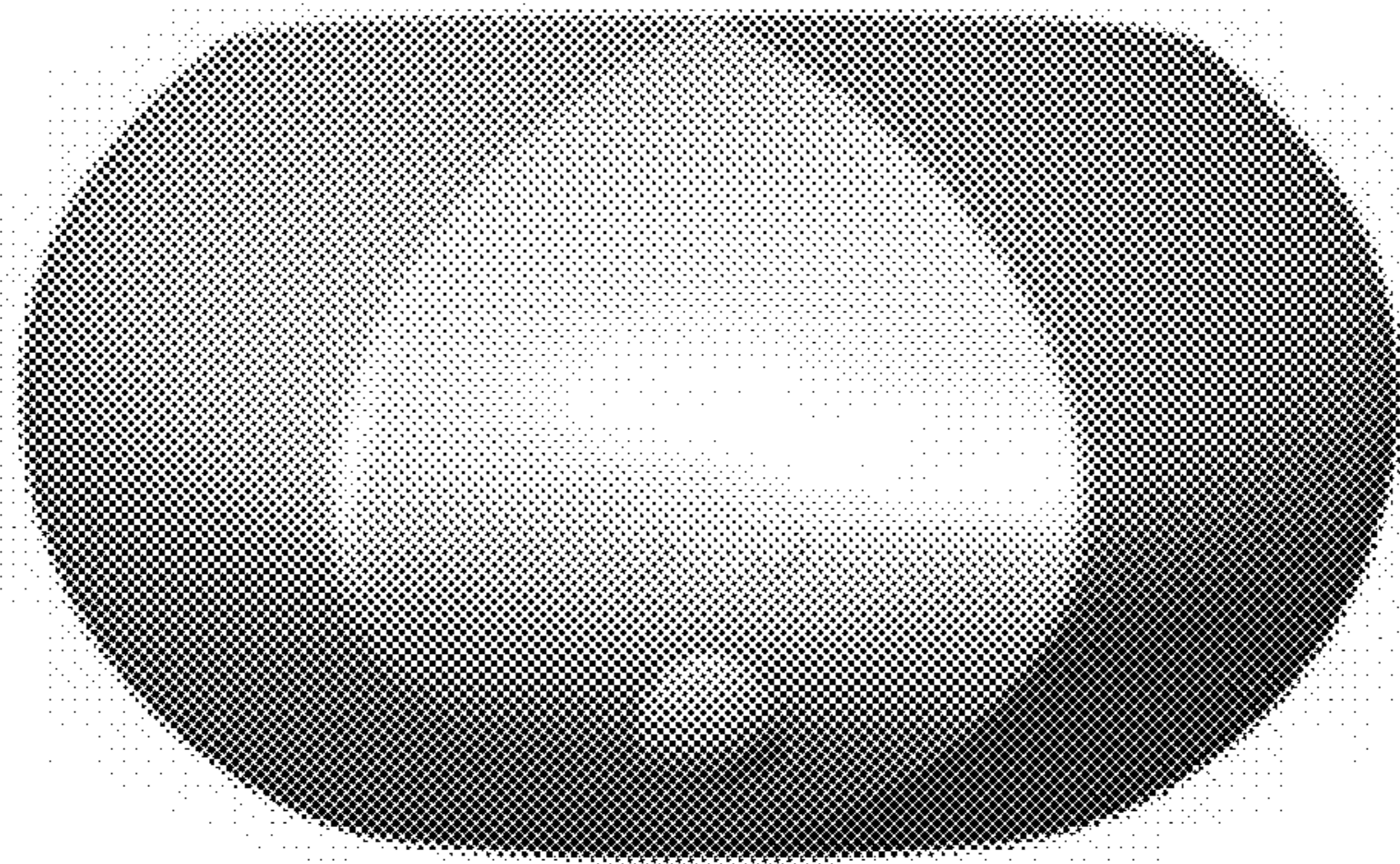
