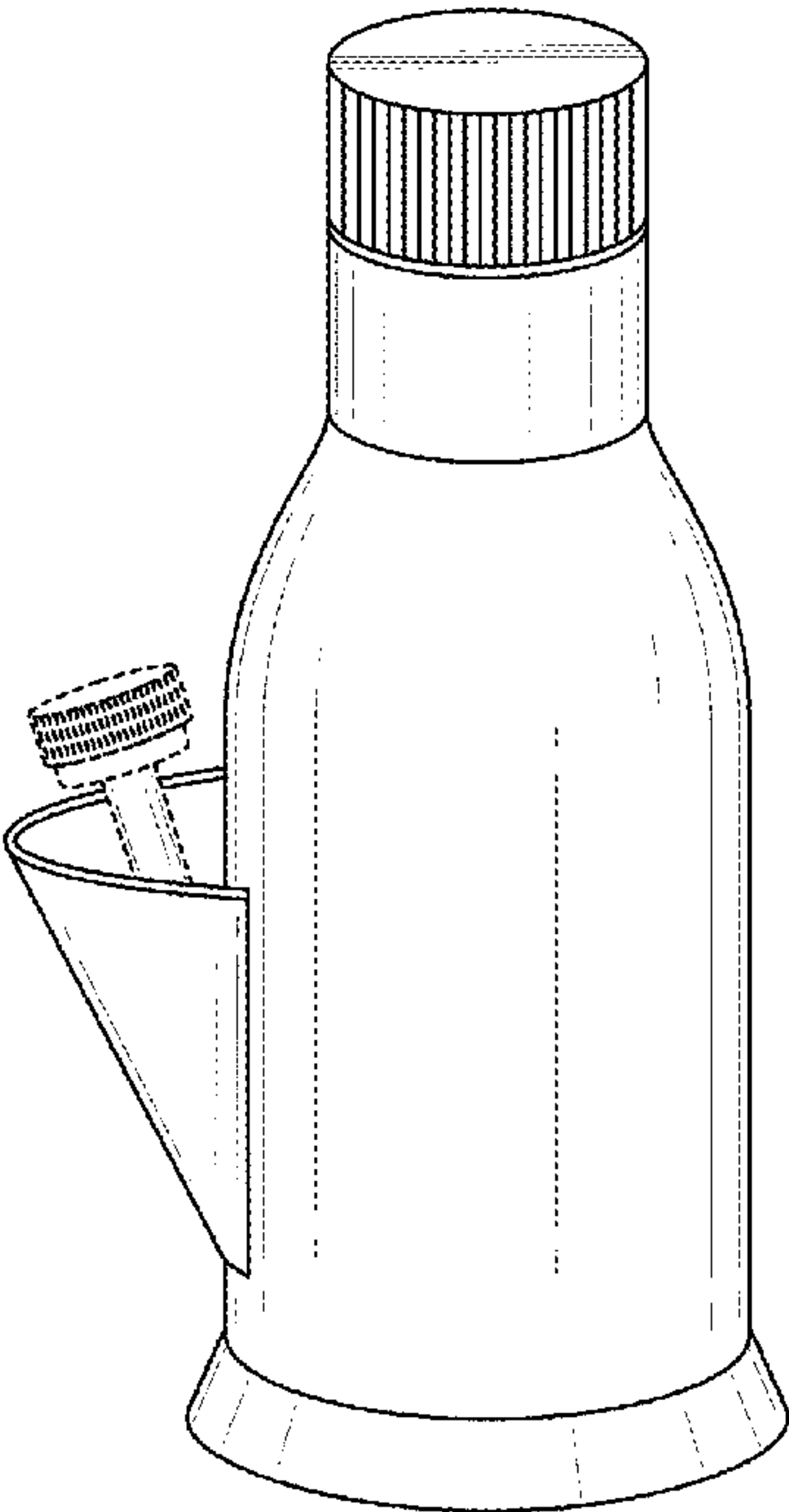
(57) CLAIM

The ornamental design for a sealable smoking bong, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a sealable smoking bong showing my new design;
FIG. 2 is an exploded isometric view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right elevational view thereof;

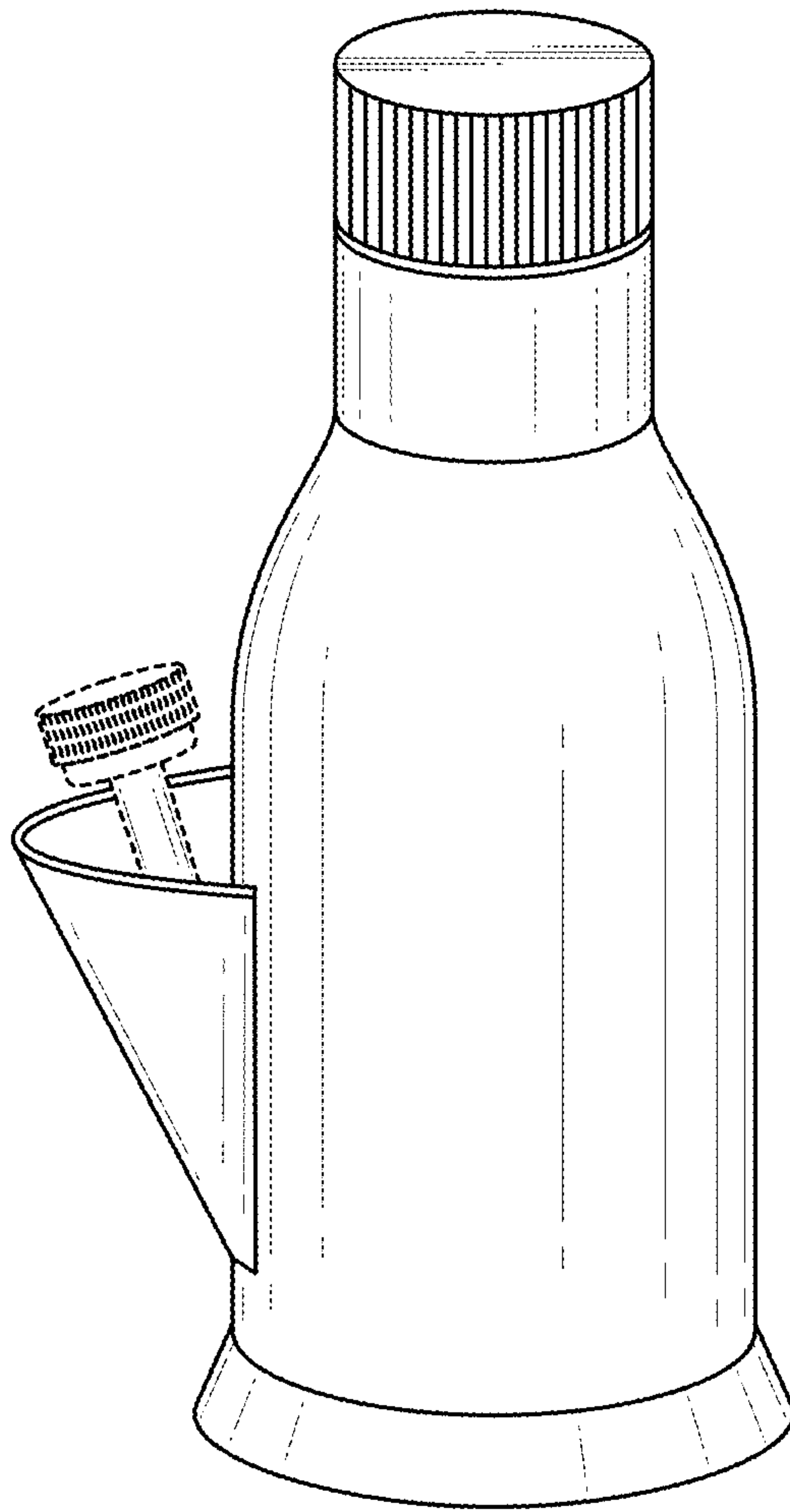

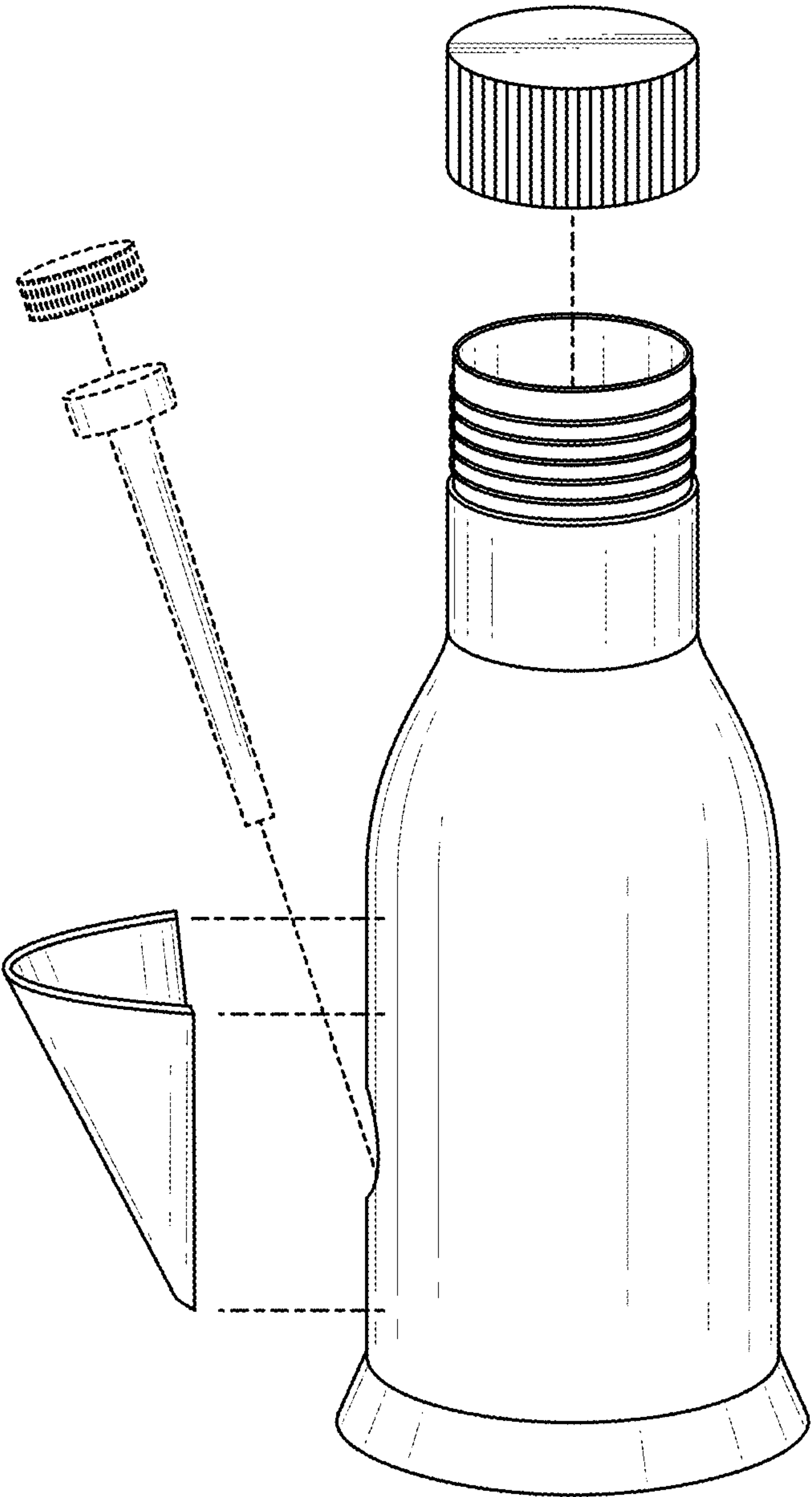

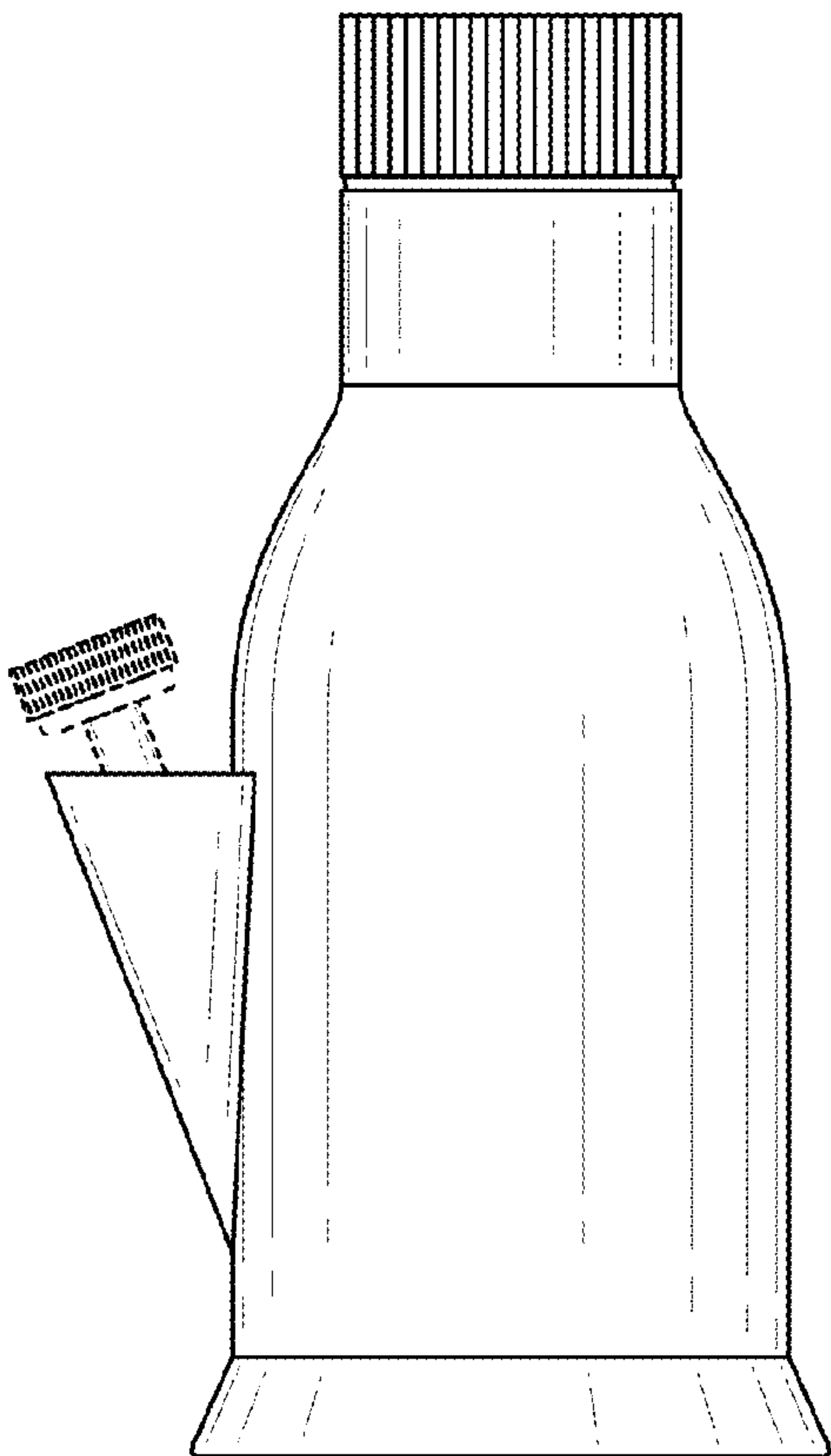

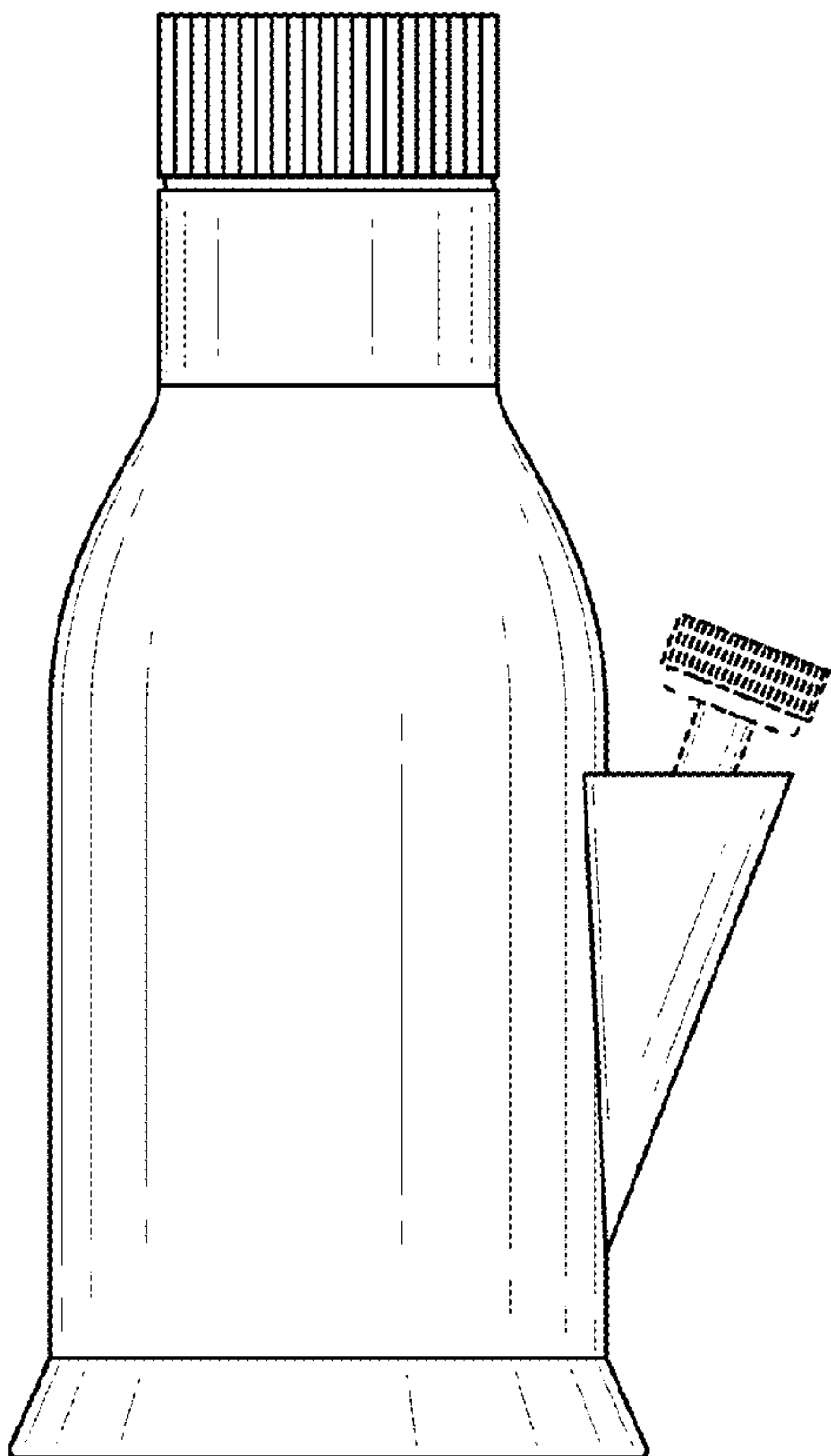

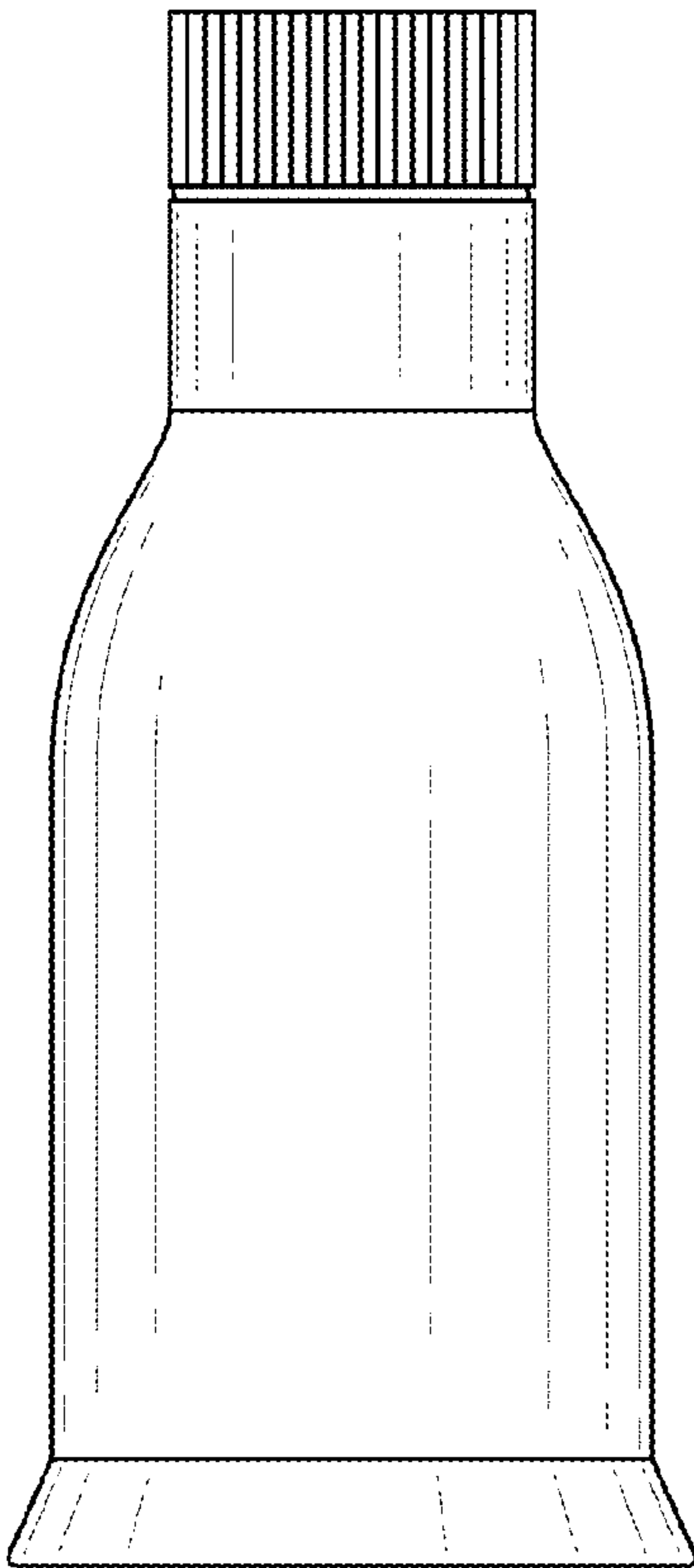

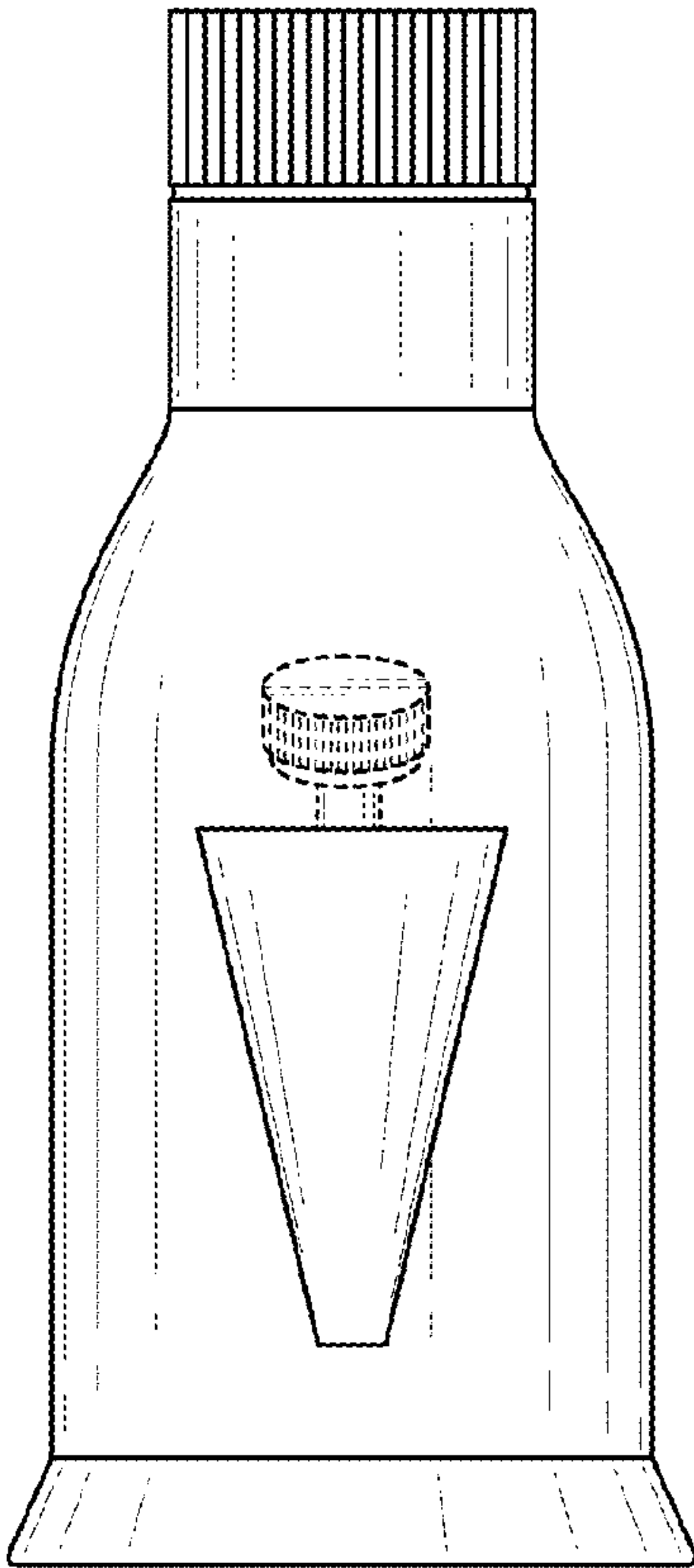

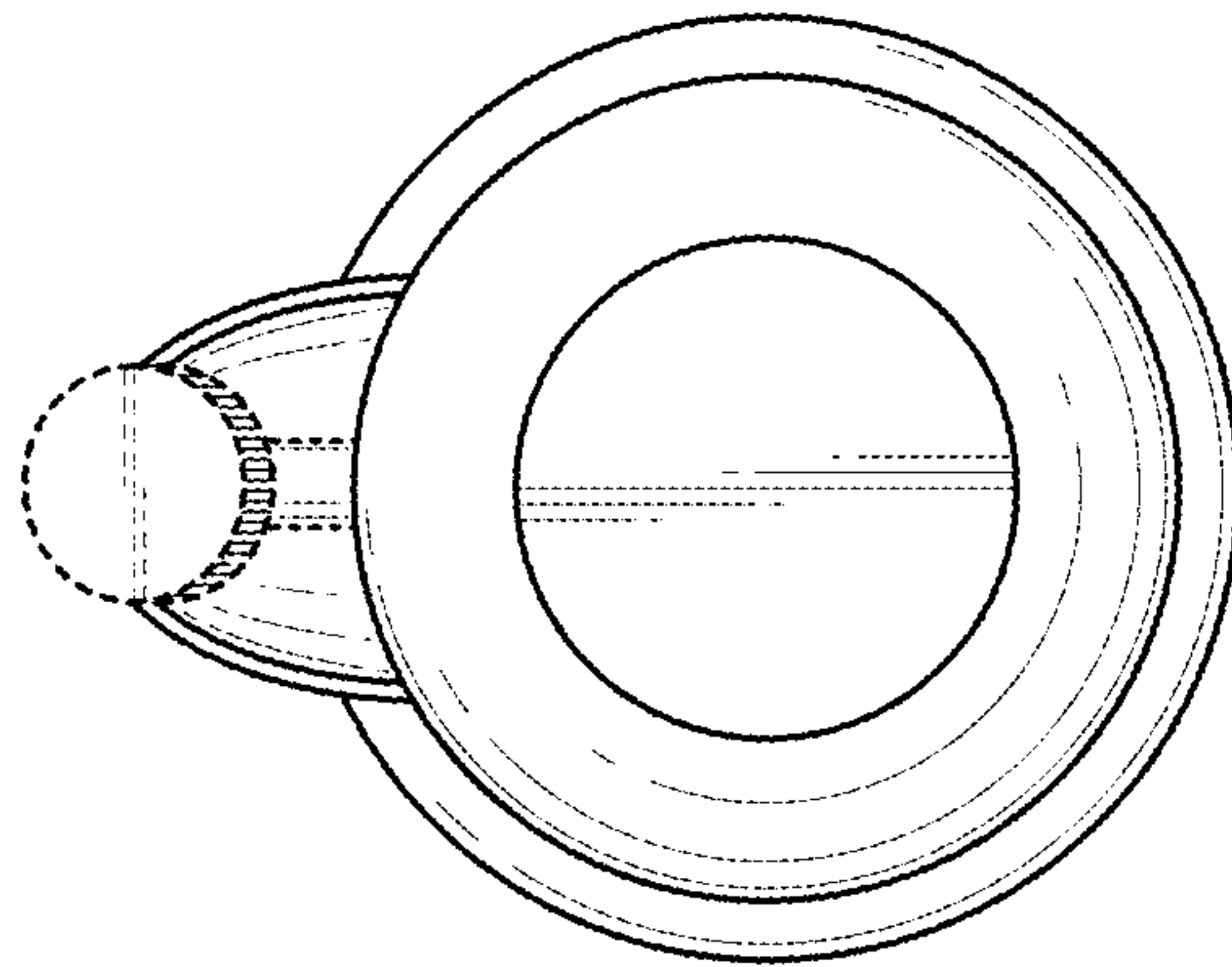

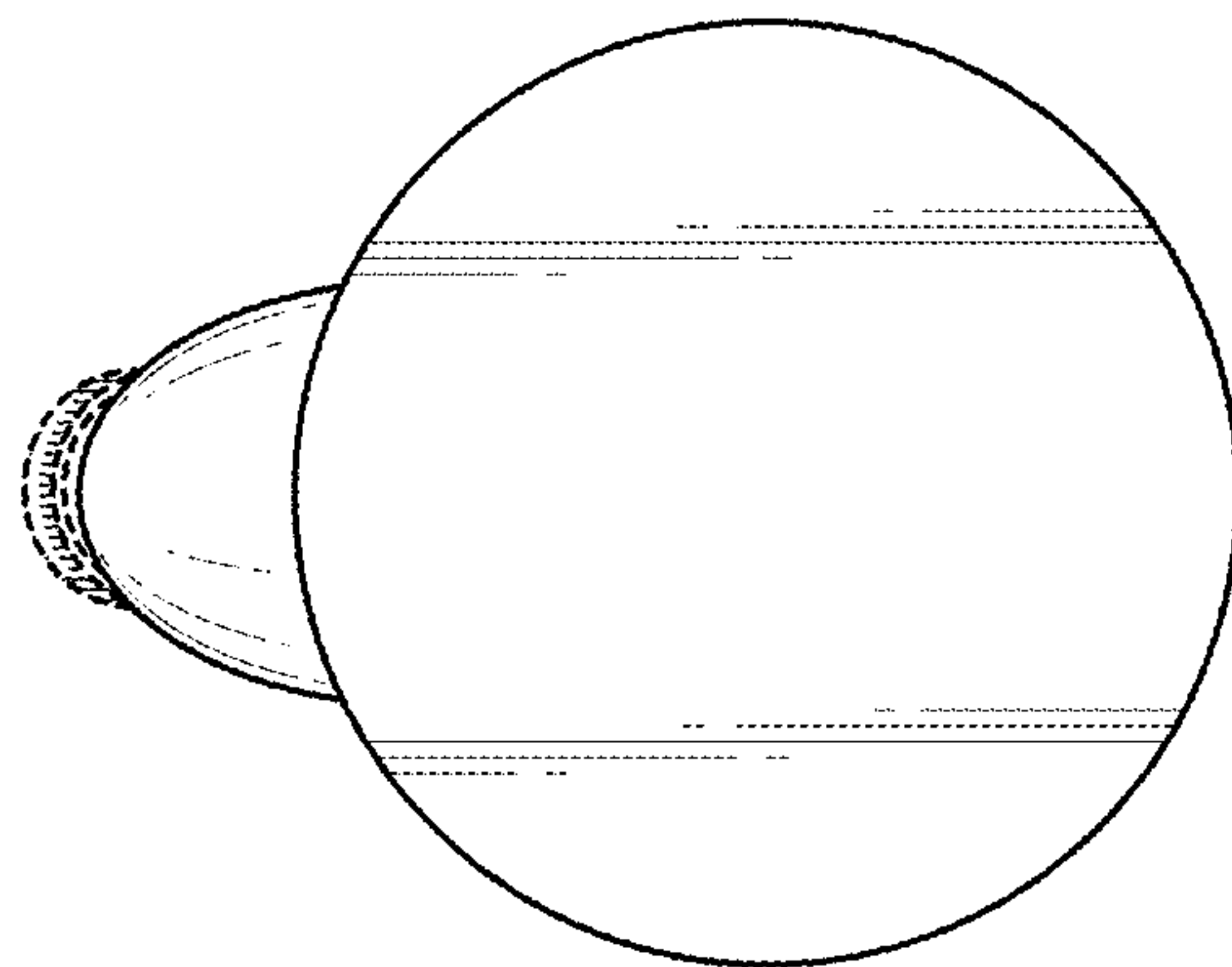
