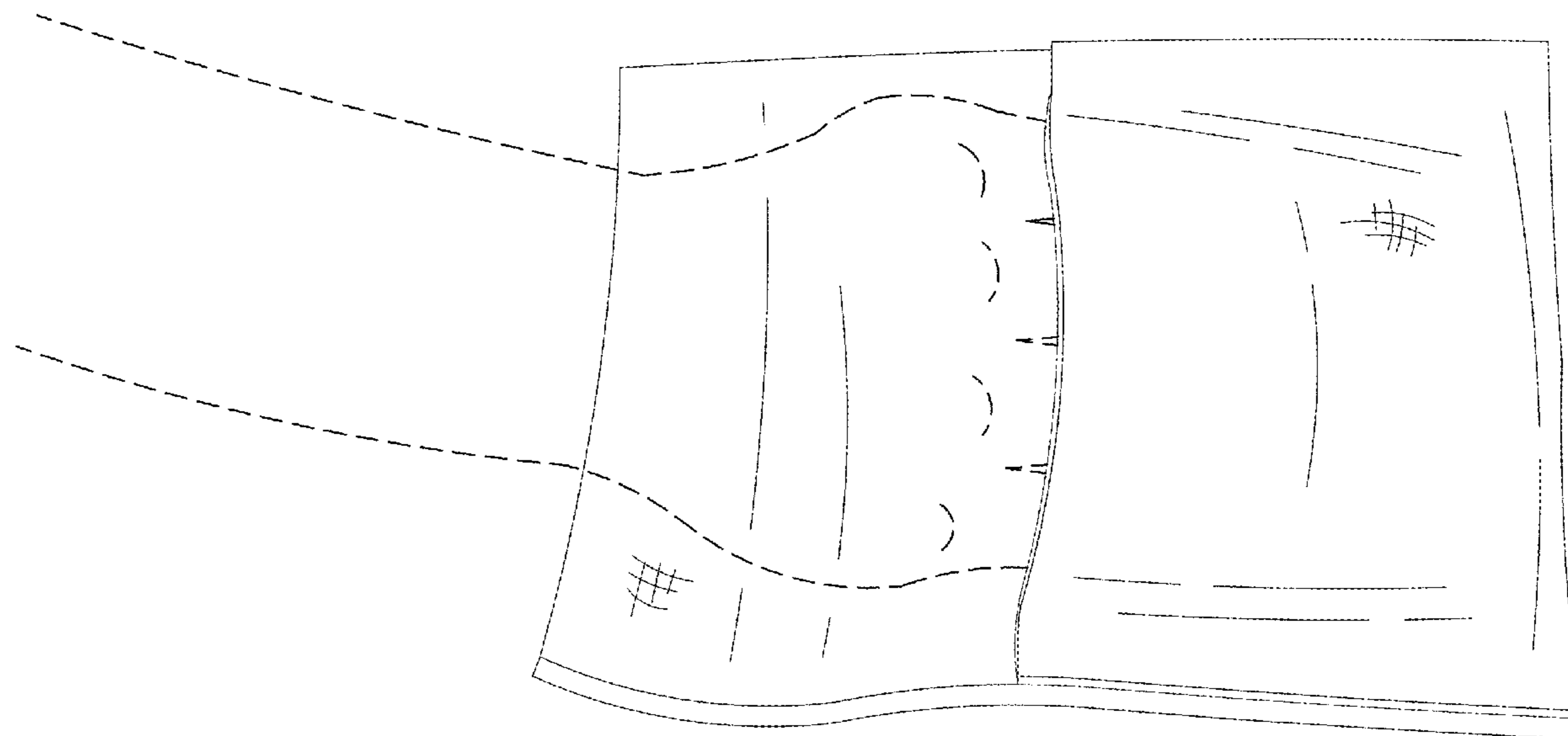
(57) **CLAIM**

The ornamental design for a cleaning wipe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a cleaning wipe showing my new design;  
 FIG. 2 is a rear view of the cleaning wipe;  
 FIG. 3 is a left side view of the cleaning wipe;  
 FIG. 4 is a right side view of the cleaning wipe;  
 FIG. 5 is a top view of the cleaning wipe;  
 FIG. 6 is a bottom view of the cleaning wipe;  
 FIG. 7 is a bottom front side perspective view of the cleaning wipe; and,  
 FIG. 8 is a bottom front perspective view of the cleaning wipe in use.  
 The broken lines in FIG. 8 are illustrative of environmental structure forming no part of the claimed design.

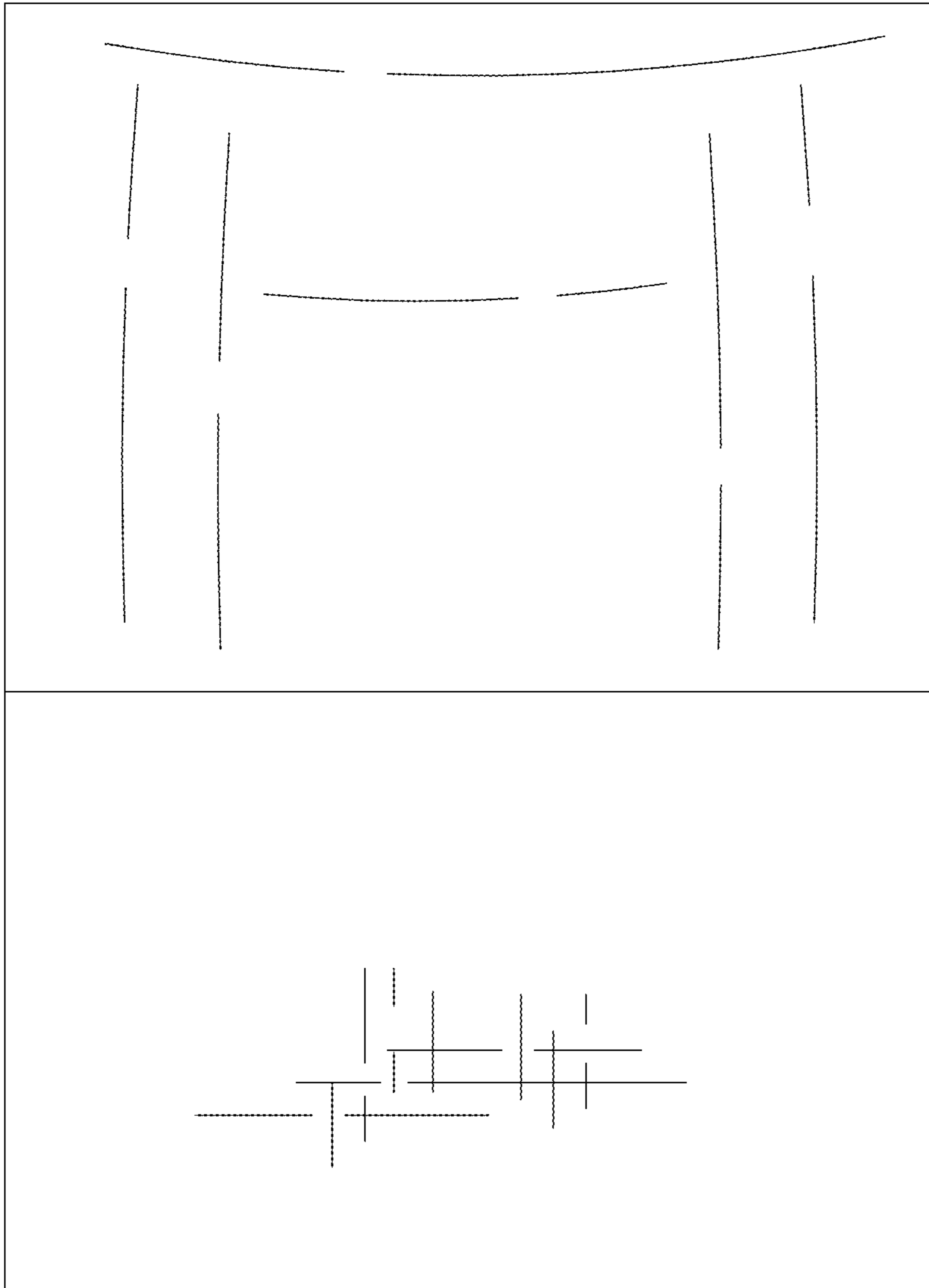

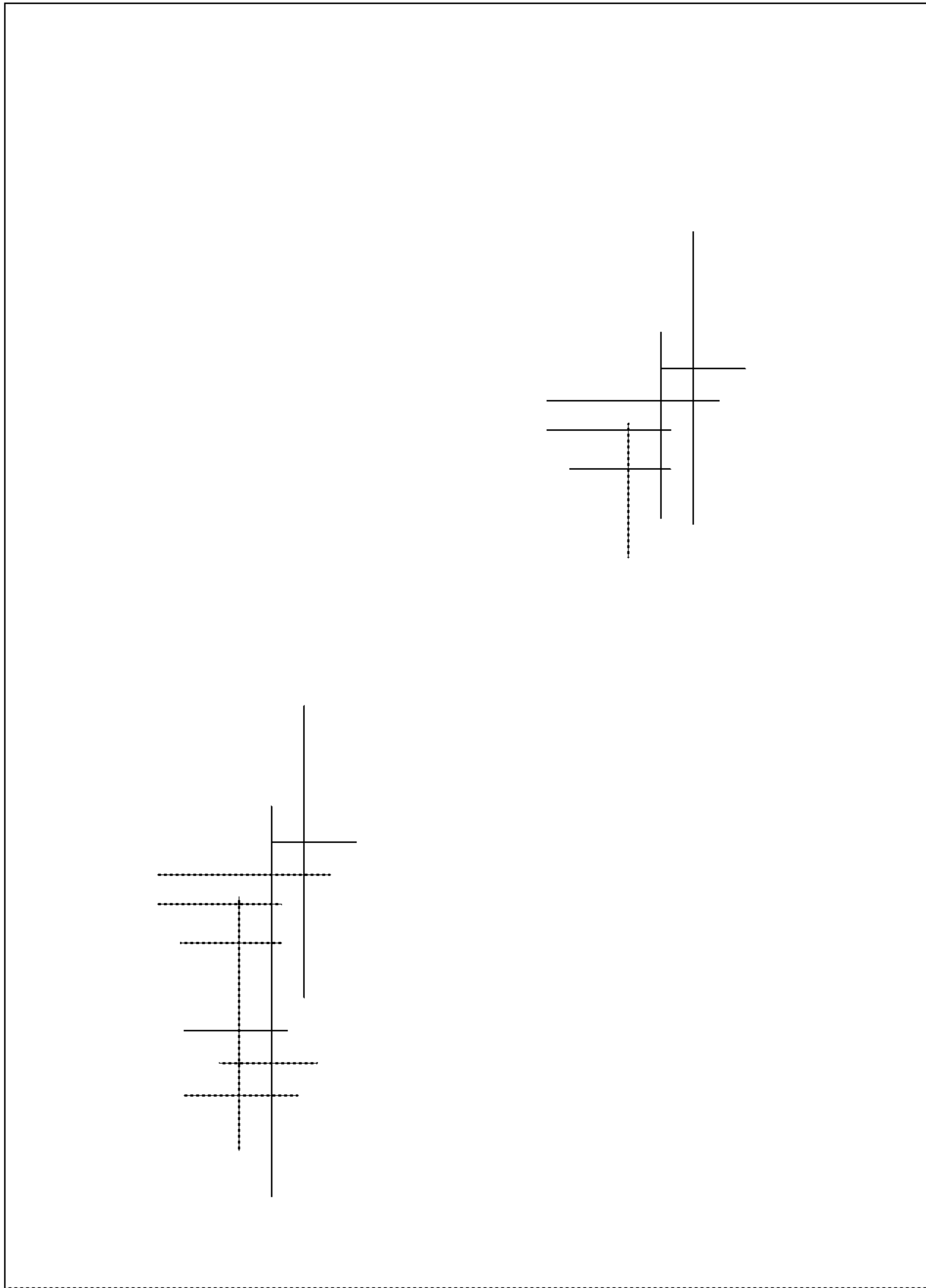

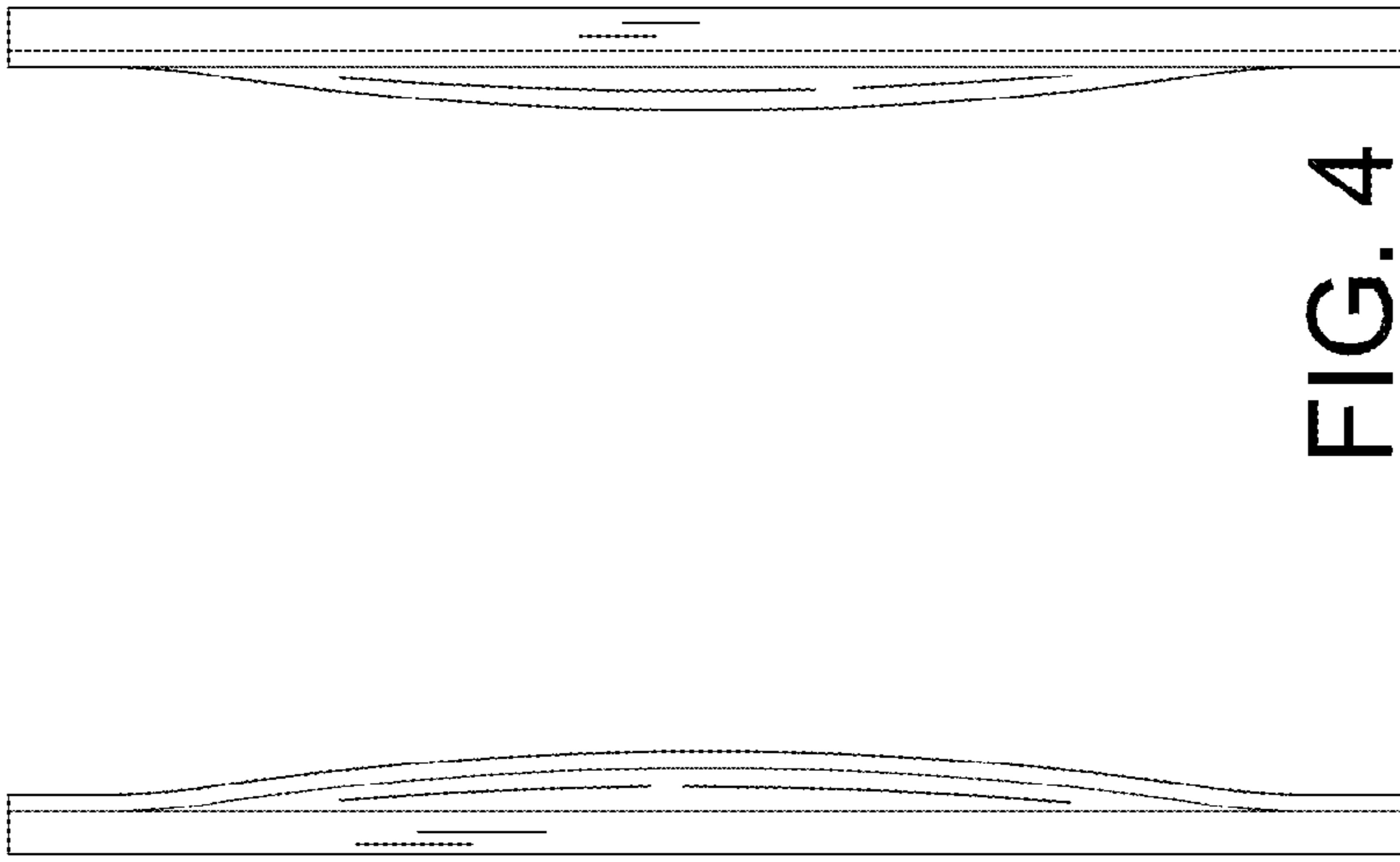

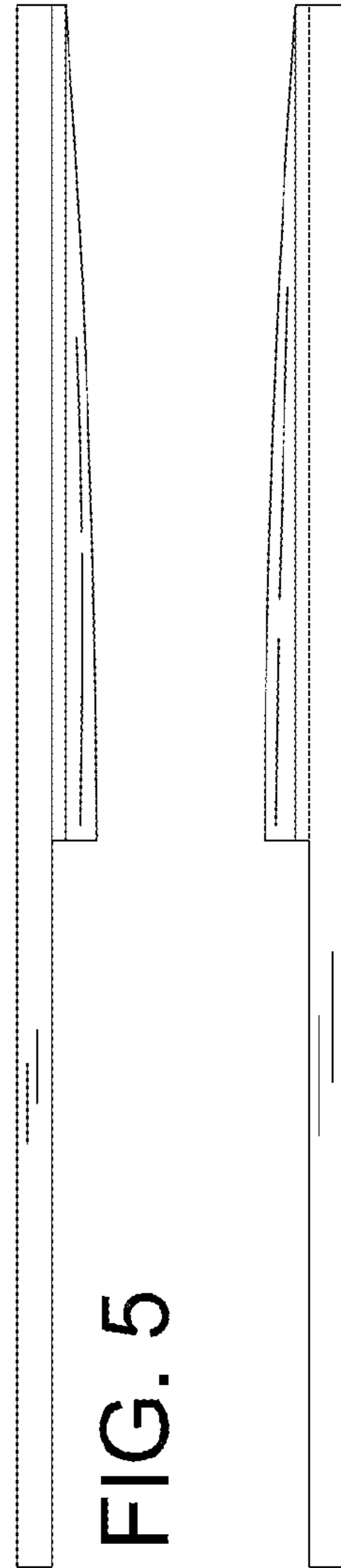

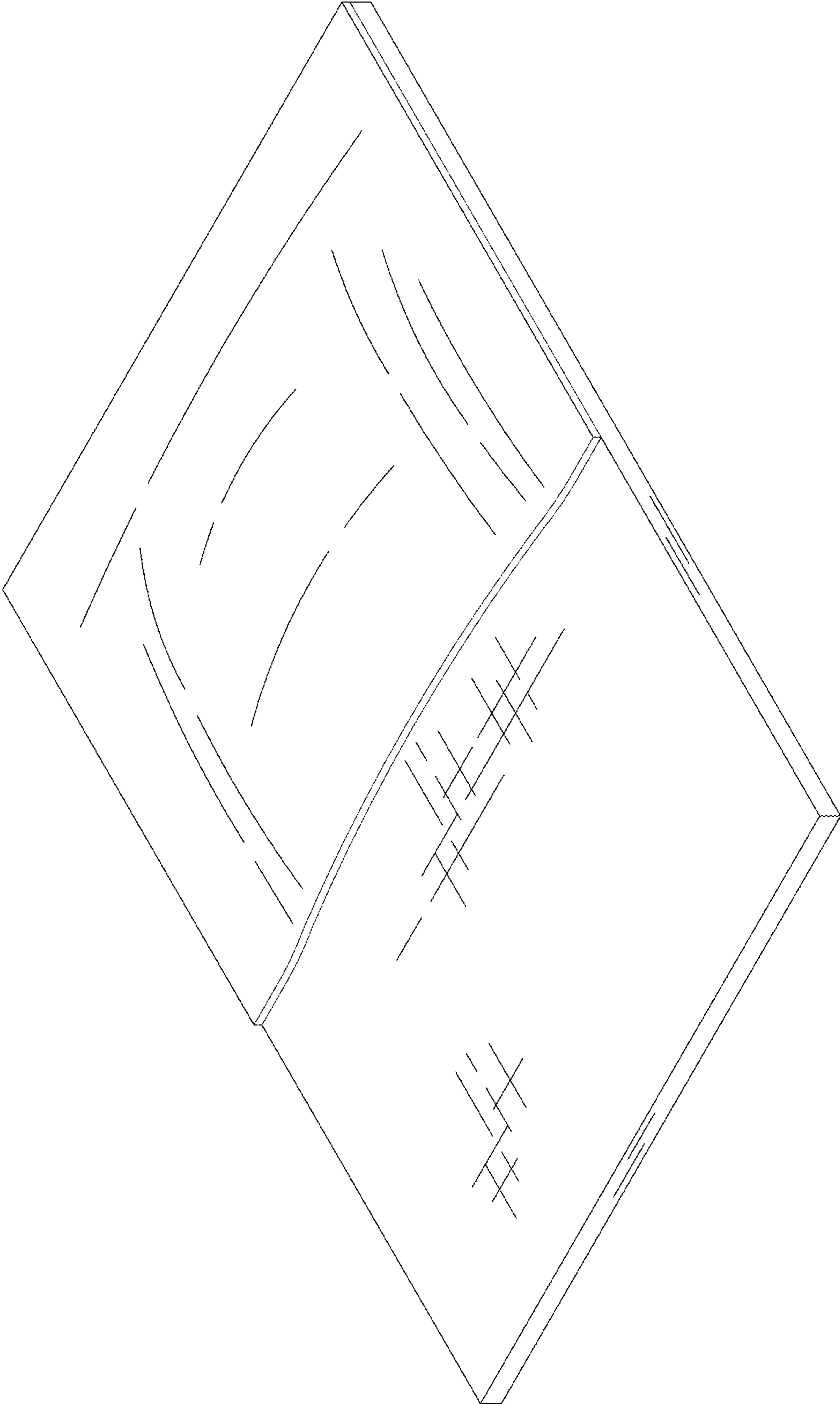

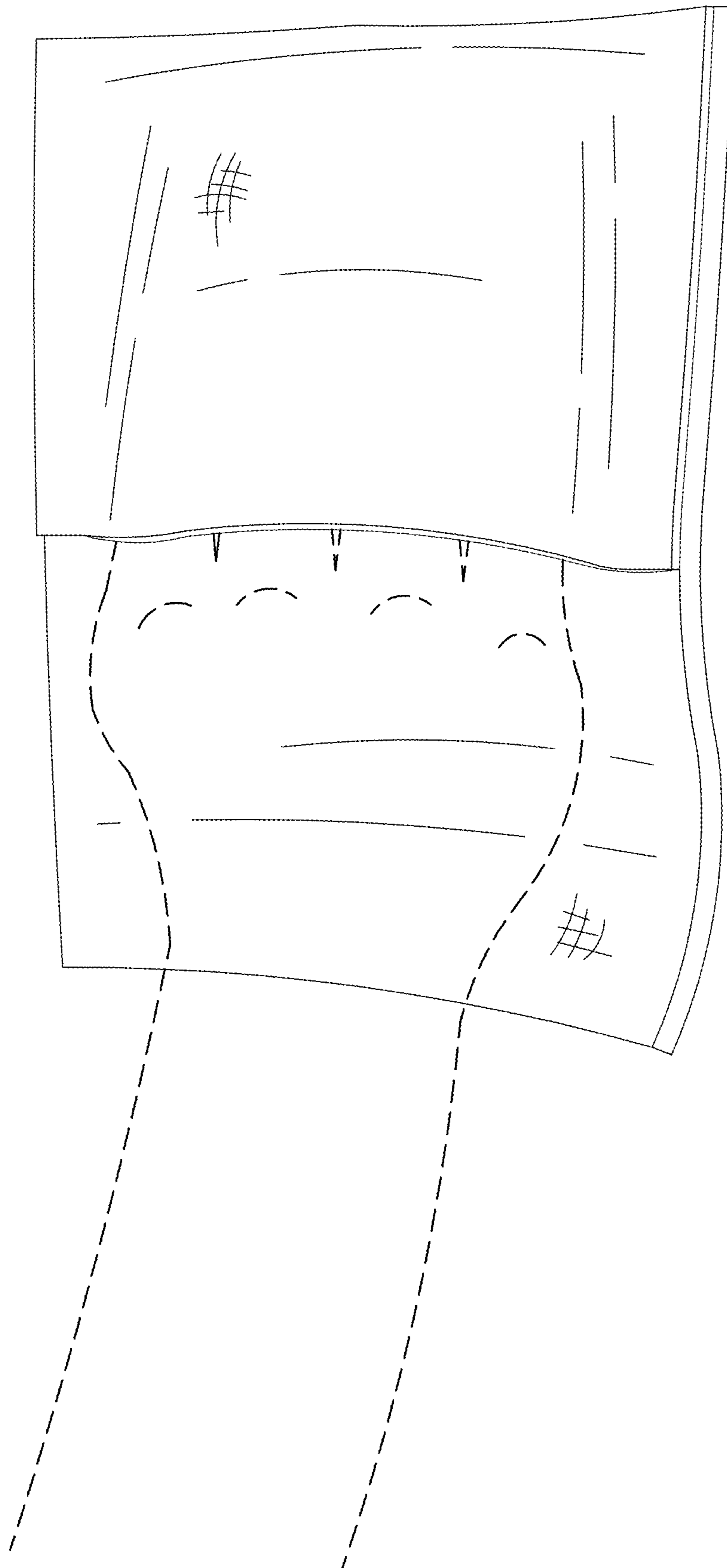
