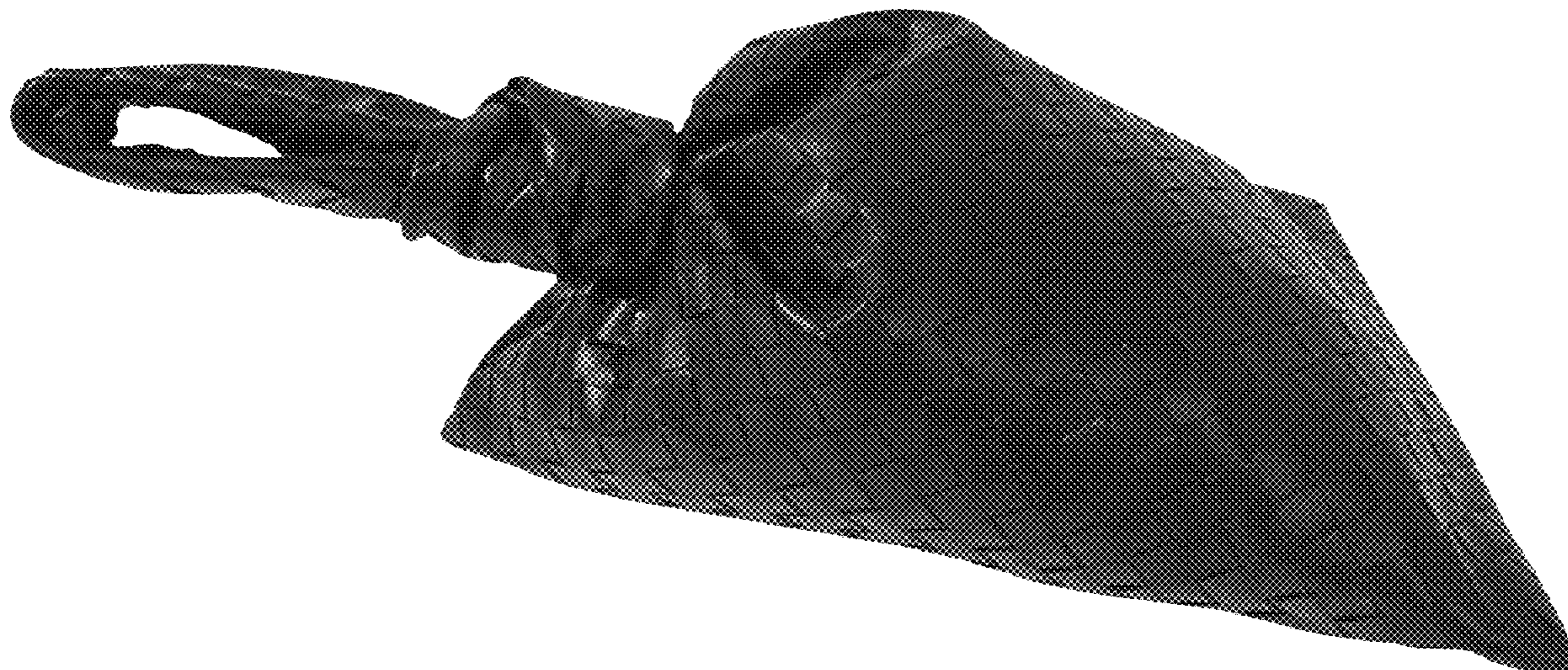
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first right side perspective view of a handbag showing my new design;
FIG. 2 is a front view thereof;

FIG. 5 is a second right side perspective view thereof;

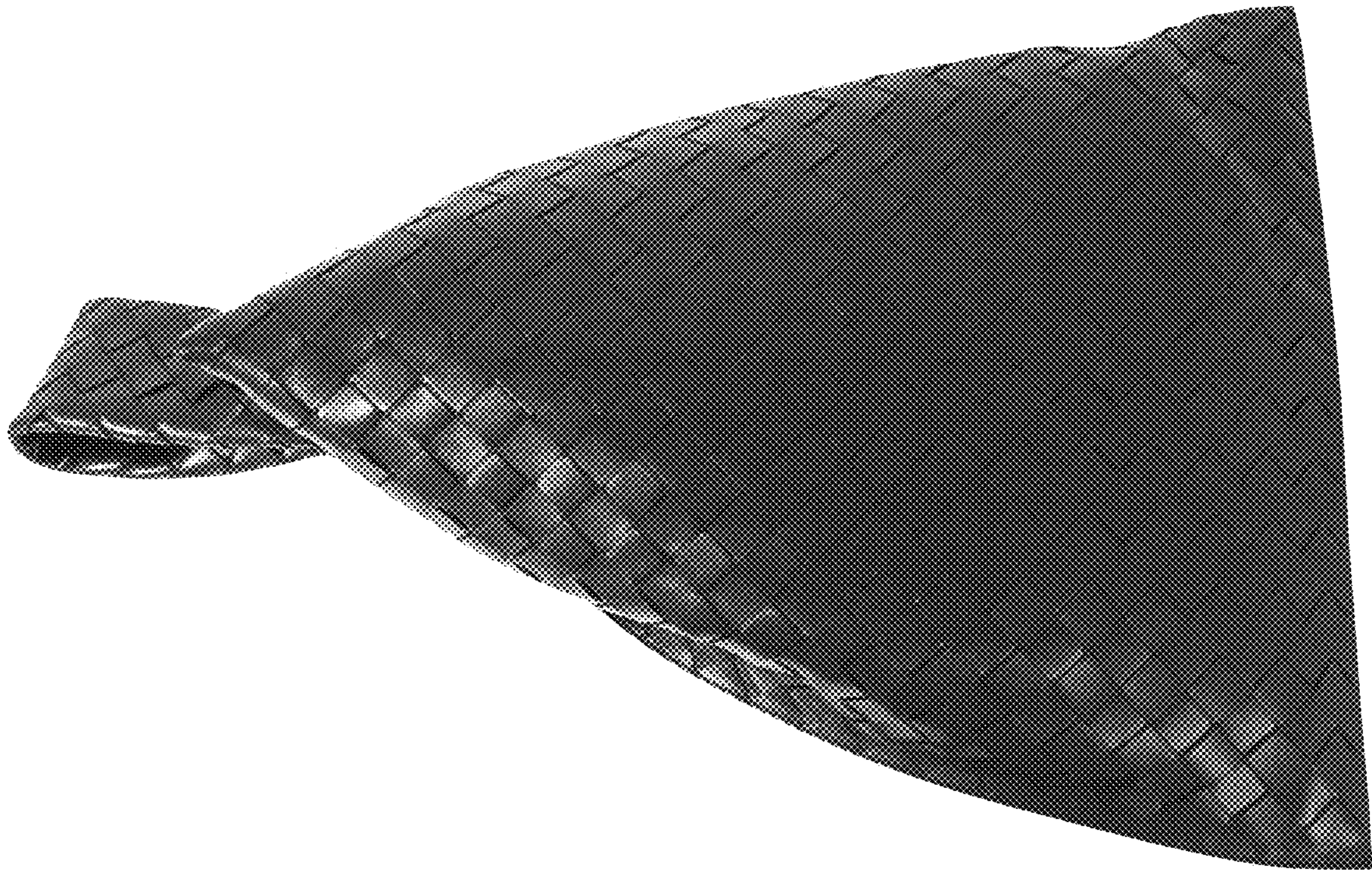

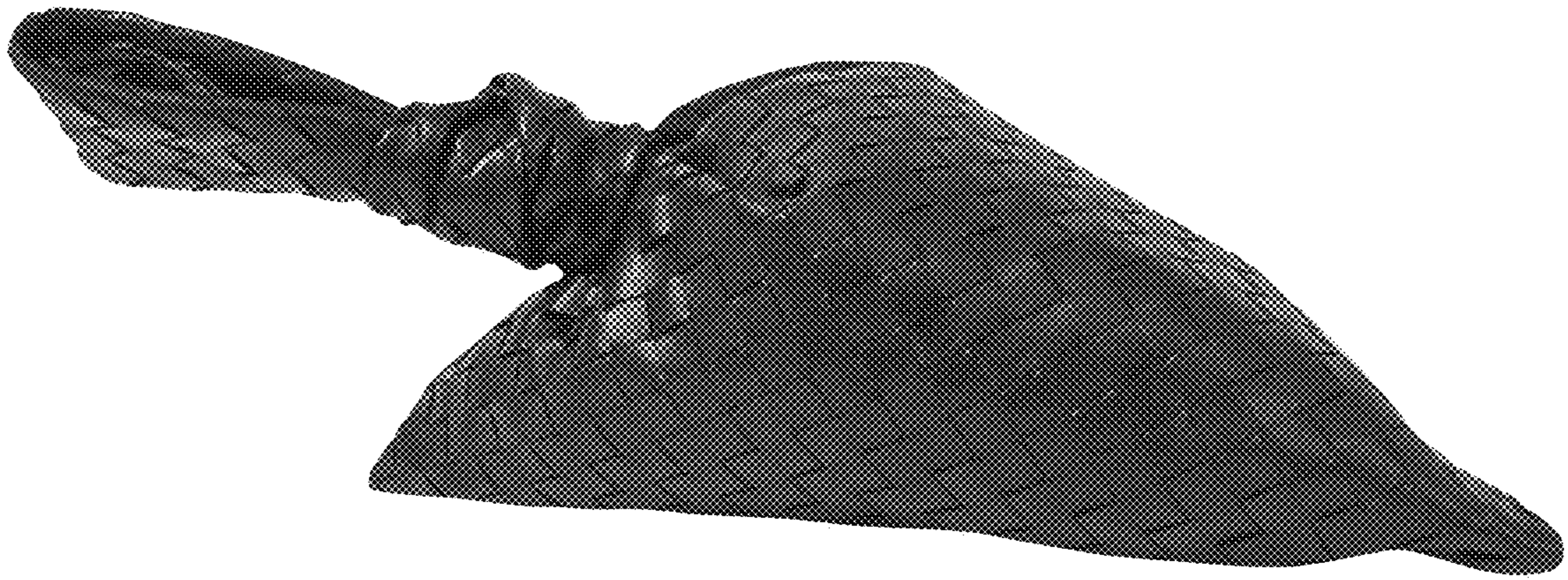

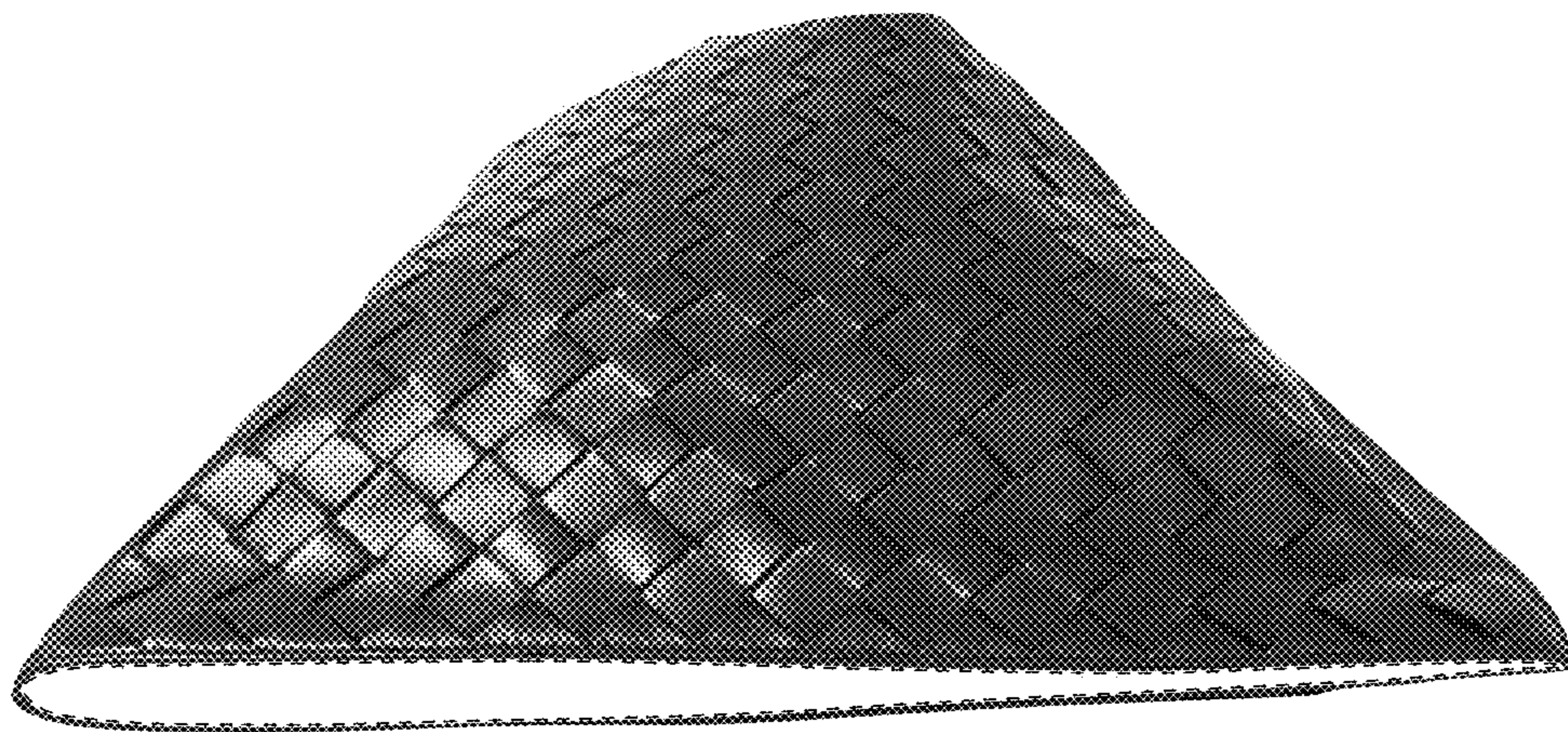
