DESCRIPTION

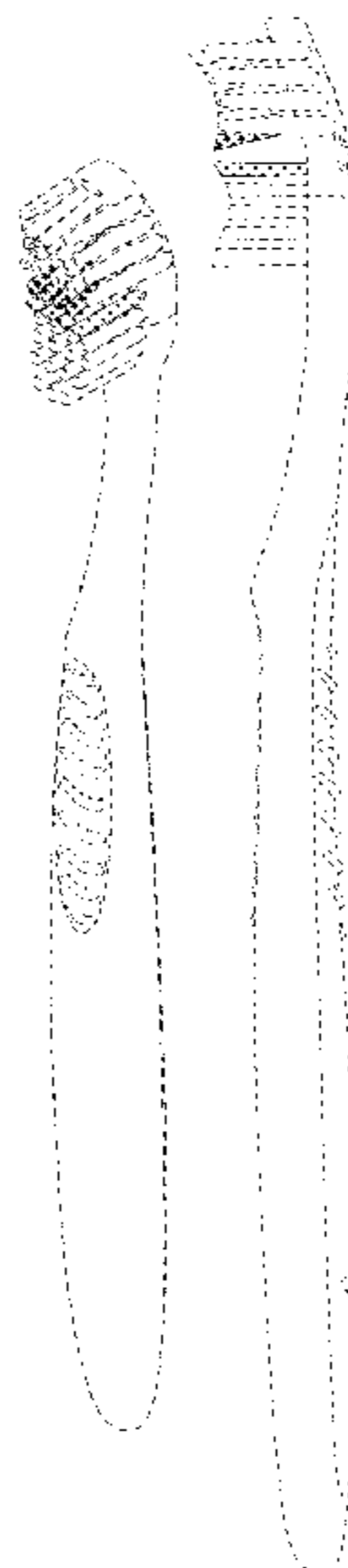
FIG. 1 is a front perspective view of a toothbrush according to the new design;

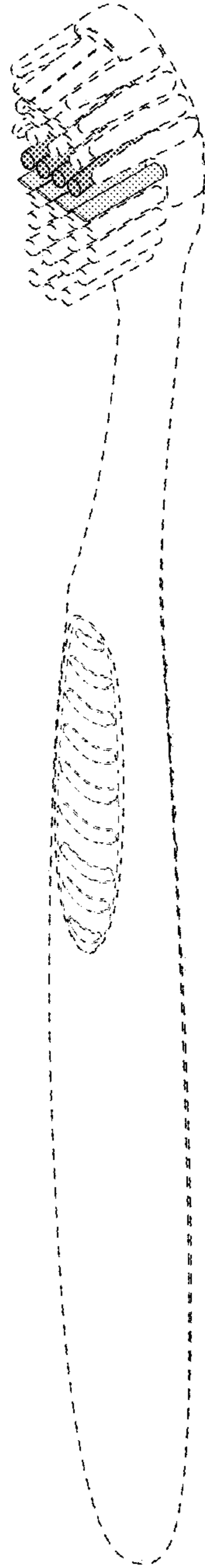

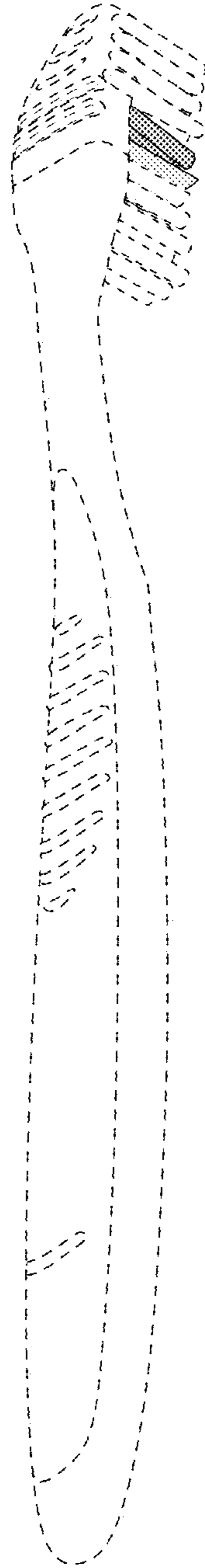

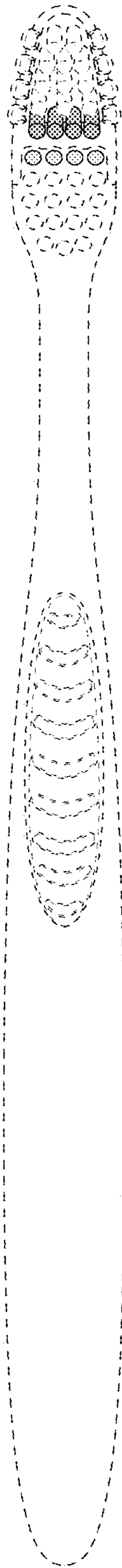

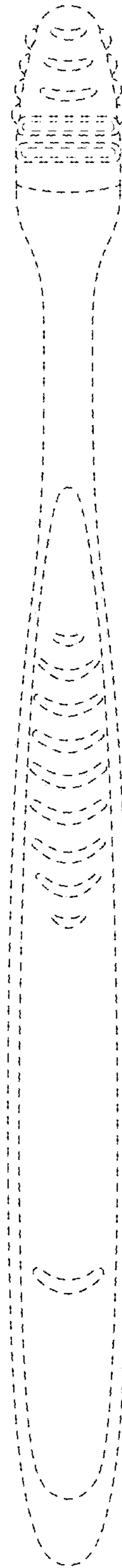

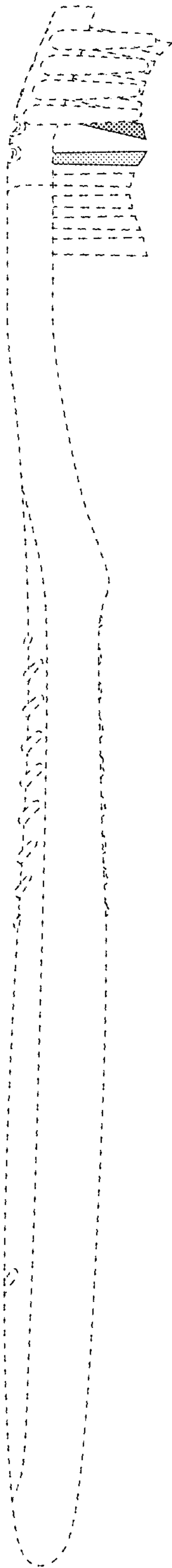

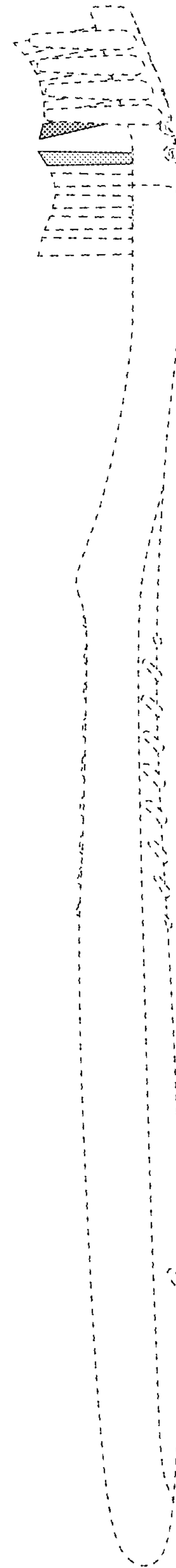

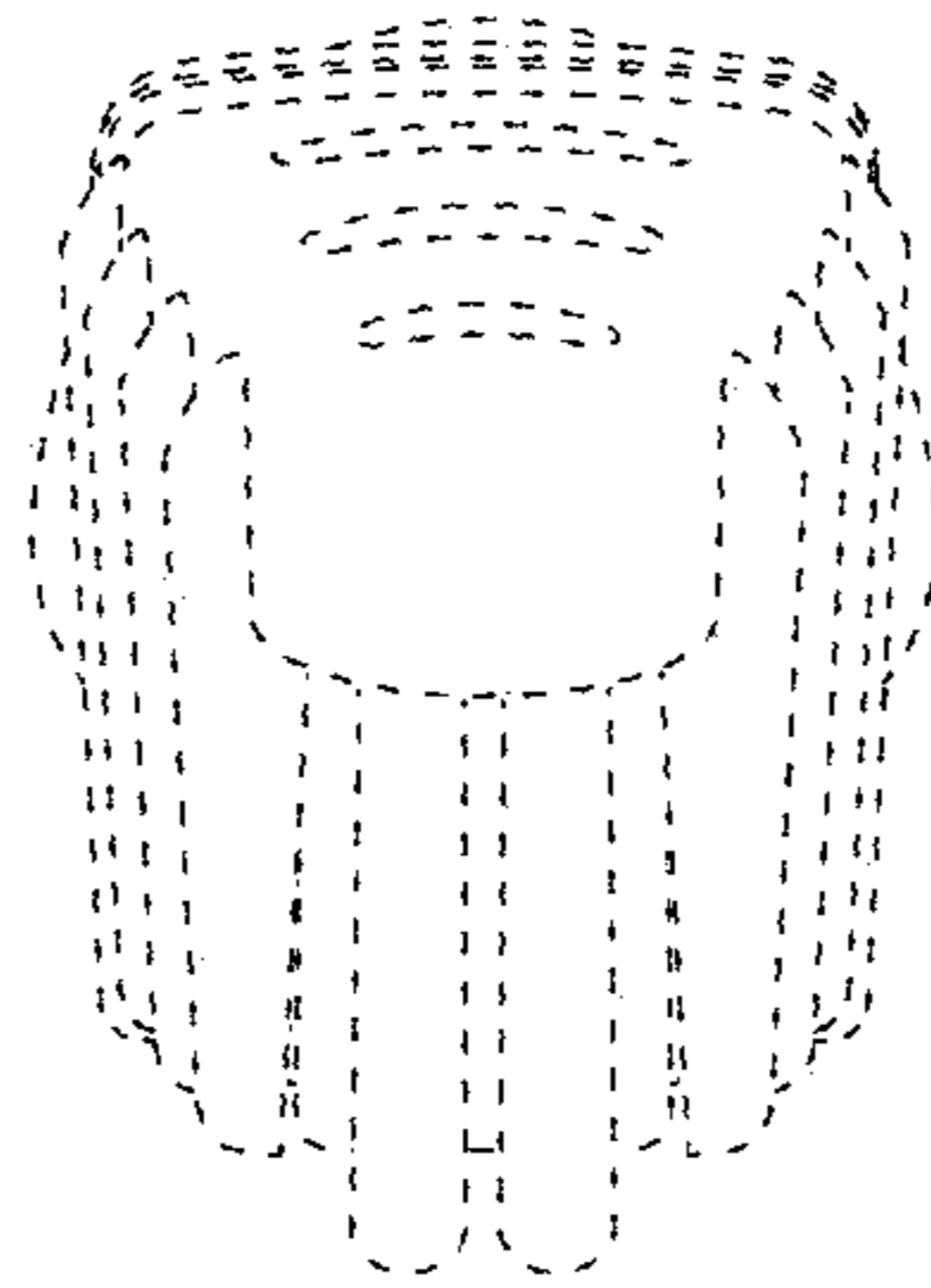

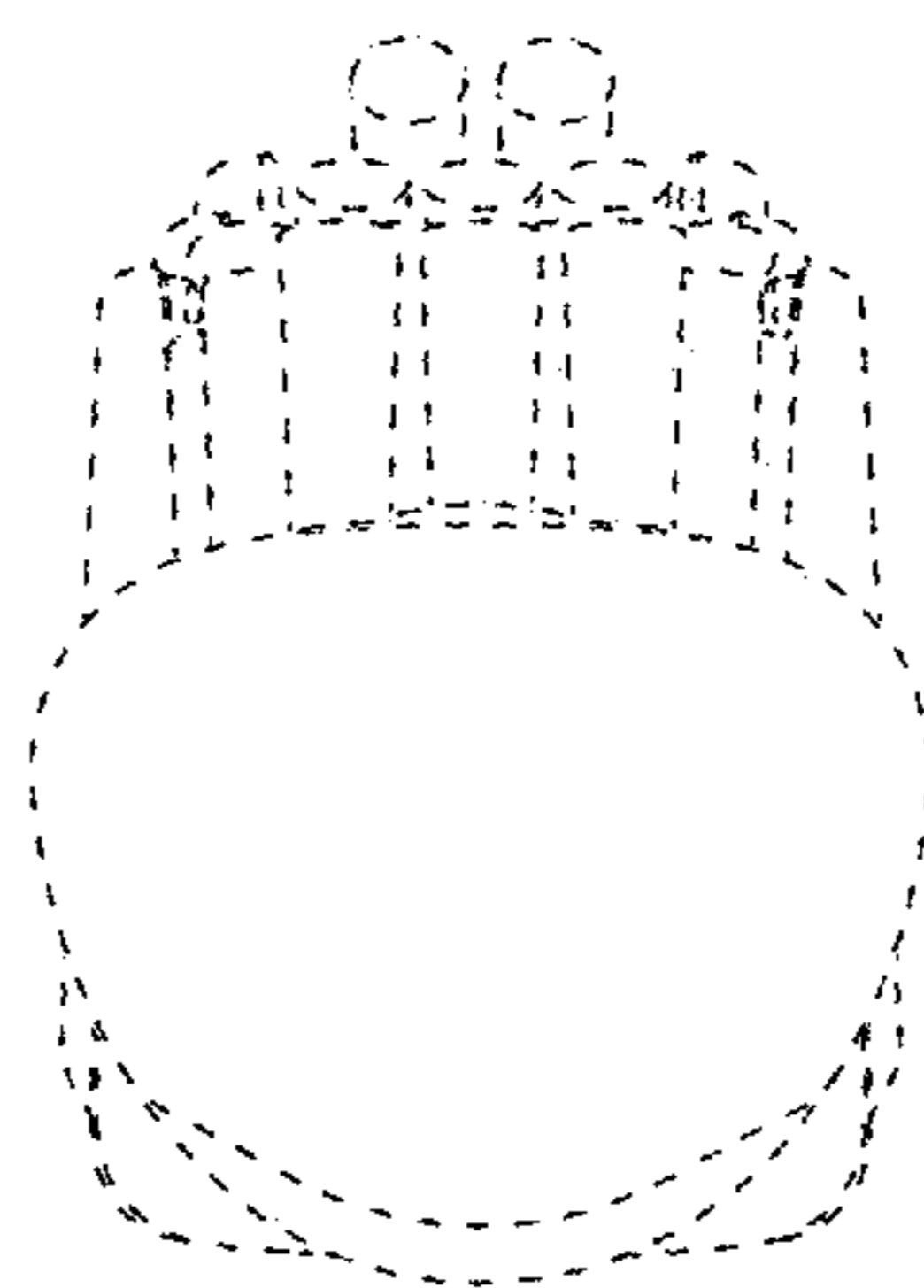
