DESCRIPTION

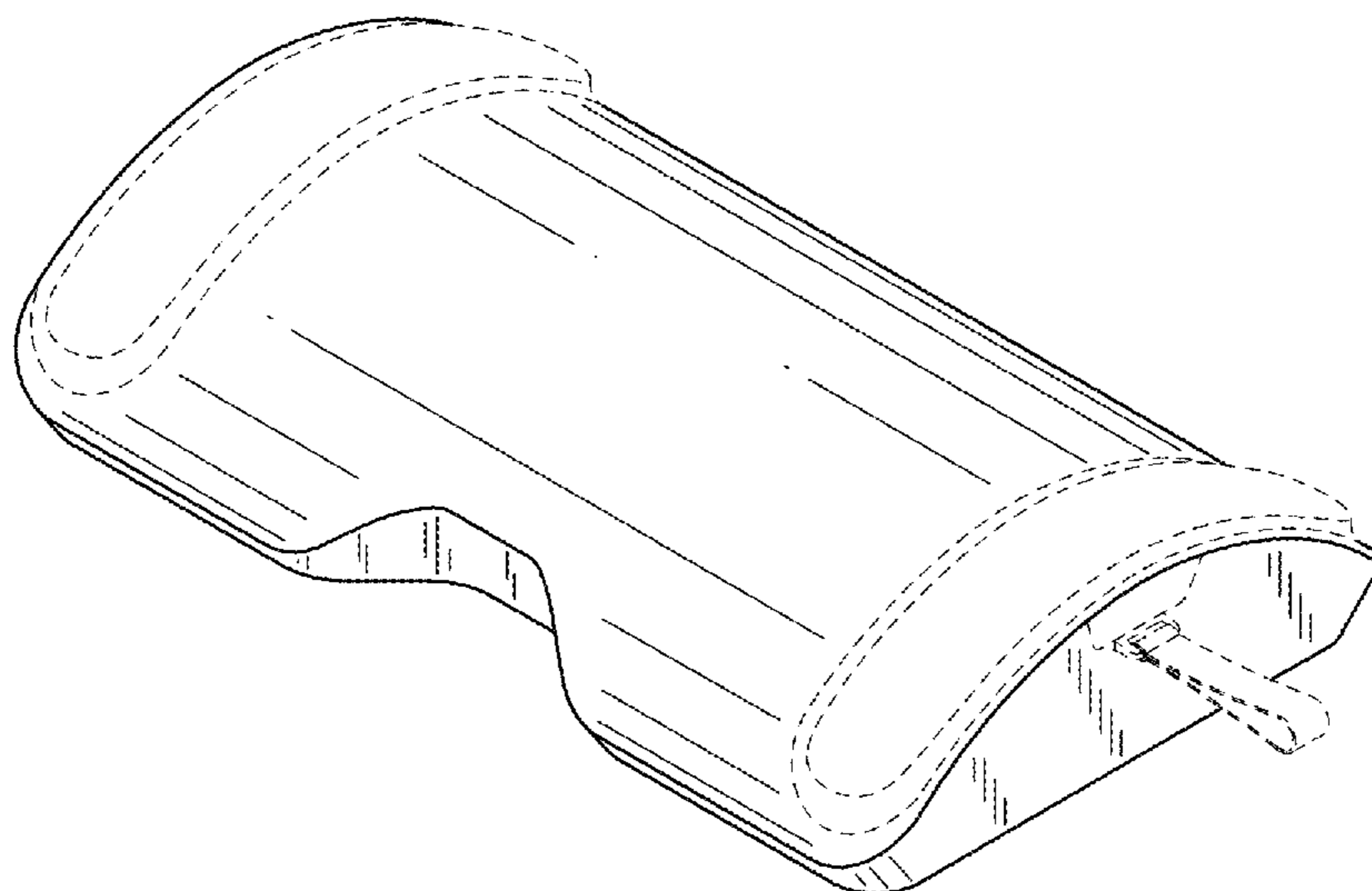
FIG. 1 is a three-quarter profile view of showing the new design;

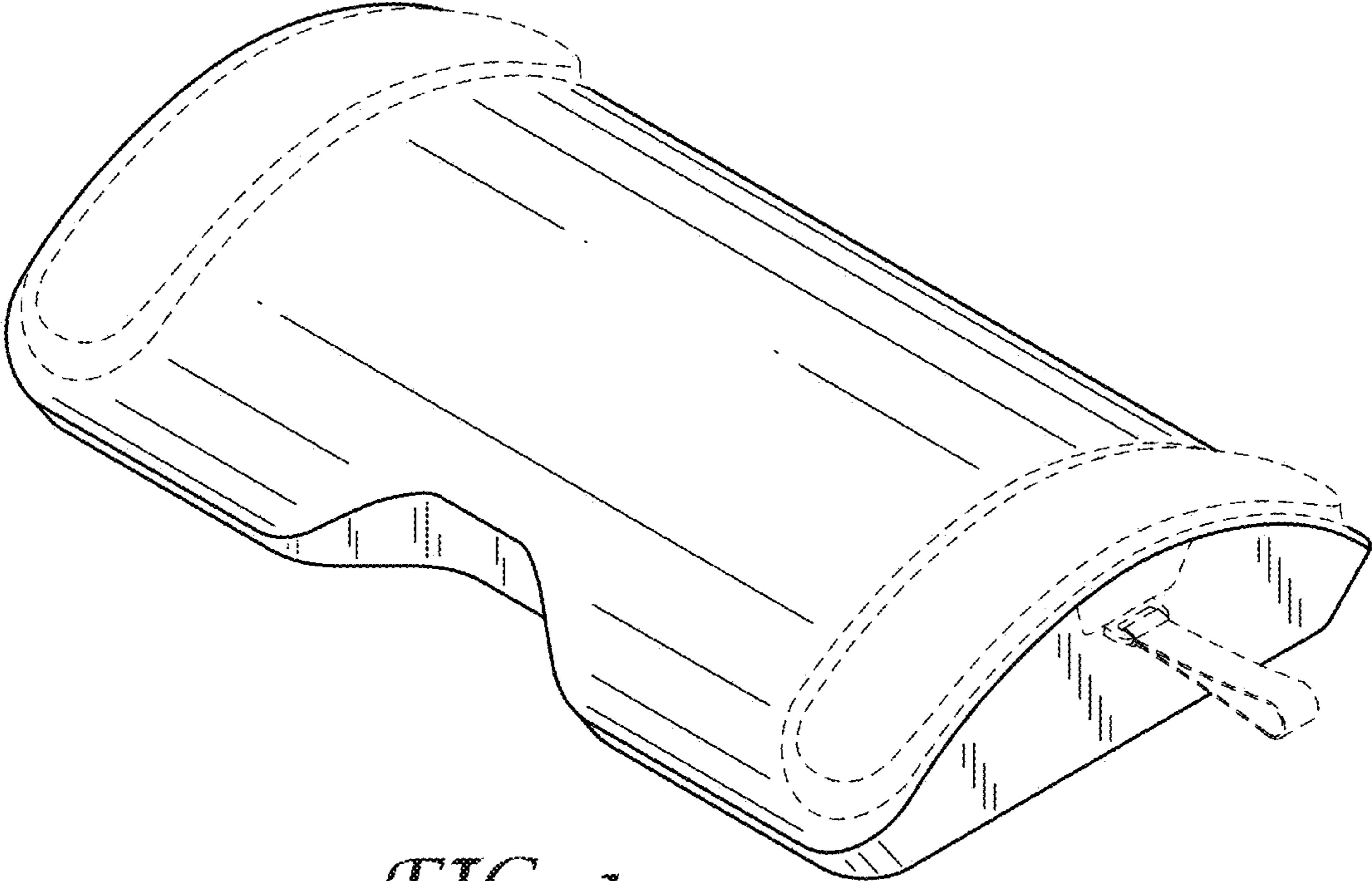

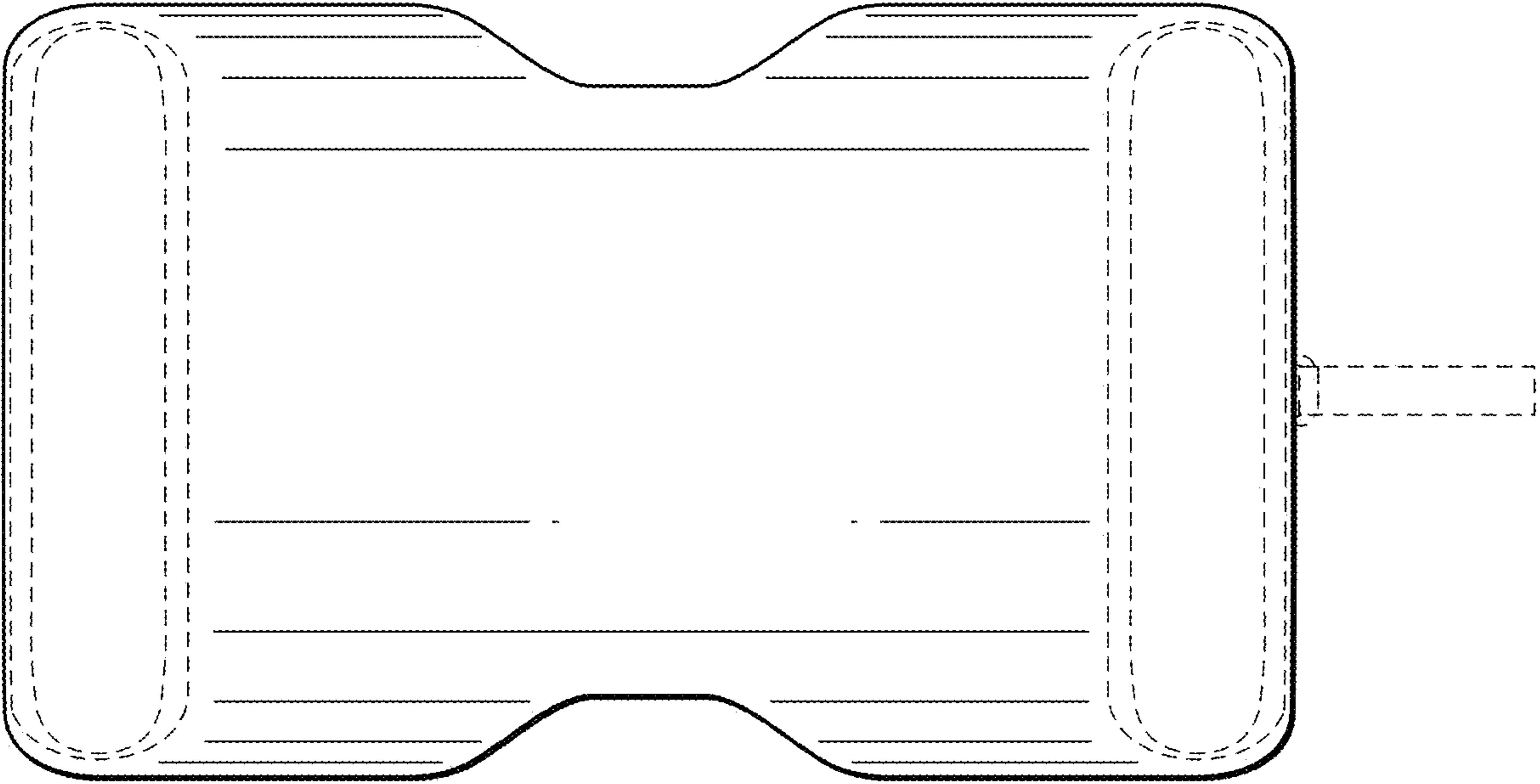

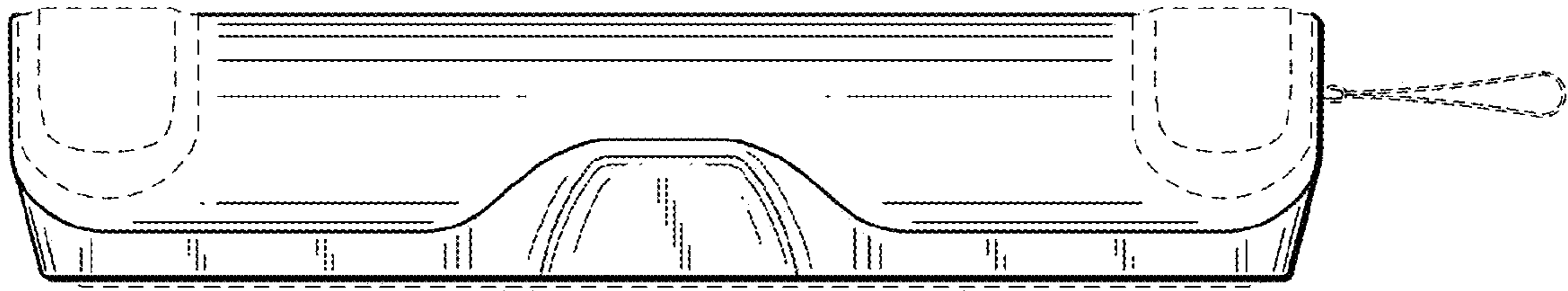

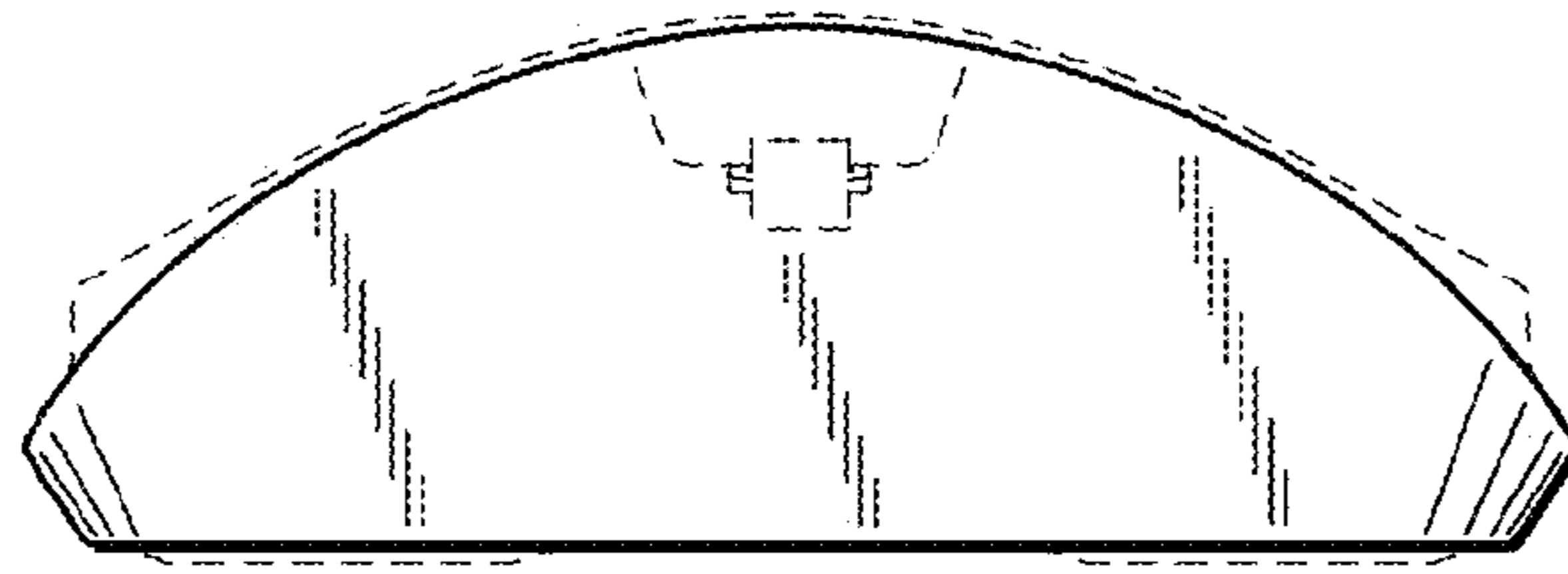

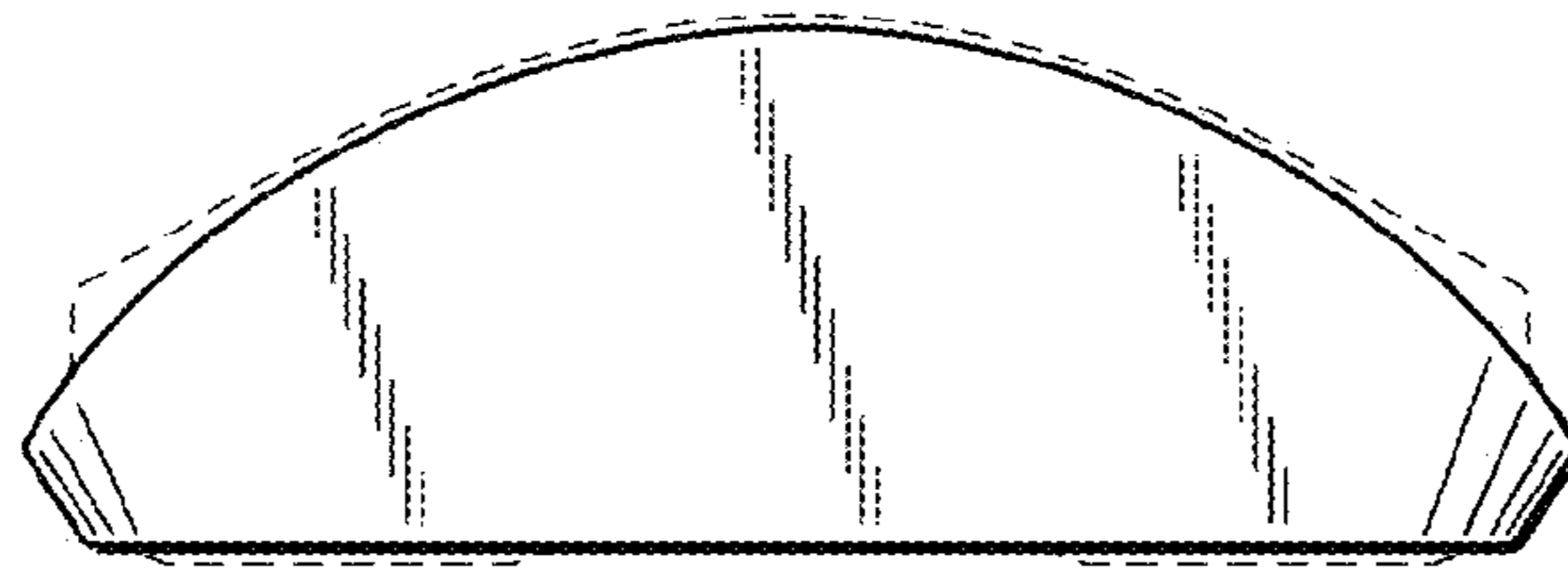

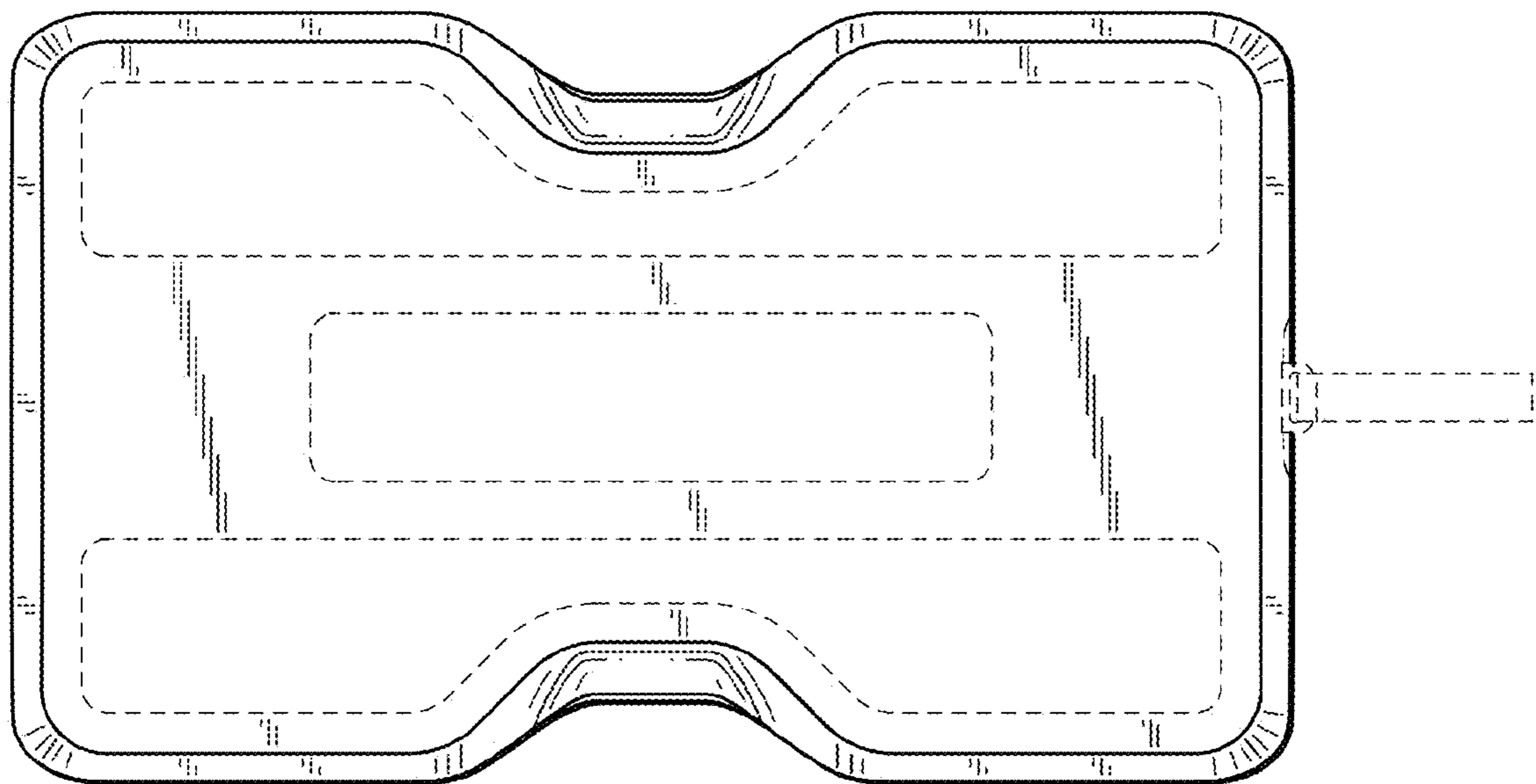
