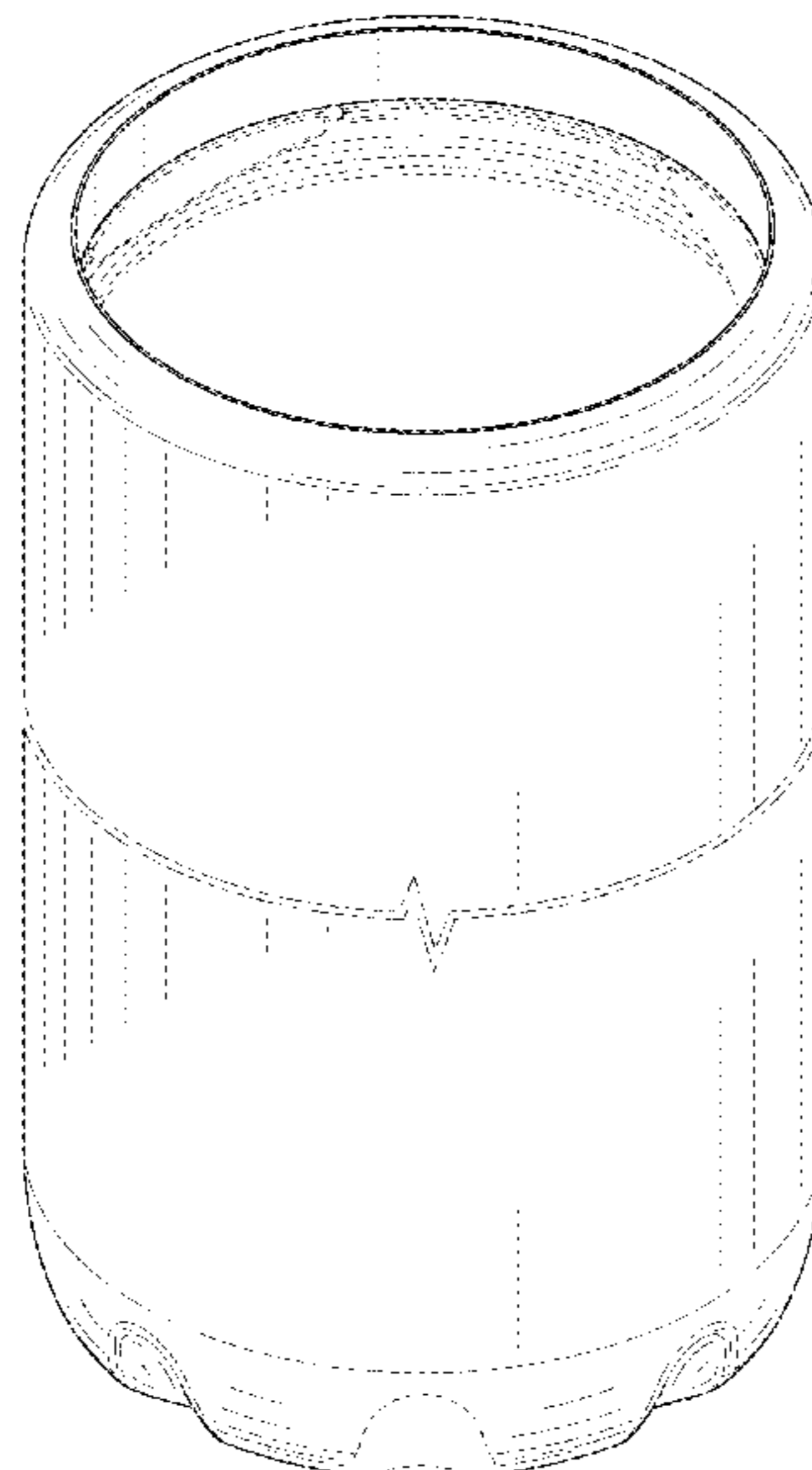
FIG. 1 is a top isometric view of an embodiment of the drink holder.

FIG. 3 is a front elevation view of the drink holder of FIG. 1.  
FIG. 4 is a rear elevation view of the drink holder of FIG. 1.  
FIG. 5 is a right side elevation view of the drink holder of FIG. 1.  
FIG. 6 is a left side elevation view of the drink holder of FIG. 1.  
FIG. 7 is a top plan view of the drink holder of FIG. 1; and, FIG. 8 is a bottom plan view of the drink holder of FIG. 1. The evenly dotted broken lines in the figures illustrate unclaimed features of the drink holder and form no part of the claimed design. The dash-dot-dot-dash broken lines depict a symbolic break in the drink holder indicating that the appearance of any portion of the drink holder between these break lines forms no part of the claimed design. The dash-dot-dash broken lines shown in FIG. 2 and FIG. 8 depict boundary lines of unclaimed portions of the drink holder that form no part of the claimed design.

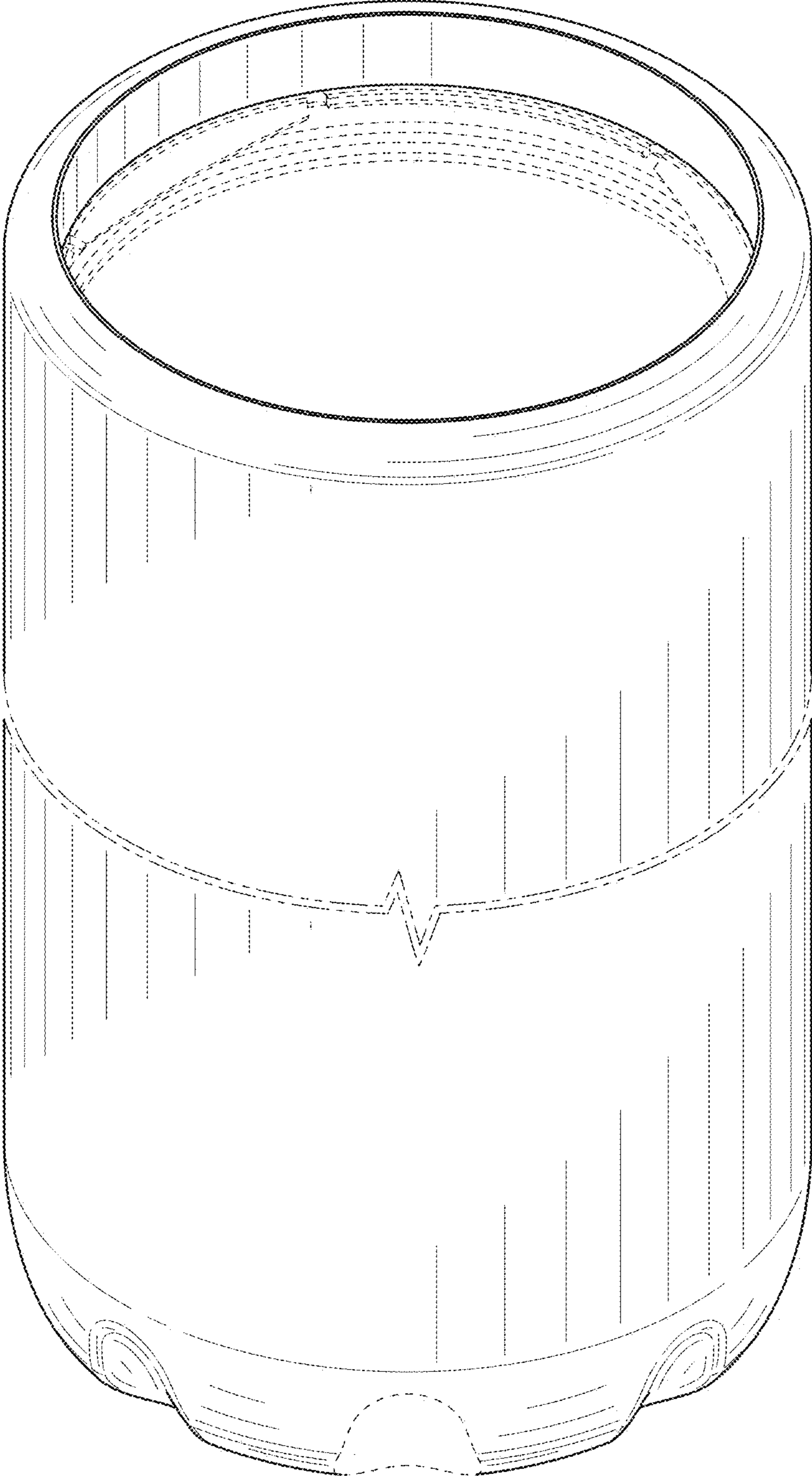

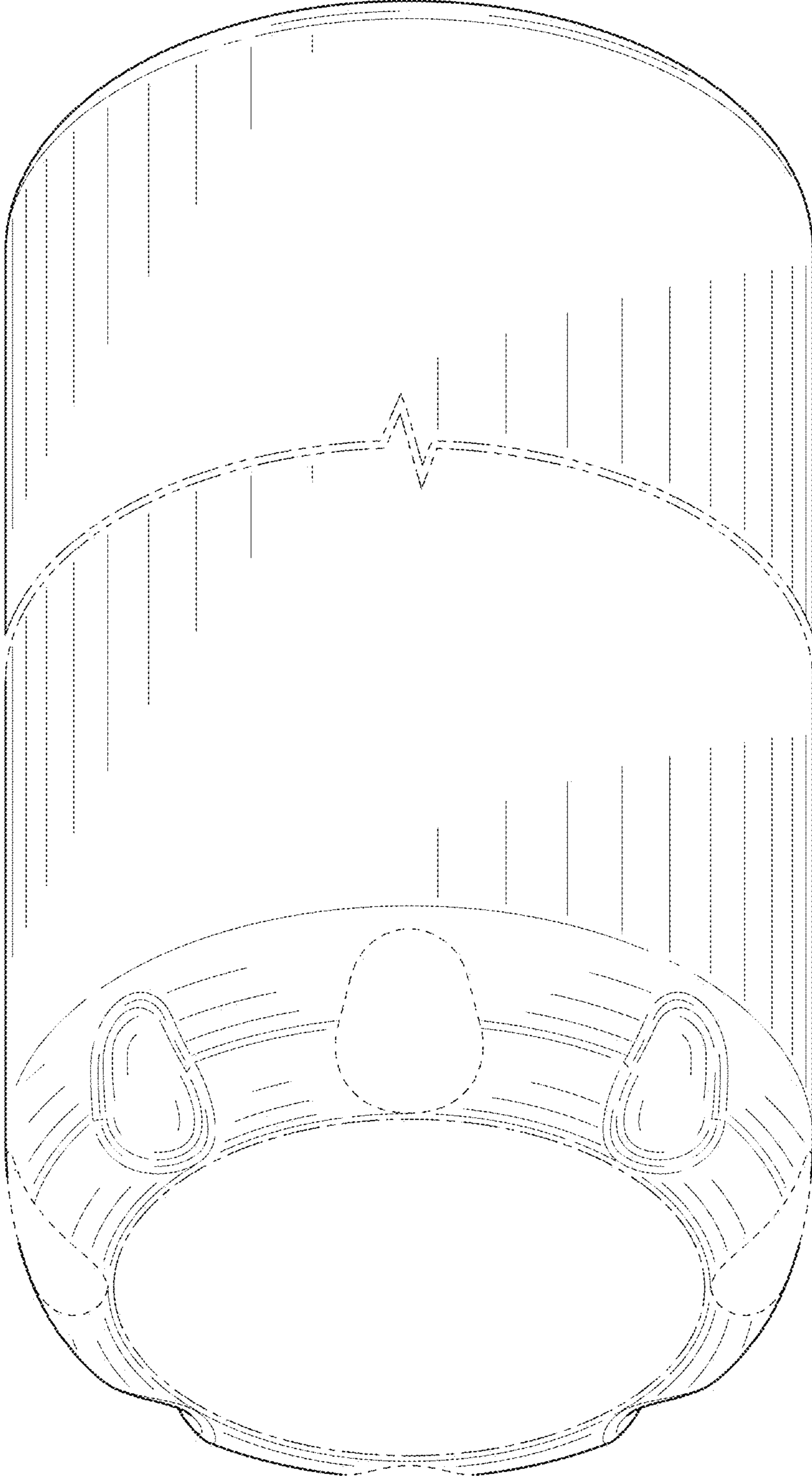

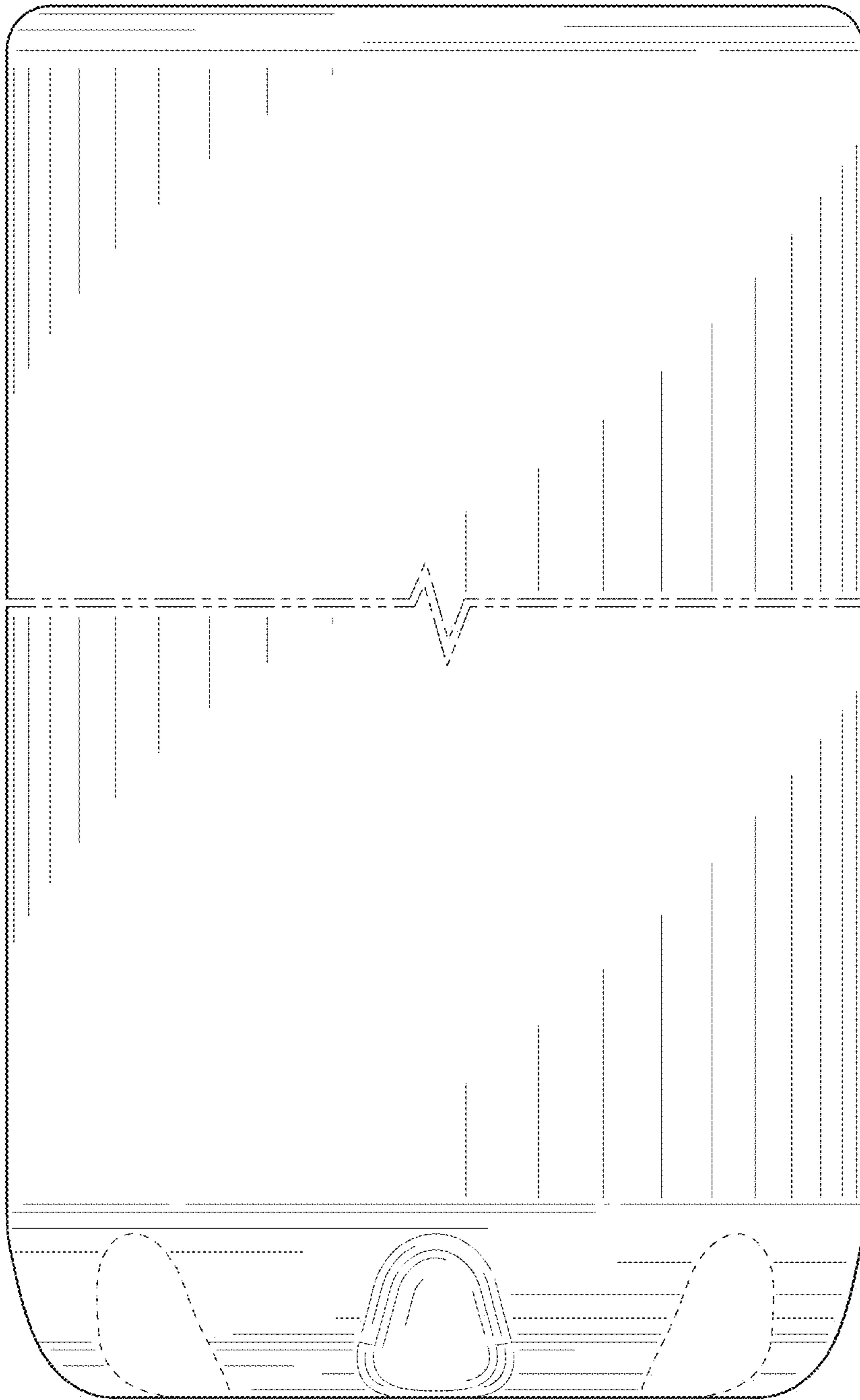

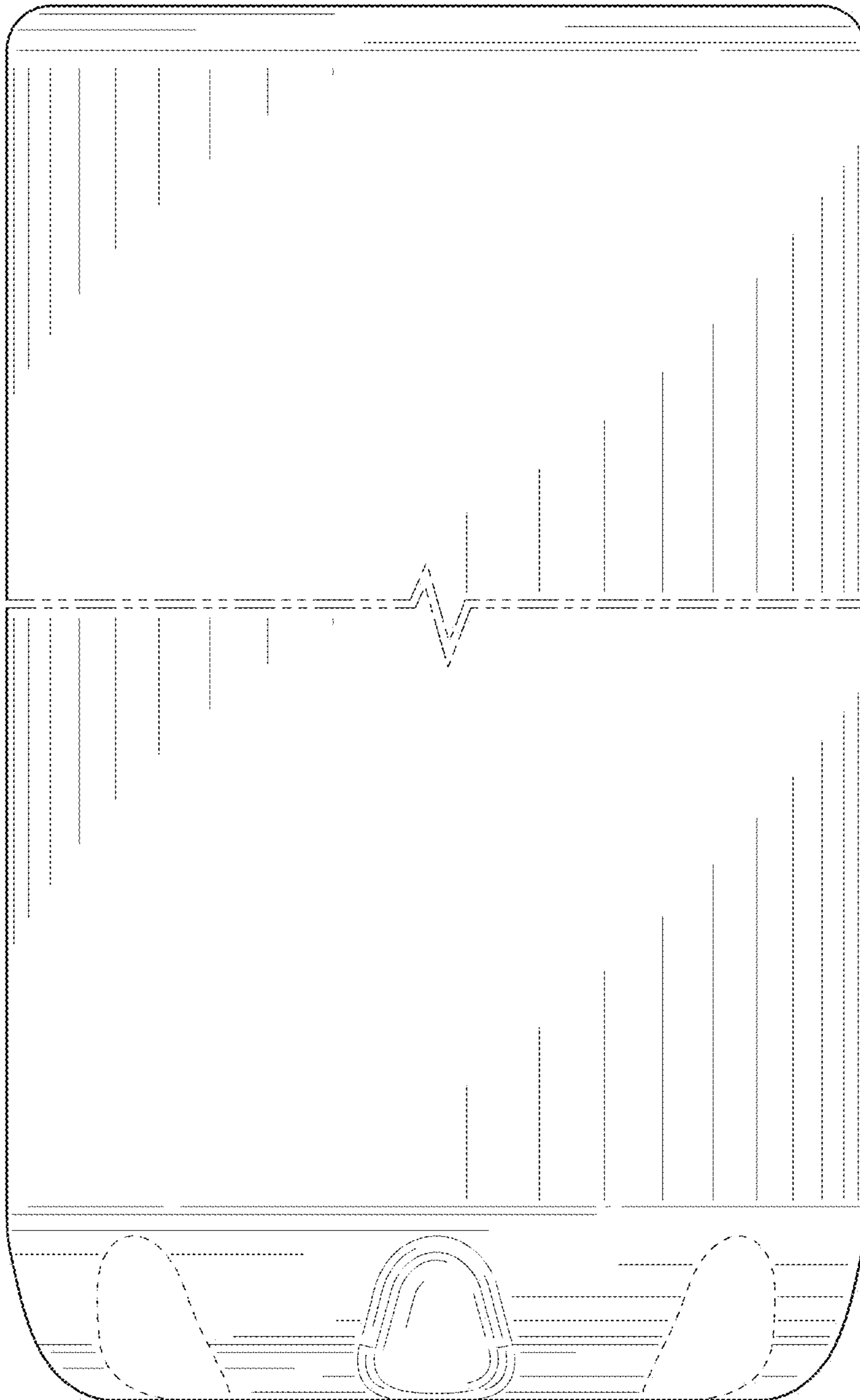

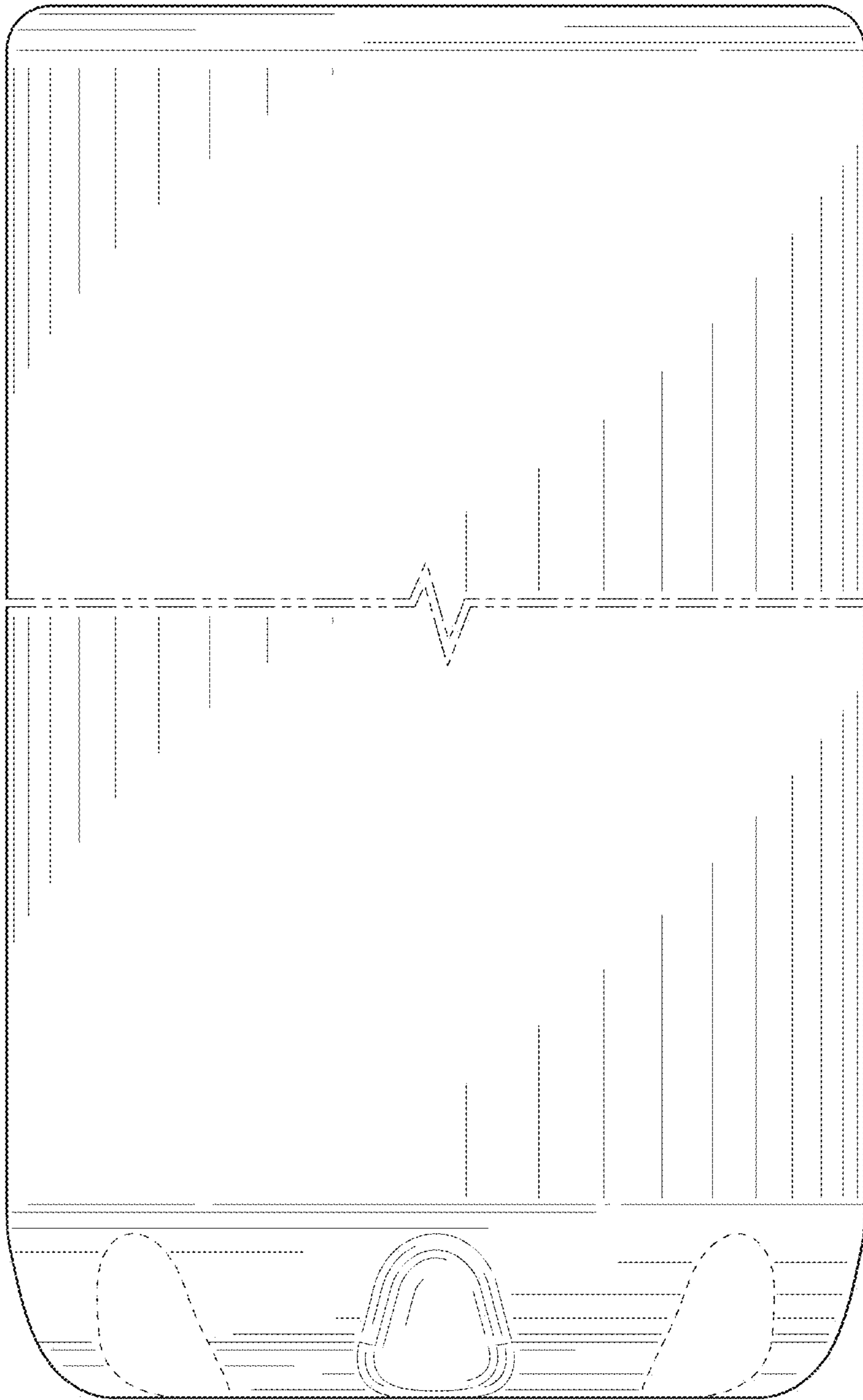

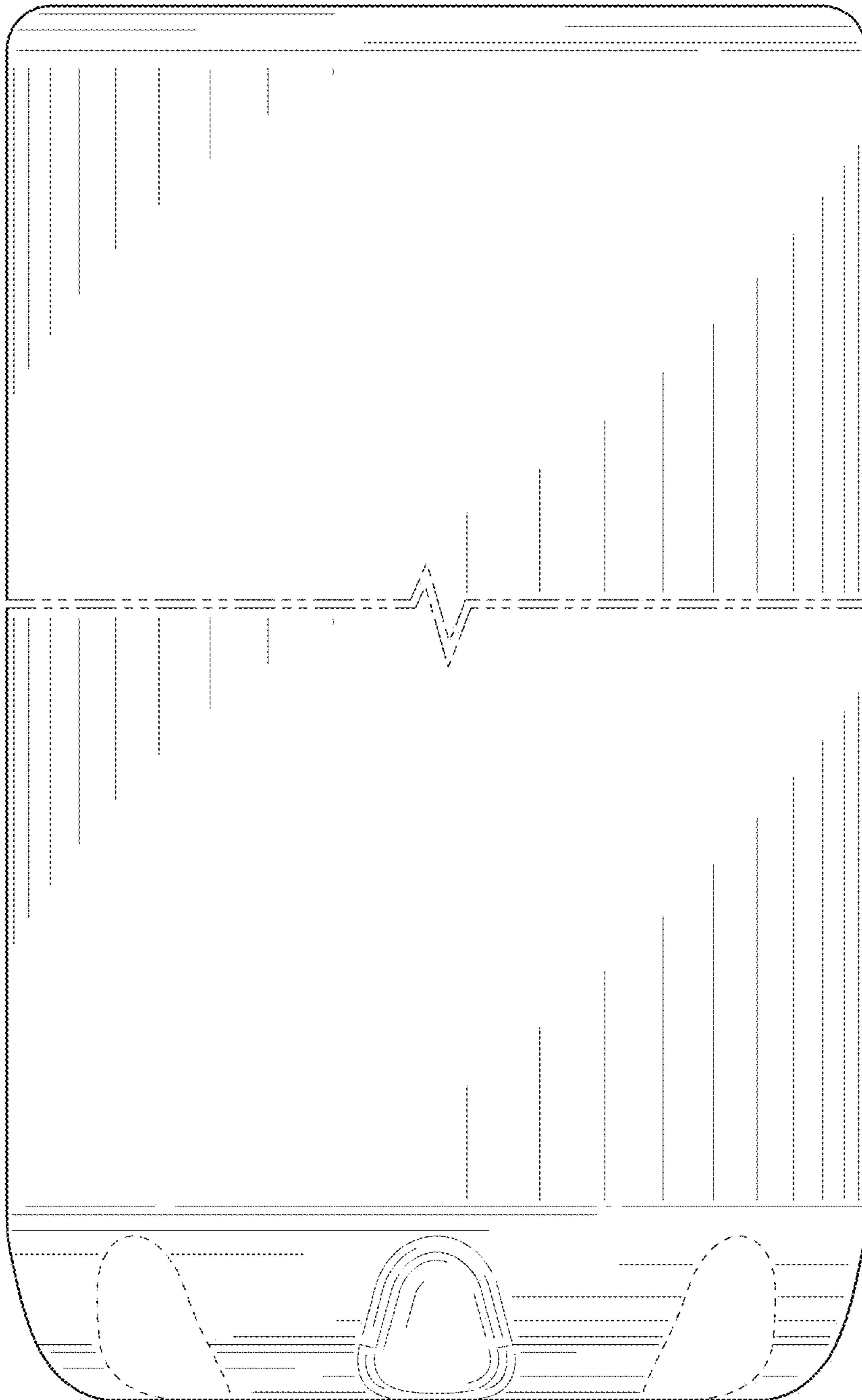

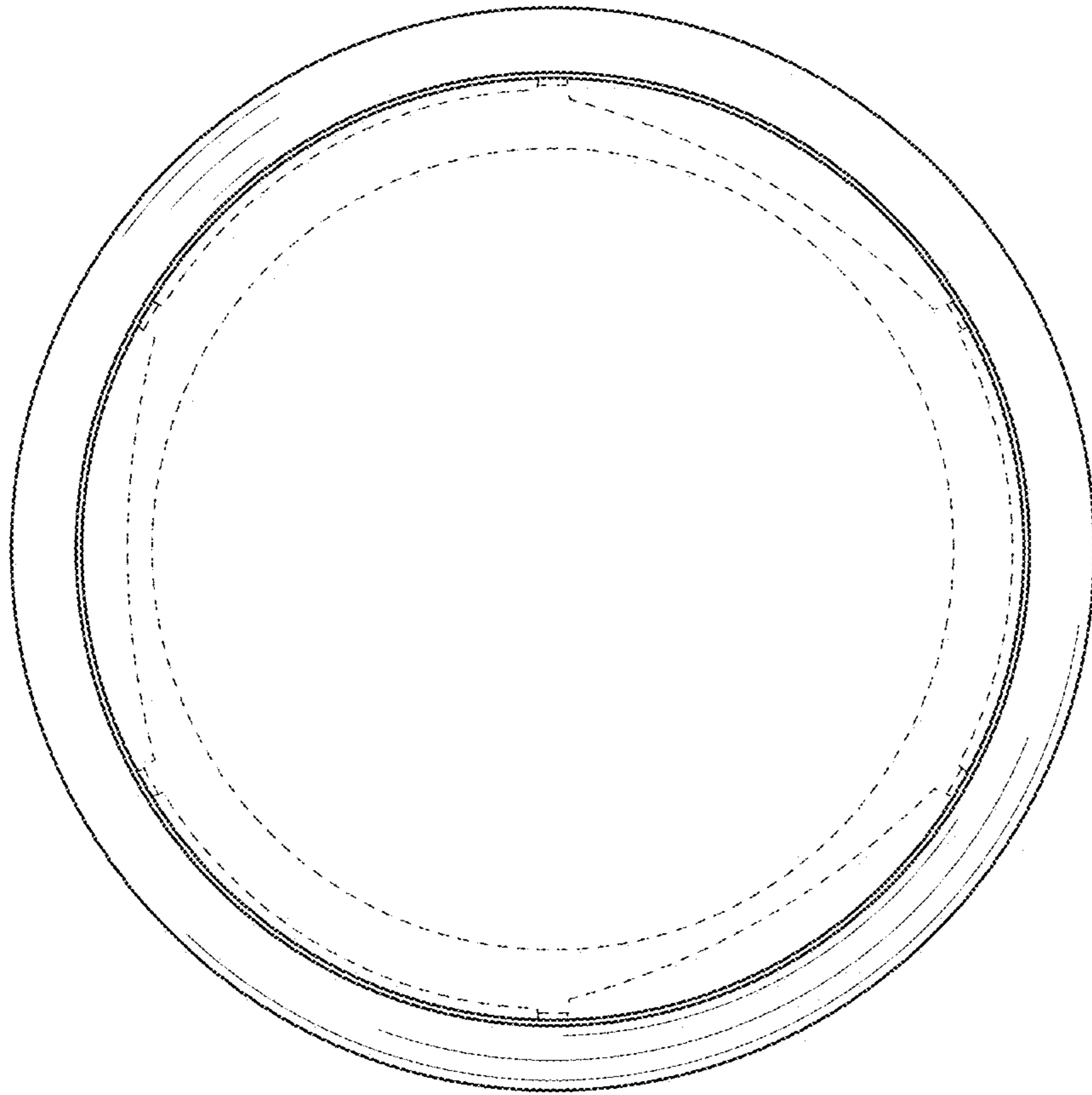

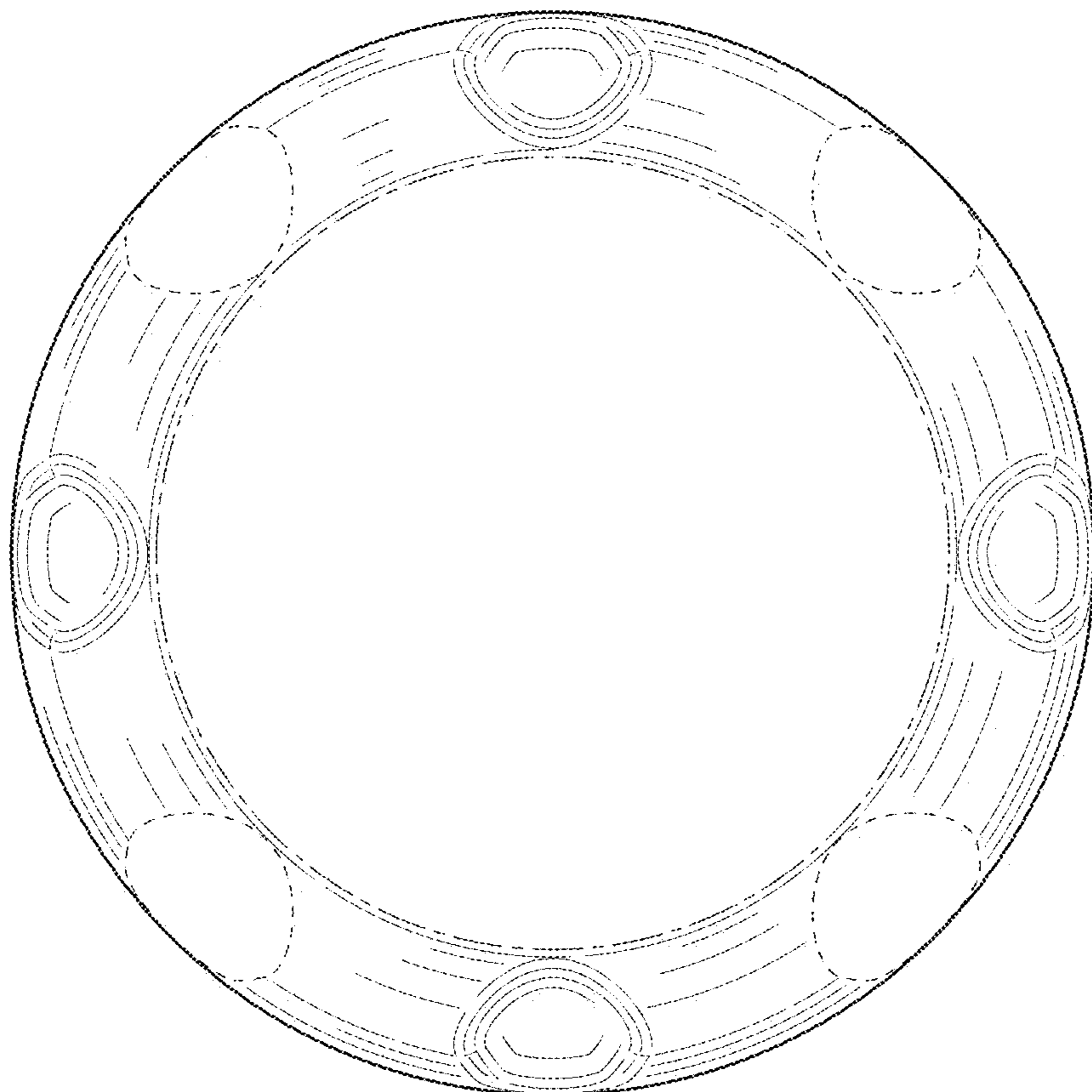
