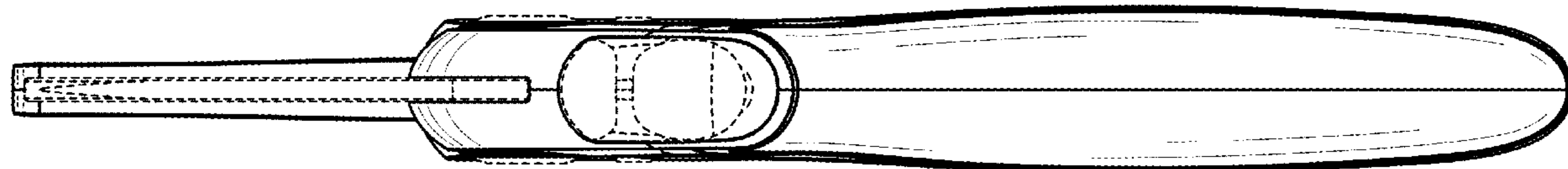
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of our pruner according to our new design;

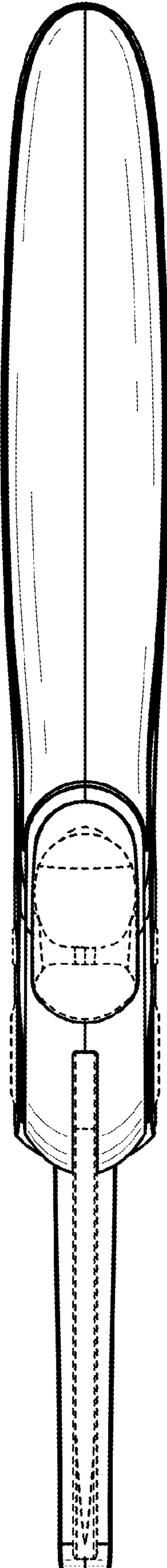

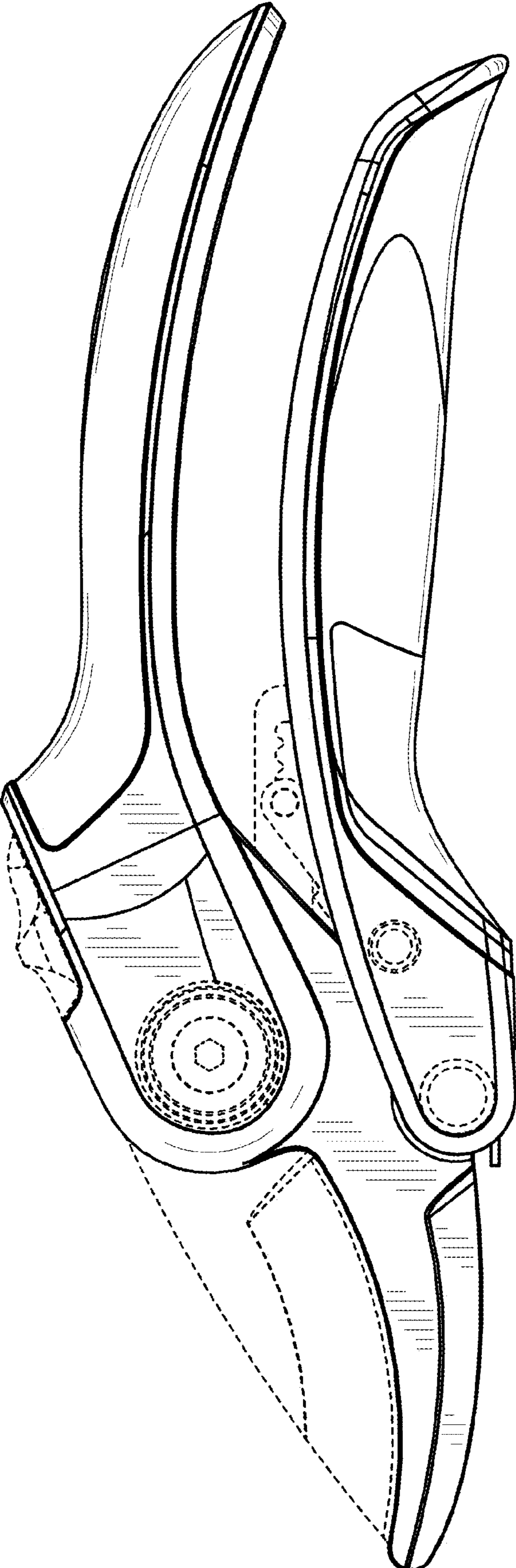

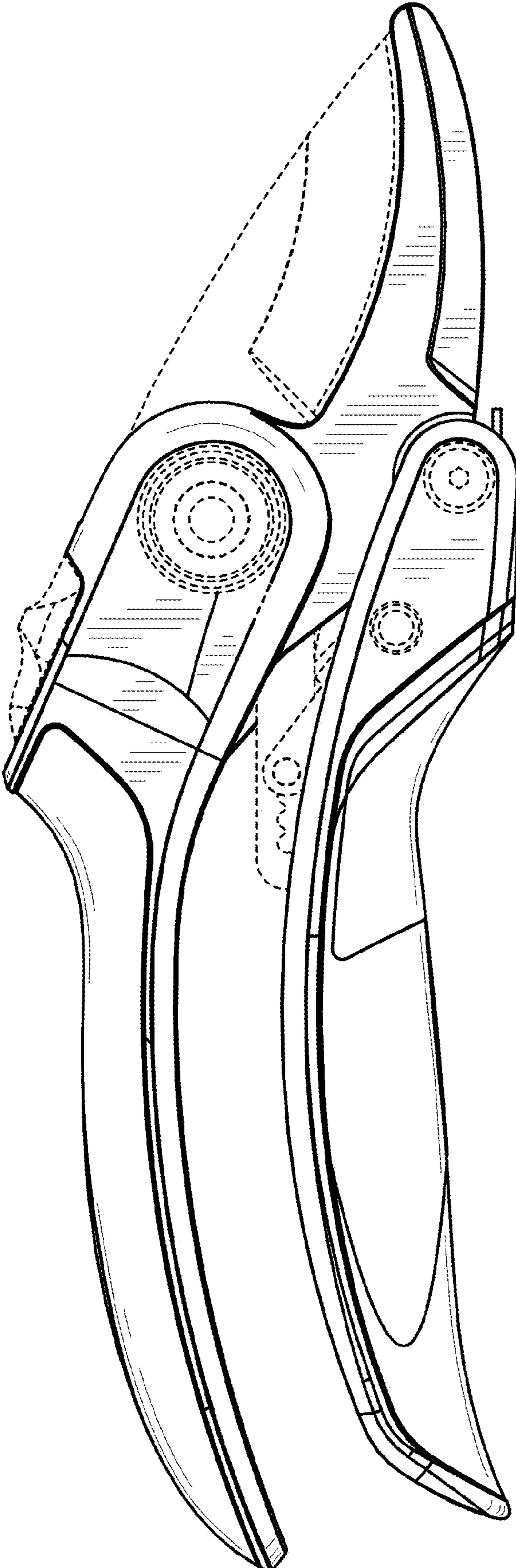

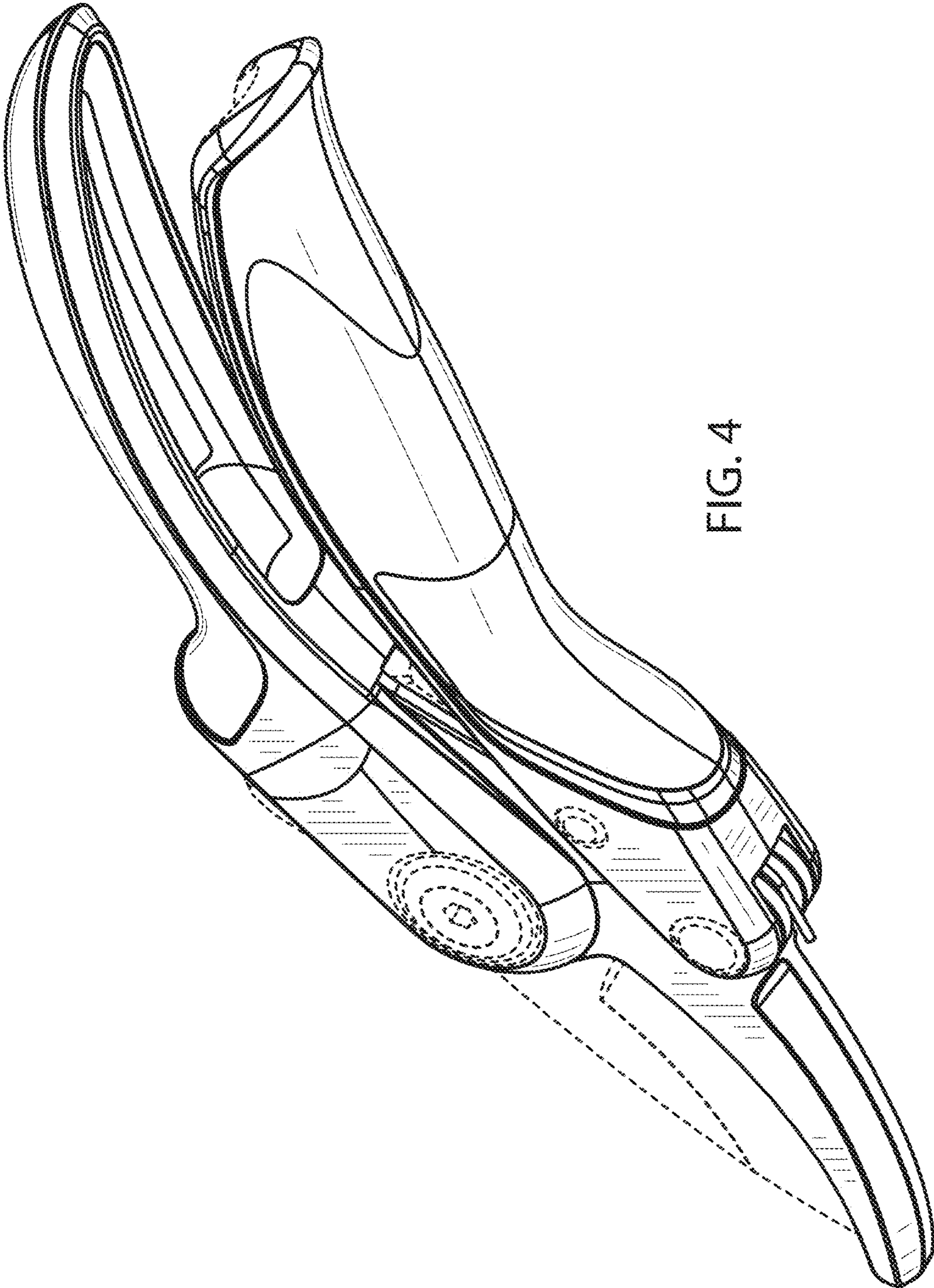

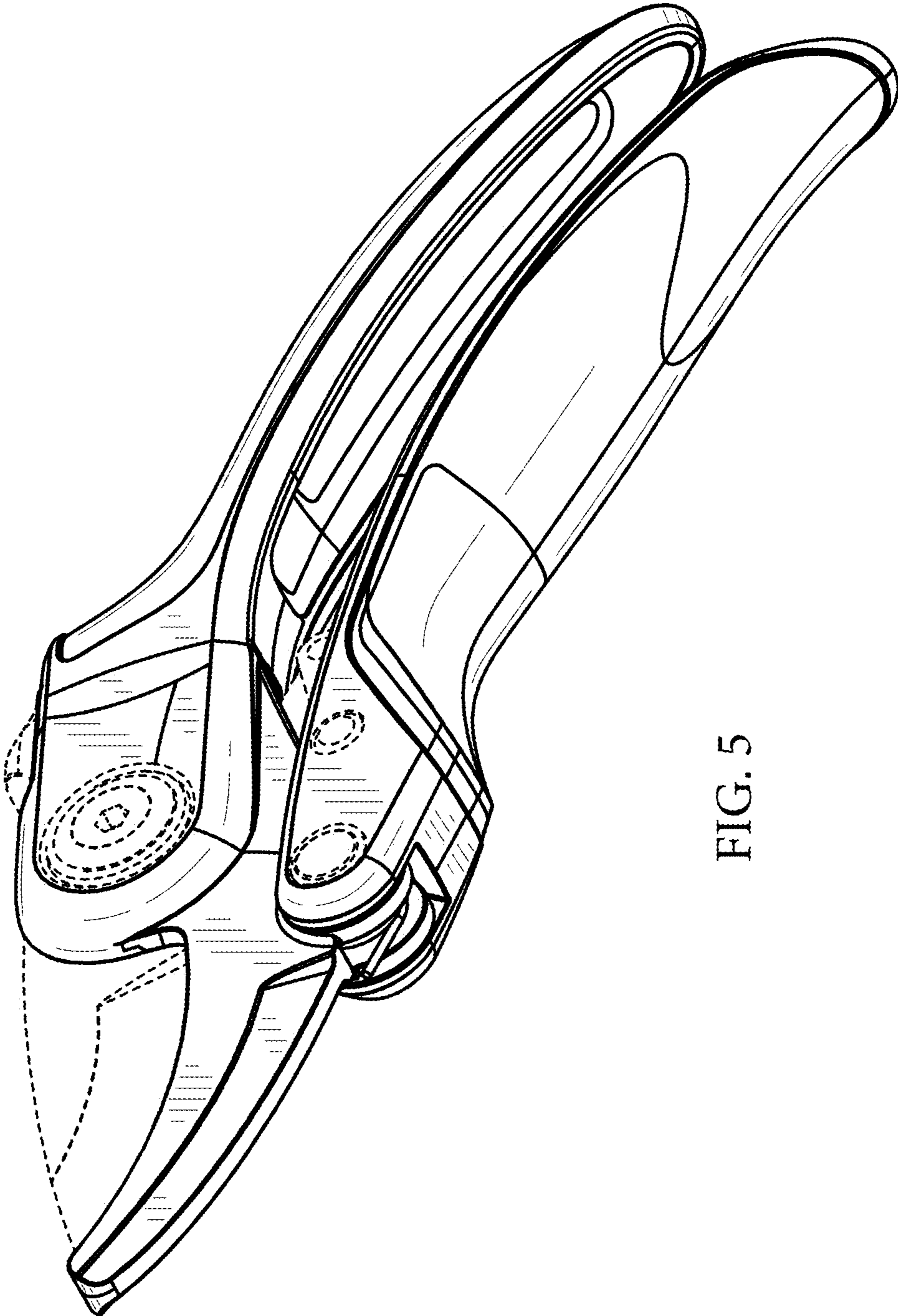

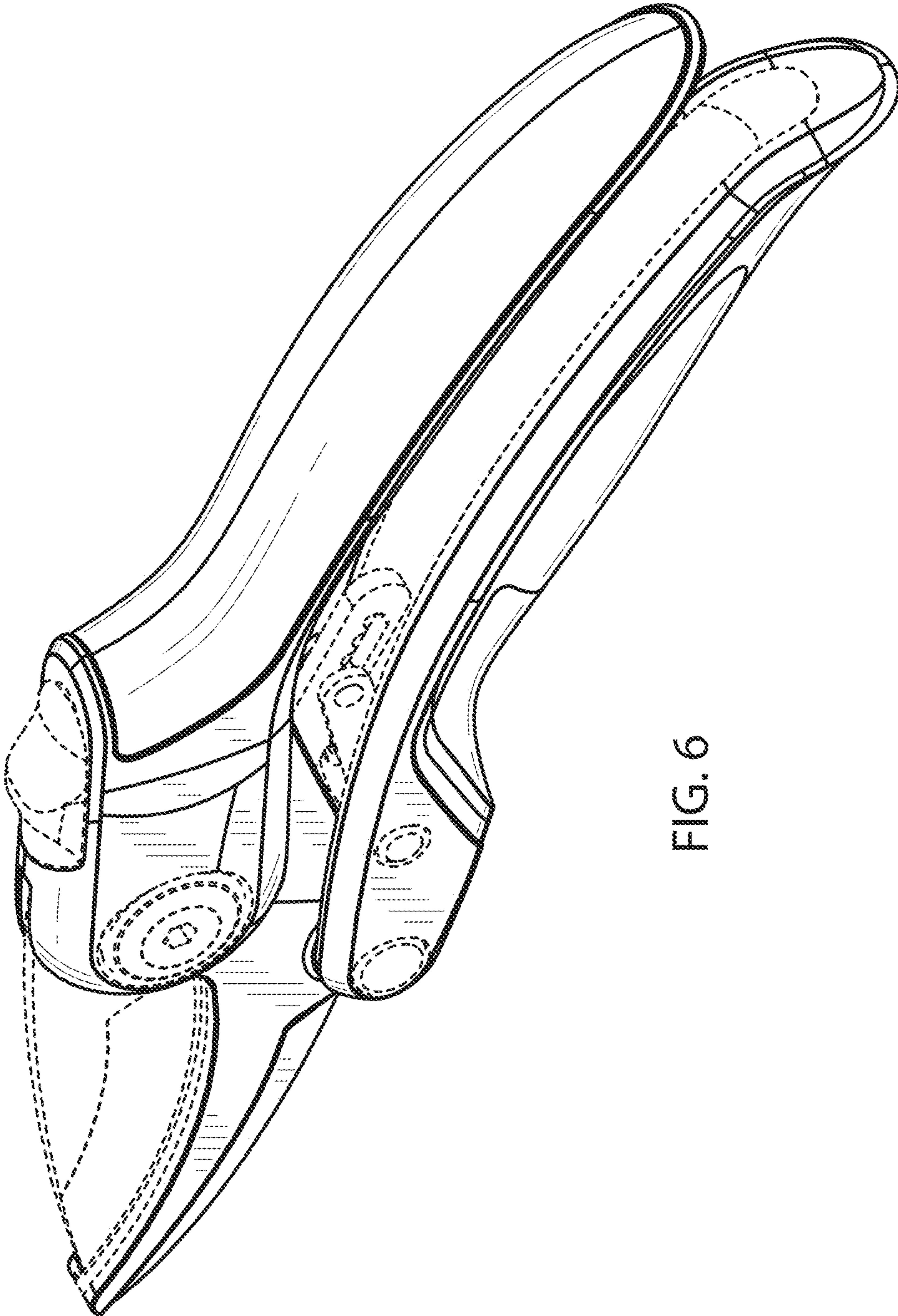

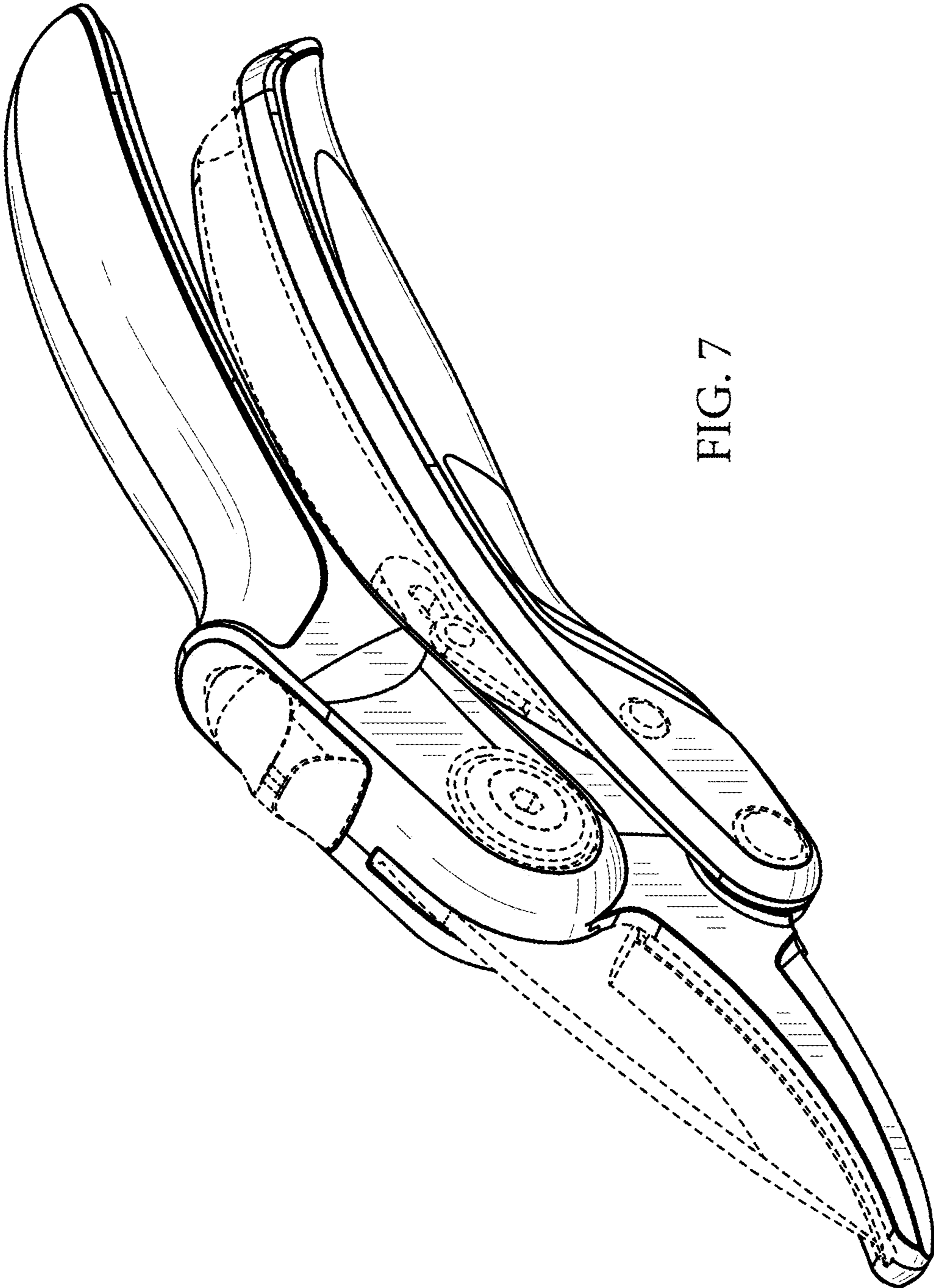

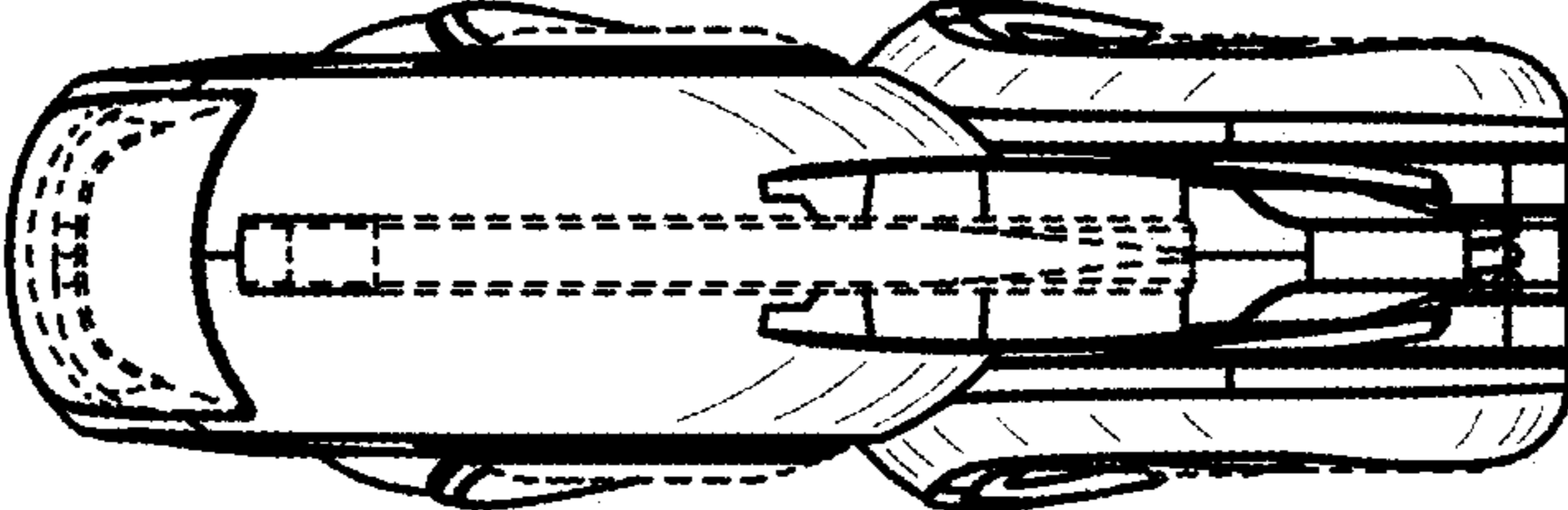

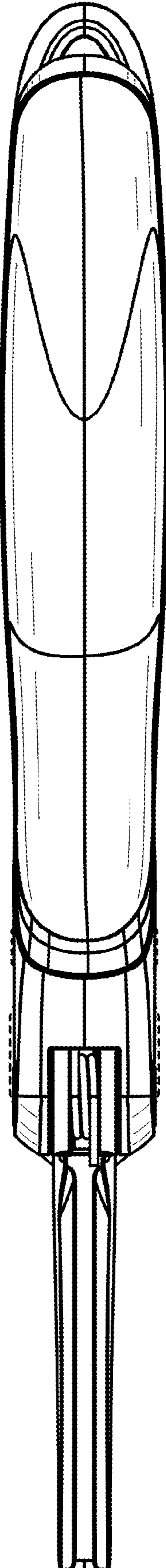

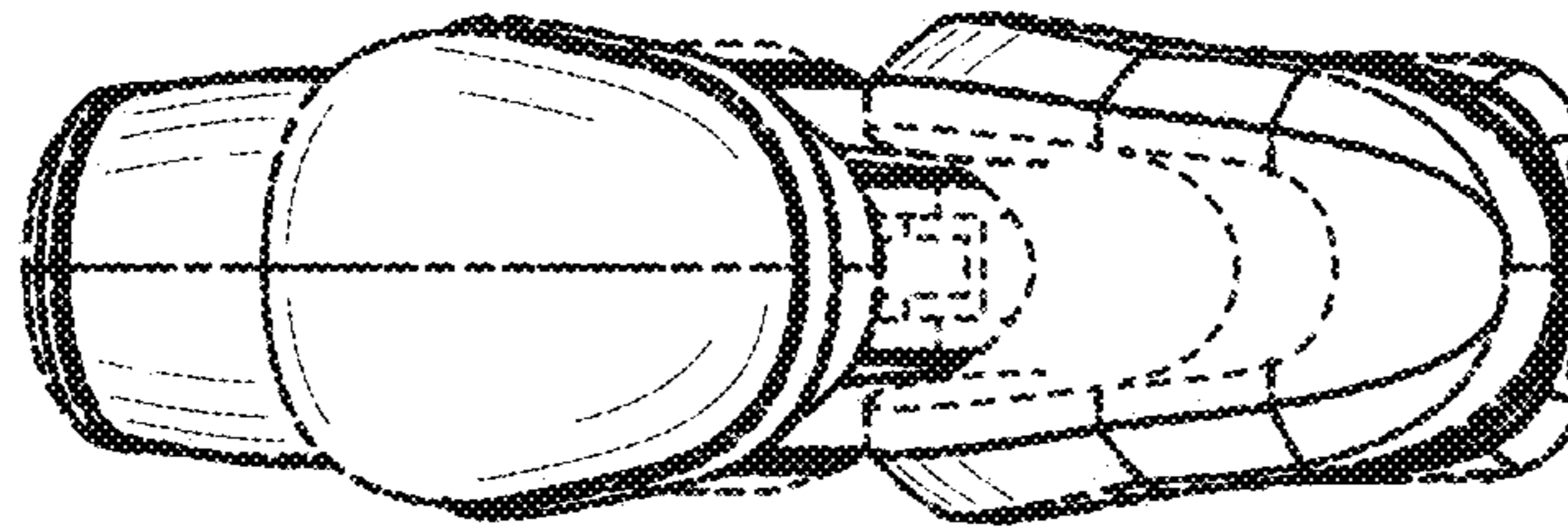
