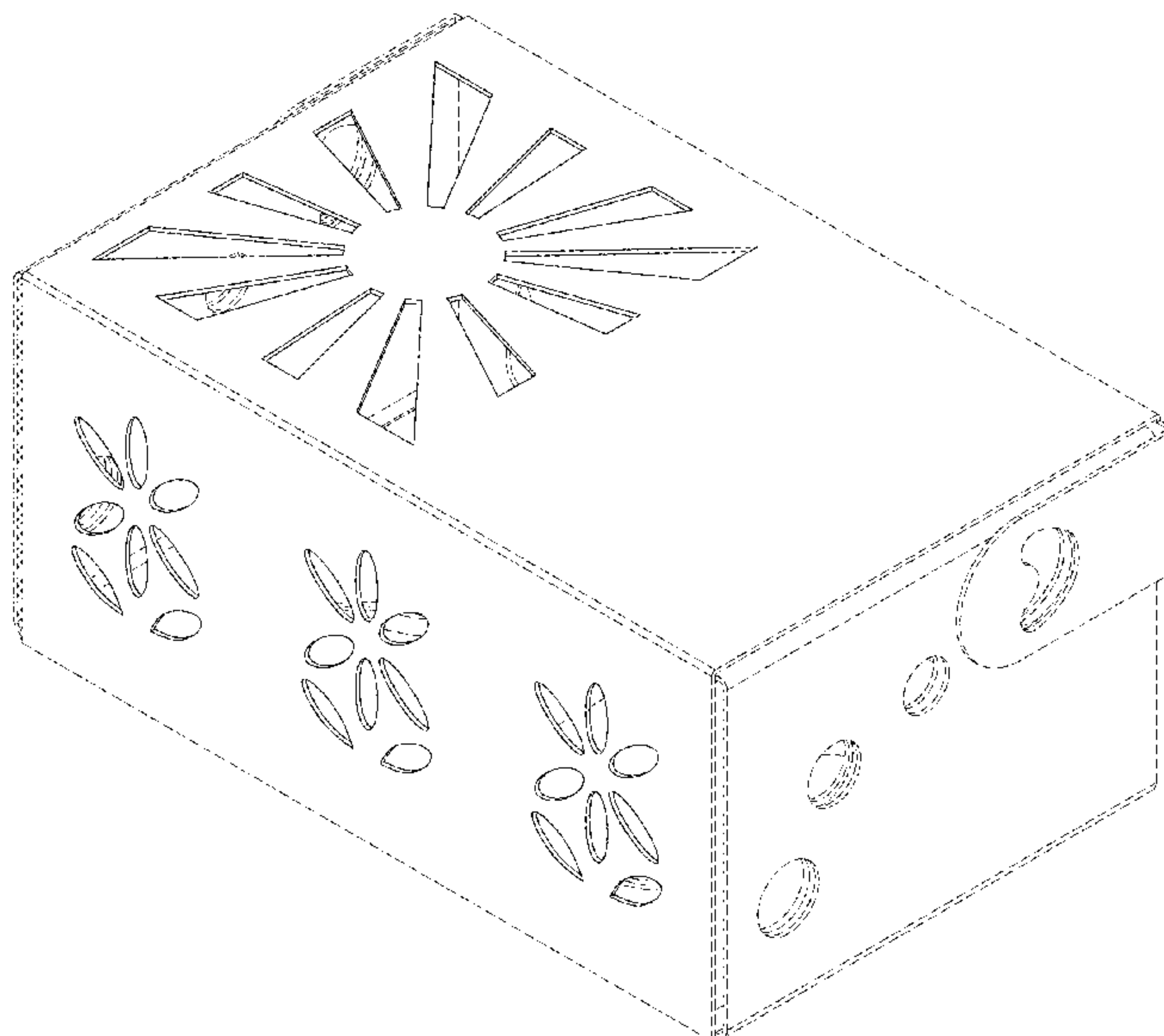
(57) **CLAIM**

The ornamental design for a produce box, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a produce box, showing the new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right elevation view thereof;  
FIG. 5 is a left elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a front perspective view thereof.  
The broken lines in the figures illustrate unclaimed portions of the produce box.

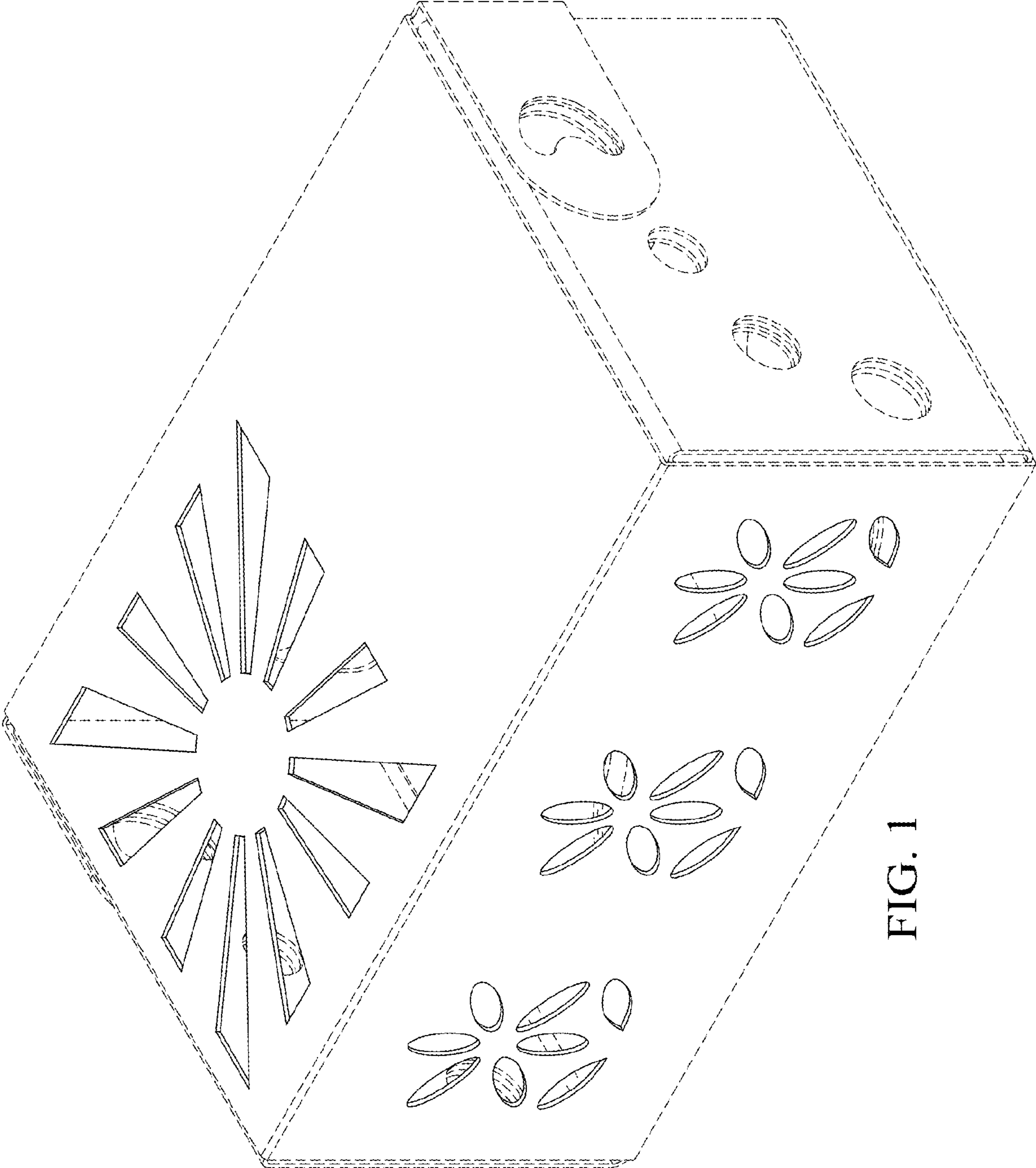

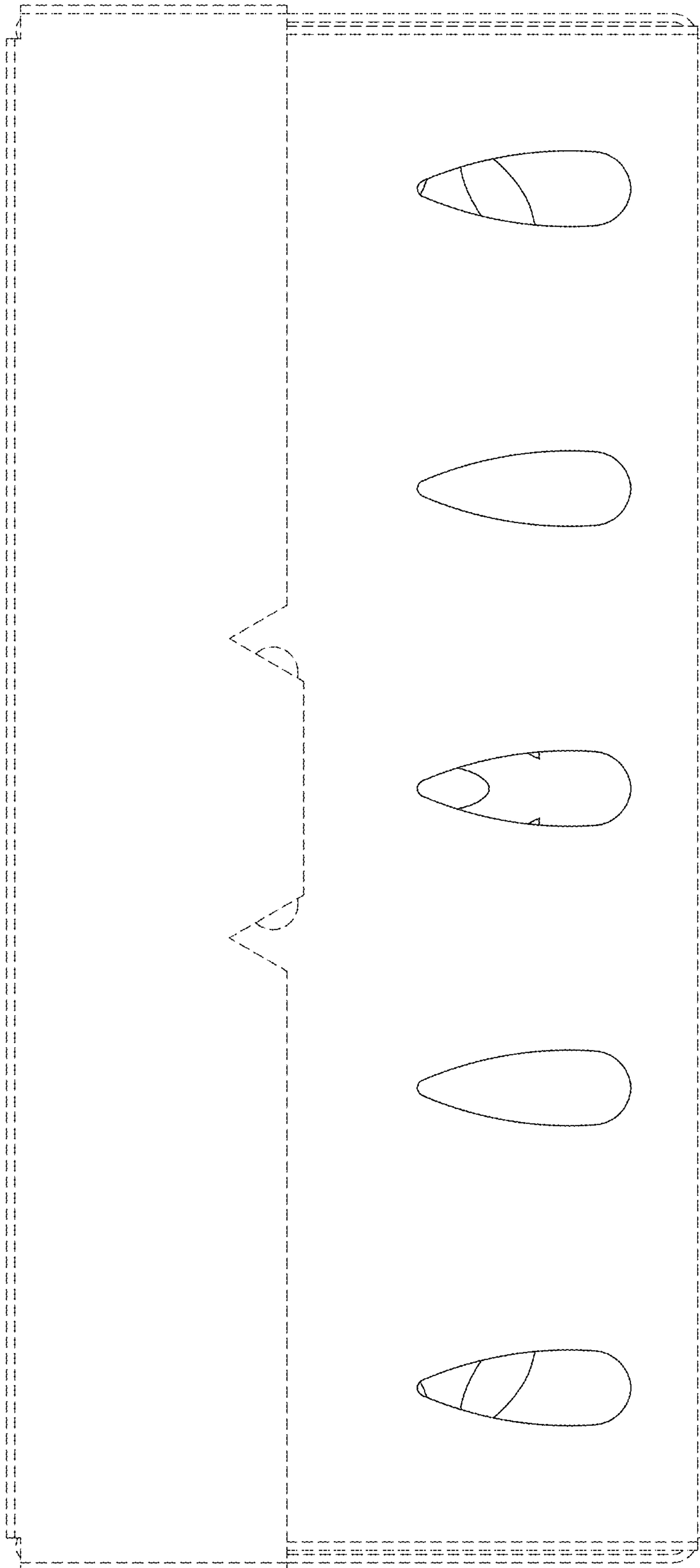

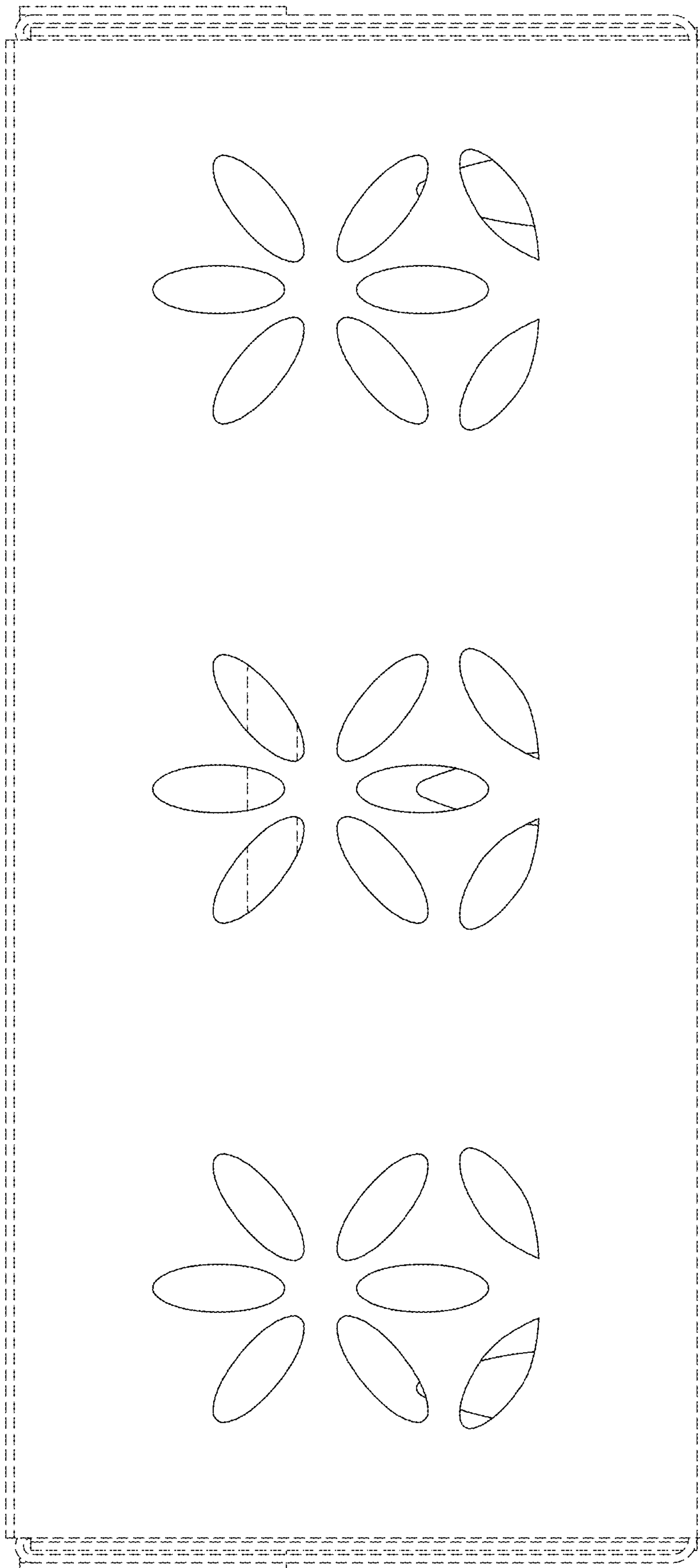

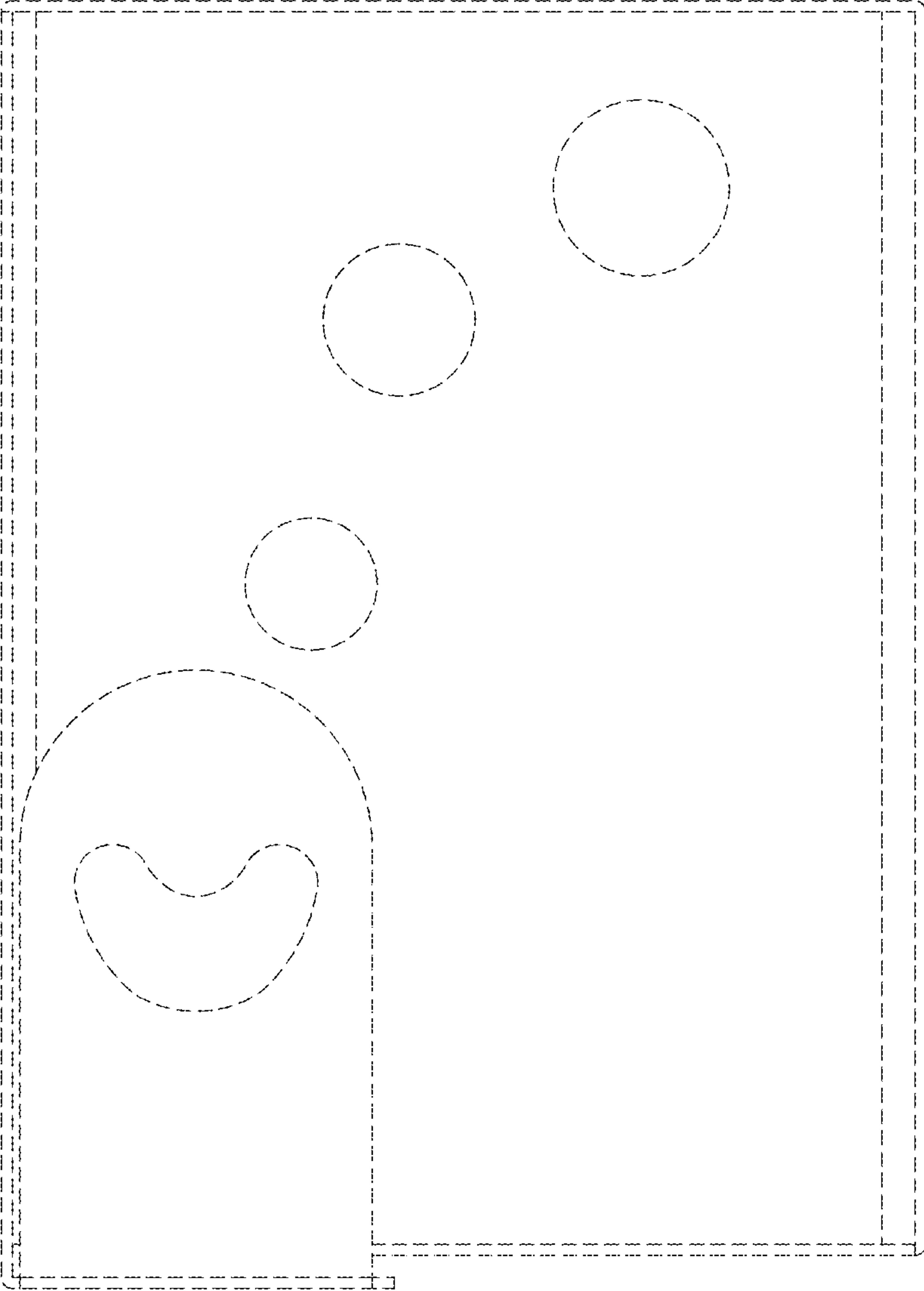

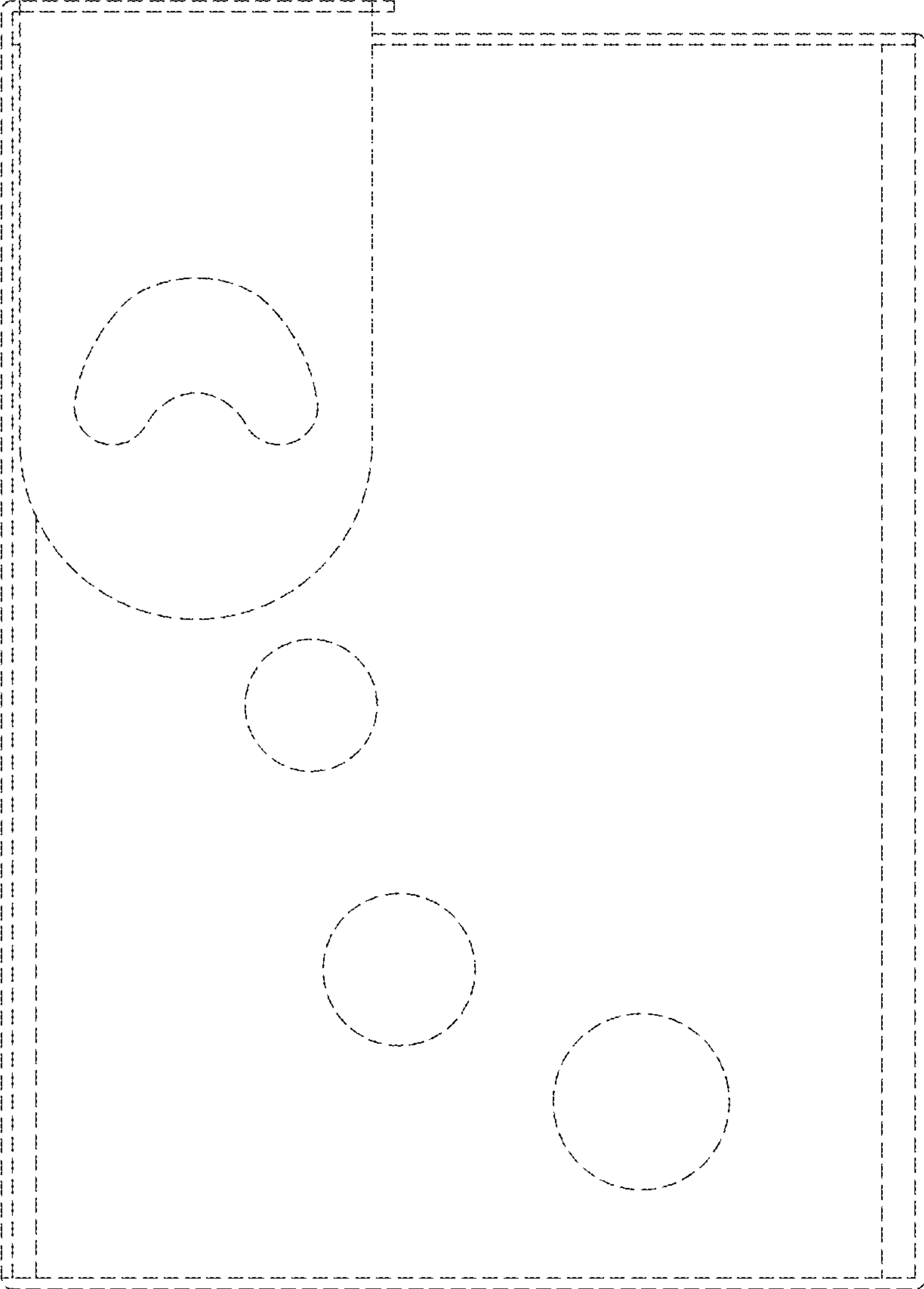

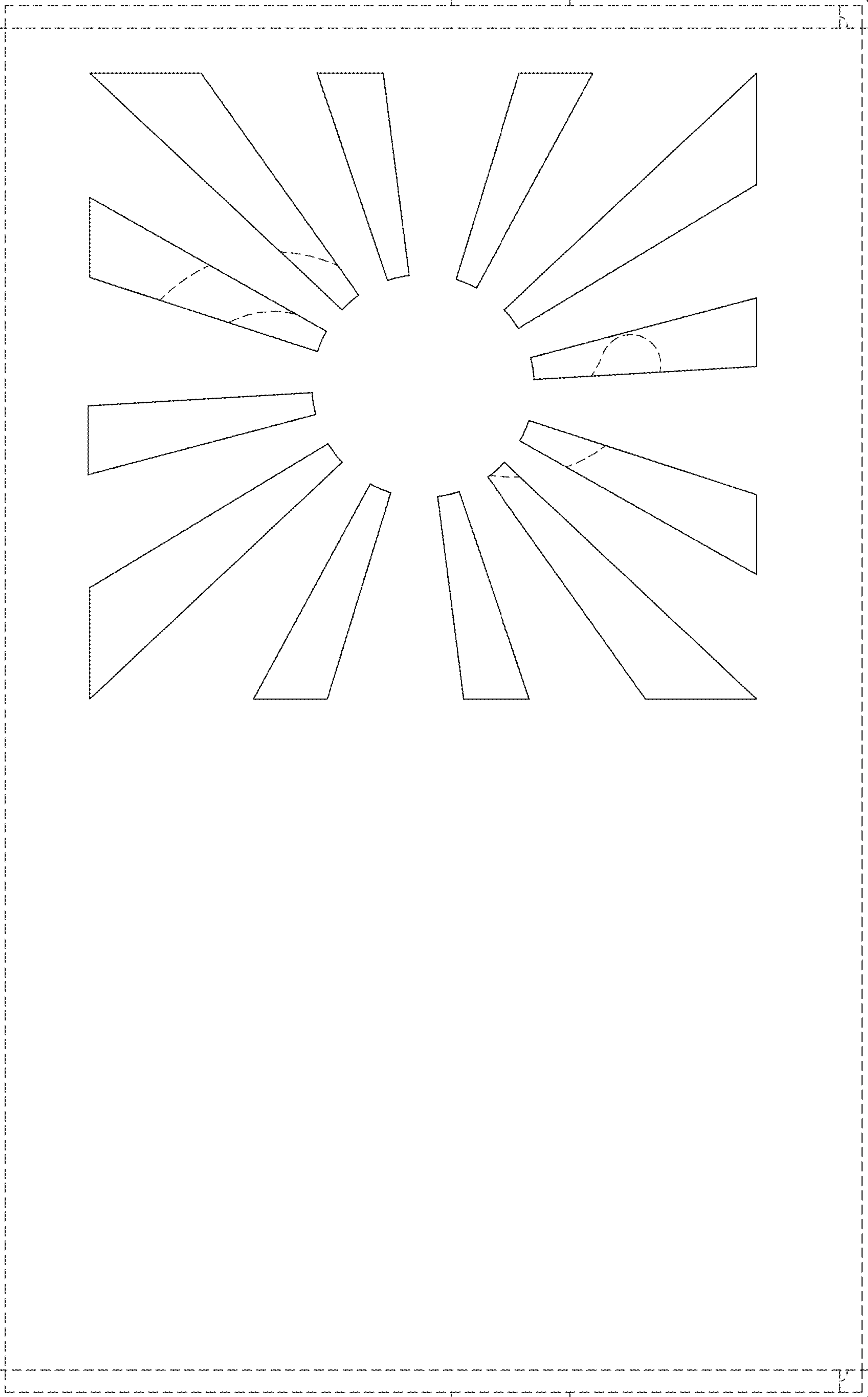

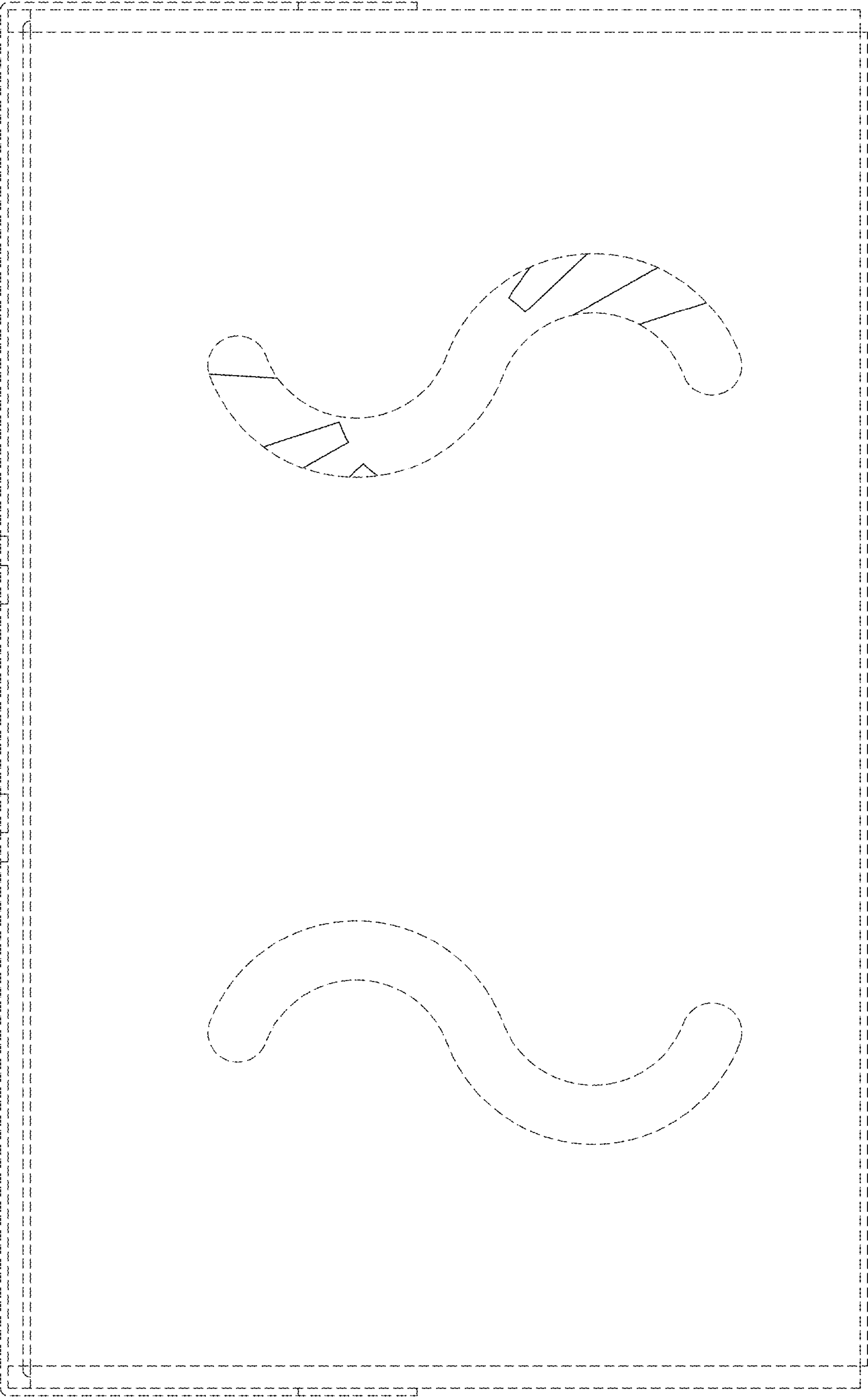

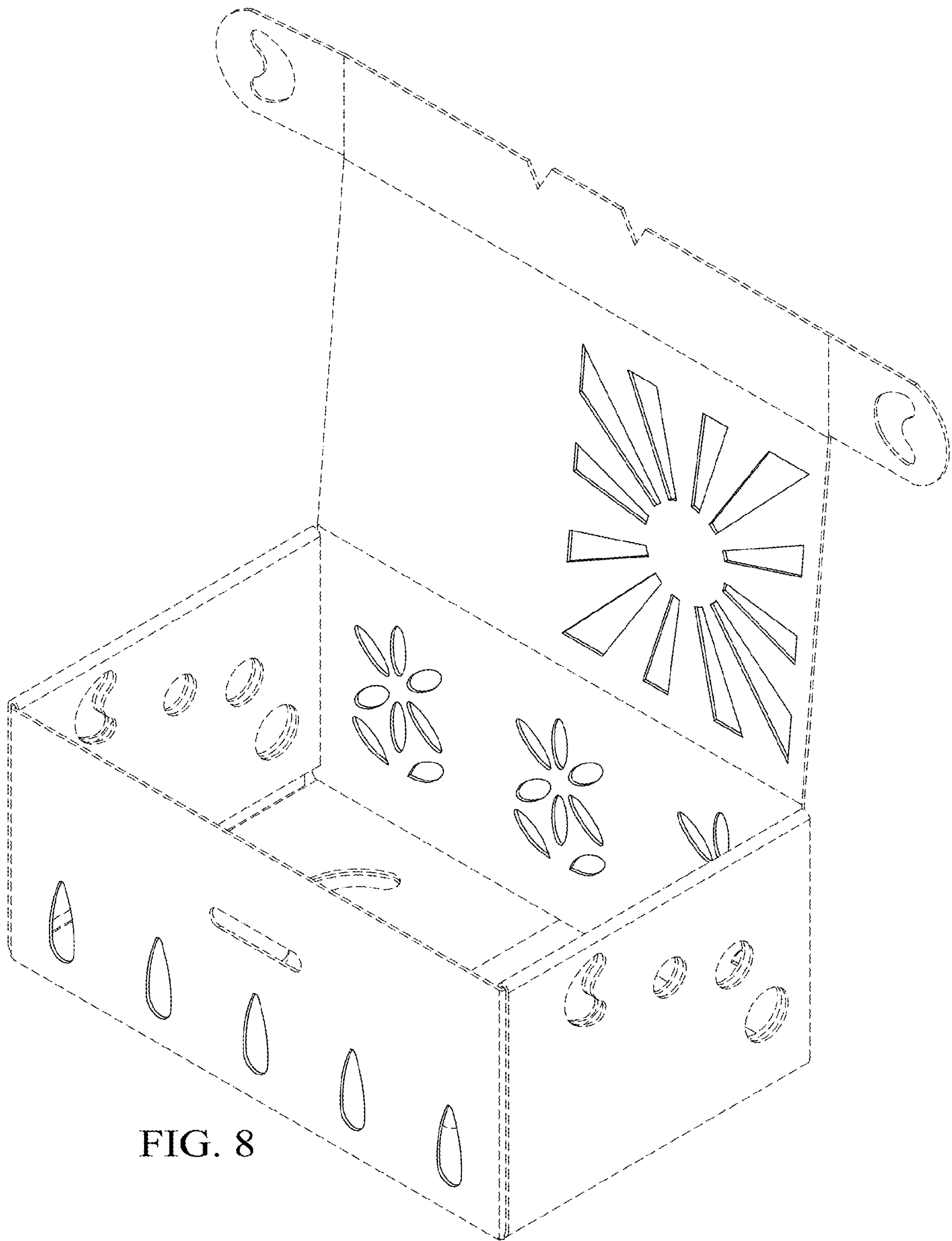
