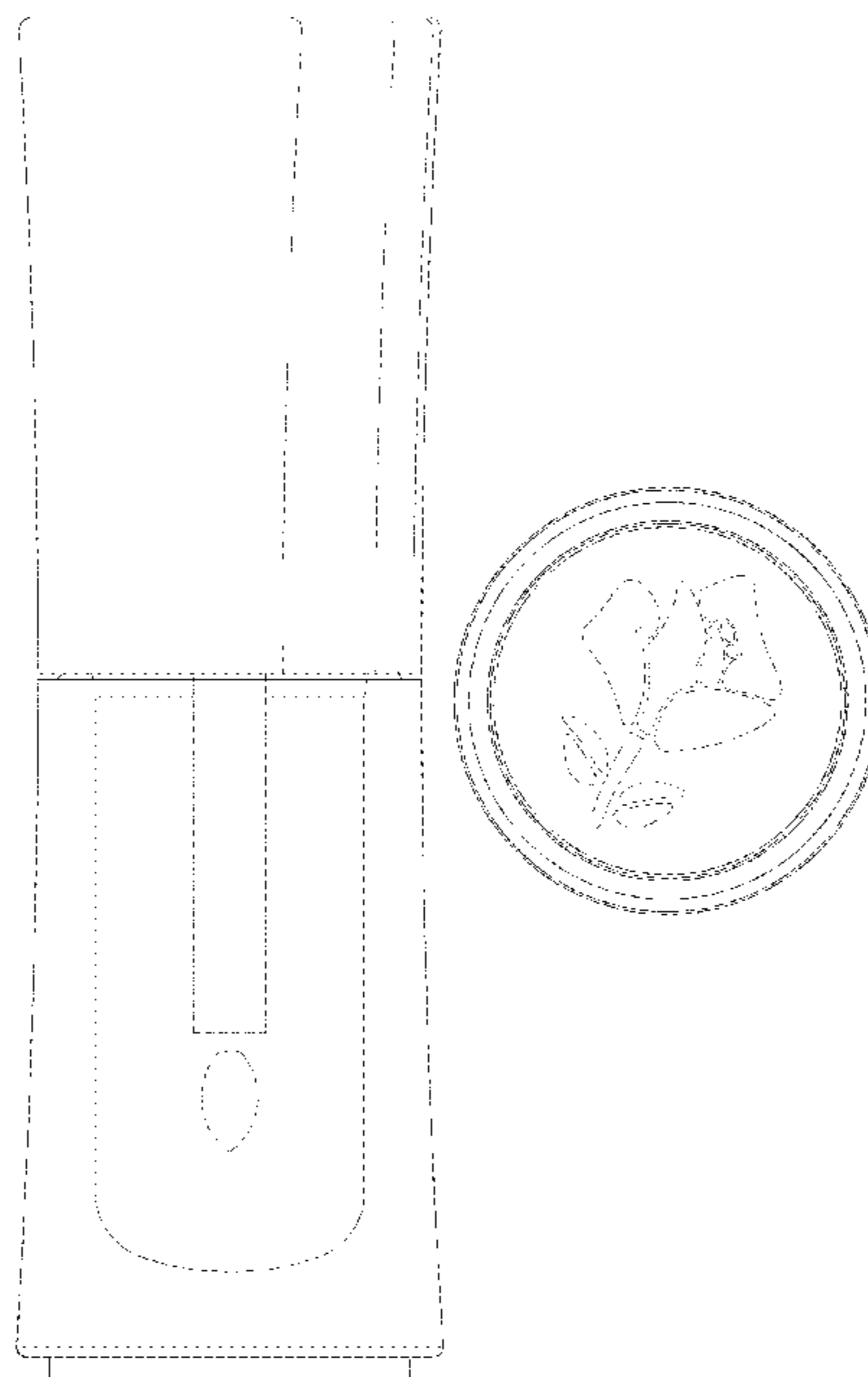
(57) **CLAIM**

The ornamental design for a bottle for cosmetics, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a bottle for cosmetics. FIG. 2 is a rear elevation view of the bottle for cosmetics of FIG. 1. FIG. 3 is a right side elevation view of the bottle for cosmetics of FIG. 1. FIG. 4 is a left side elevation view of the bottle for cosmetics of FIG. 1. FIG. 5 is a bottom plan view of the bottle for cosmetics of FIG. 1. FIG. 6 is a top plan view of the bottle for cosmetics of FIG. 1; and, FIG. 7 is a front perspective view from above of the bottle for cosmetics of FIG. 1. The broken lines in the drawings illustrate the portions of the bottle that form no part of the claimed design.

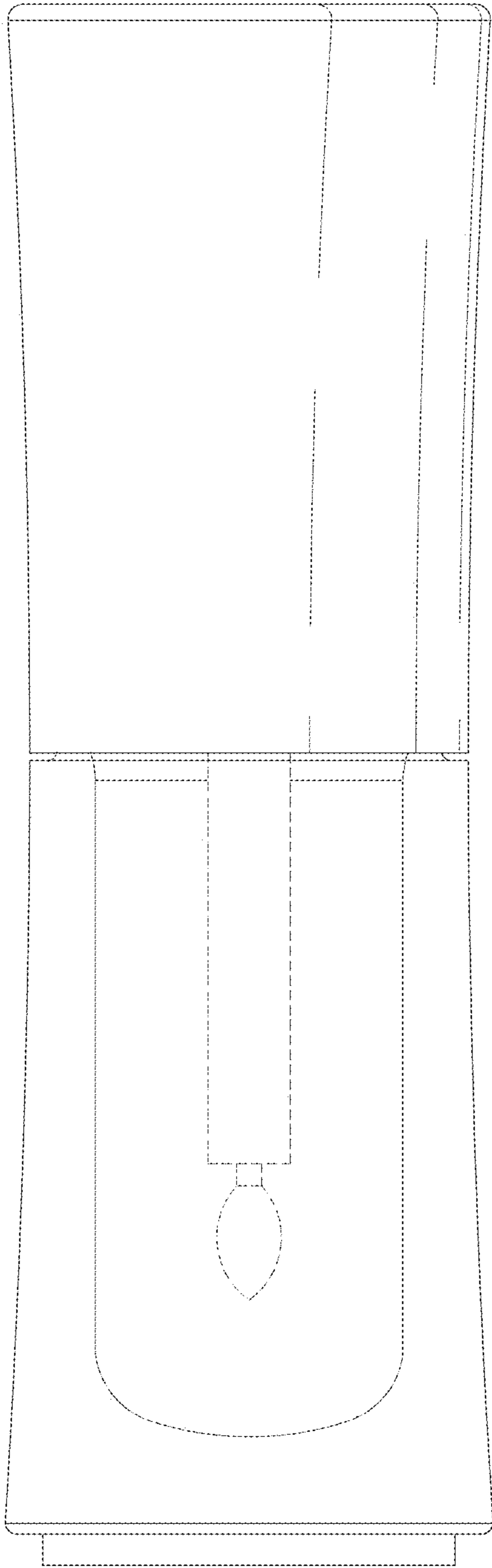

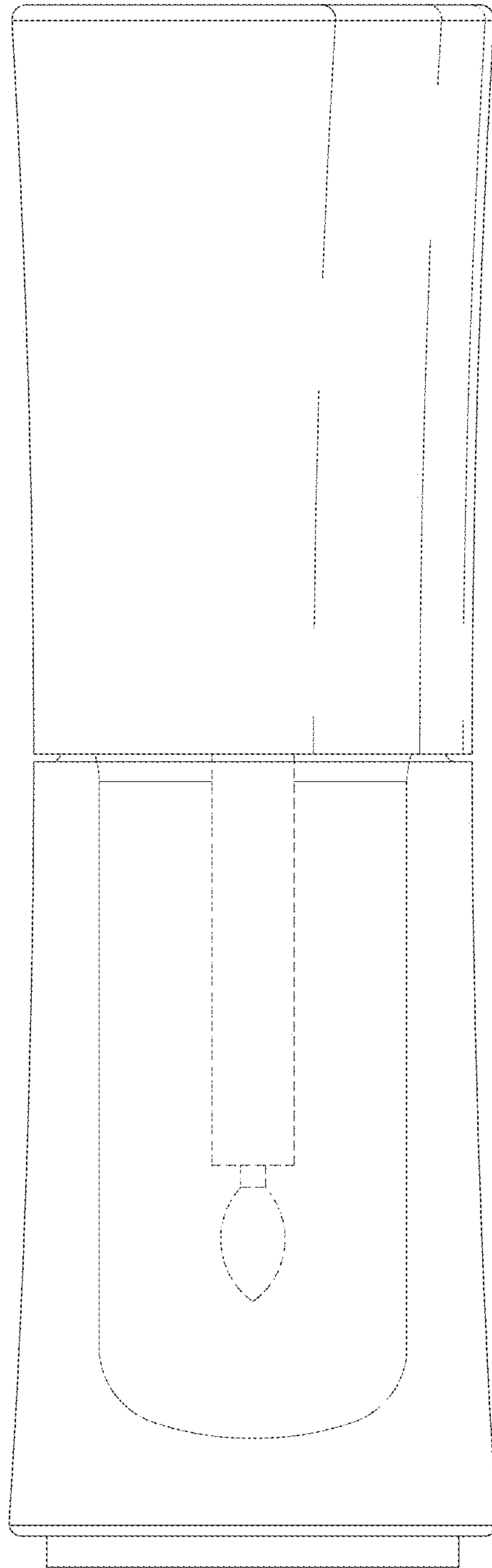

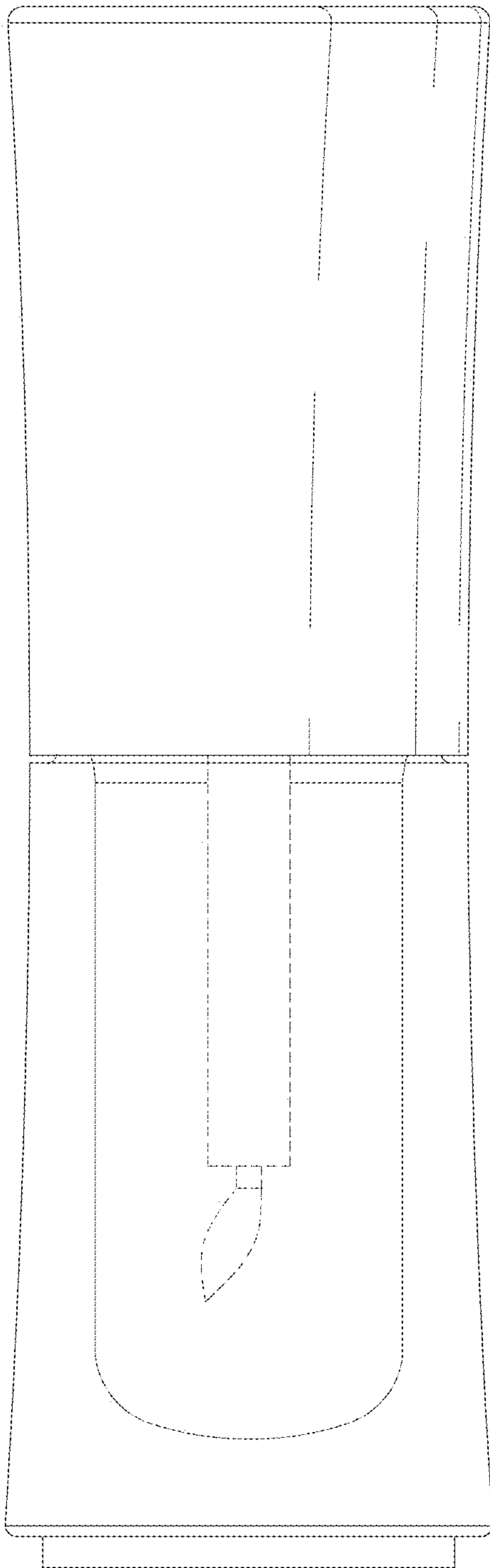

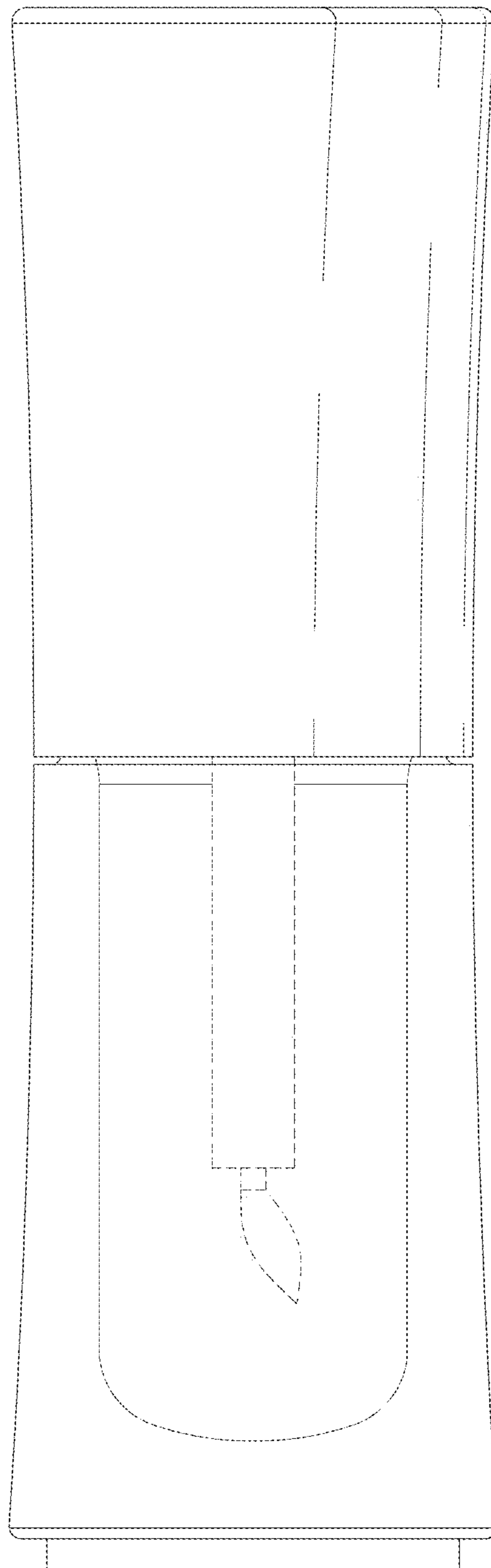

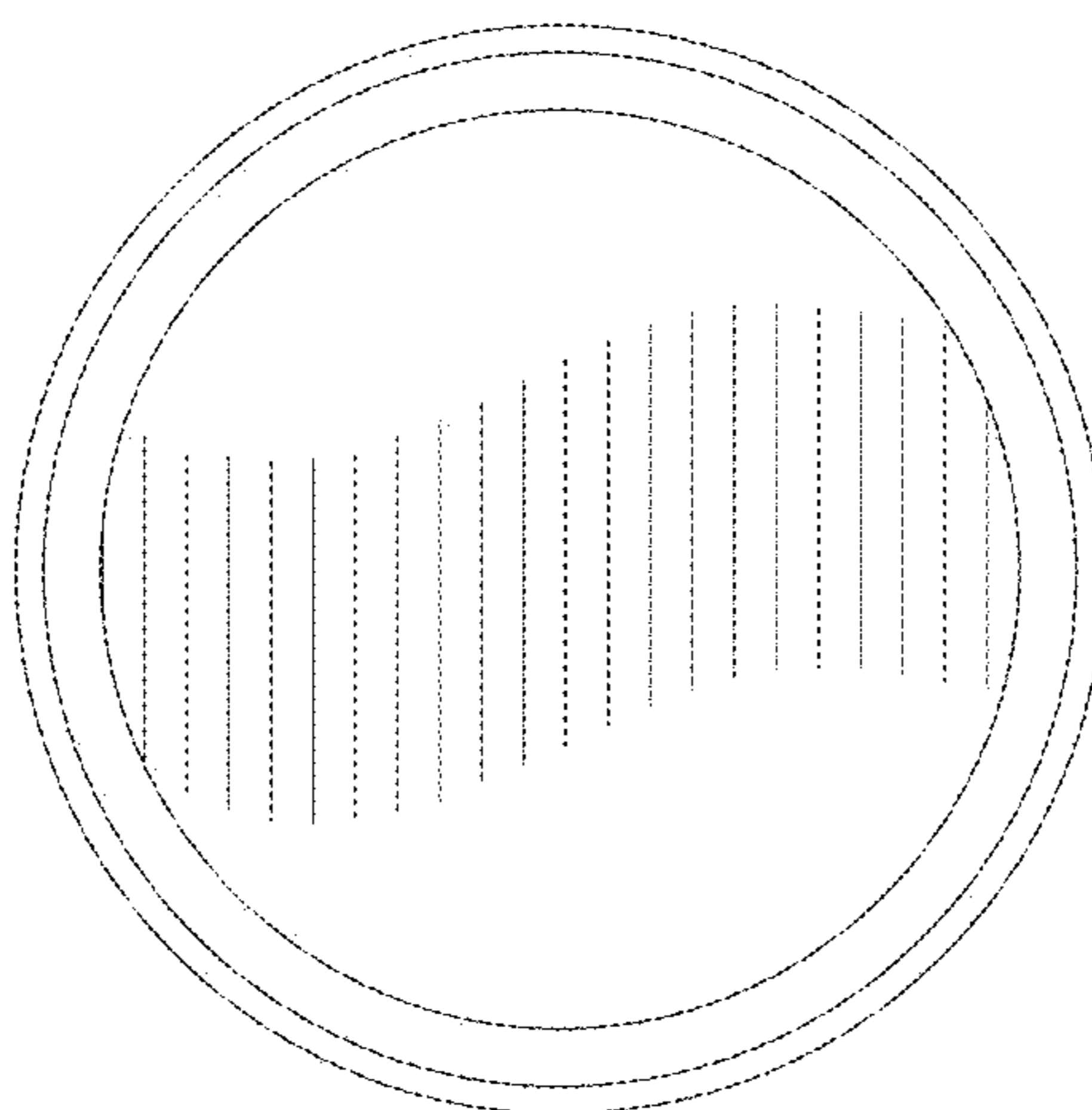

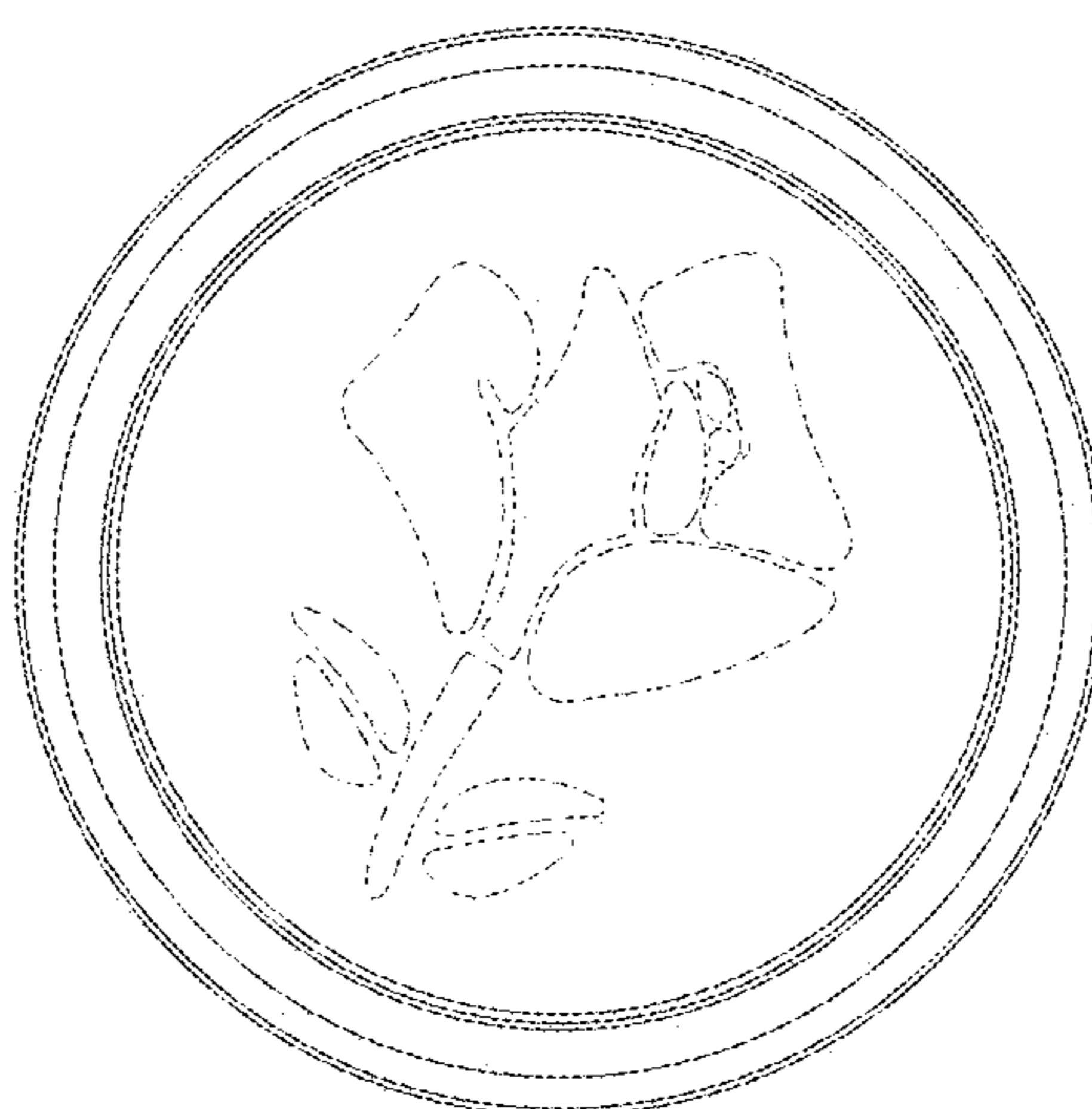

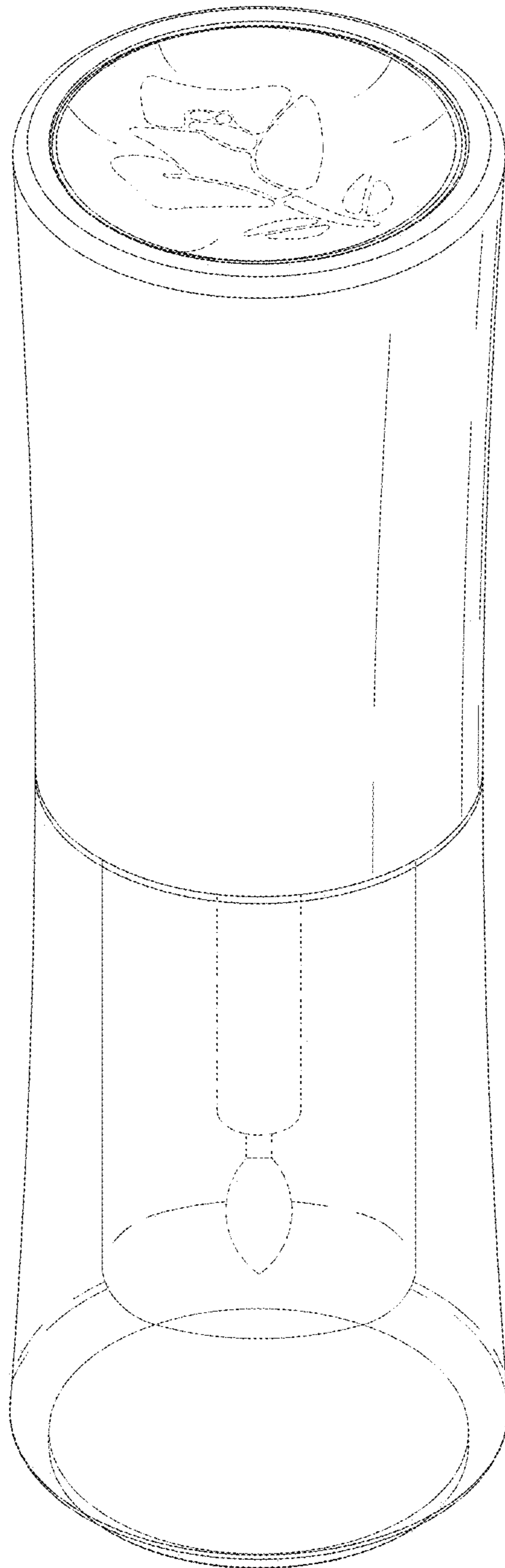
