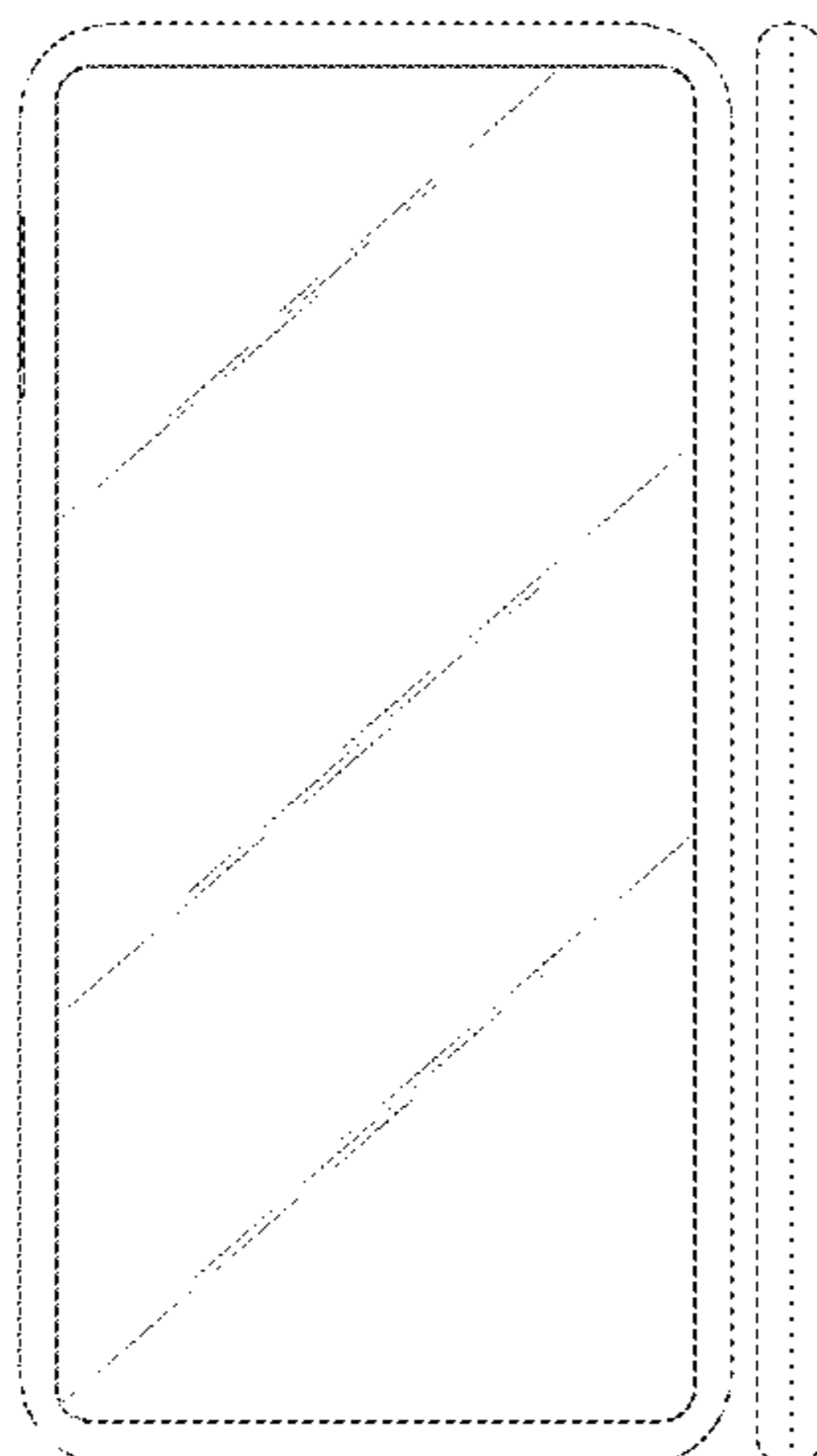


FIG. 36 is a front view of a sixth embodiment of a mobile phone;

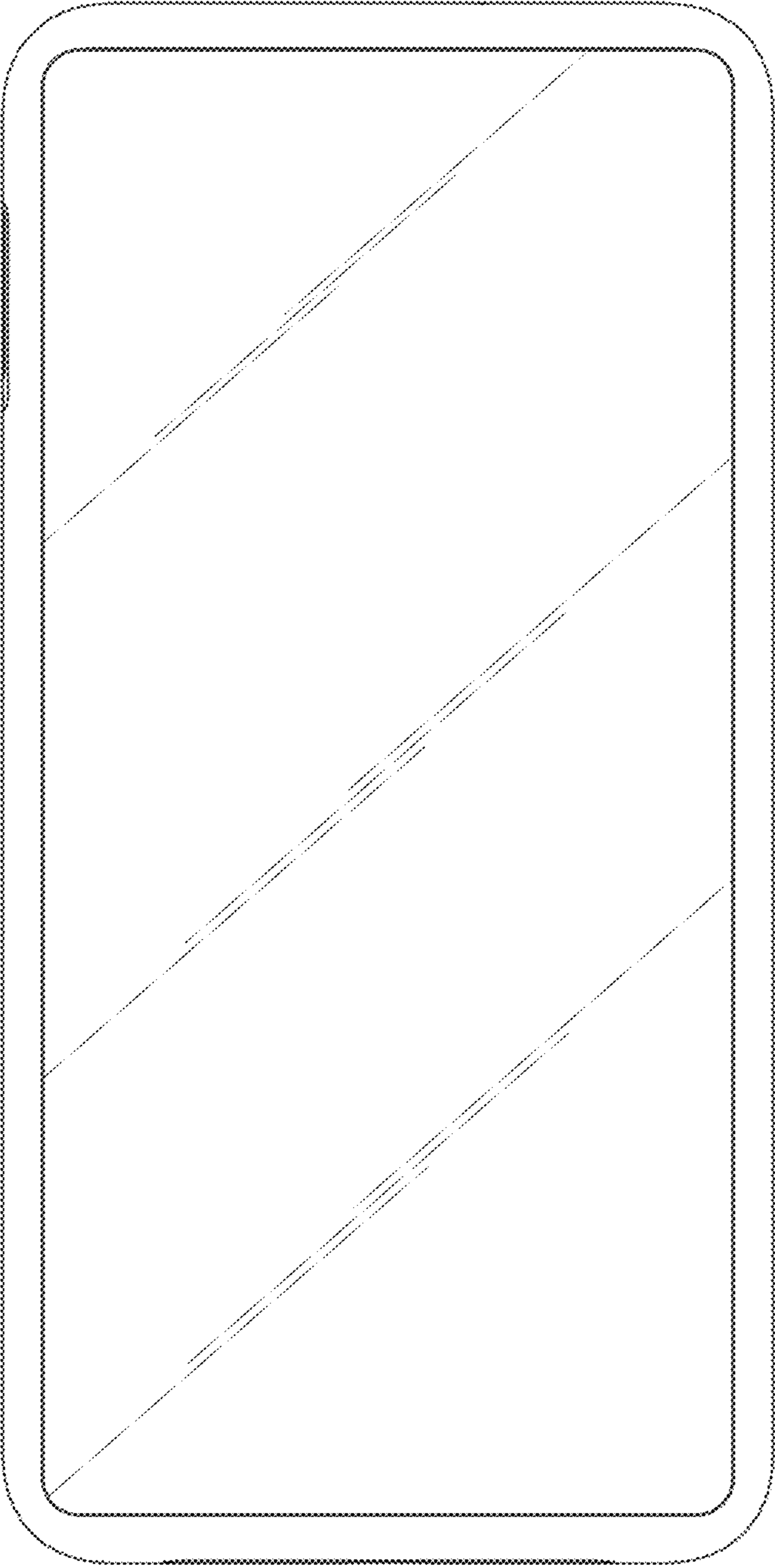

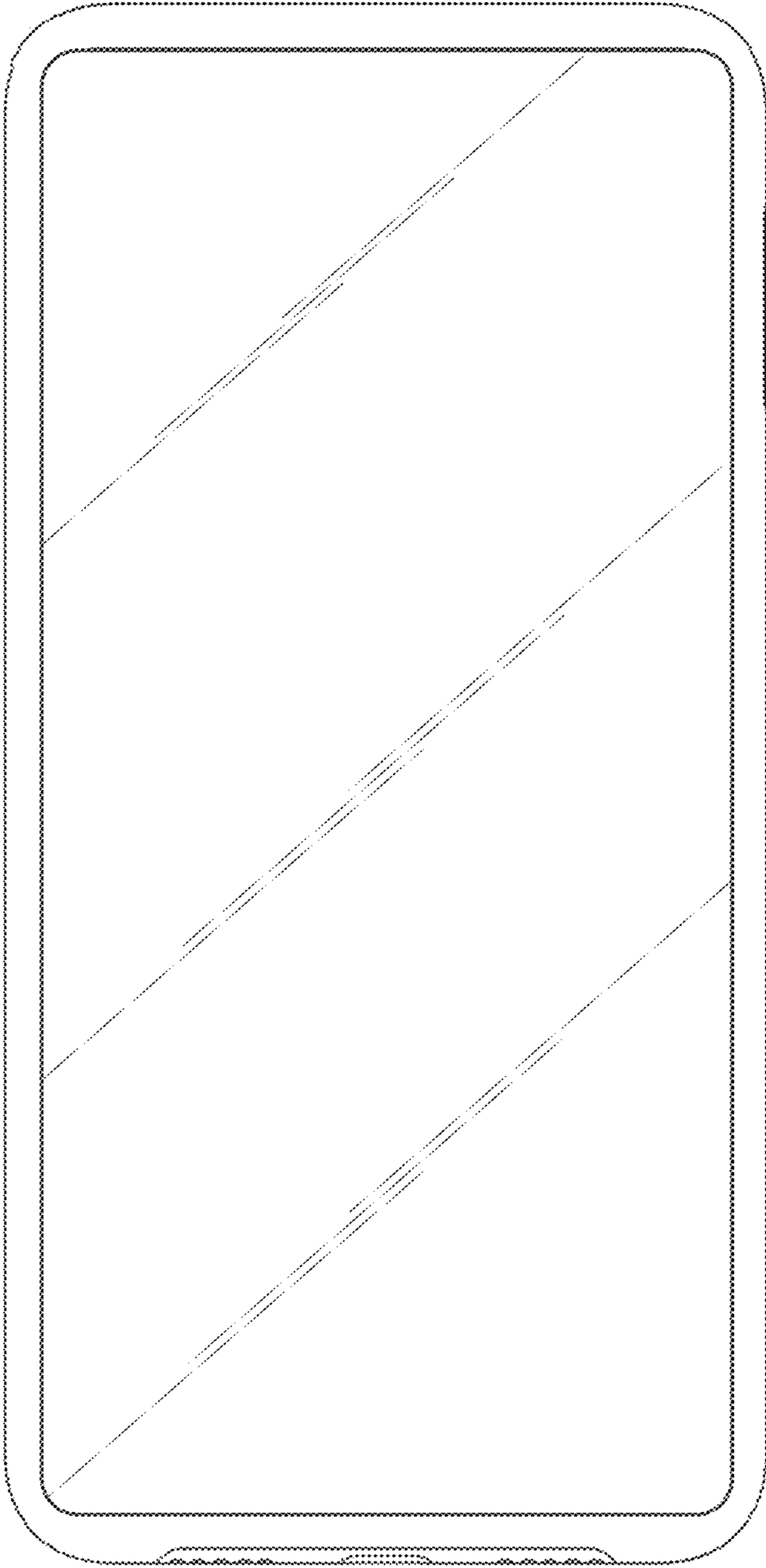

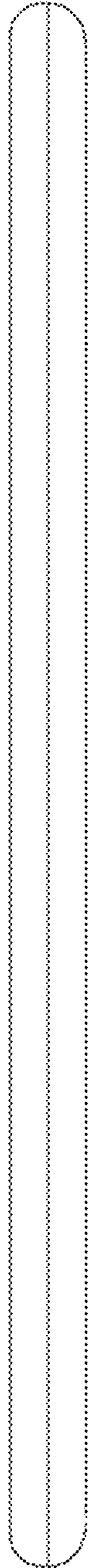

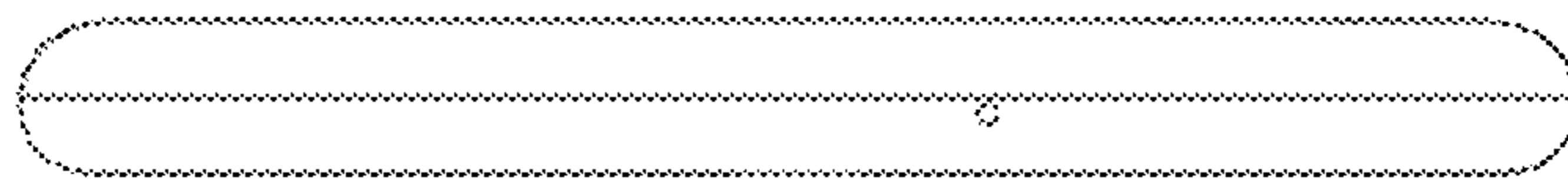

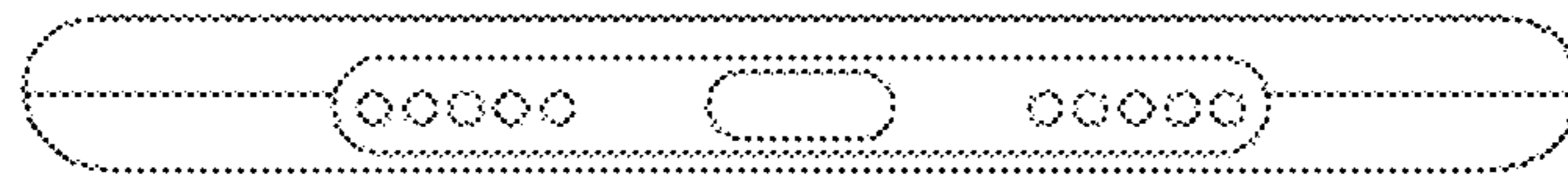

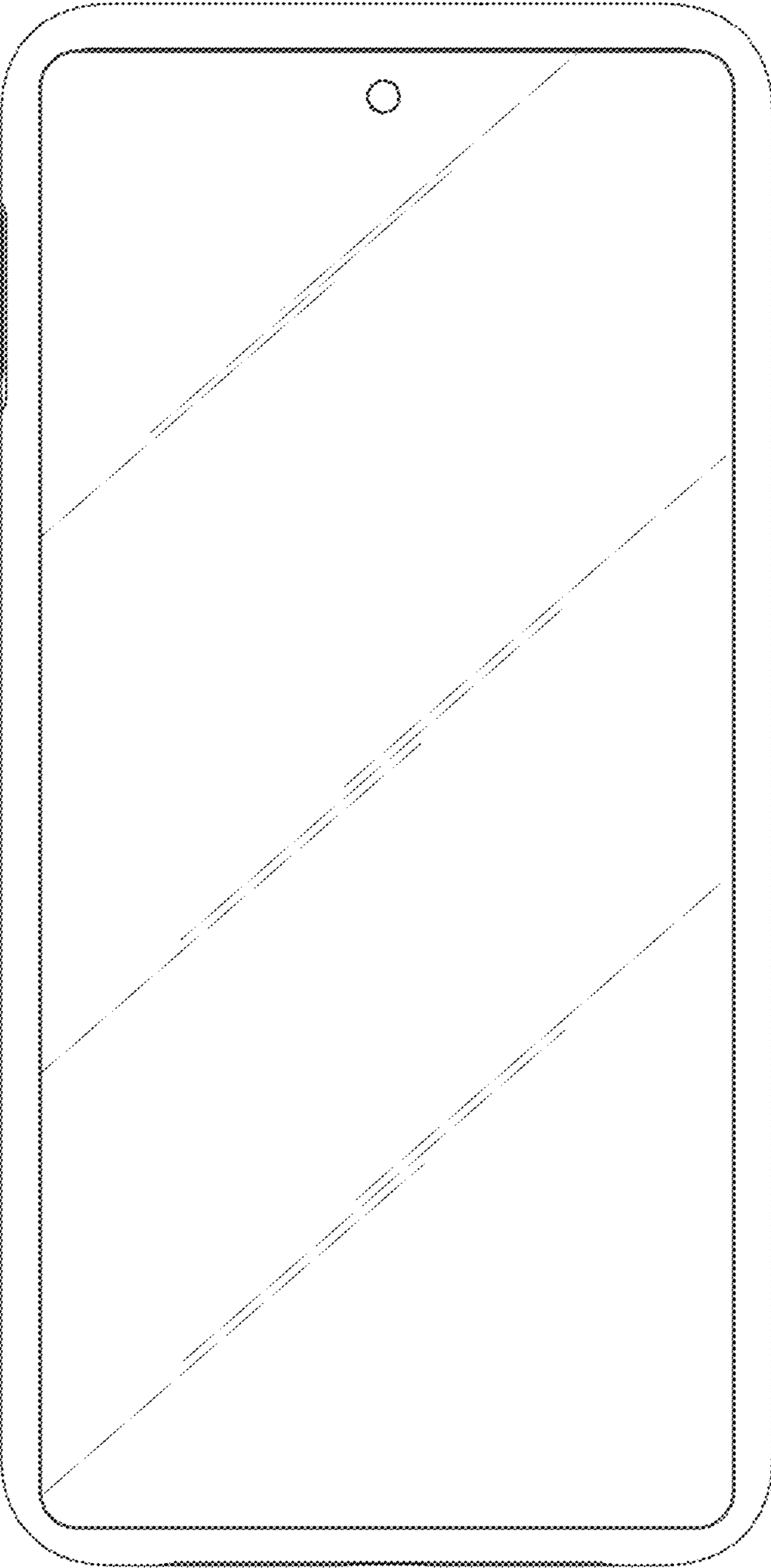

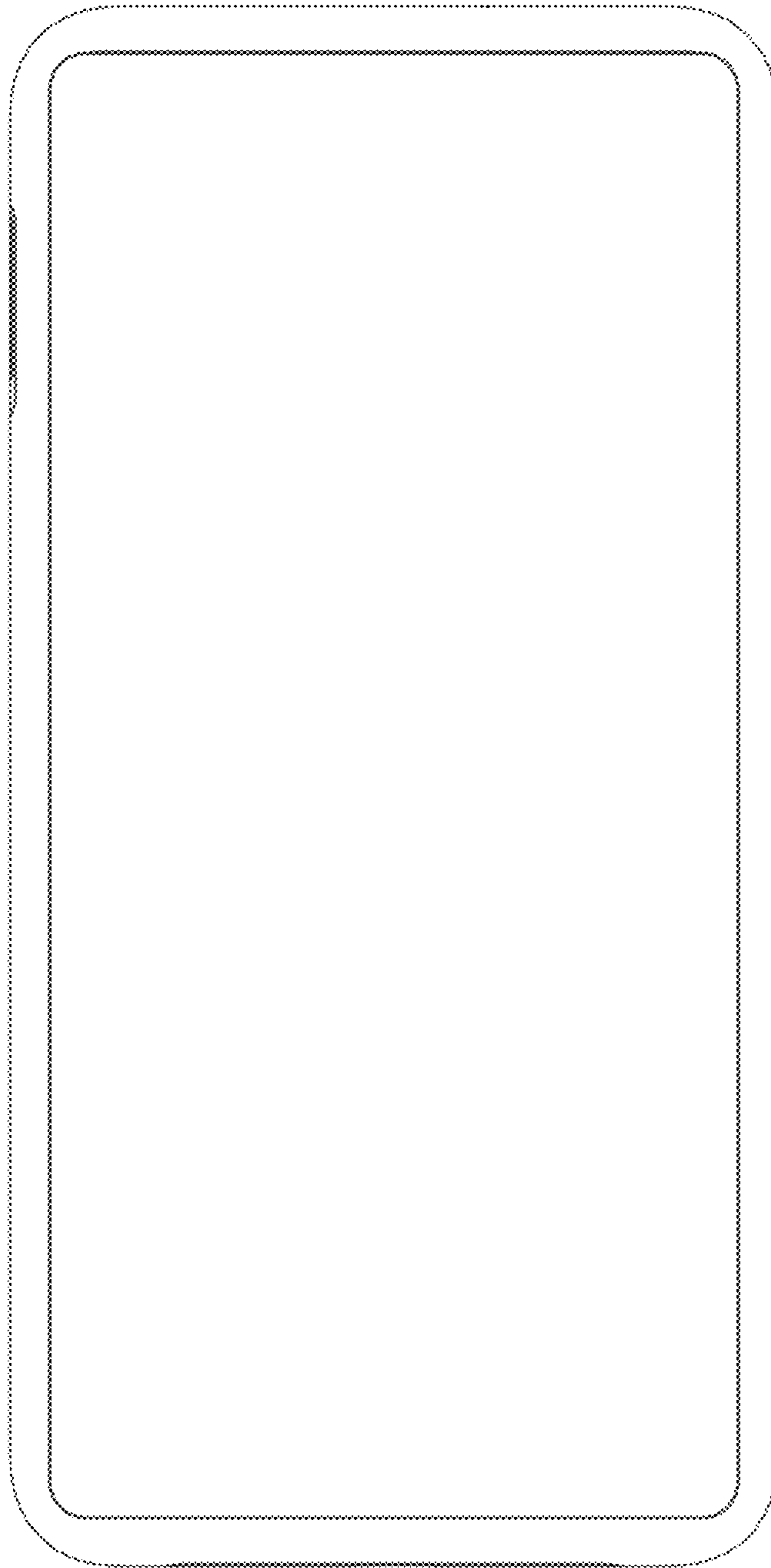

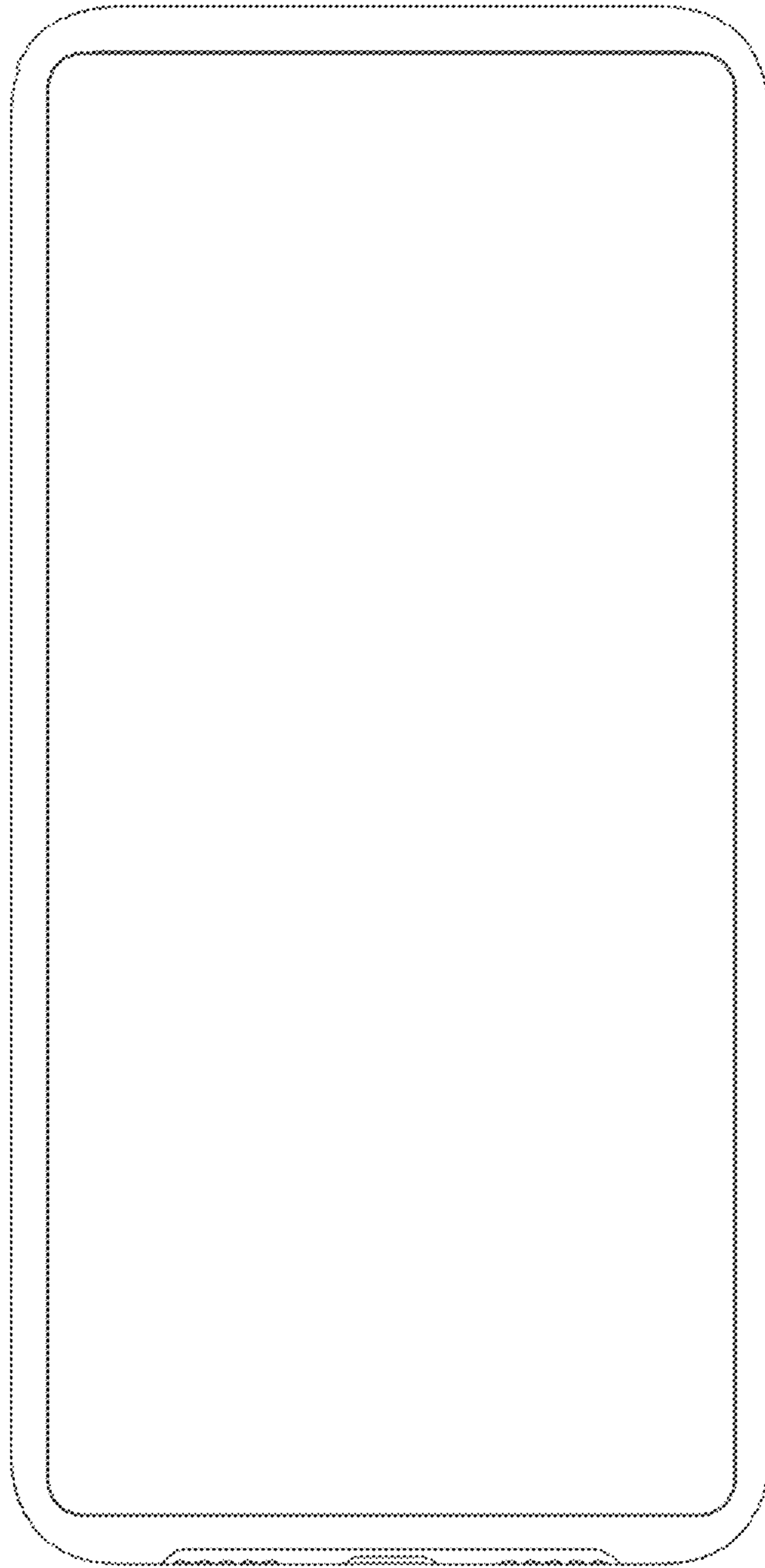

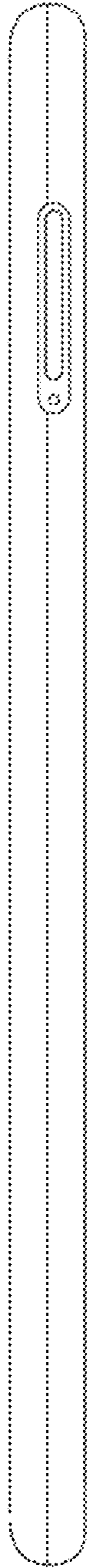

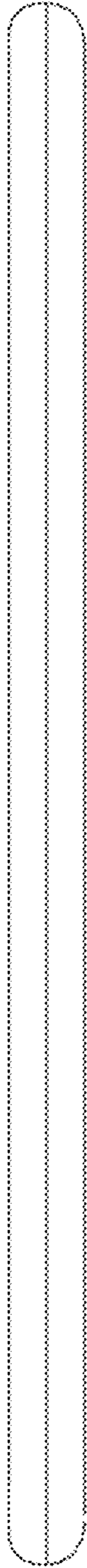

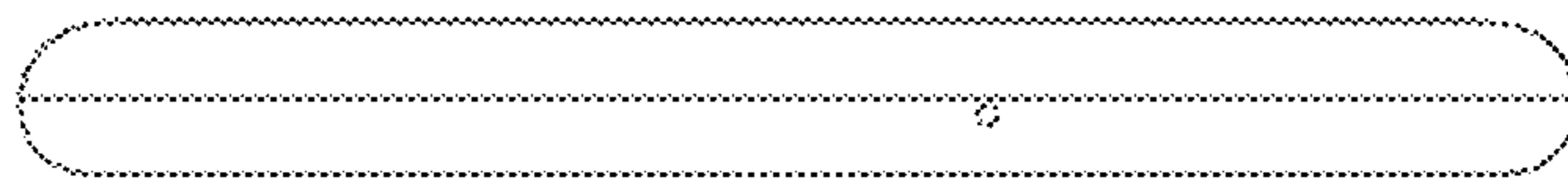

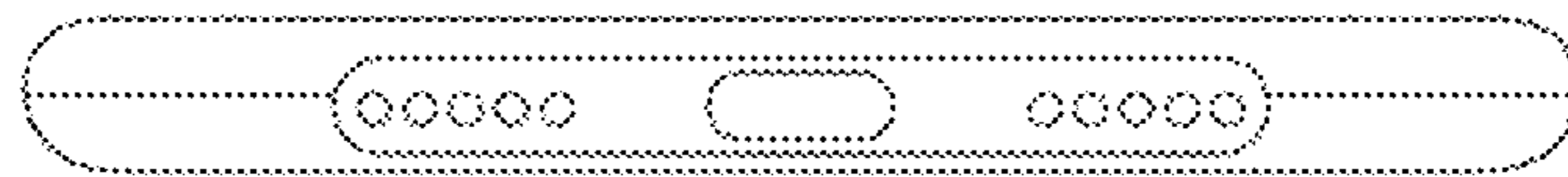

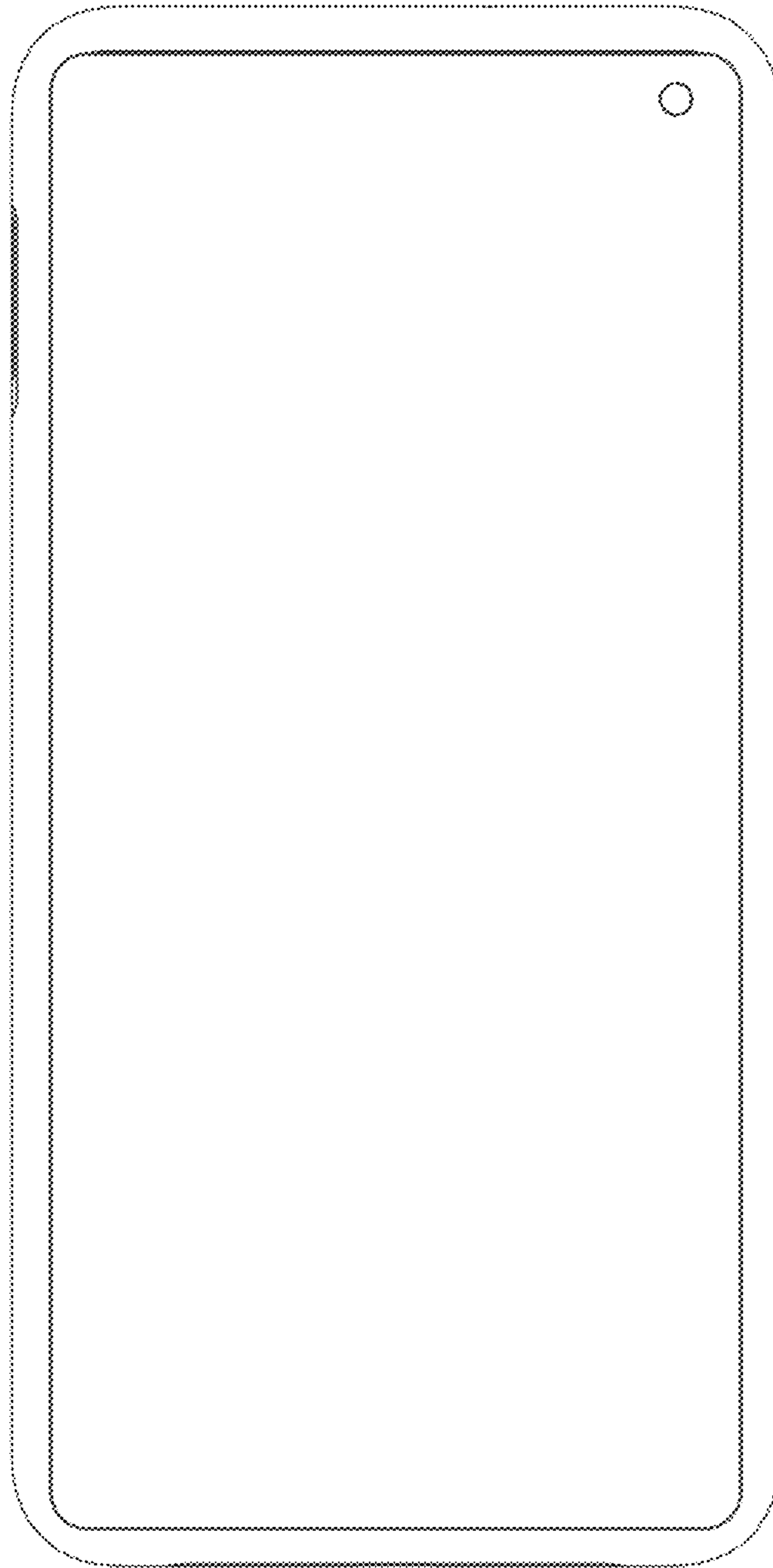

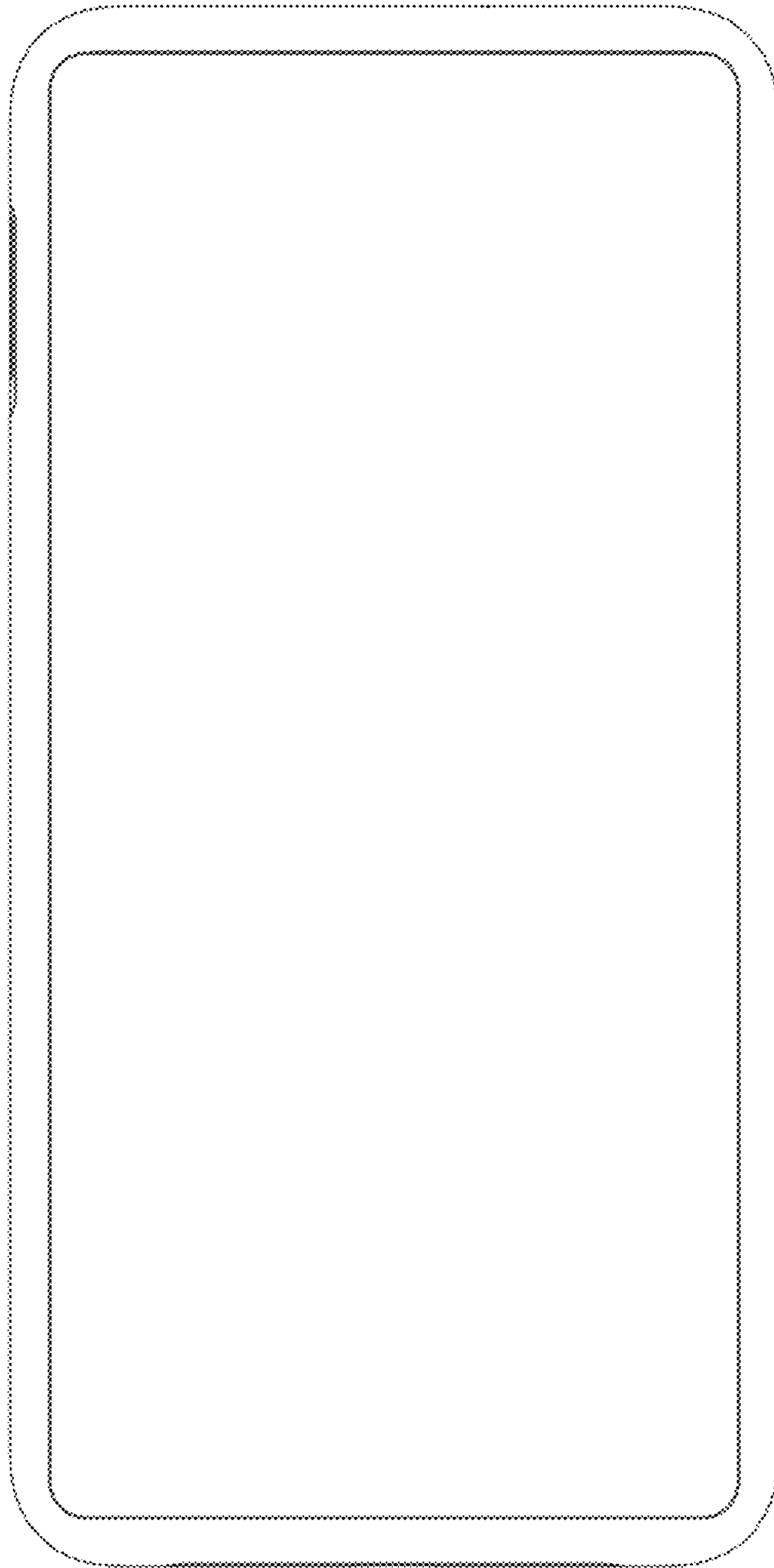

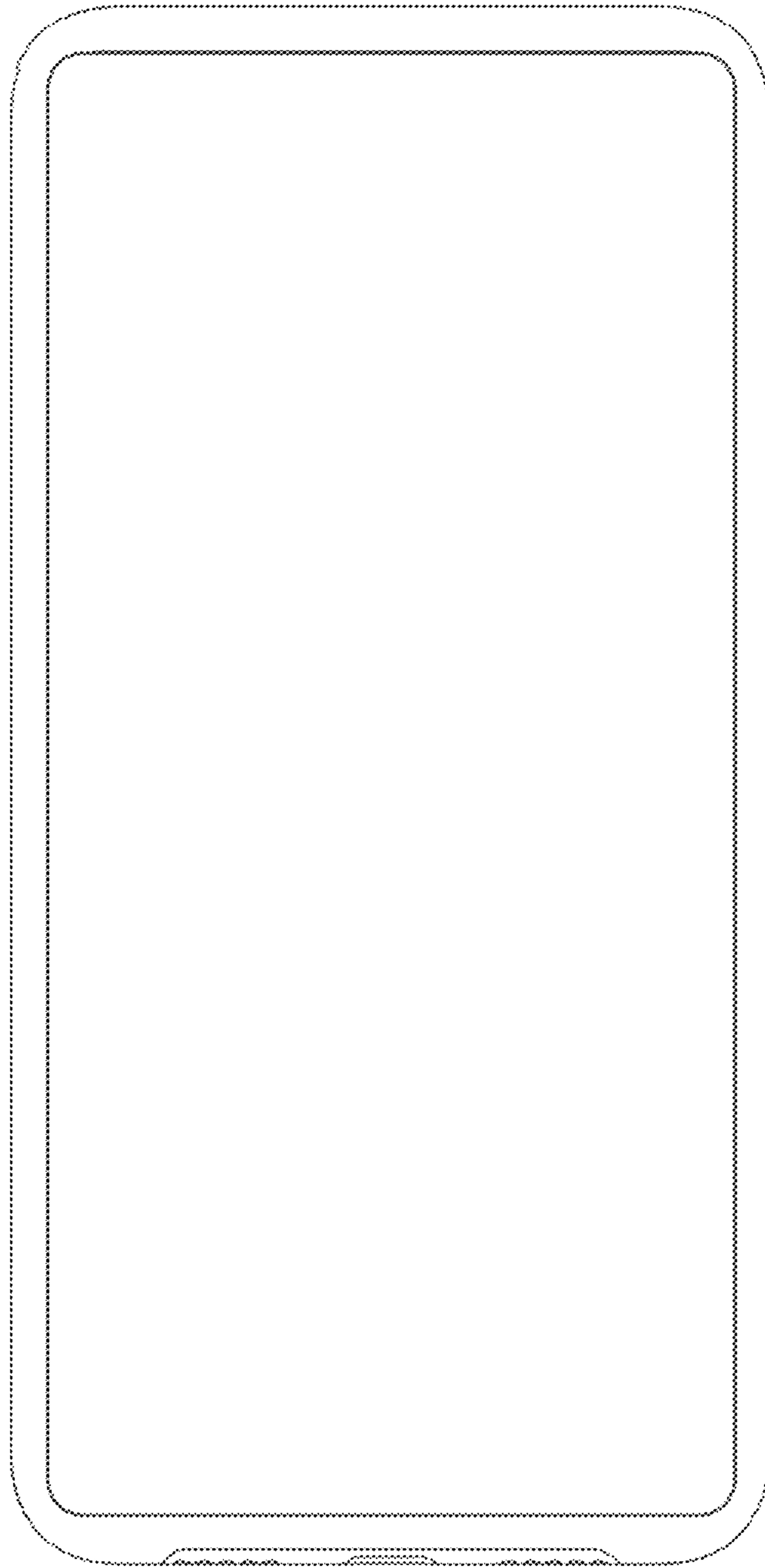

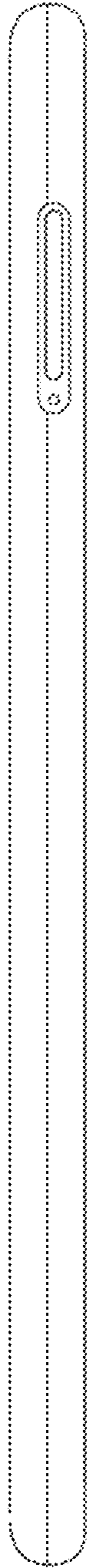

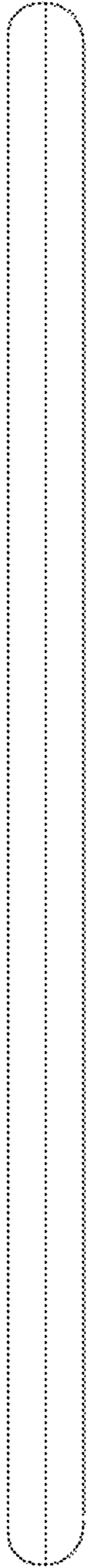

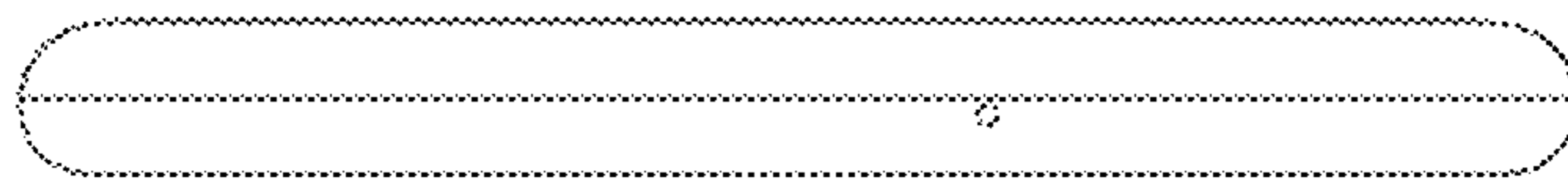

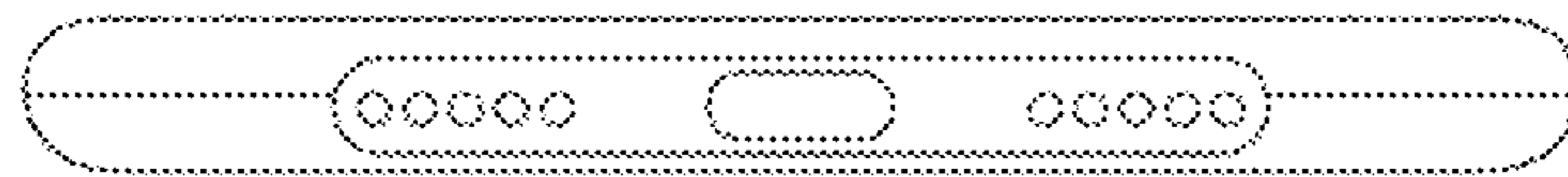

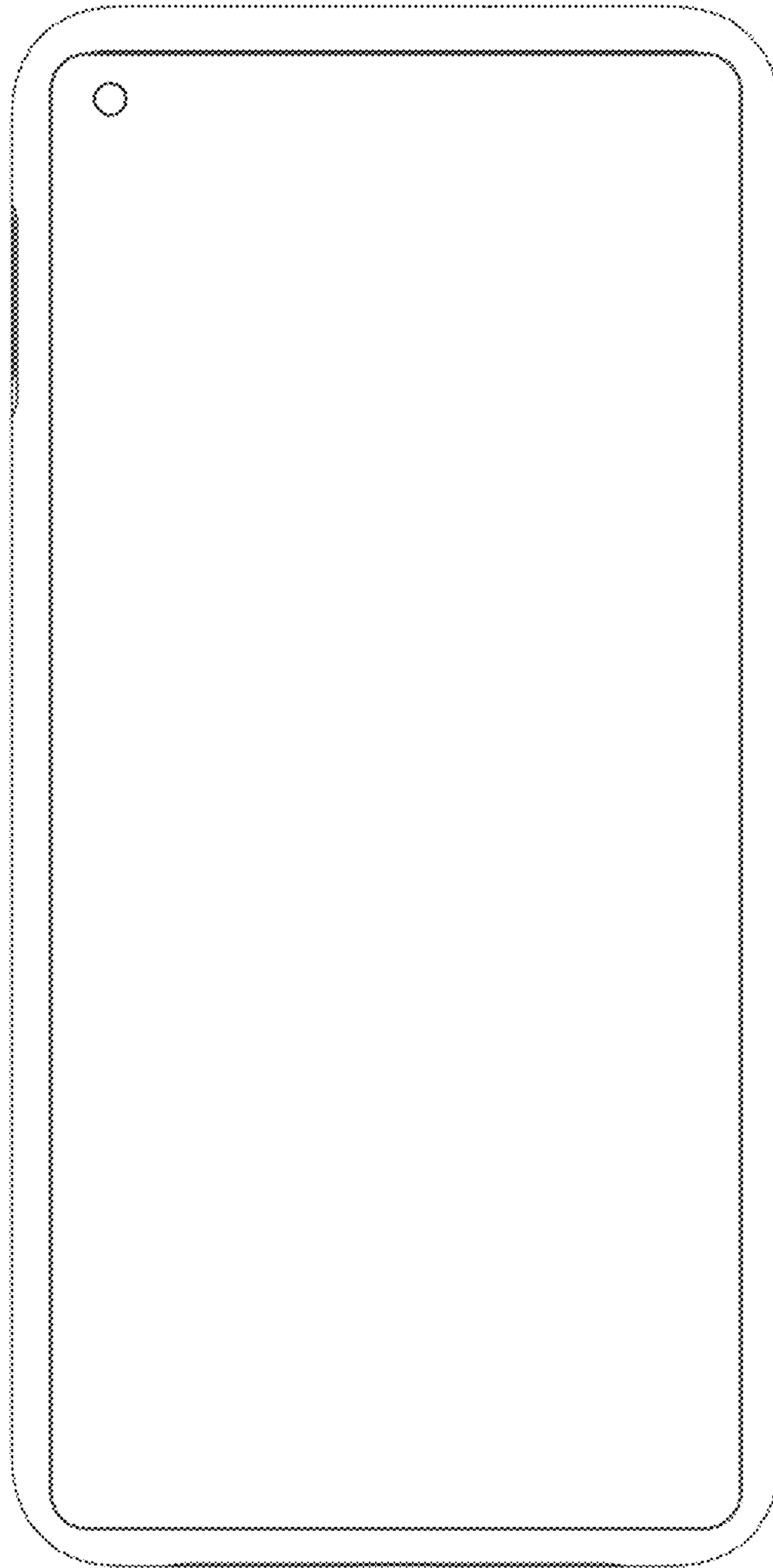

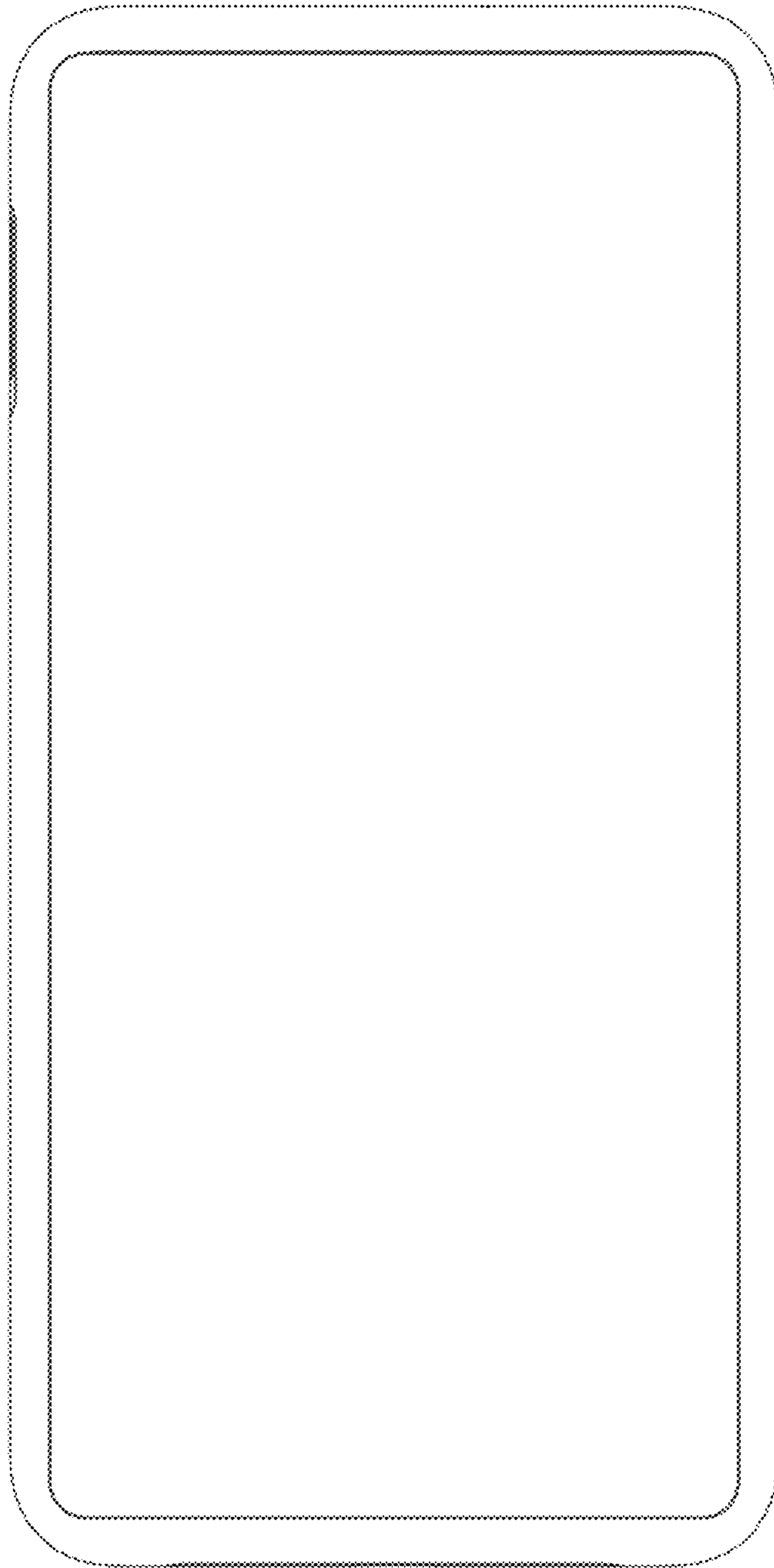

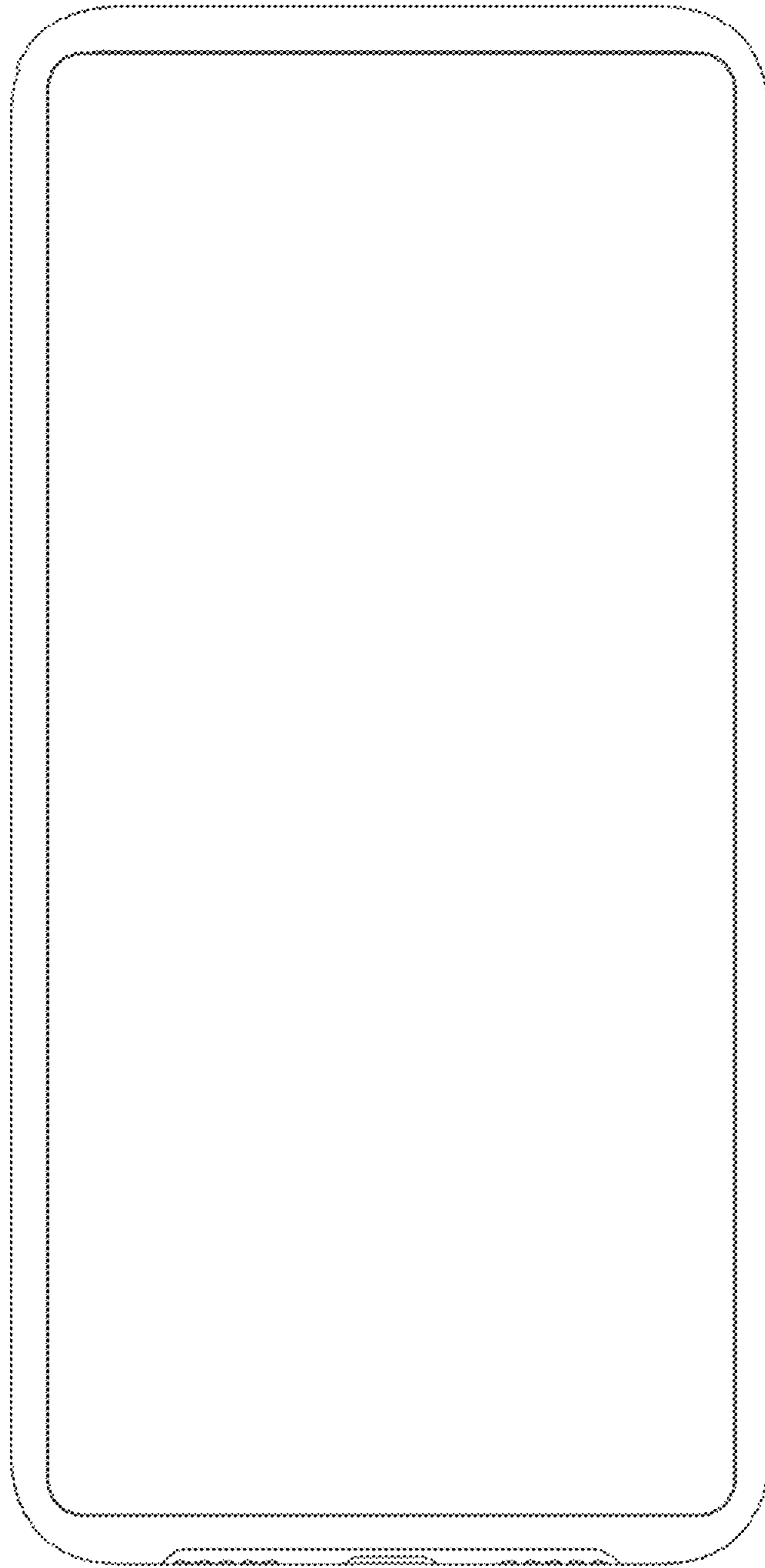

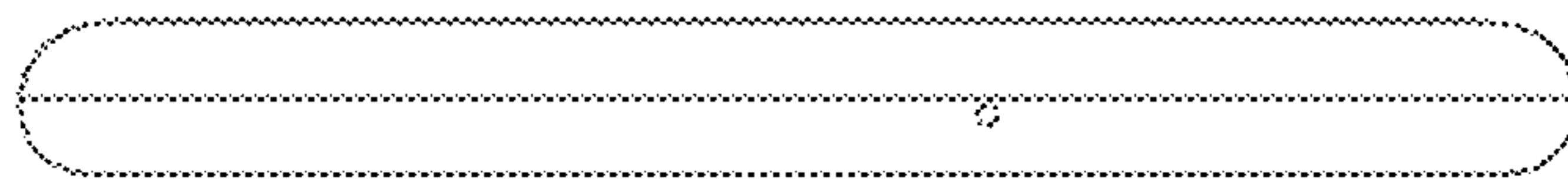

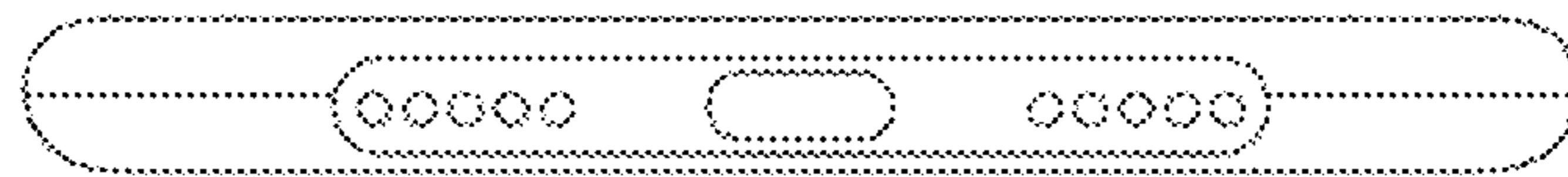

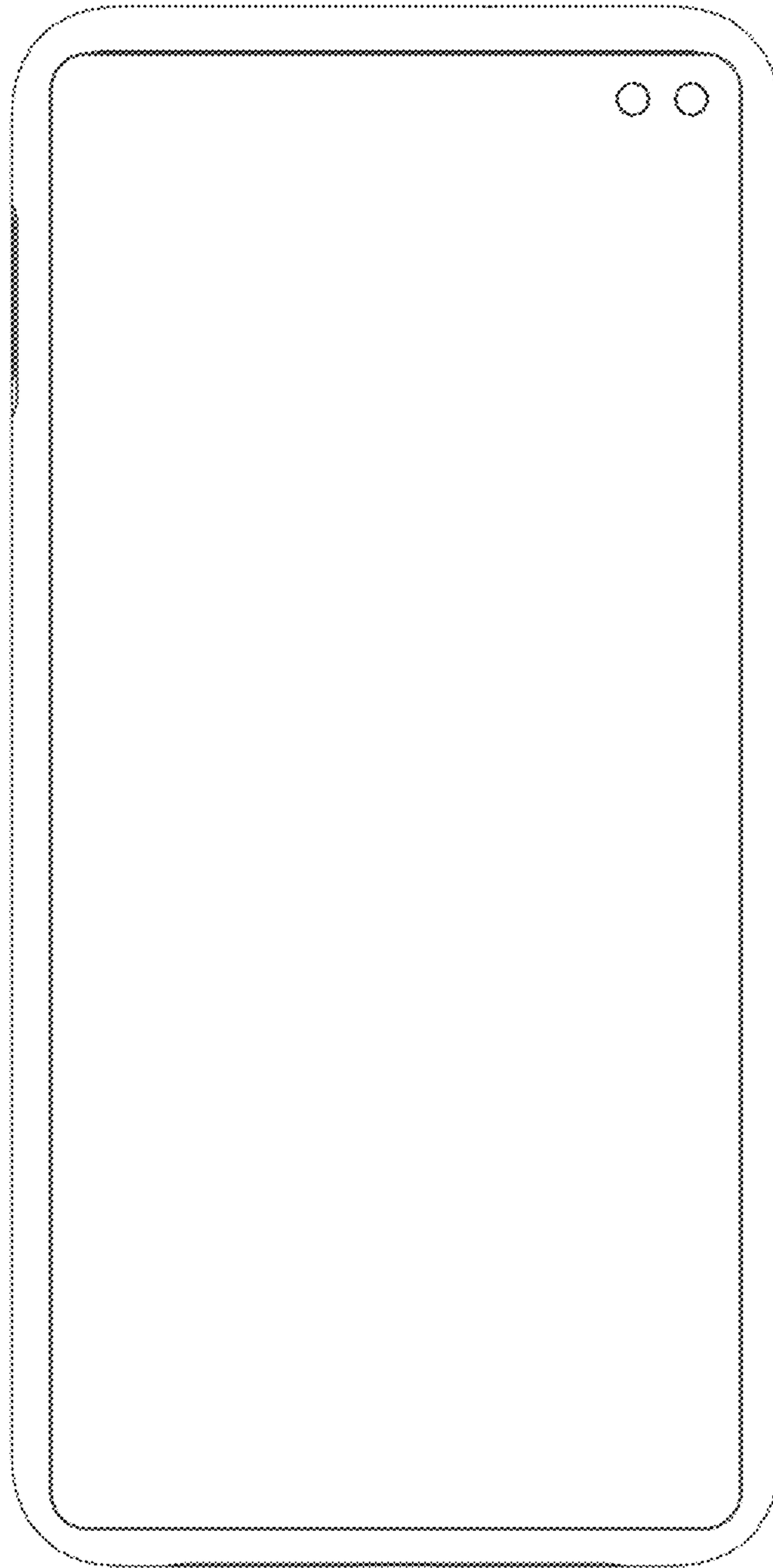

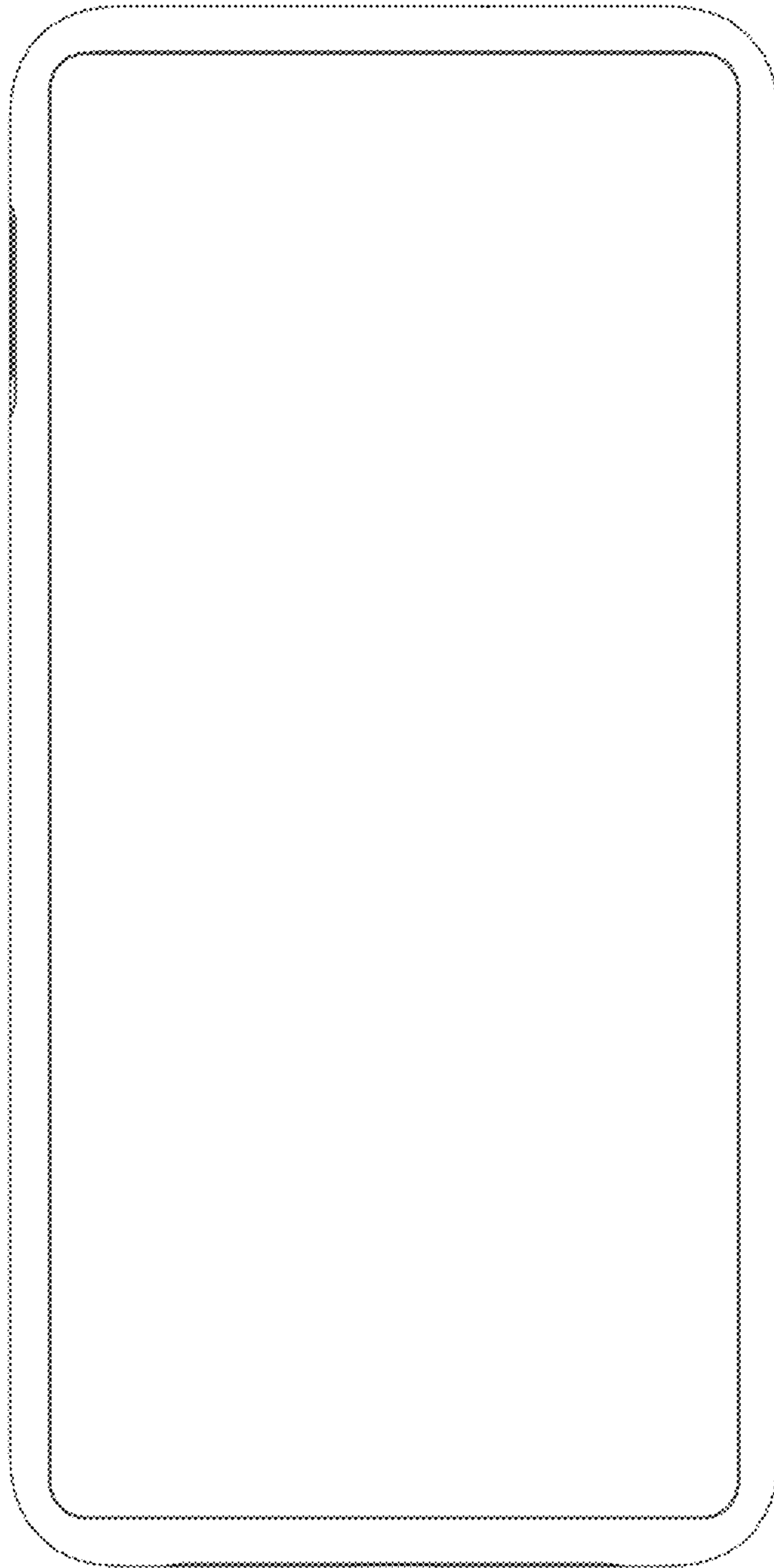

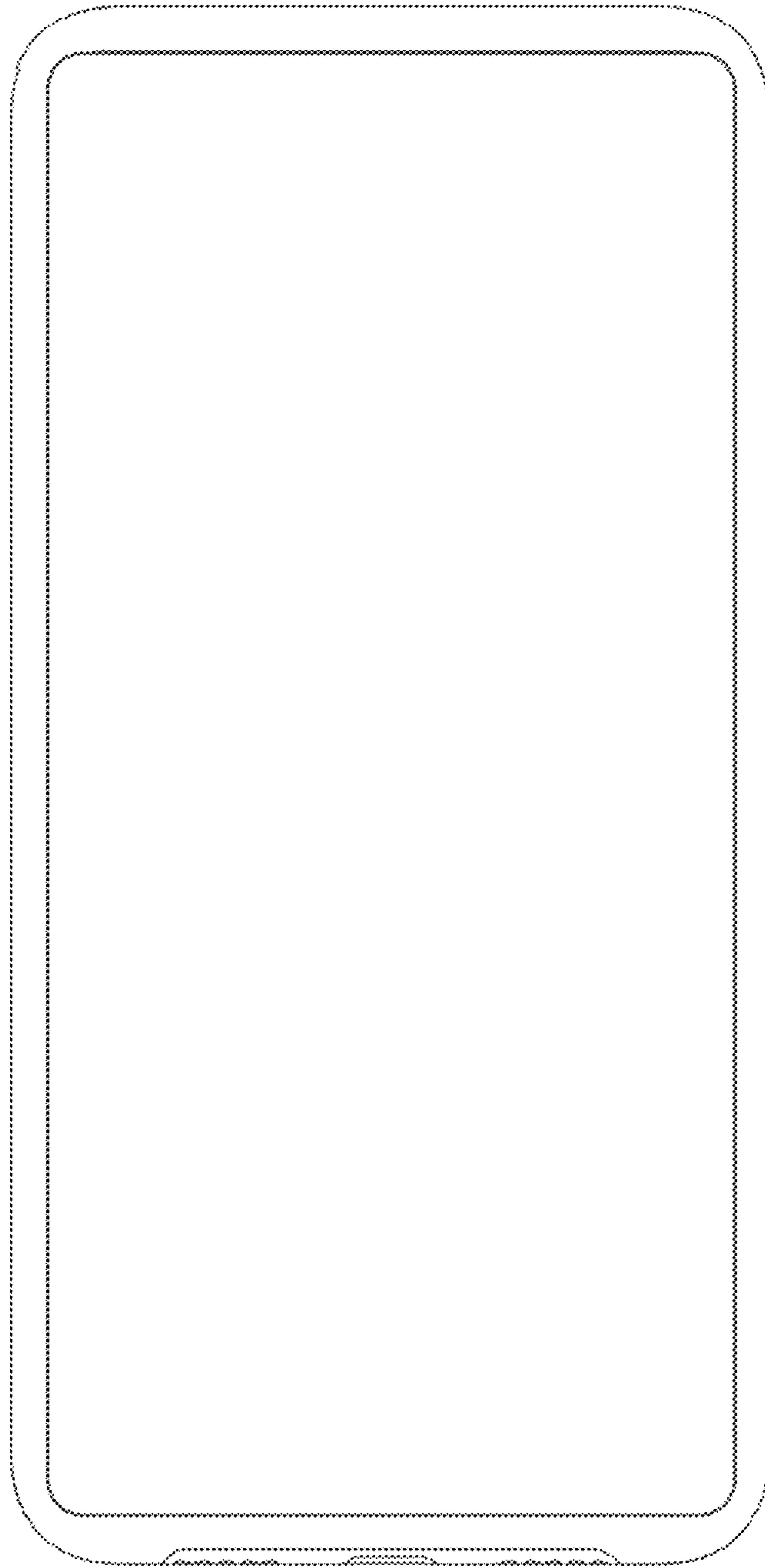

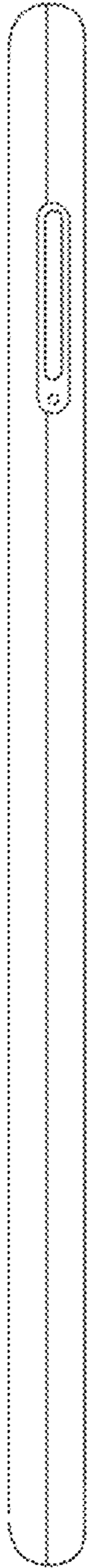

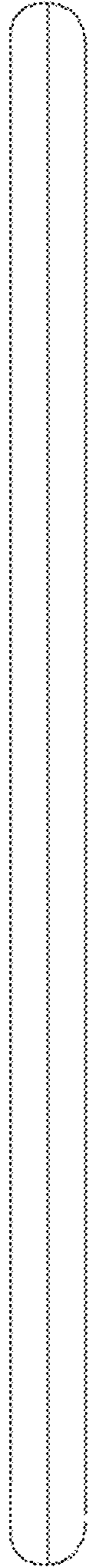

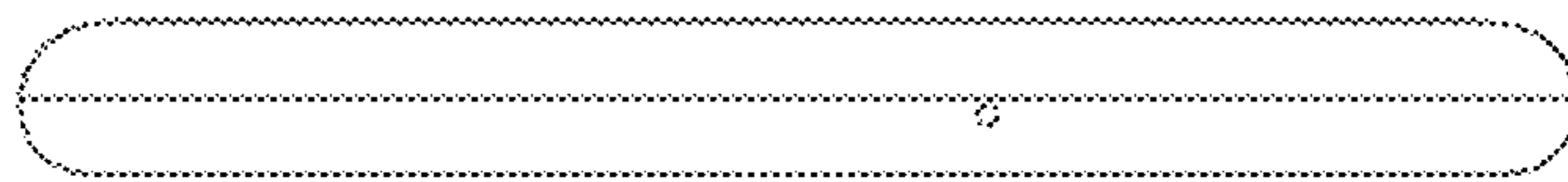

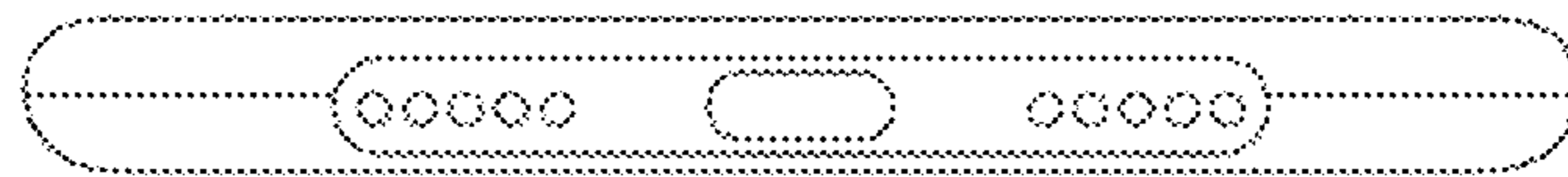

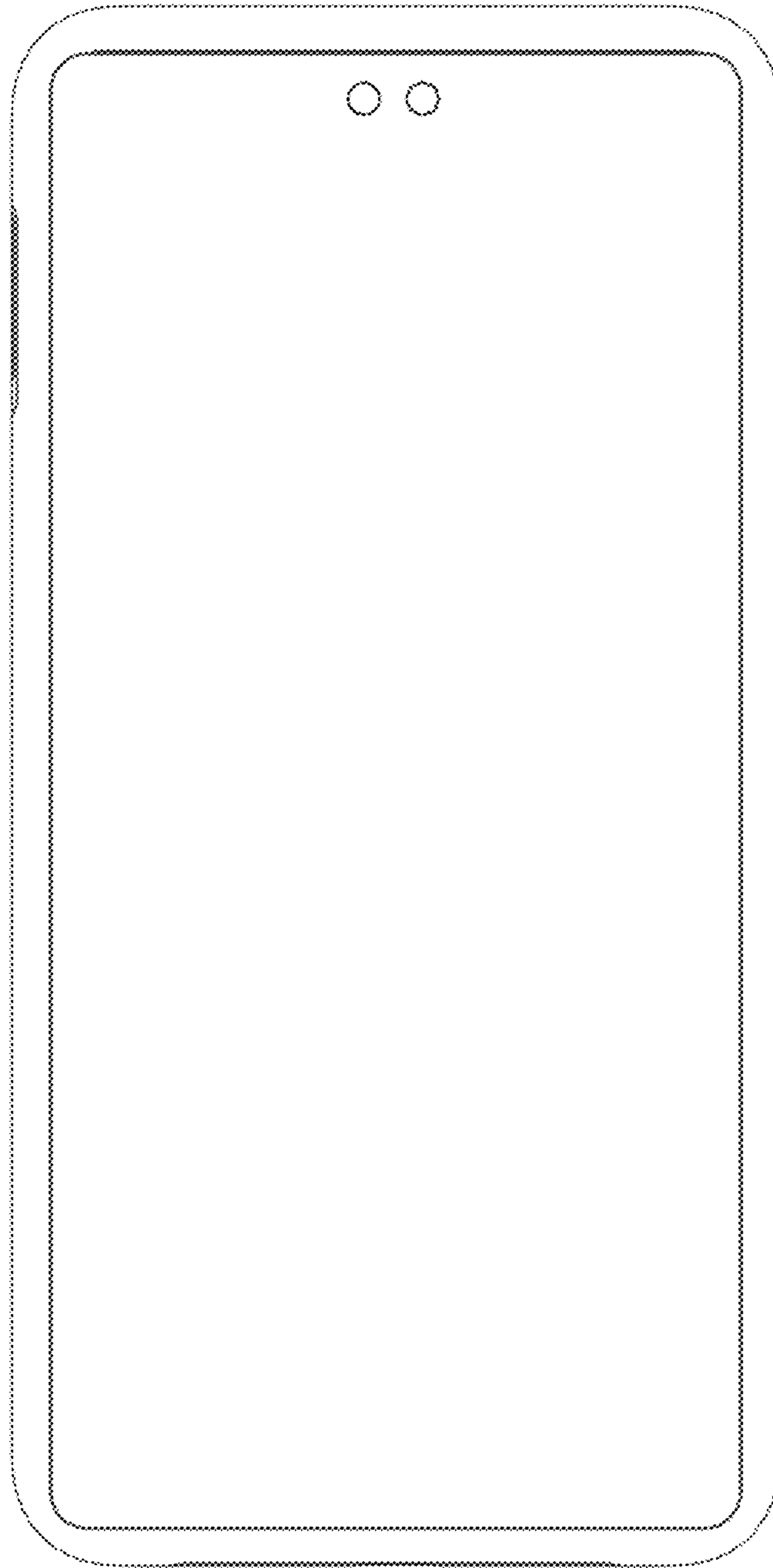

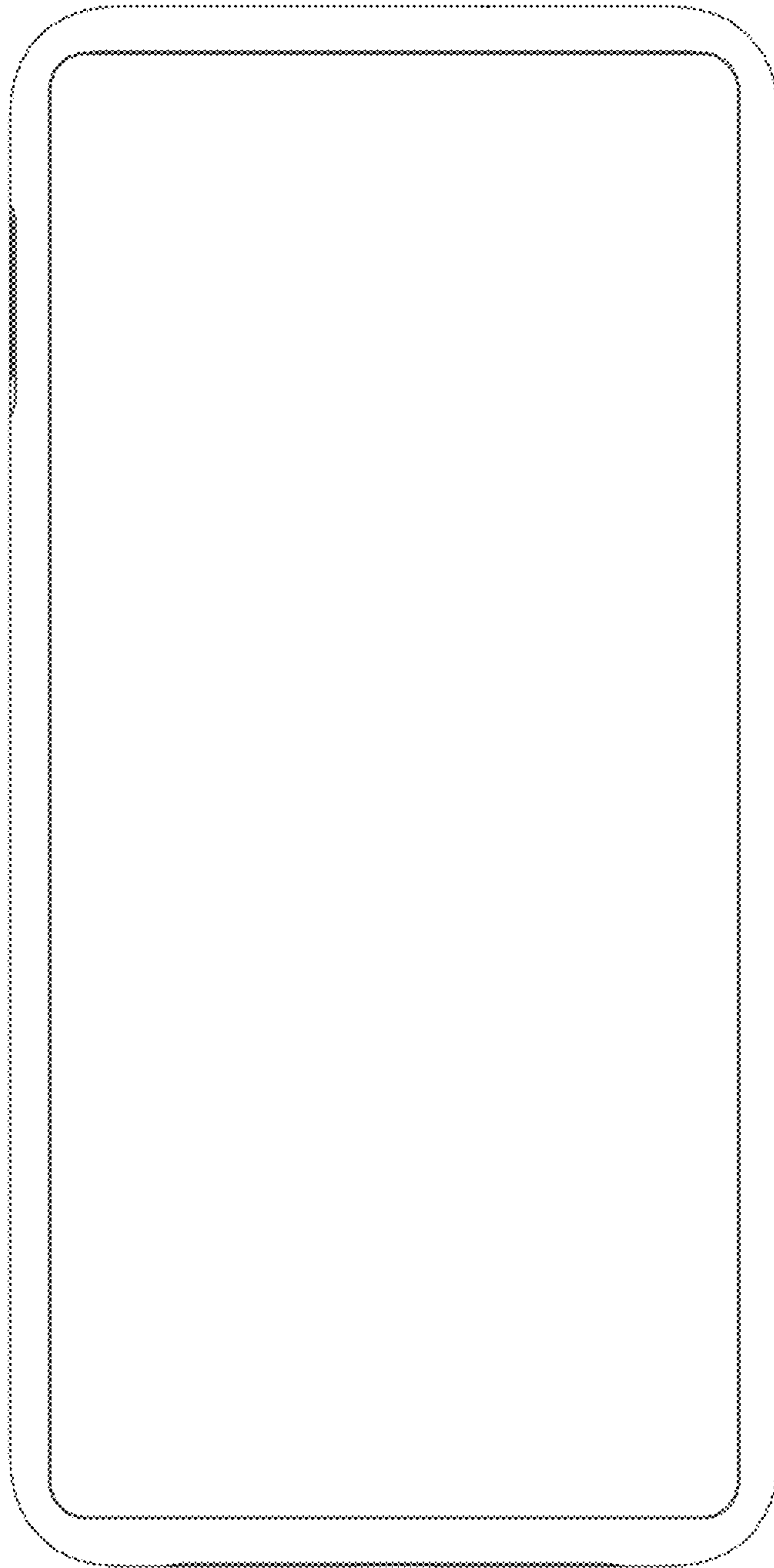

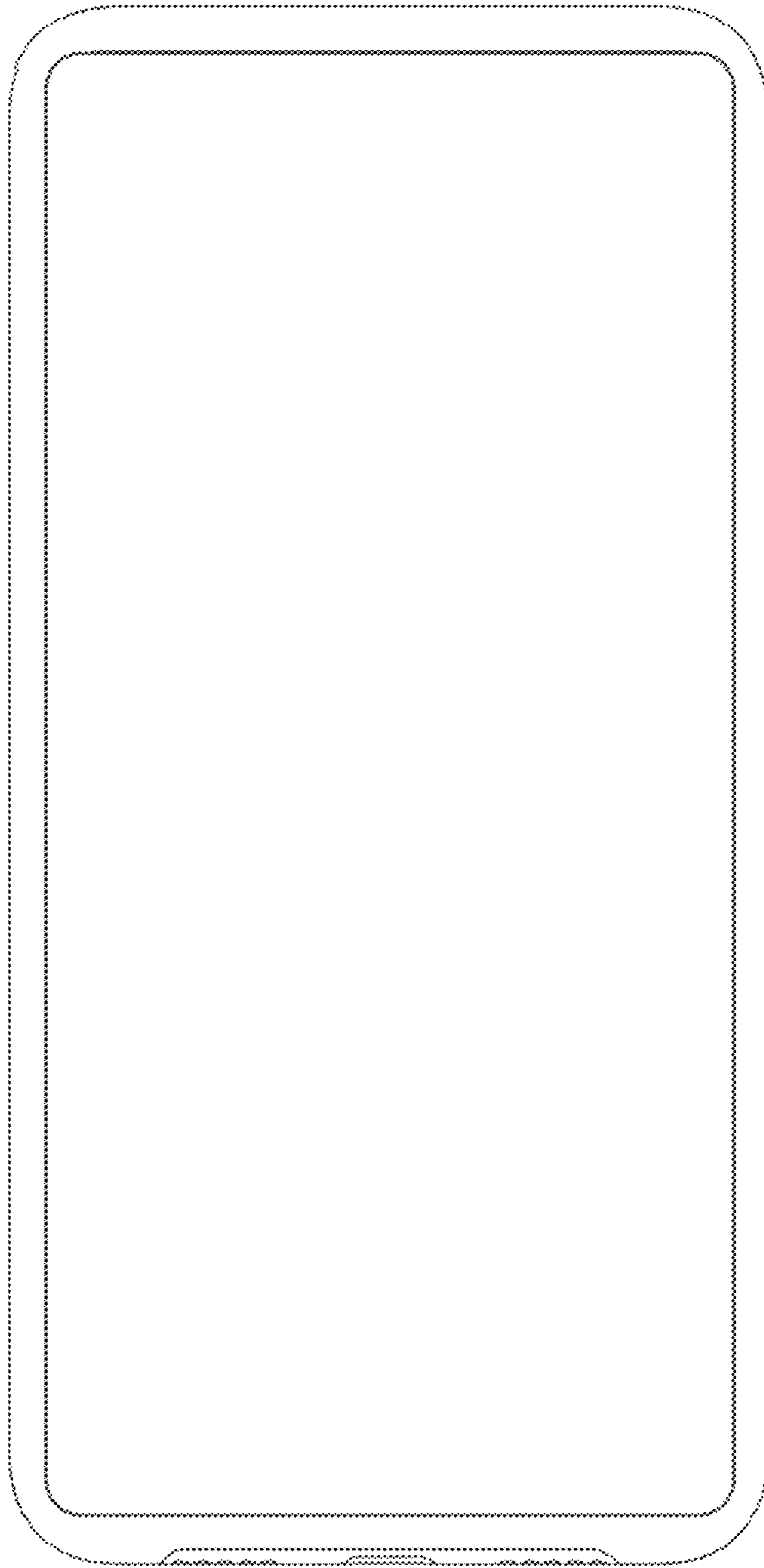

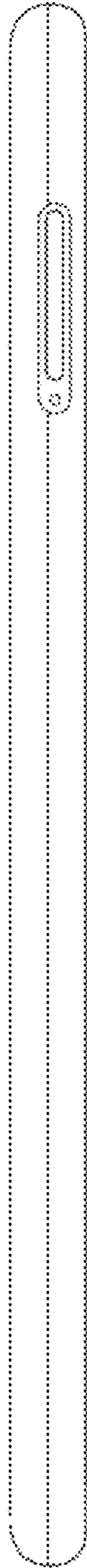

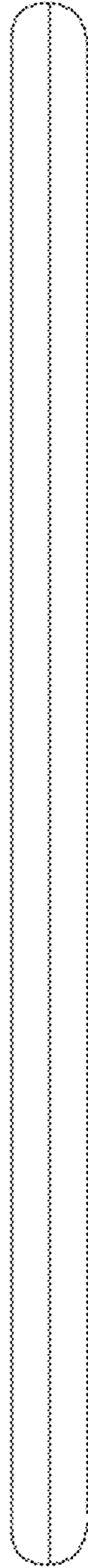

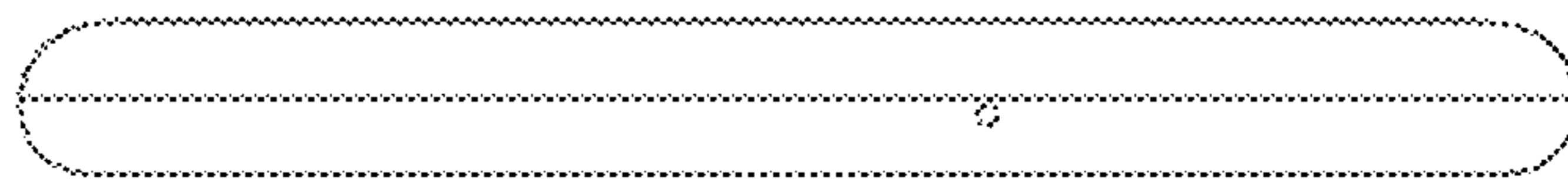

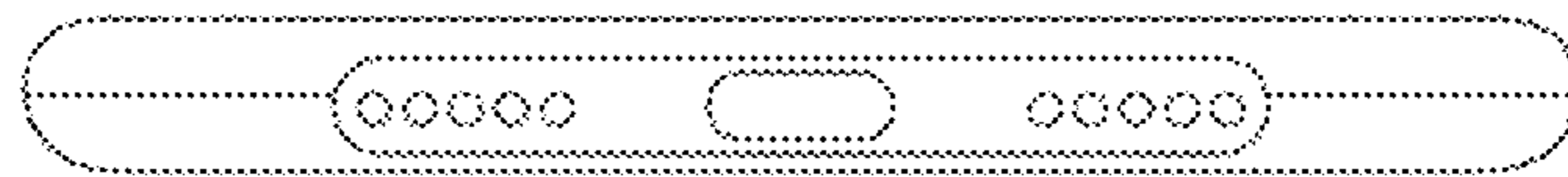

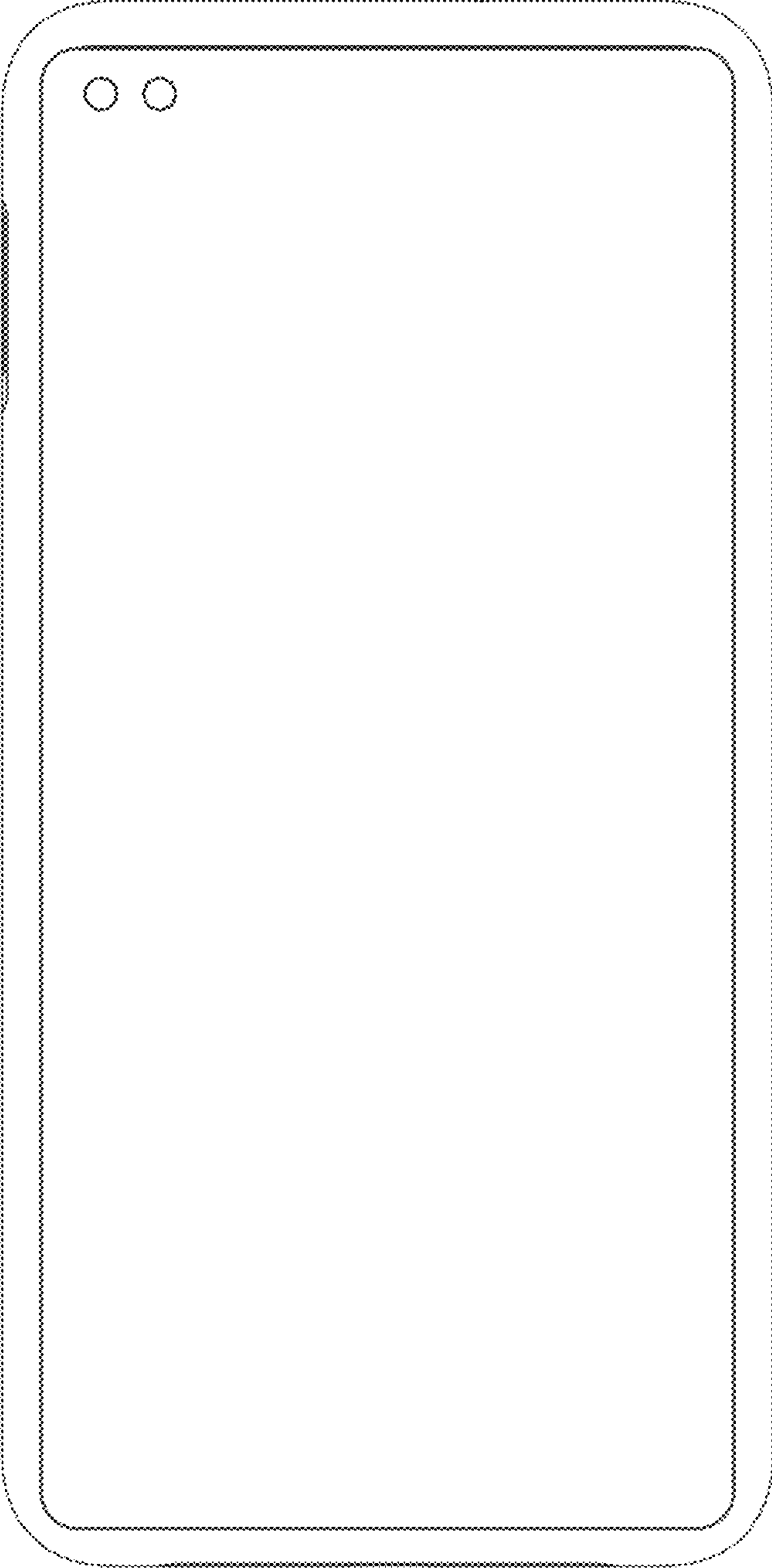
