(57) **CLAIM**

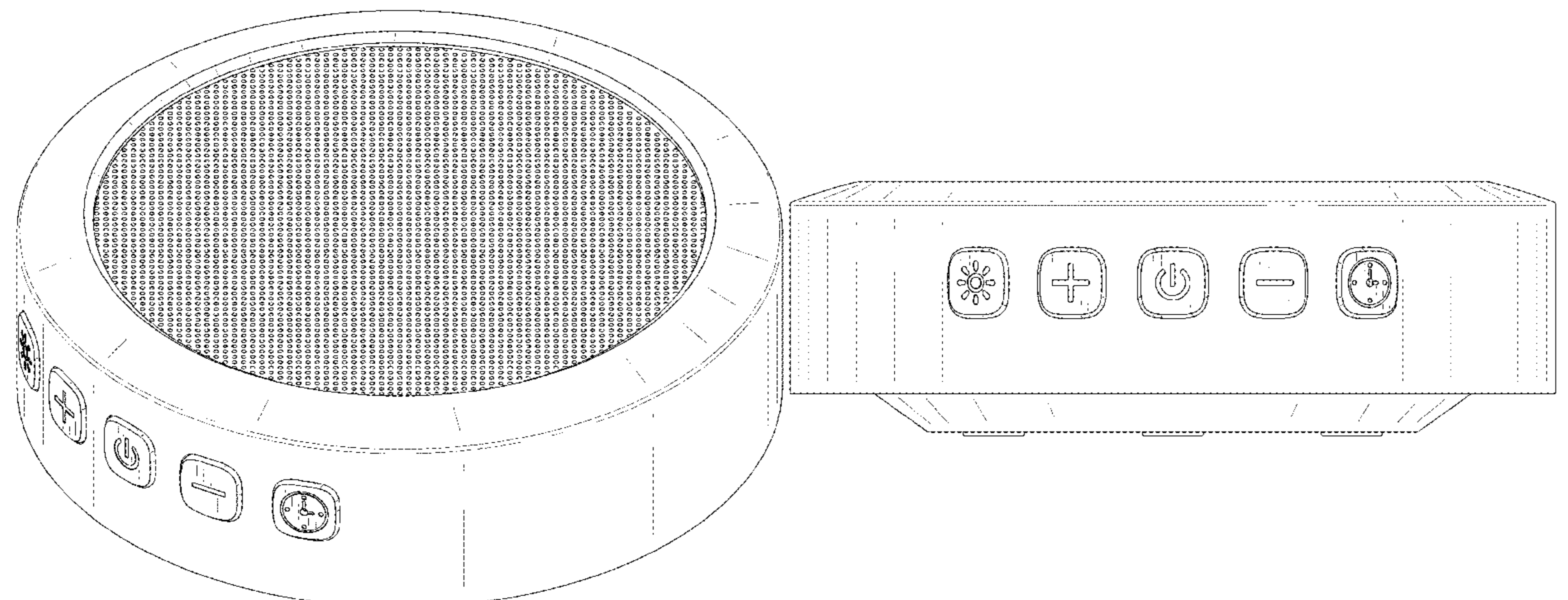
The ornamental design for a white noise machine, as shown and described.

DESCRIPTION

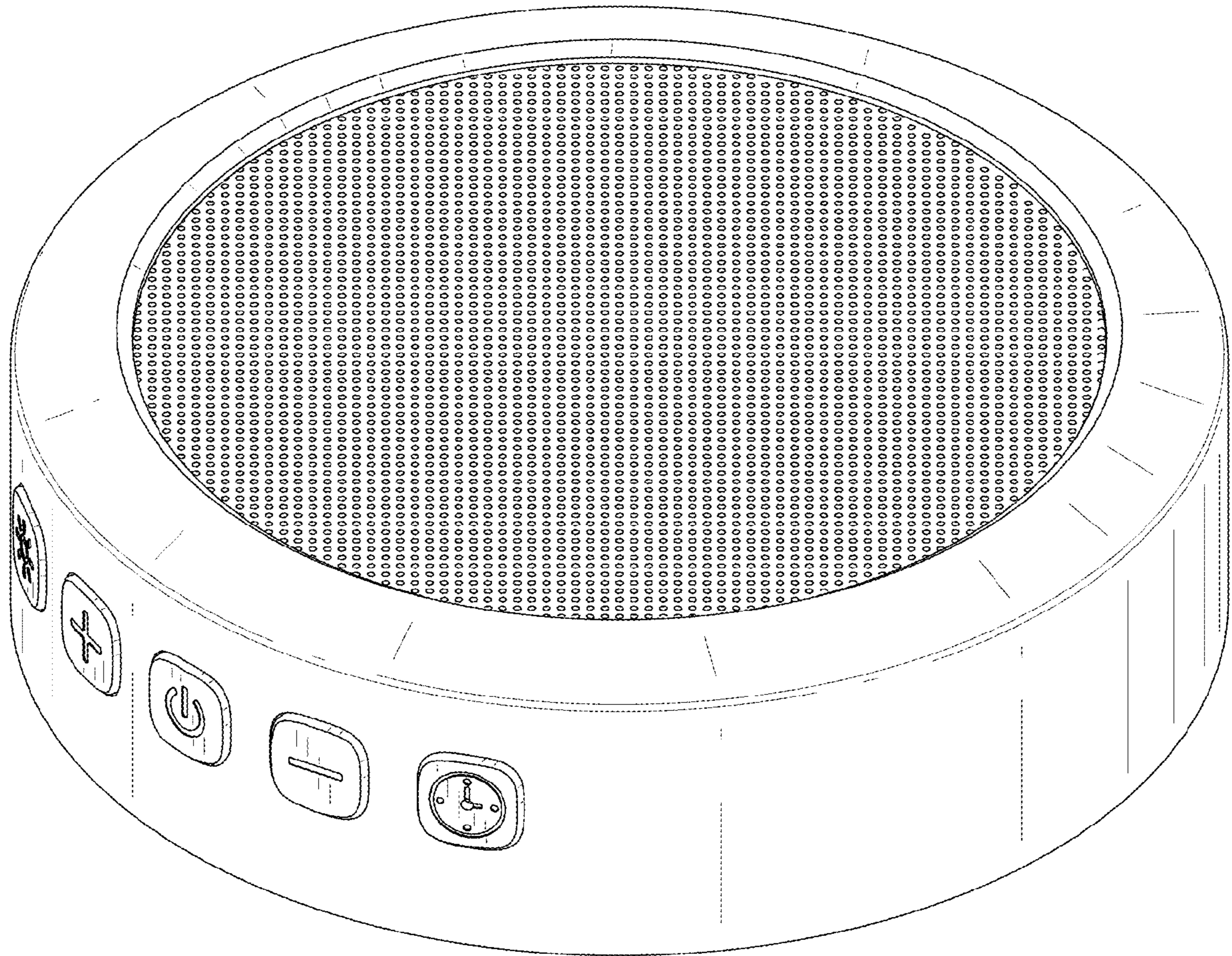

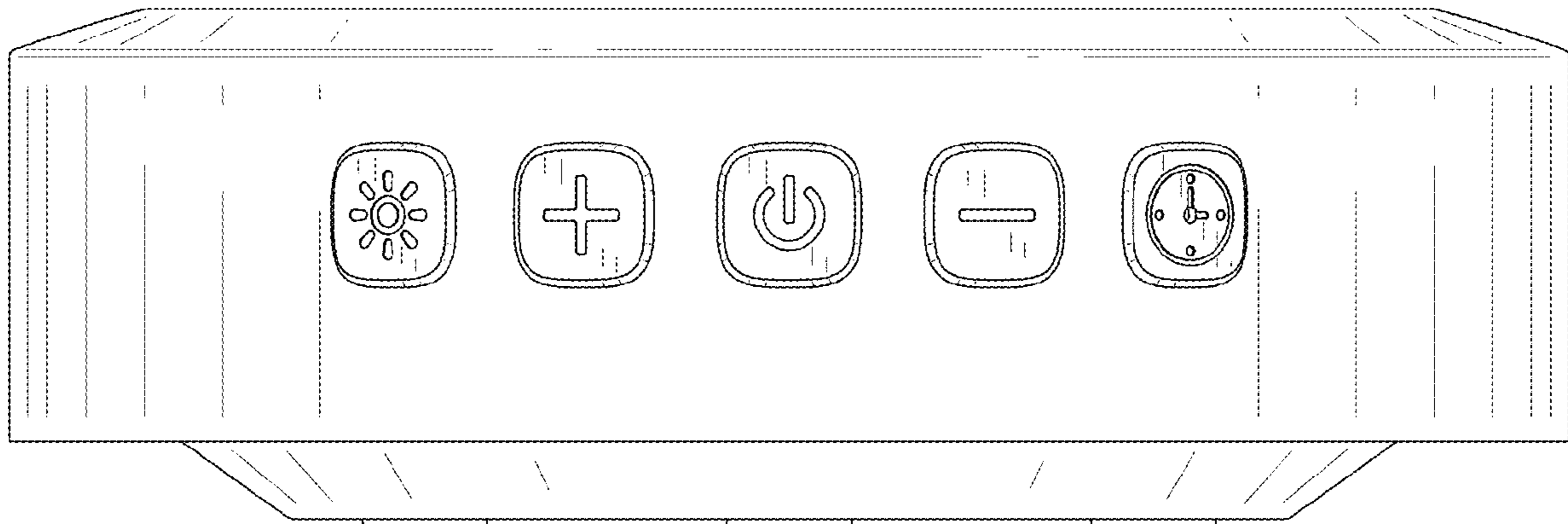

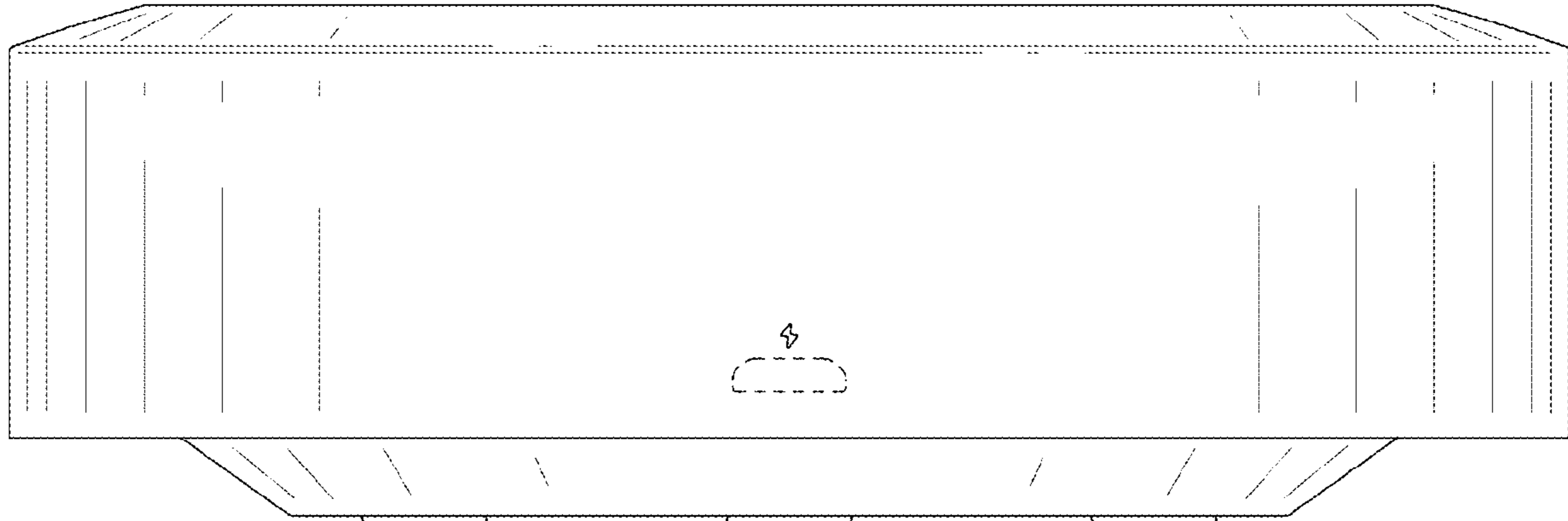

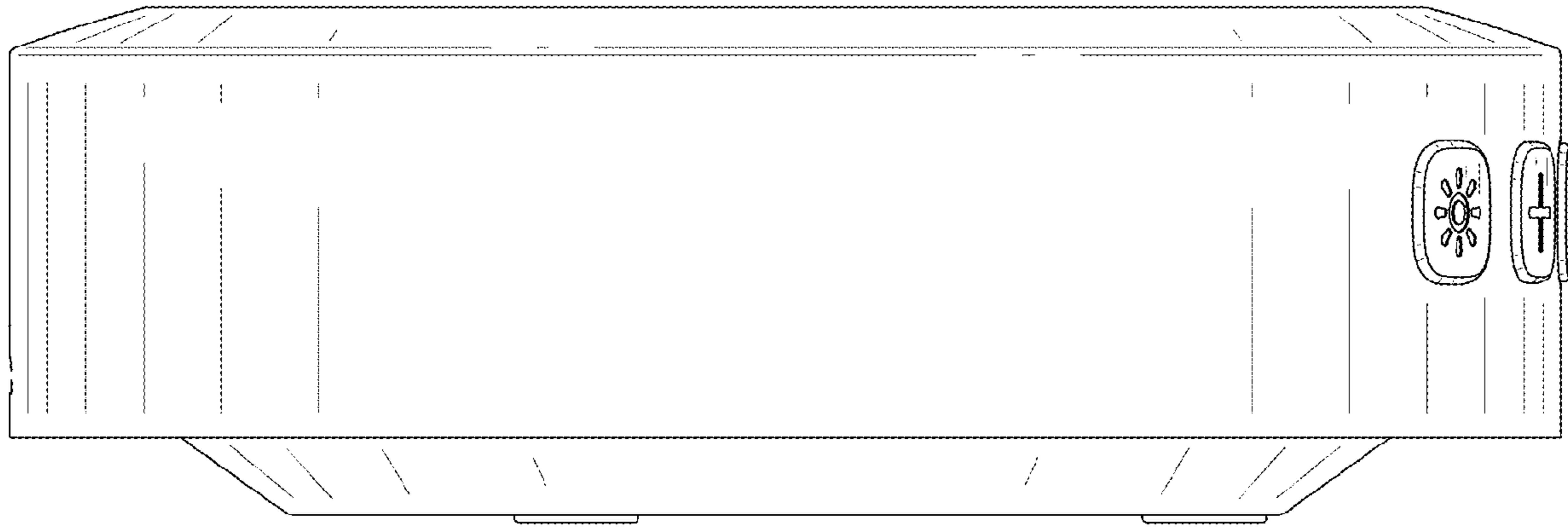

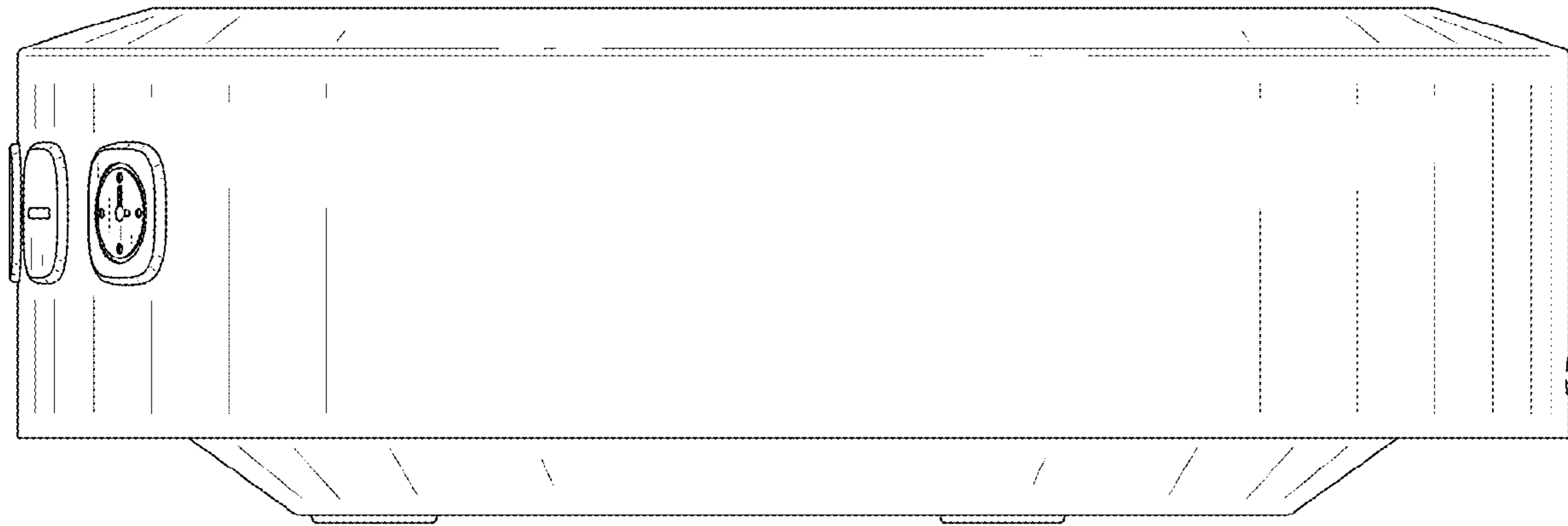

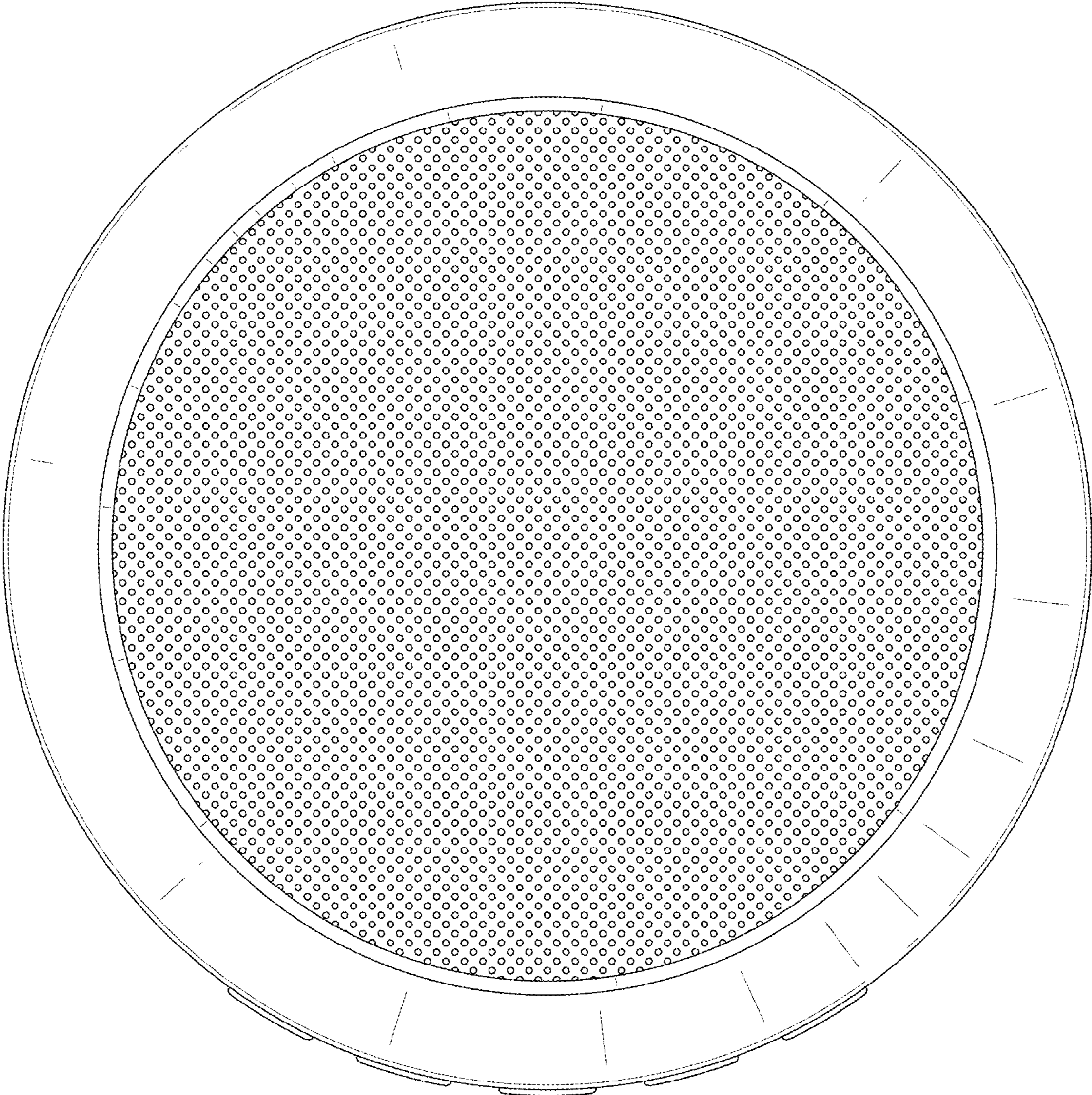

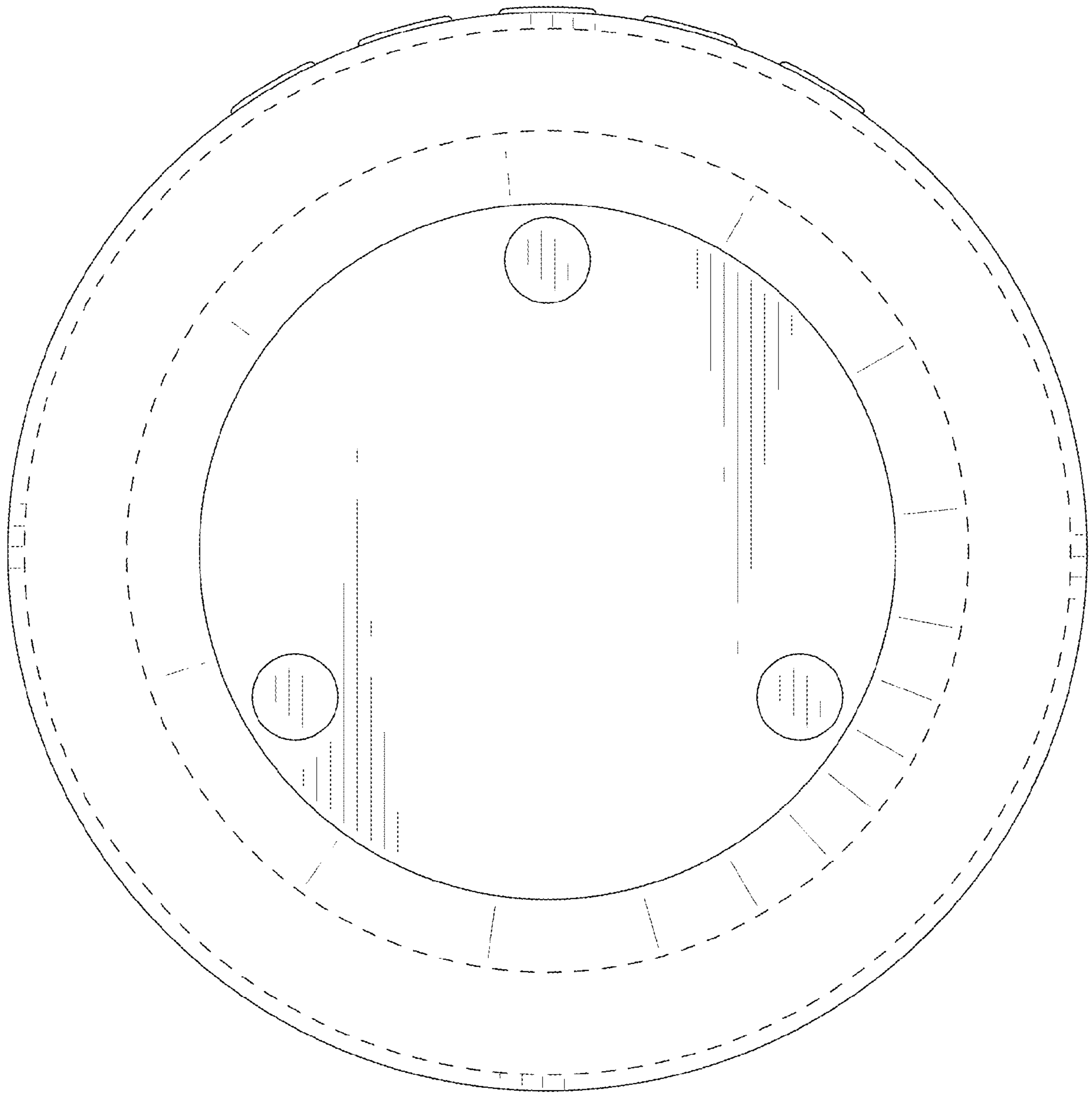
