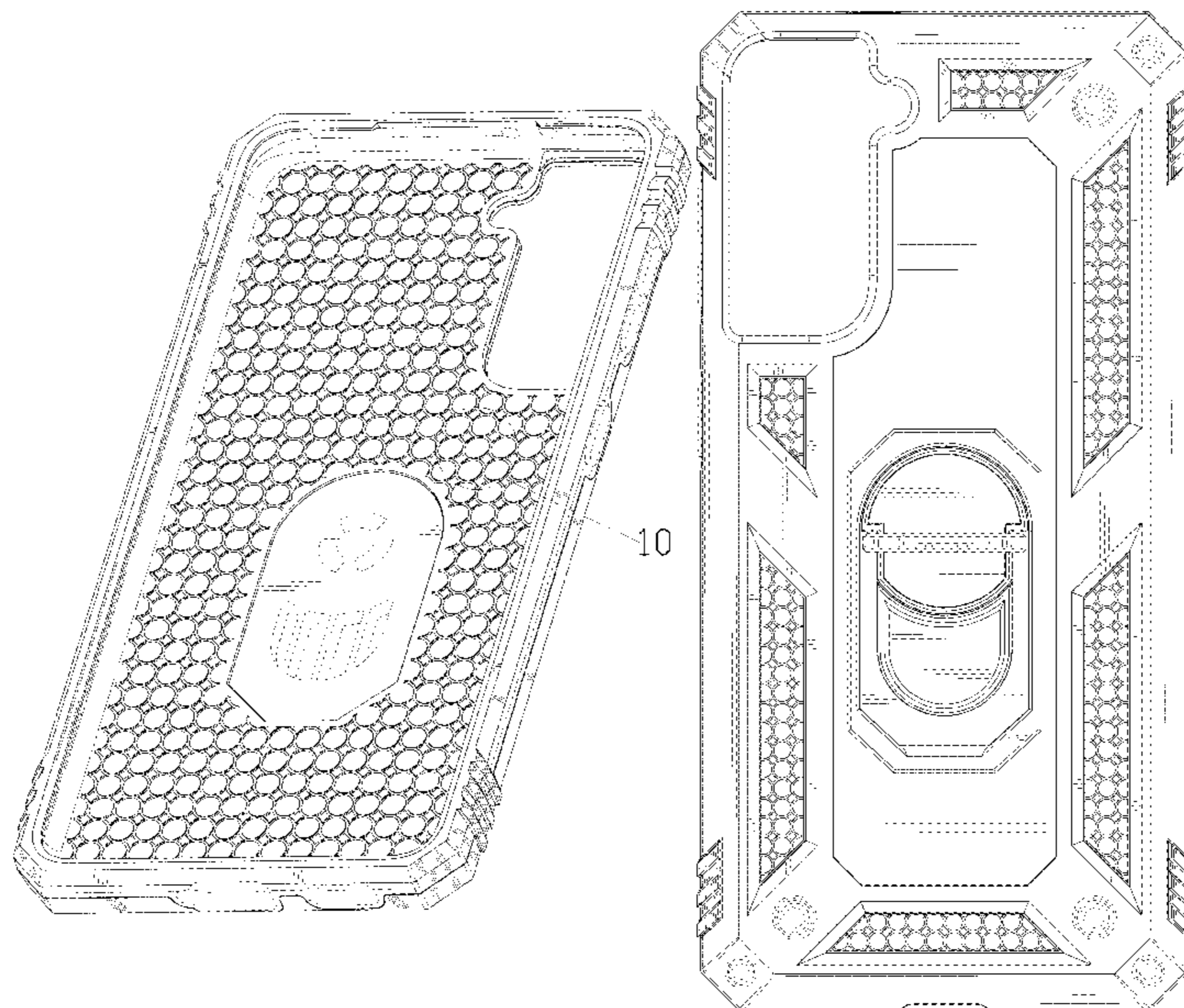
(57) **CLAIM**

The ornamental design for a phone case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right-side, and bottom perspective view of a phone case showing my new design with the kickstand component in an extended position;  
 FIG. 2 is a rear, left-side, and top perspective view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a bottom plan view thereof;  
 FIG. 9 is a rear, left-side, and top perspective view thereof showing the kickstand component in the stowed position; and,  
 FIG. 10 is an enlarged view of portion 10 shown in FIG. 1. The dot-dash broken lines in FIGS. 1 and 10 form no part of the claimed design and delineate a portion of the phone case that is part of the claimed design and that is shown on an enlarged scale in FIG. 10. The dashed broken lines throughout the drawing figures form no part of the claimed design and depict portions of the phone case that form no part of the claimed design.

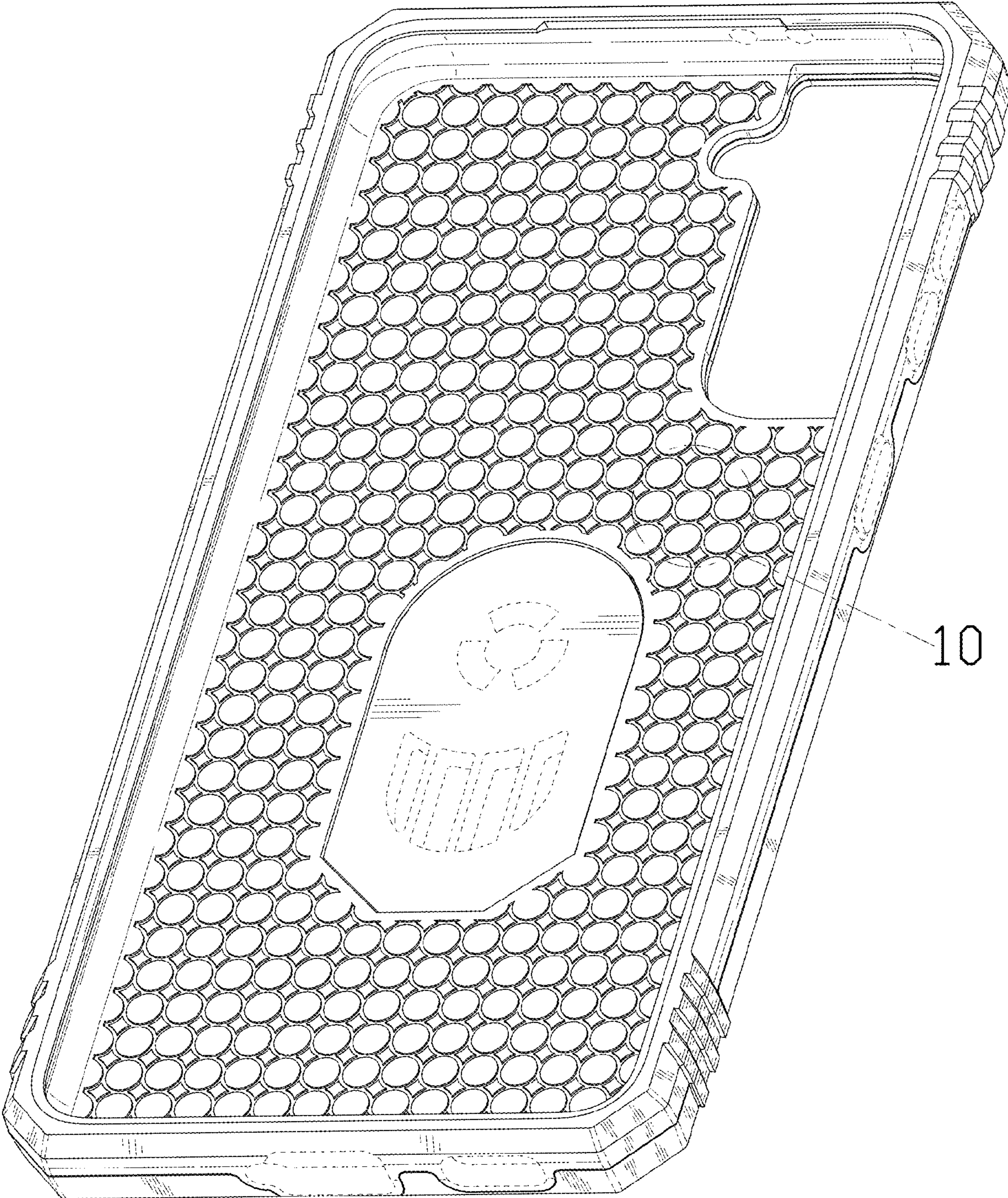

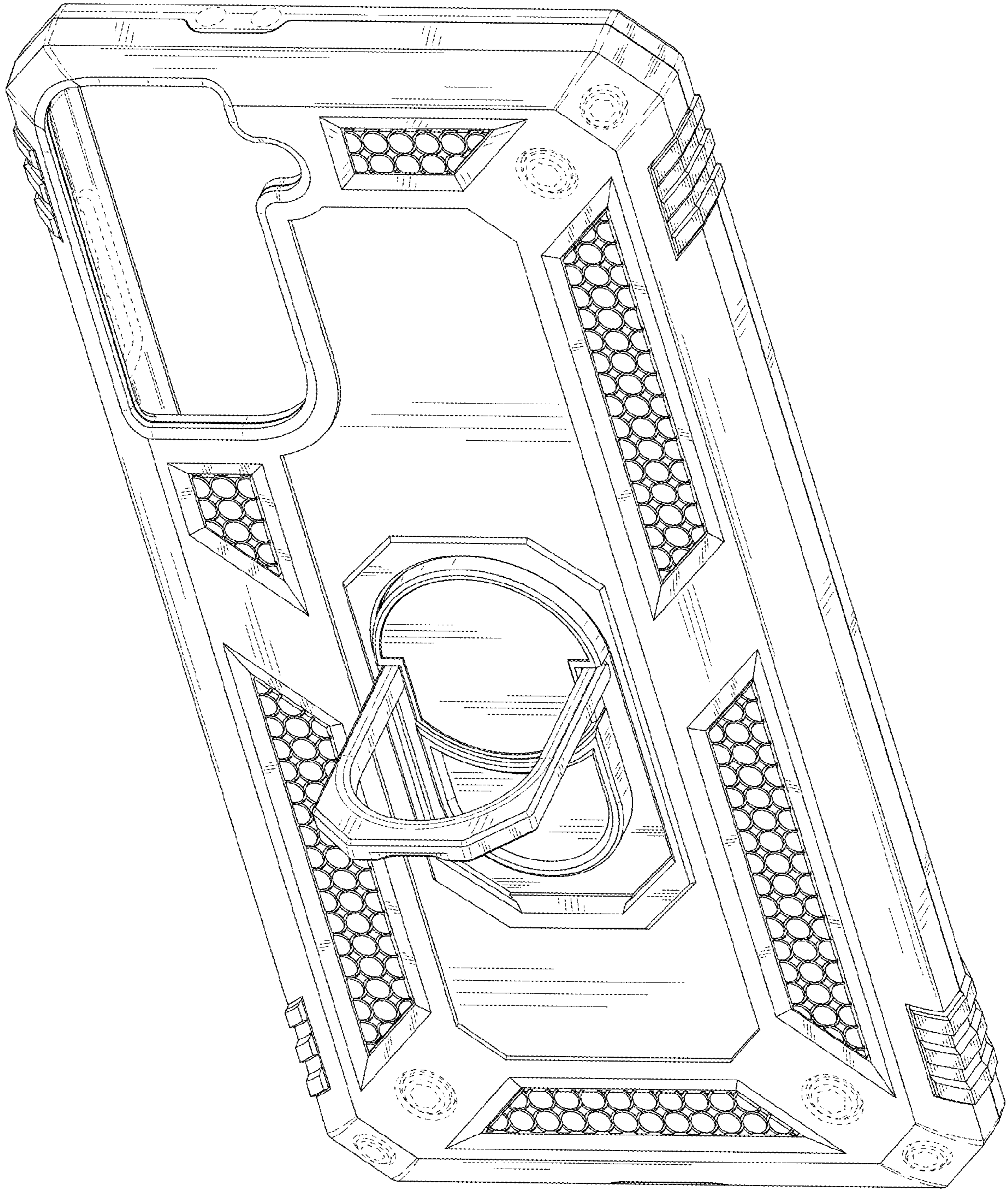

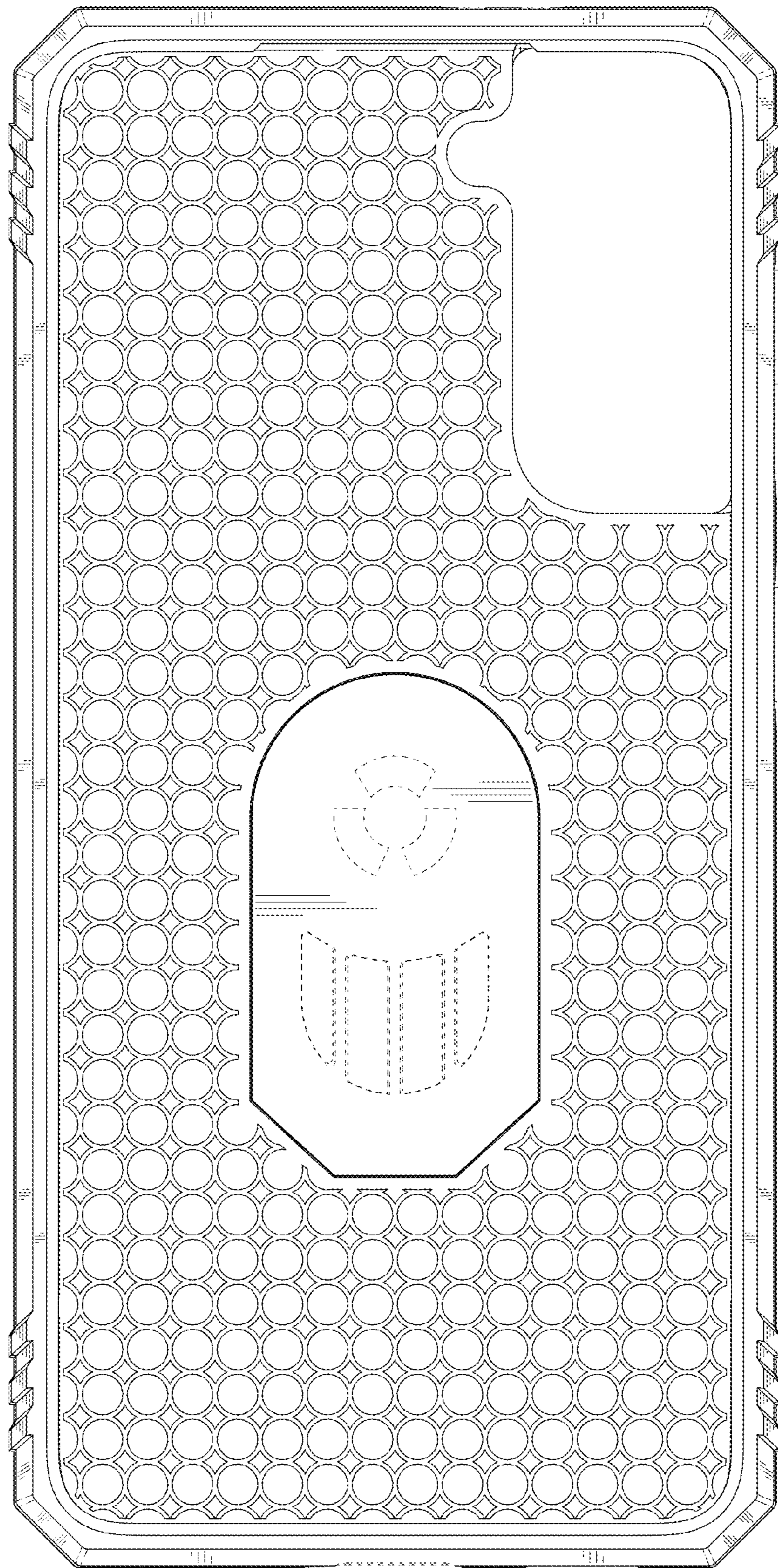

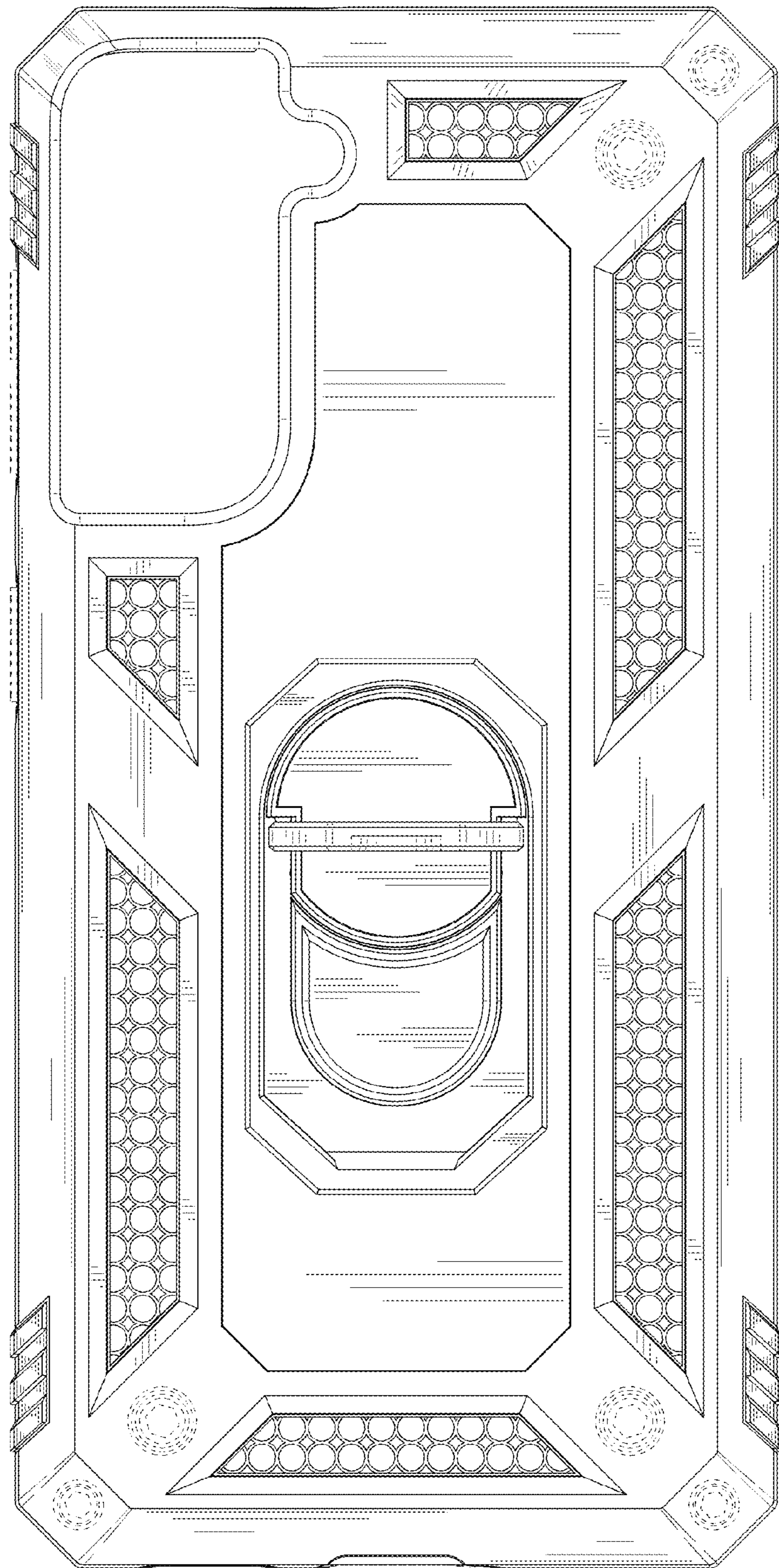

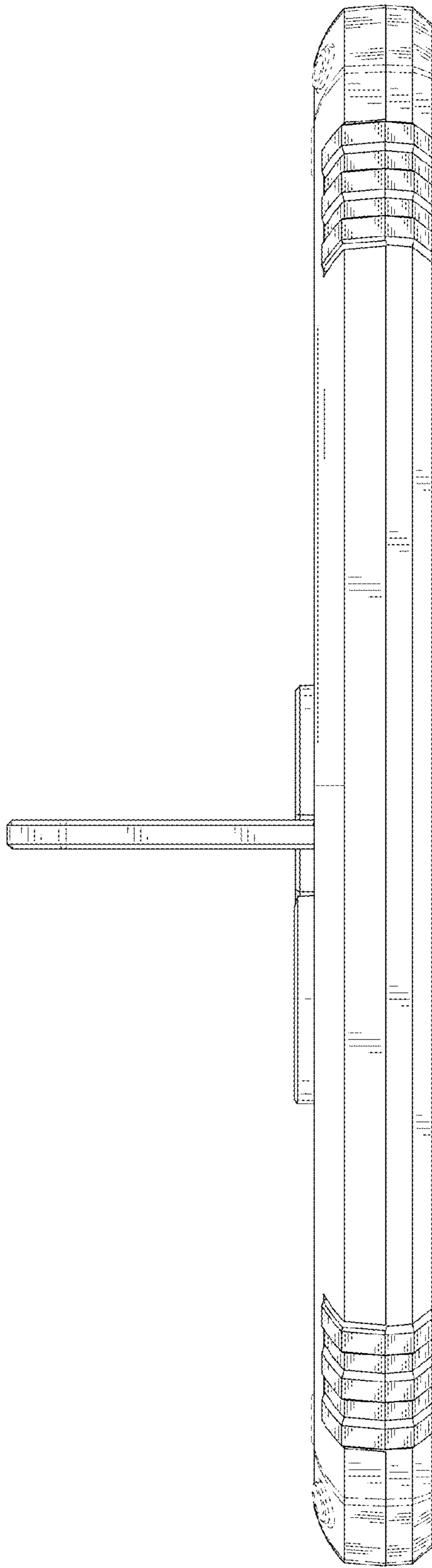

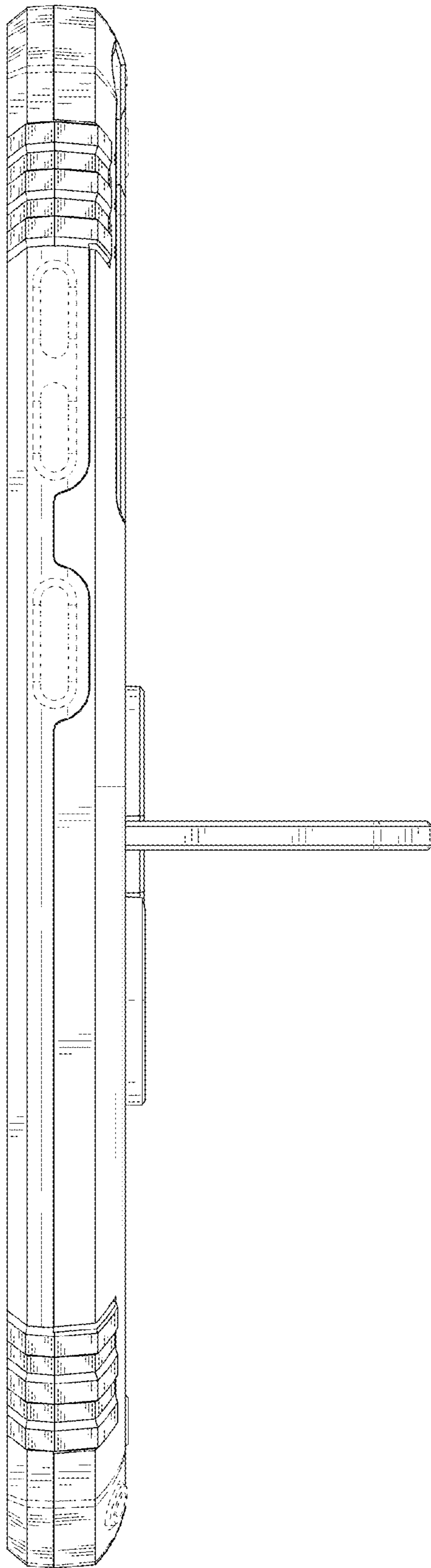

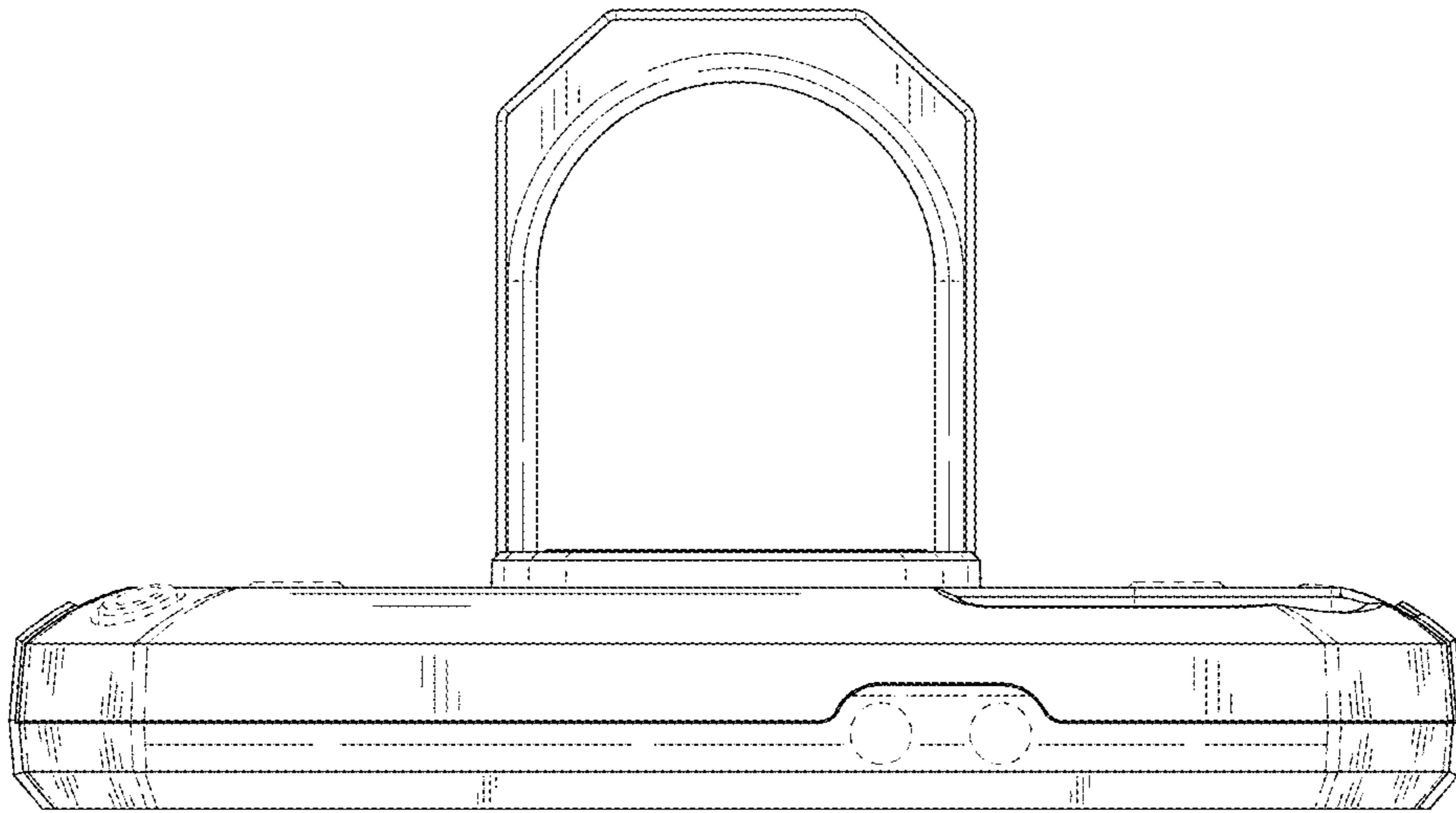

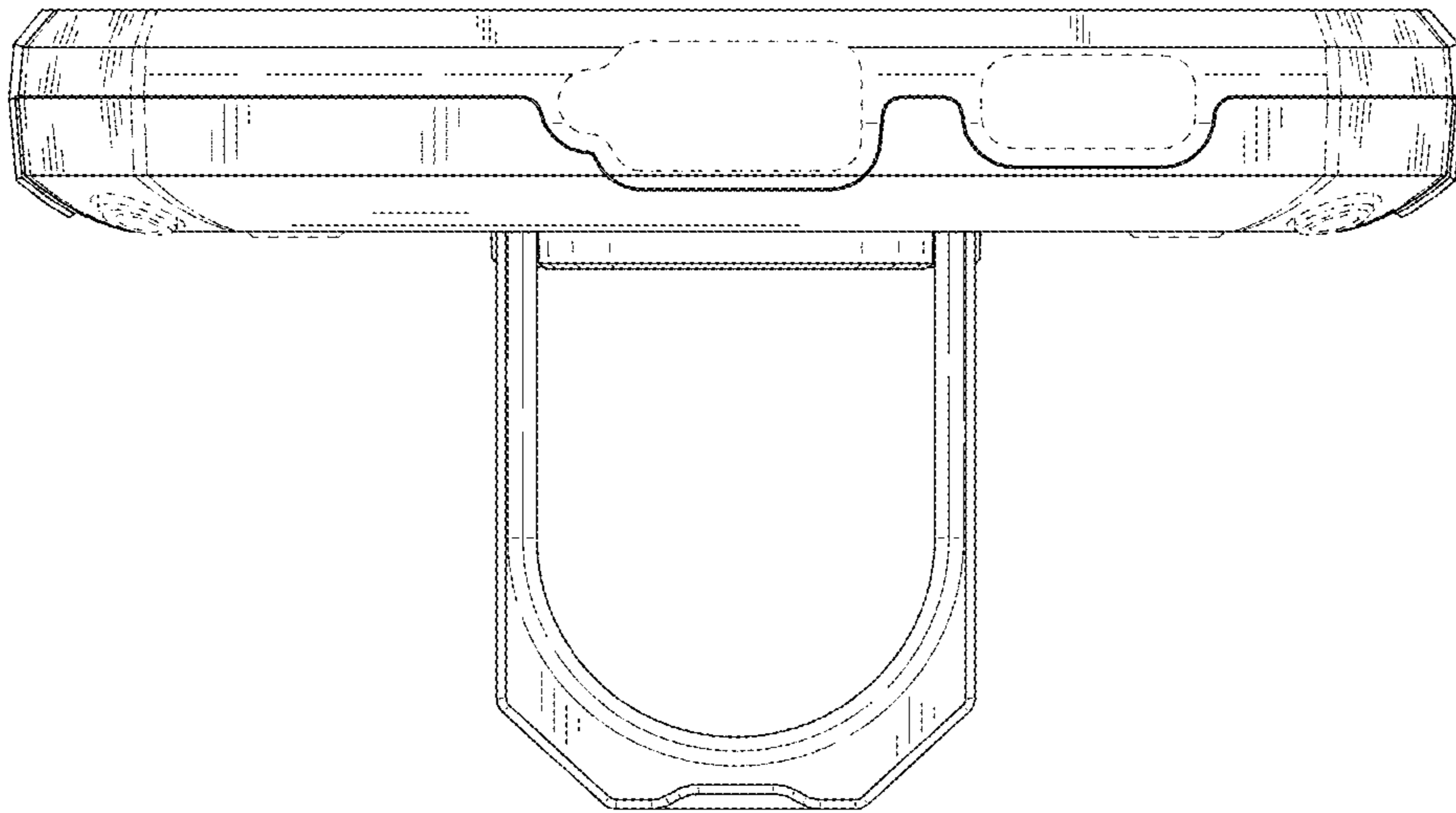

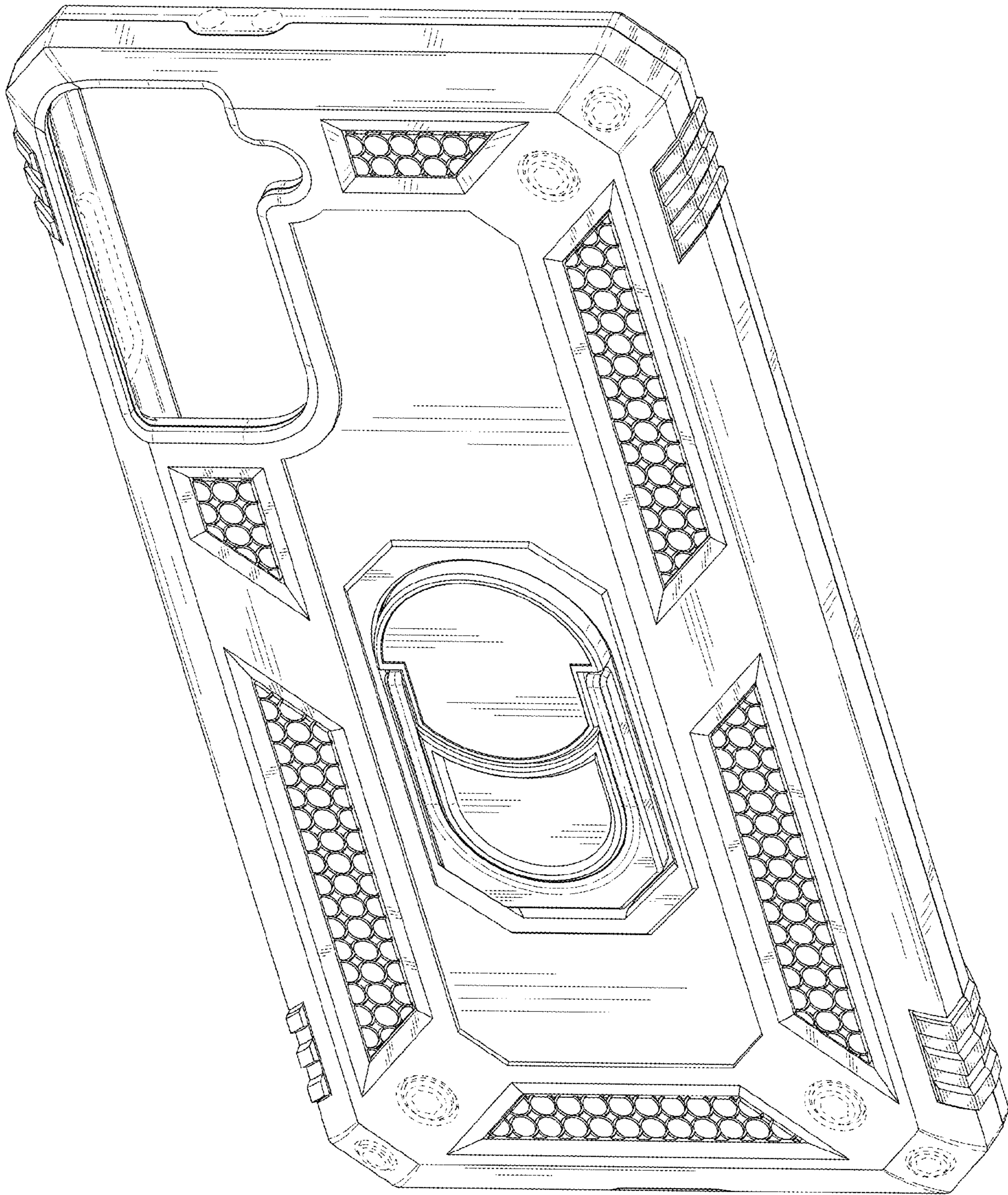

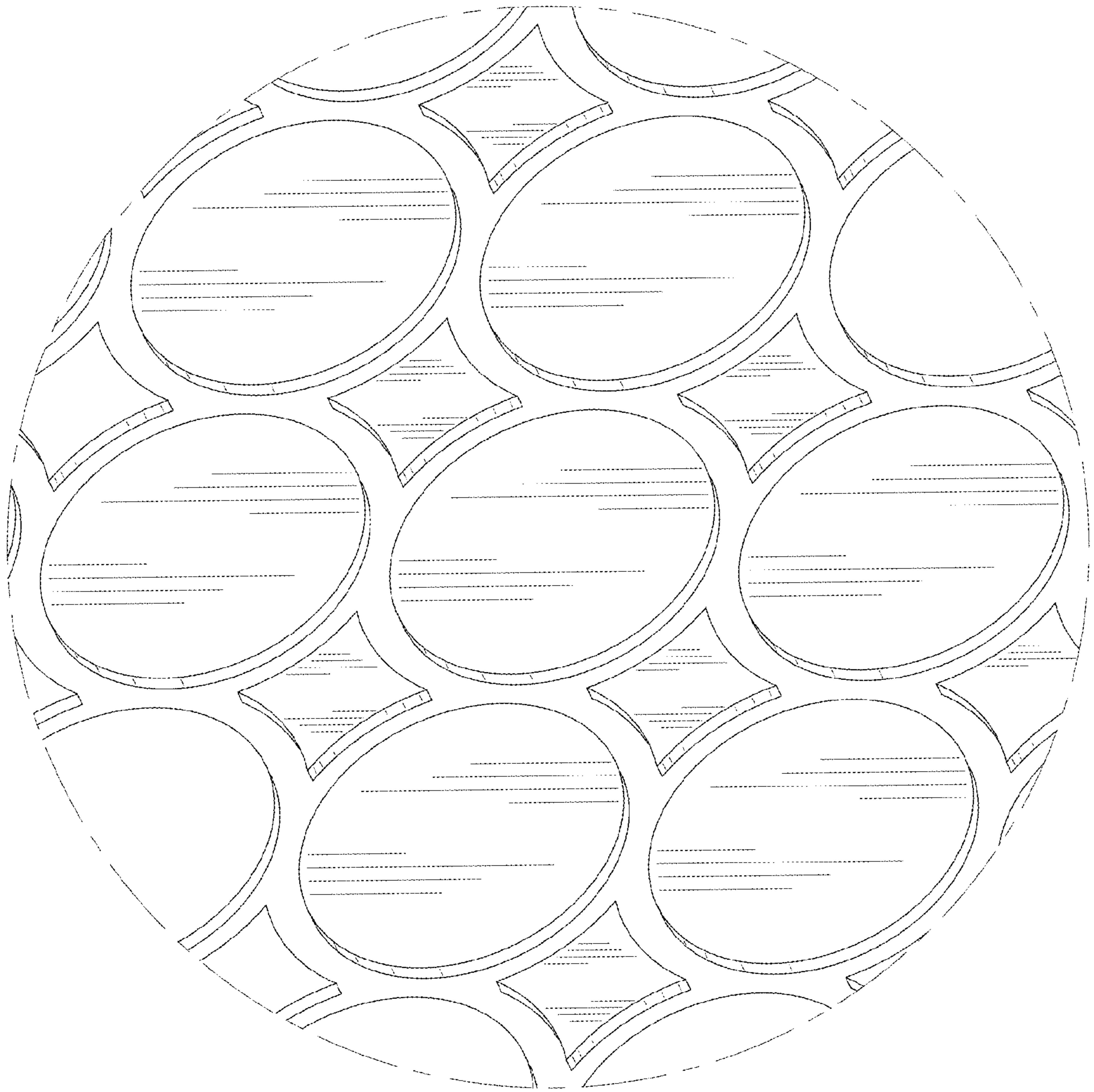
