The ornamental design for a display or portion thereof with graphical user interface, as shown and described.

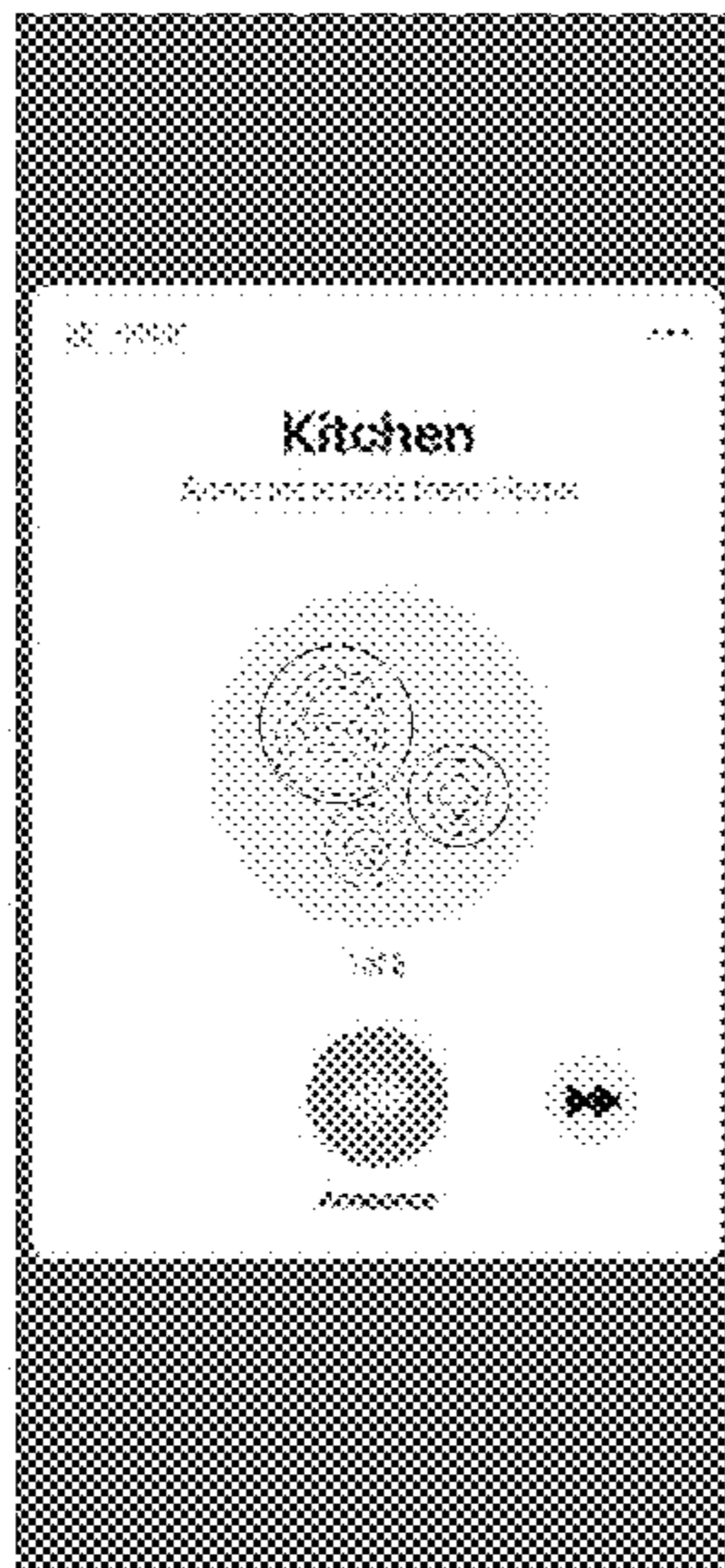
**DESCRIPTION**
