**DESCRIPTION**

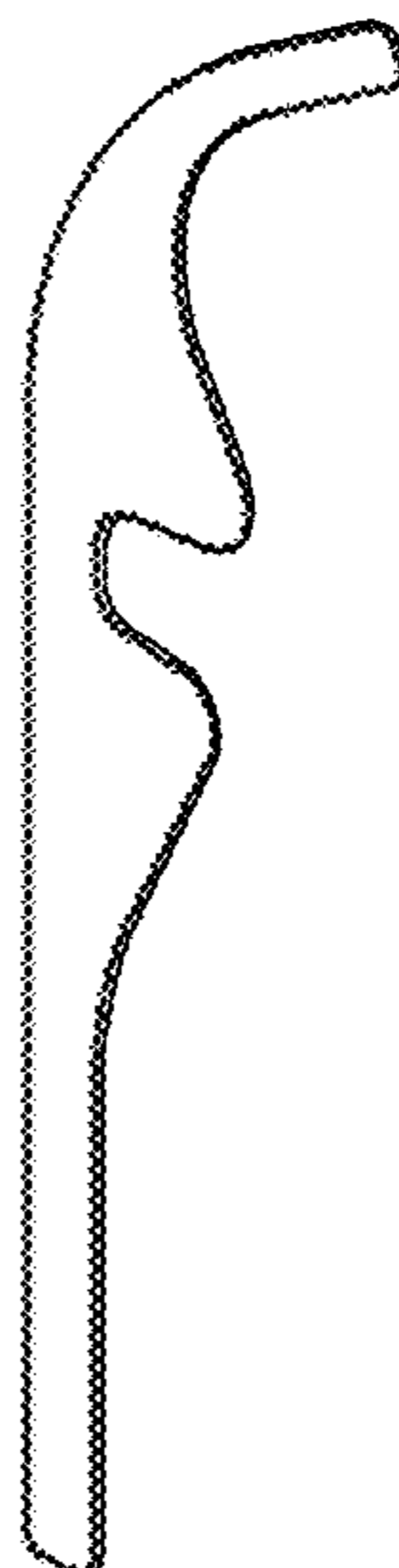
FIG. 1 is a perspective view of the claimed design in accordance with one aspect of the disclosure.

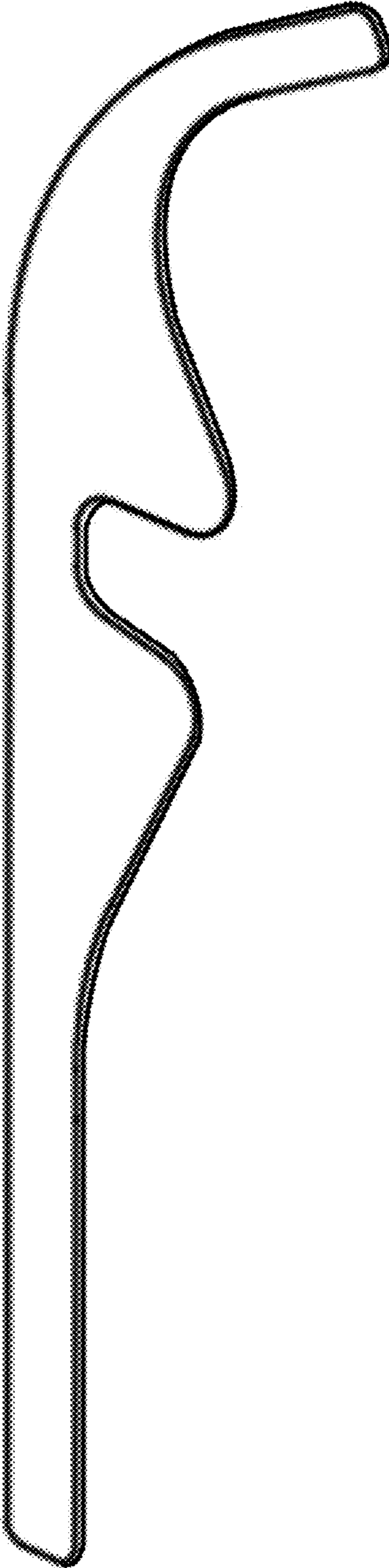
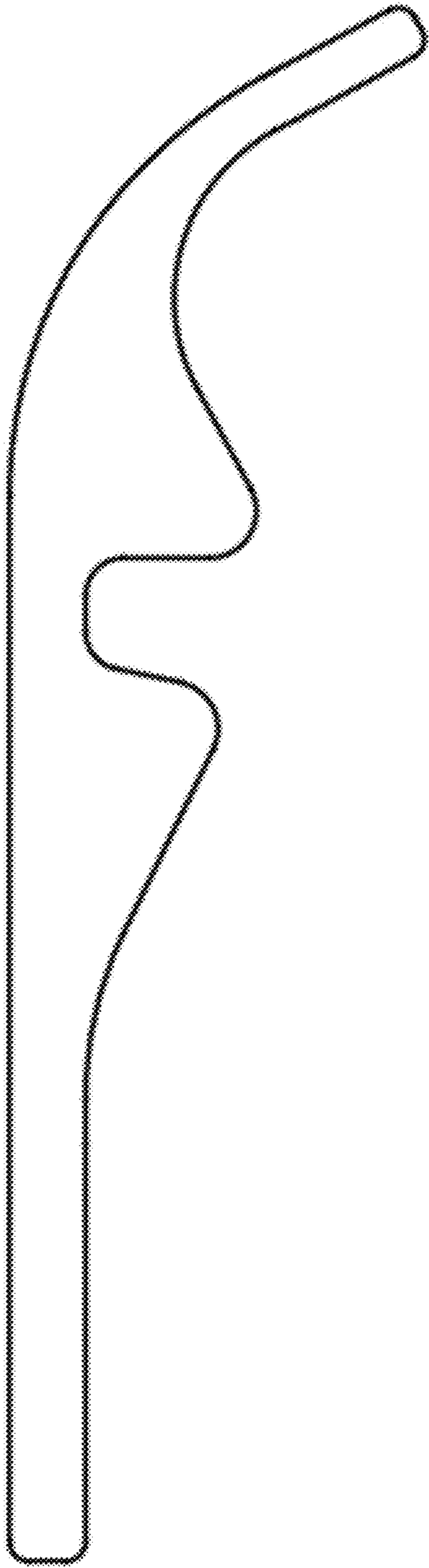
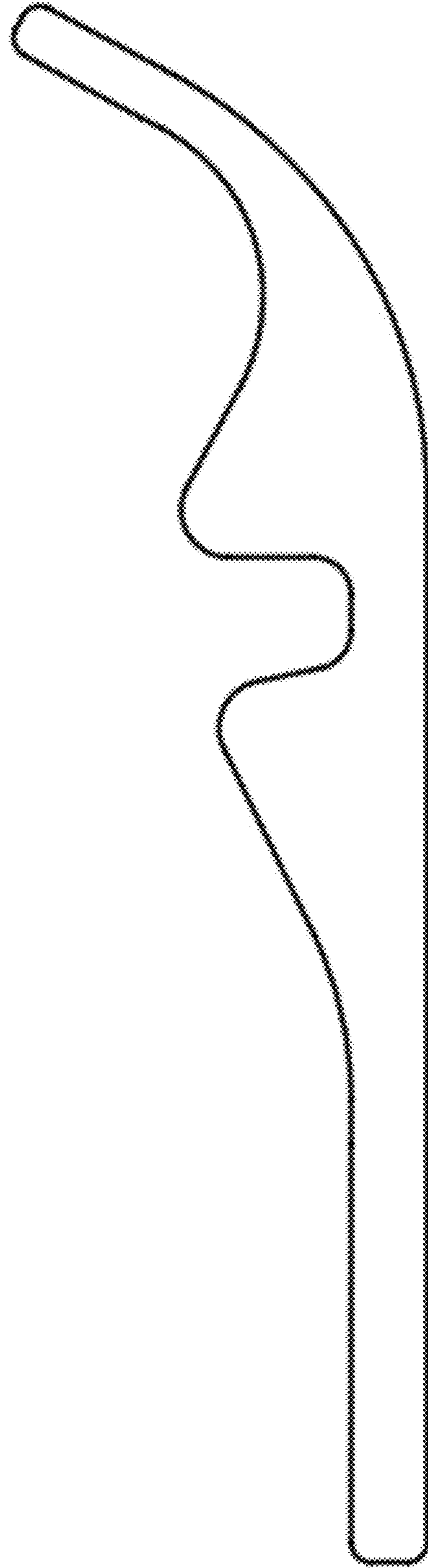

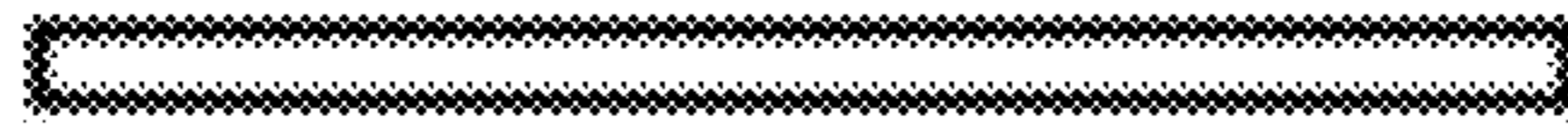
