DESCRIPTION

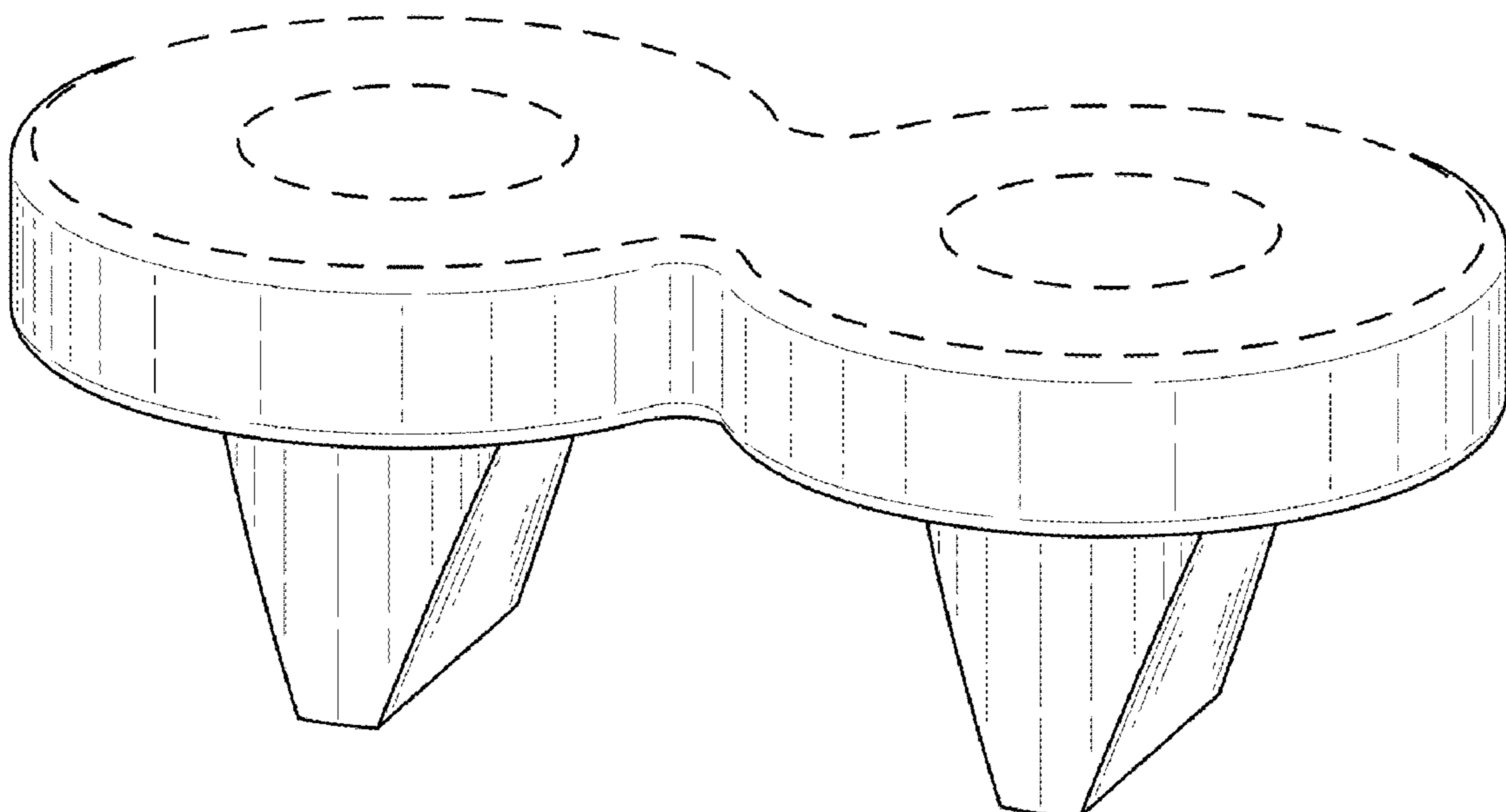
FIG. 1 is a top, front, left perspective view of a valve showing my new design;

FIG. 7 is a top view thereof; and,

The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the valve show features that form no part of the claimed design.

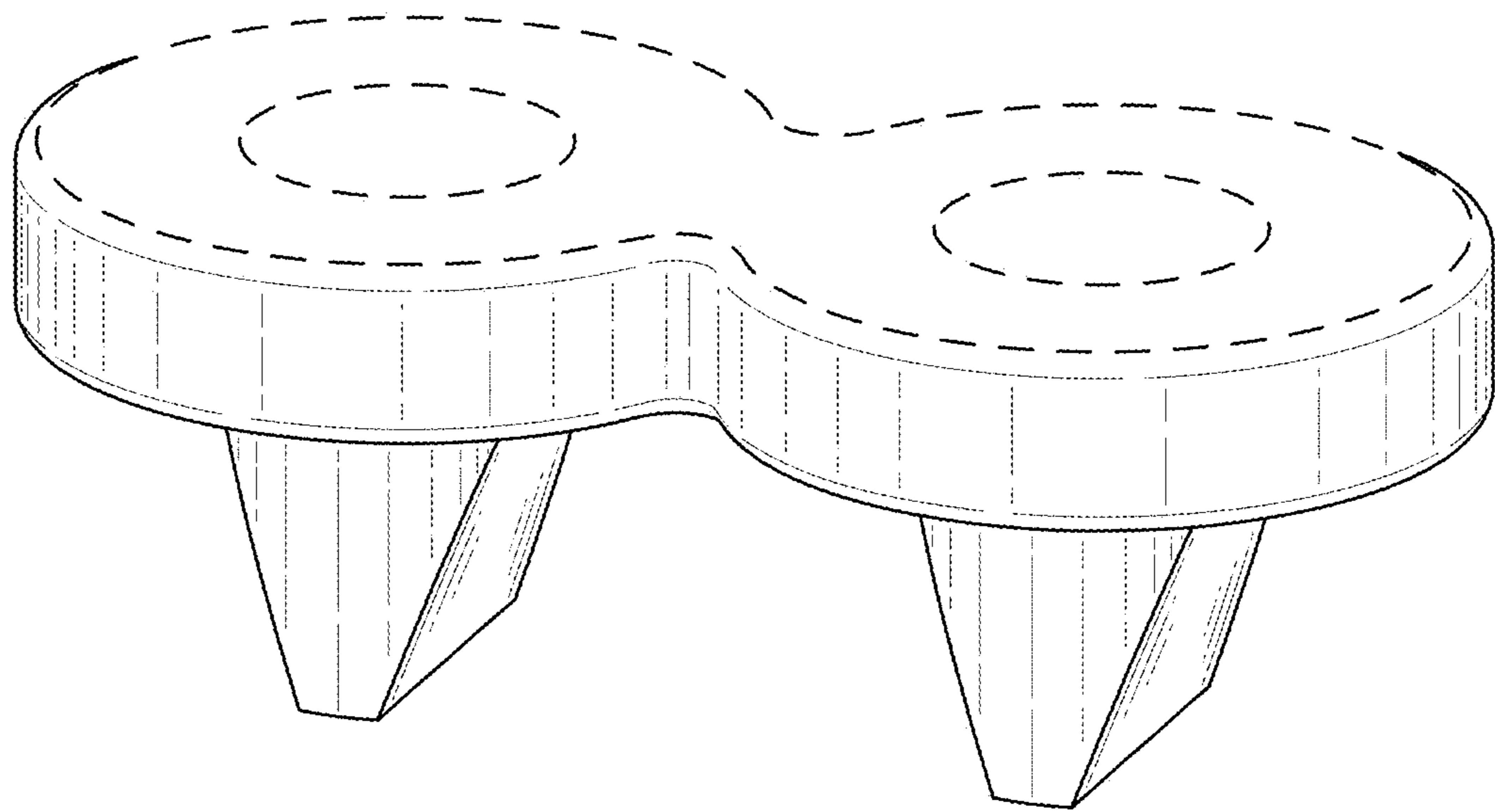

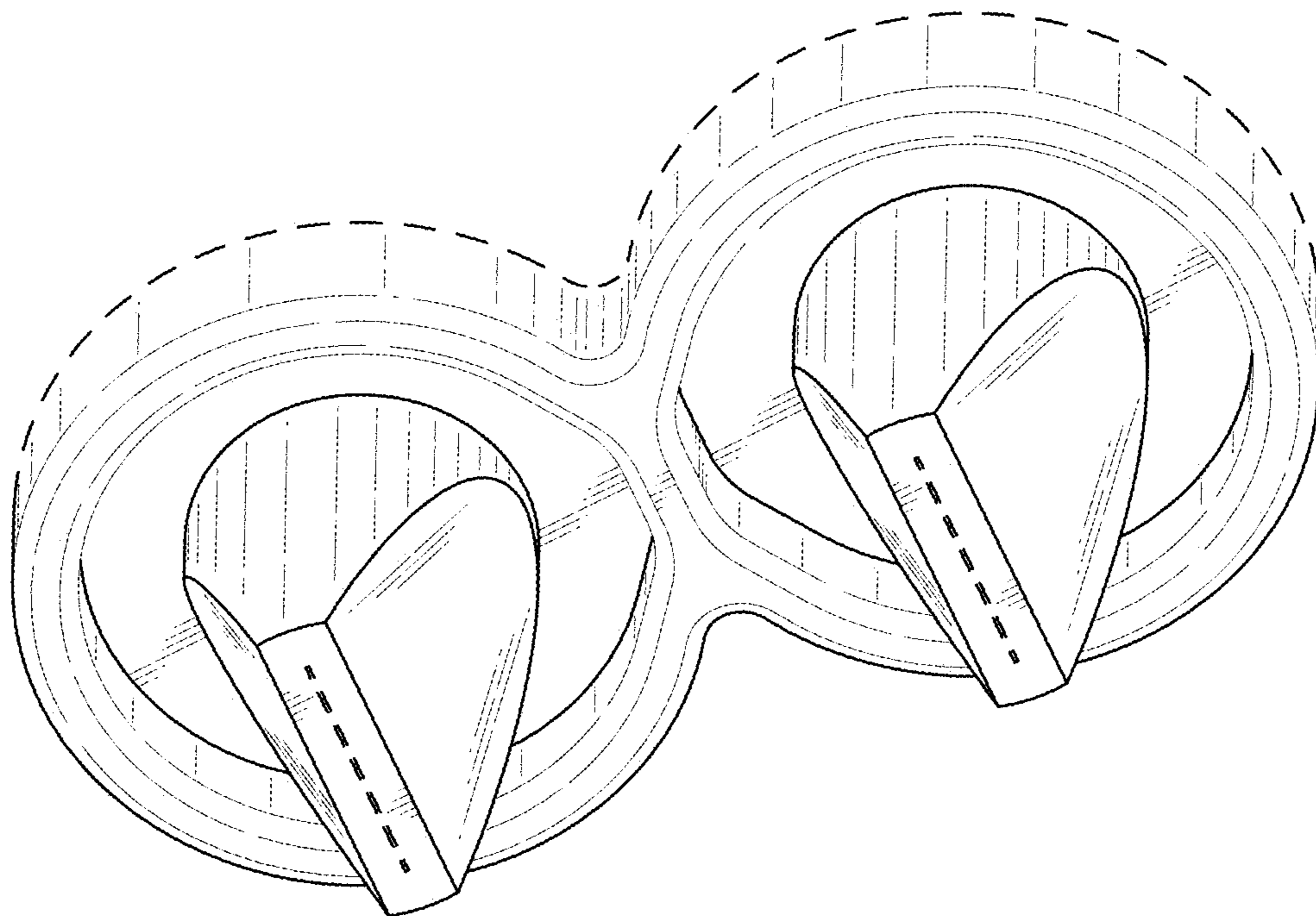

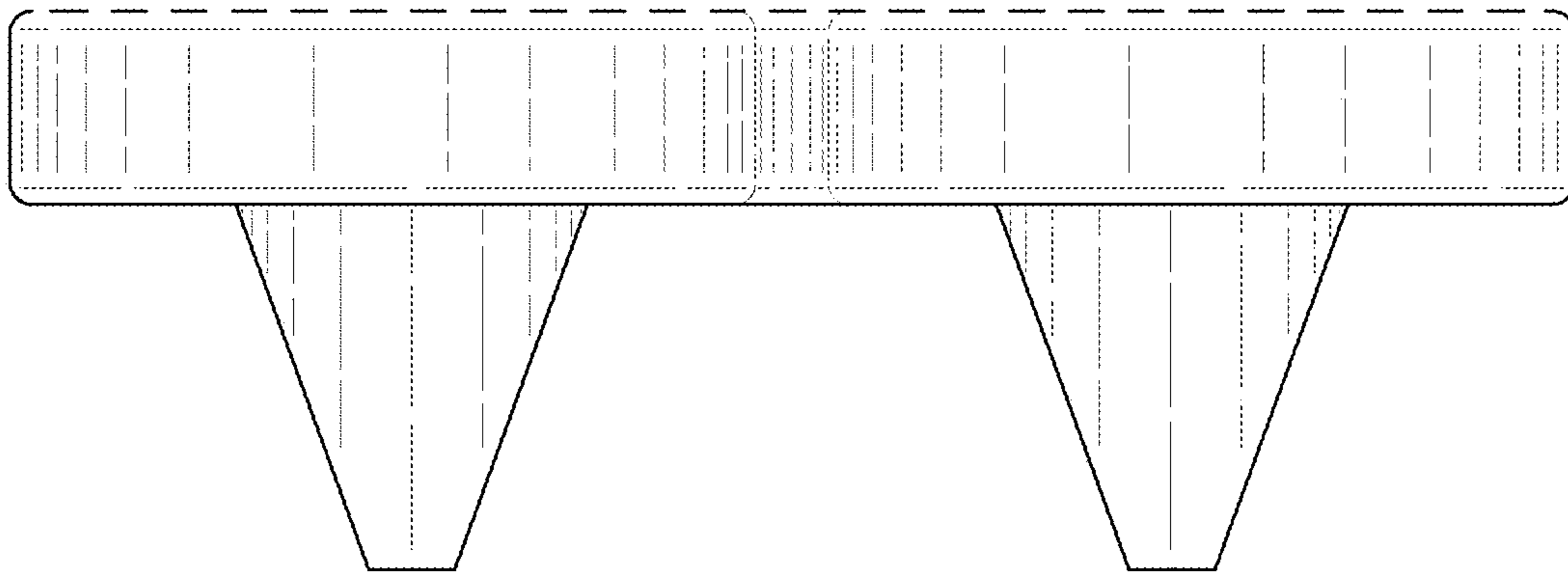

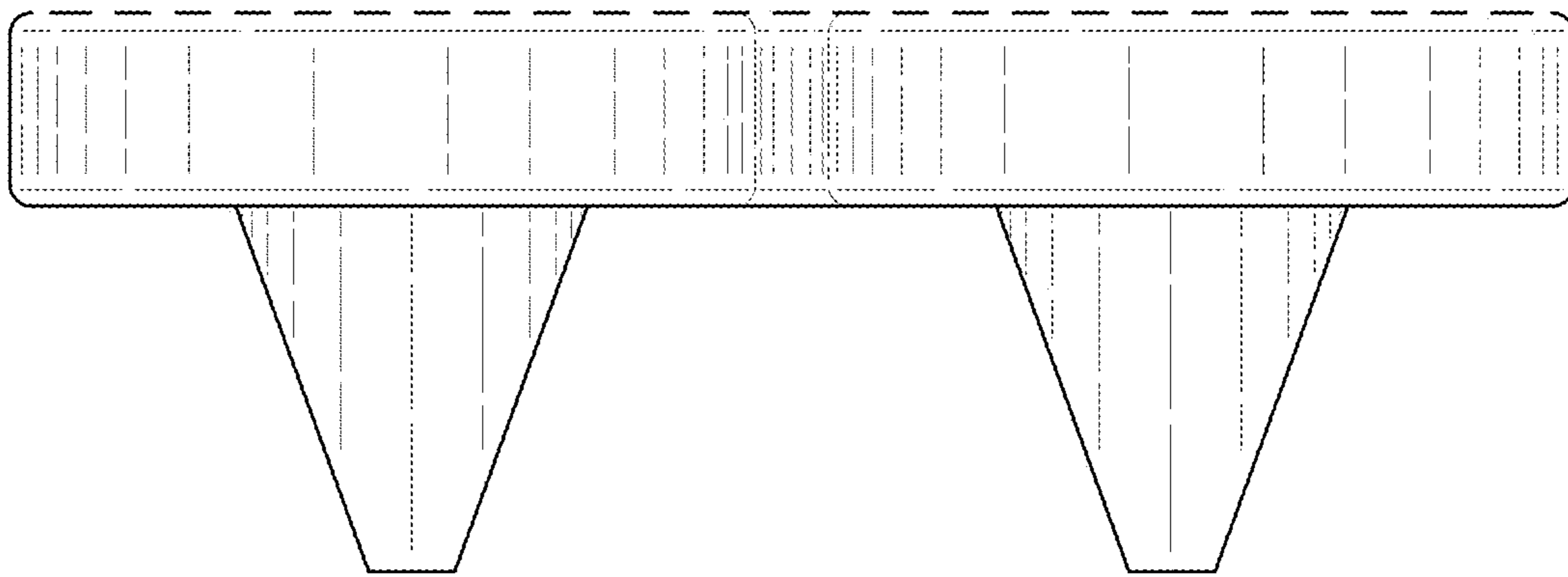

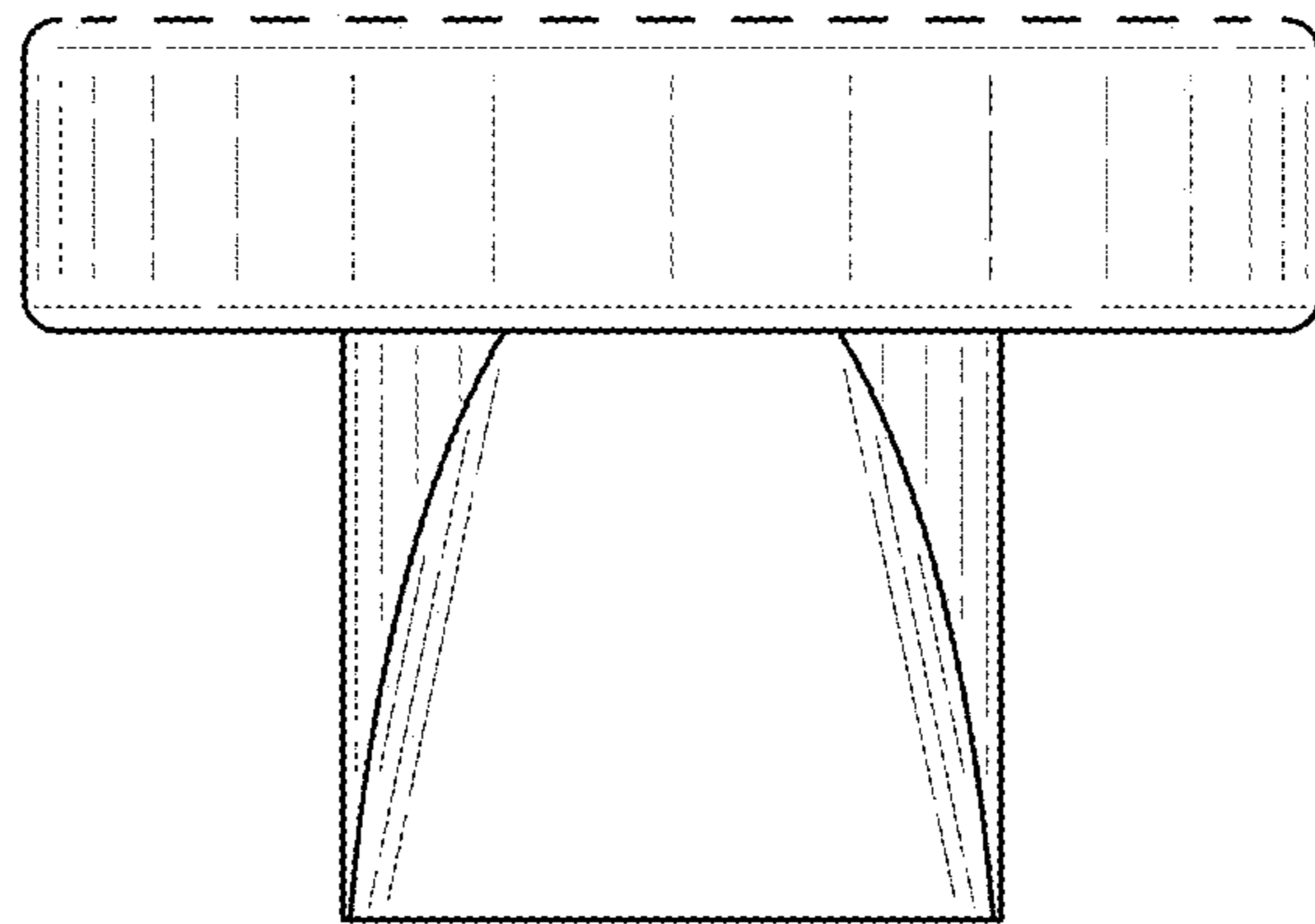

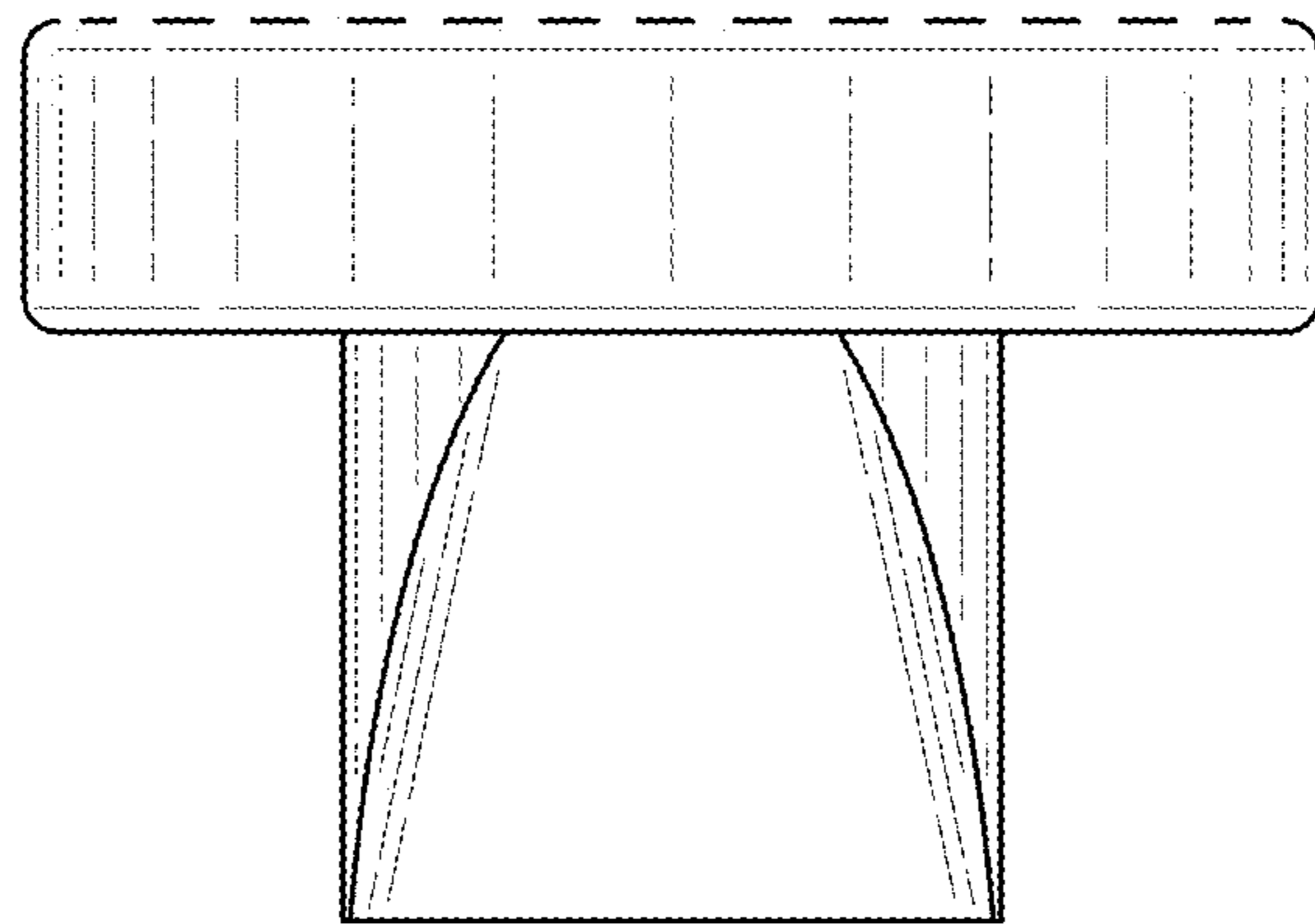

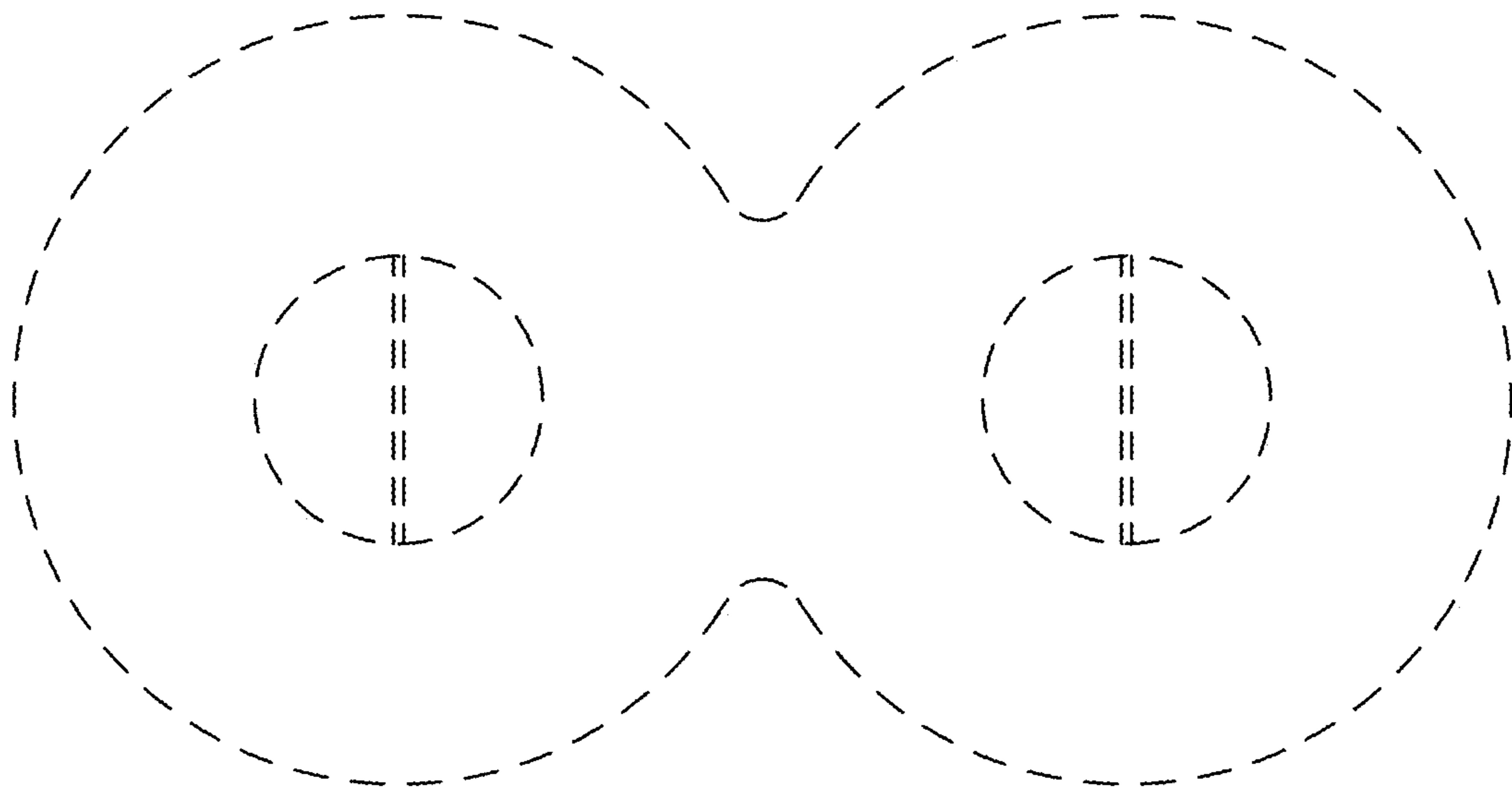

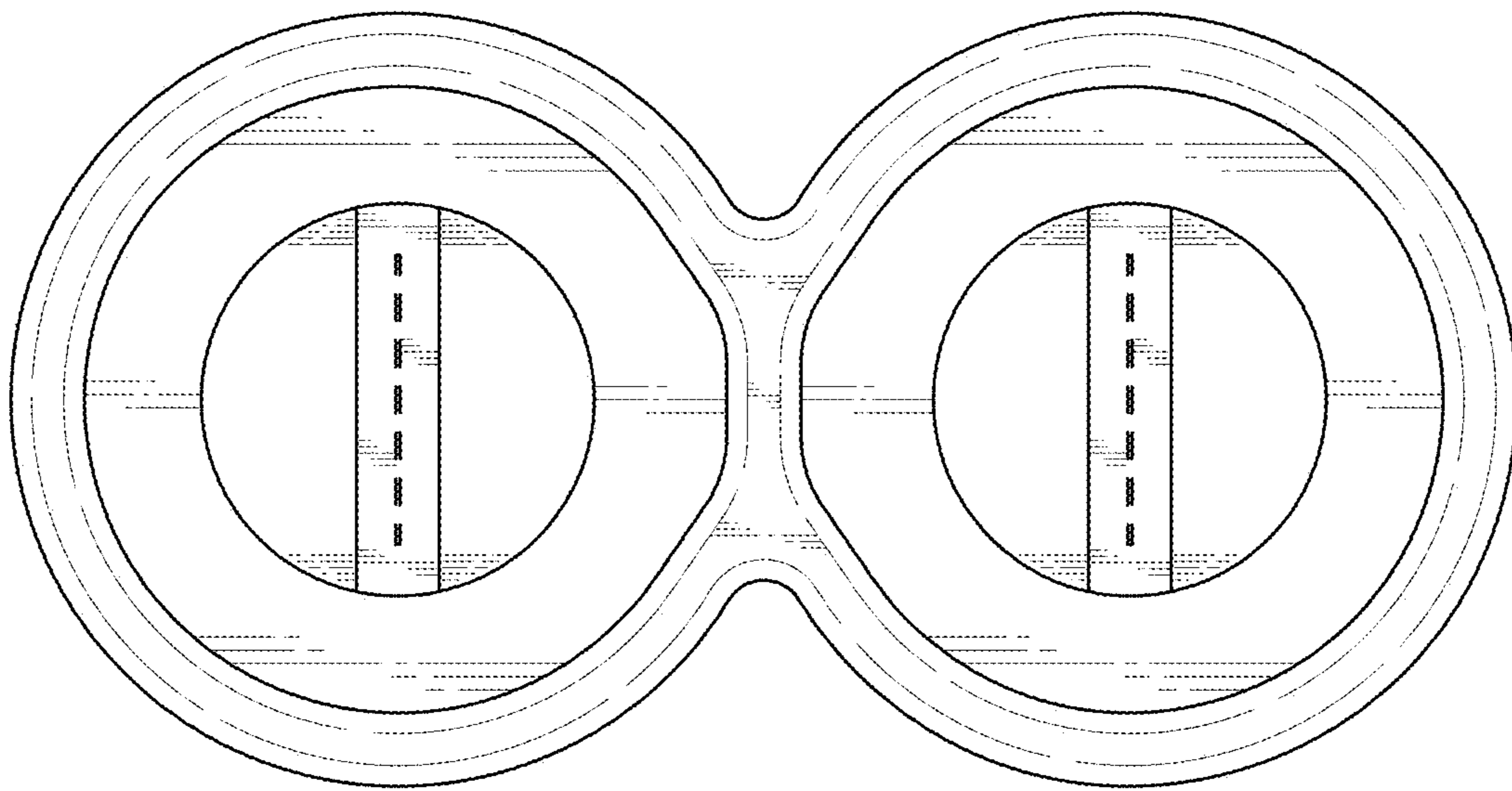
