(57) **CLAIM**

The ornamental design for a face mask, as shown and described.

DESCRIPTION

The application is related to U.S. patent application Ser. No. 29/745,891, entitled Face Mask, filed on Aug. 10, 2020, which is hereby incorporated by reference.

FIG. 1 is a front view of a design for a face mask in a first configuration;

FIG. 2 is a back view of the design for a face mask in the first configuration;

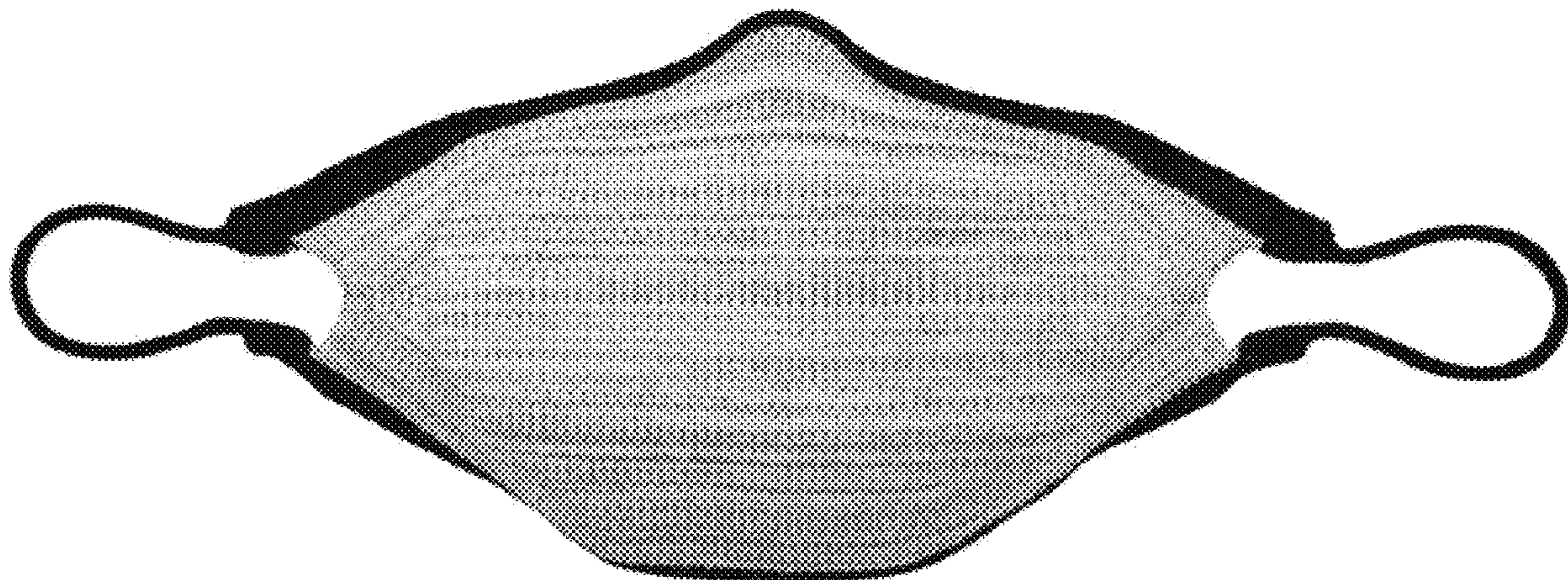
FIG. 3 is a front view of the design for a face mask in a second configuration;

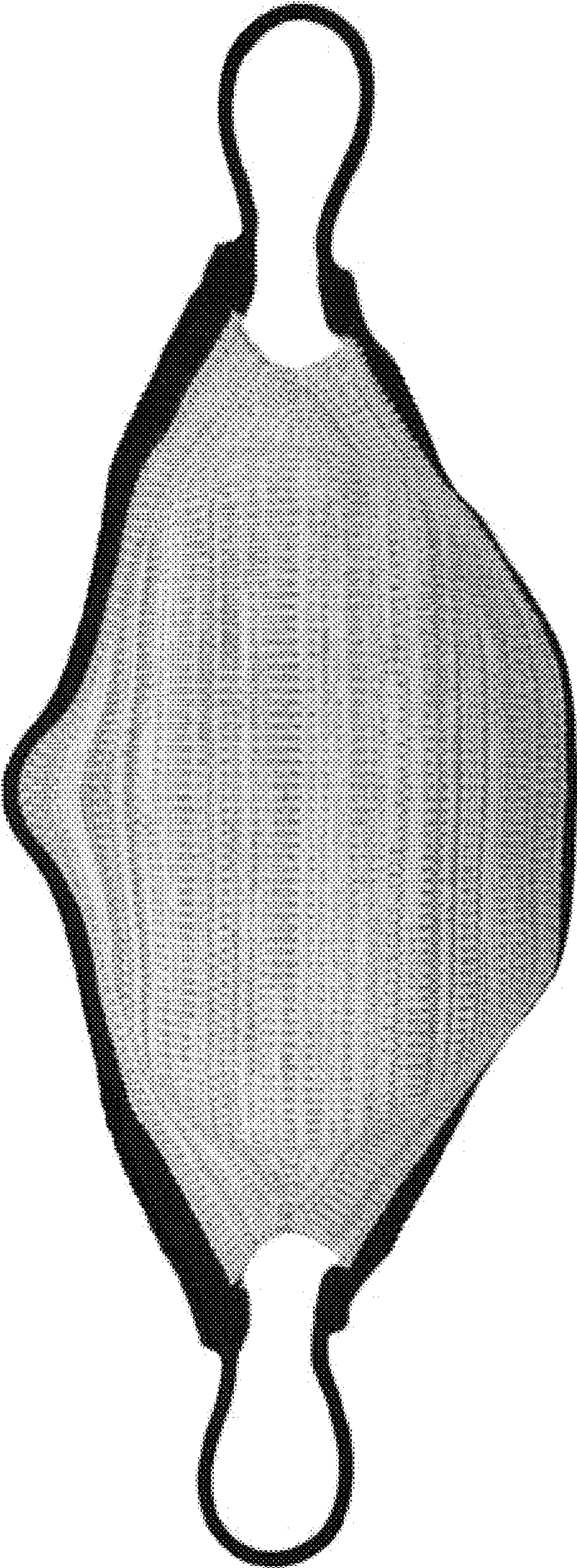

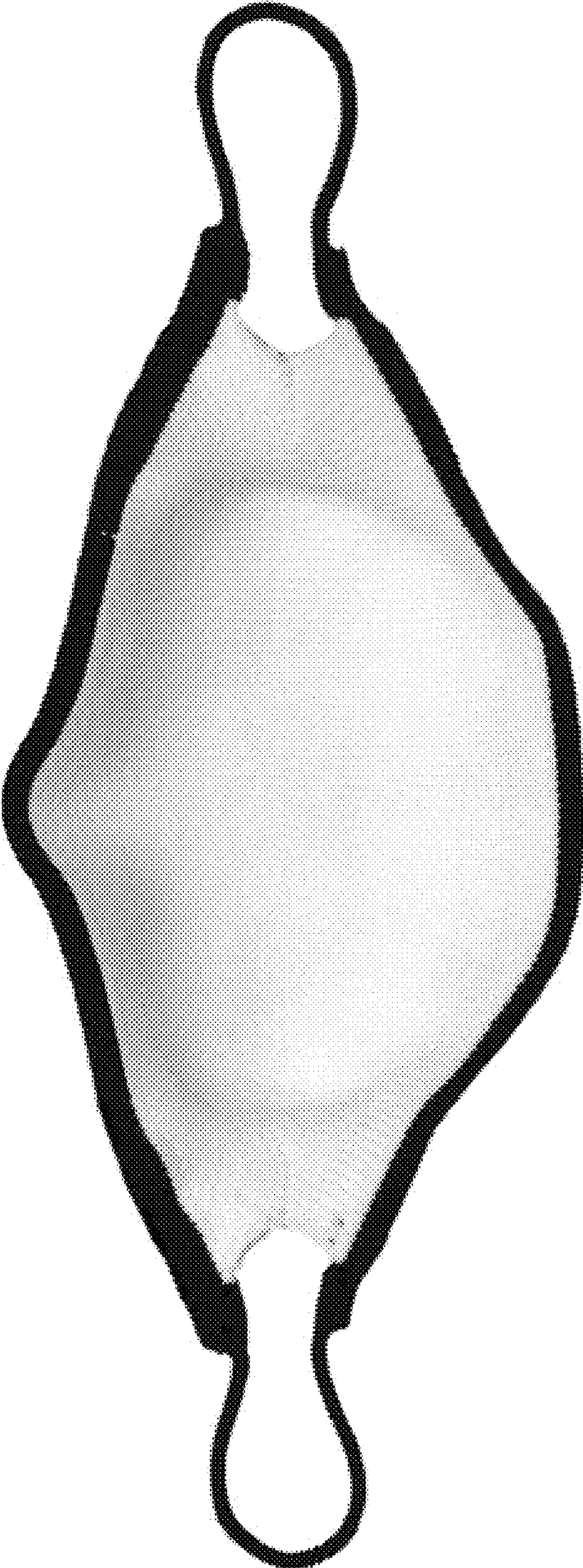

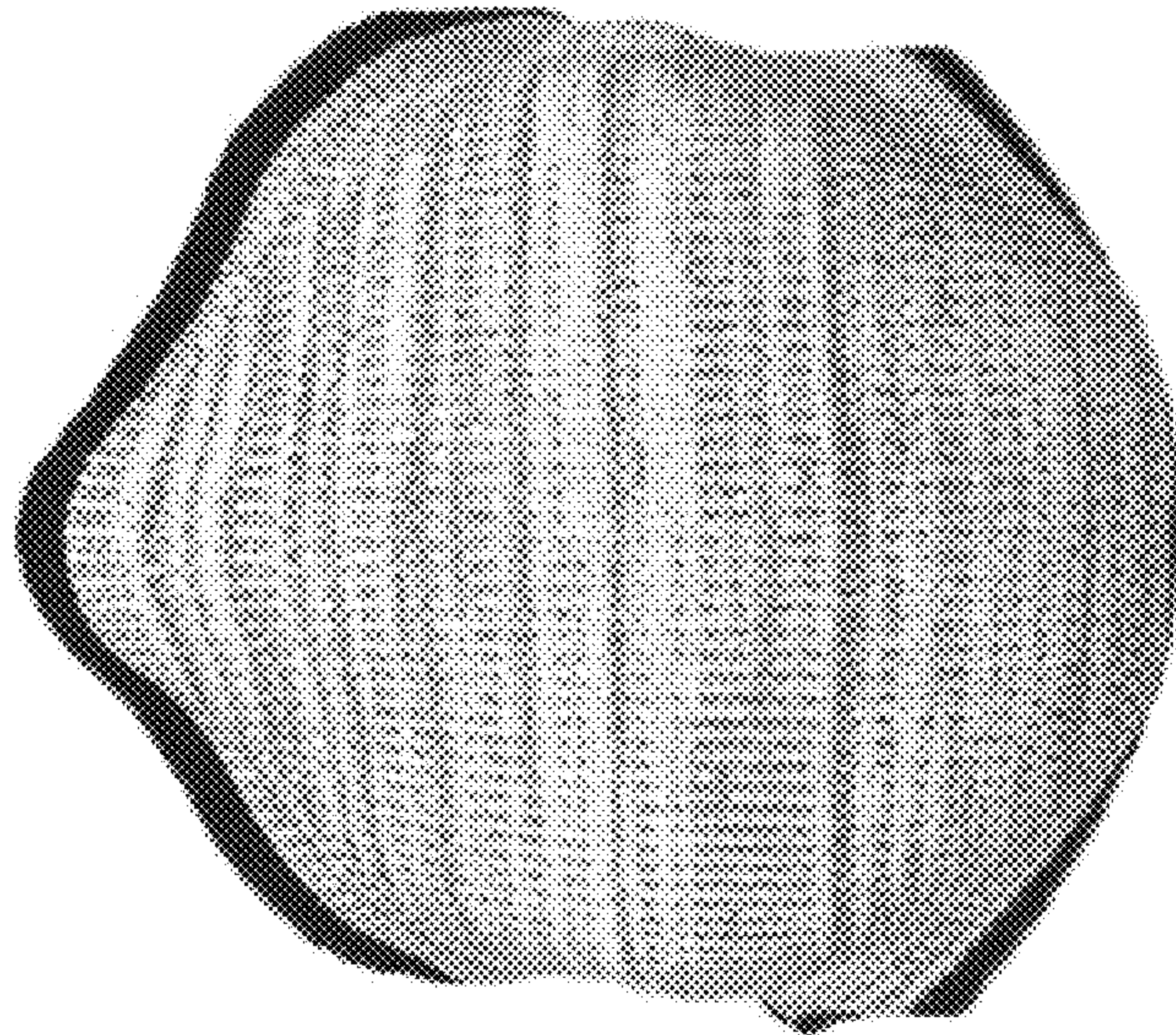

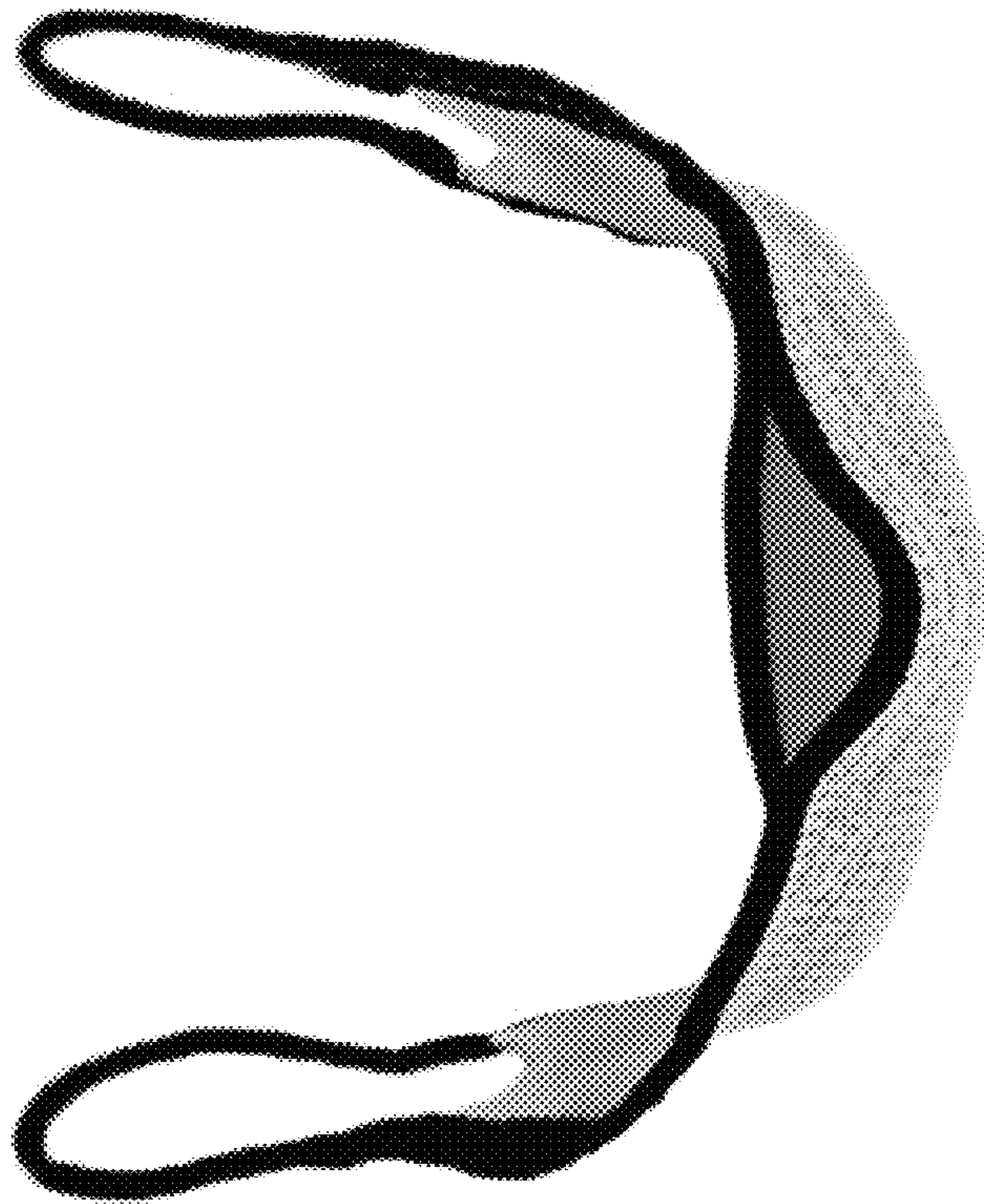

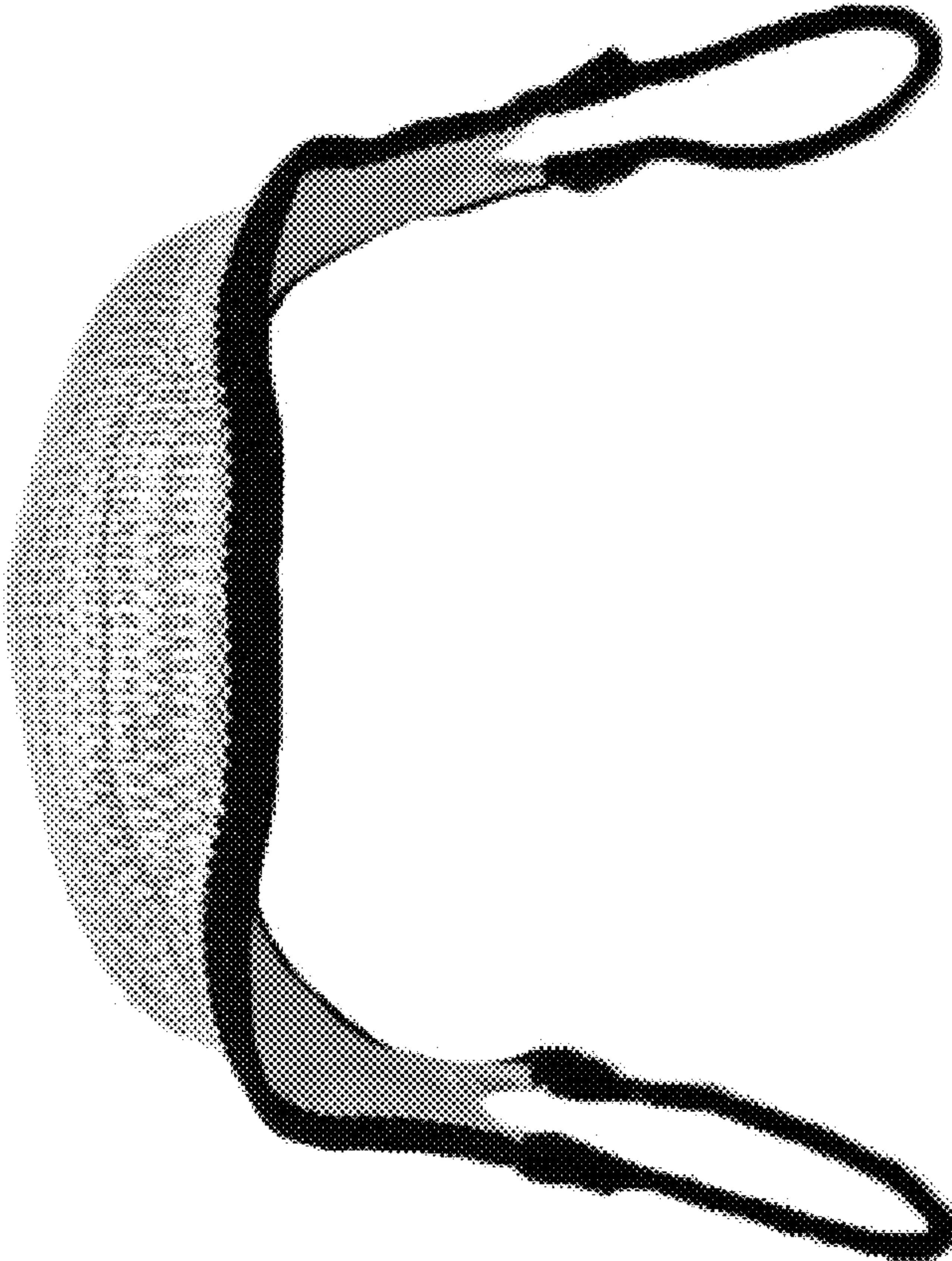

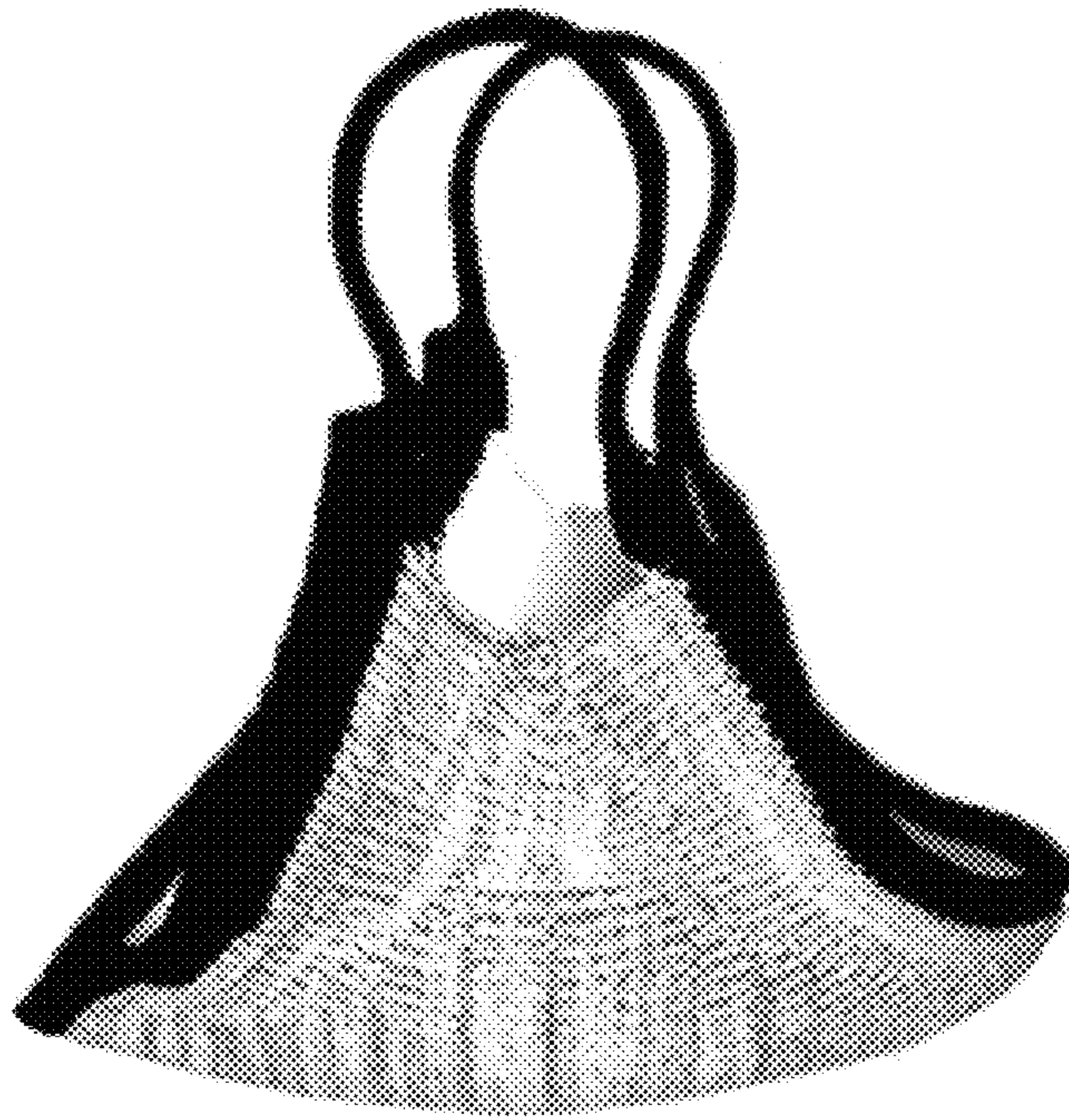
