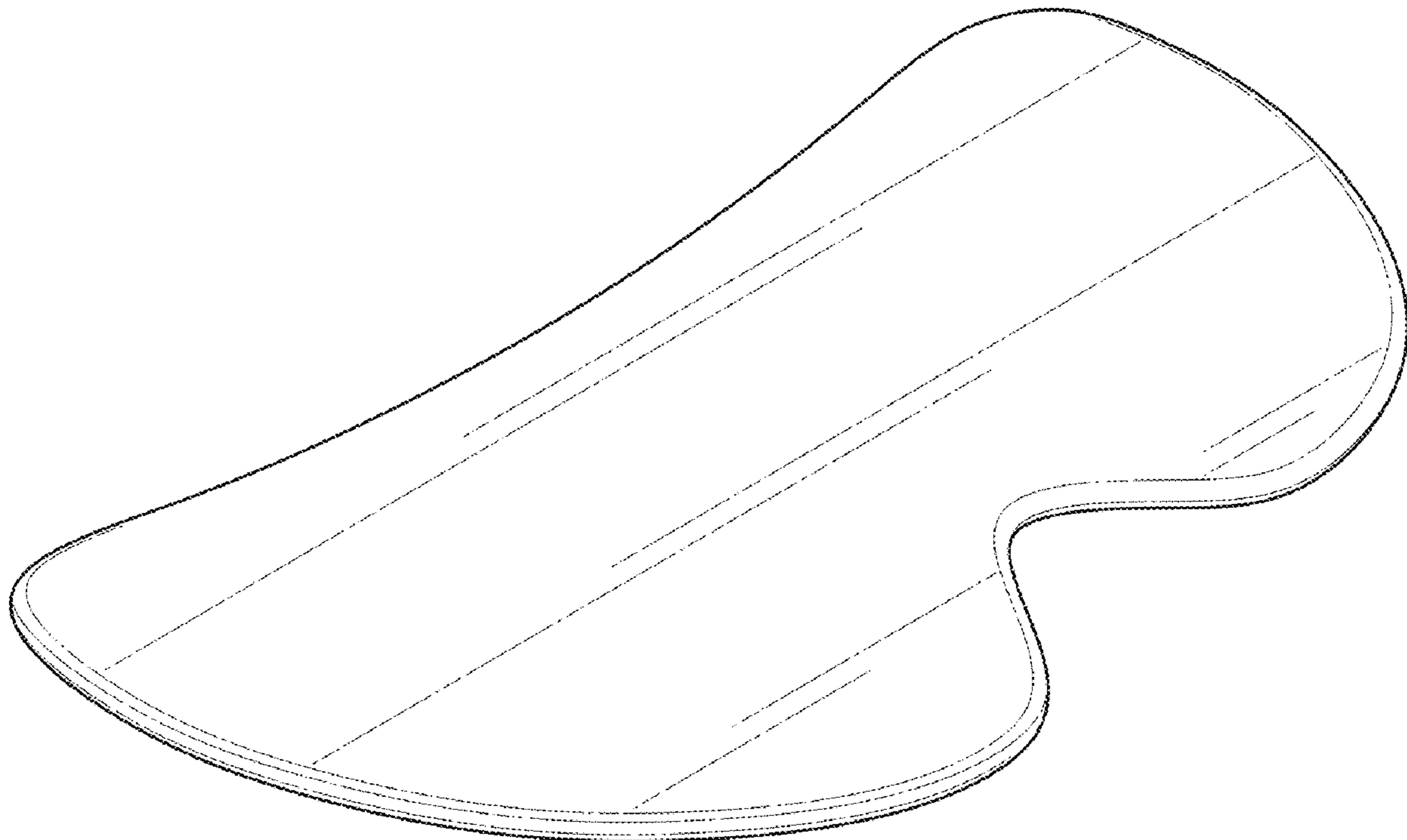
The ornamental design for a letter B shaped gua sha plate, as shown and described.

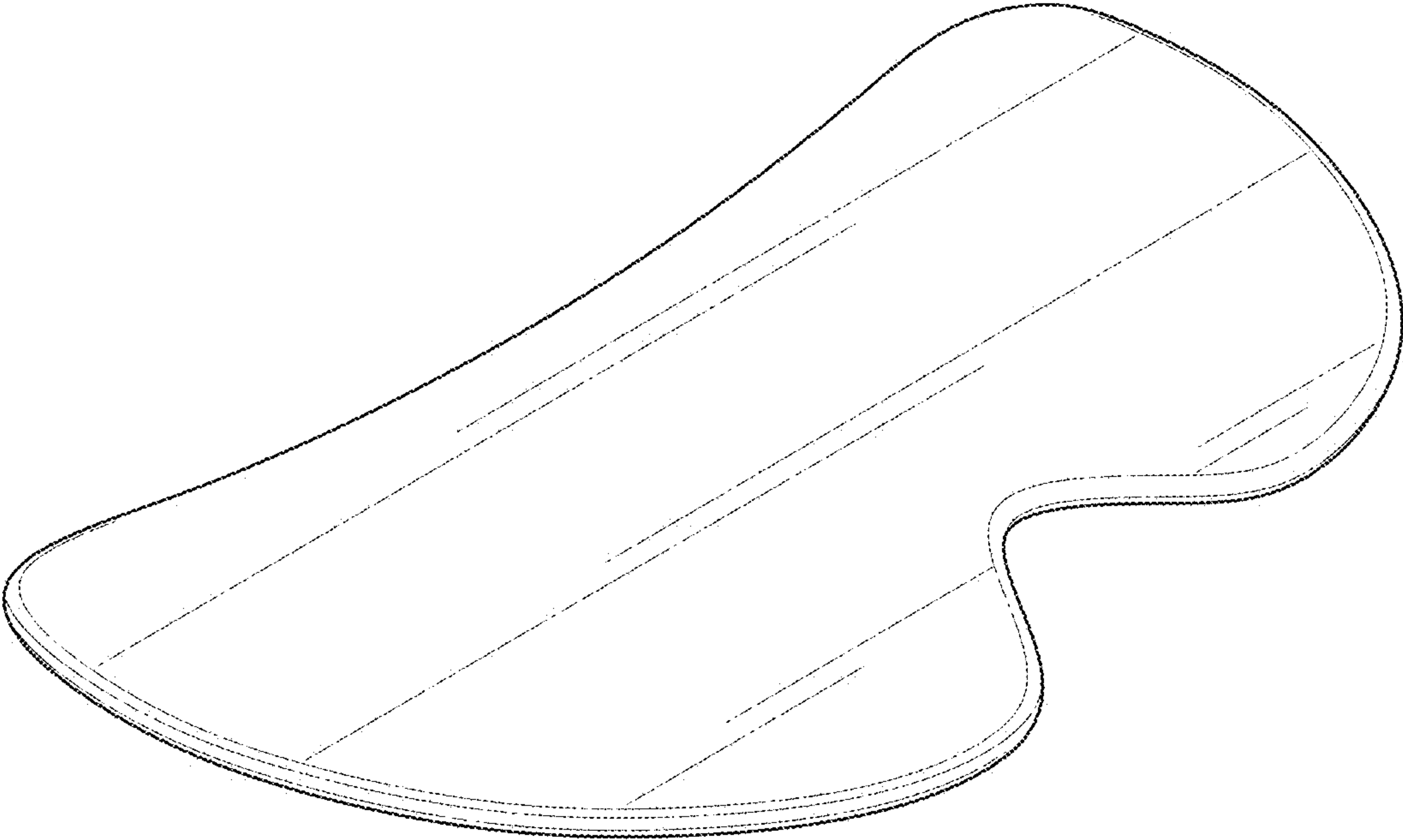

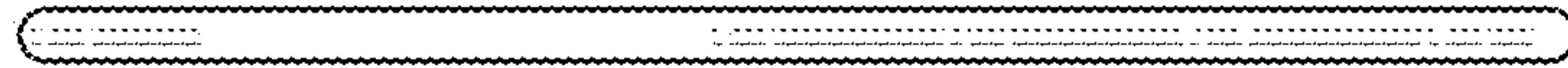

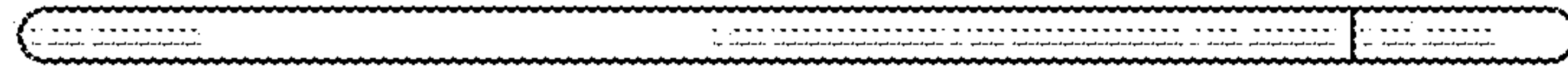

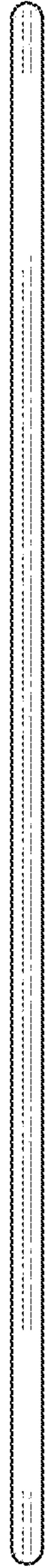

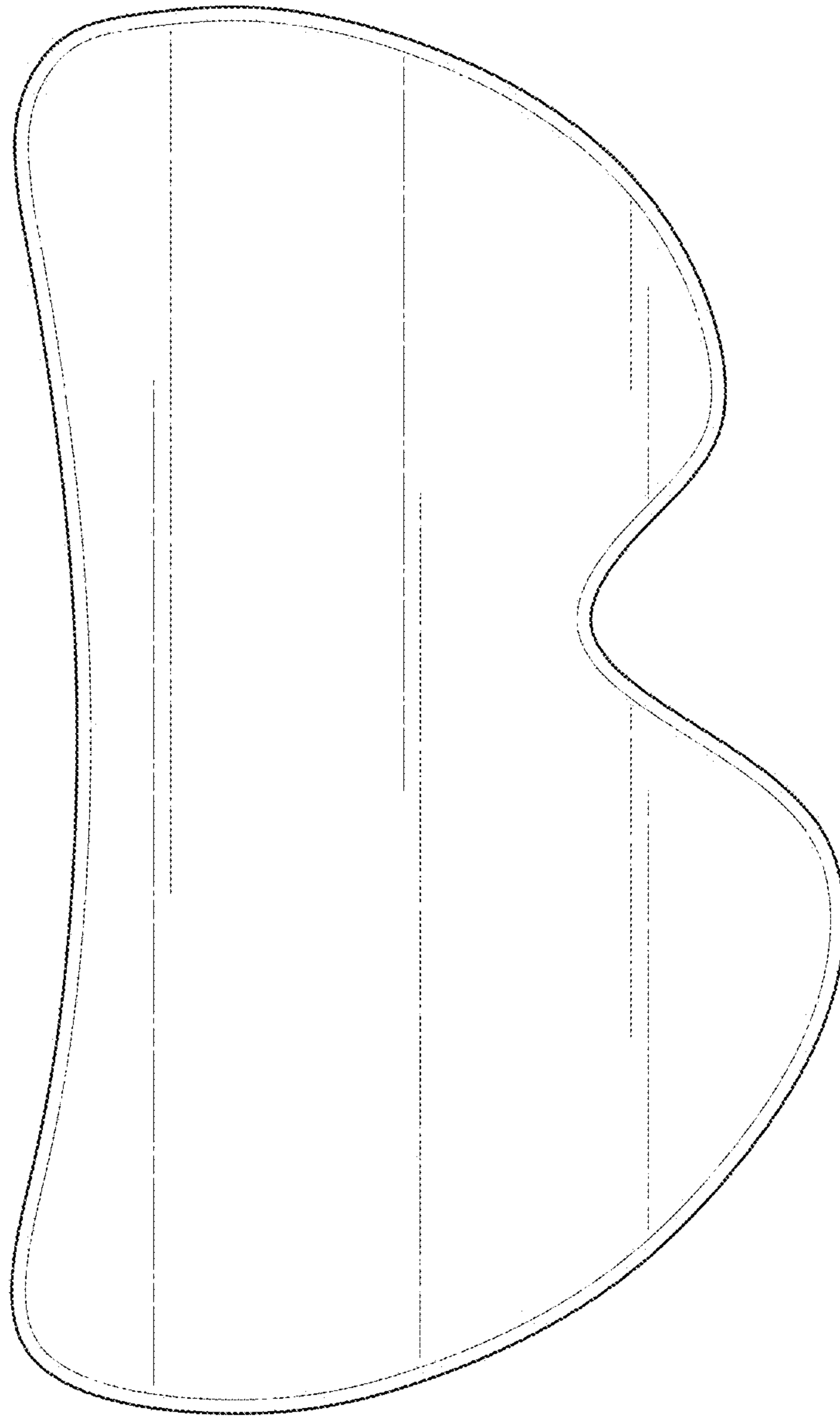

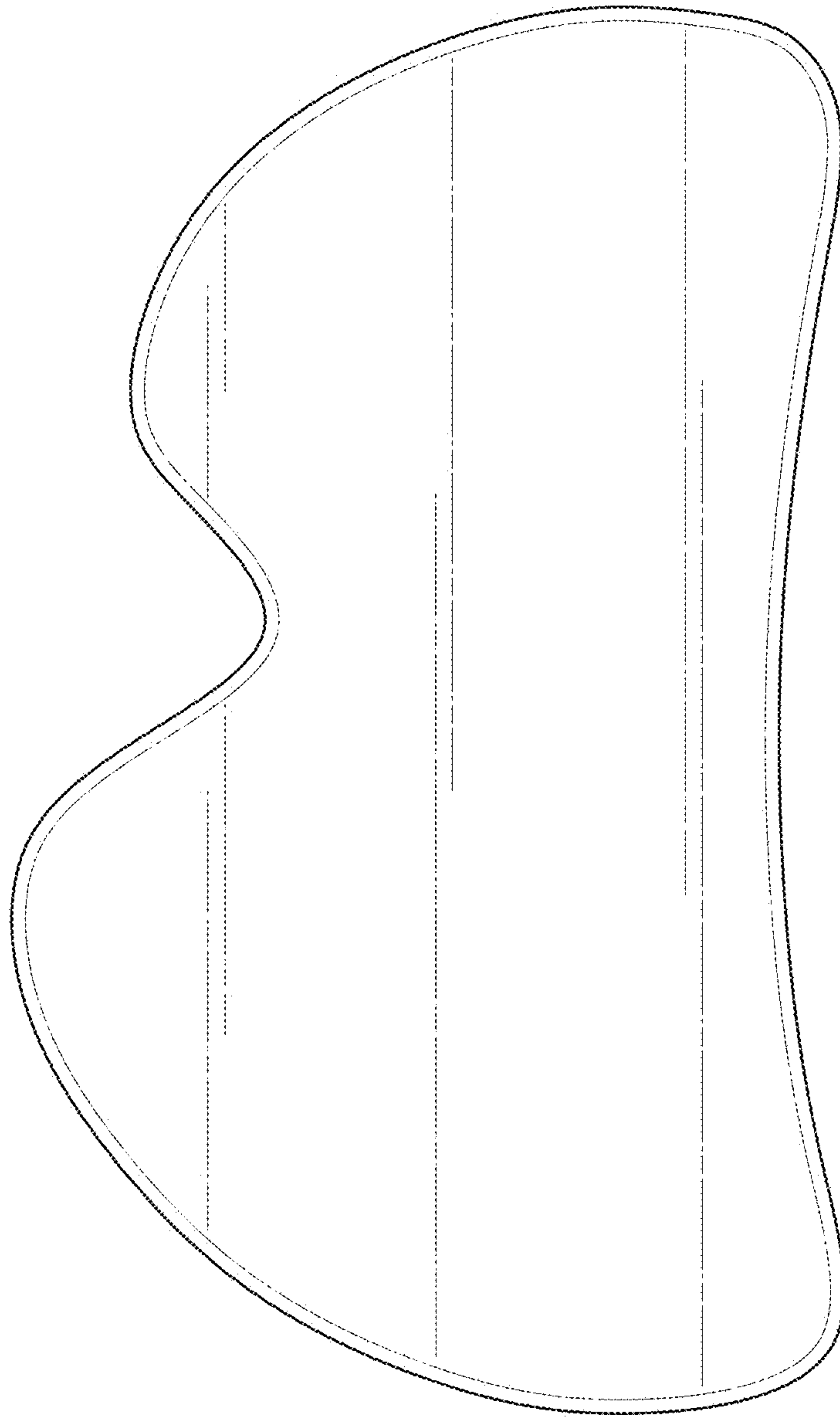
