FIG. 1.4 is side elevation view thereof;

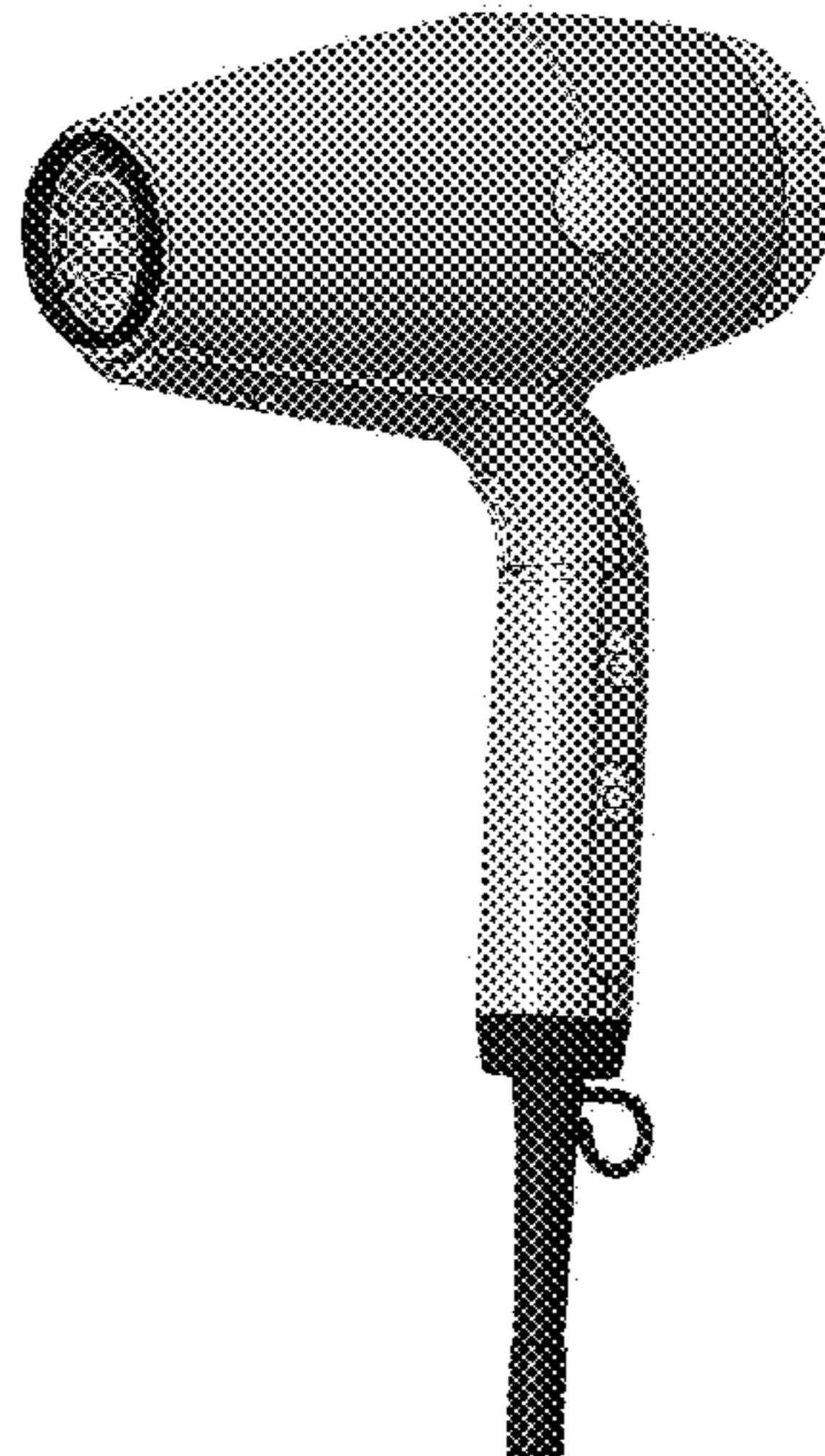
FIG. 1.5 is another side elevation view thereof;

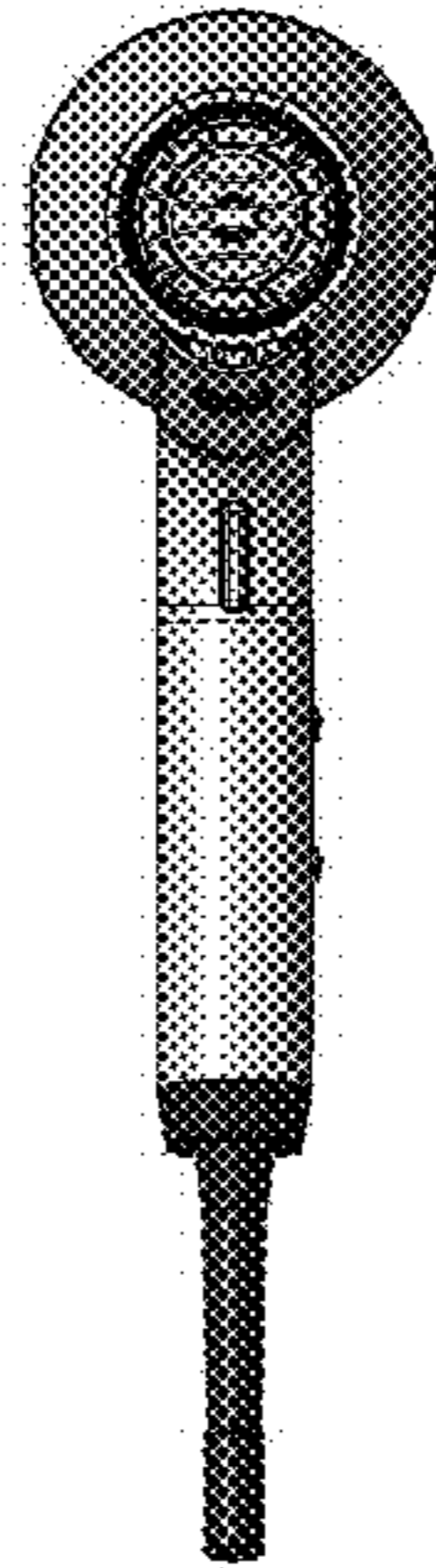

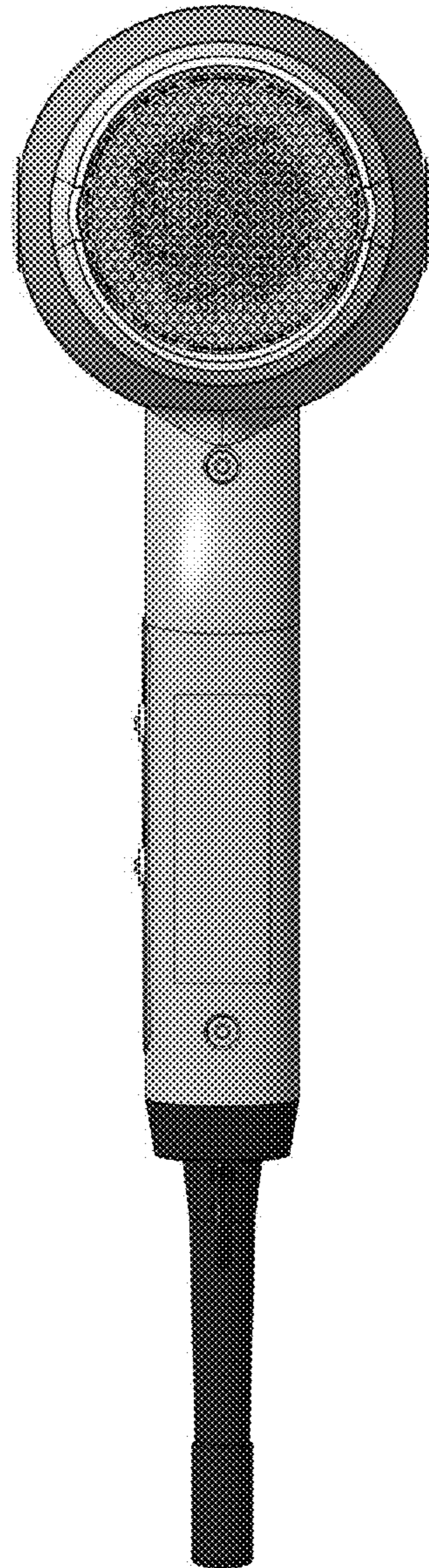

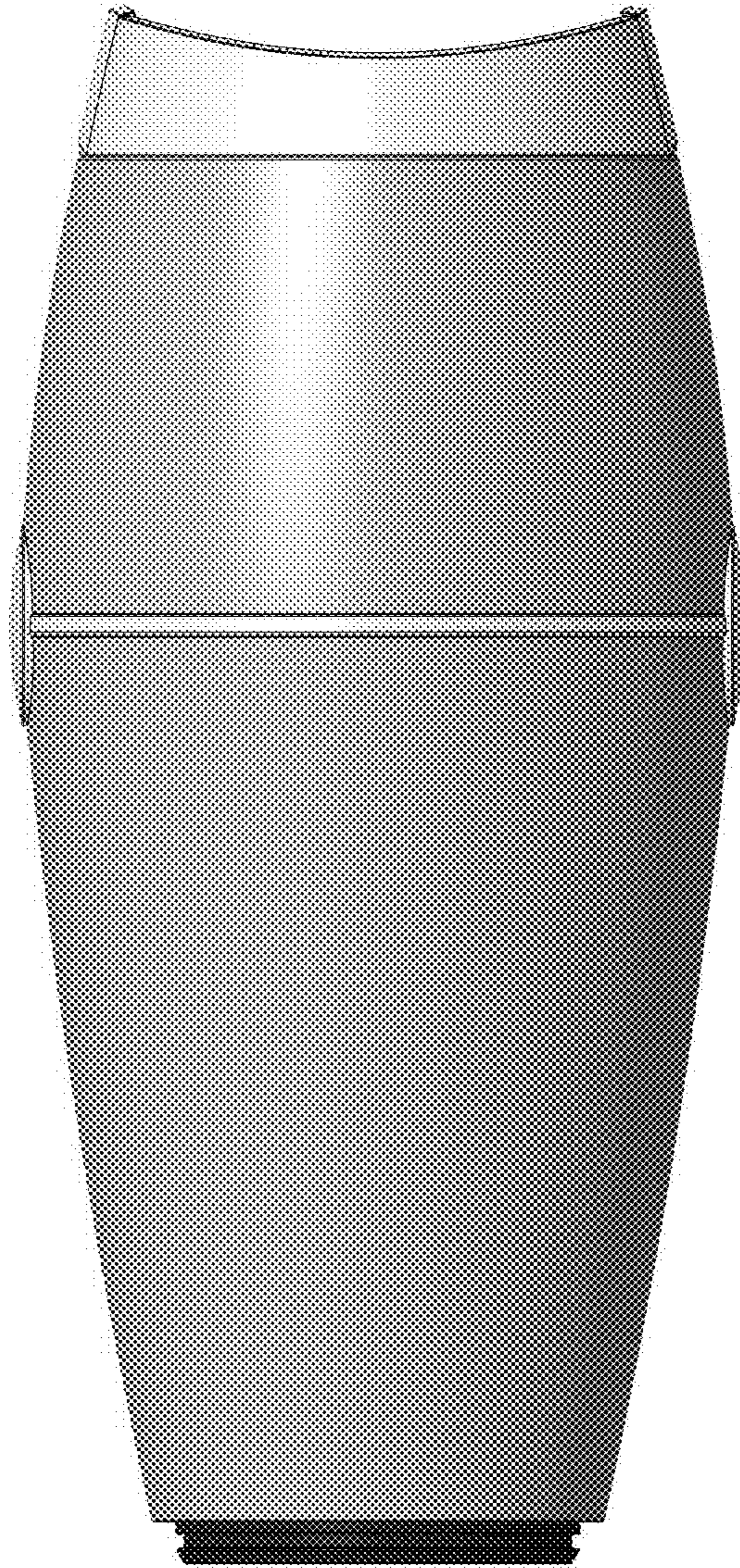

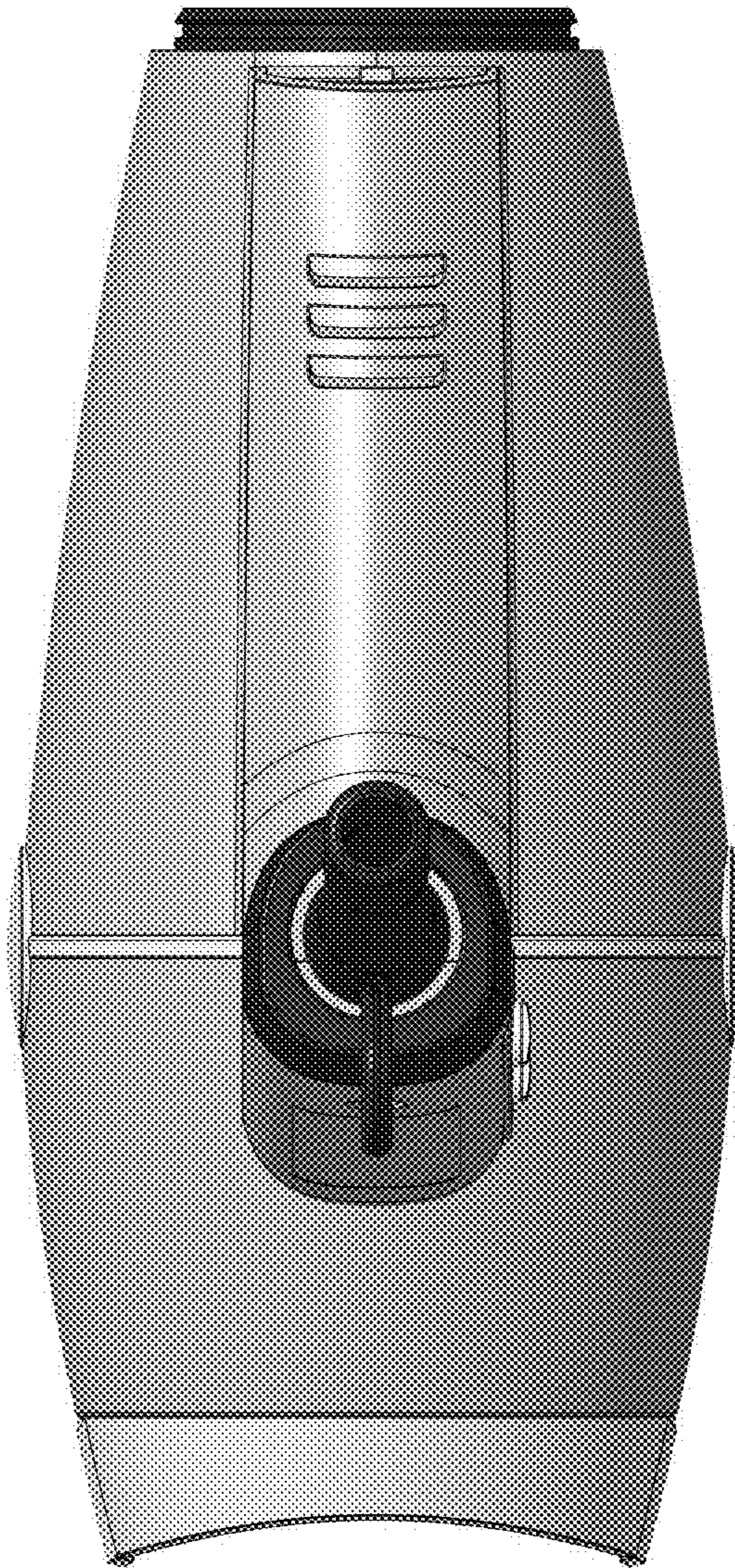
