FIG. 3.3 is a rear elevation view thereof;

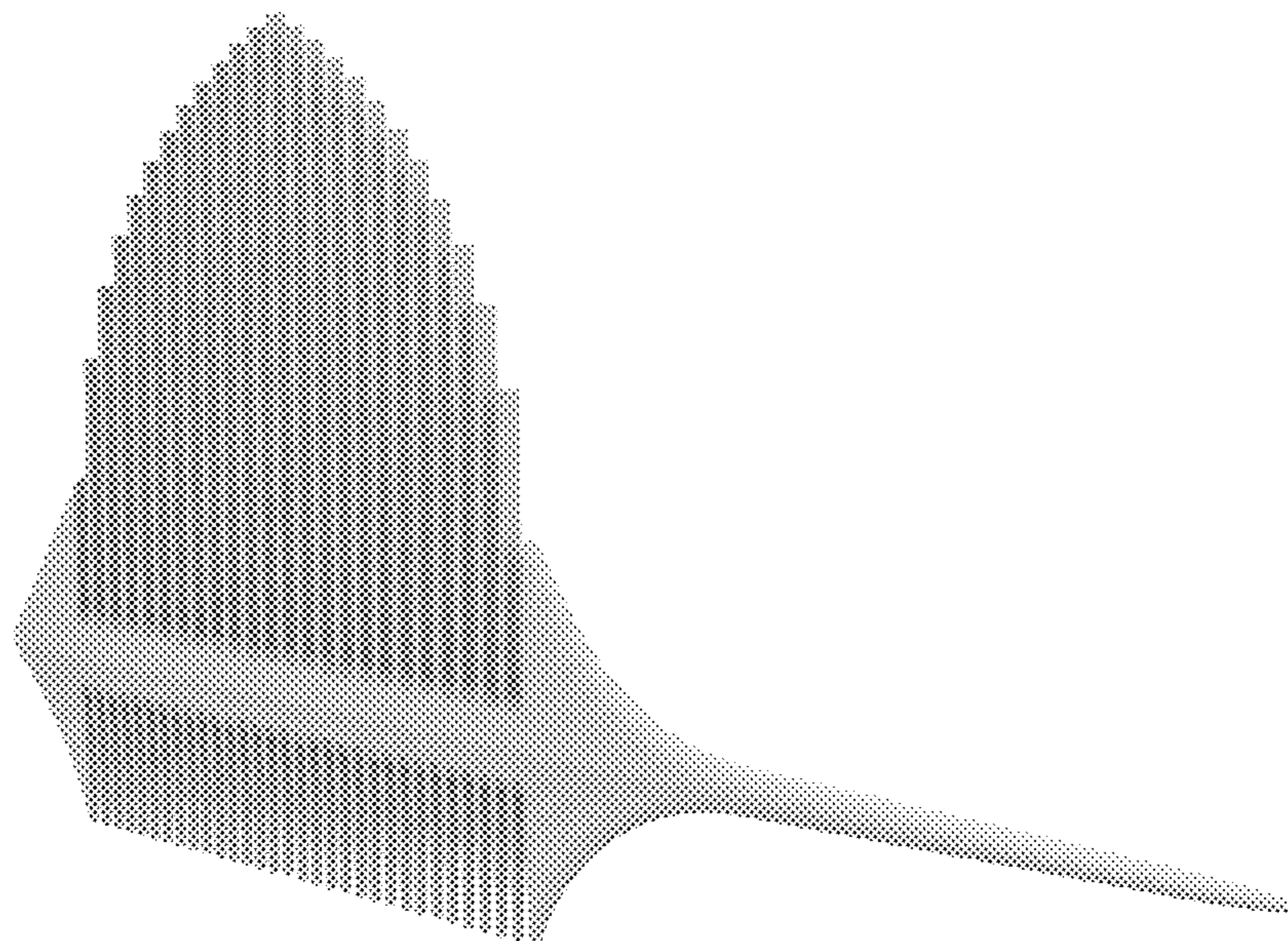

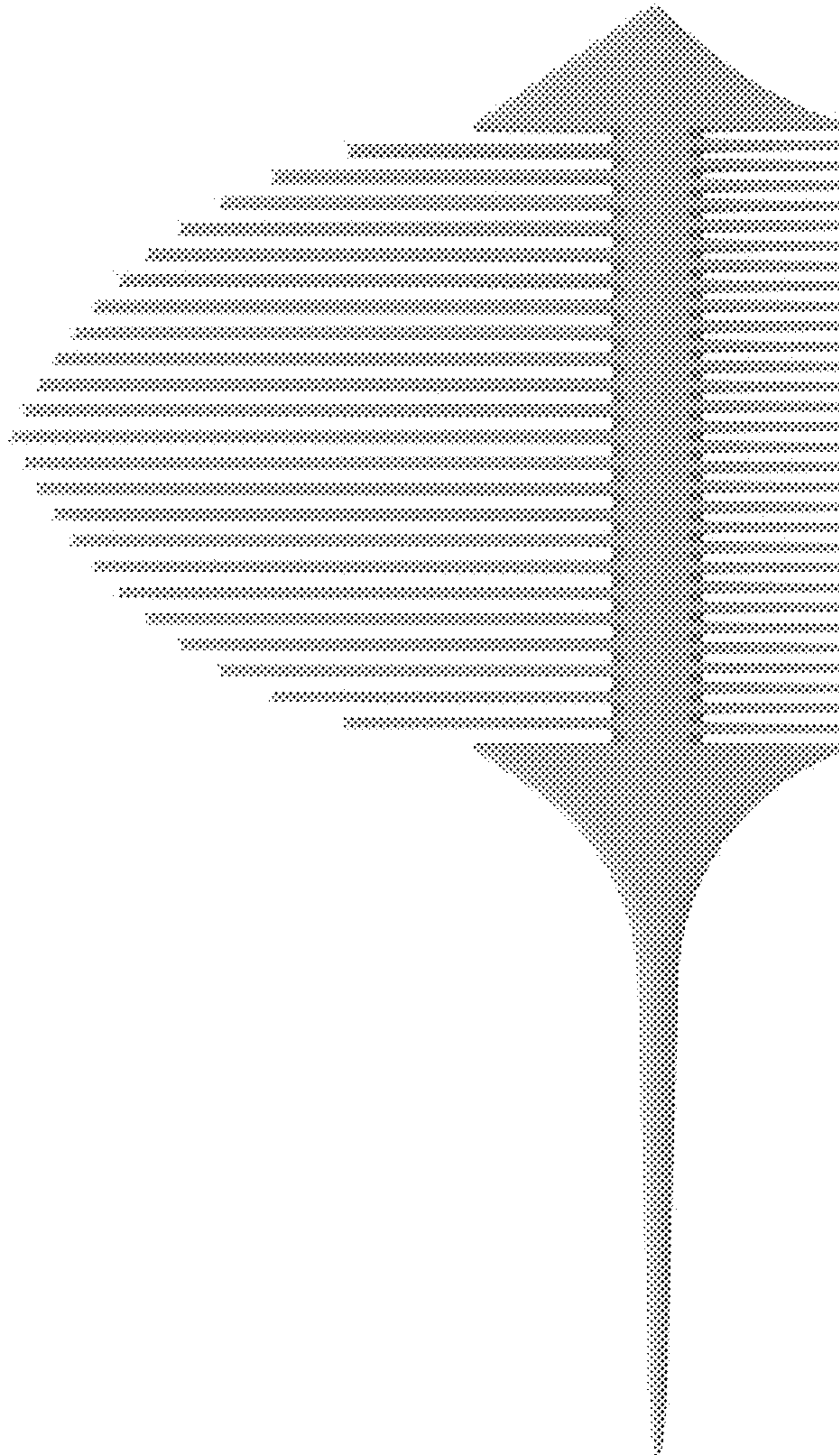

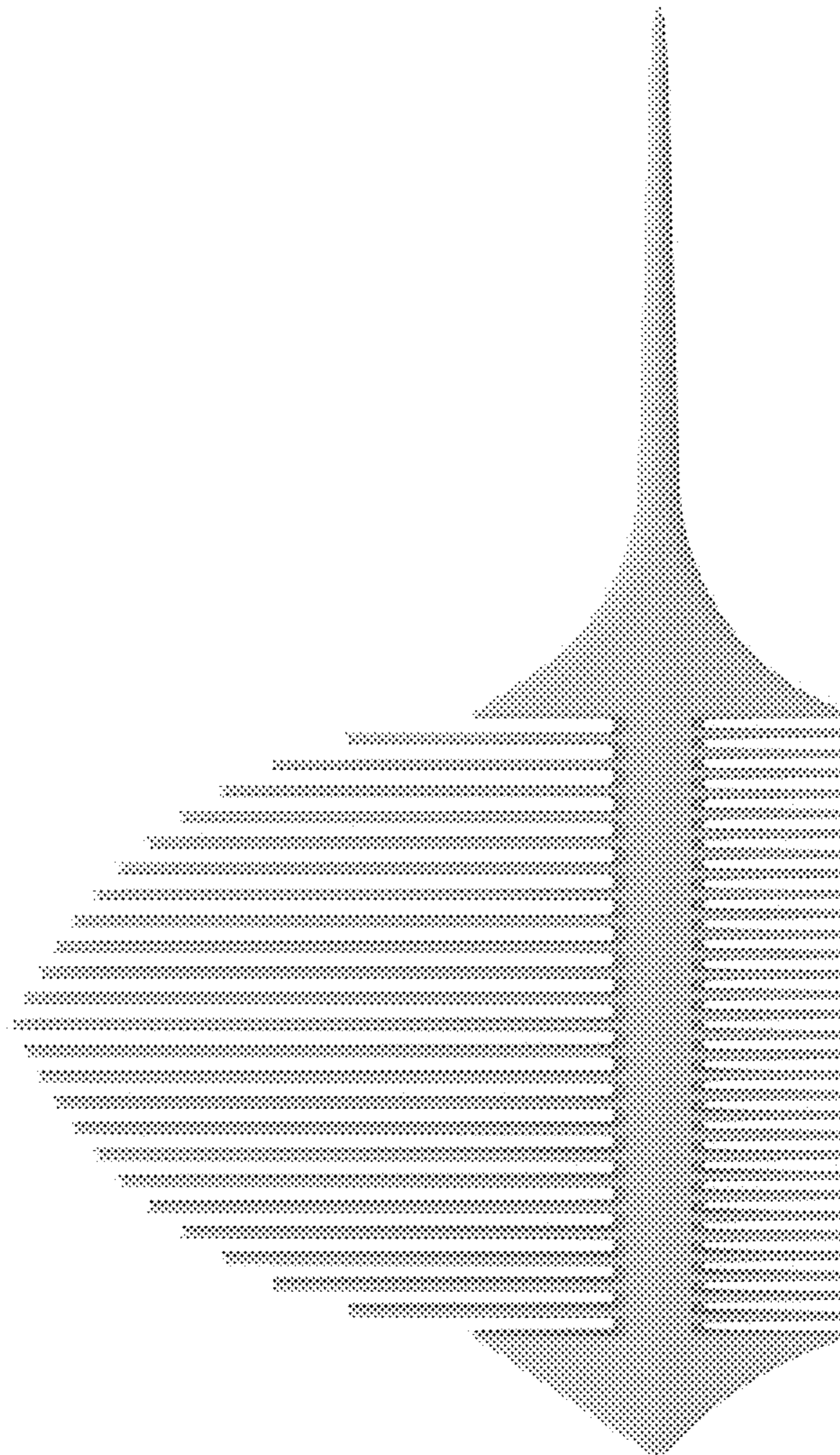

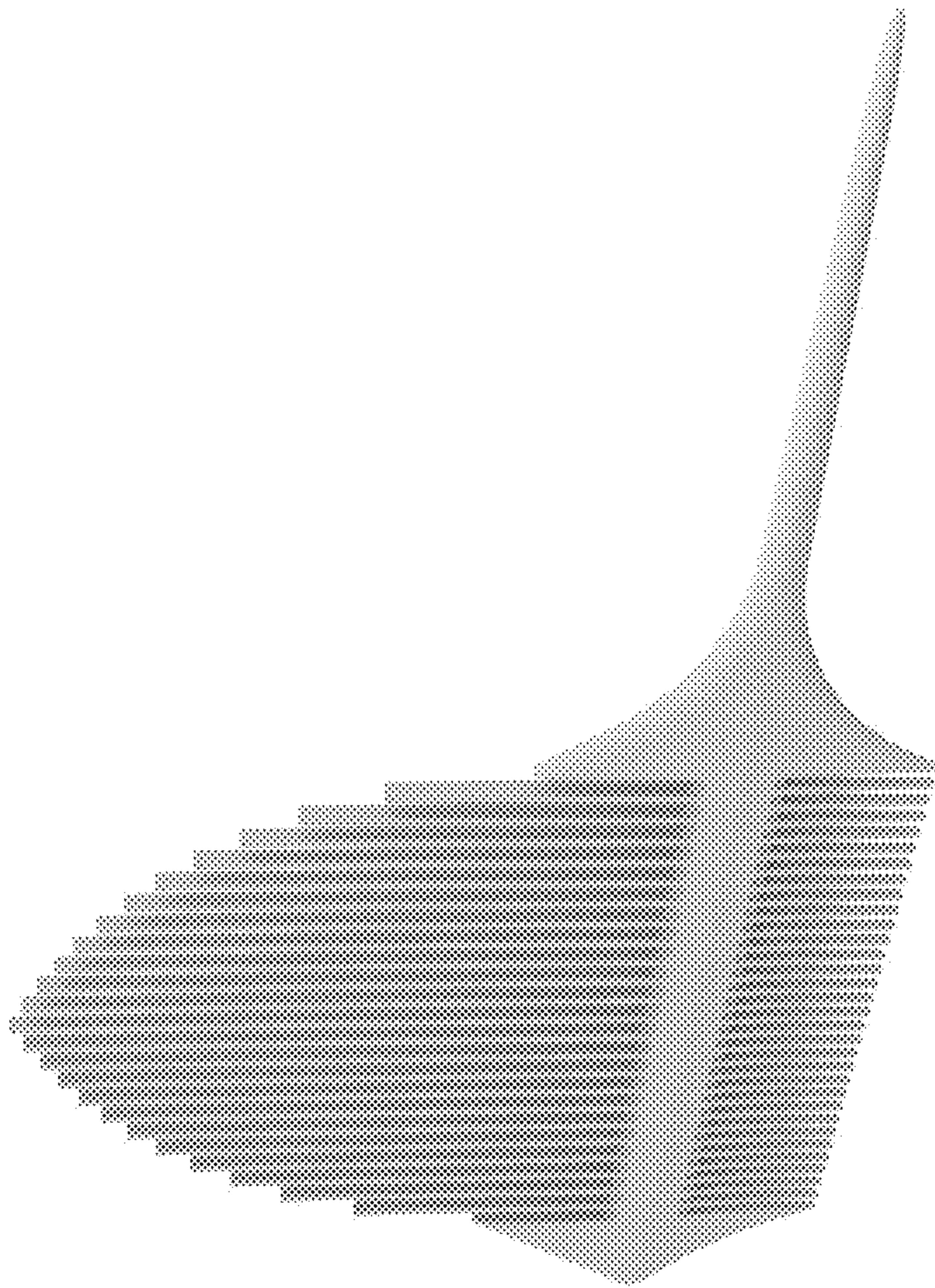




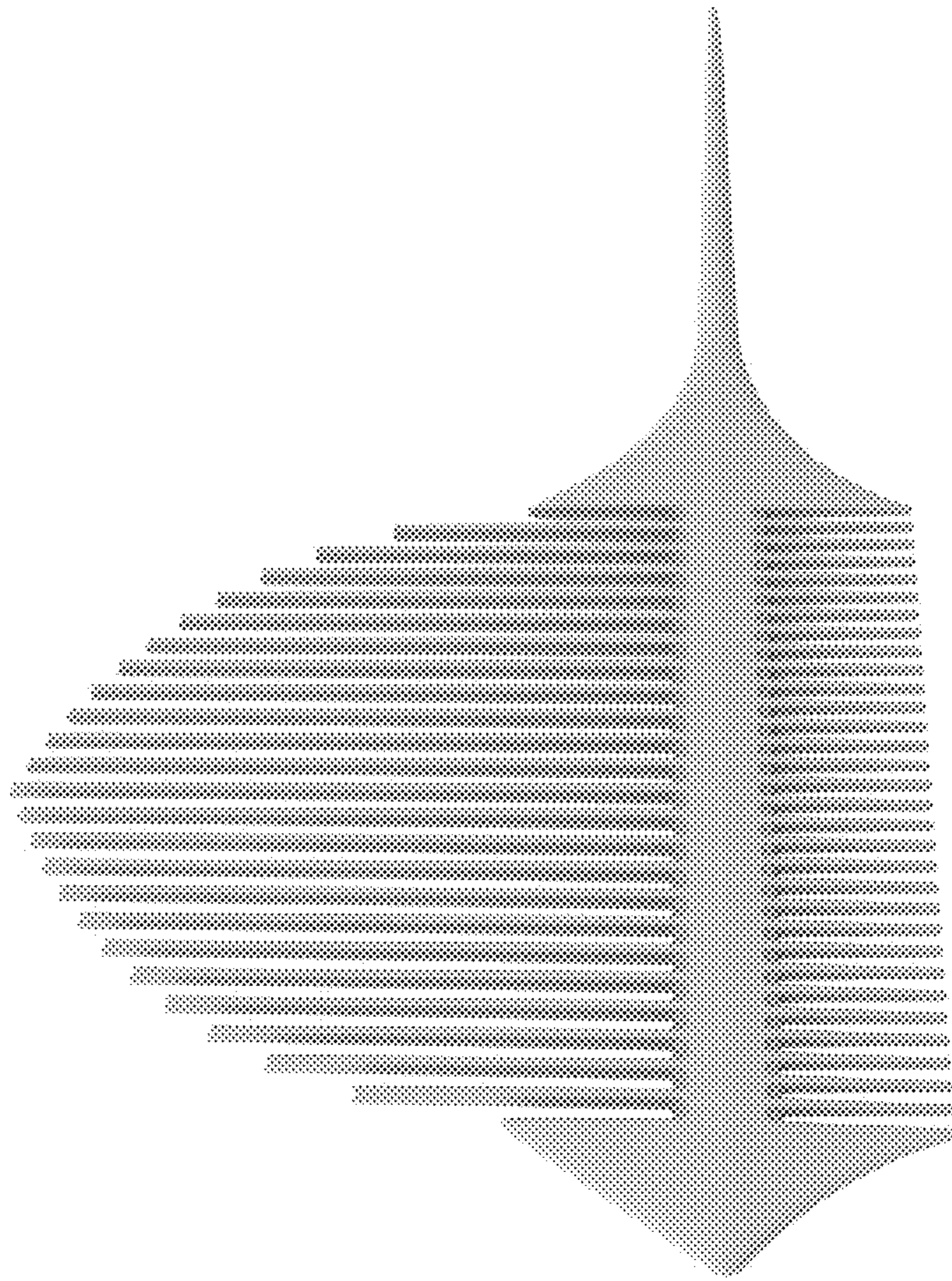

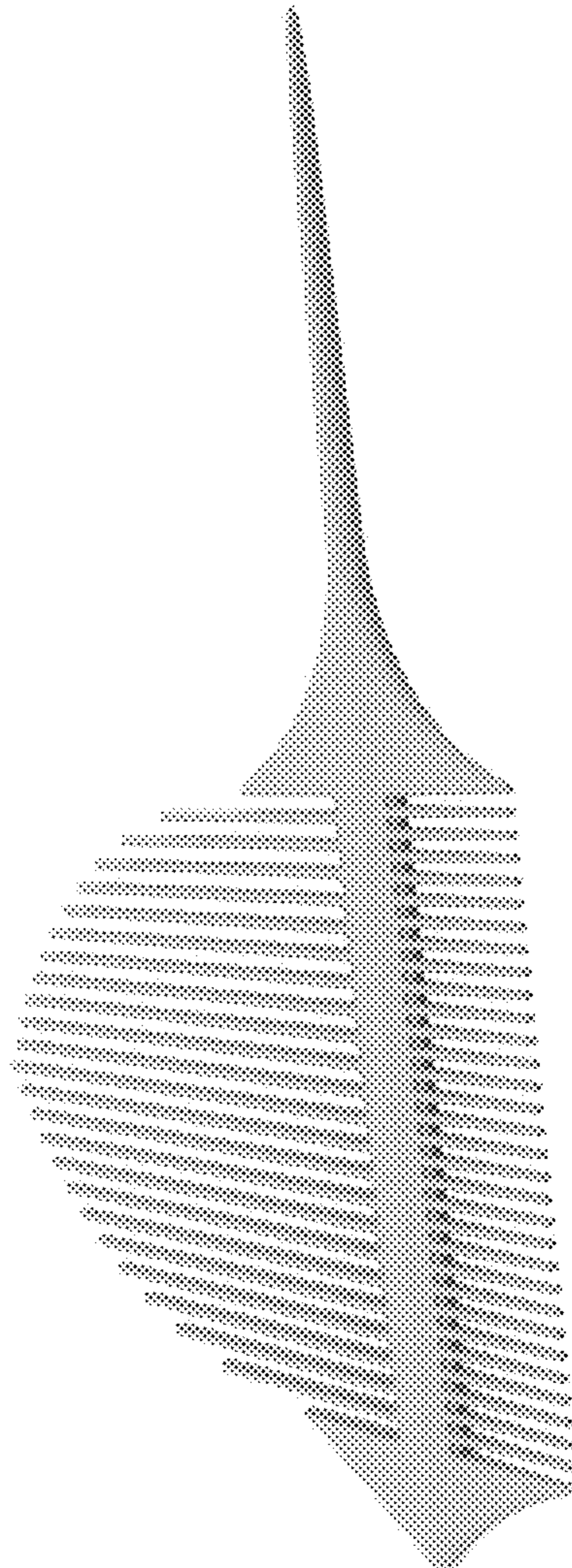

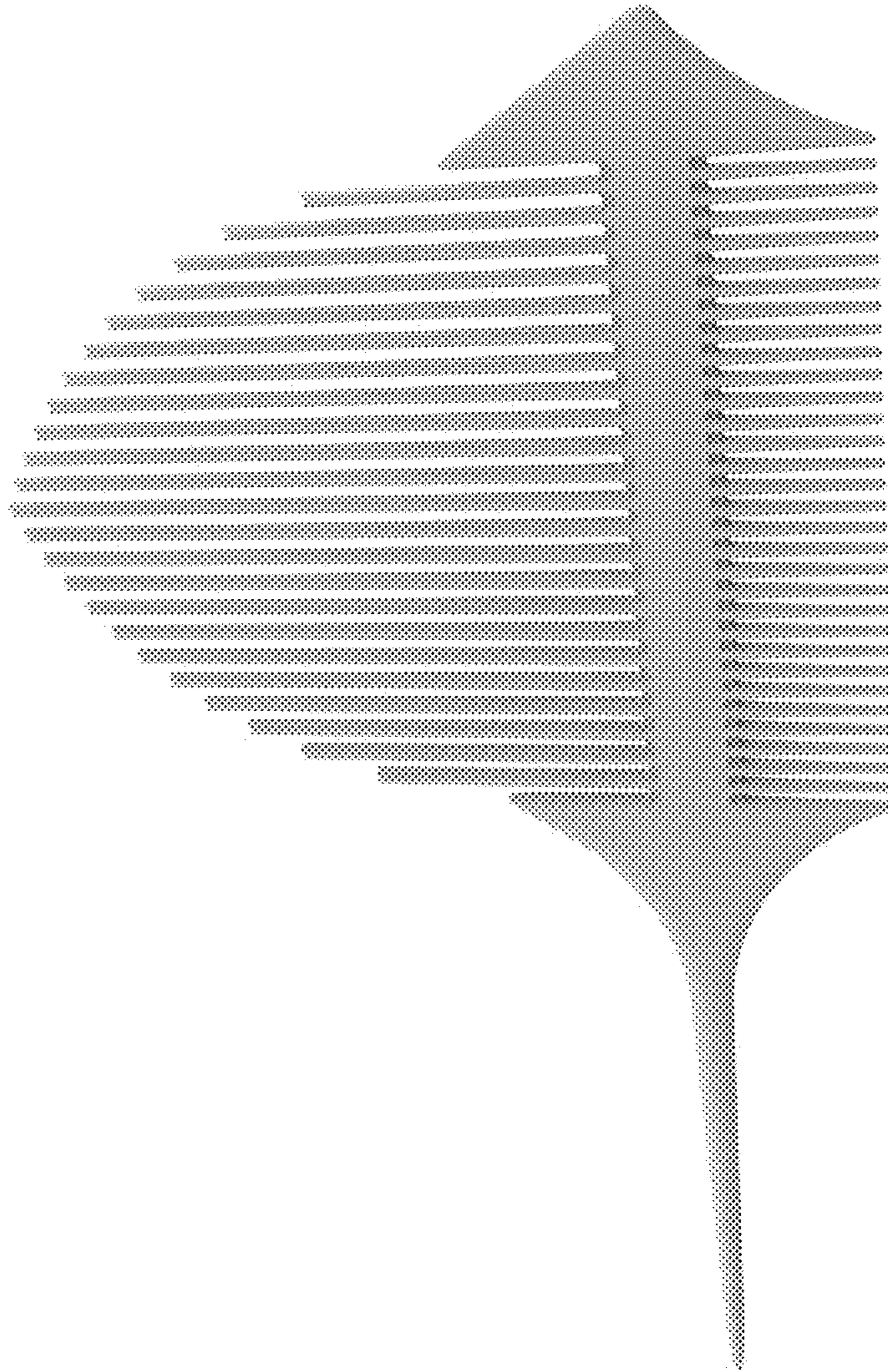

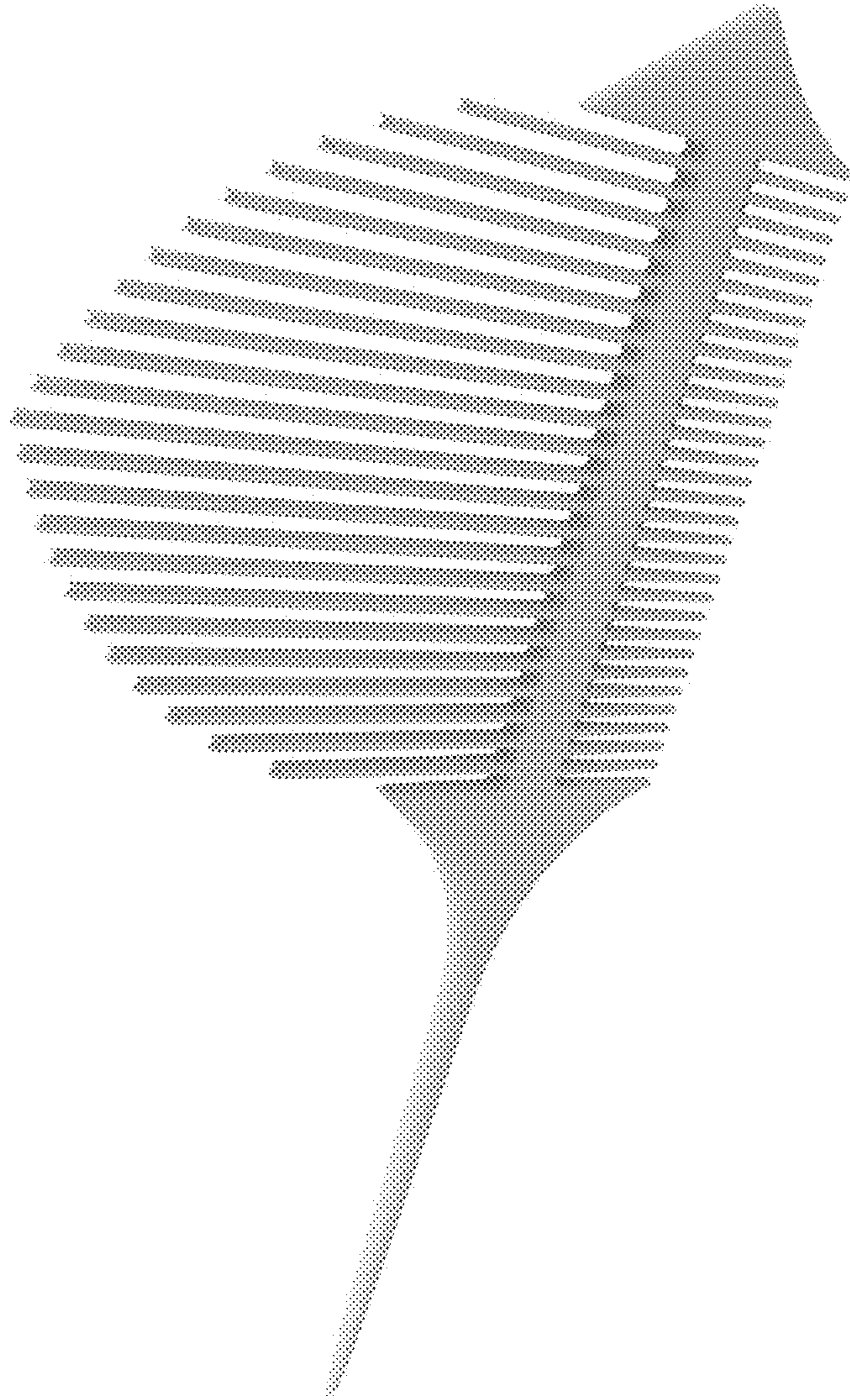

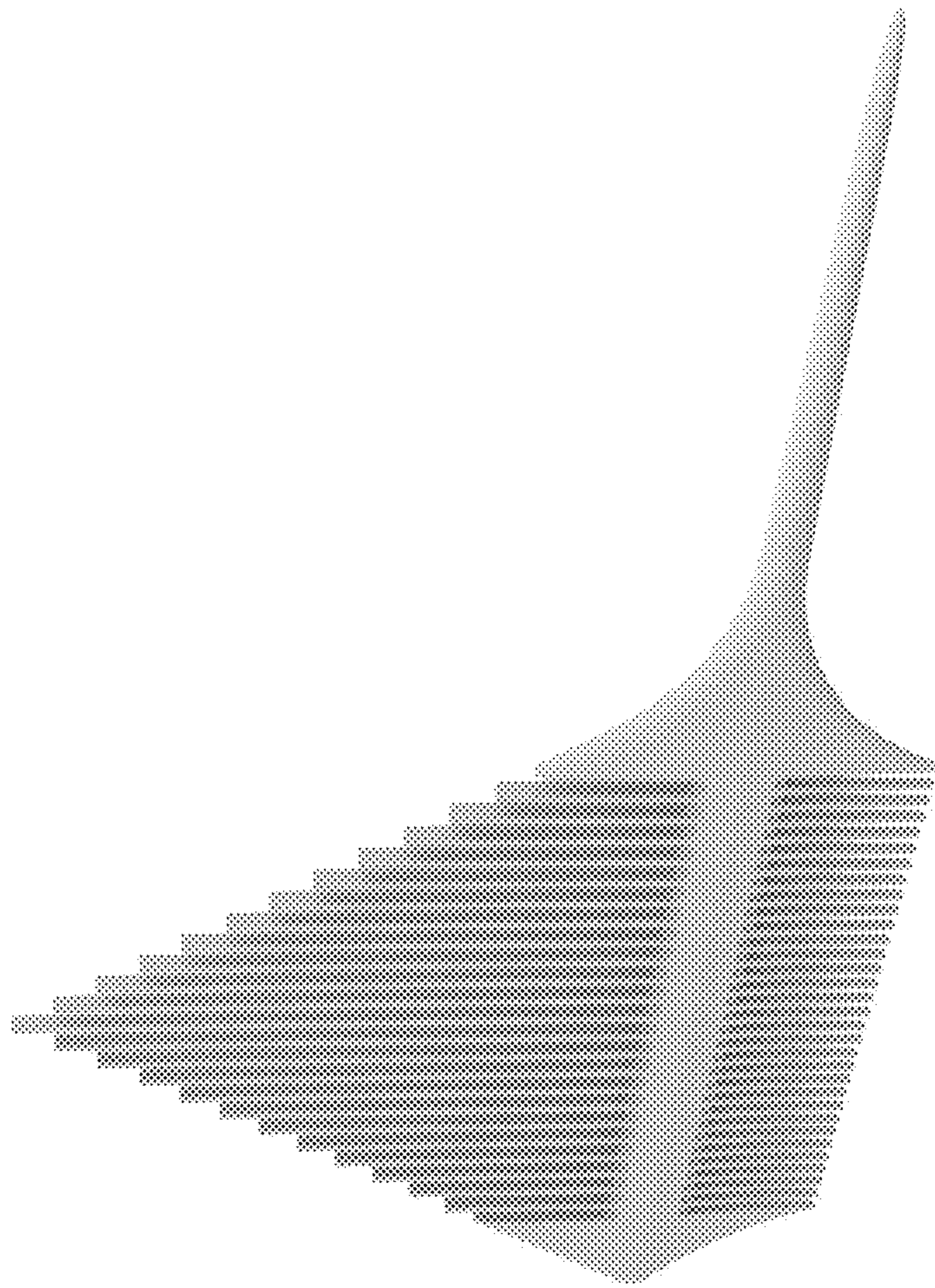

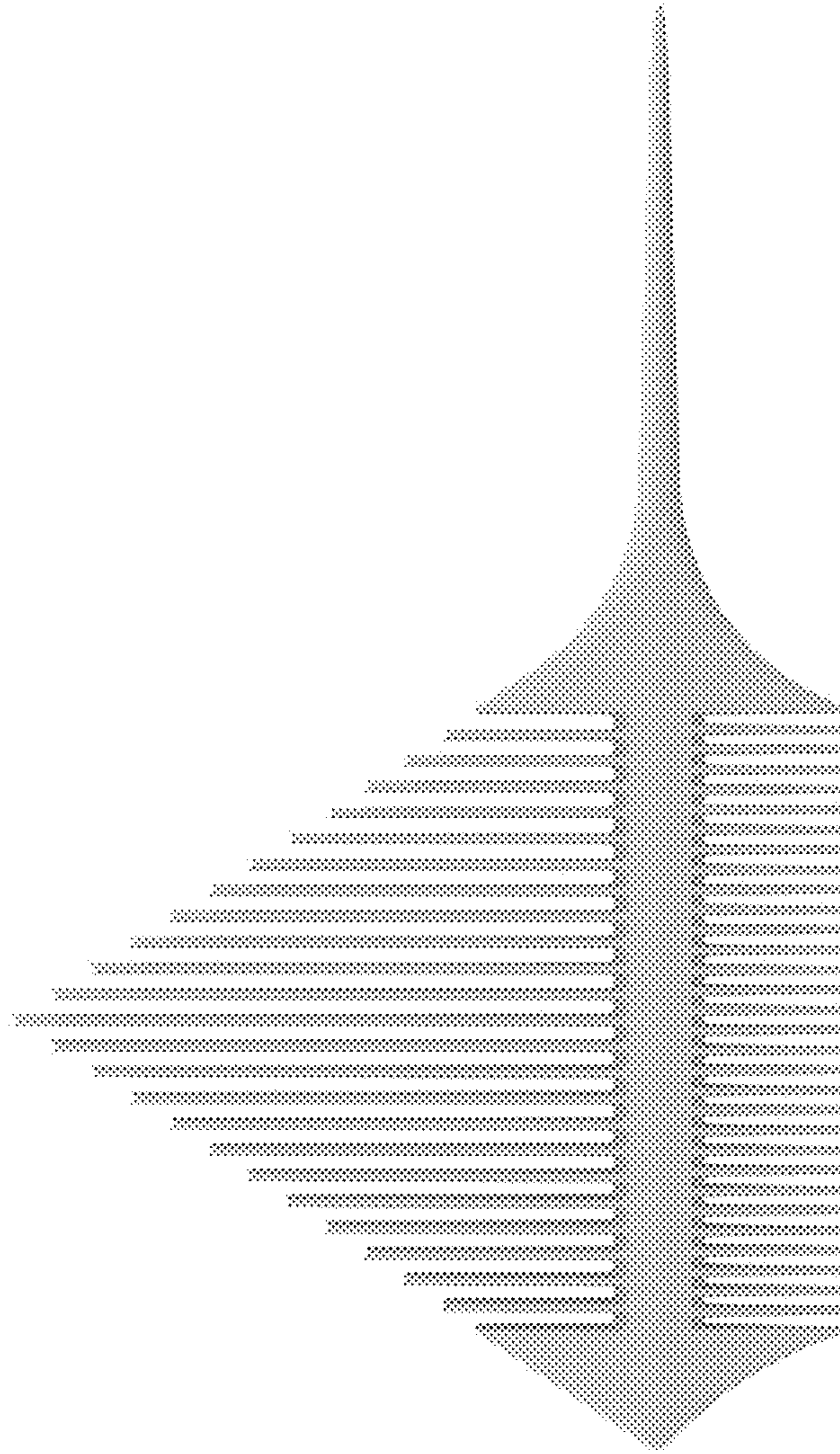

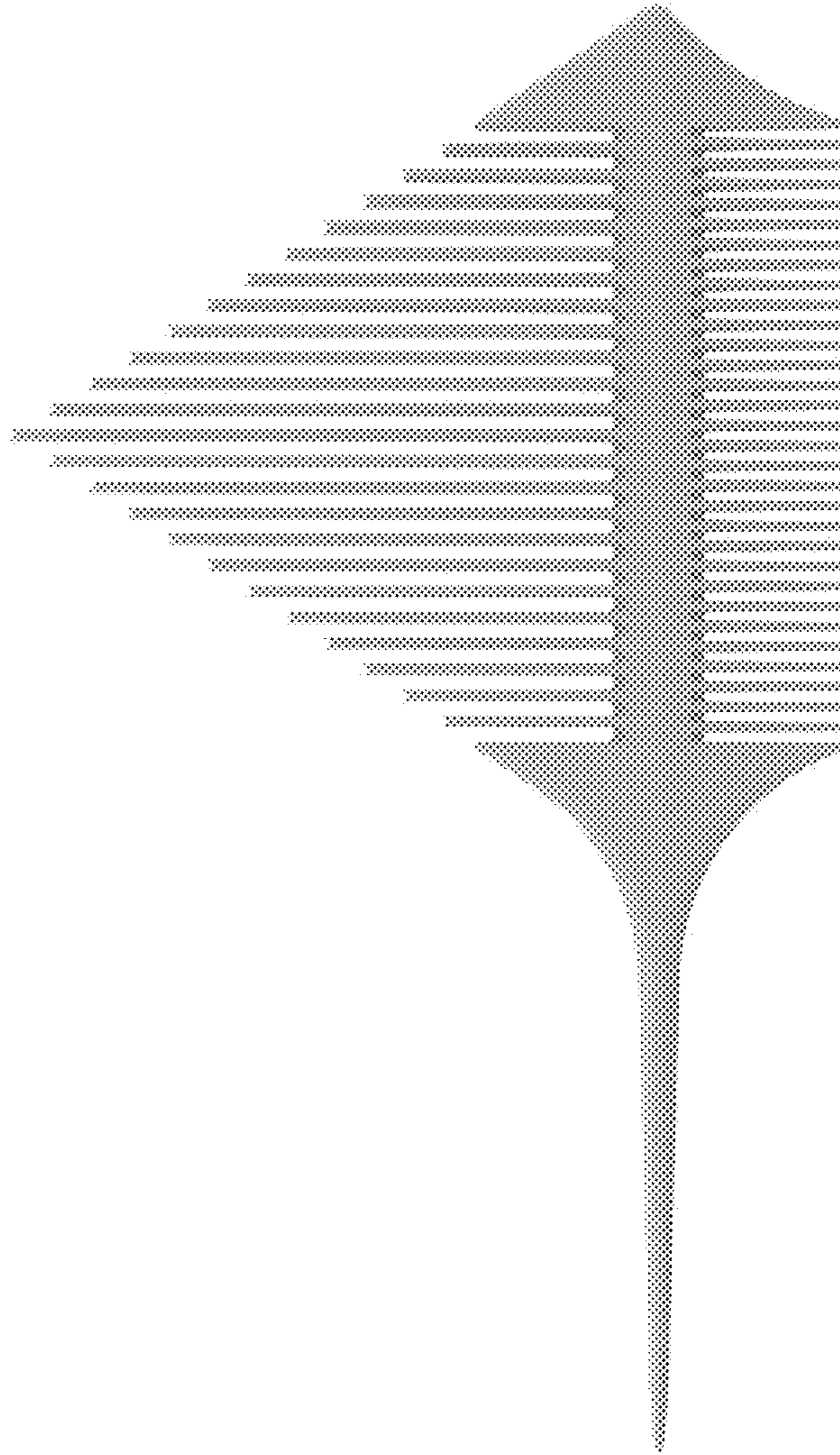

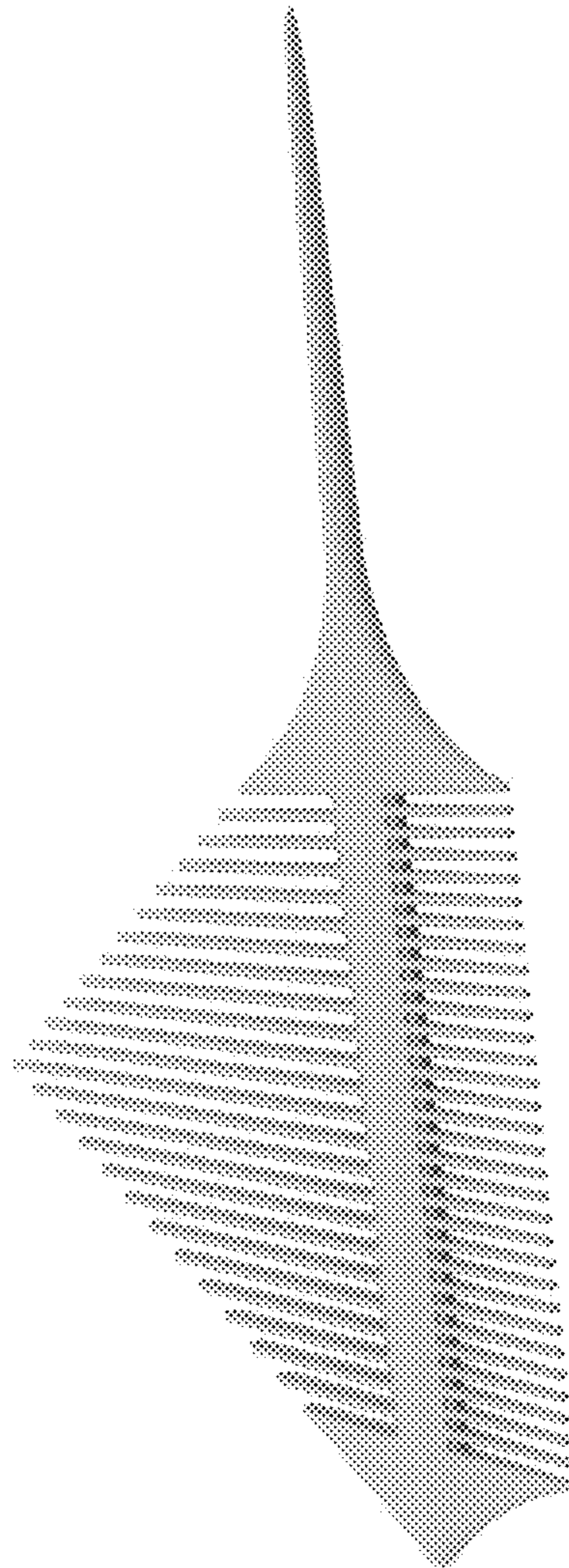

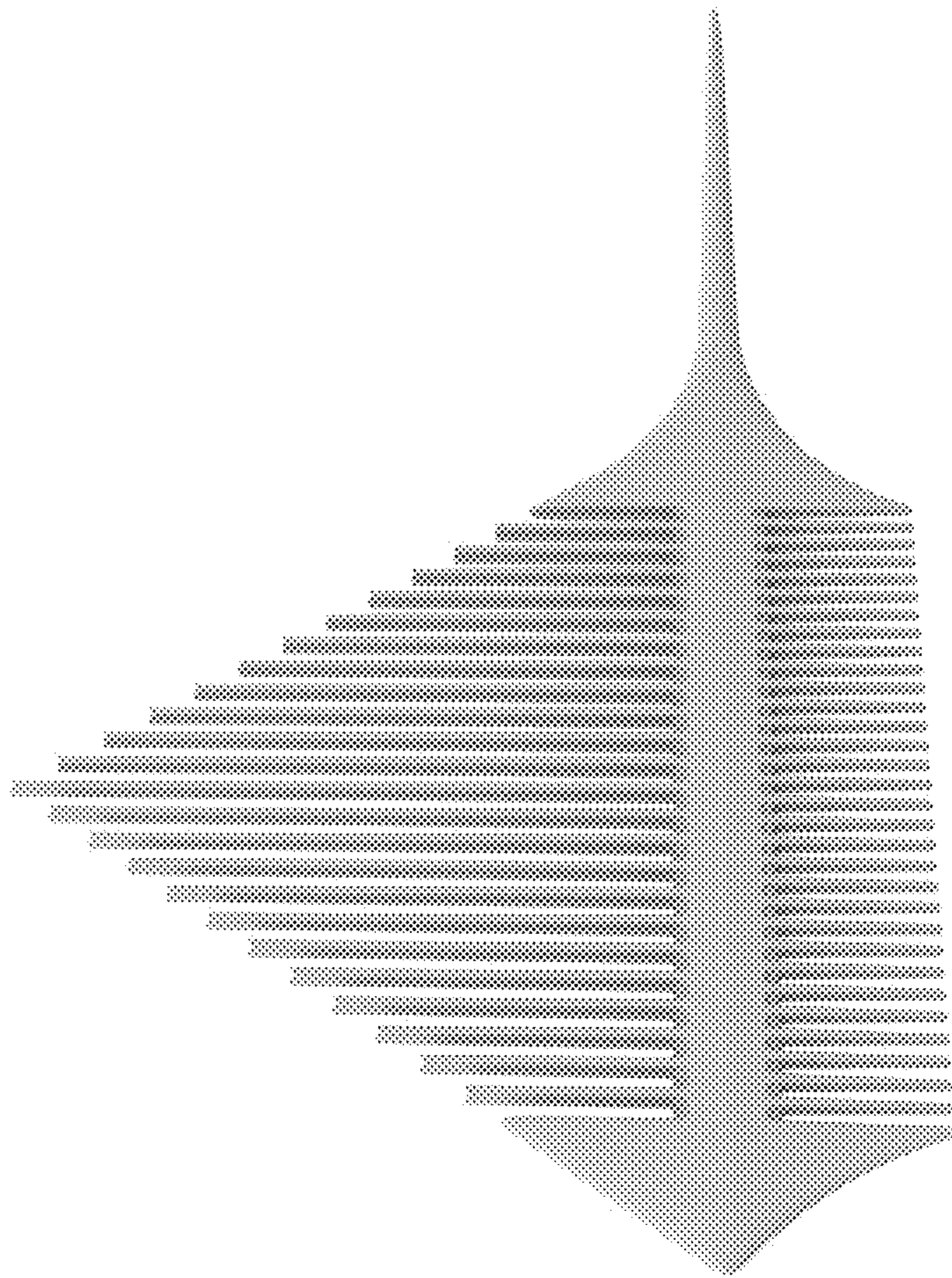

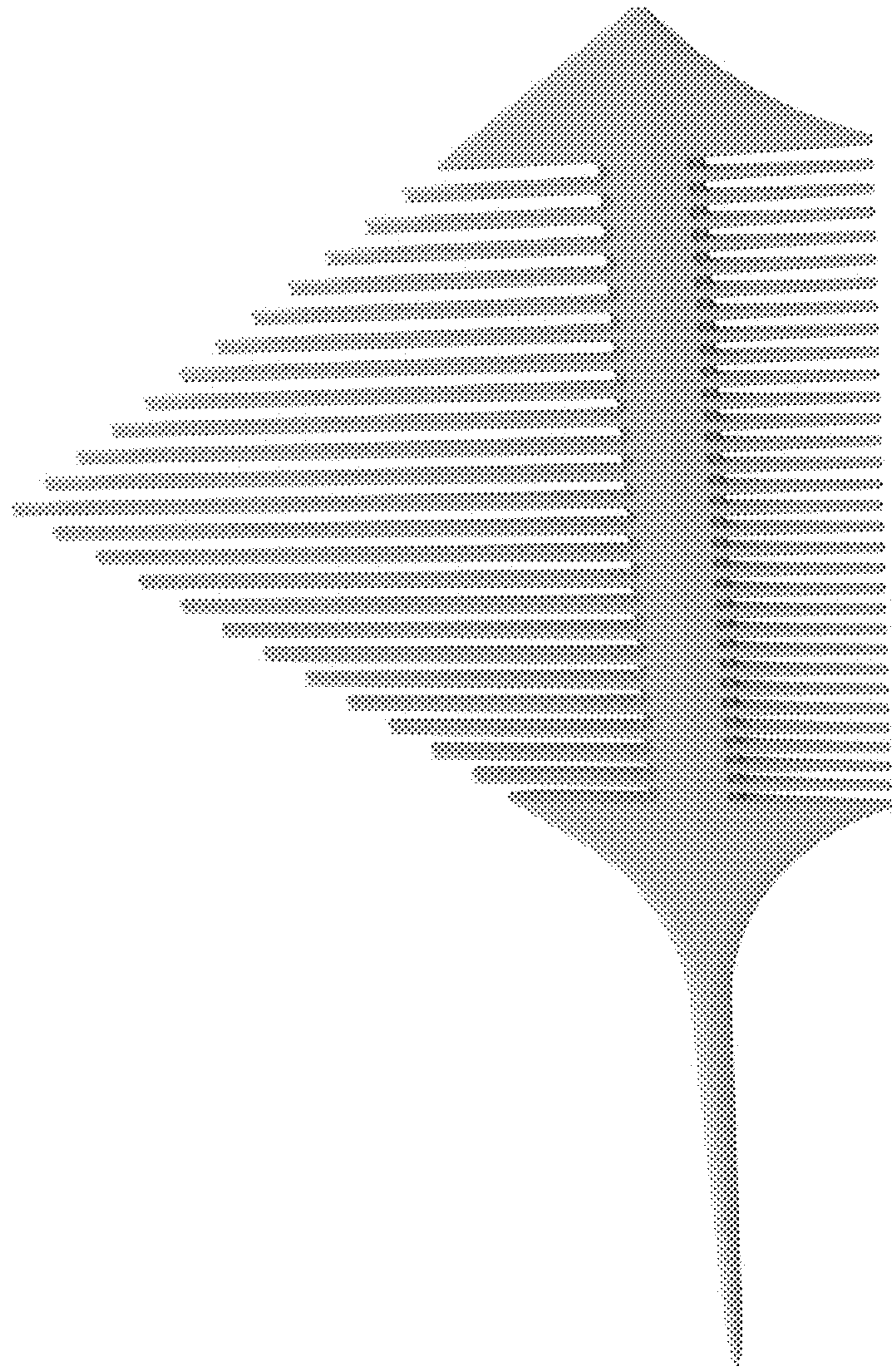

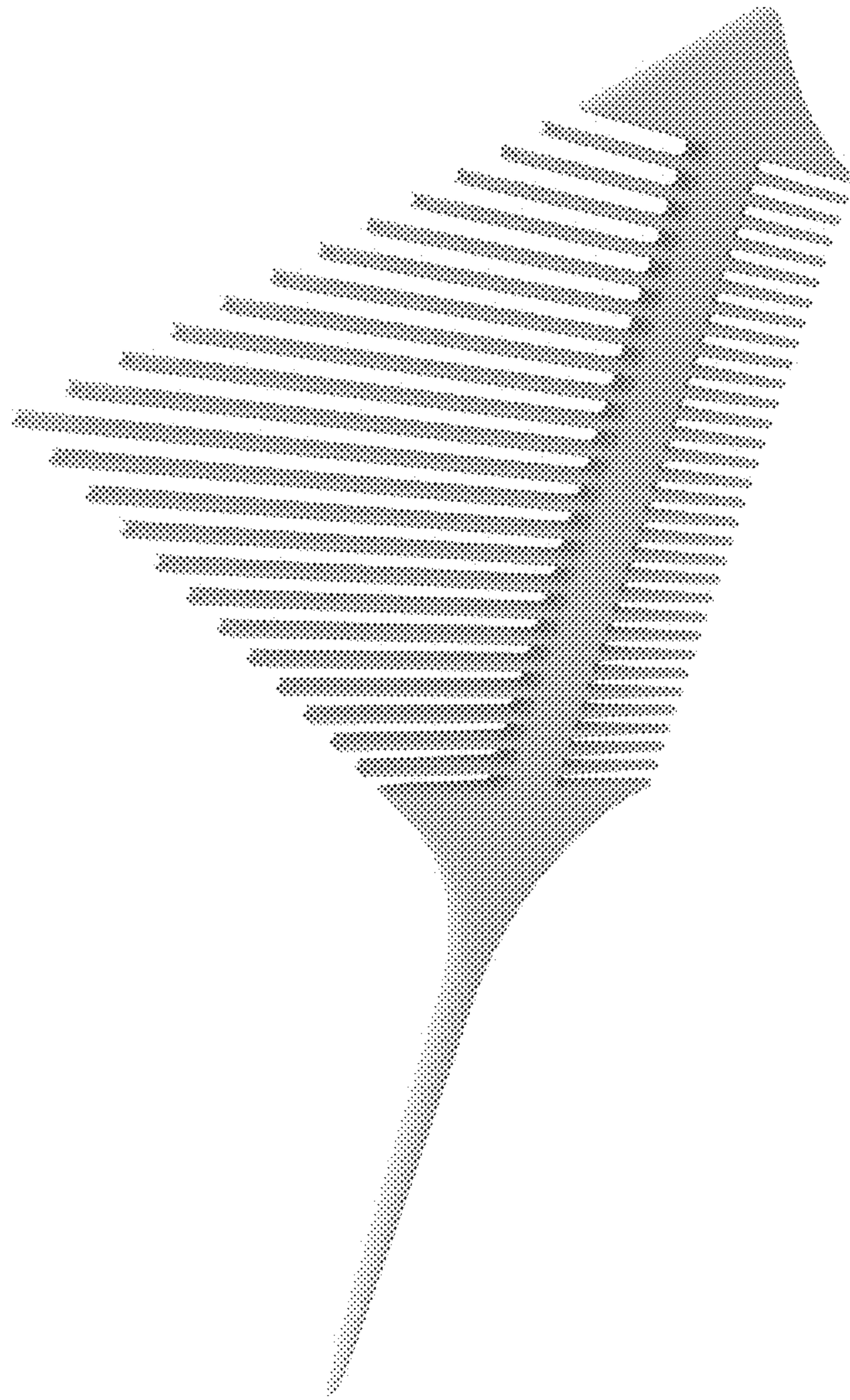

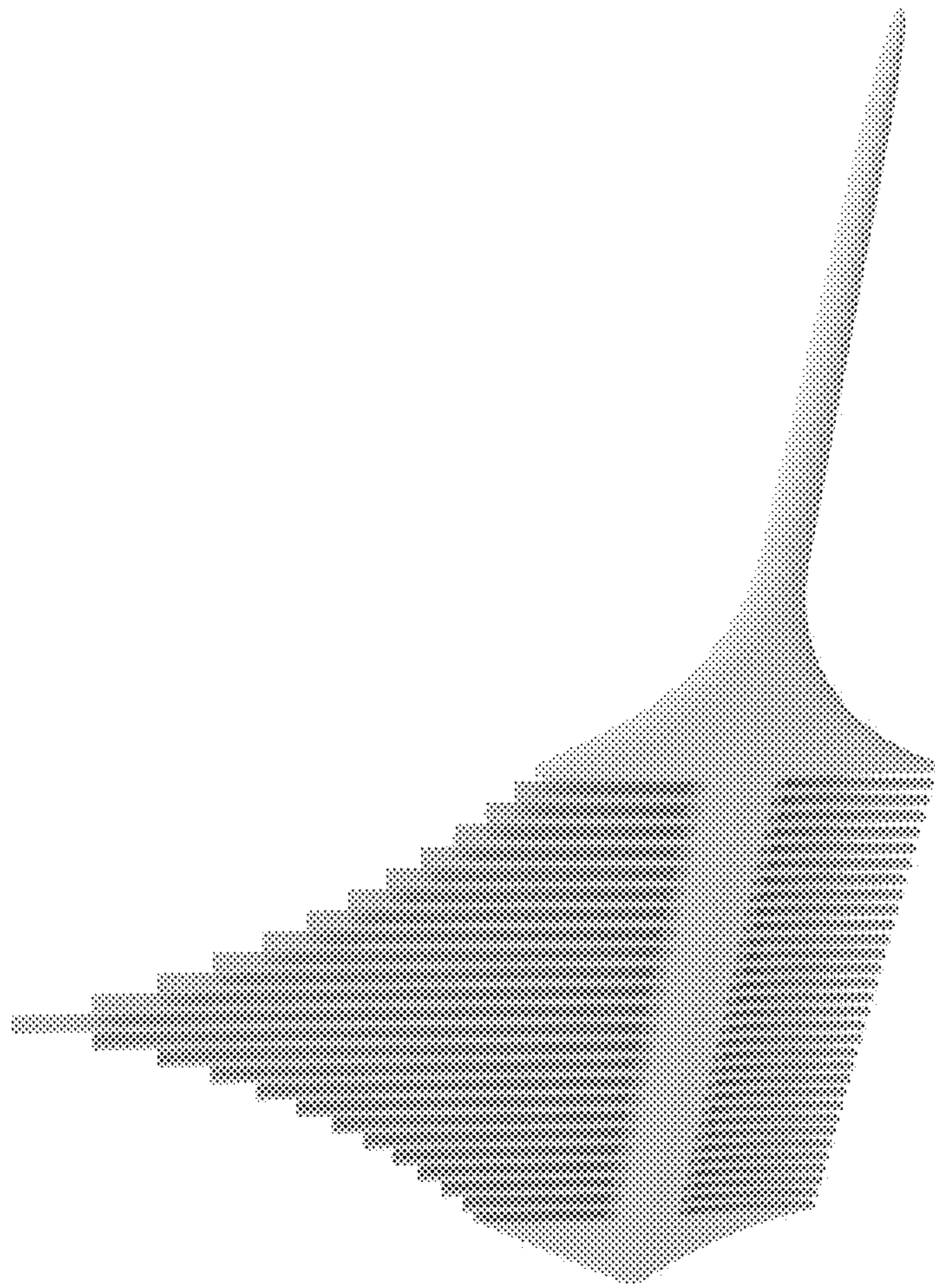

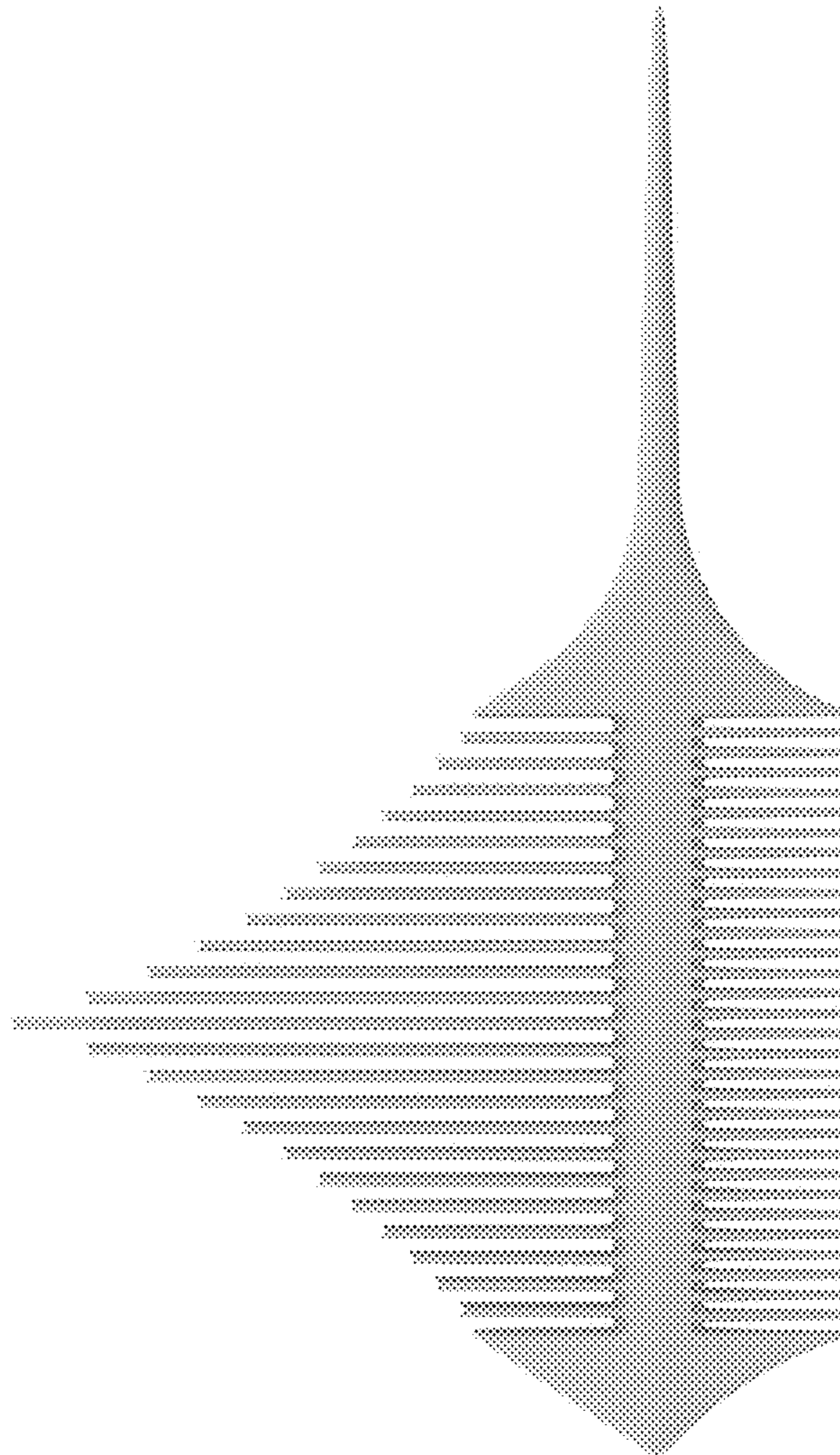

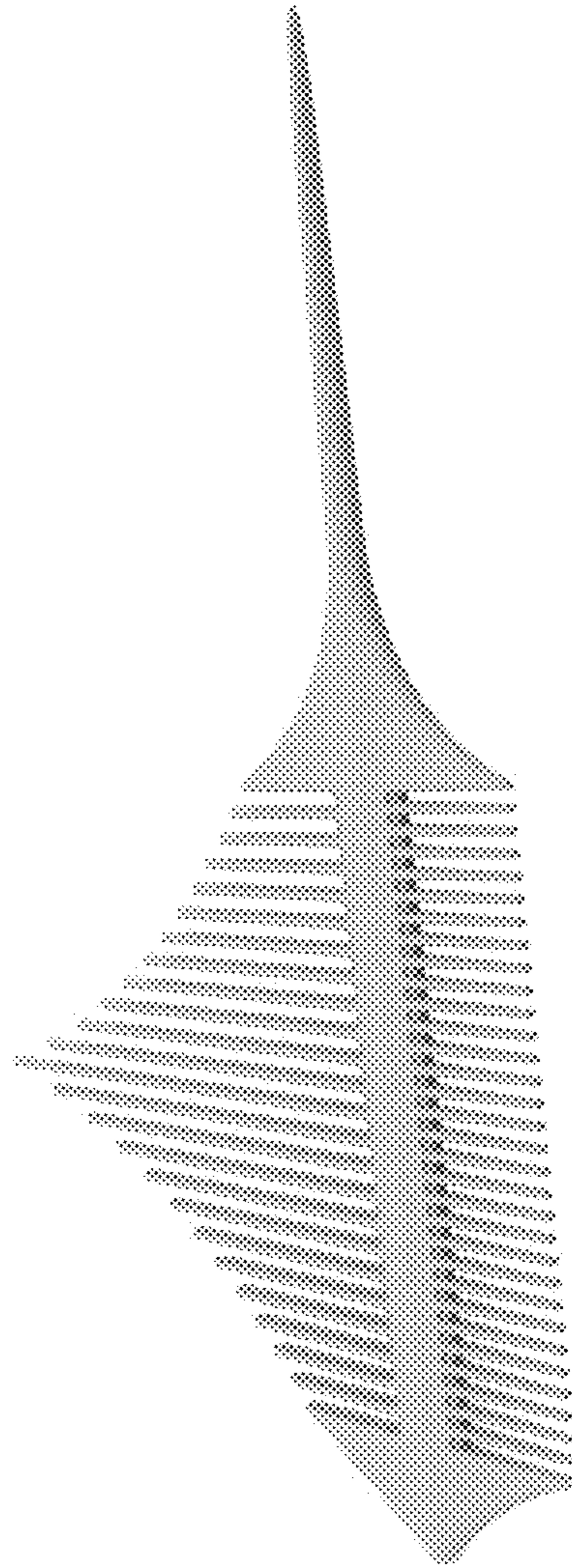

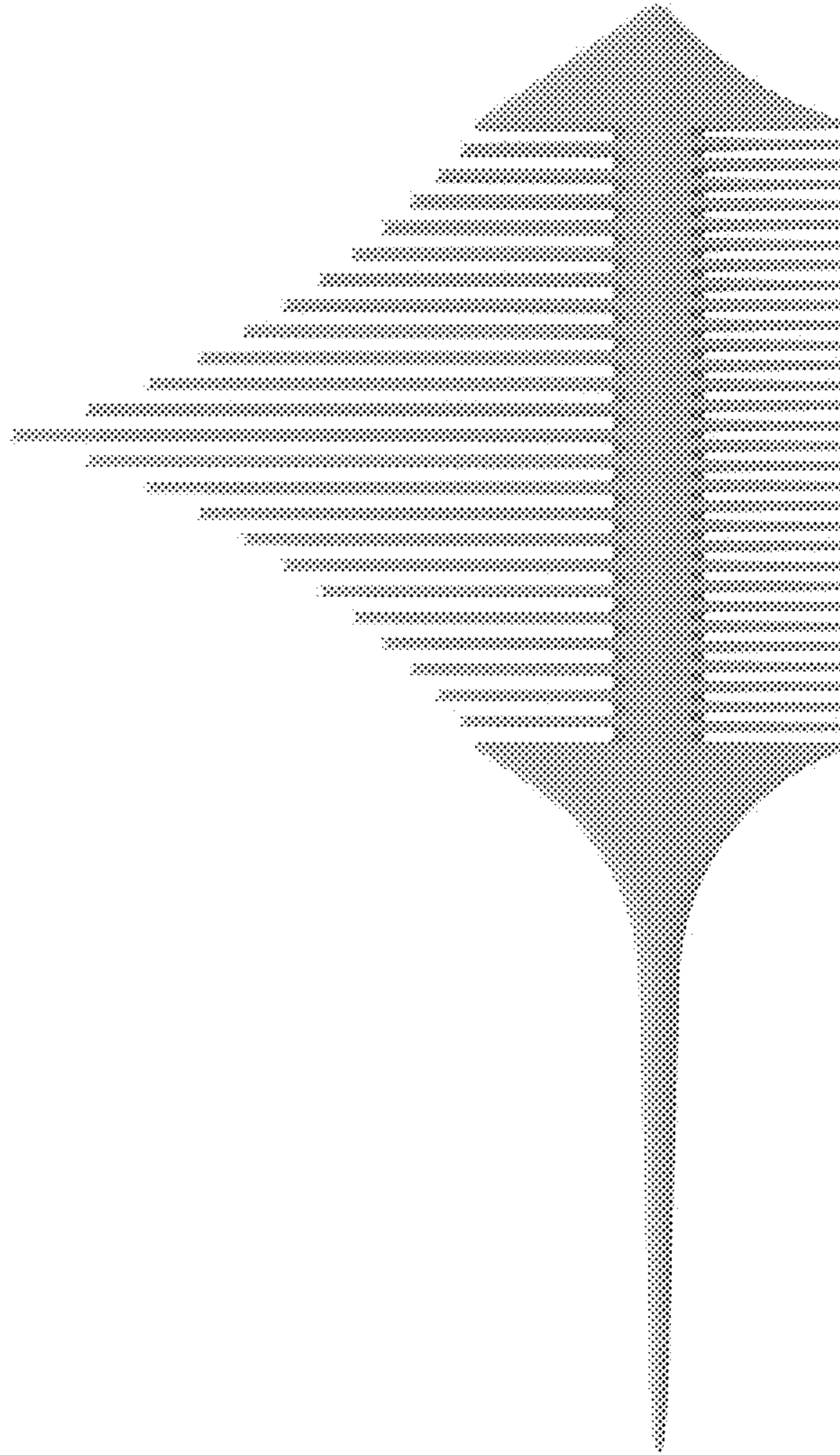

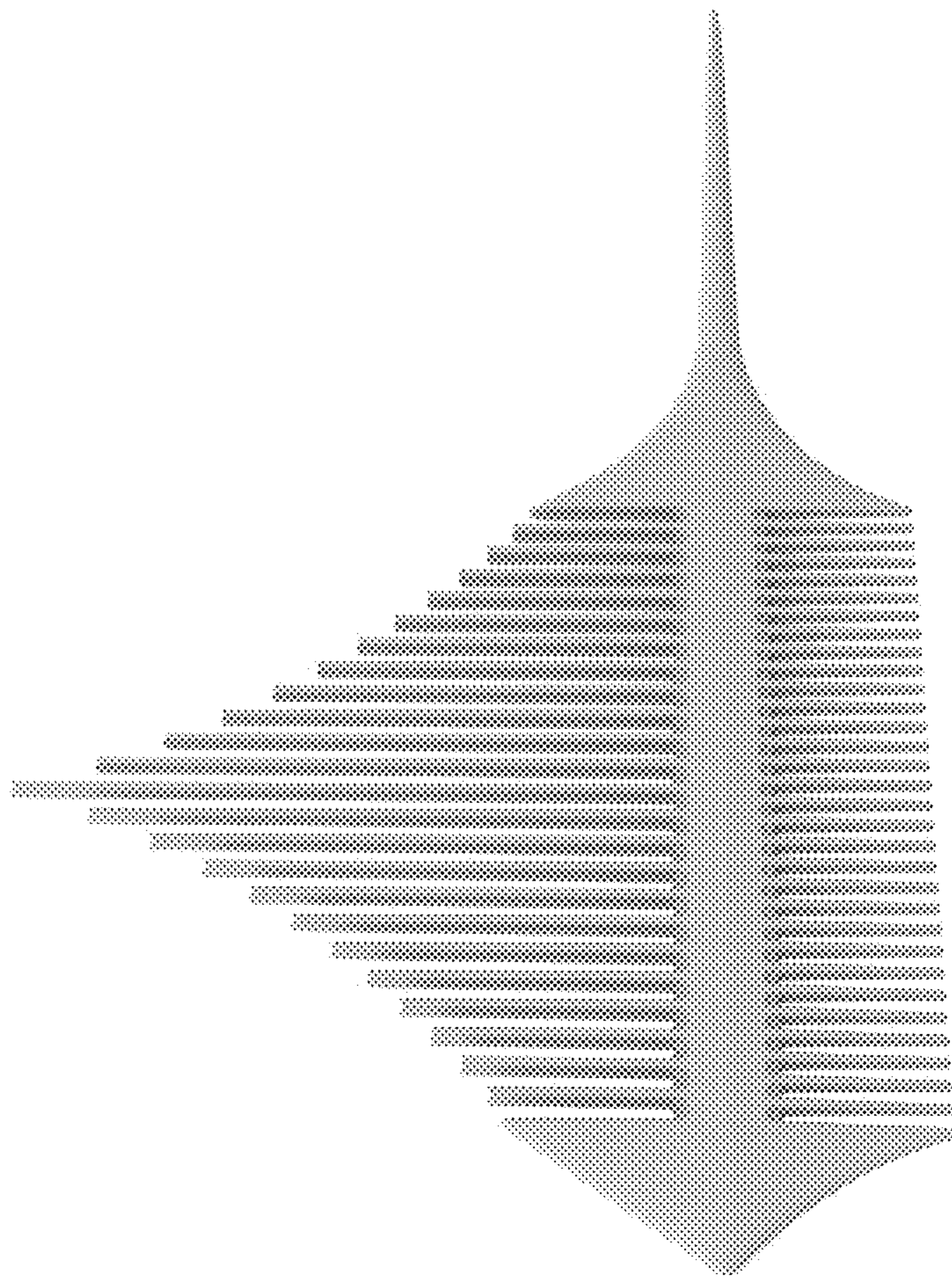

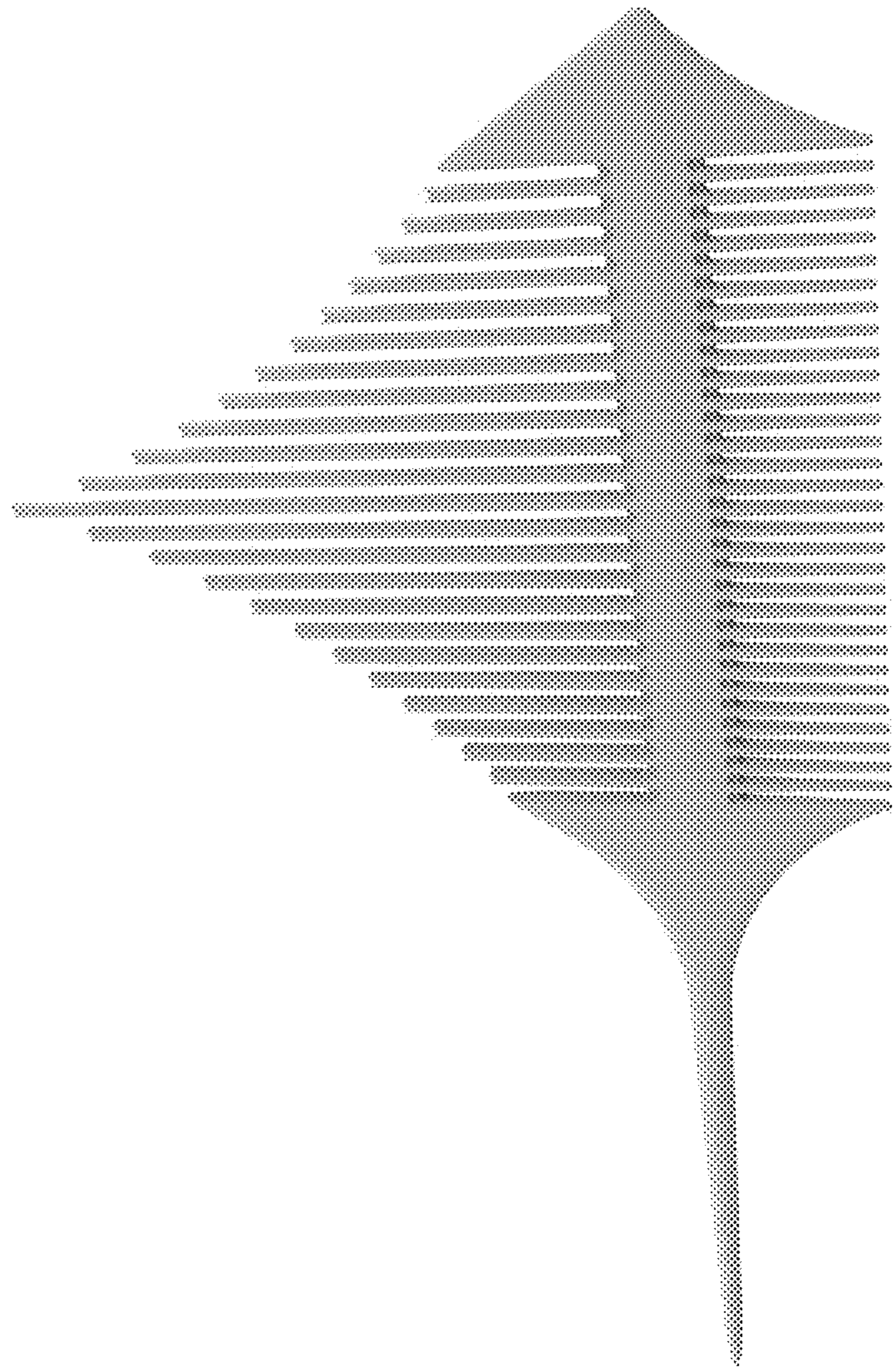

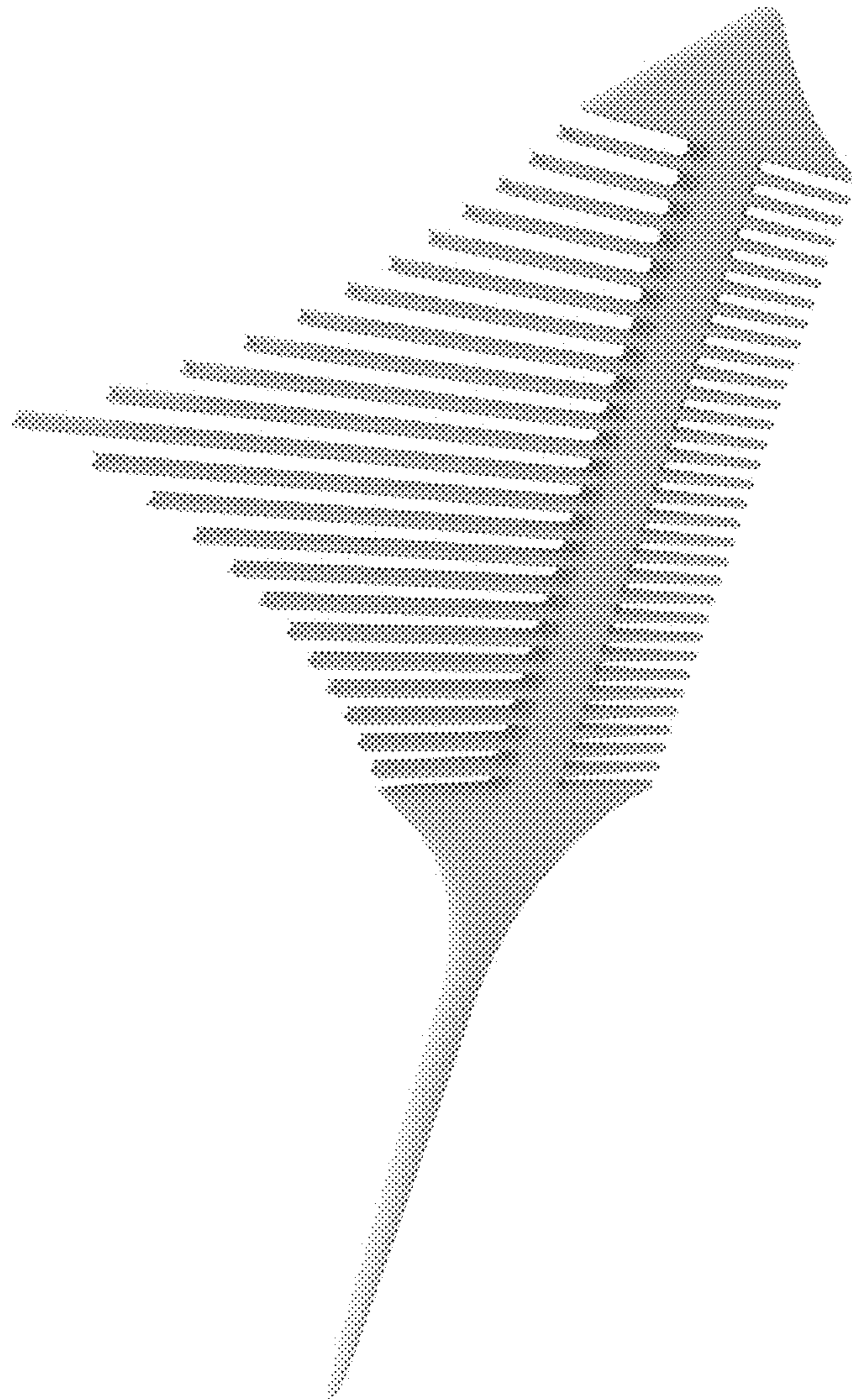
