(57) **CLAIM**

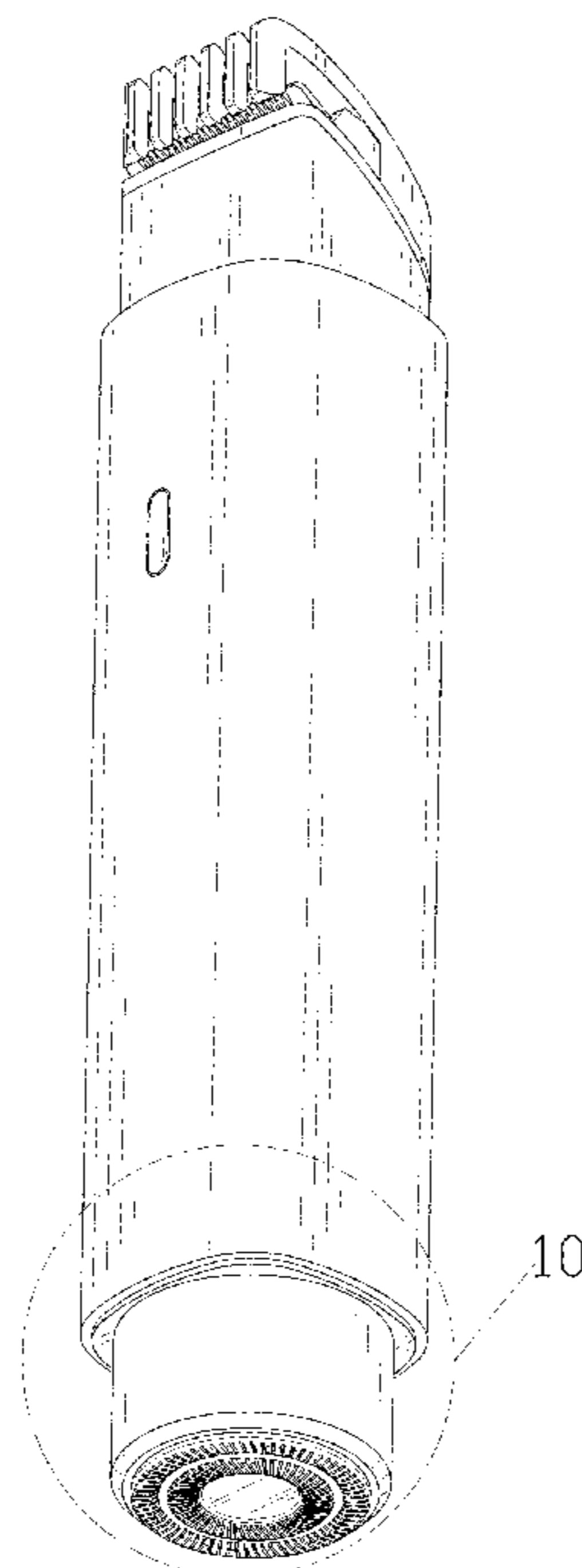
The ornamental design for a hair remover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hair remover showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a perspective view of the hair remover, shown with the cap on; and,
FIG. 10 is an enlarged view of the encircled portion 10 of FIG. 1.

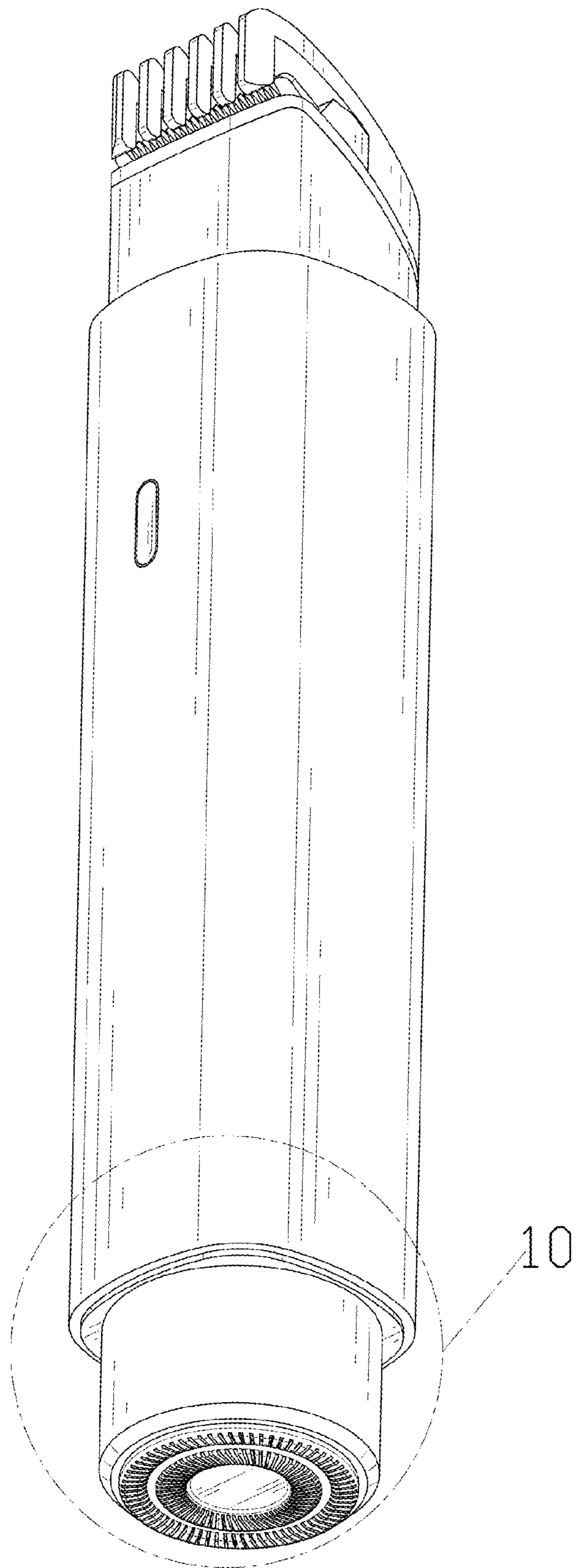

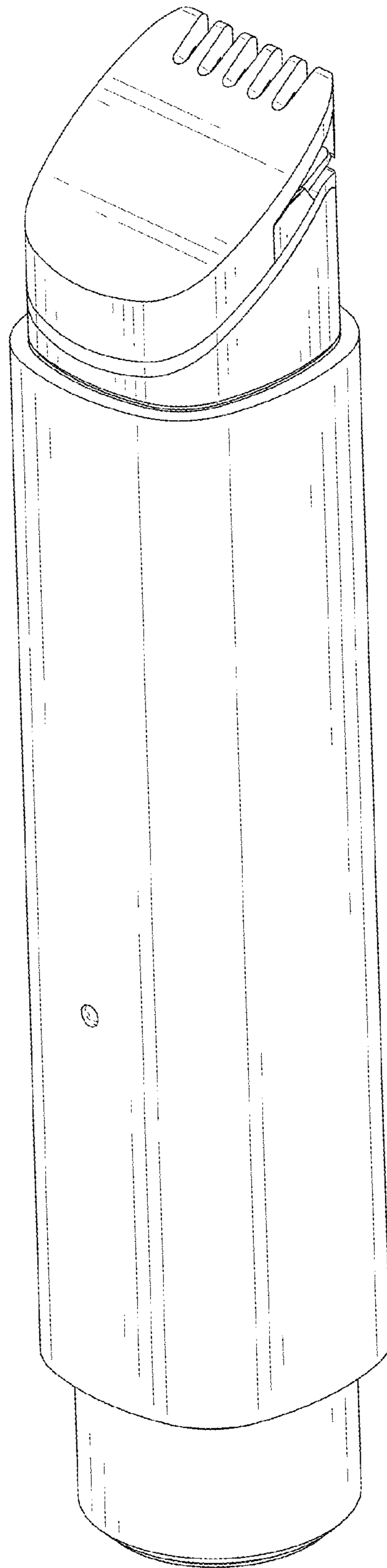

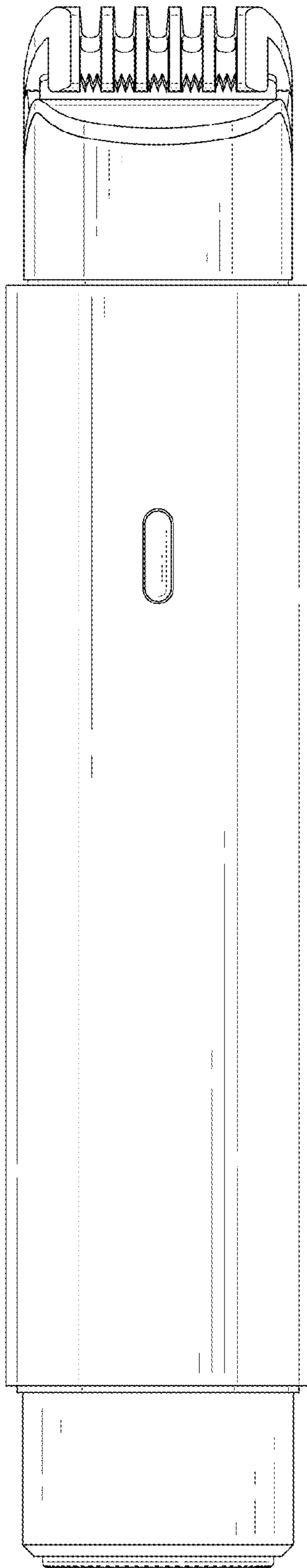

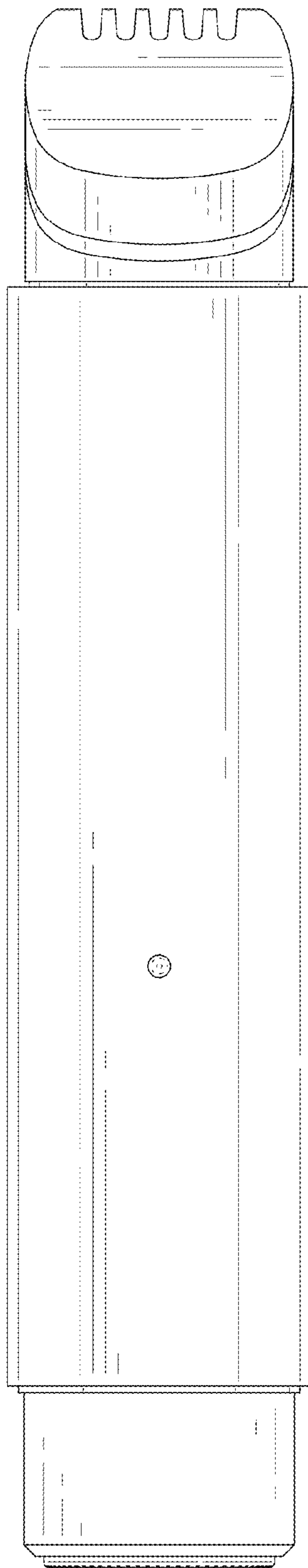

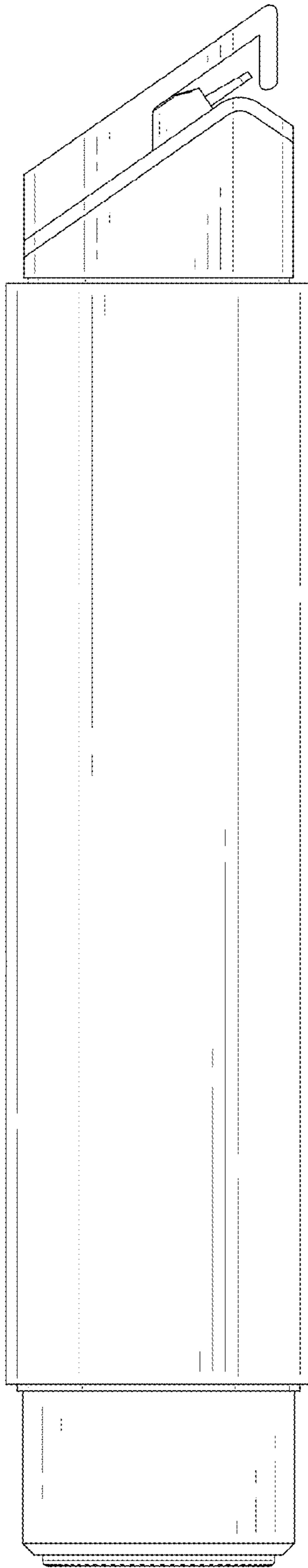

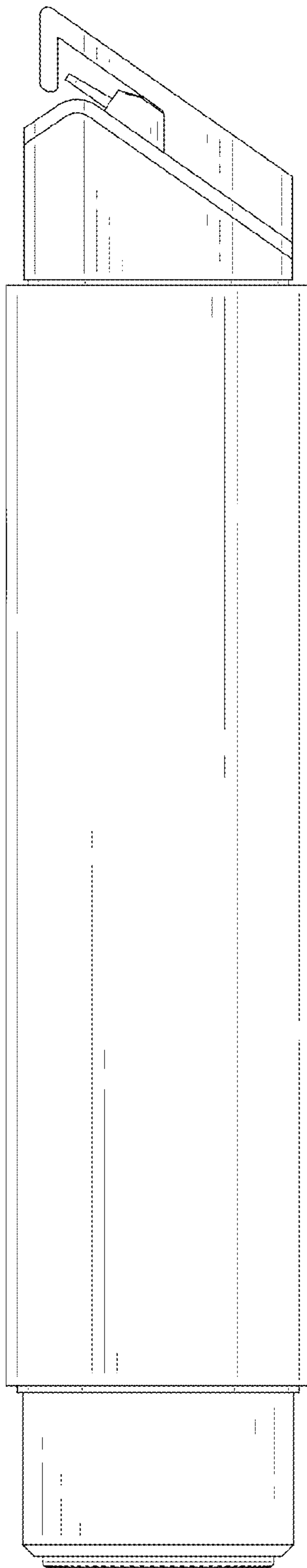

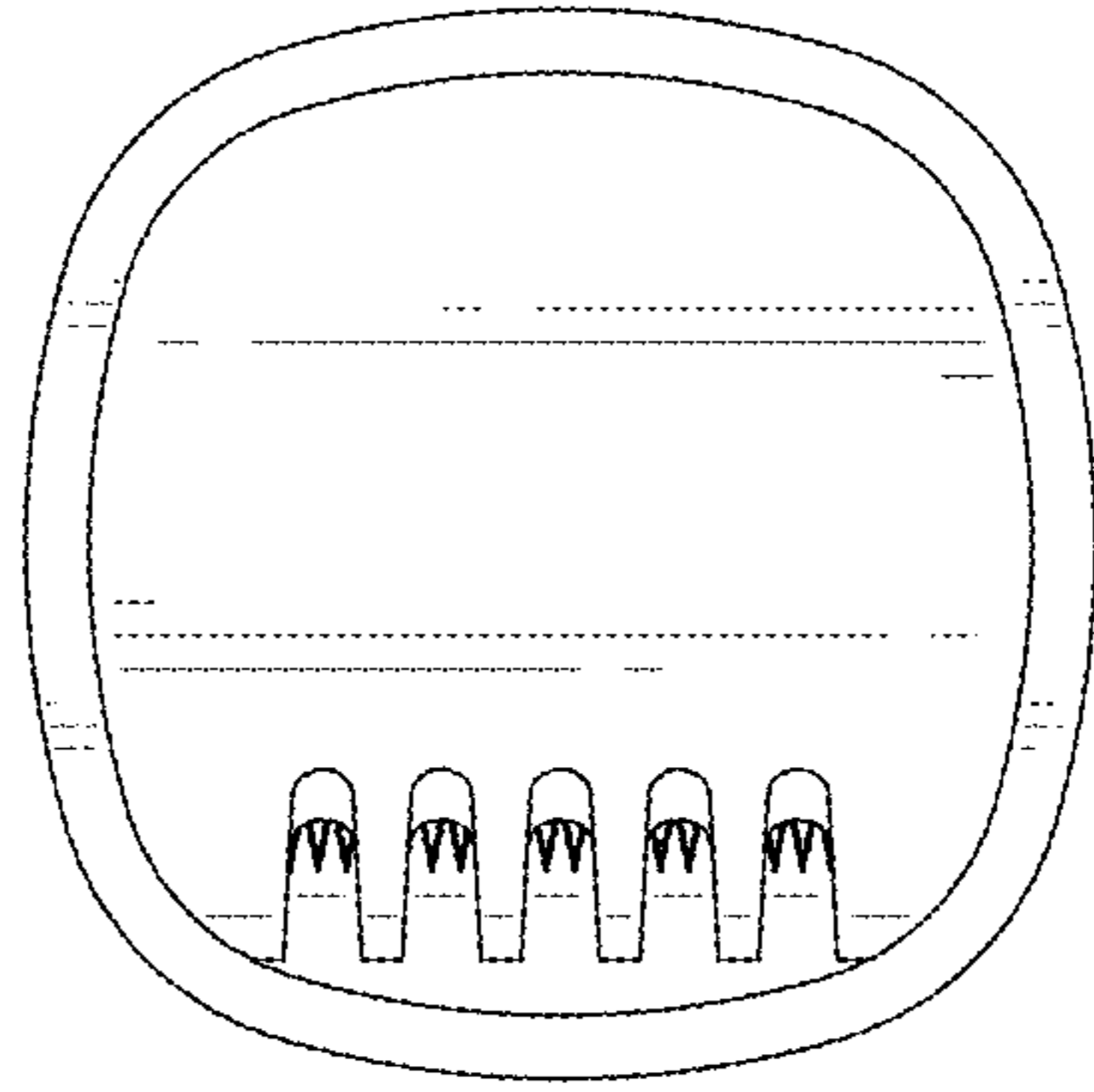

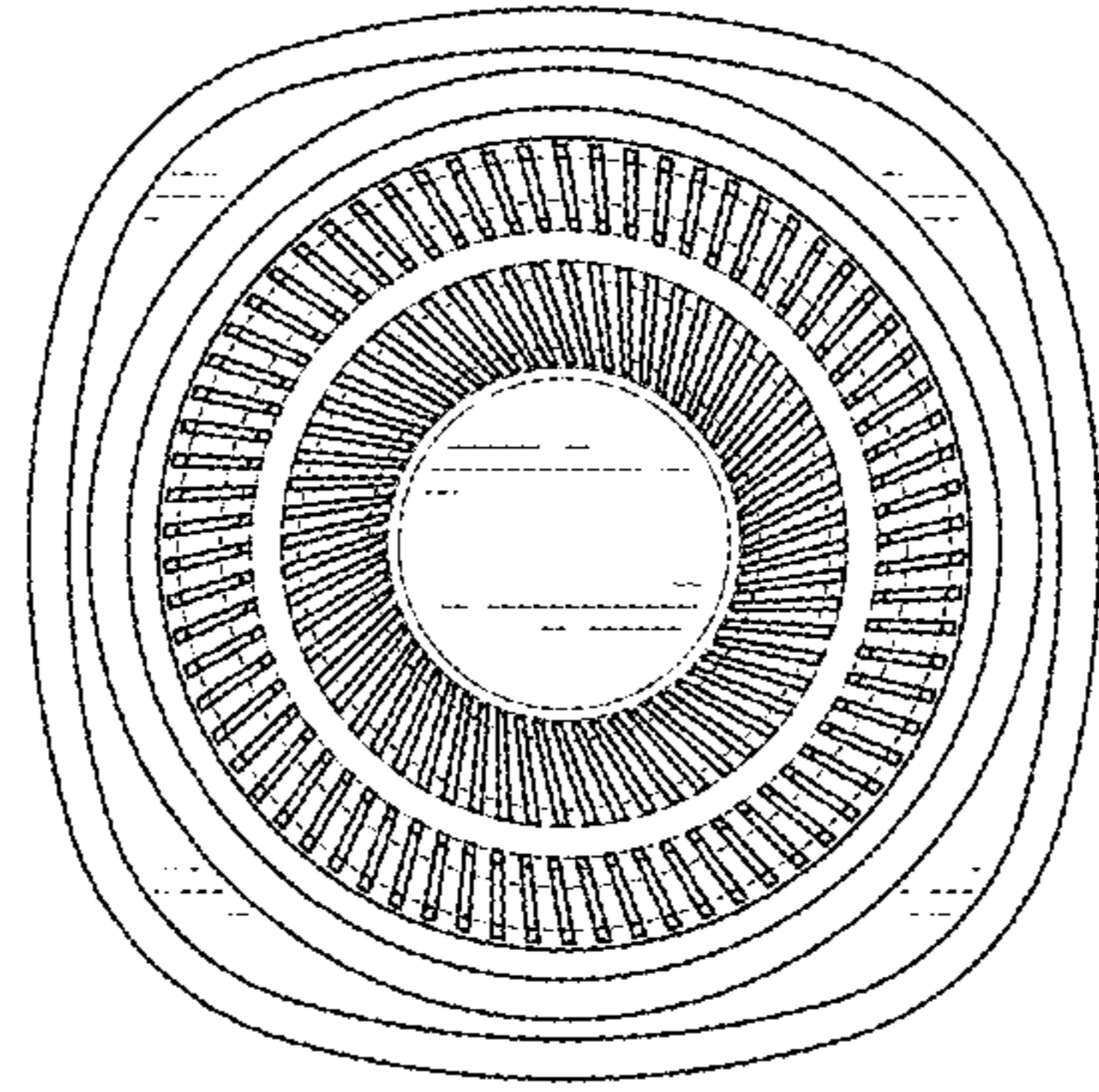

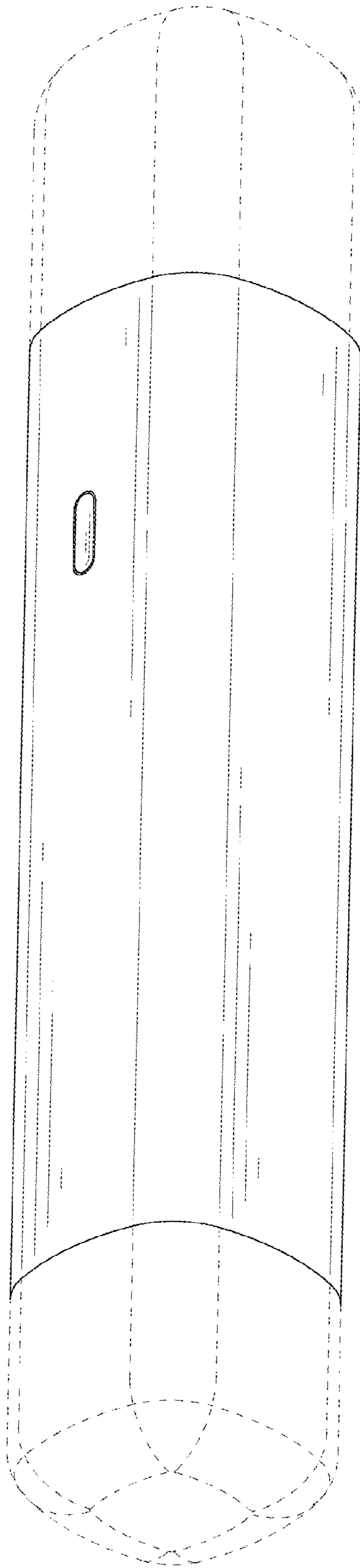

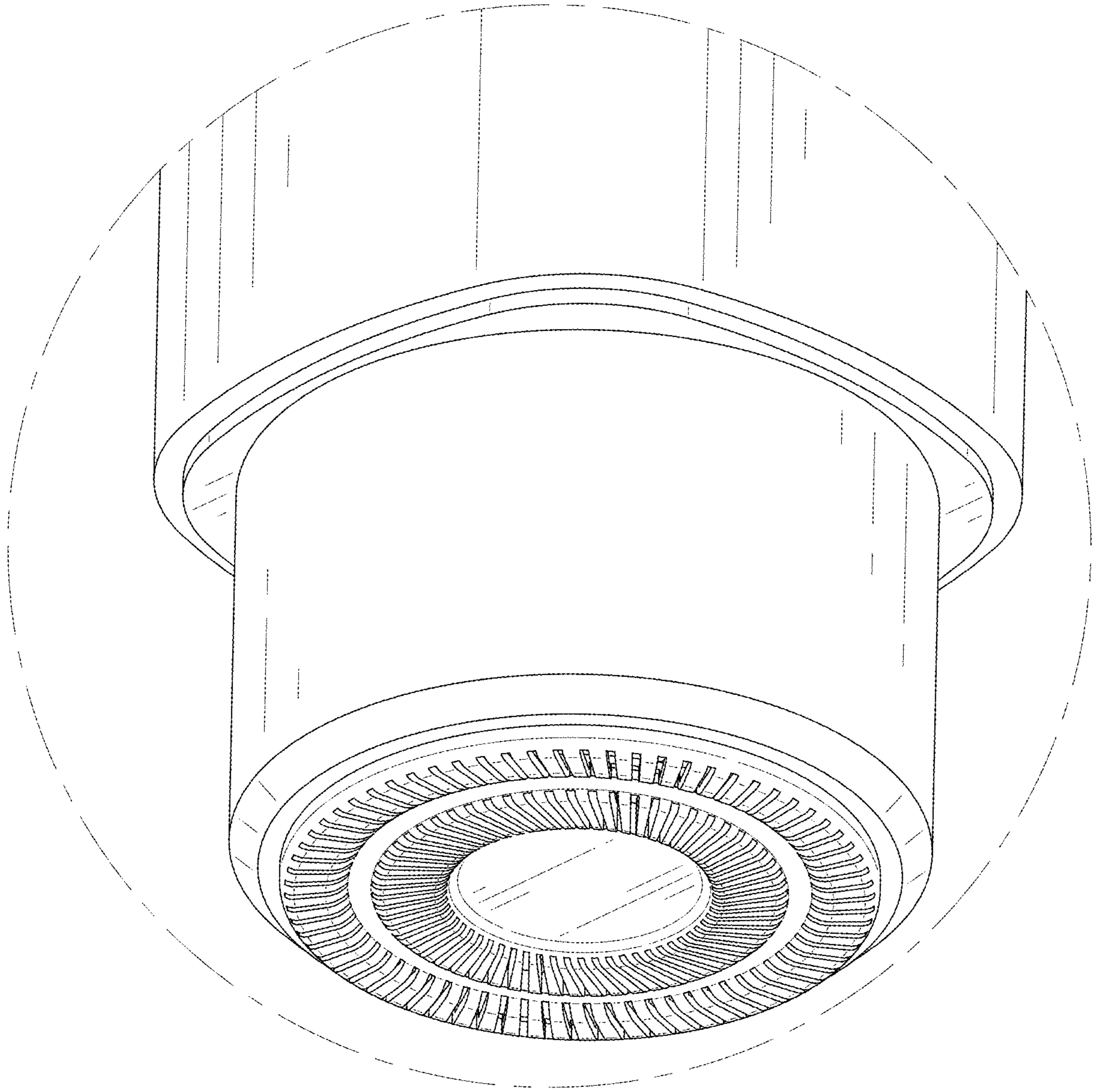
