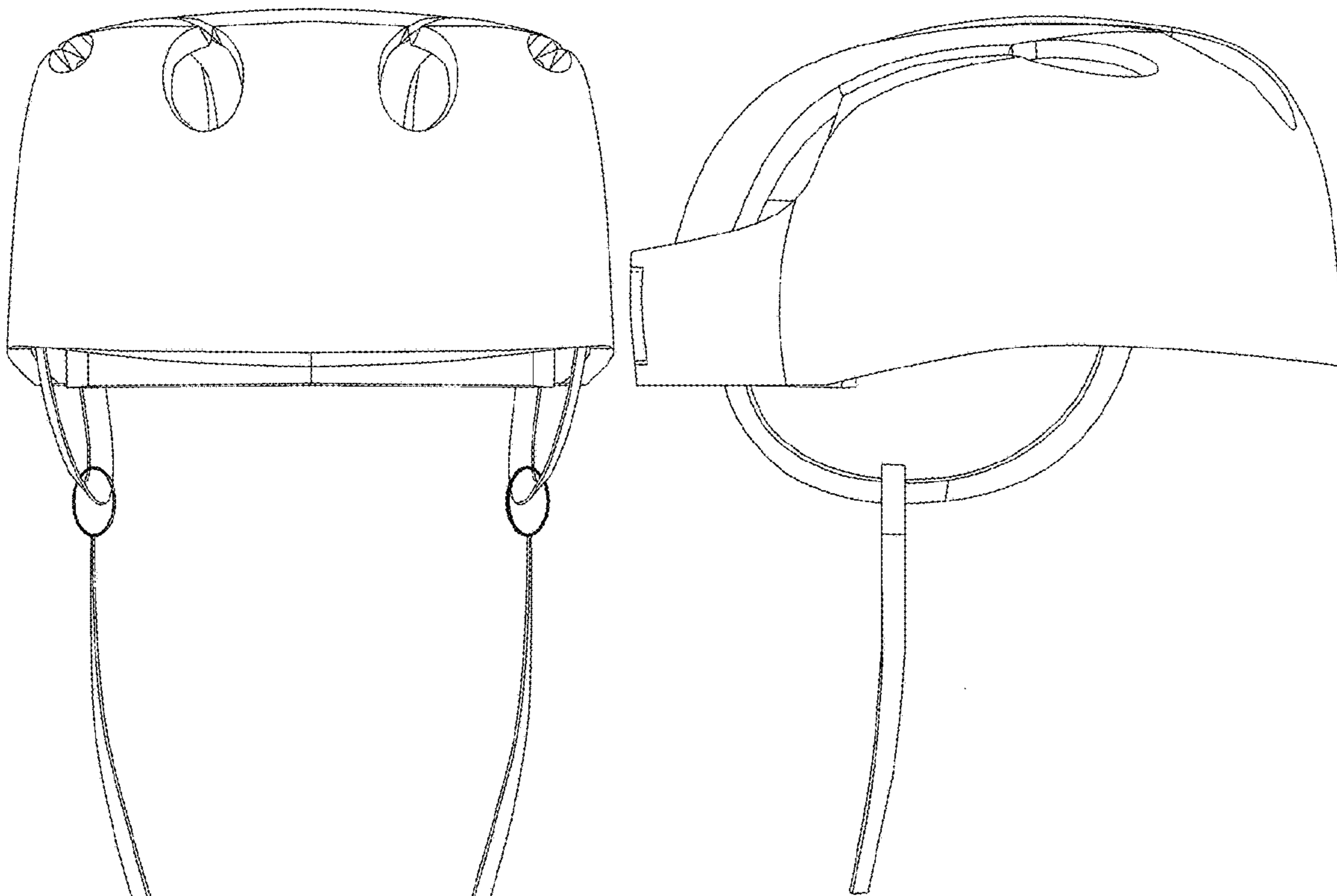
FIG. 1 is a bottom plan view of a hat of the claimed design;

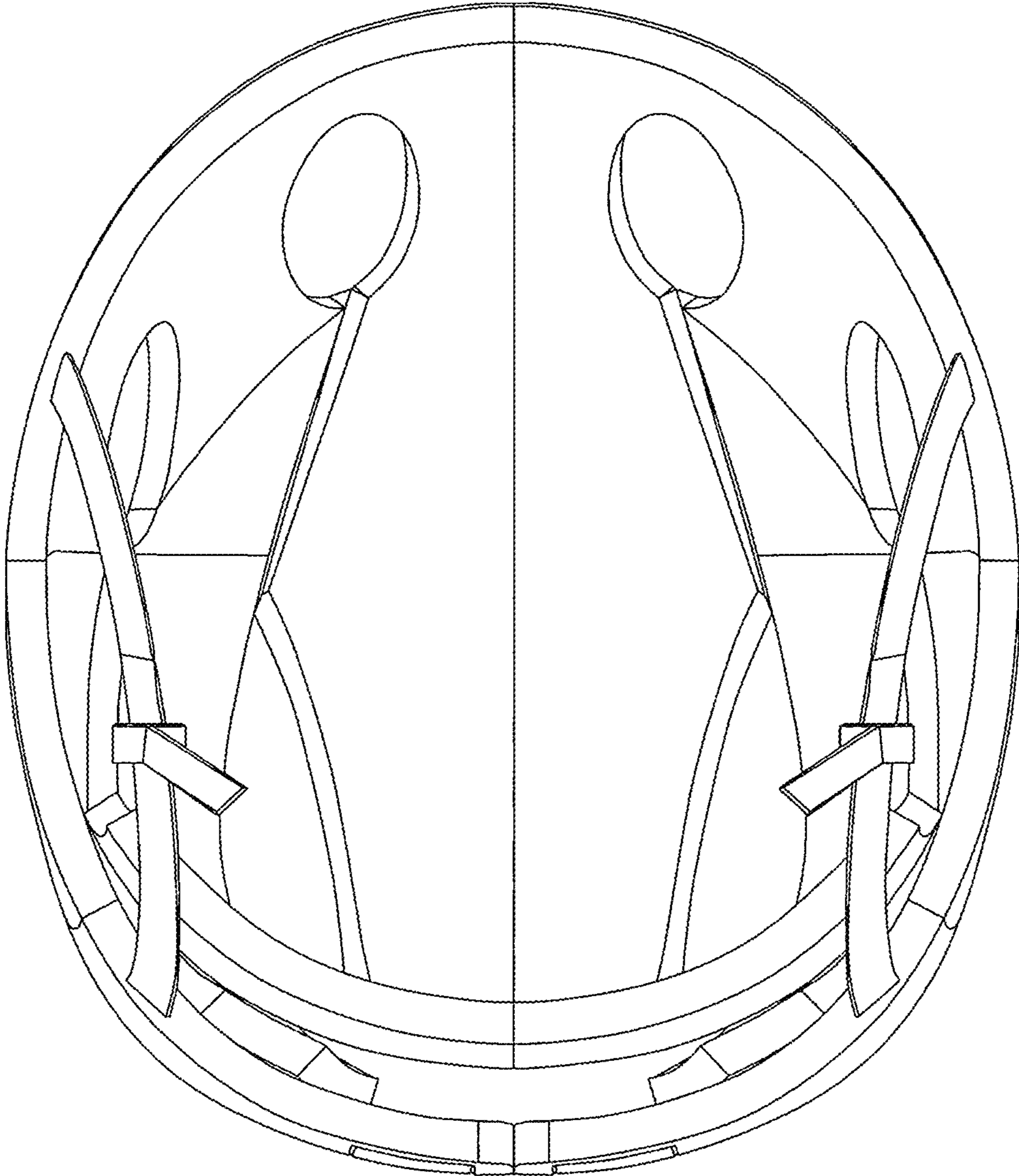

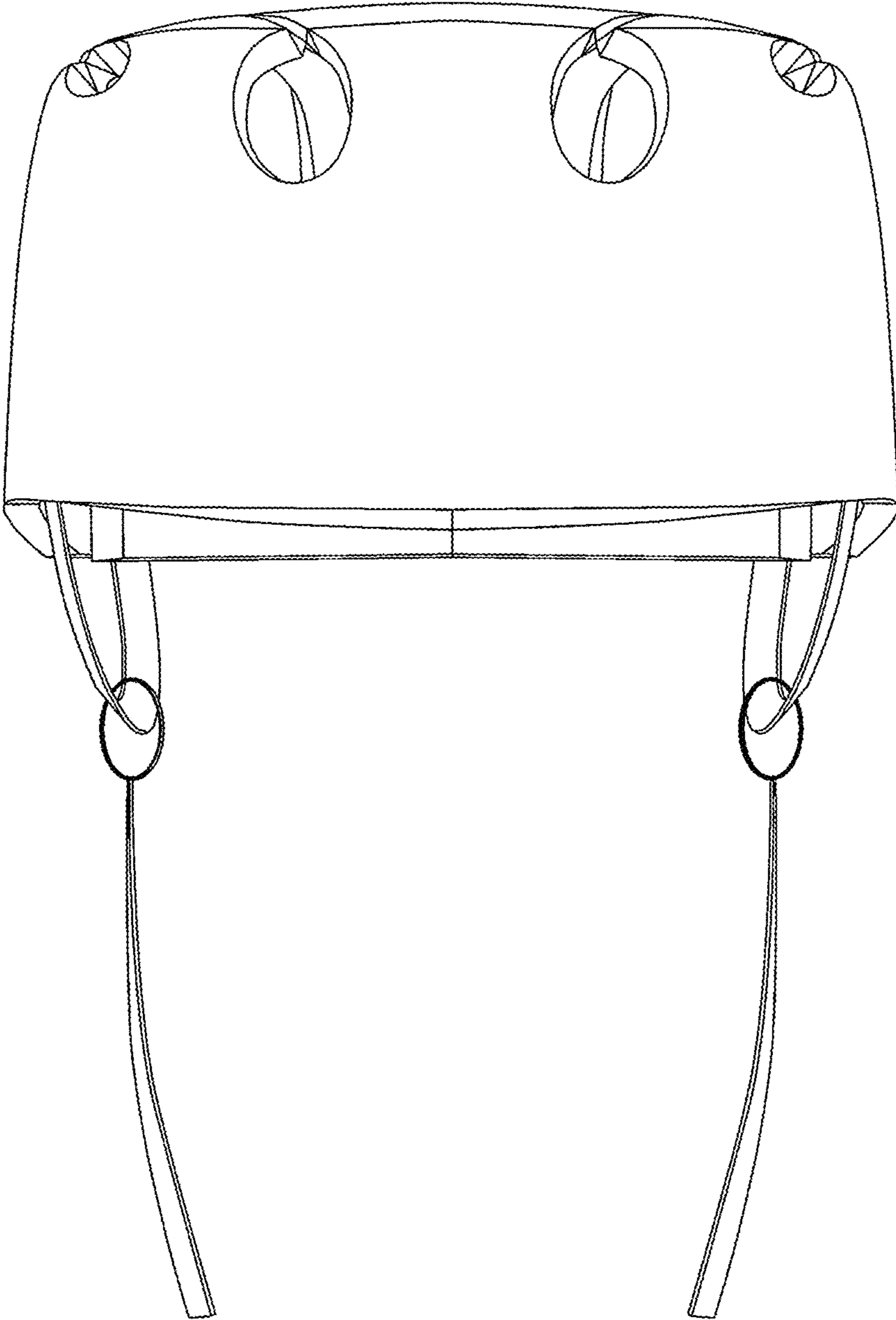

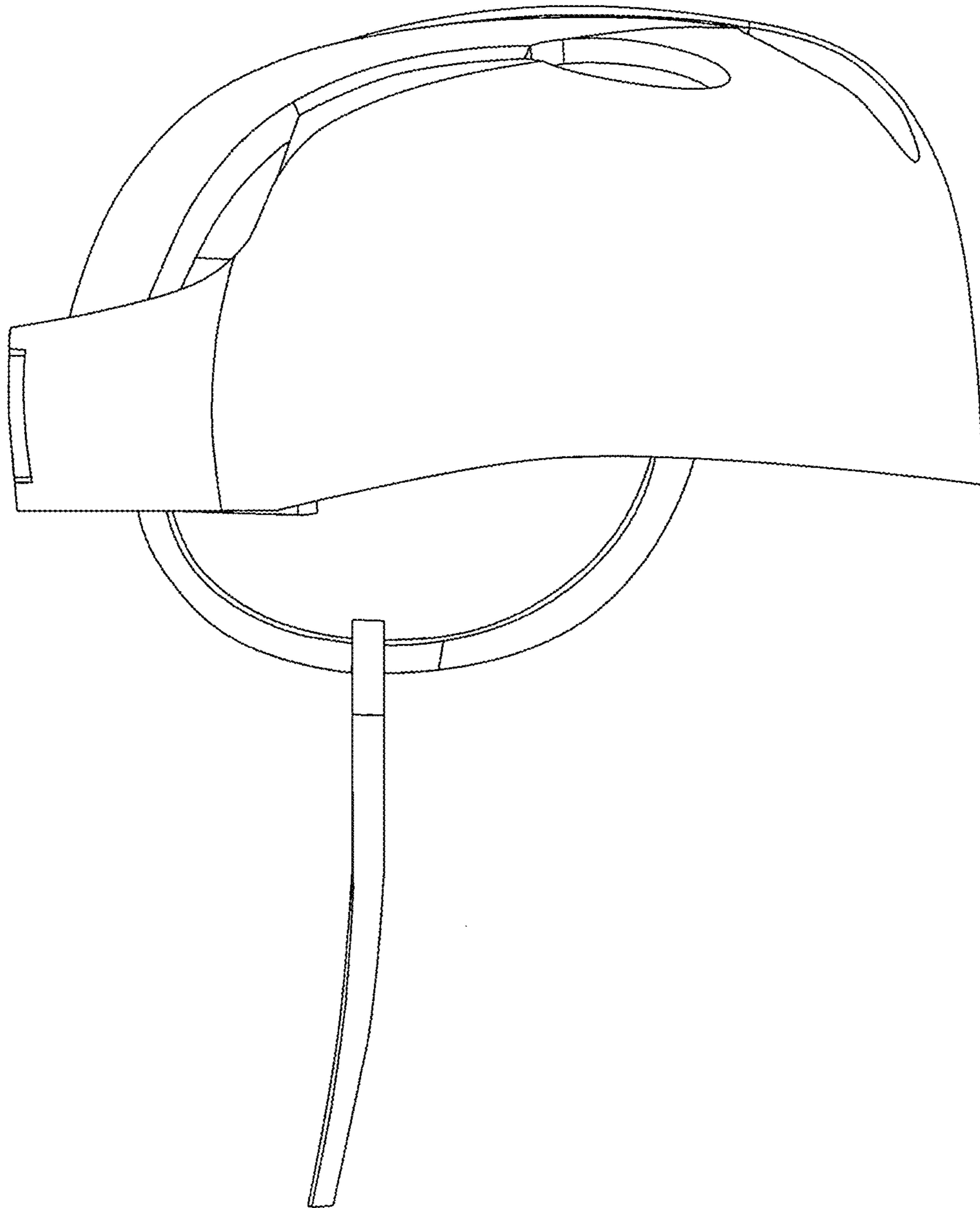

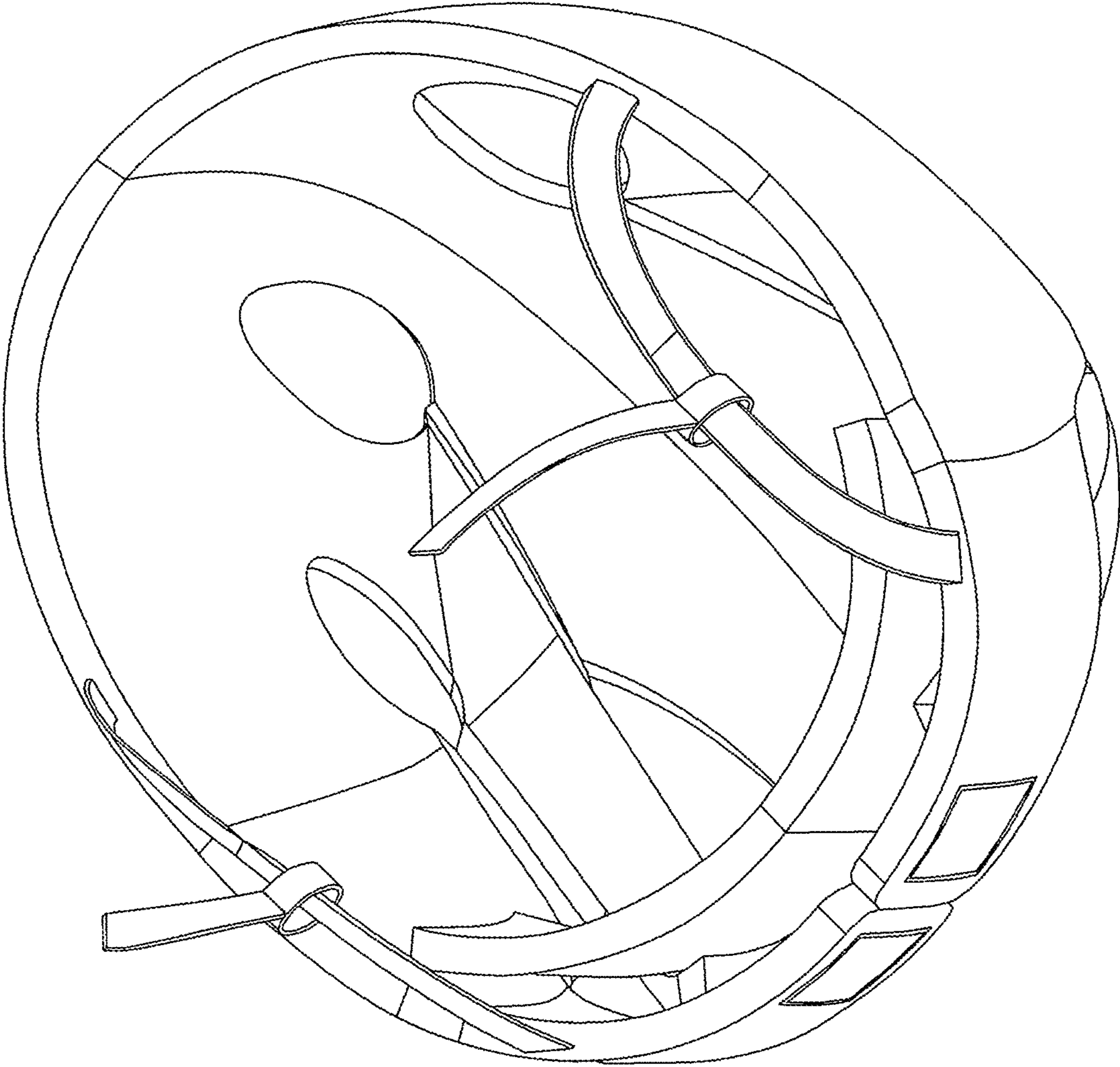

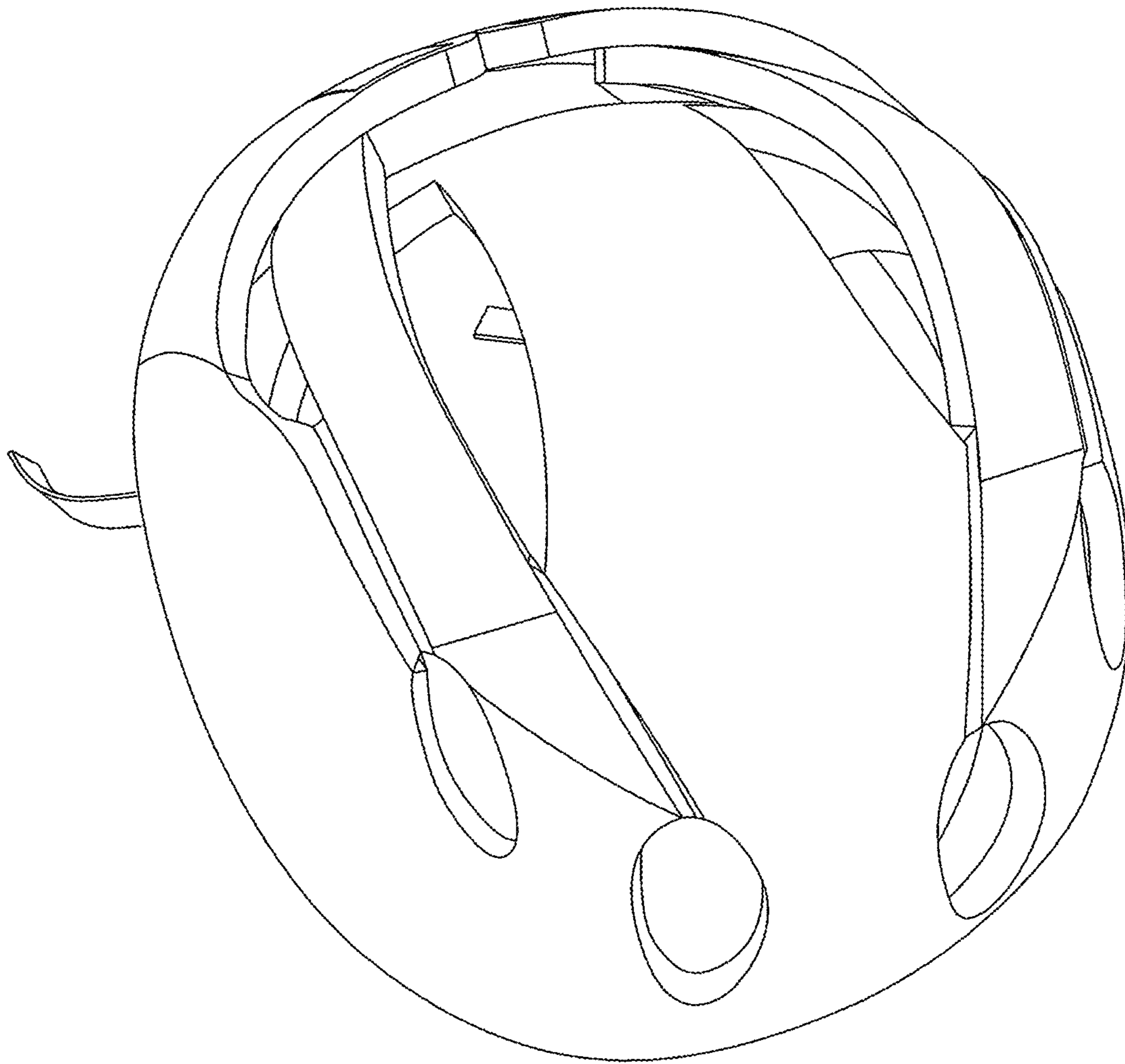

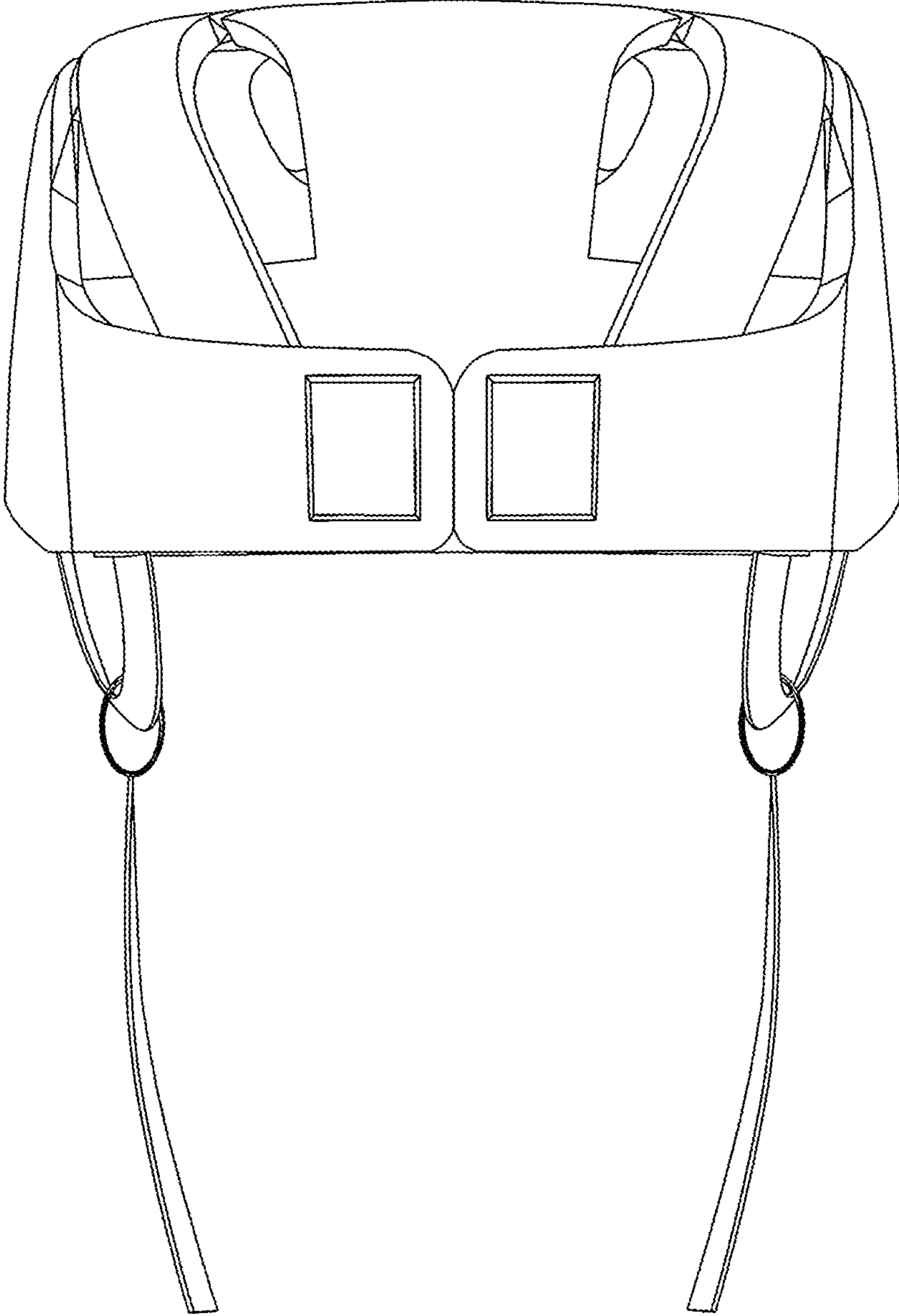

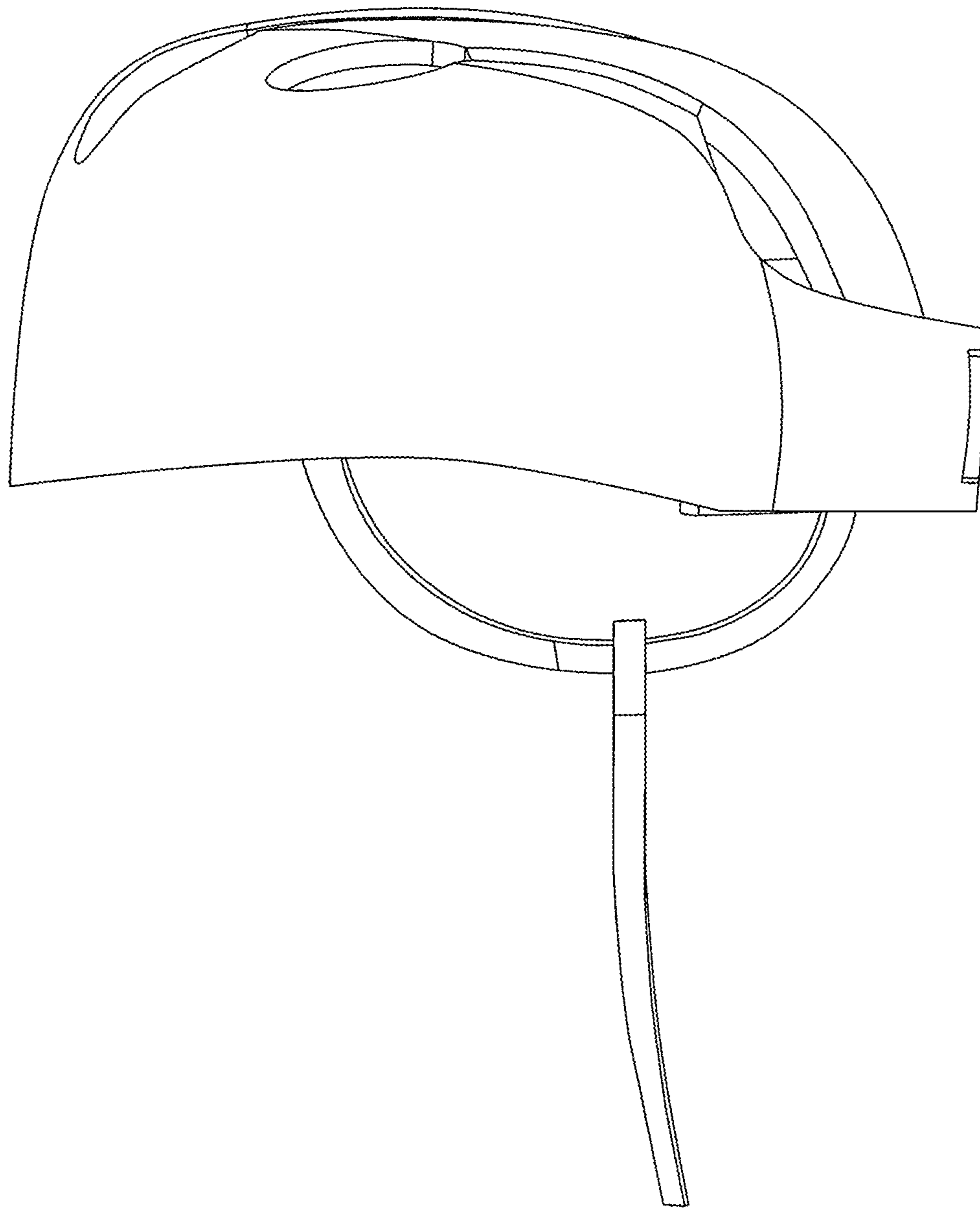

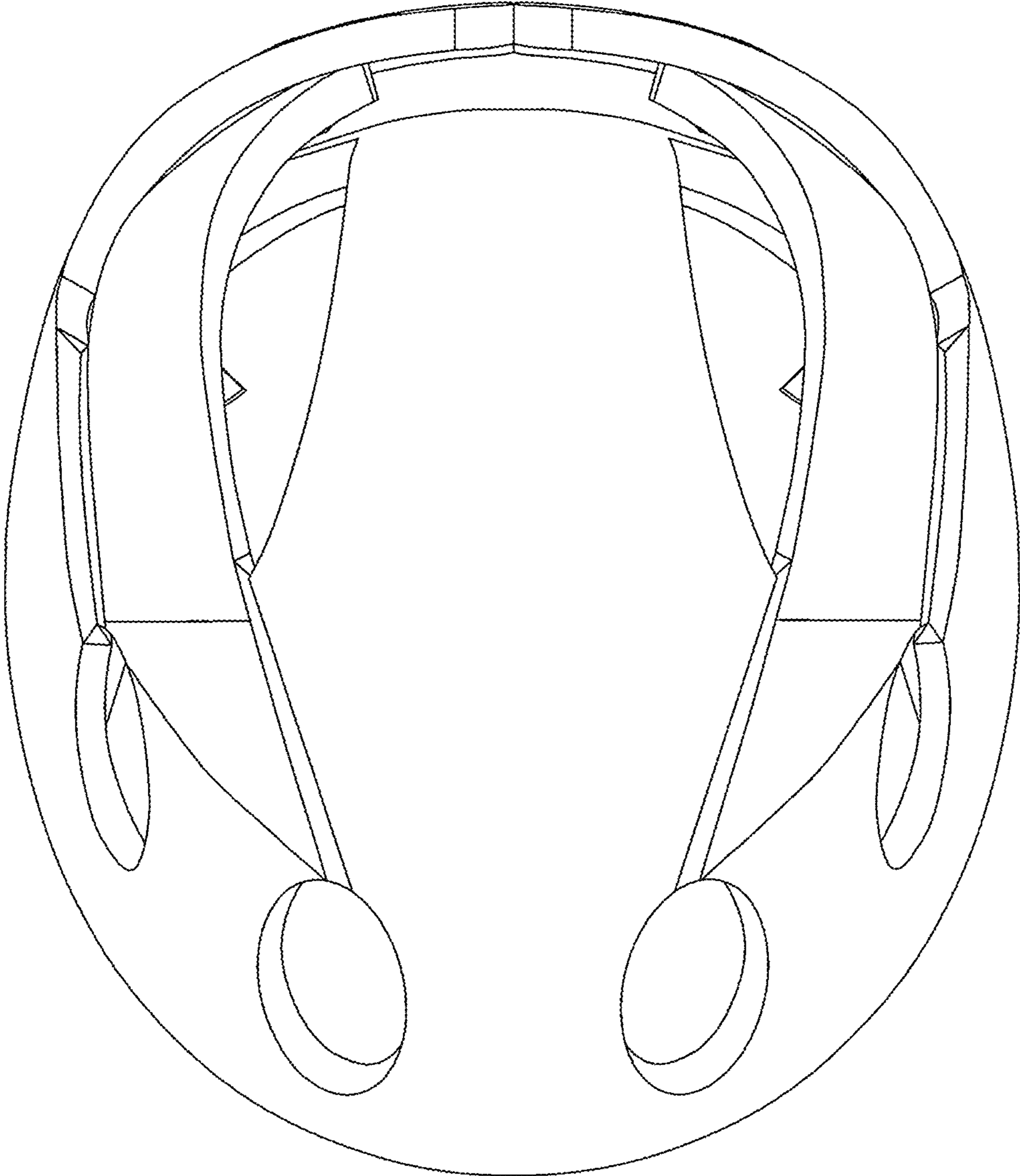
