DESCRIPTION

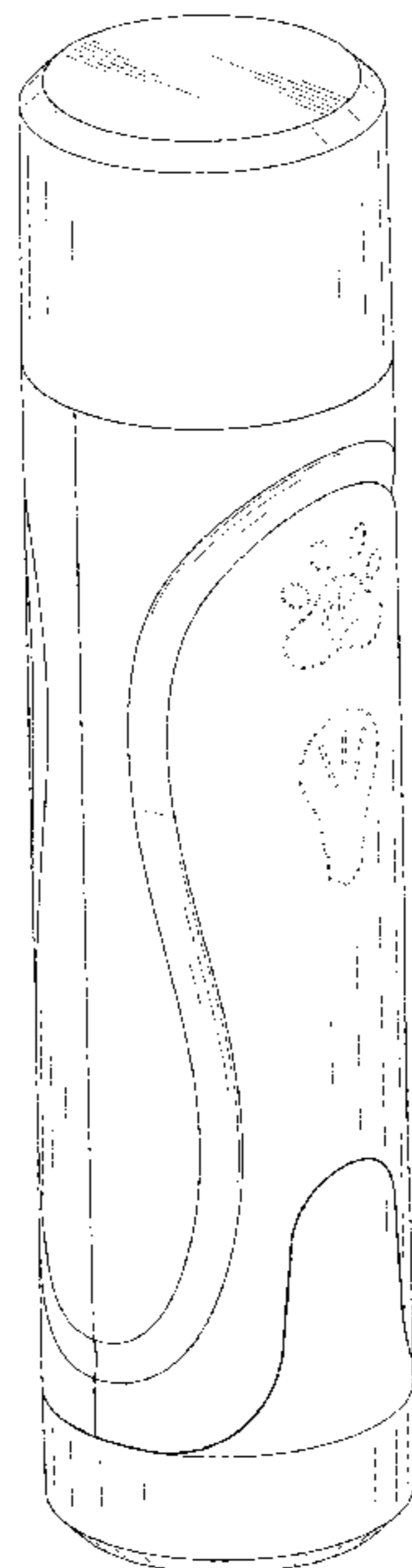
FIG. 1 is a perspective view of a pet nail grinder showing my new design;

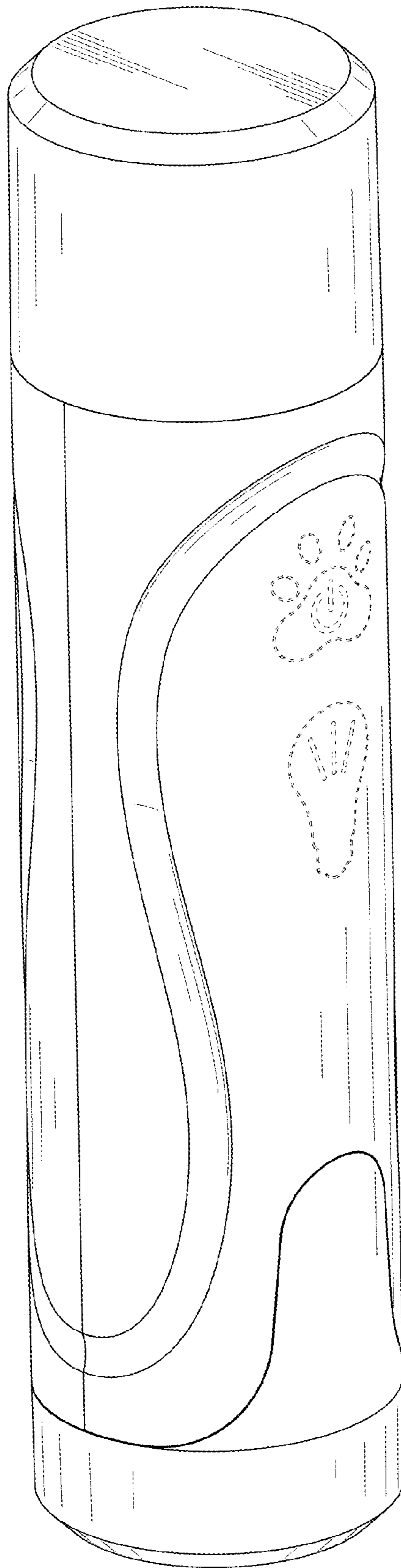

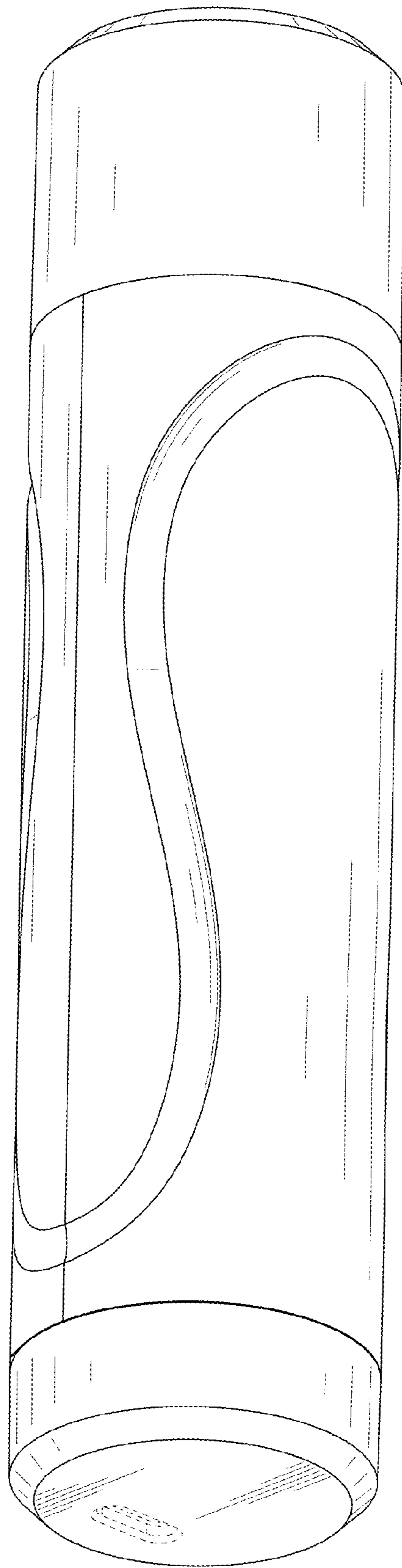

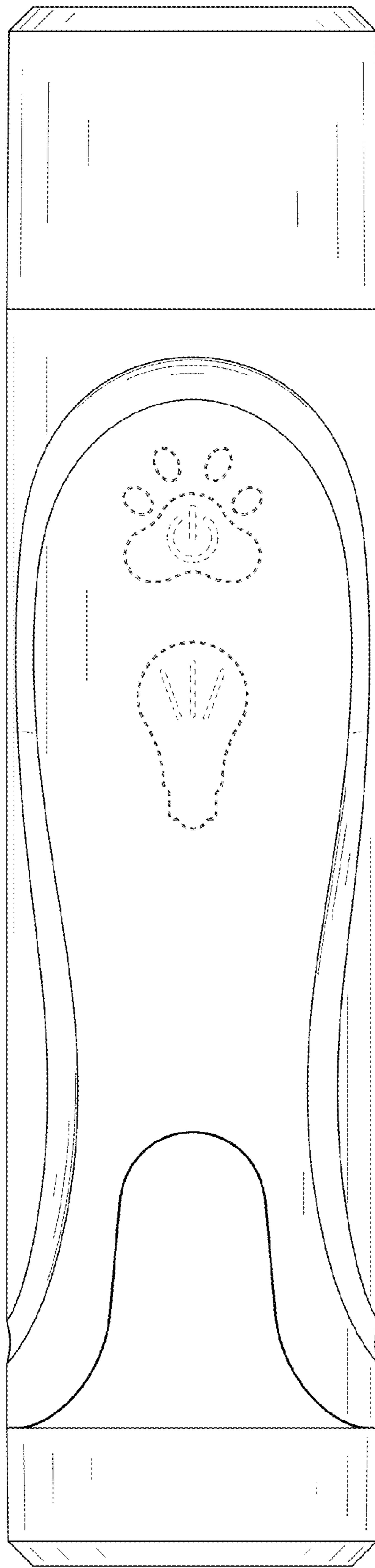

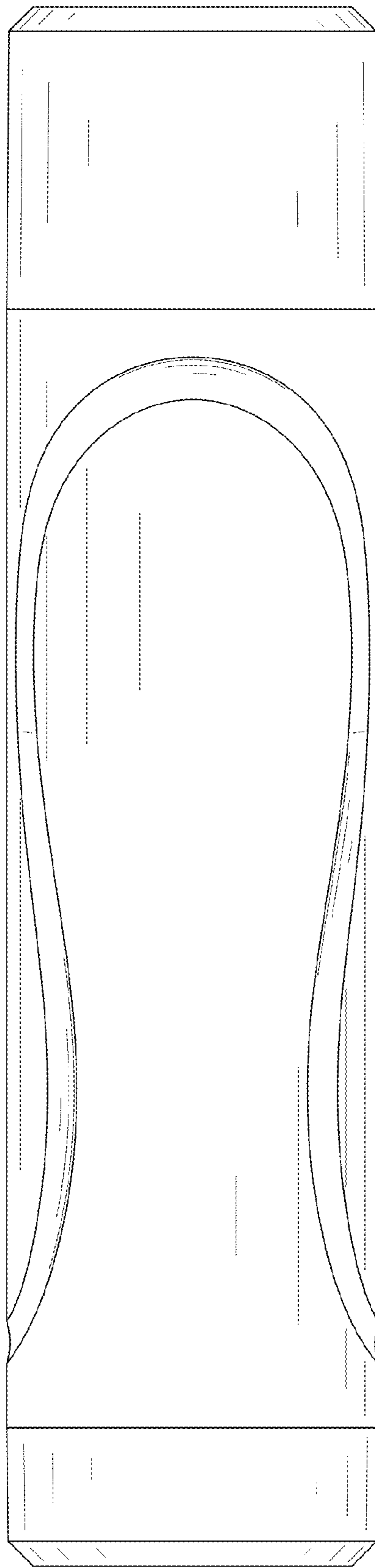

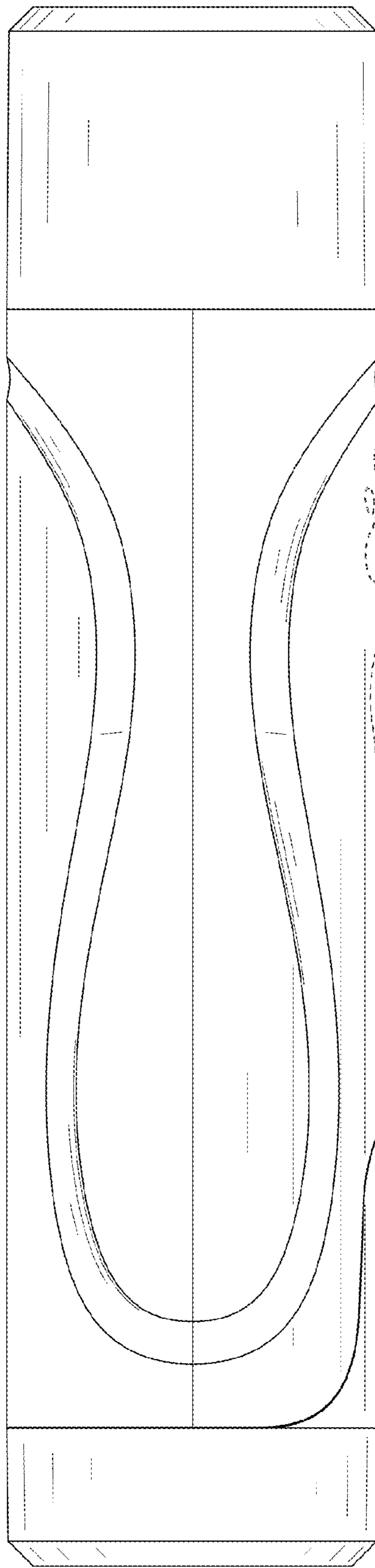

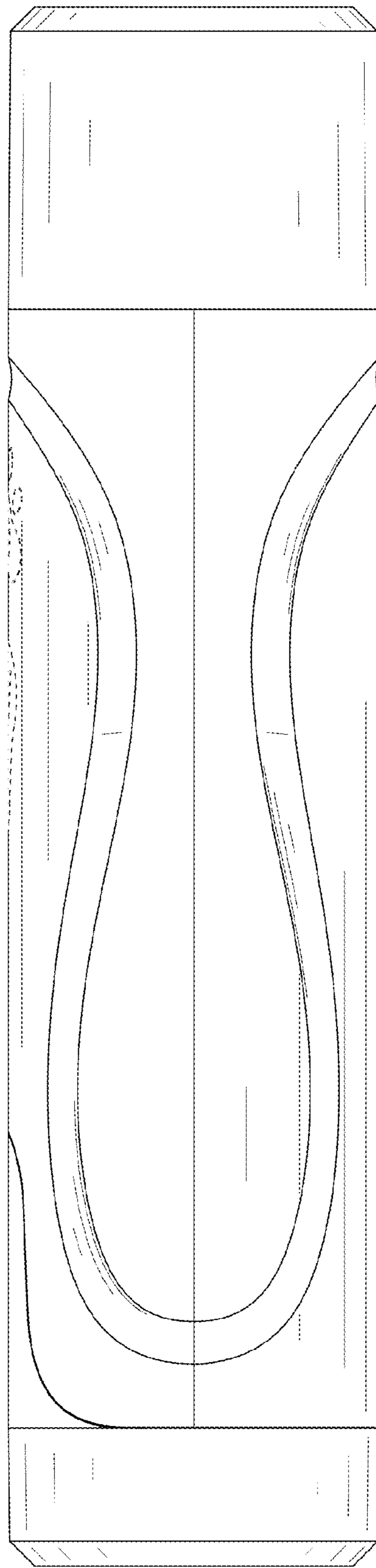

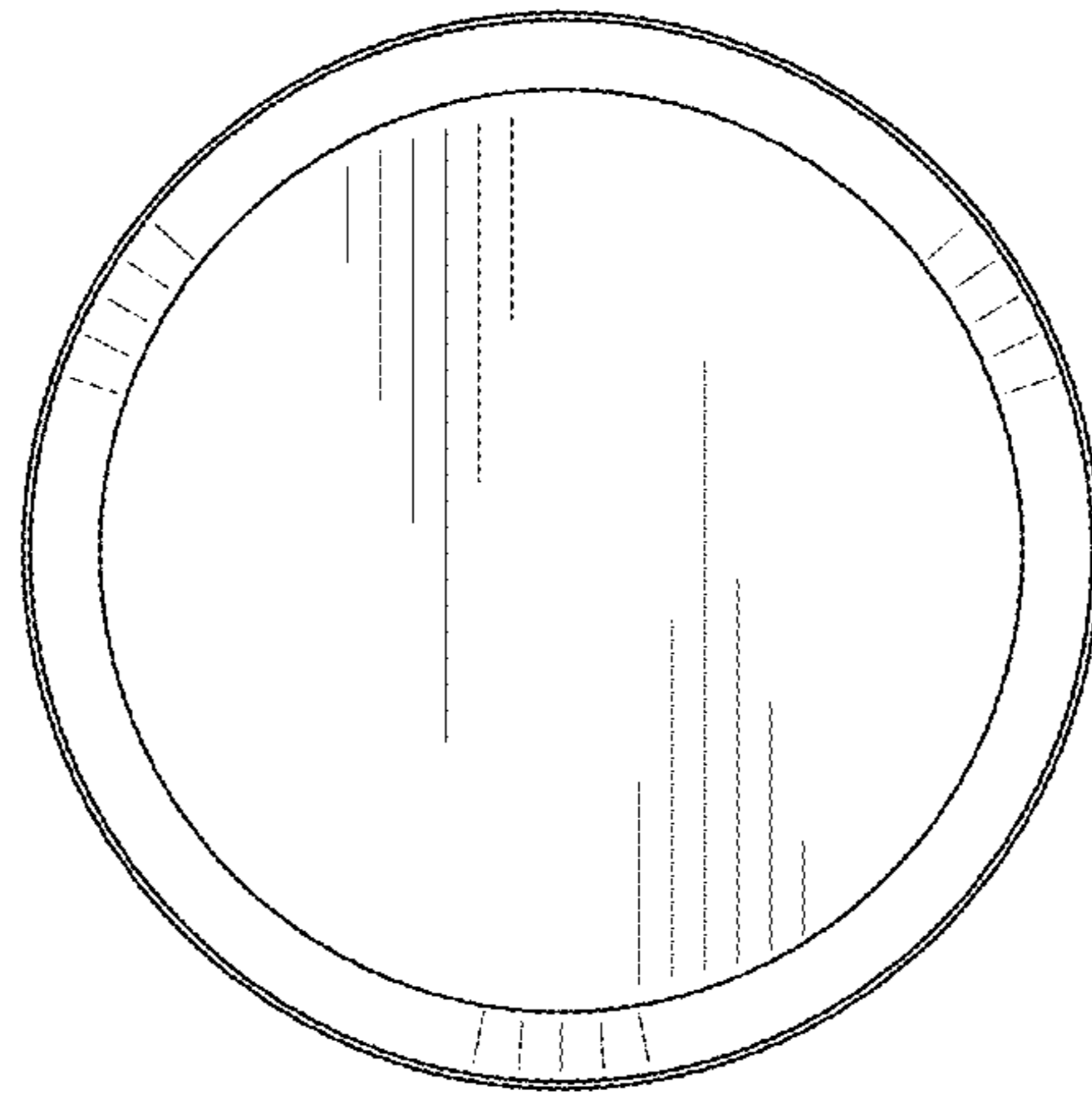

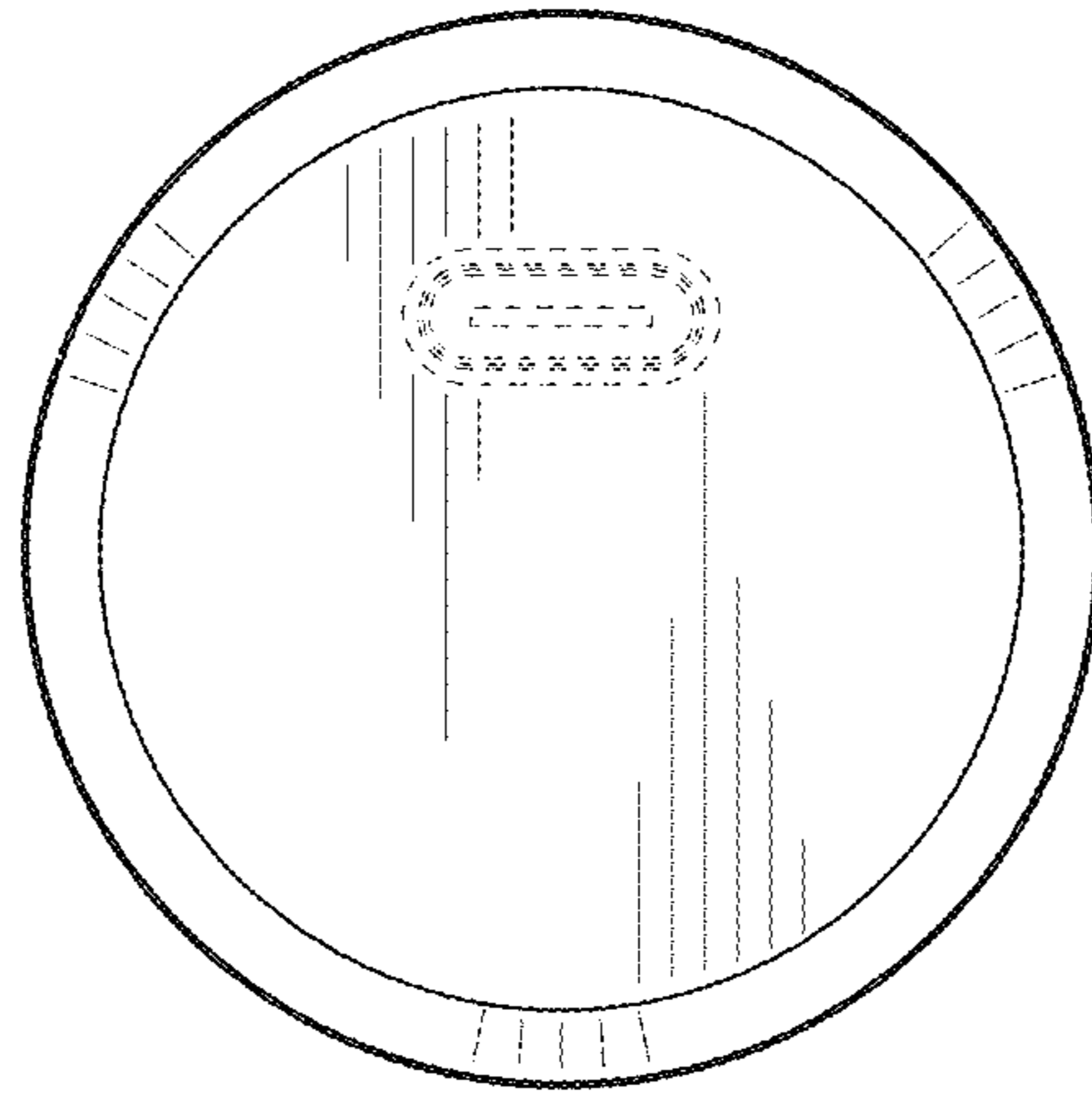

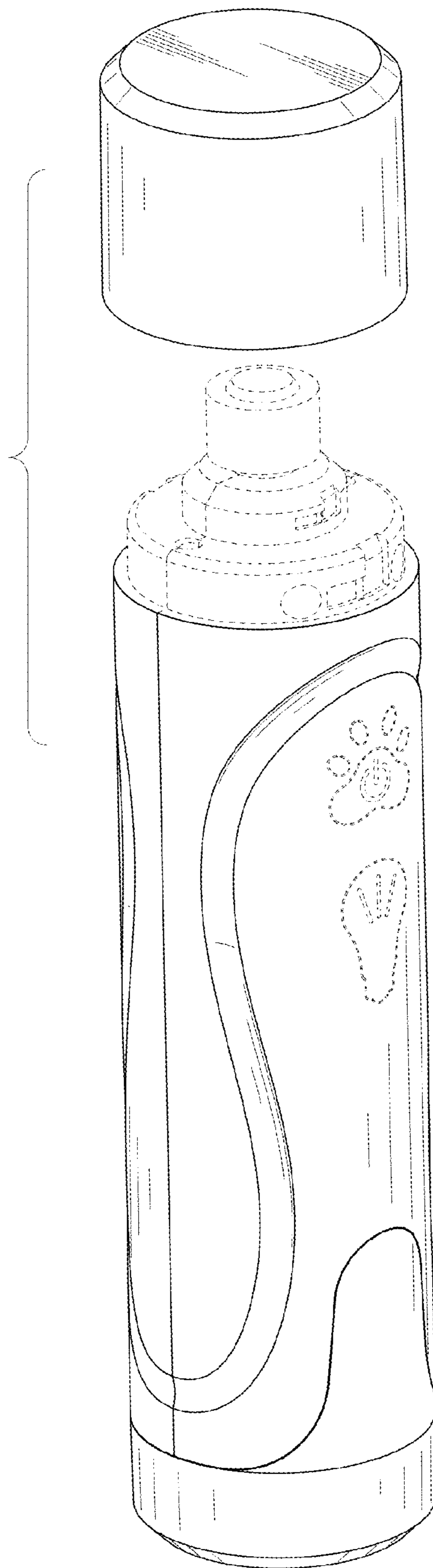
