(57) **CLAIM**

The ornamental design for an apron, as shown and described.

DESCRIPTION

FIG. 1 is a view in front elevation of an apron showing my new design, with the mask portion of the apron being shown in a folded-down position.

FIG. 2 is a right-side elevational view of the apron shown in FIG. 1, the left-side elevational view of the apron shown in FIG. 1 being a mirror image of FIG. 2;

FIG. 3 is a view in rear elevation of the apron shown in FIG. 1;

FIG. 4 is a top plan view of the apron shown in FIG. 1; FIG. 5 is a bottom plan view of the apron shown in FIG. 1; FIG. 6 is a view in front elevation of the apron of FIG. 1, showing the mask portion of the apron in an extended position;

FIG. 7 is a right-side elevational view of the apron shown in FIG. 6, the left-side elevational view of the apron shown in FIG. 6 being a mirror image of FIG. 7;

FIG. 8 is a view in rear elevation of the apron shown in FIG. 6;

FIG. 9 is a top plan view of the apron shown in FIG. 6; FIG. 10 is a bottom plan view of the apron shown in FIG. 6;

FIG. 11 is a view in front elevation of a second embodiment of the apron, with the mask portion of the apron being shown in a folded-down position;

FIG. 12 is a right-side elevational view of the apron shown in FIG. 11, the left-side elevational view of the apron shown in FIG. 11 being a mirror image of FIG. 12;

FIG. 13 is a view in rear elevation of the apron shown in FIG. 11;

FIG. 14 is a top plan view of the apron shown in FIG. 11; FIG. 15 is a bottom plan view of the apron shown in FIG. 11;

FIG. 16 is a view in front elevation of the apron of FIG. 1, showing the mask portion of the apron in an extended position;

FIG. 17 is a right-side elevational view of the apron shown in FIG. 16, the left-side elevational view of the apron shown in FIG. 16 being the mirror image of FIG. 17;

FIG. 18 is a view in rear elevation of the apron shown in FIG. 16;

FIG. 19 is a top plan view of the apron shown in FIG. 16; and

FIG. 20 is a bottom plan view of the apron shown in FIG. 16;

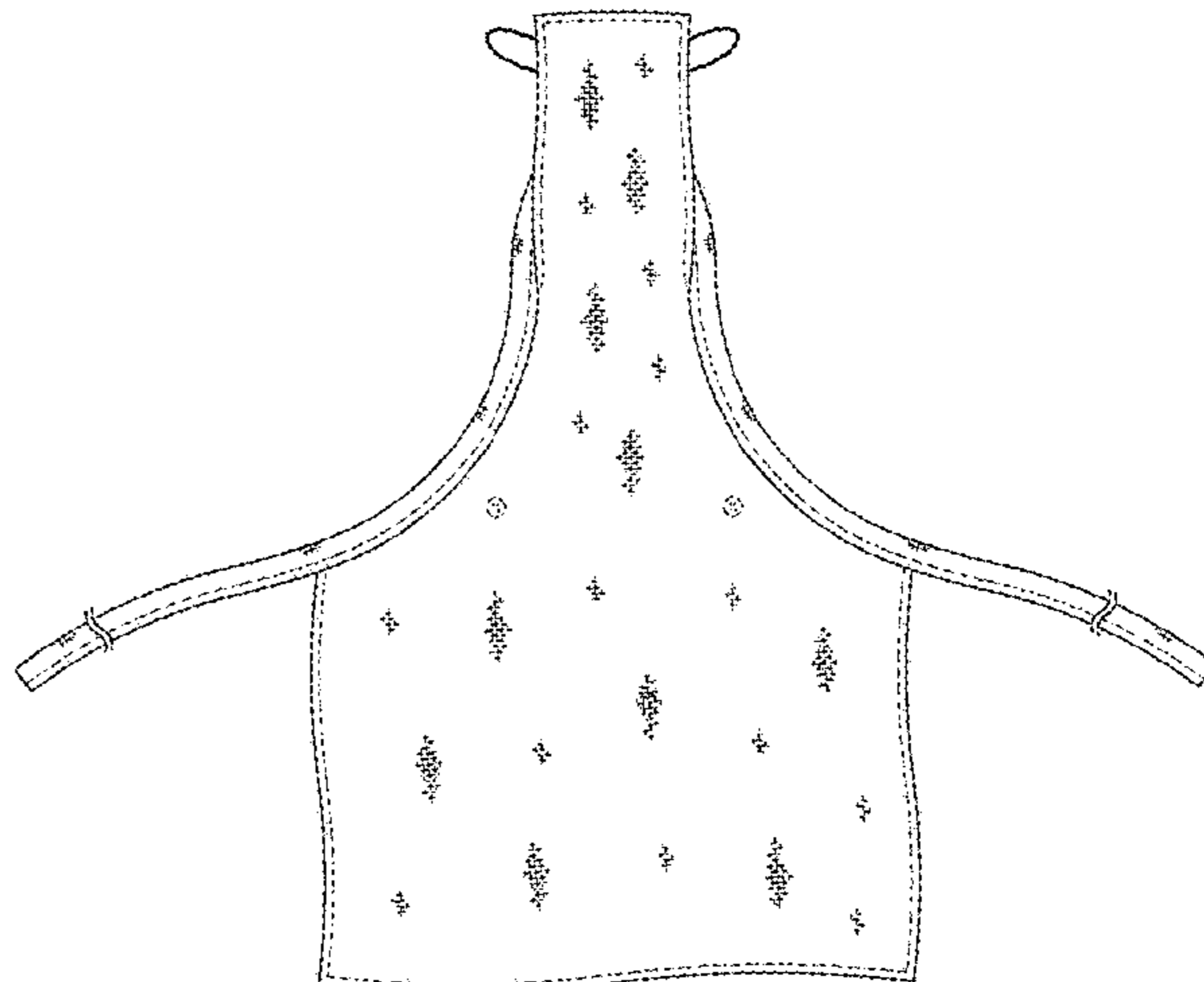
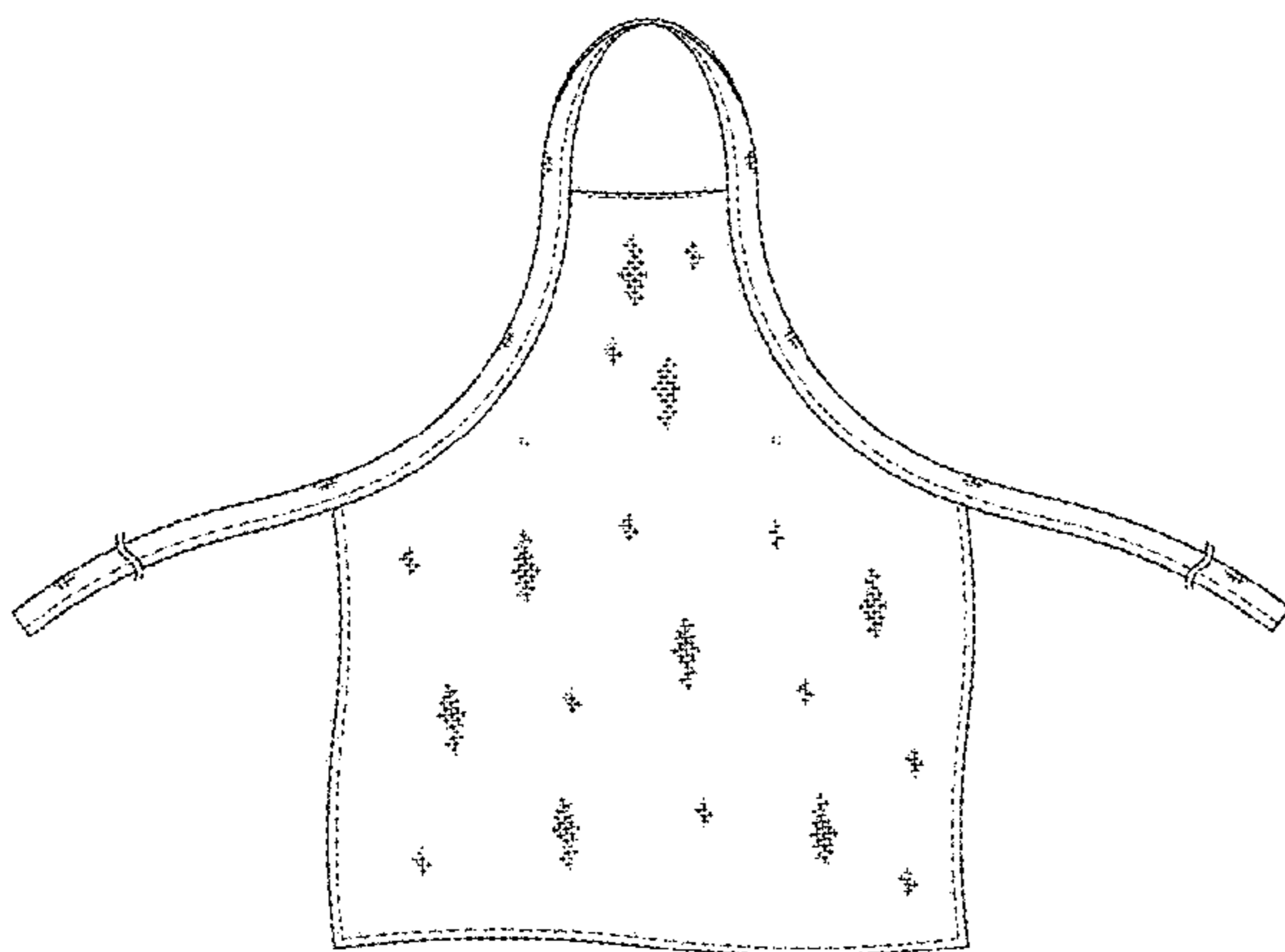


FIG. 21 is a view in front elevation of a third embodiment of the apron, with the mask portion of the apron being shown in a folded-down position;

 FIG. 33 is a view in rear elevation of the apron shown in FIG. 31;

 FIG. 35 is a bottom plan view of the apron shown in FIG. 31;
 FIG. 36 is a view in front elevation of the apron of FIG. 31, showing the mask portion of the apron in an extended position;
 FIG. 37 is a right-side elevational view of the apron shown in FIG. 36, the left-side elevational view of the apron shown in FIG. 36 being a mirror image of FIG. 37;
 FIG. 38 is a view in rear elevation of the apron shown in FIG. 36;

FIG. 39 is a top plan view of the apron shown in FIG. 36; and,
 FIG. 40 is a bottom plan view of the apron shown in FIG. 36.
 The broken lines show stitching on the apron that forms no part of the claimed design. The broken lines illustrating buttons on the apron show portions of the article that form no part of the claimed design.
 The apron is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.
 The cross hatching shown in the drawings indicates a material, such as fabric, only and does not represent any particular color, texture, pattern or finish.

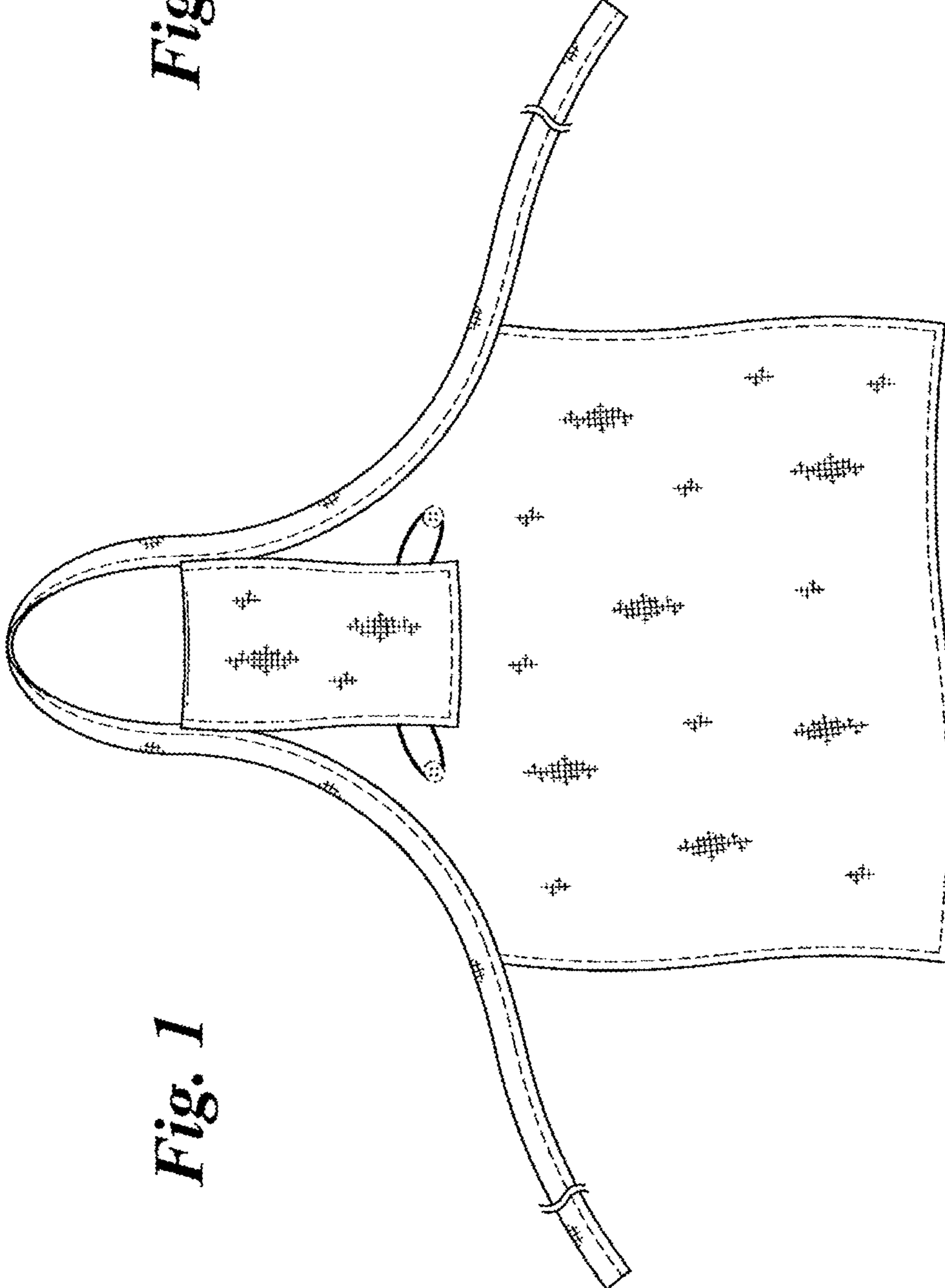

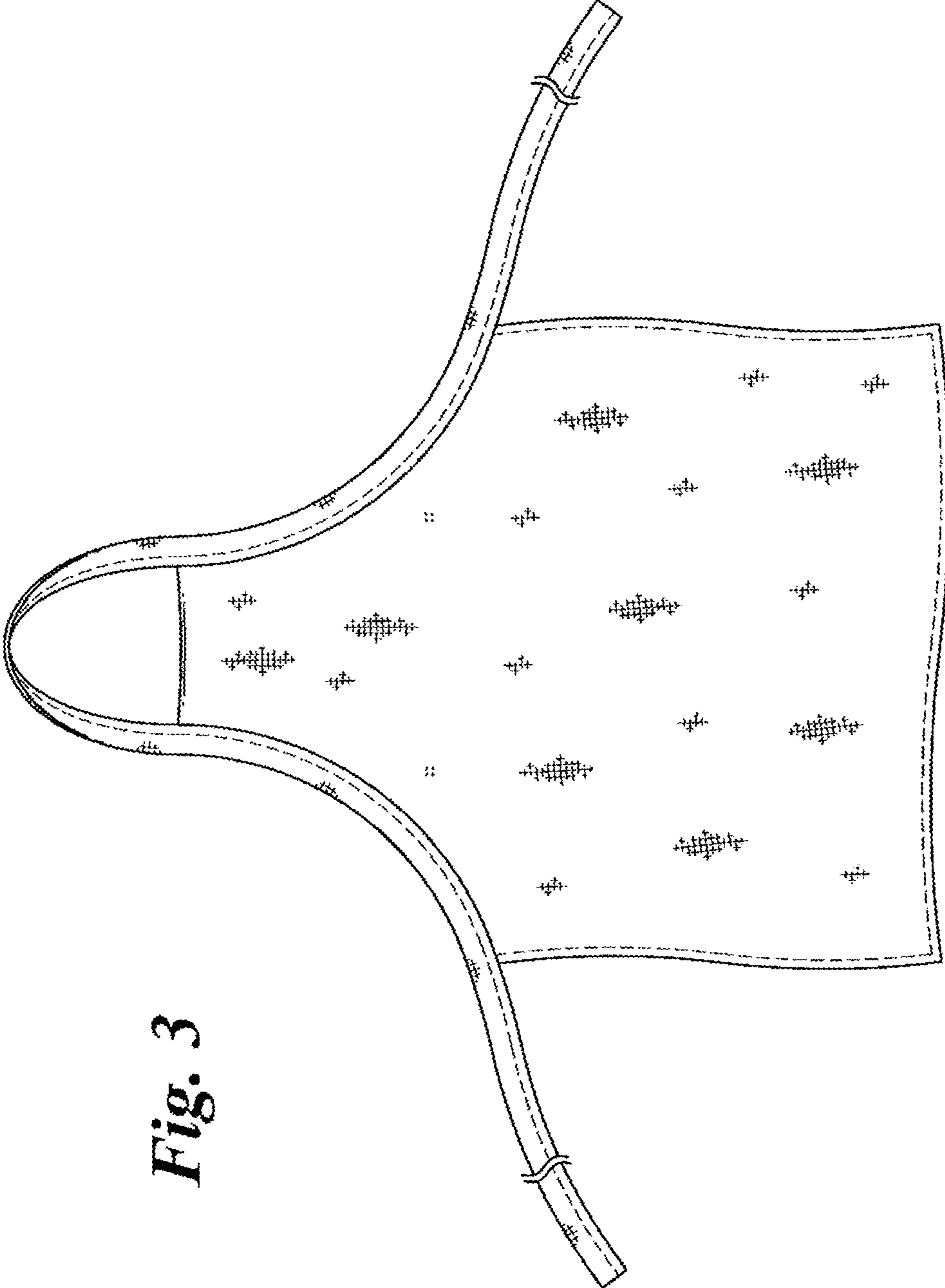

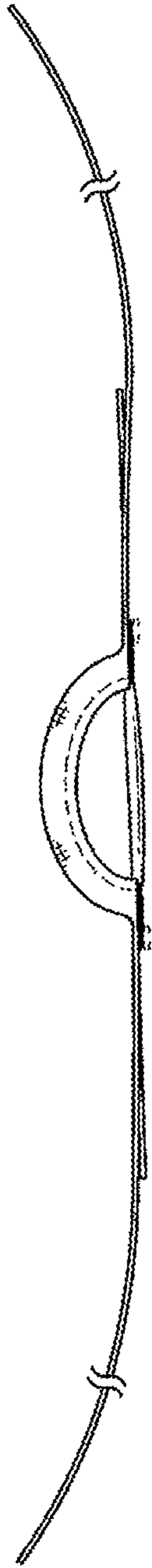

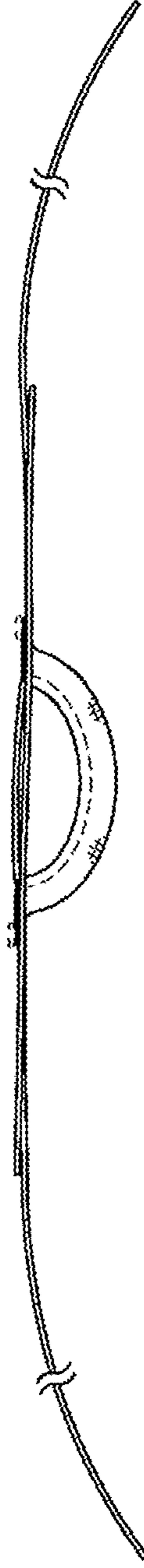

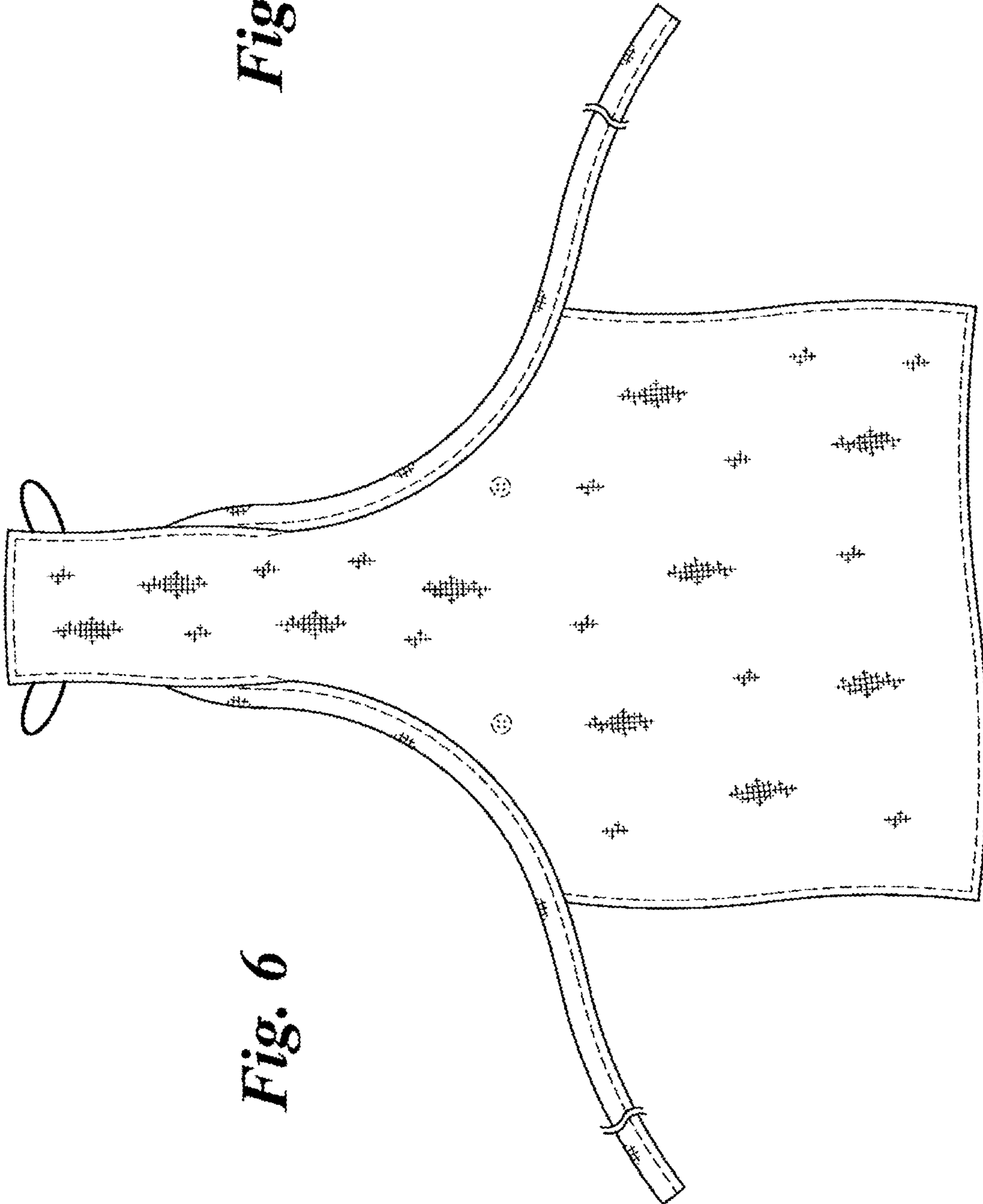

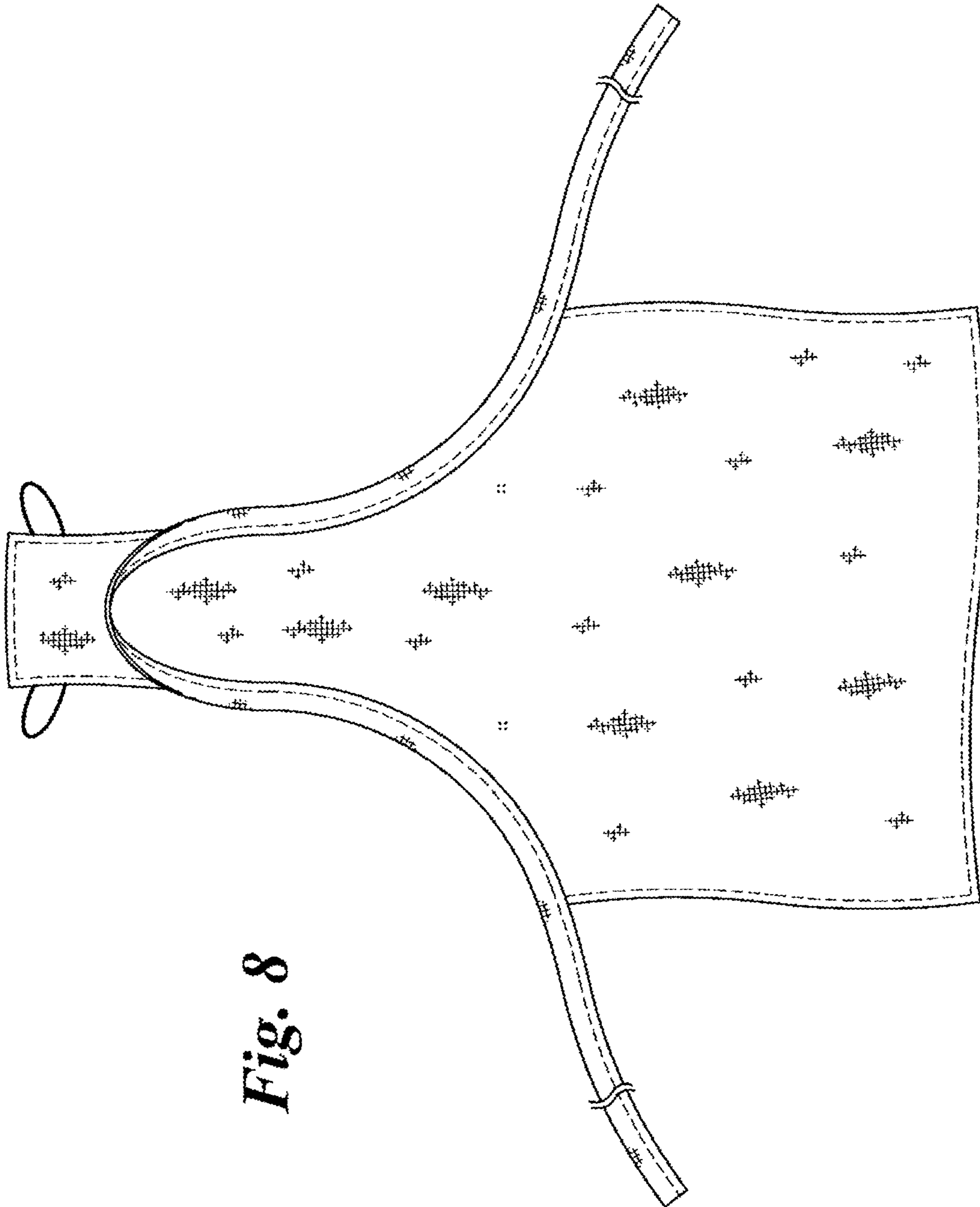

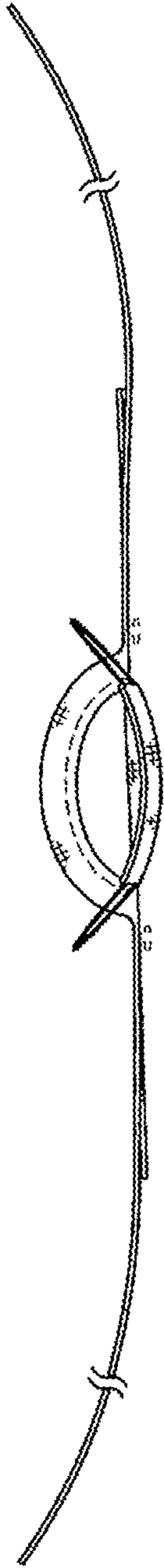

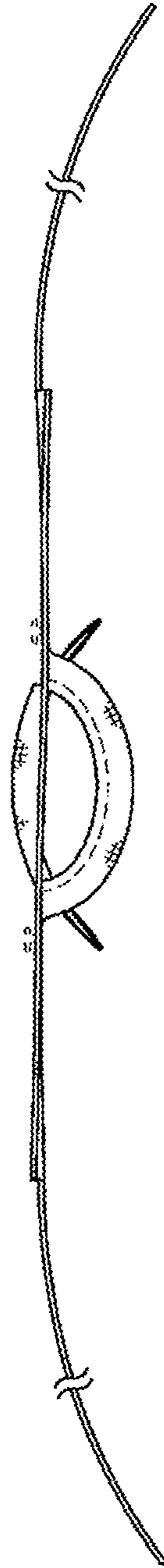

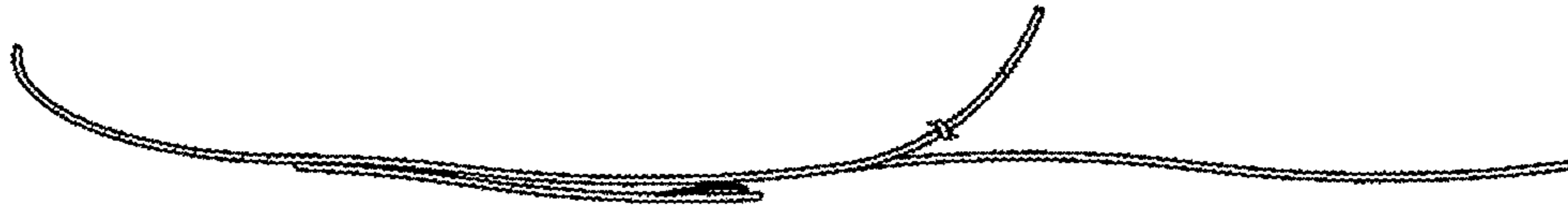

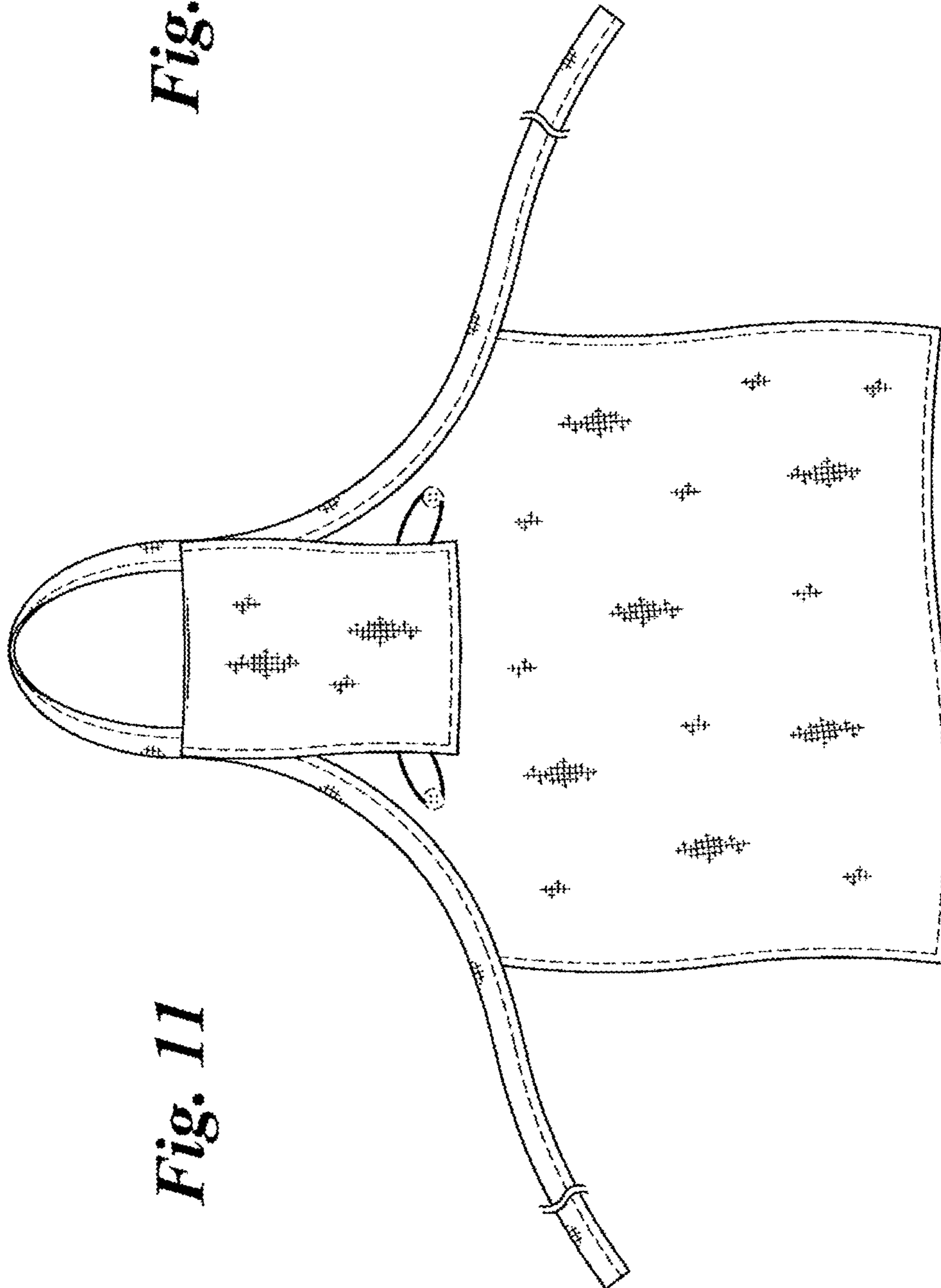

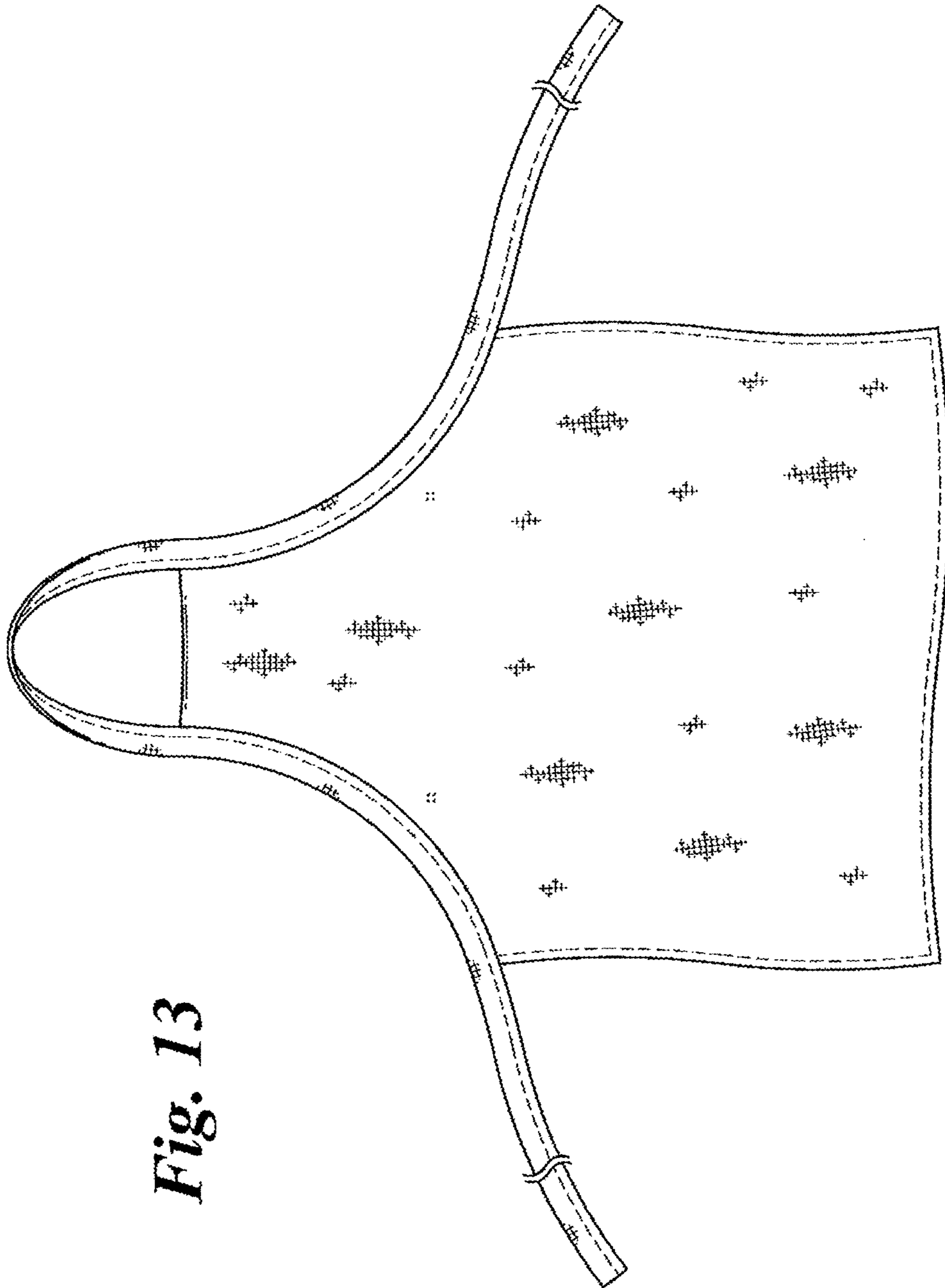

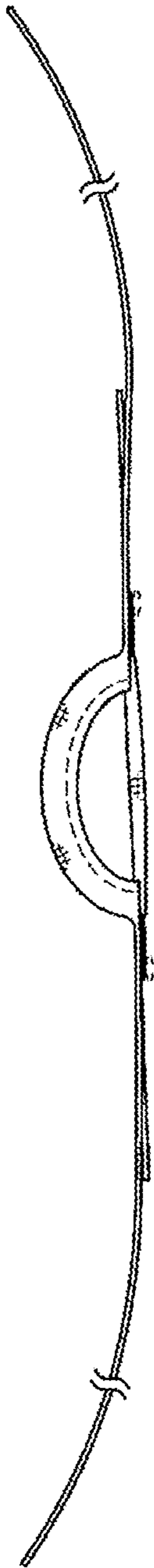

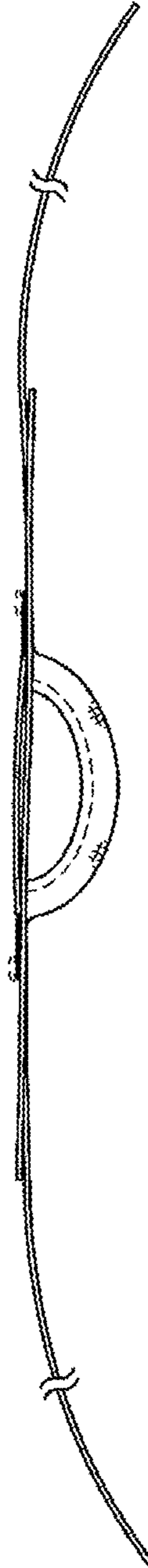

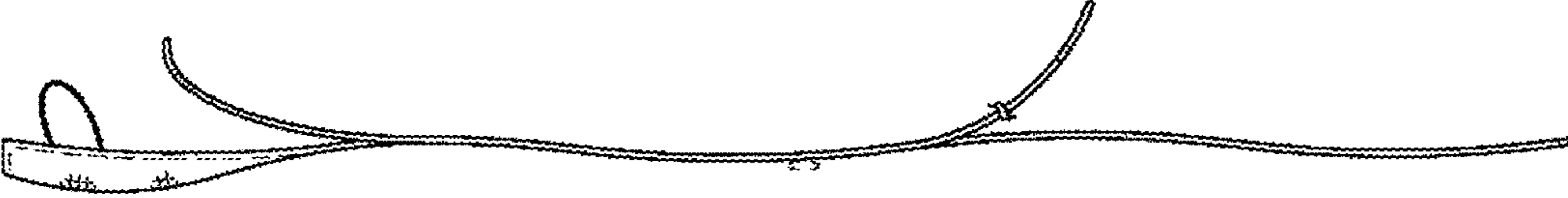

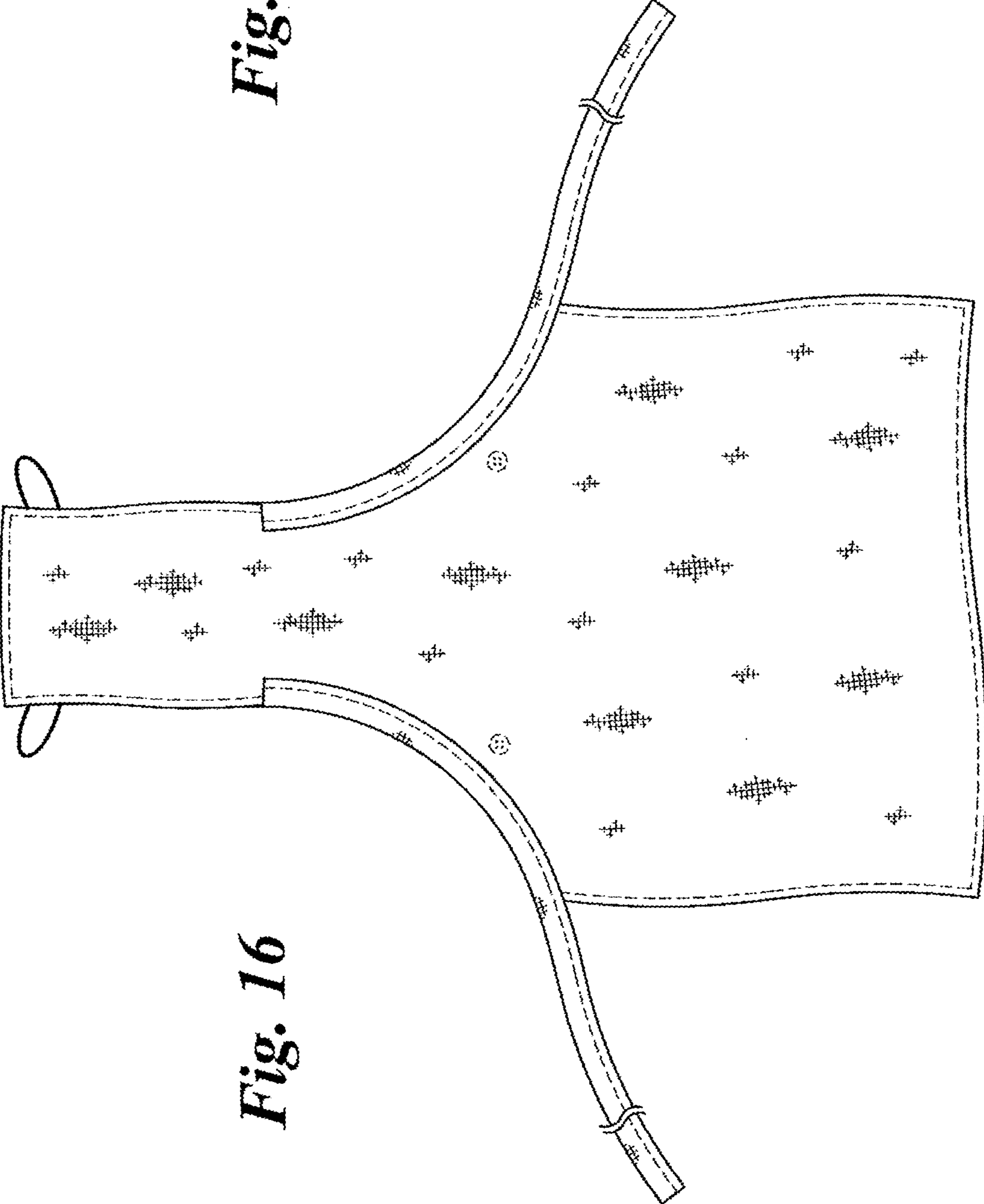

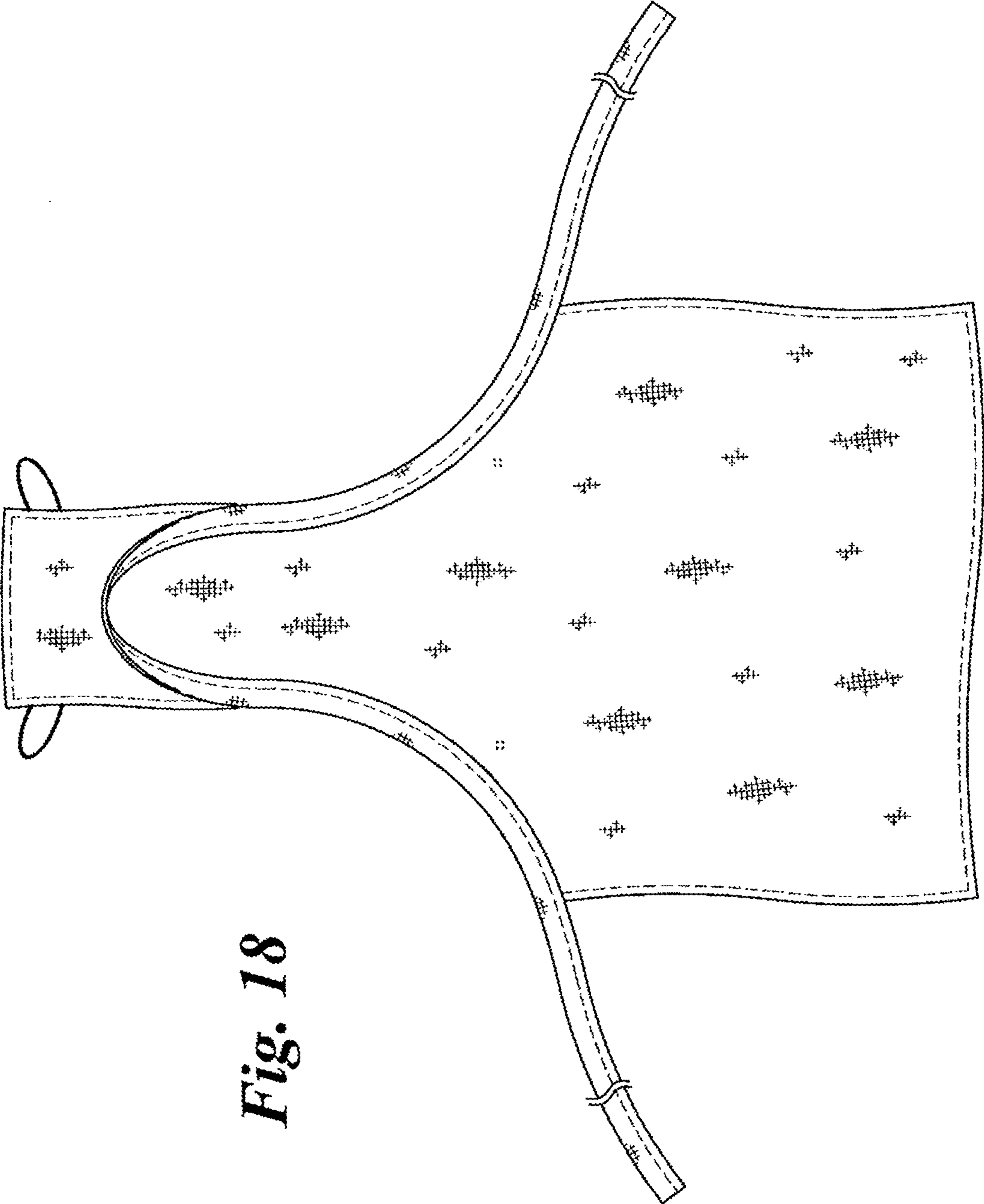

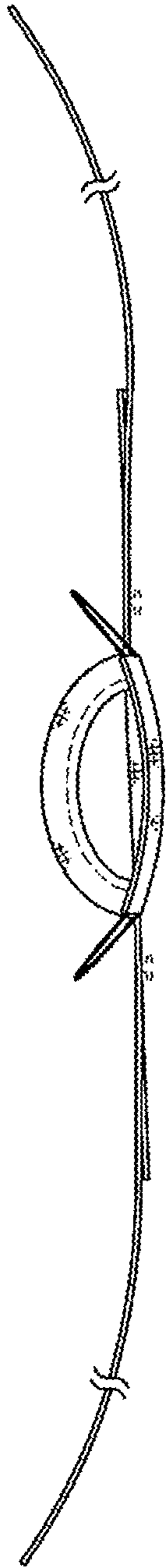

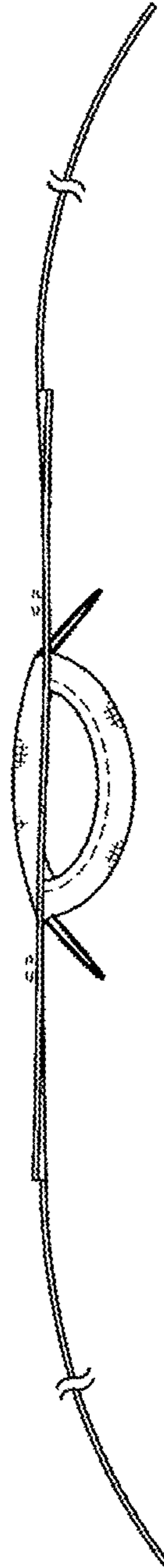

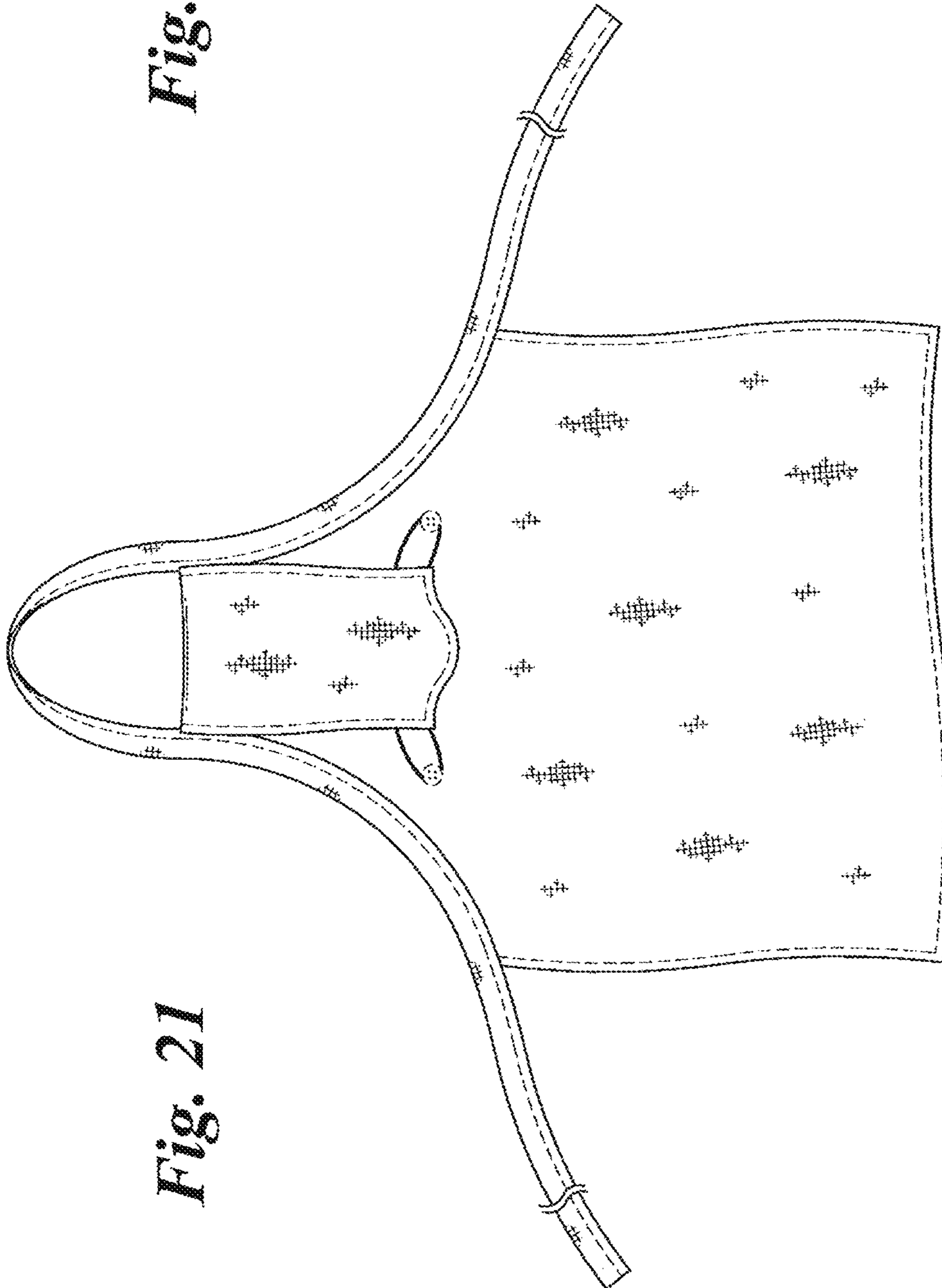

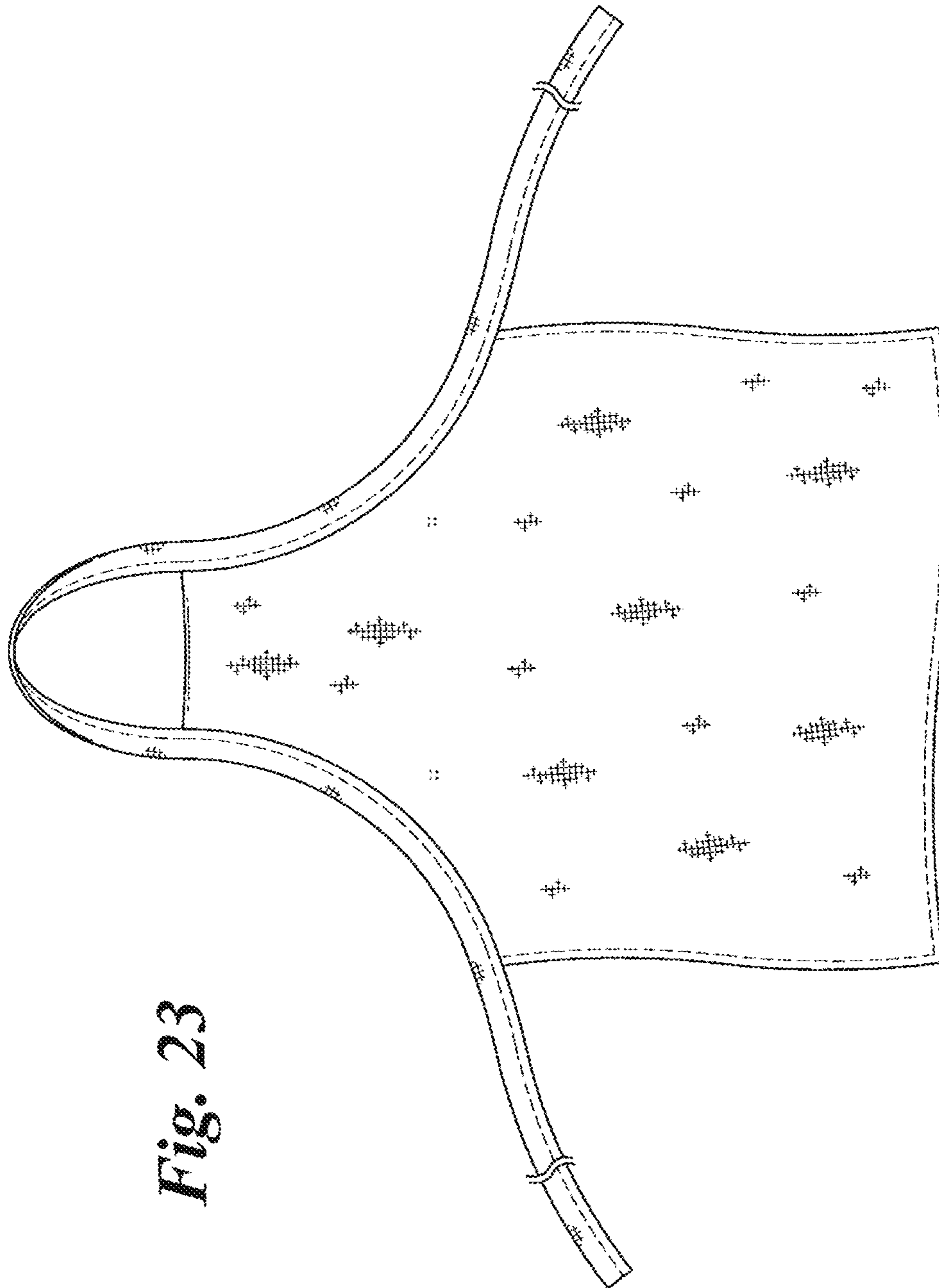

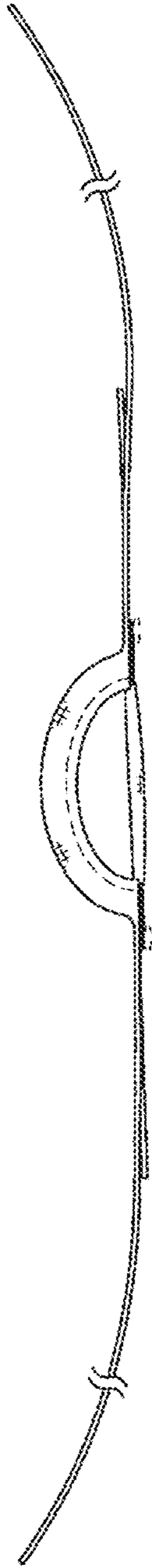

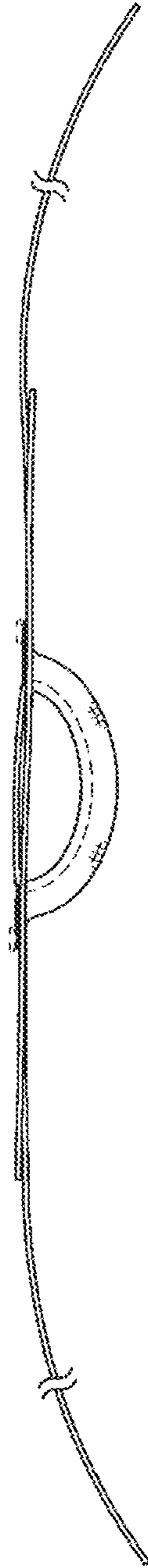

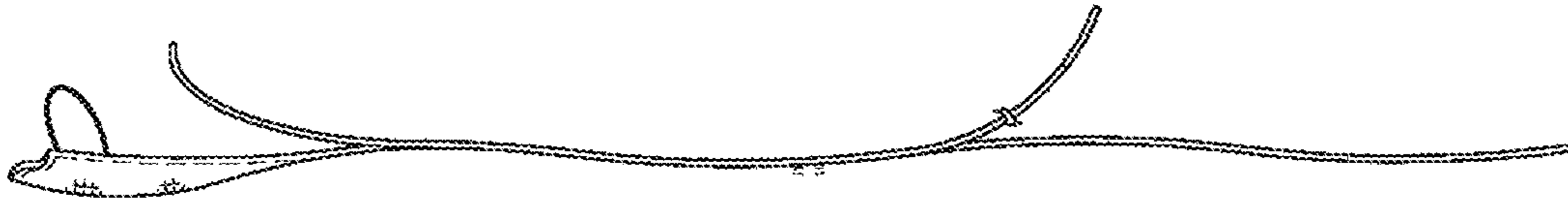

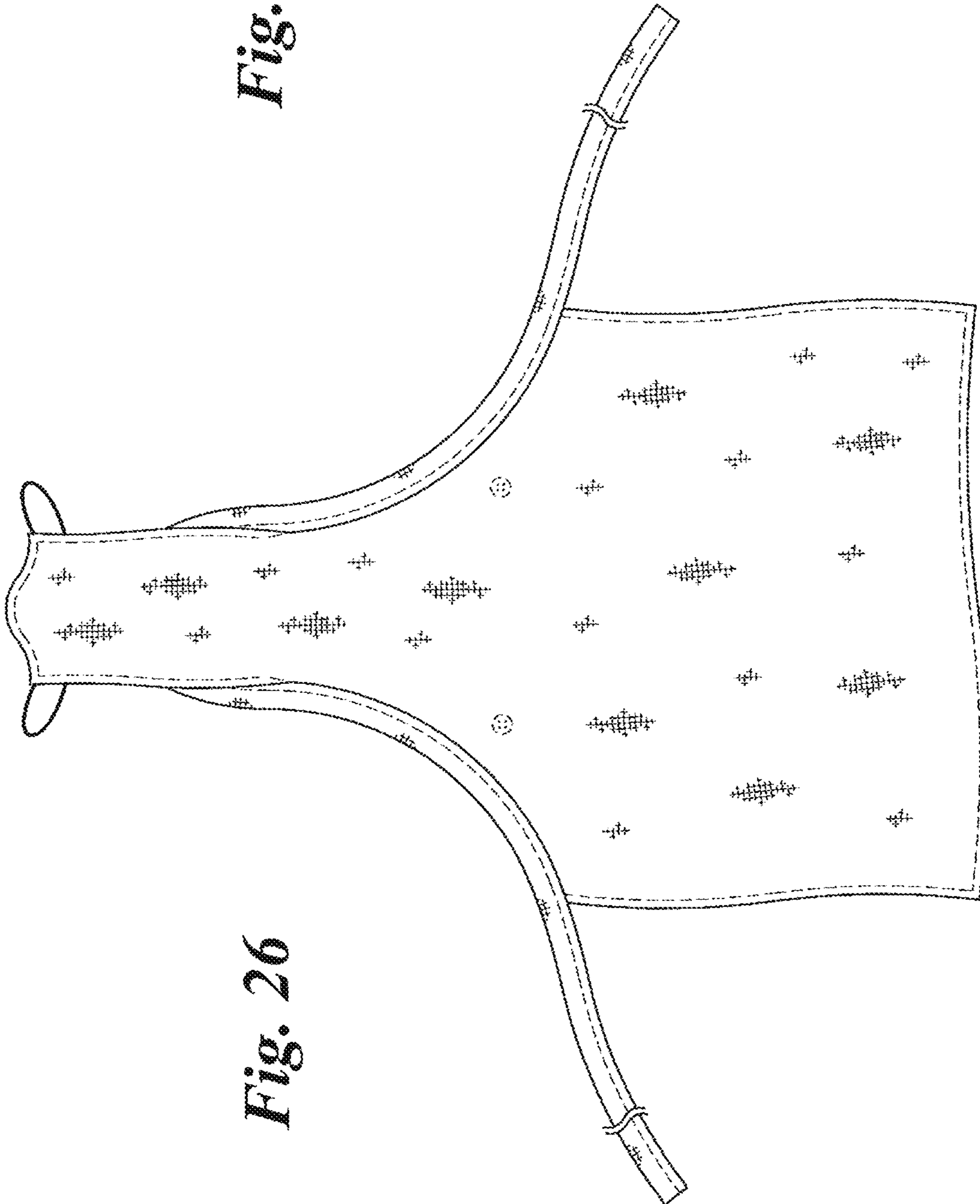

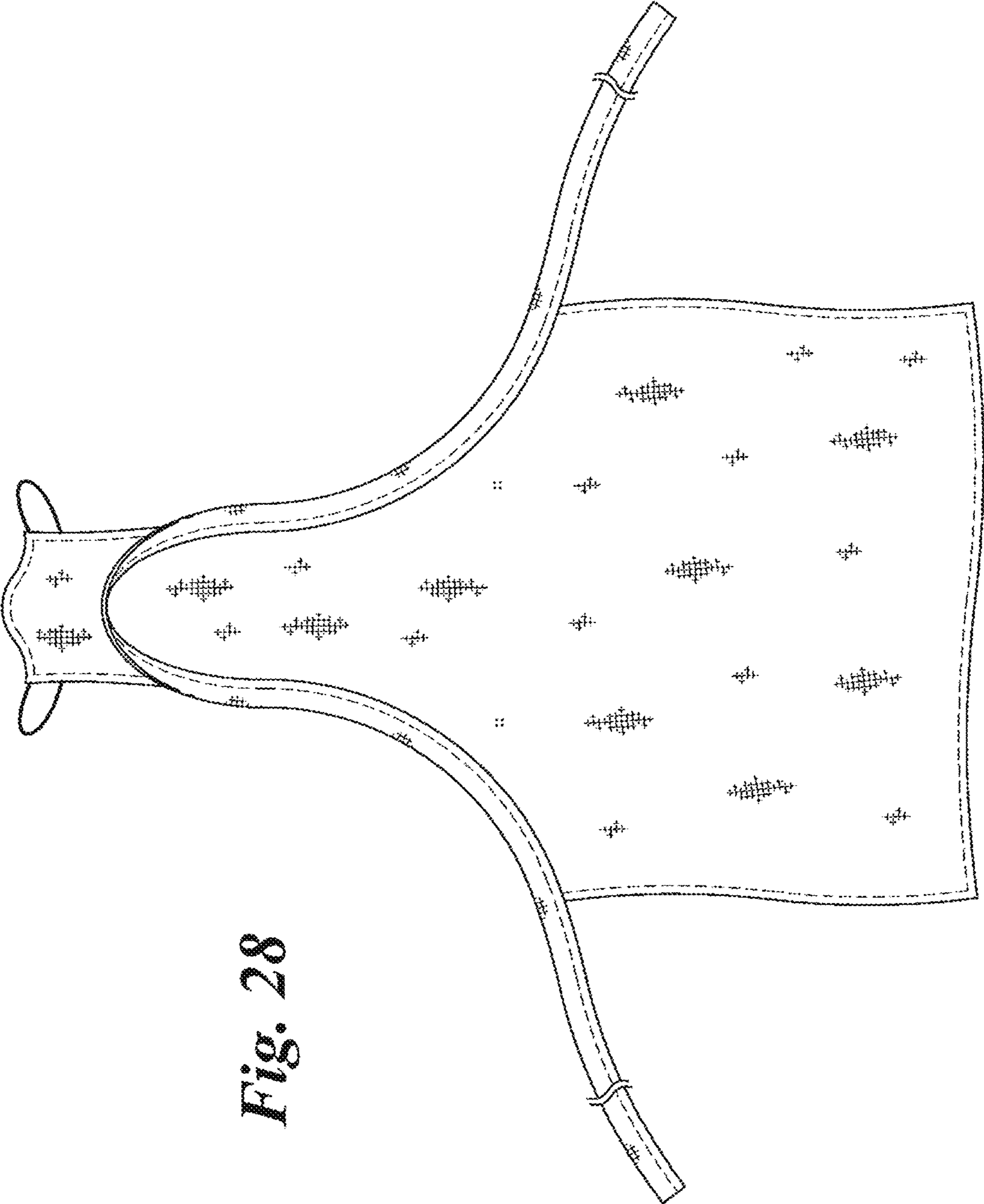

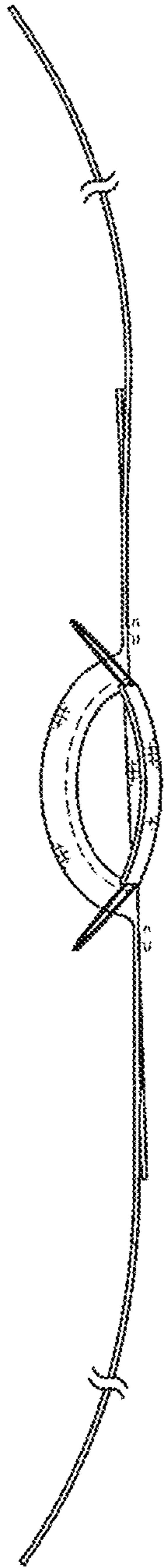

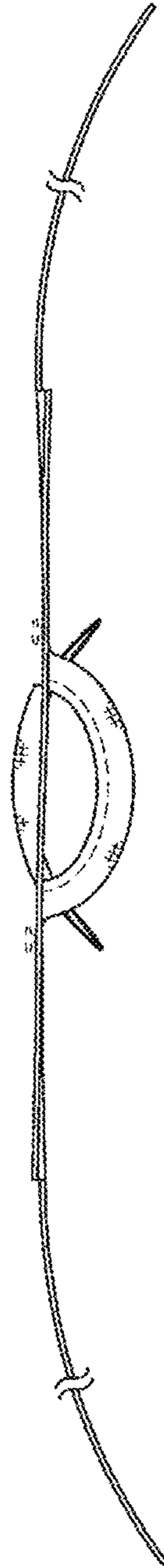

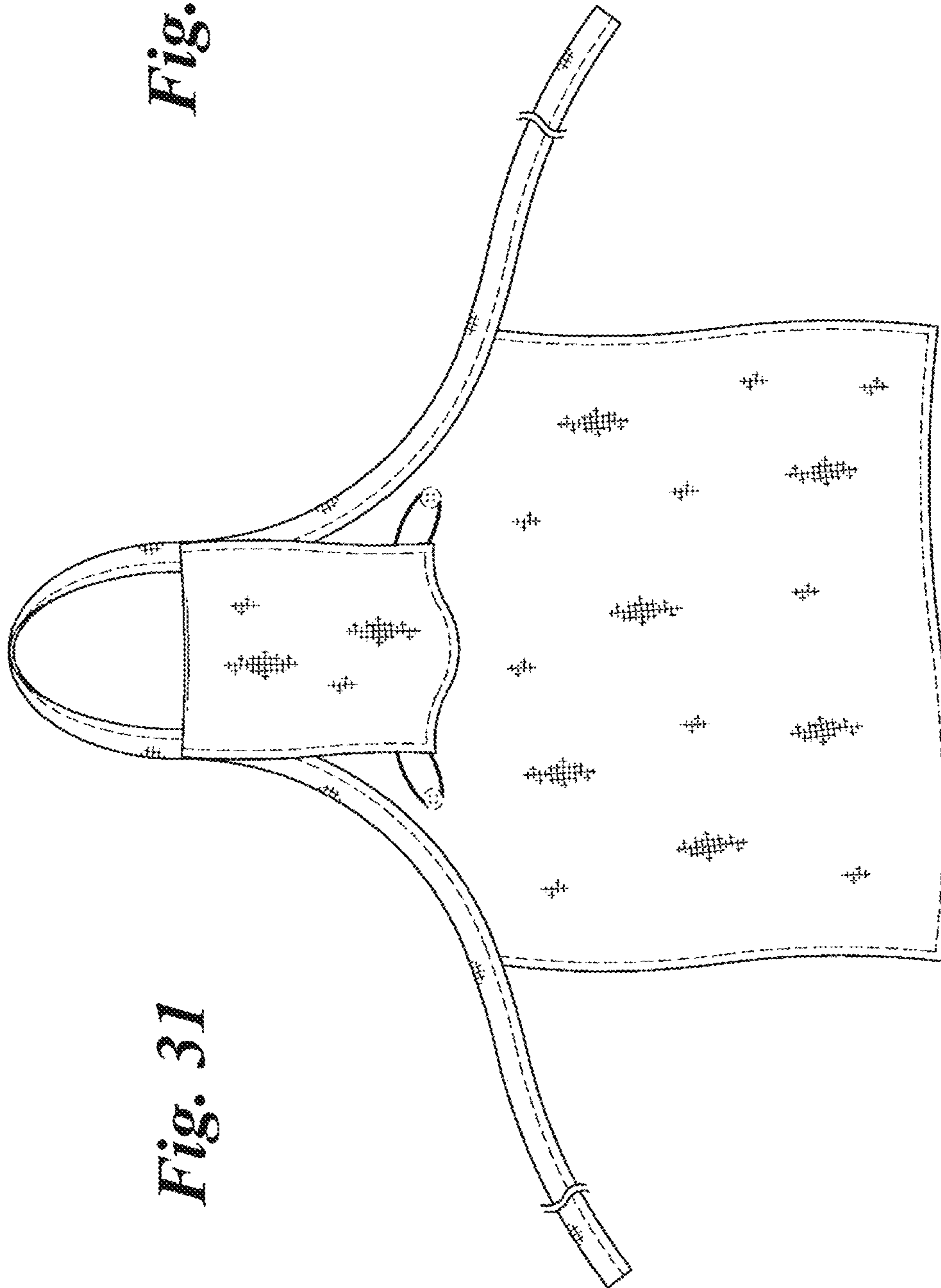

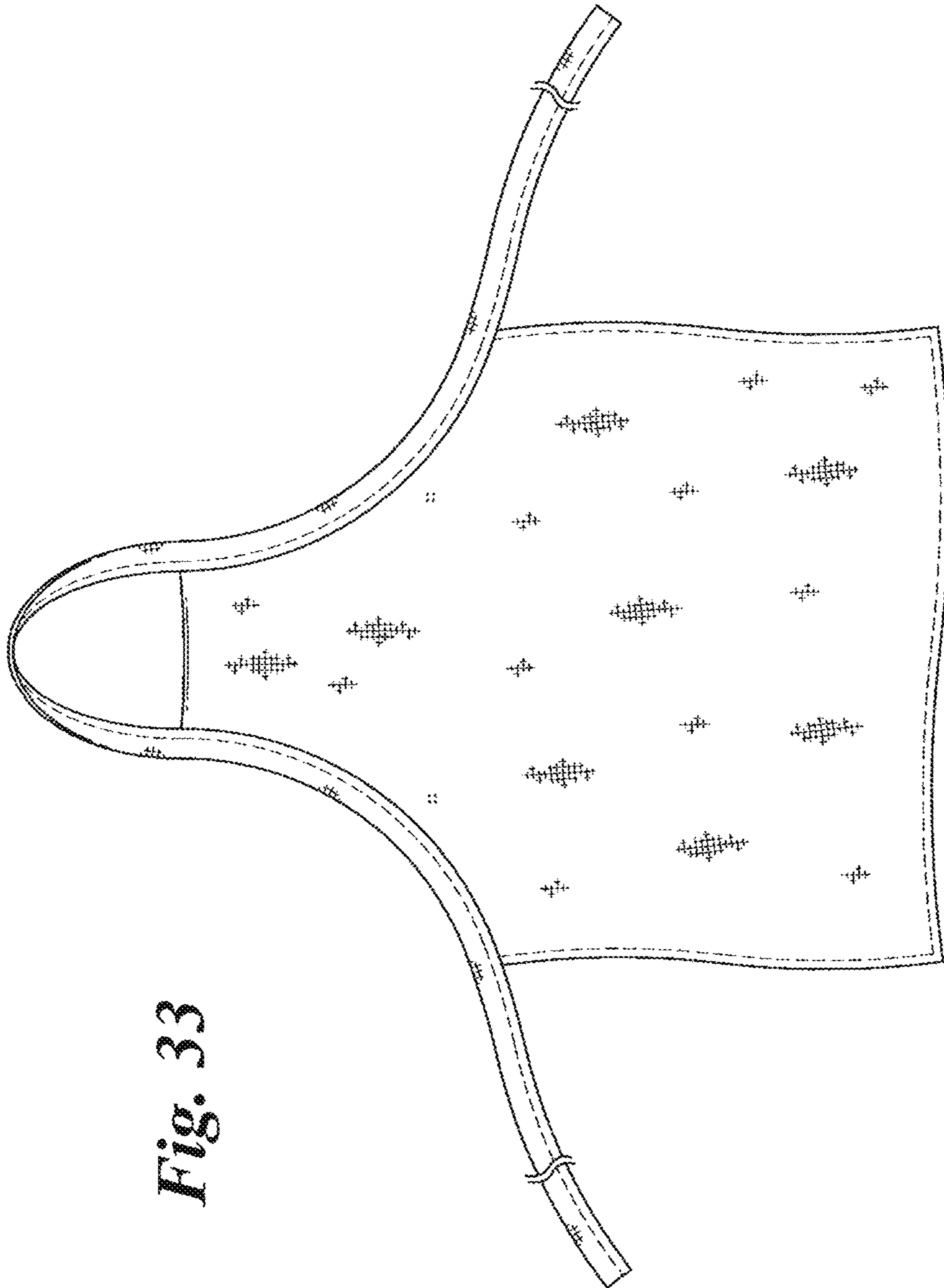

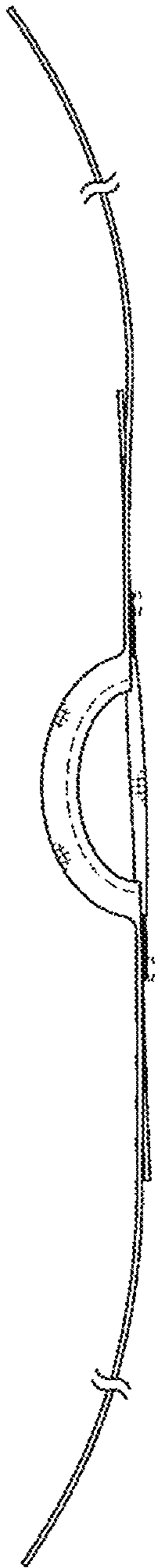

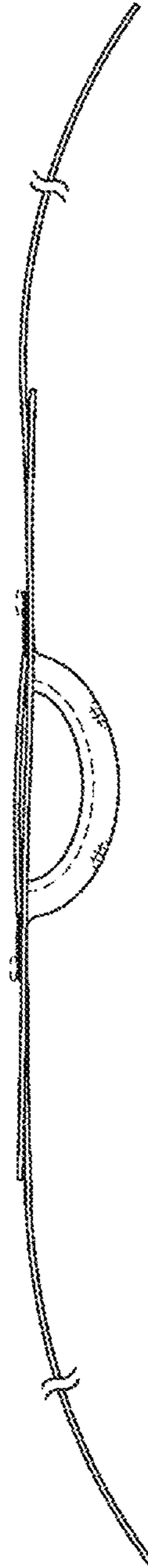

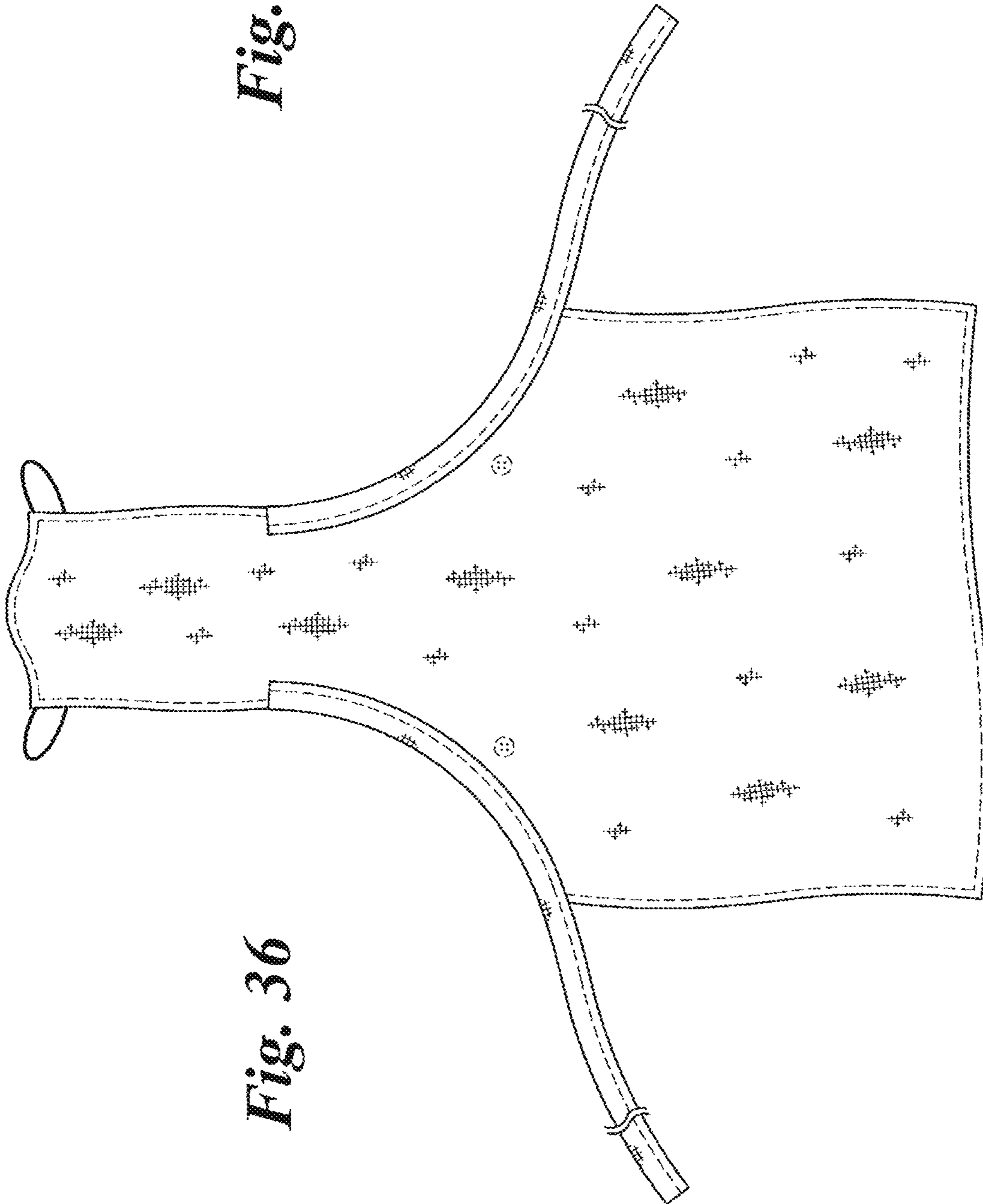

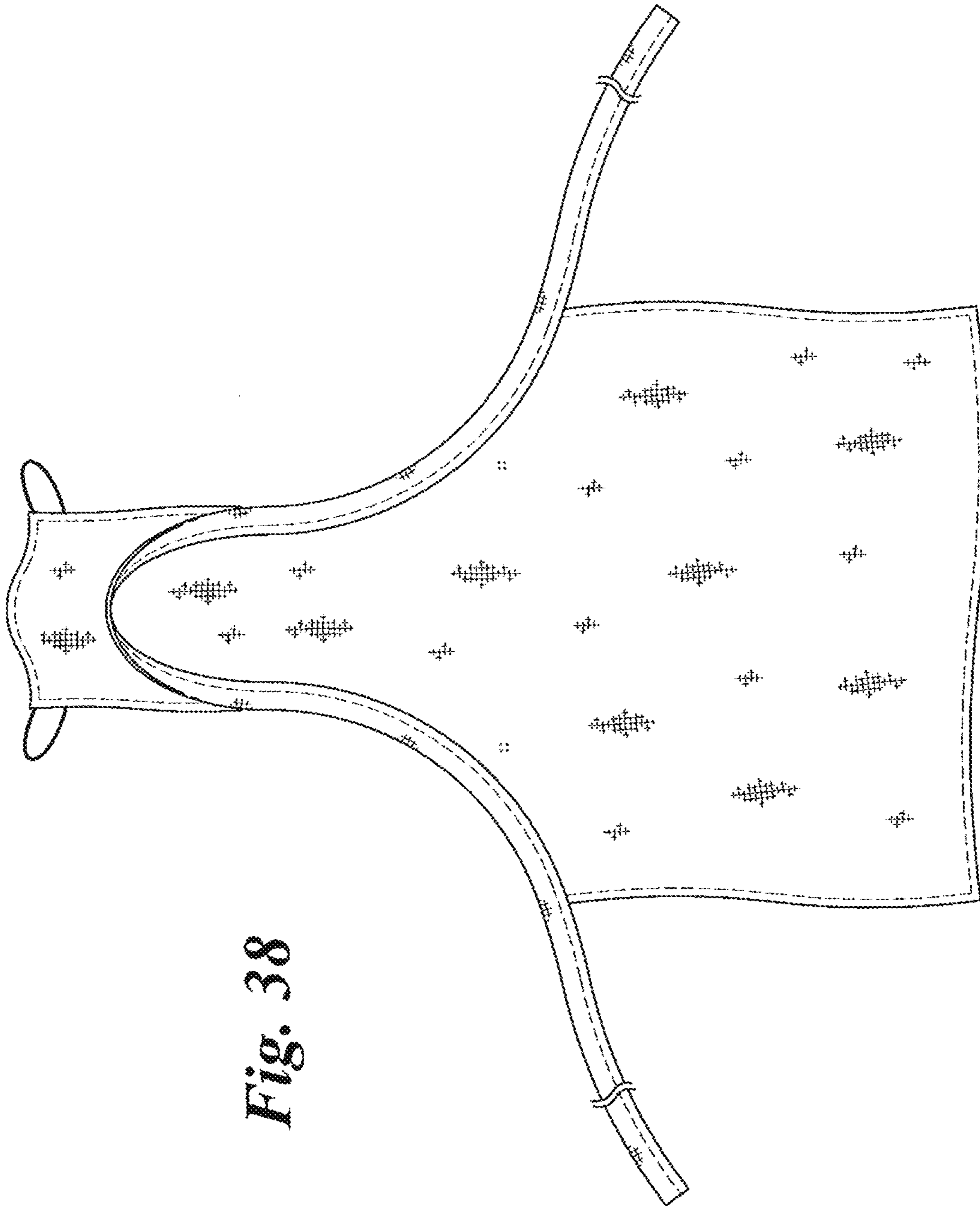

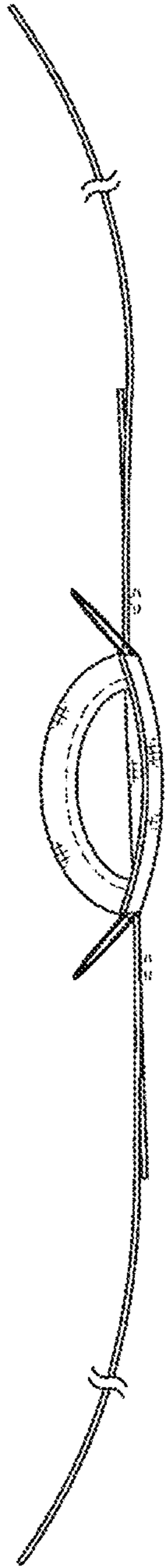

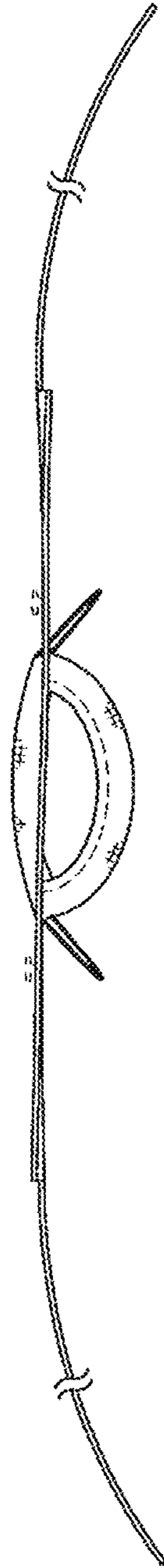
