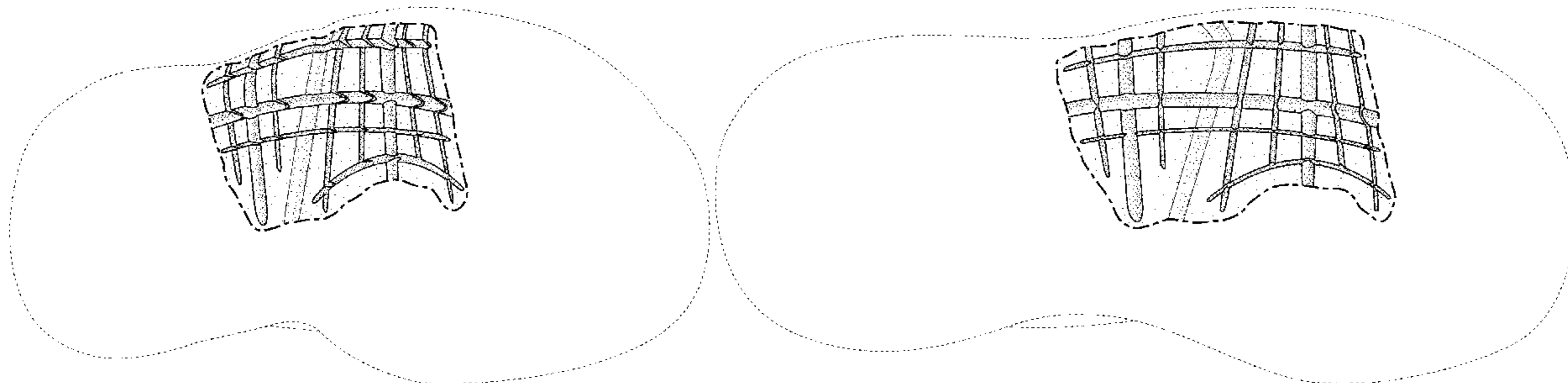
(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front bottom perspective view of a shoe, showing my new design;
FIG. 2 is a rear bottom perspective view thereof; and,
FIG. 3 is a bottom view thereof.
The dot-dash broken lines represent unclaimed boundaries of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

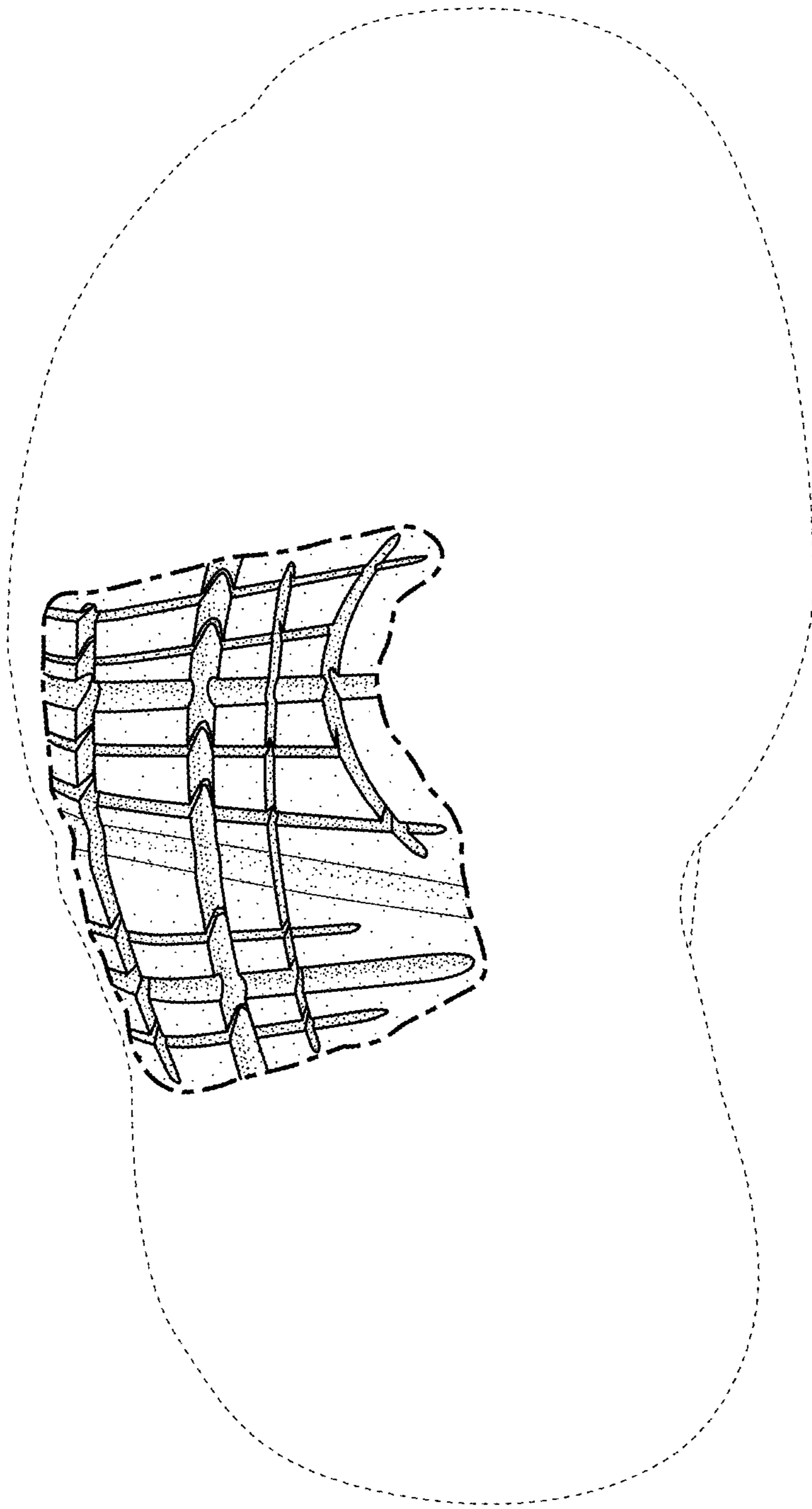

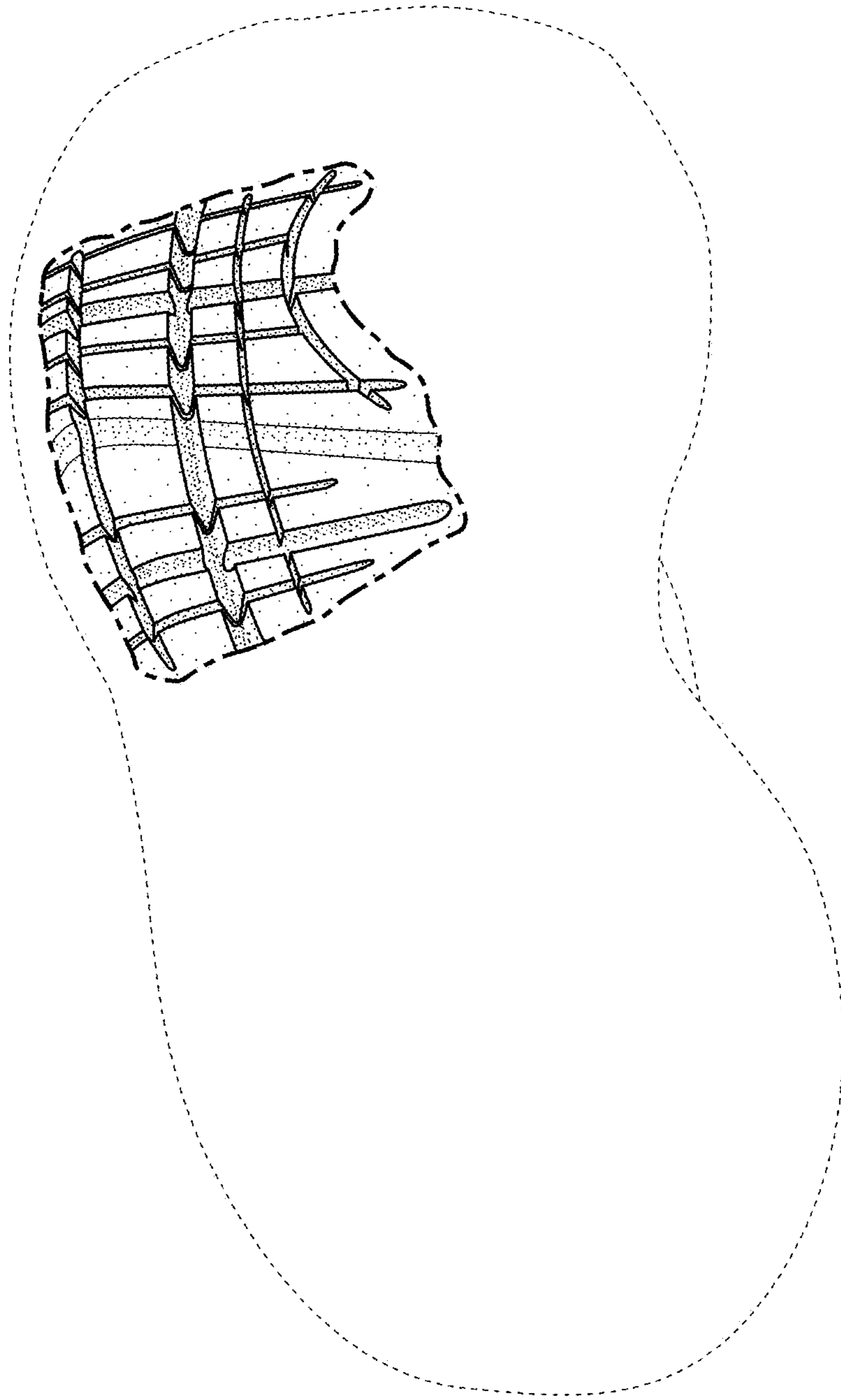

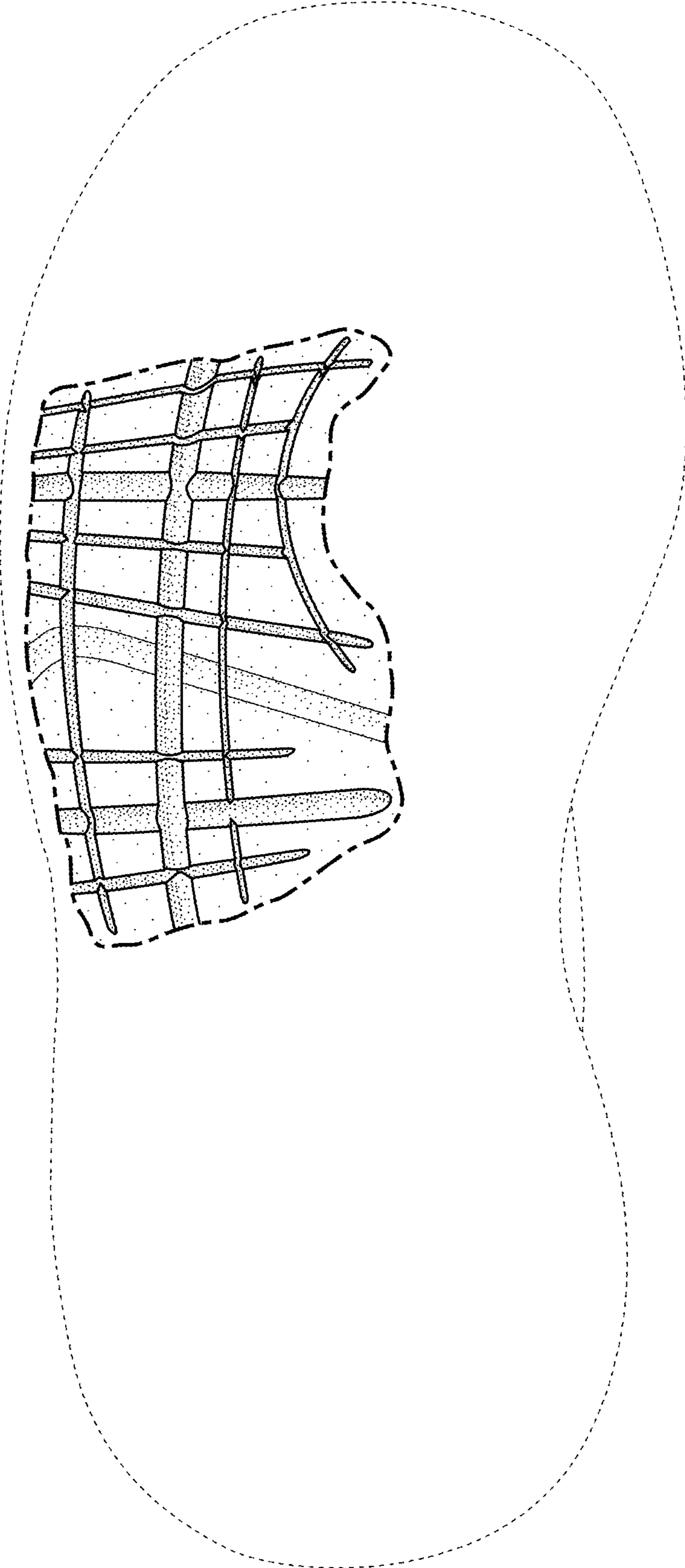
