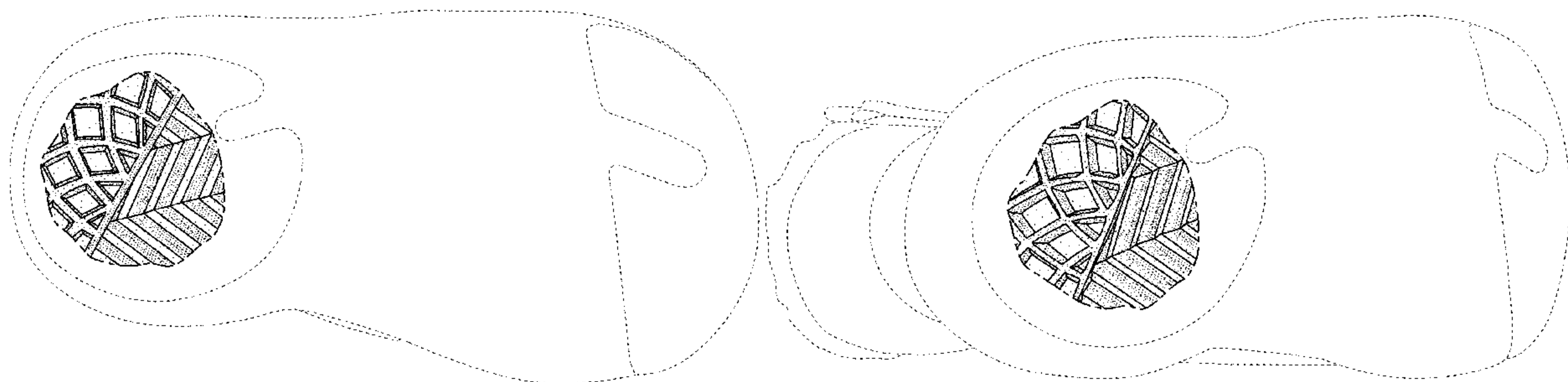

(57) **CLAIM**
I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of a shoe, showing my new design; FIG. 2 is a rear bottom perspective view thereof; and, FIG. 3 is a front bottom perspective view thereof. The dot-dash broken lines adjacent to the shaded area represent unclaimed boundaries of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

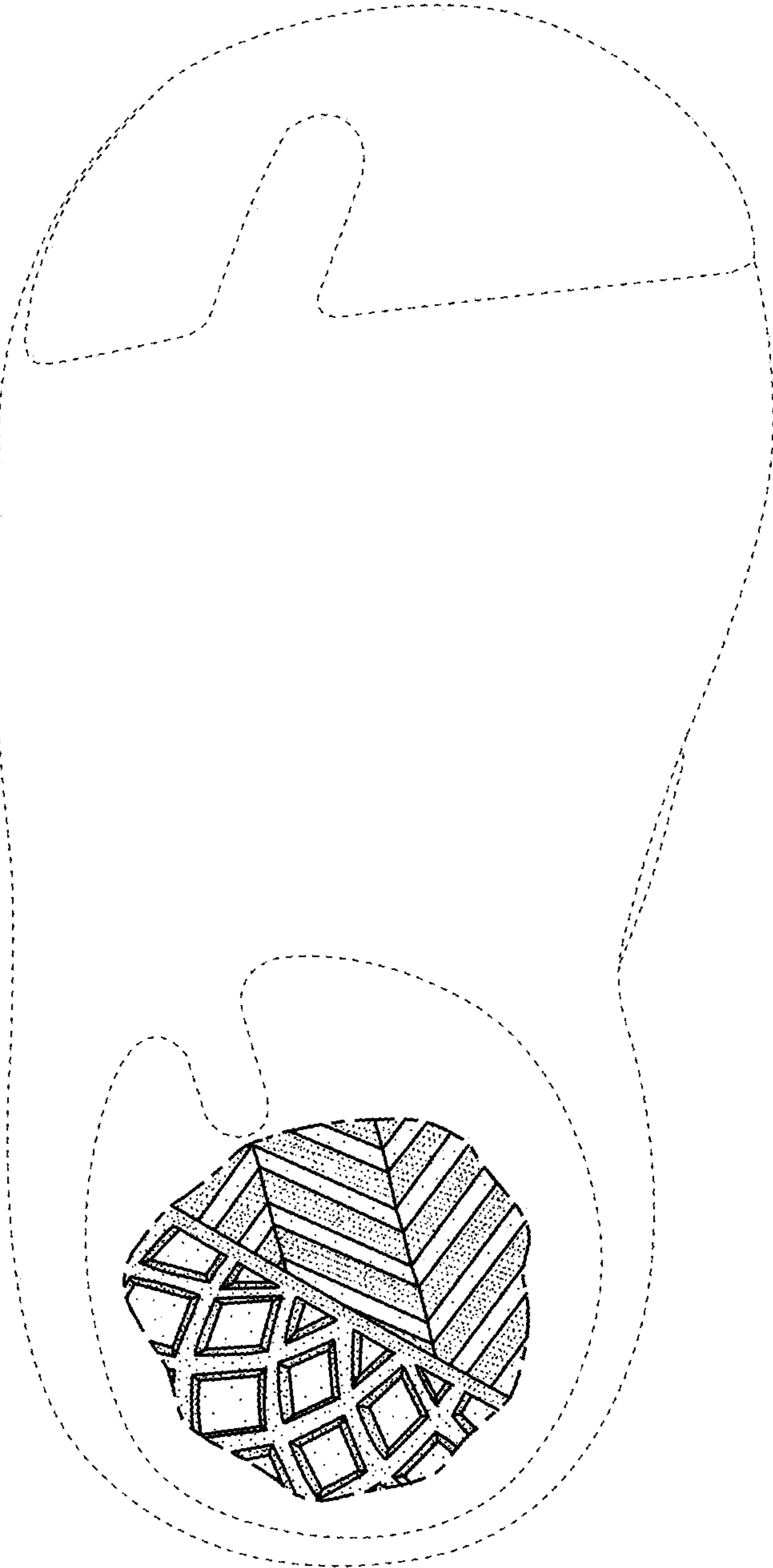

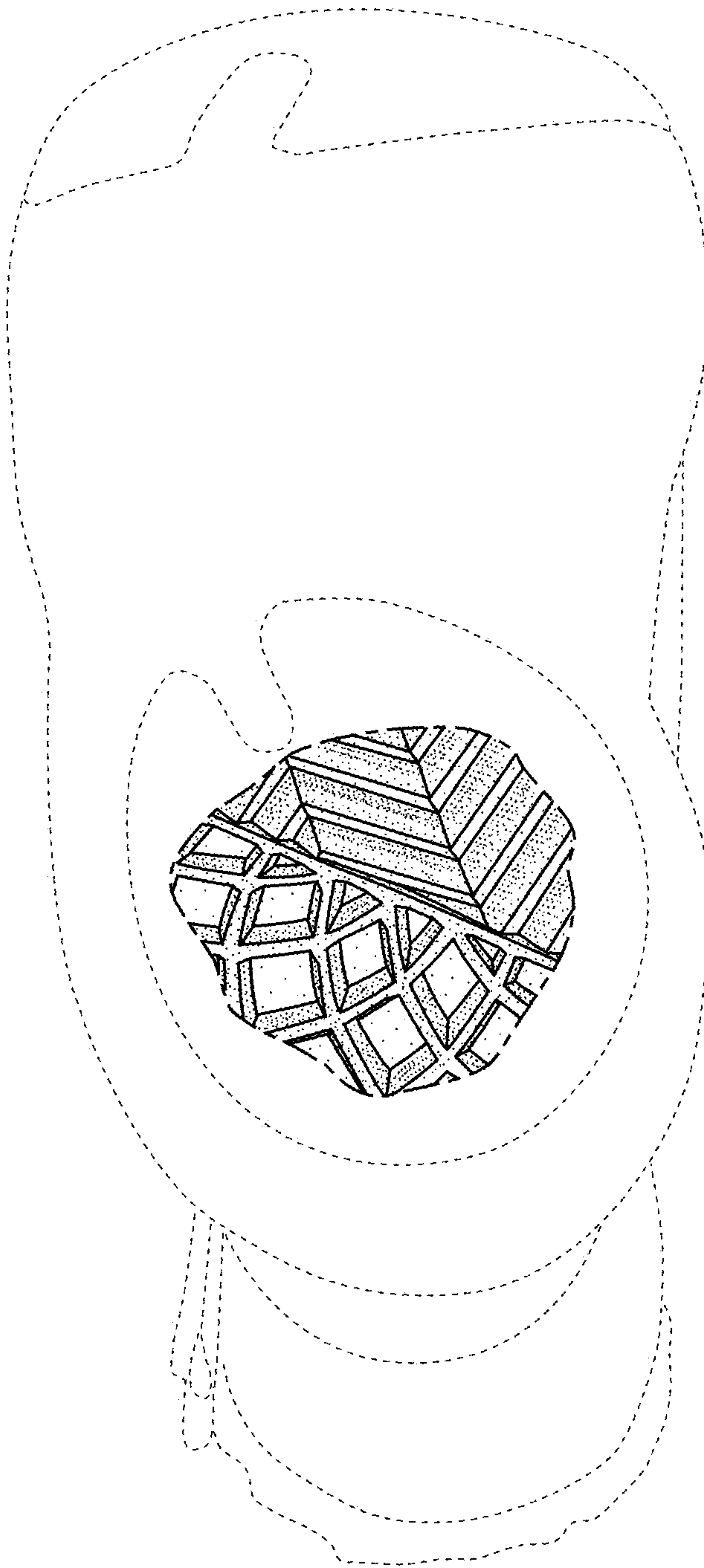

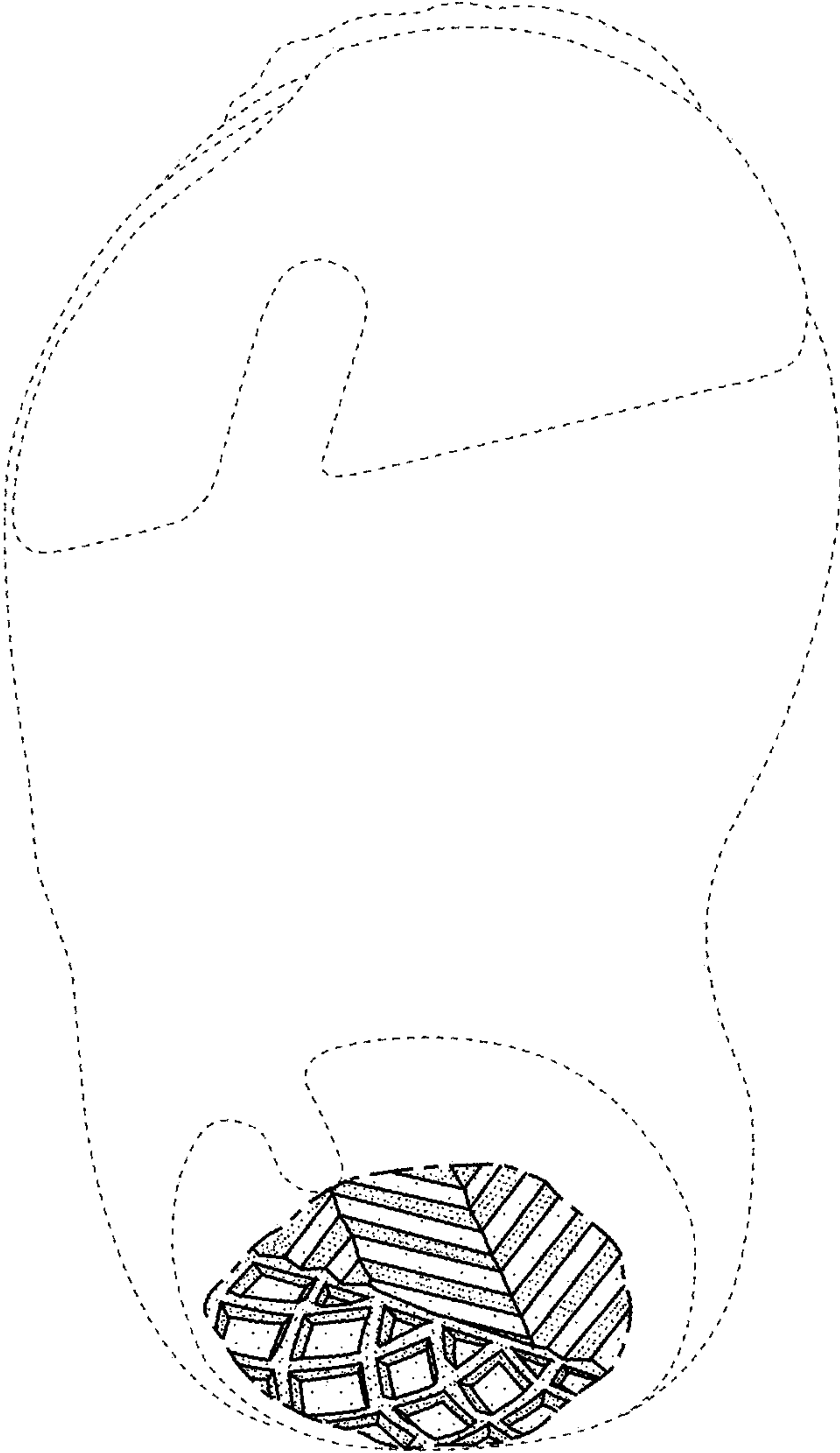
