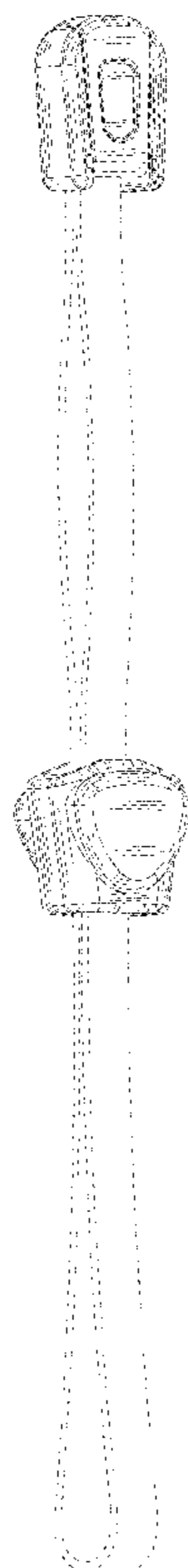
The ornamental design for a shoelace buckle, as shown and described.

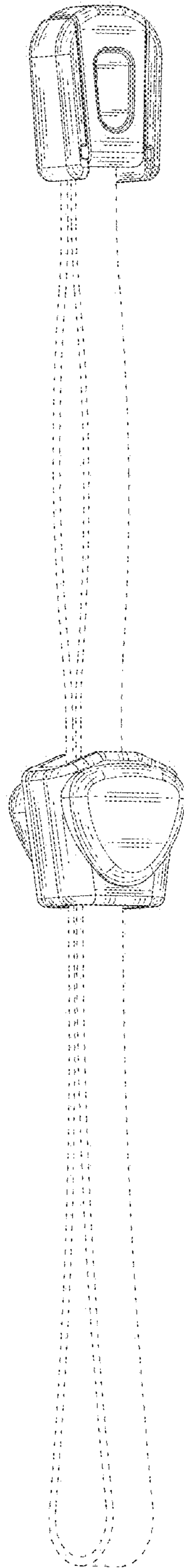

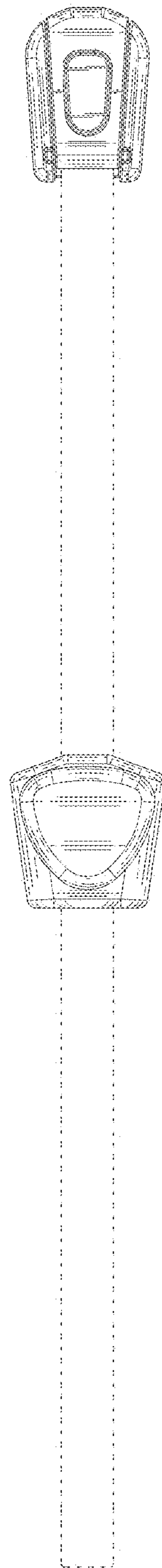

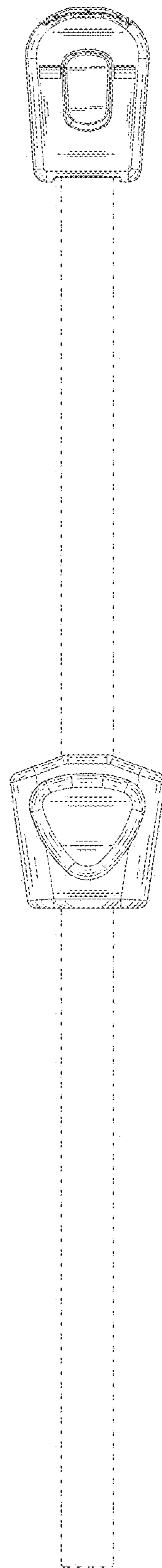

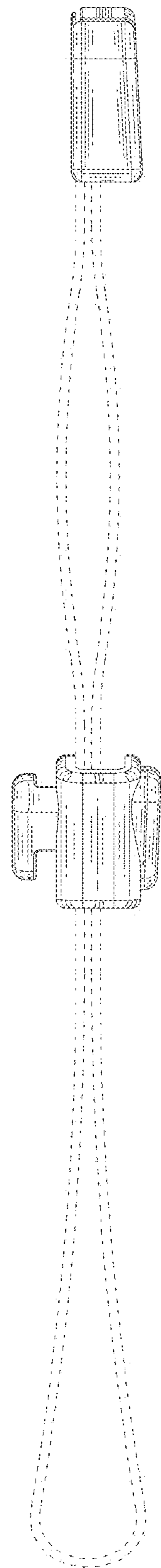

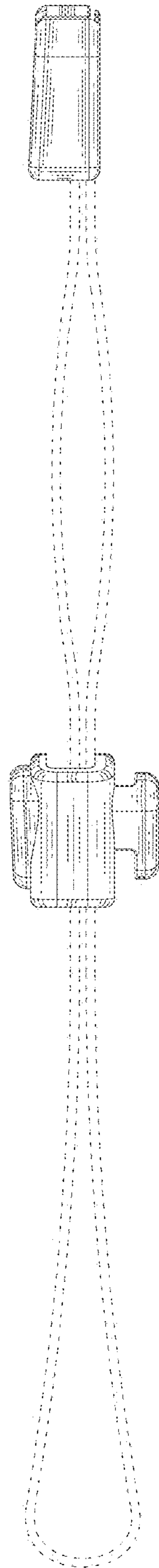

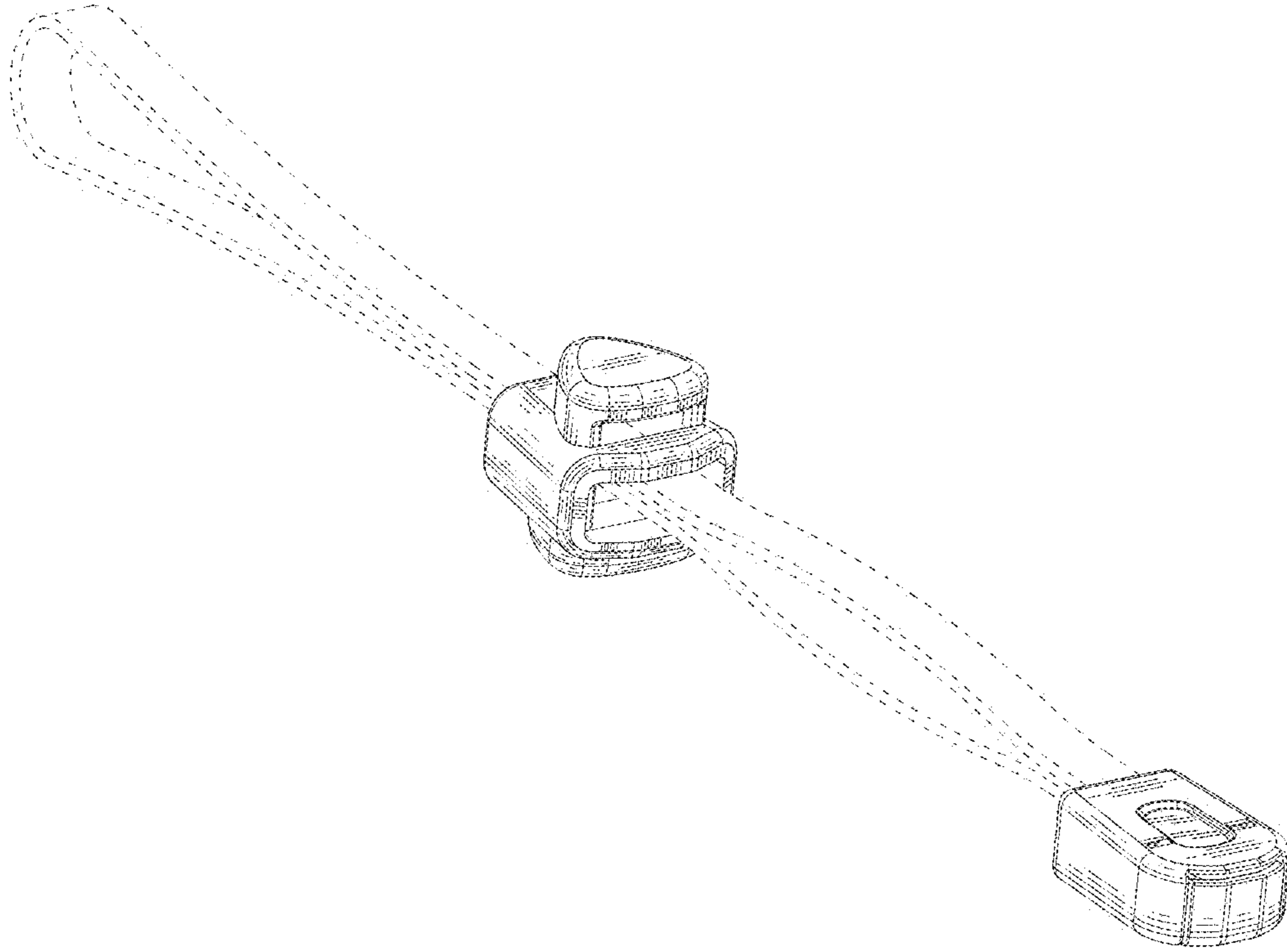
