DESCRIPTION

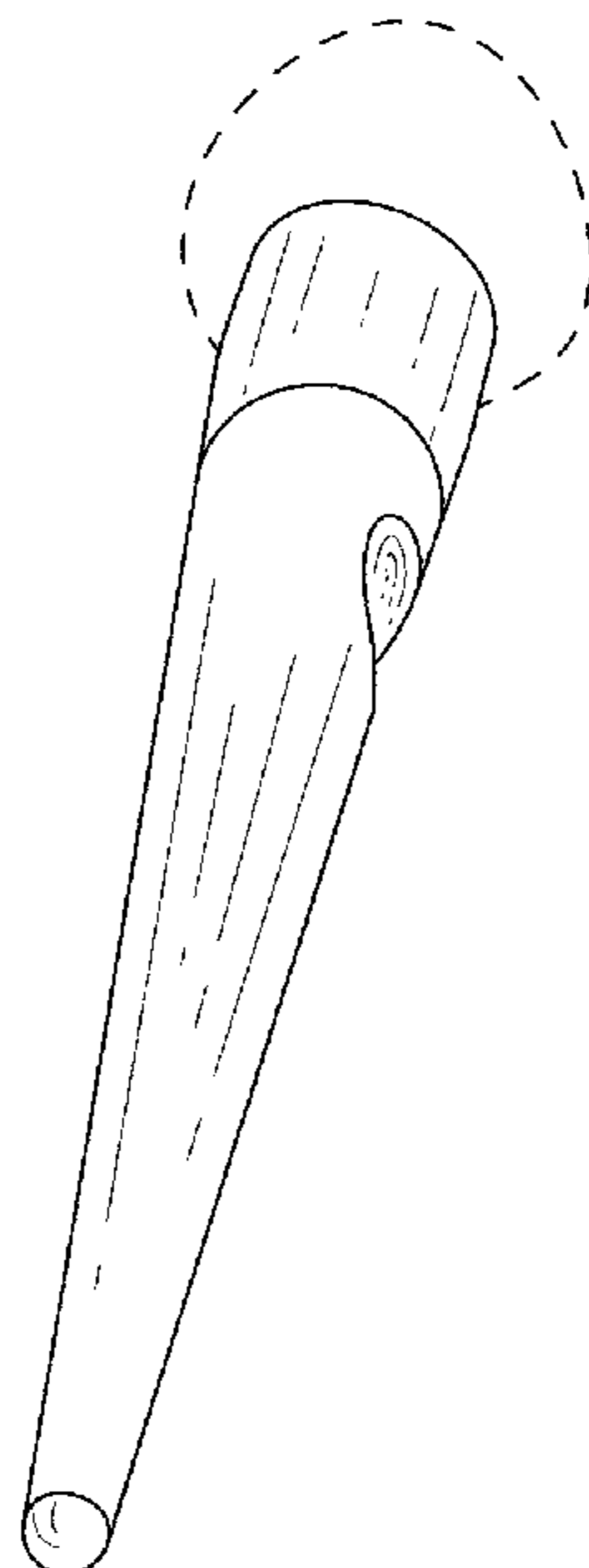
FIG. 1 is a perspective view of a cosmetic brush showing my new design;

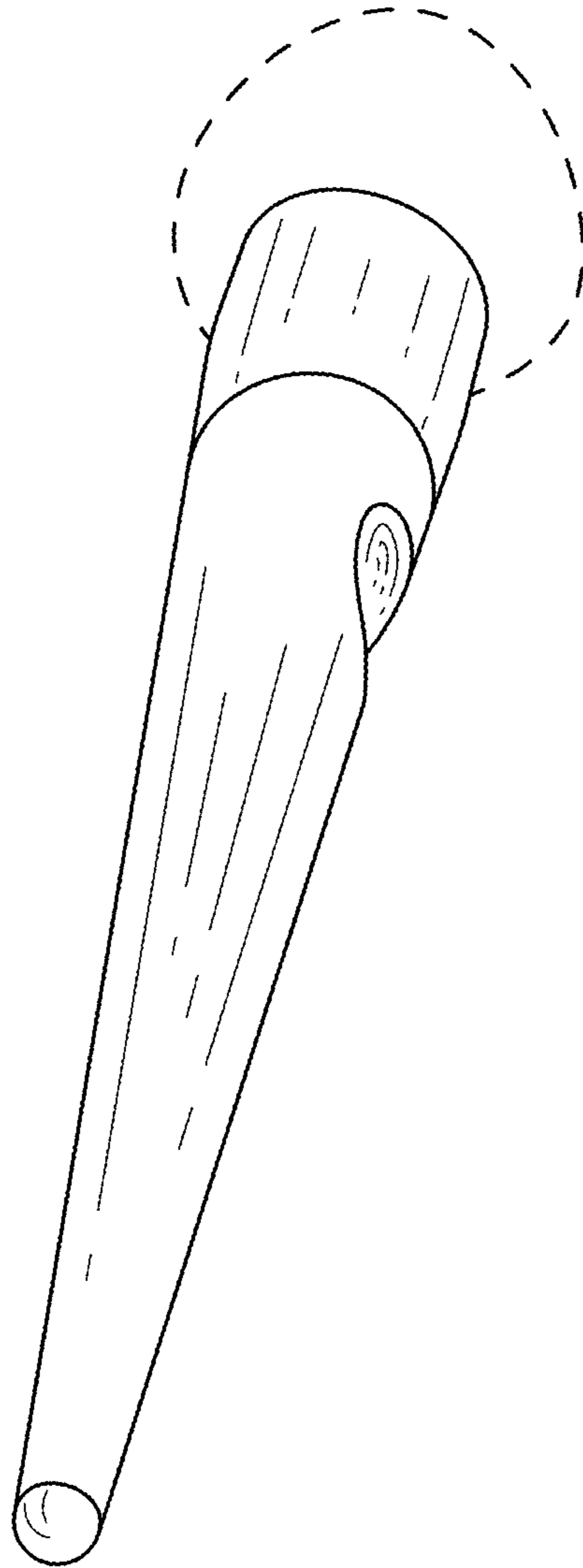

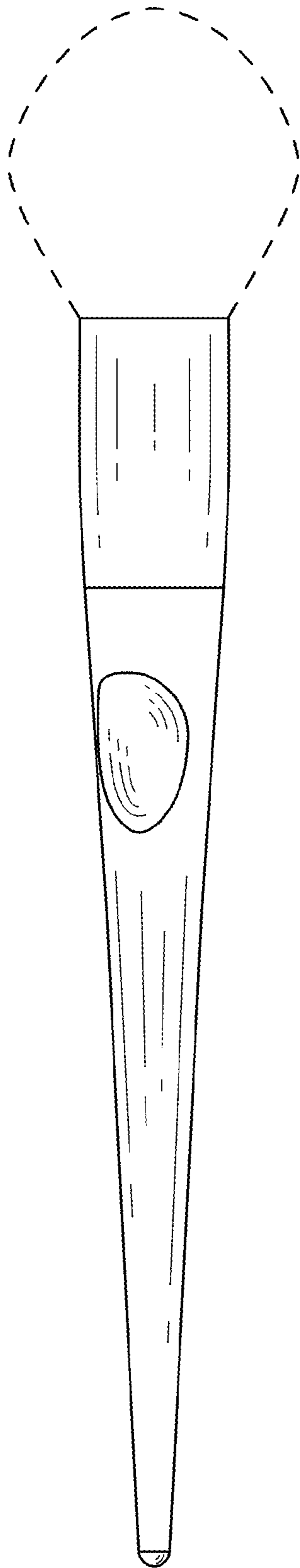

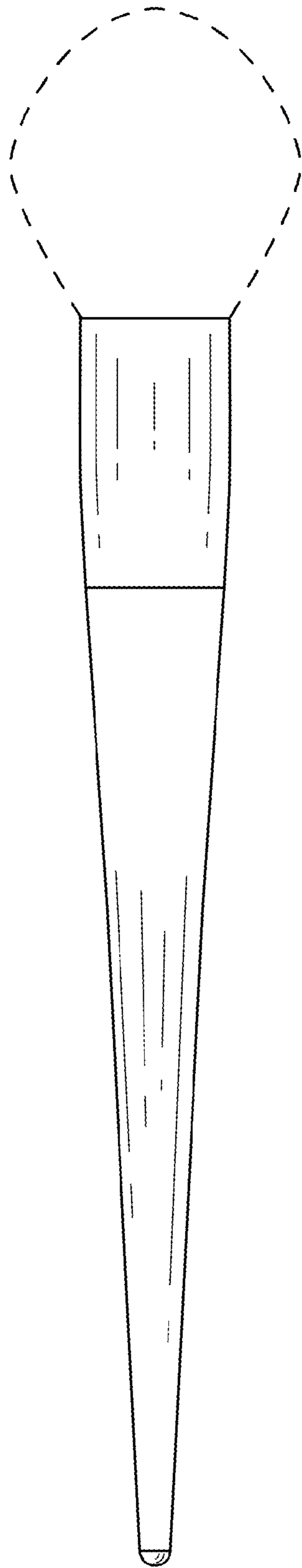

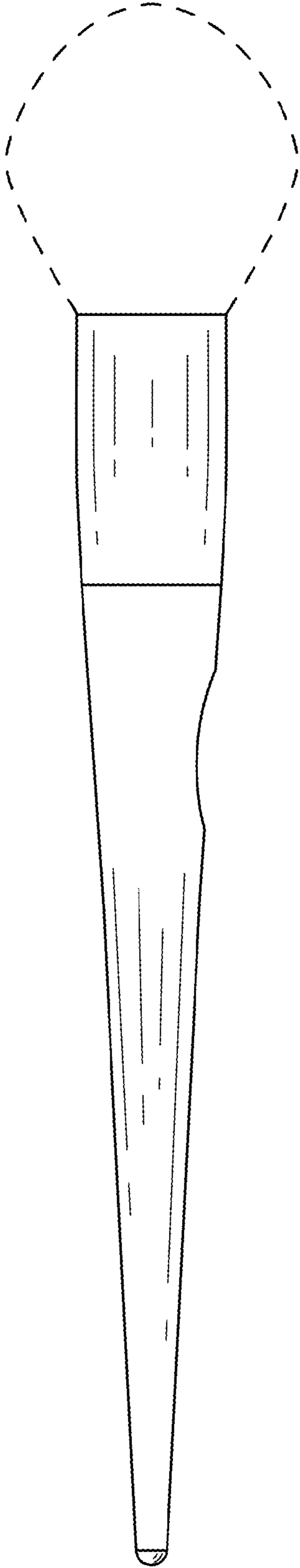

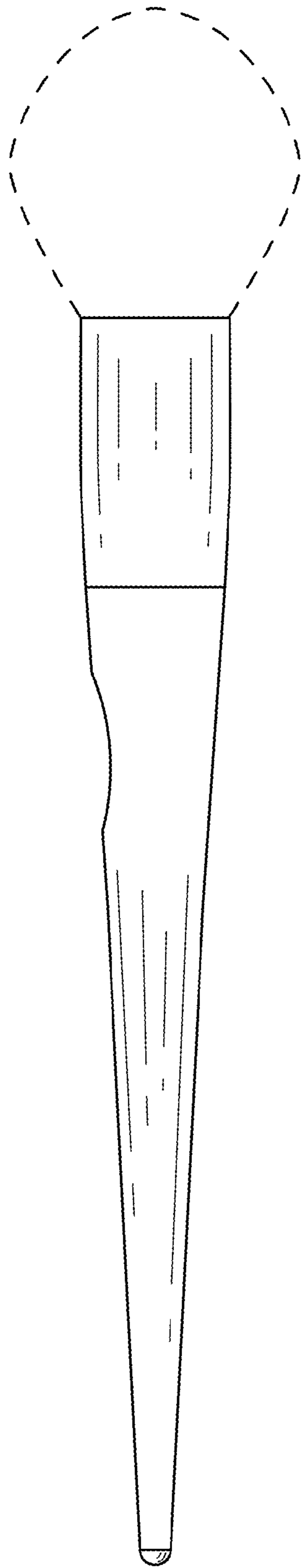

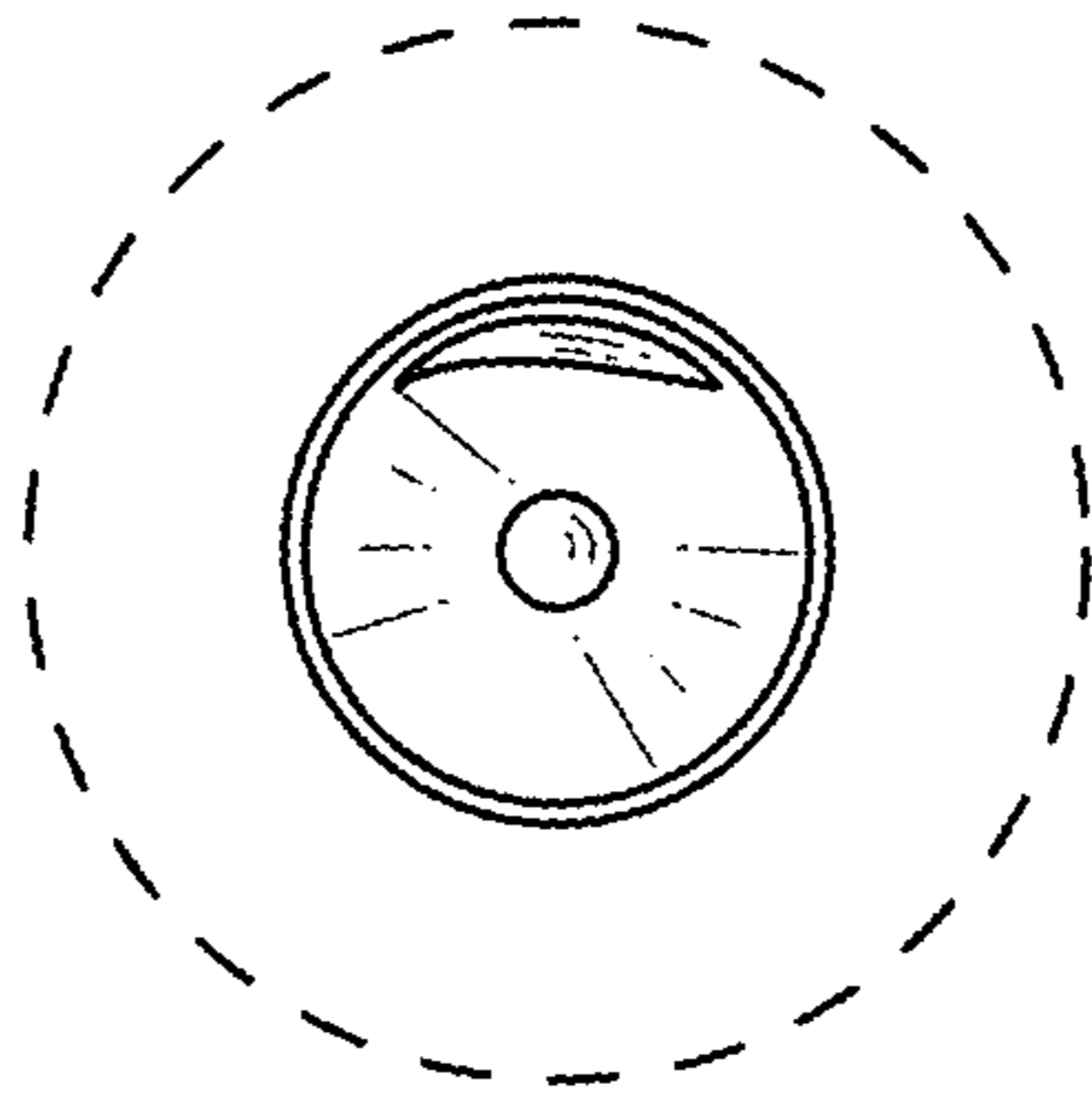

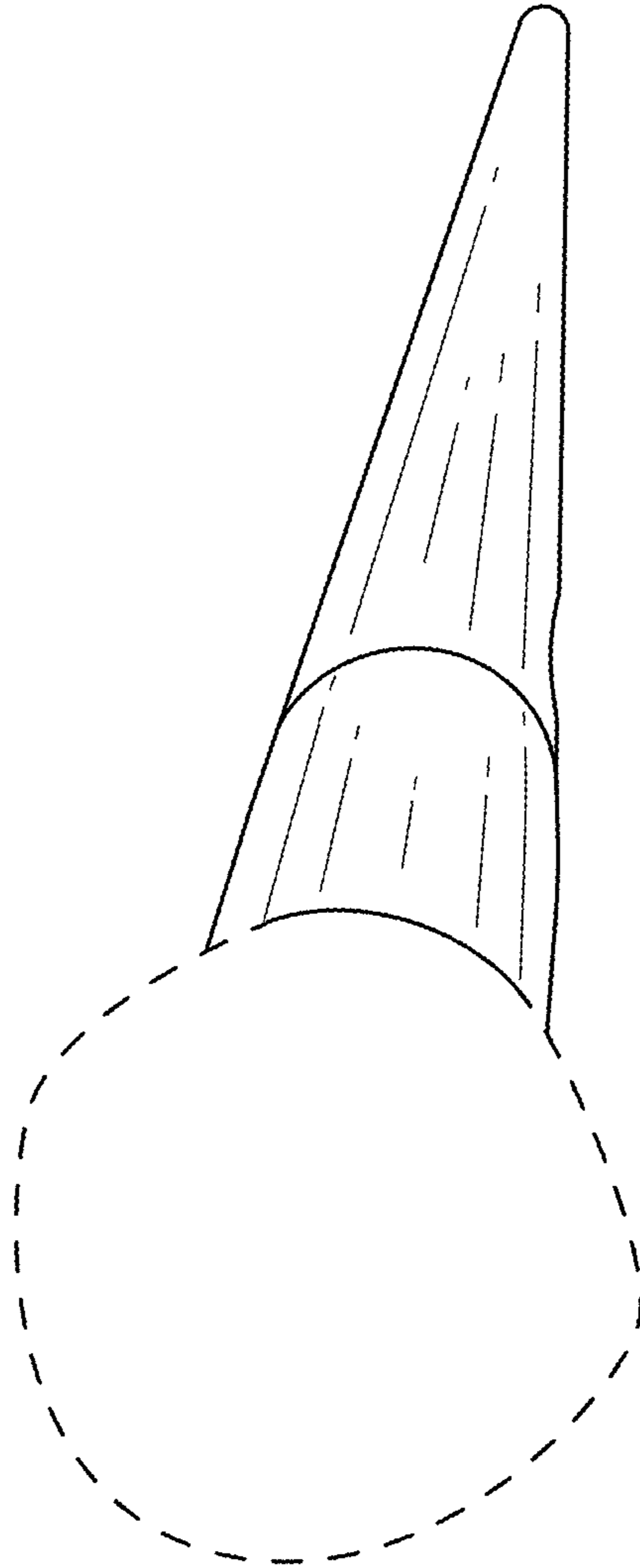
