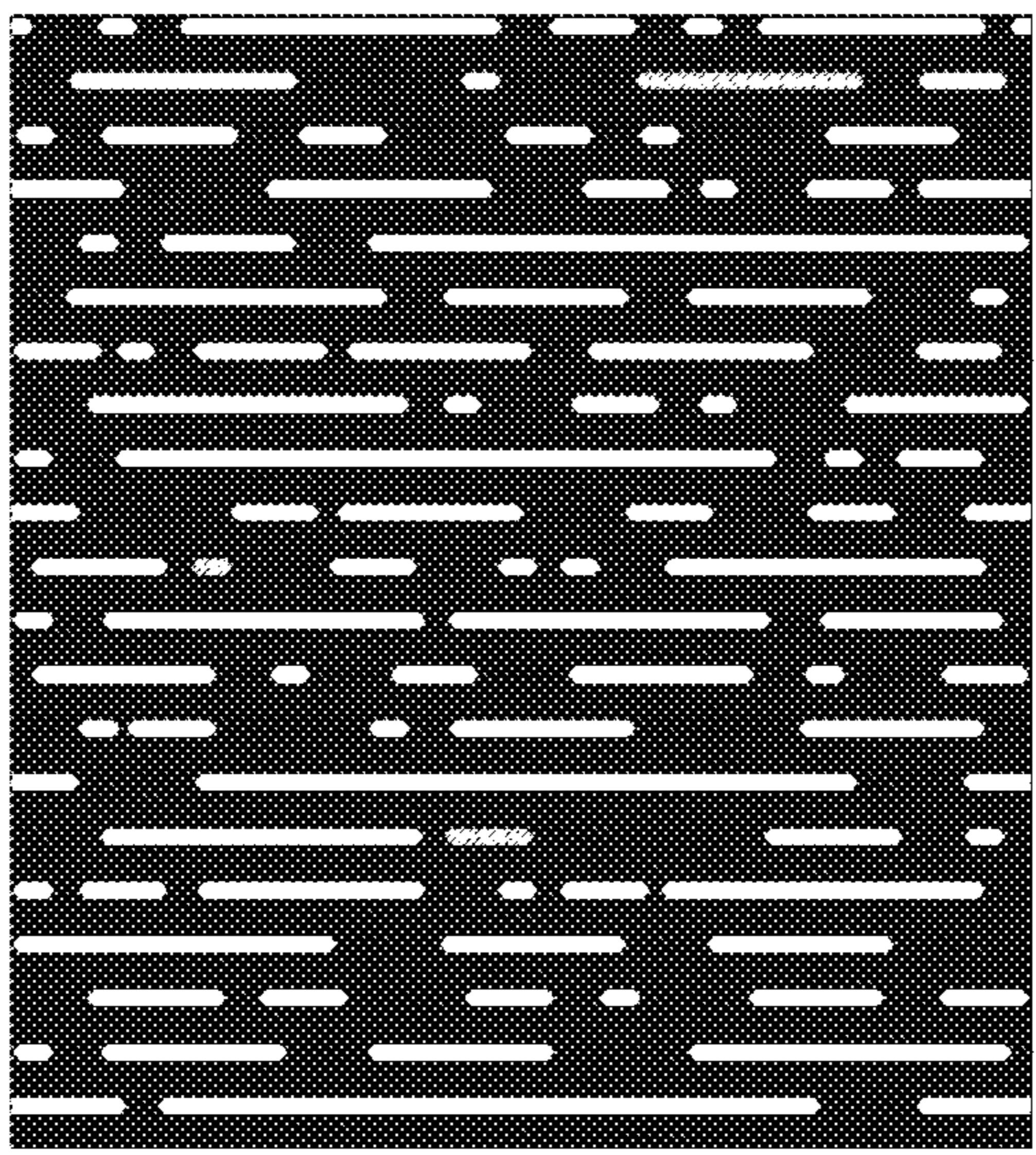
(57) **CLAIM**

The ornamental design for an awning fabric with pattern, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of an awning fabric with pattern; FIG. 2 is a top view of the awning fabric with pattern of FIG. 1; FIG. 3 is a lower perspective view of the awning fabric with pattern of FIG. 1 as used on an awning assembly; and, FIG. 4 is an upper perspective view of the awning fabric with pattern of FIG. 1 as used on an awning assembly. The broken lines and white space surrounding the pattern features in FIGS. 1 and 3 depict portions of the awning fabric with pattern that form no part of the claimed design. The dot-dash-dot broken line in FIG. 4 depicts the boundary to the claim and forms no part thereof. The broken lines illustrating the awning assembly in FIGS. 3 and 4 depict environment and form no part of the claimed design. The cross-hatch portions of the pattern in FIGS. 2 and 4 depict unclaimed portions of the pattern.

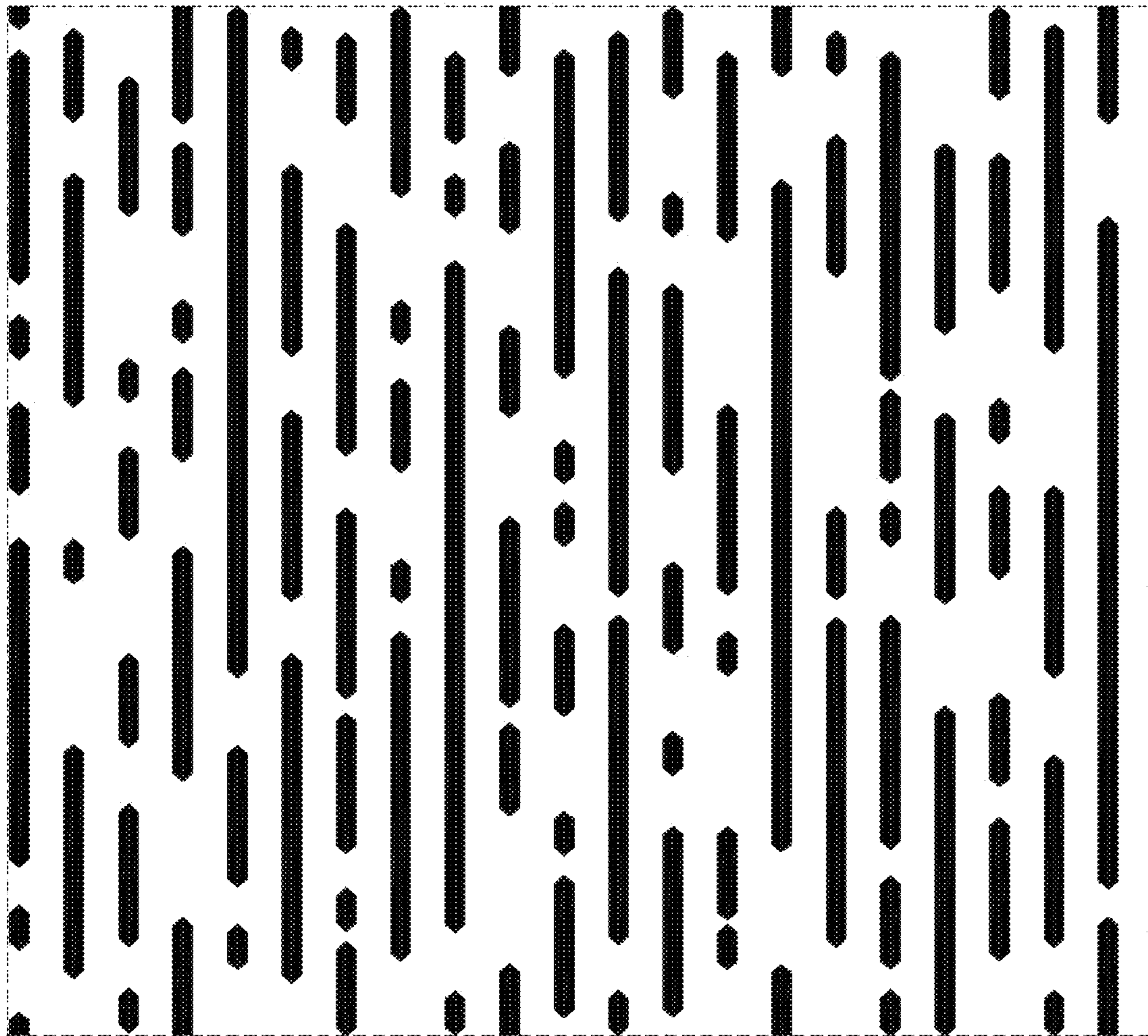

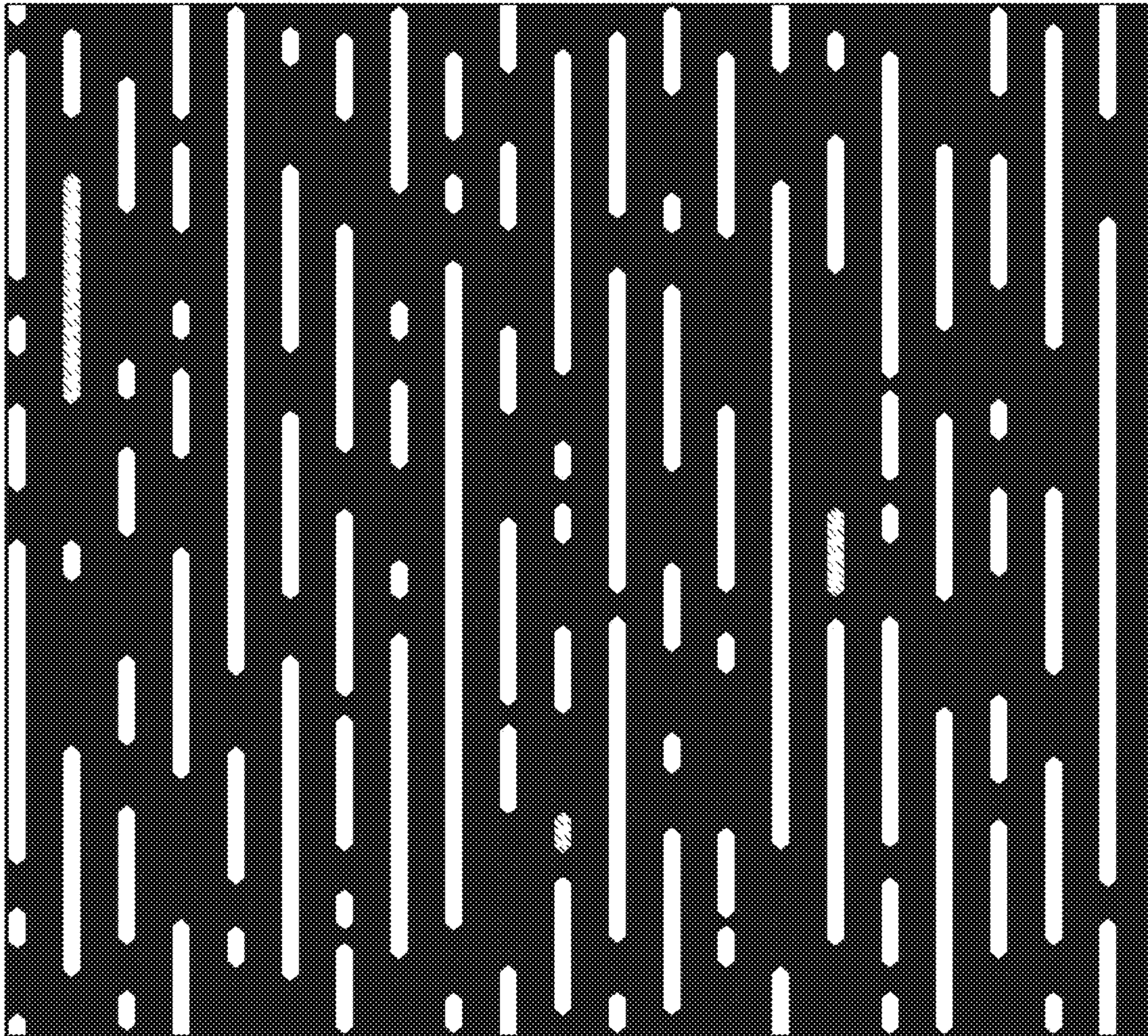

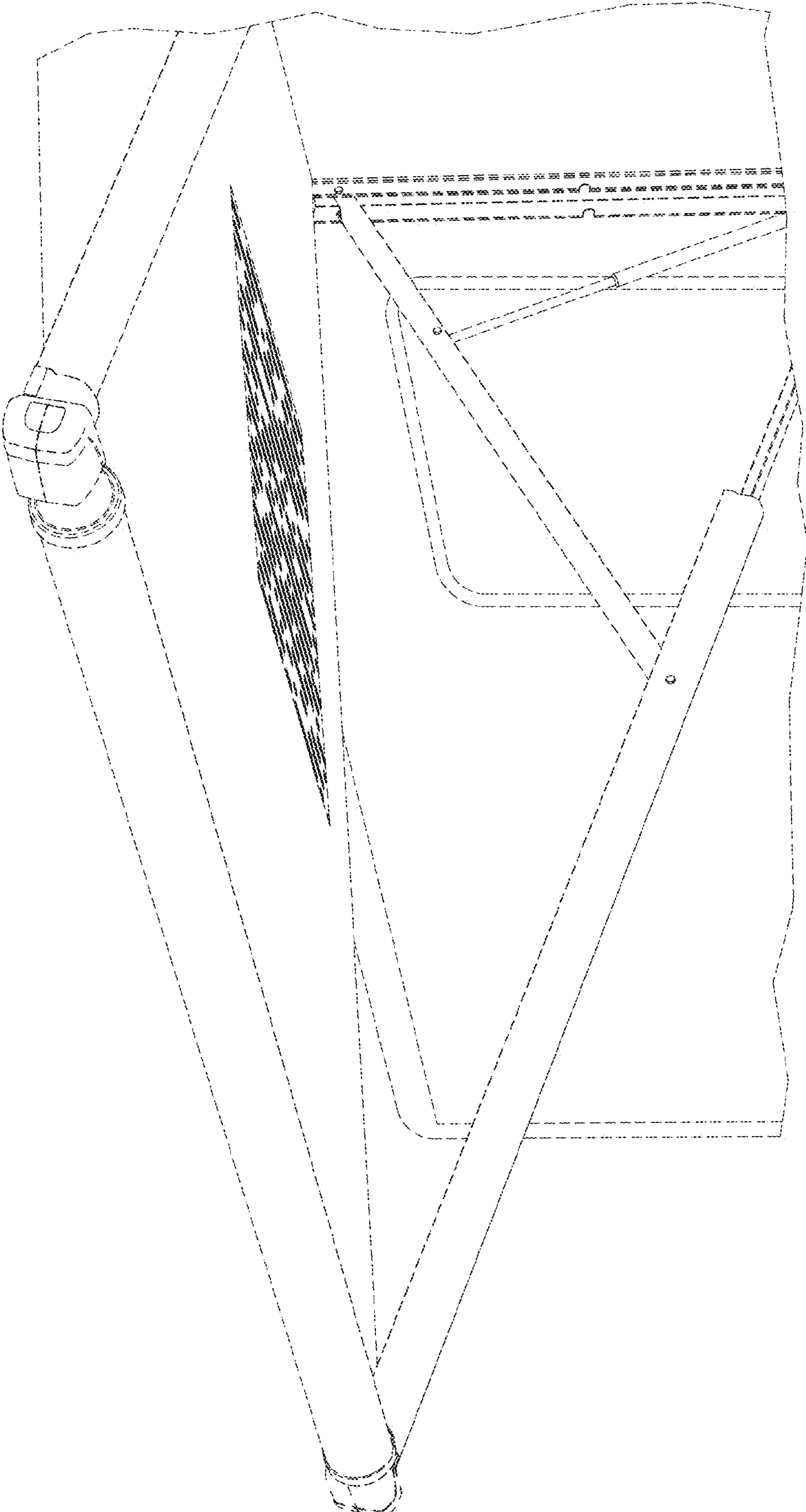

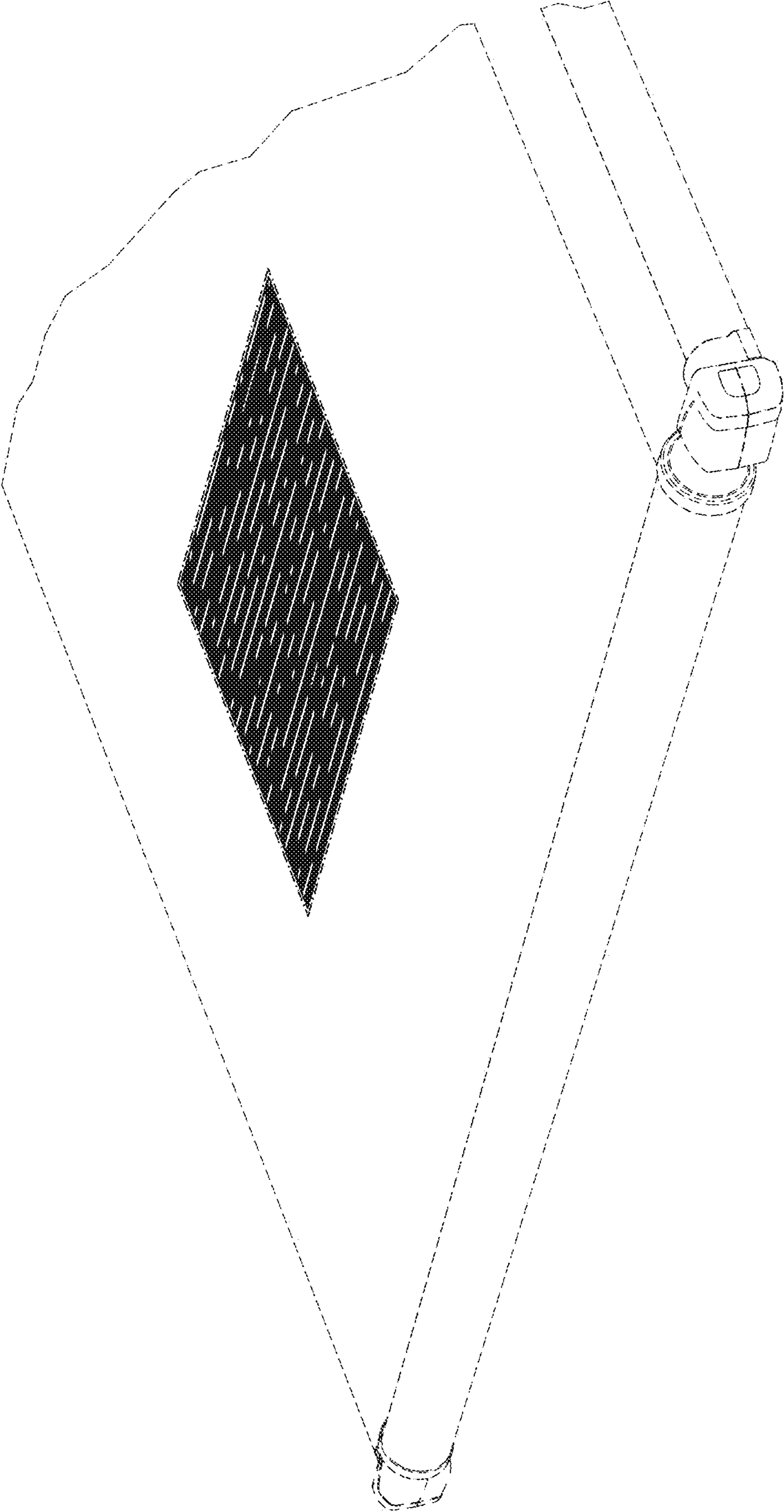
