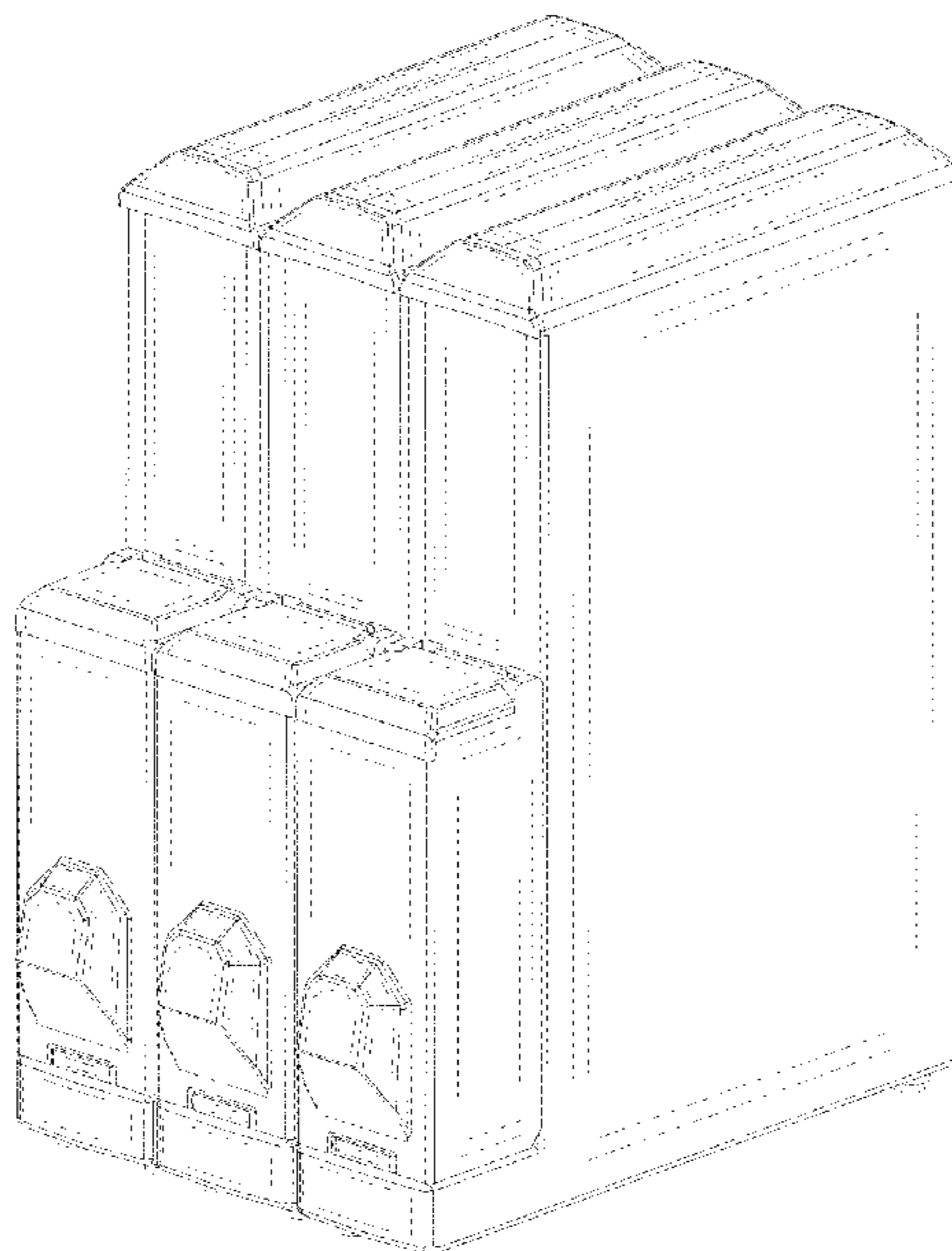
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a tableware self-service taking device showing our new design;

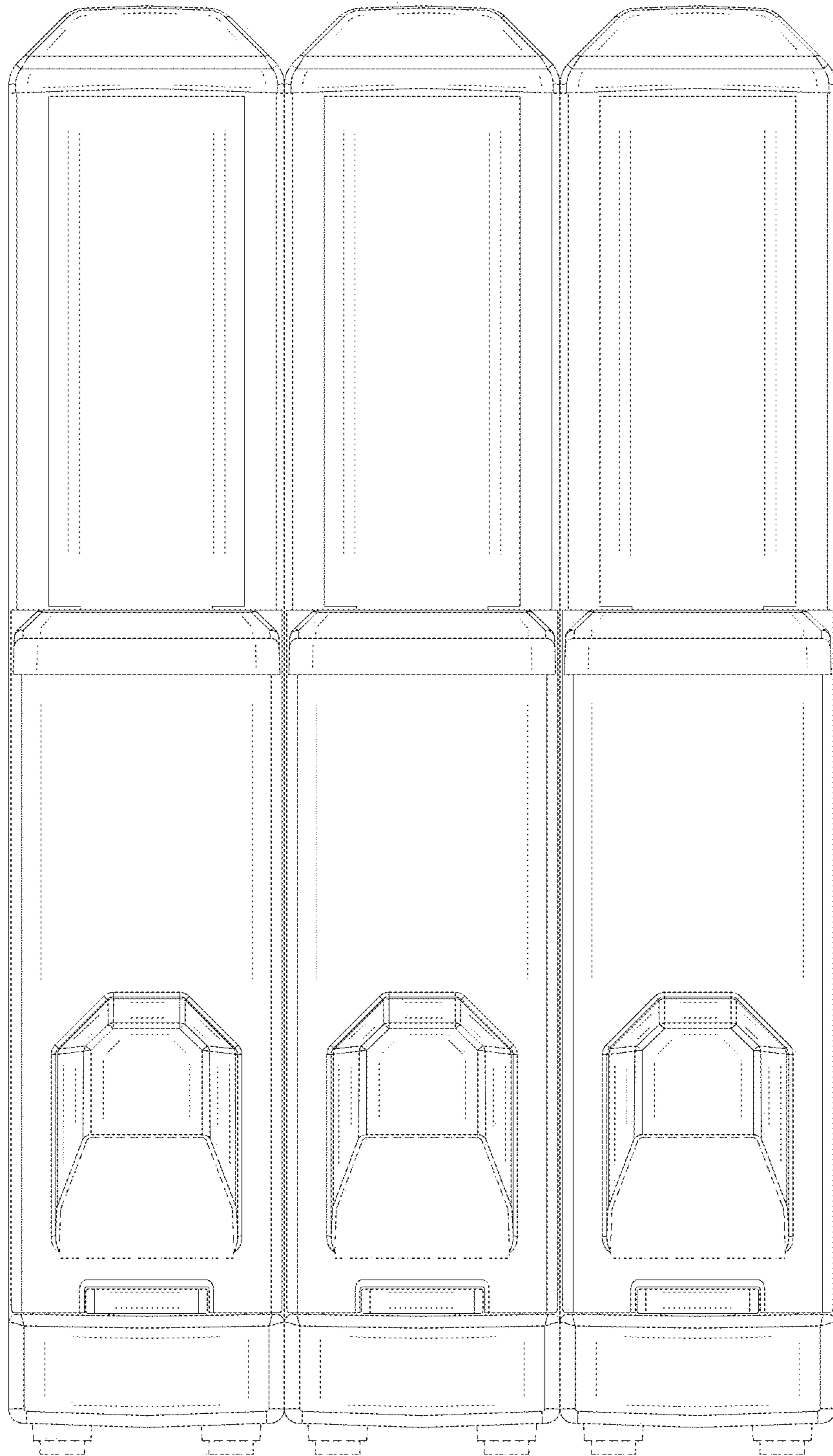

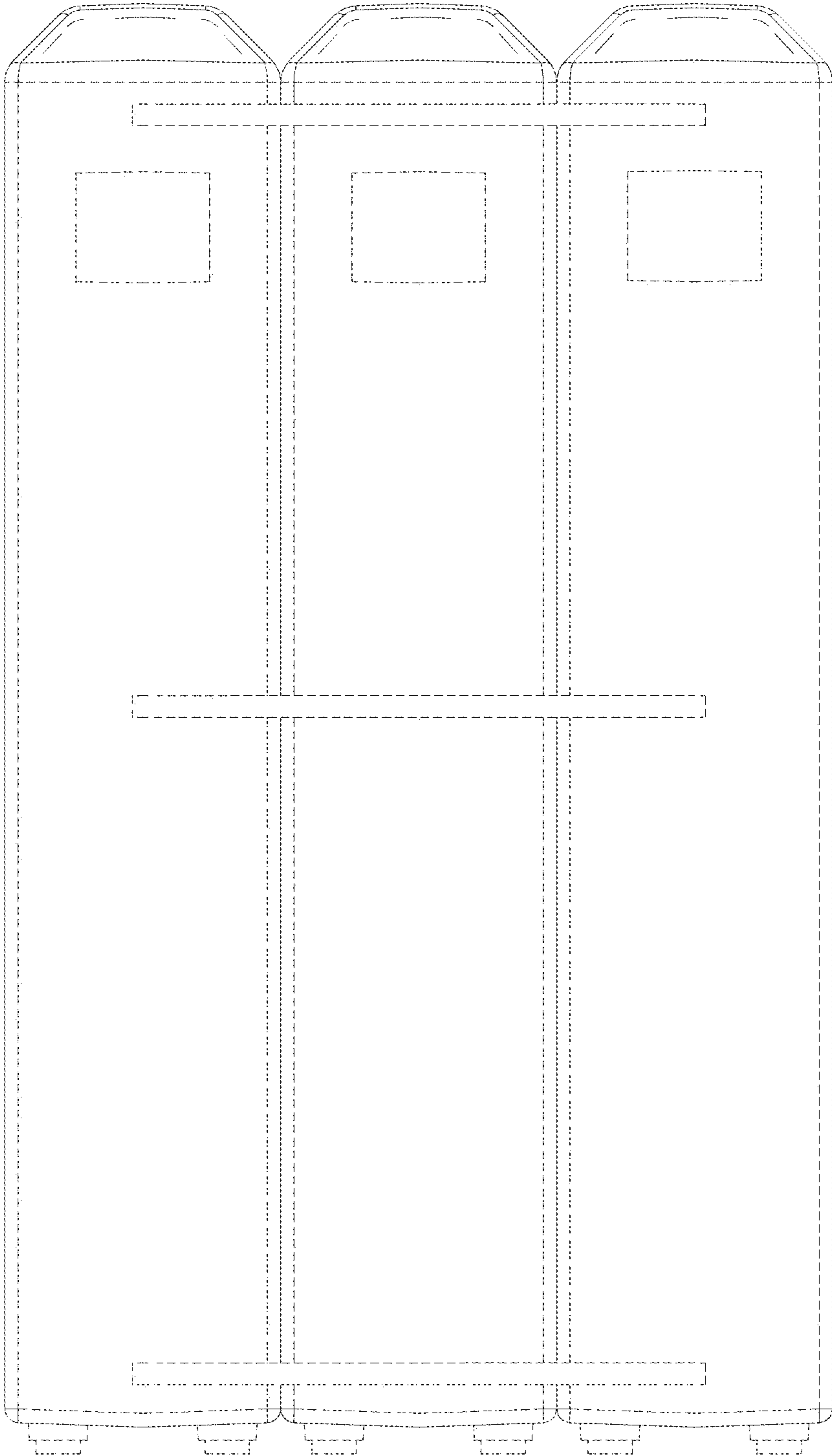

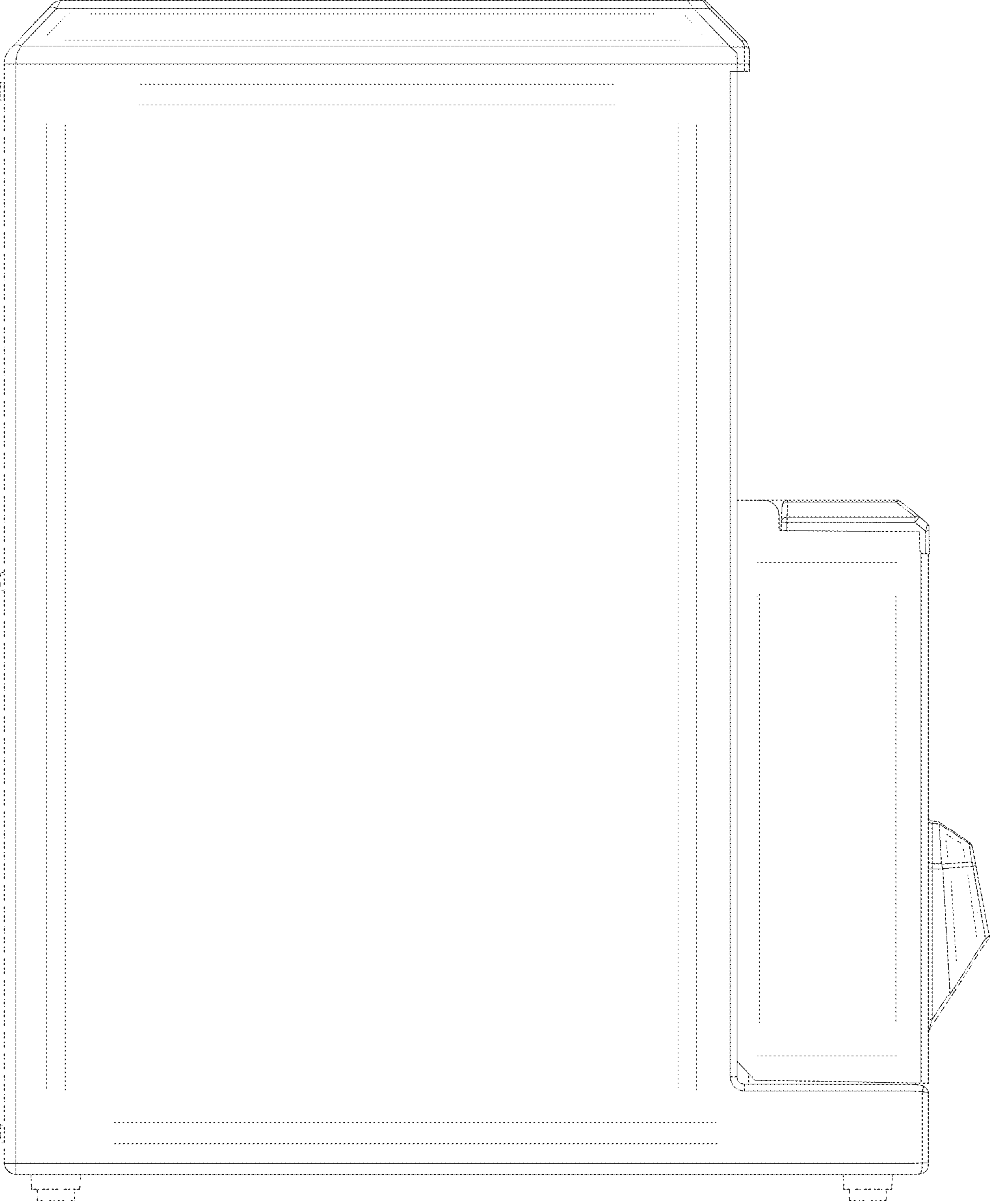

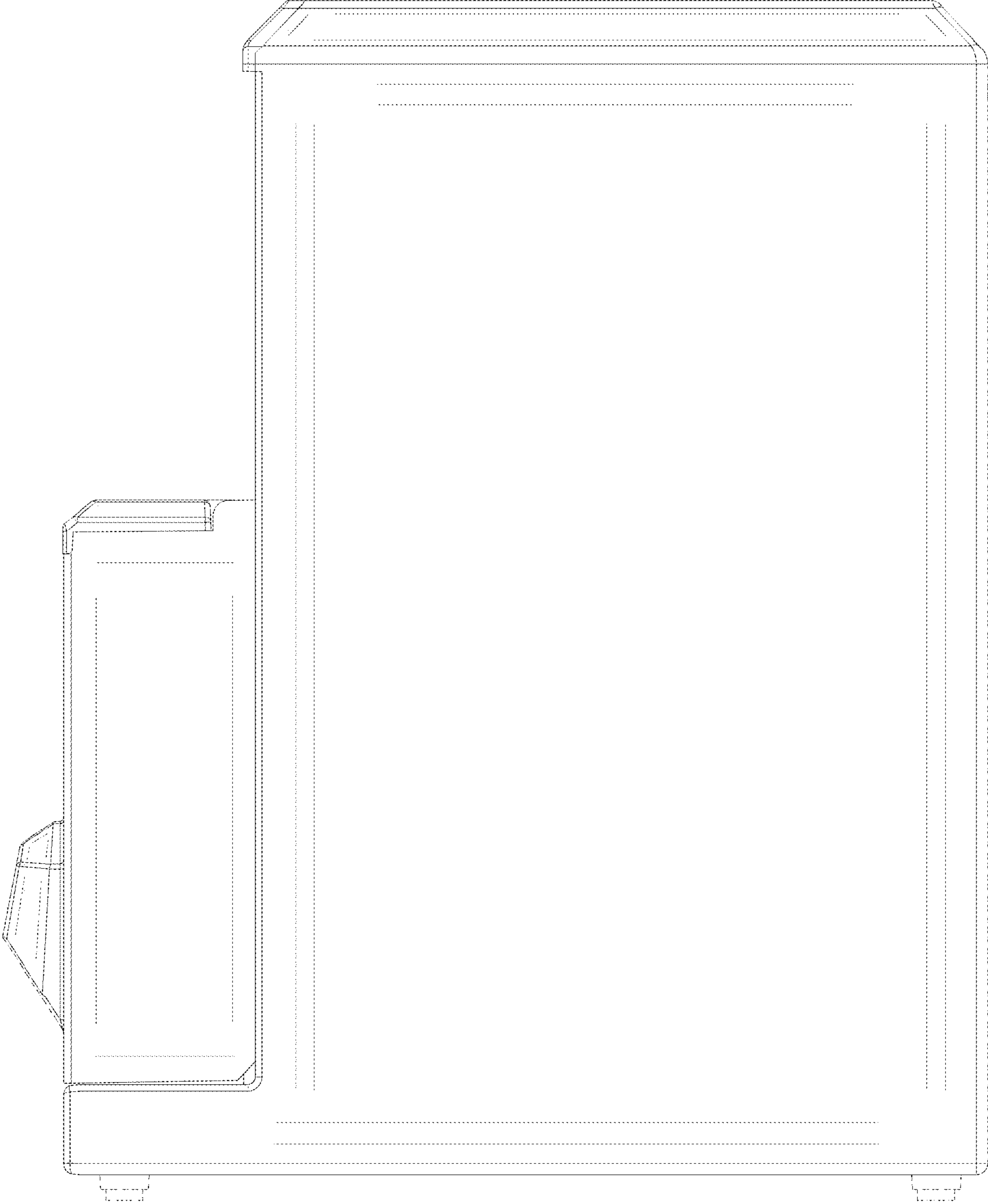

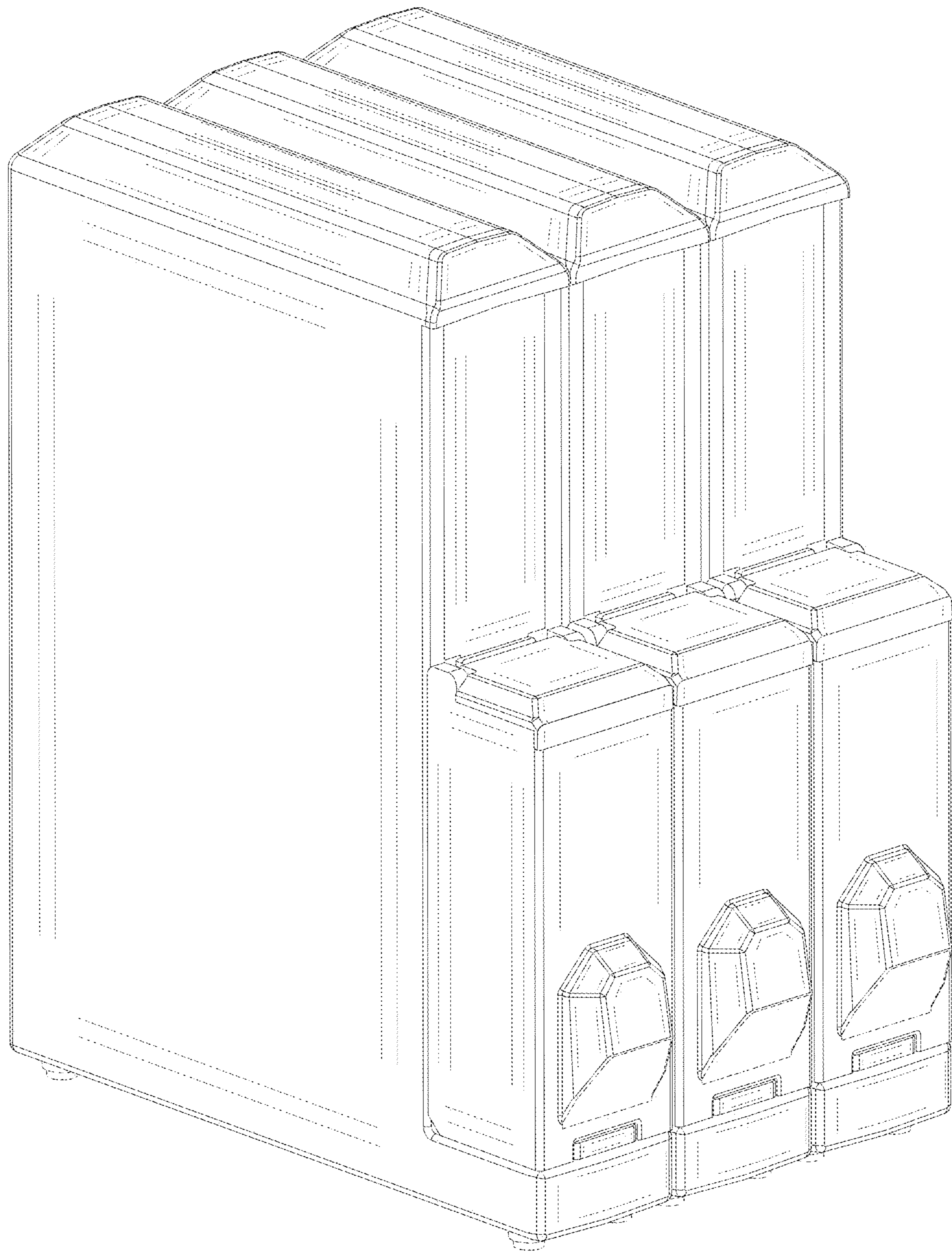

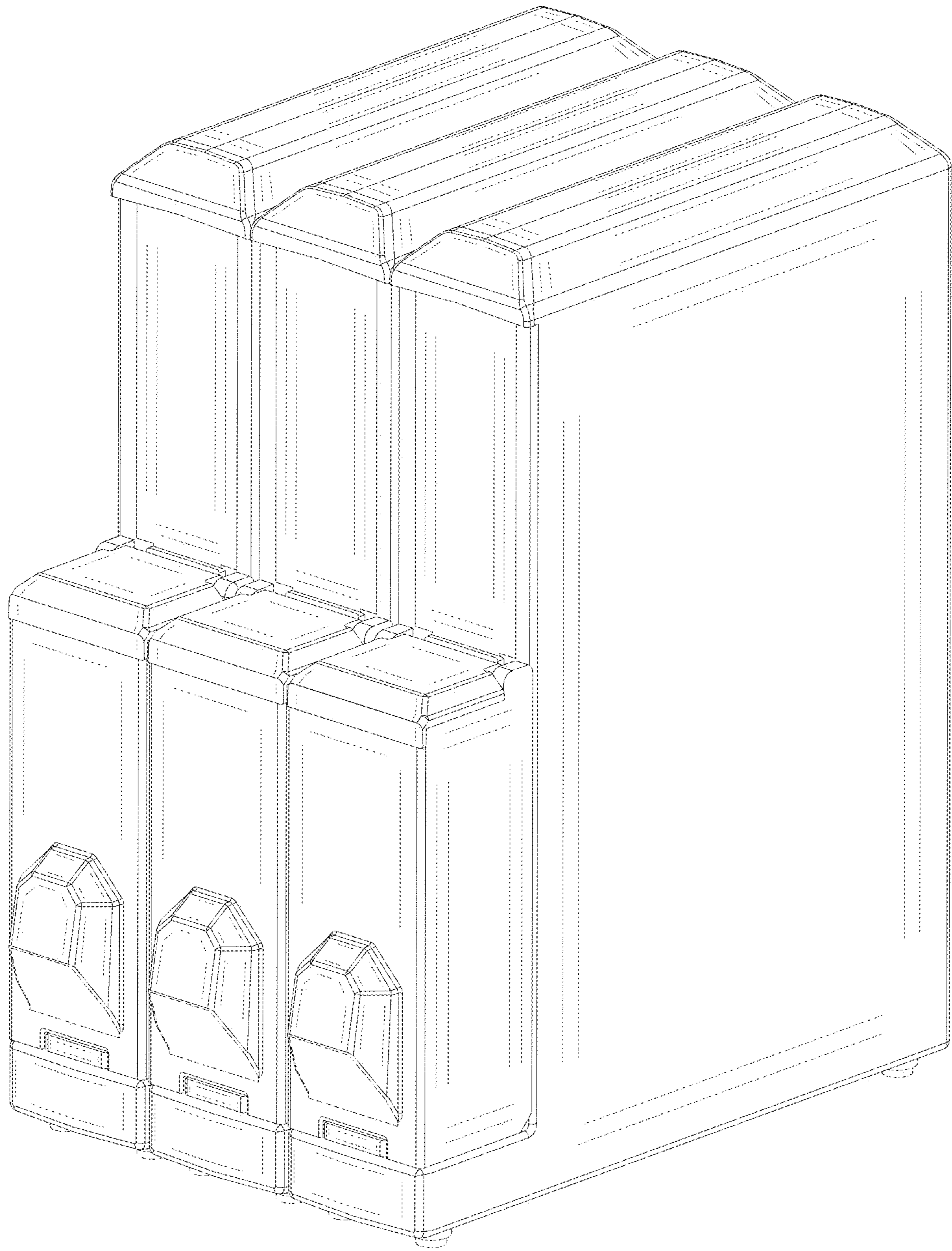

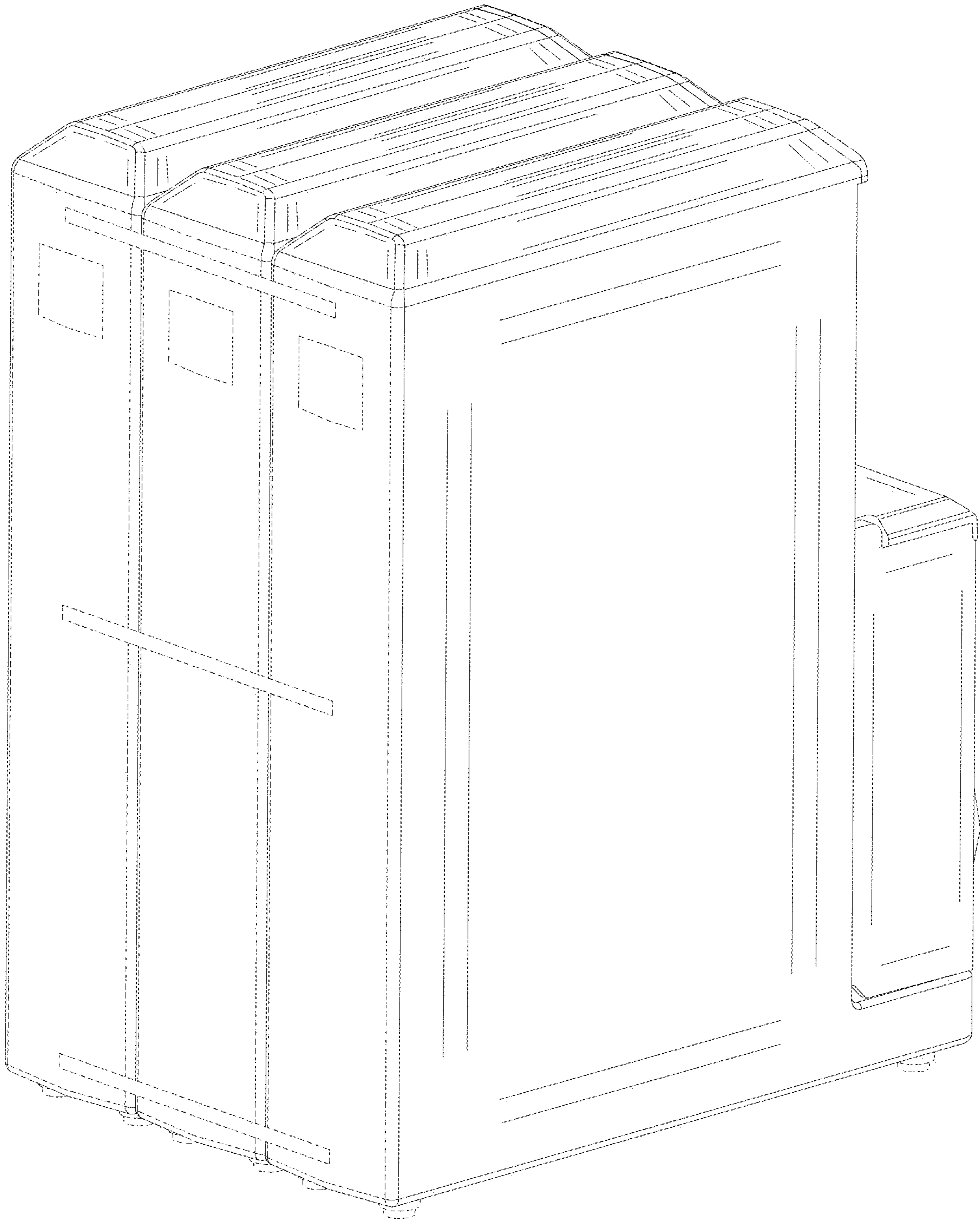

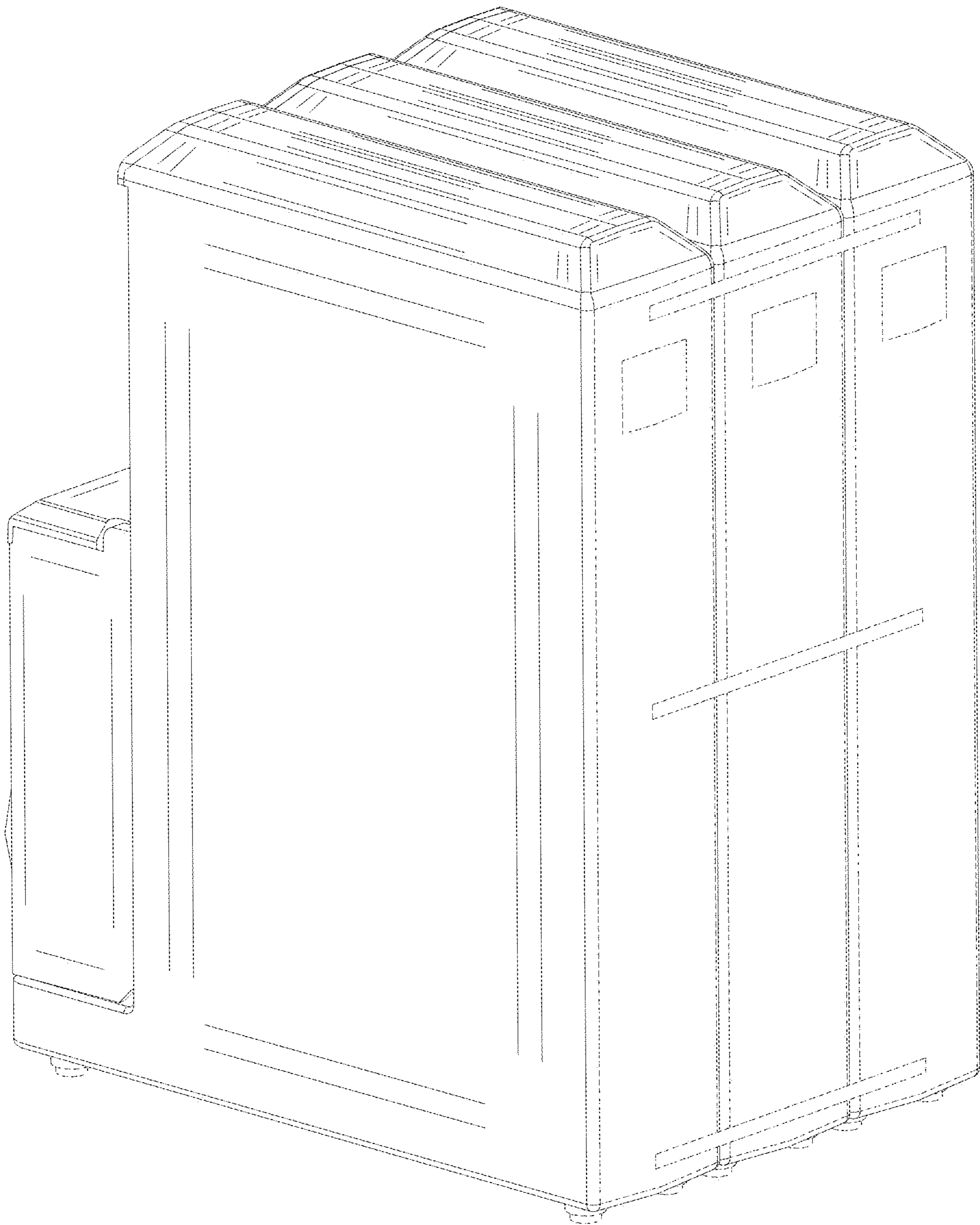
