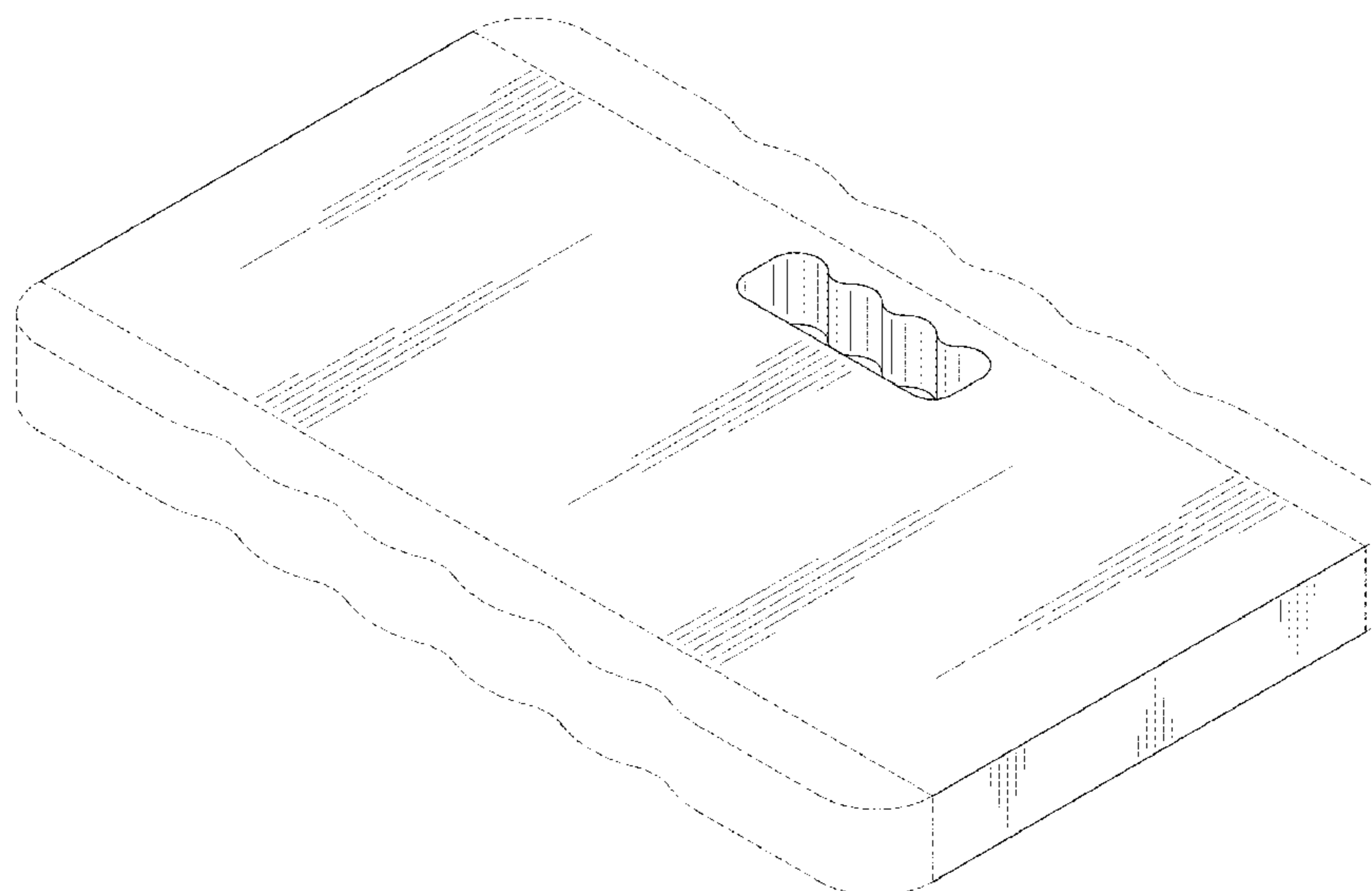
The ornamental design for a kneeling pad, as shown and described.

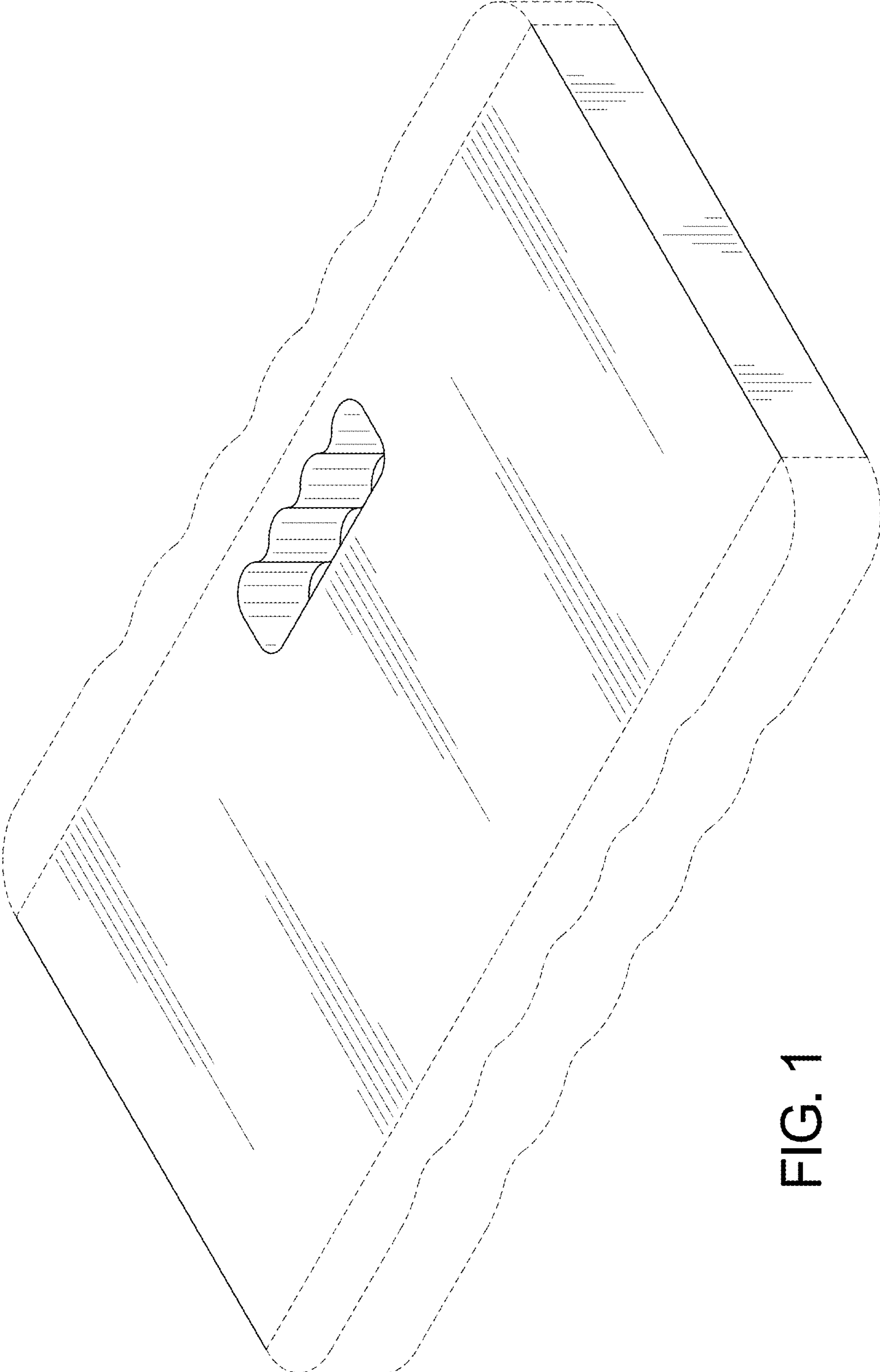

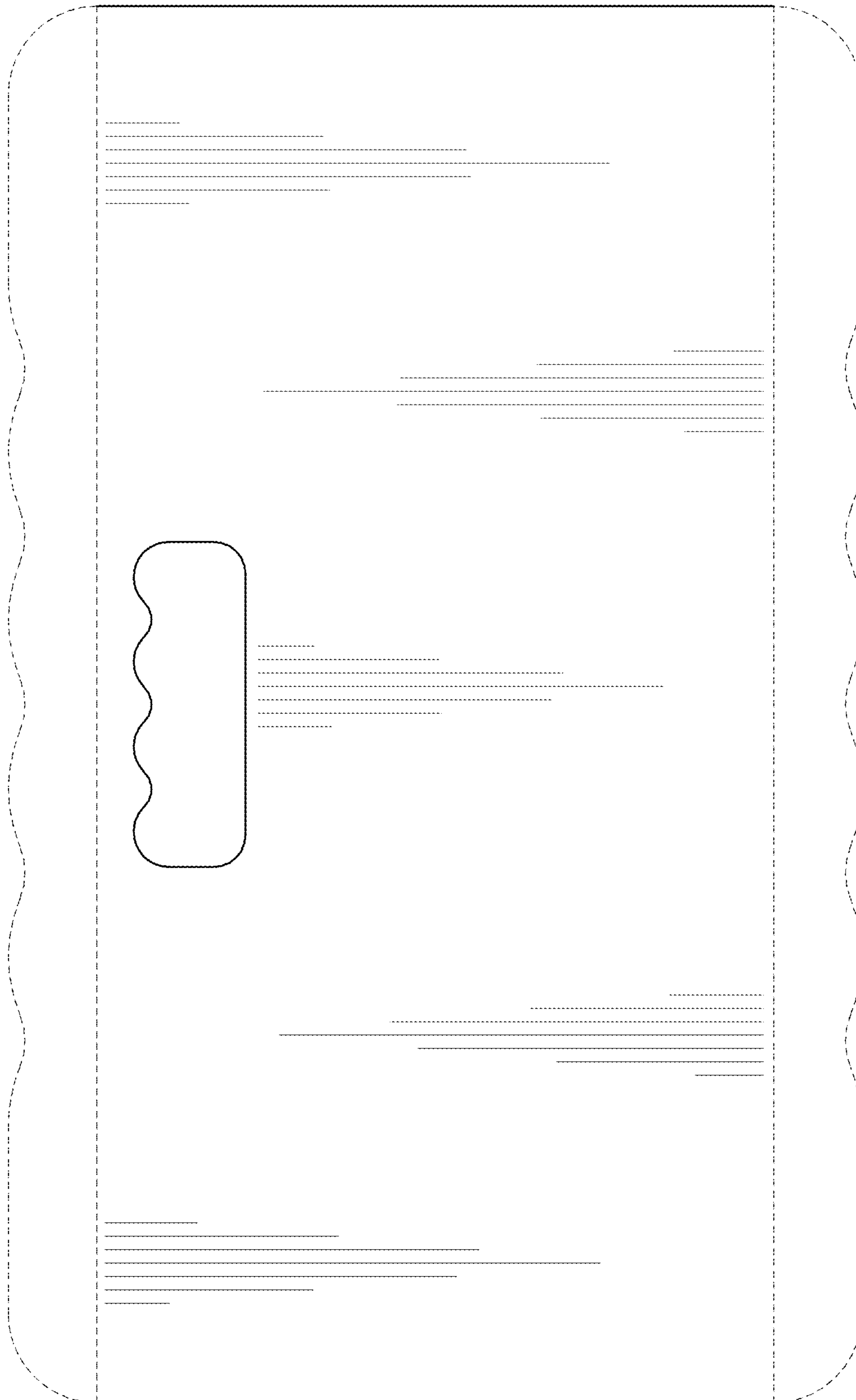

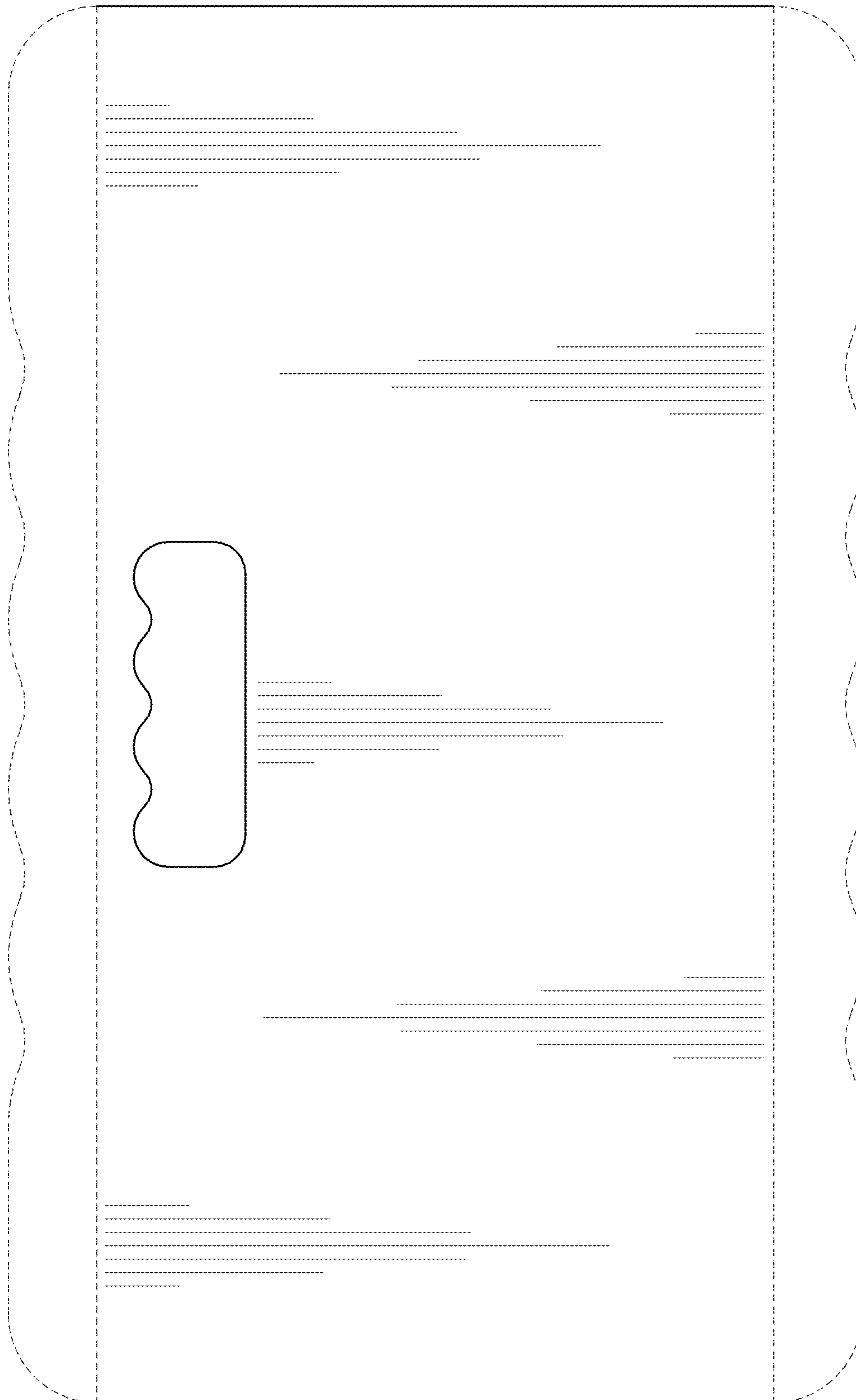

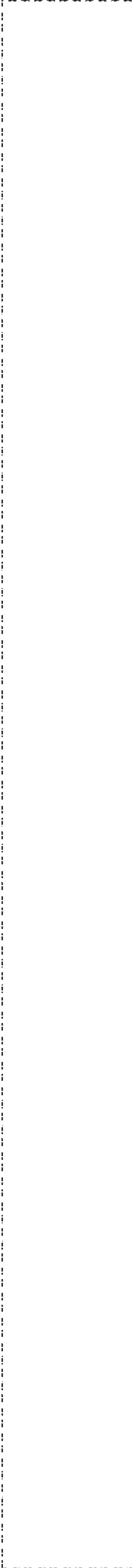

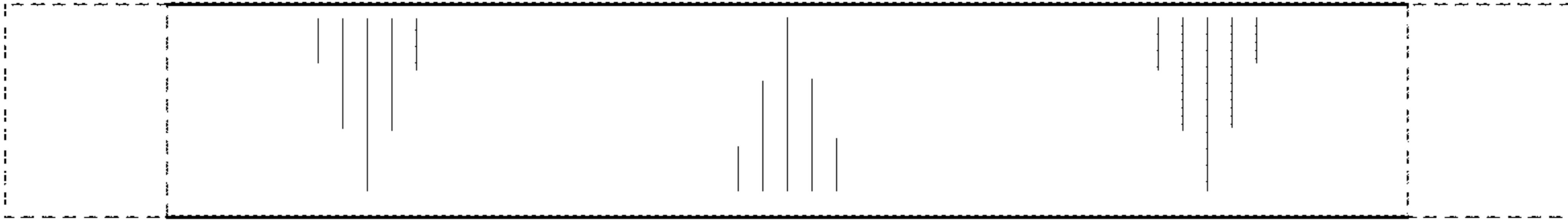

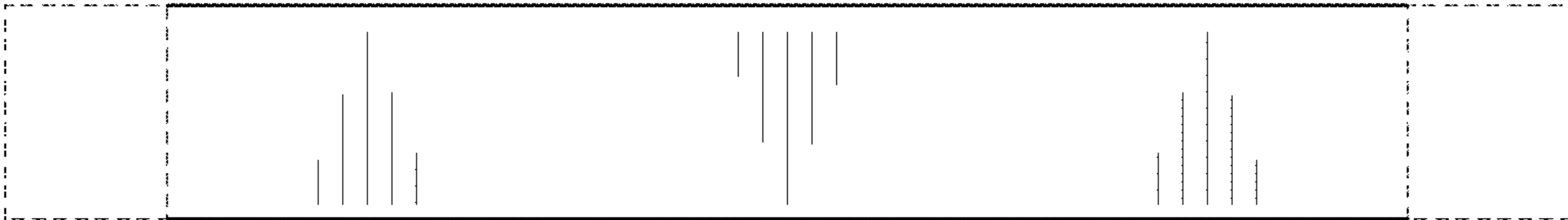

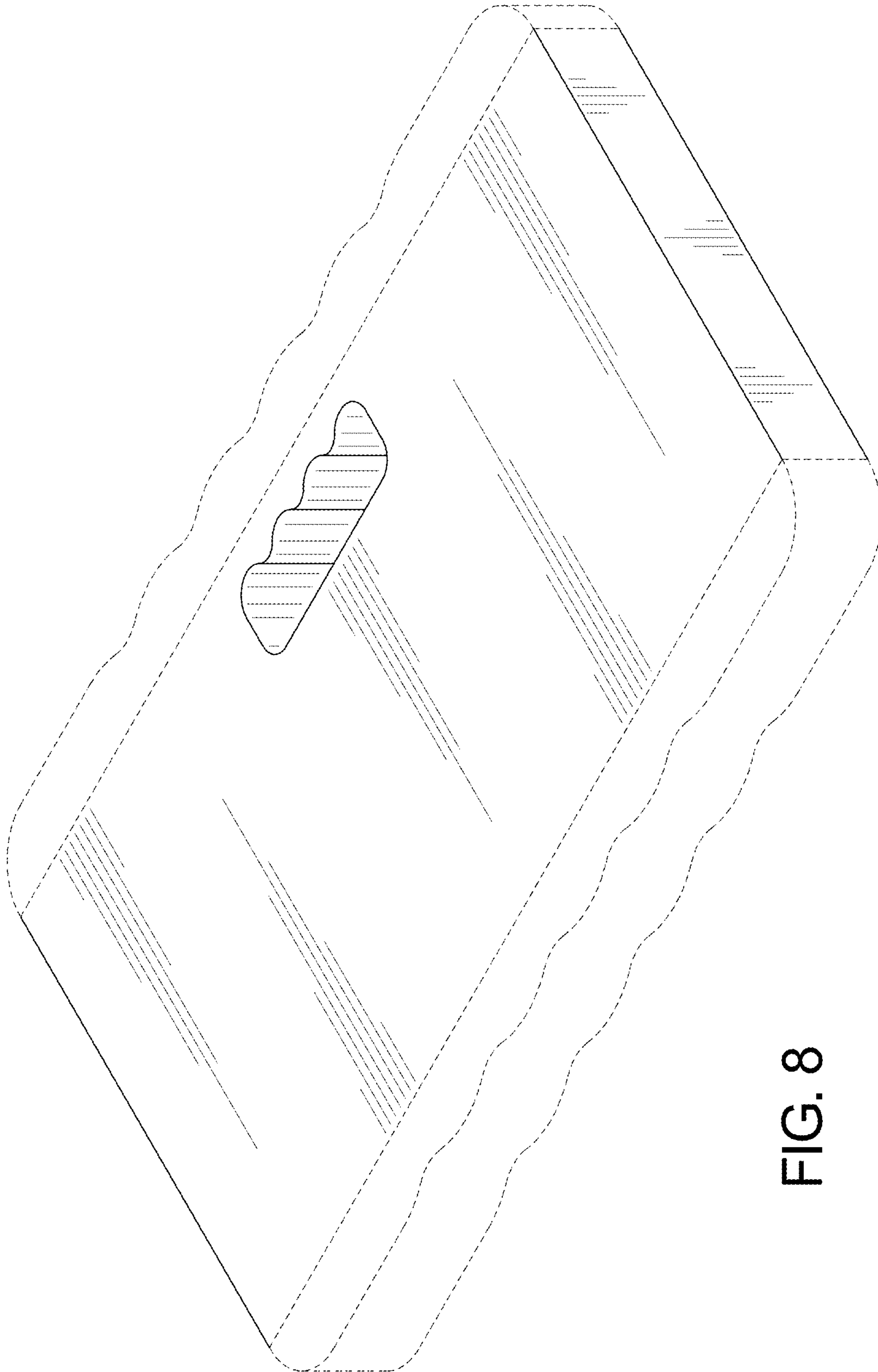

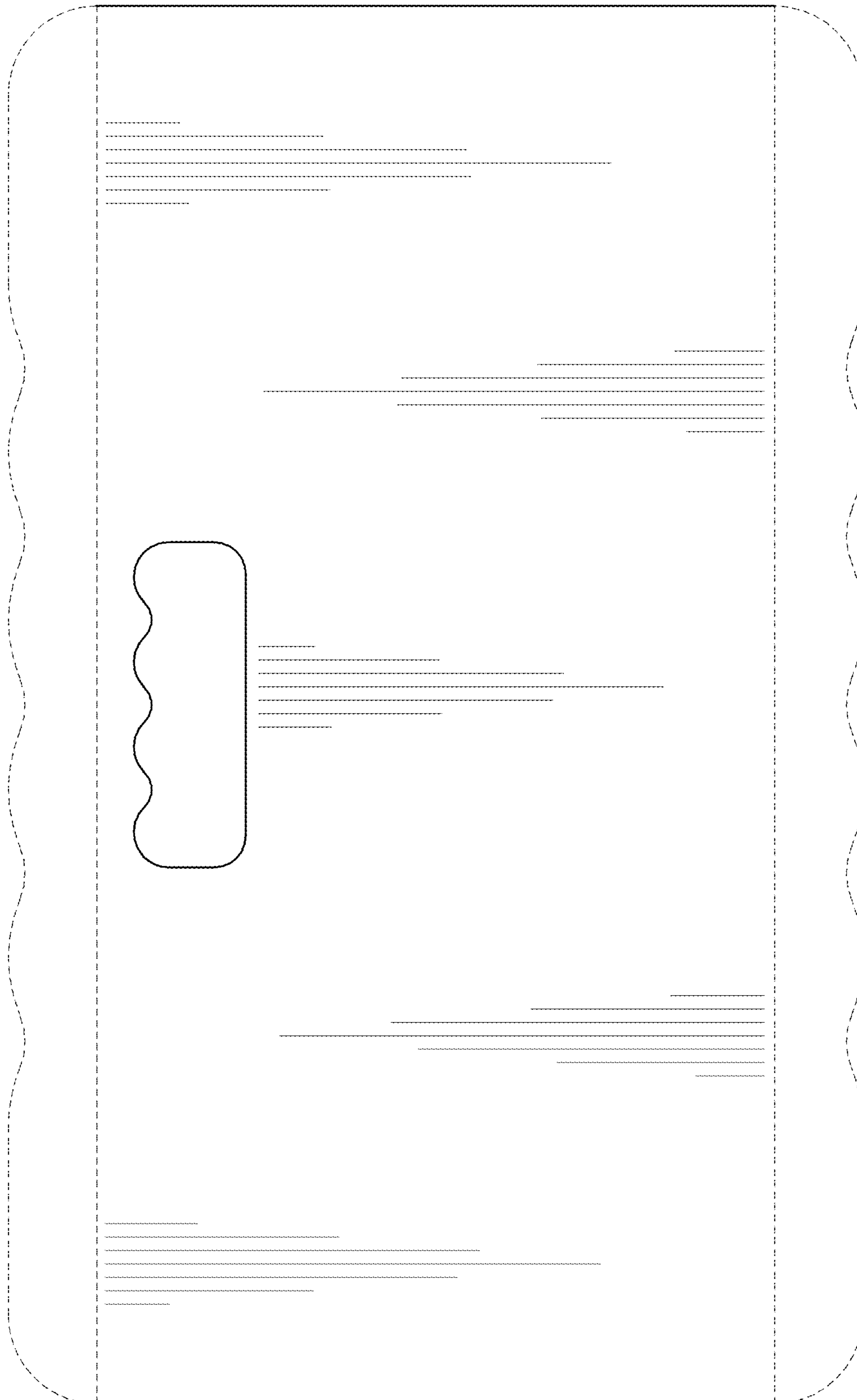

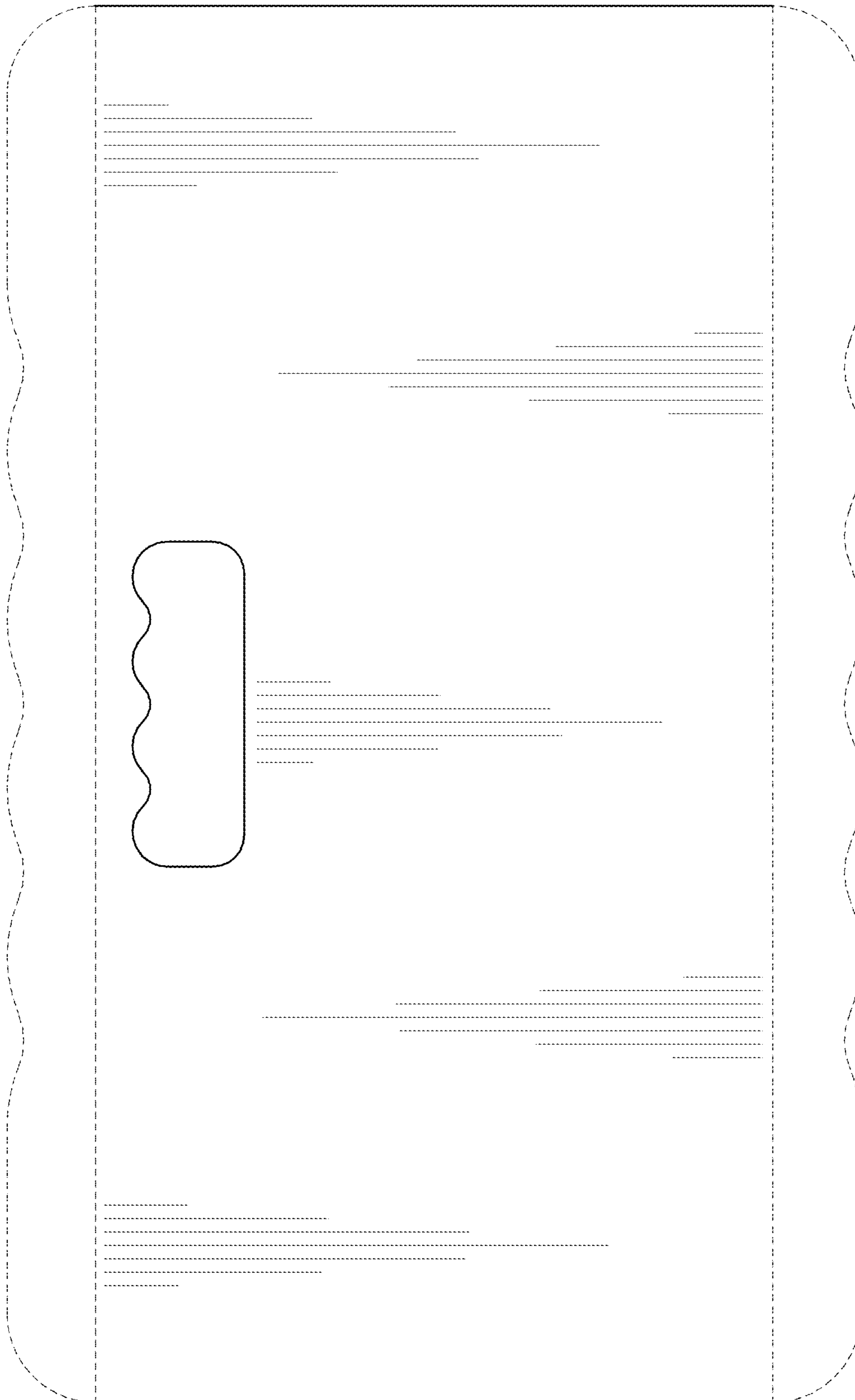

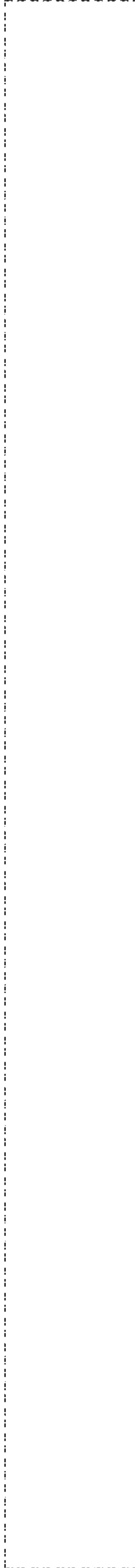

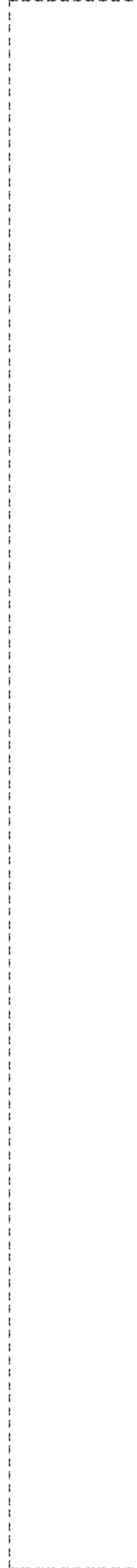

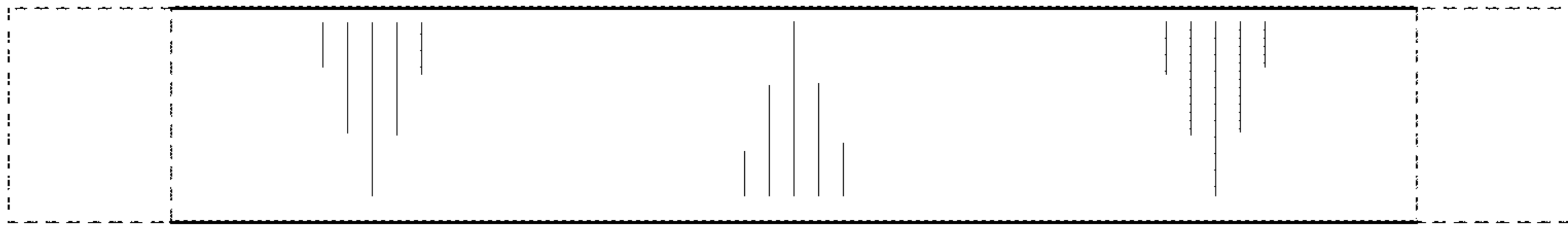

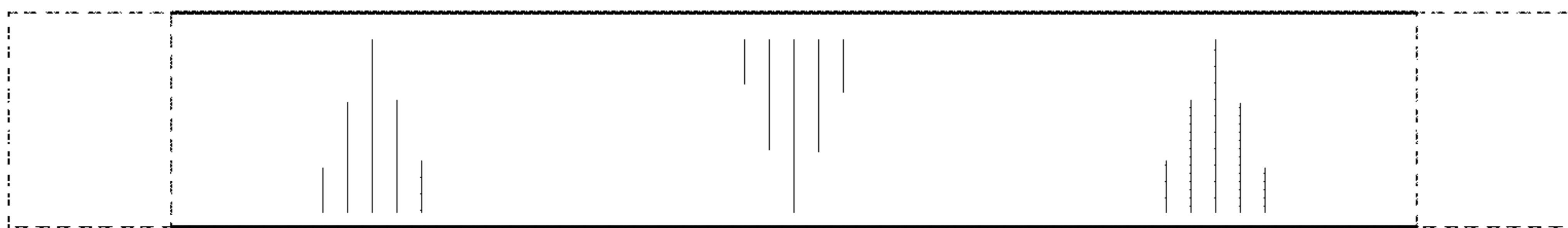

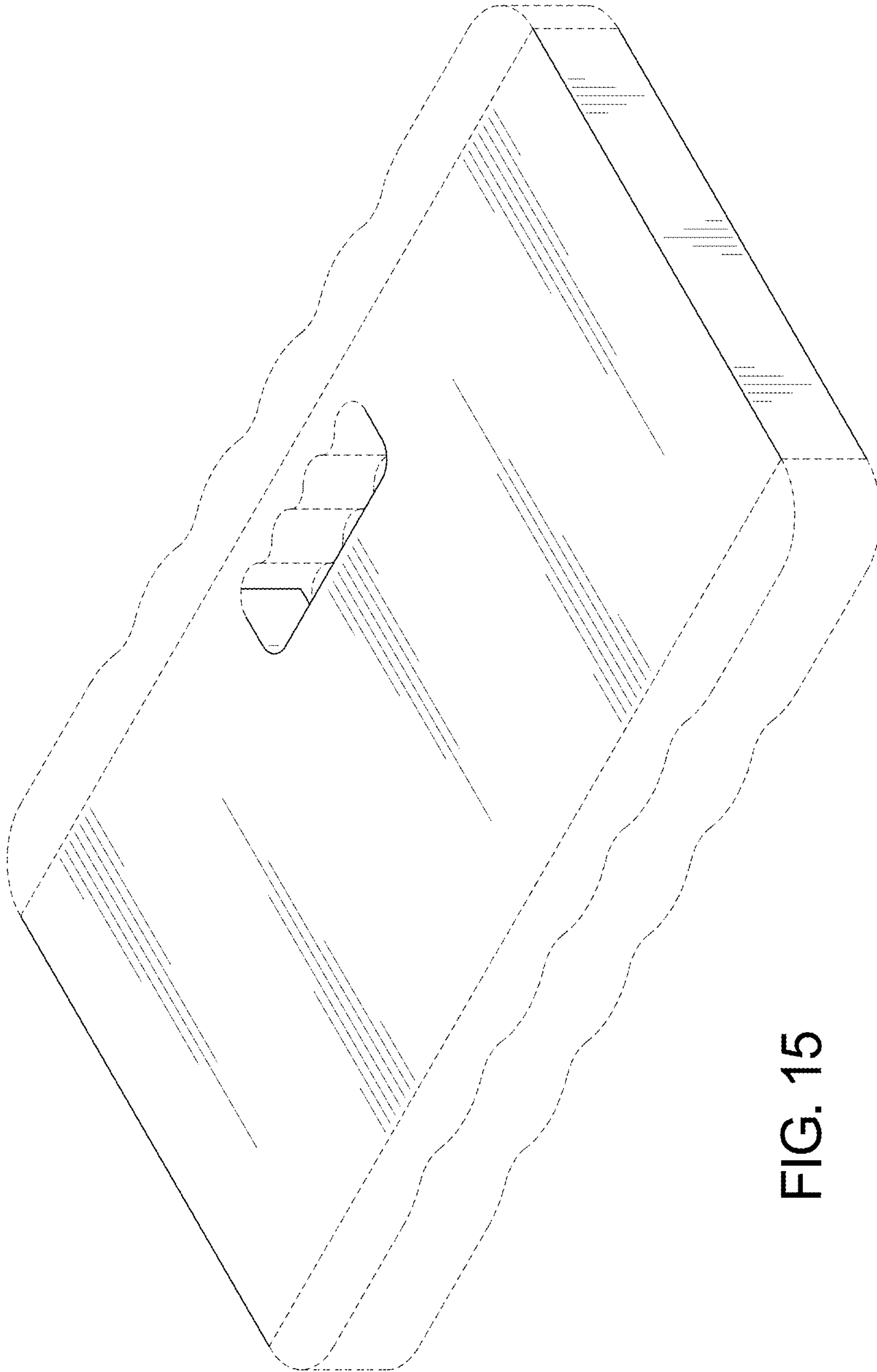

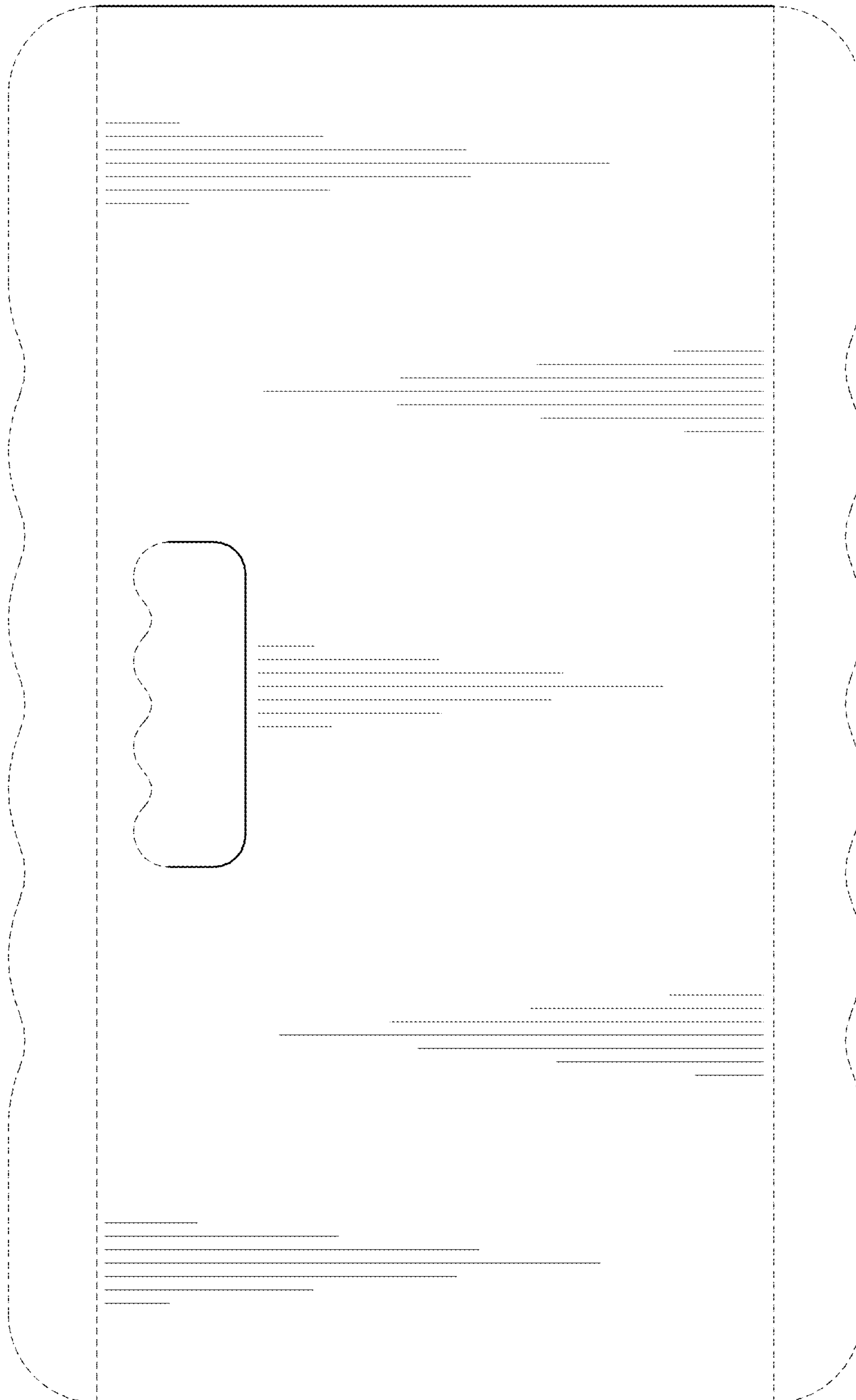

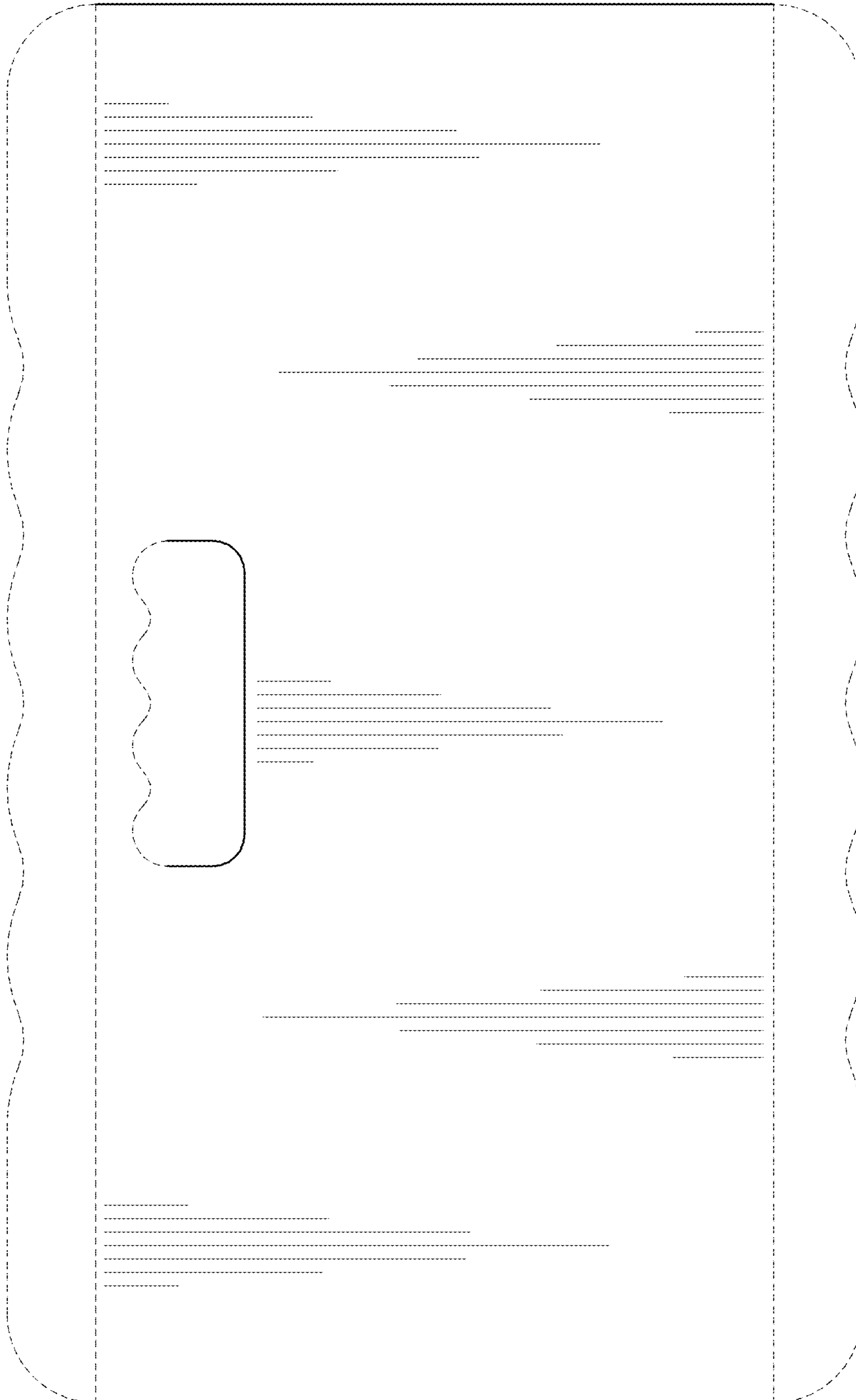

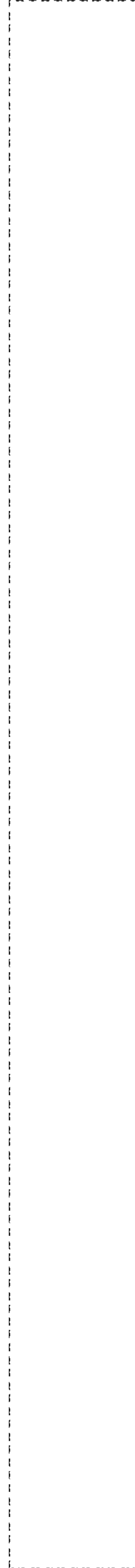

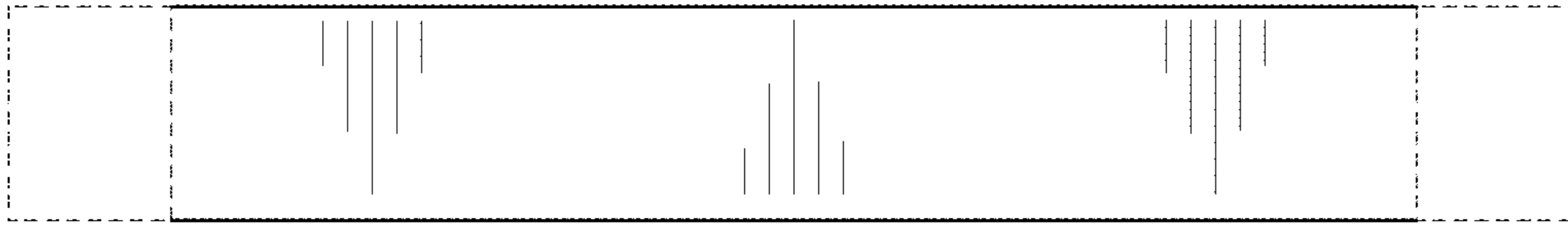

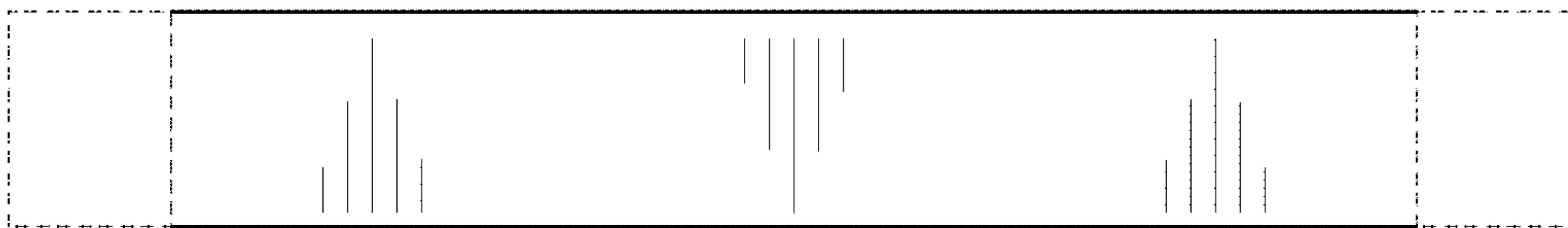

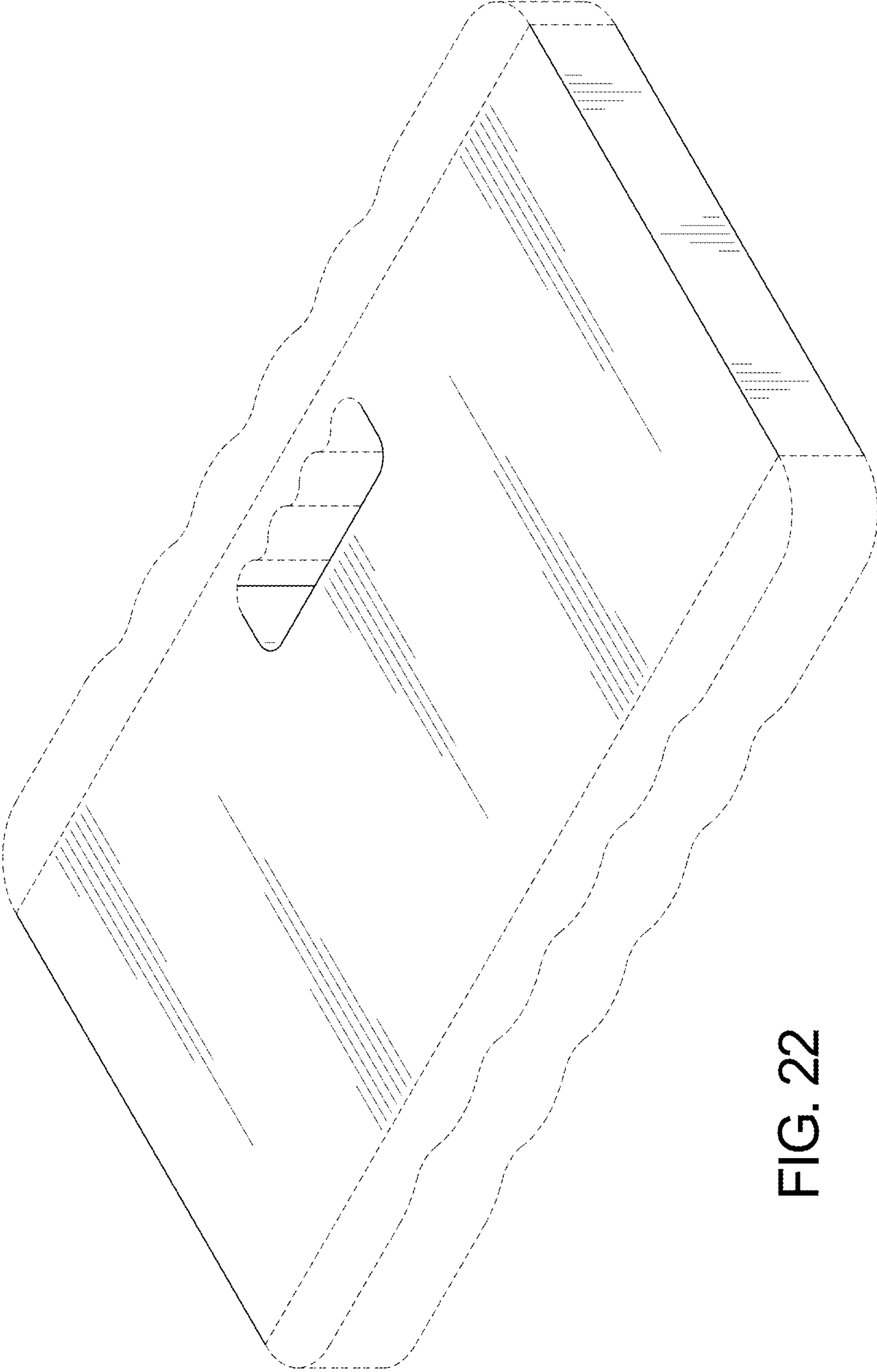

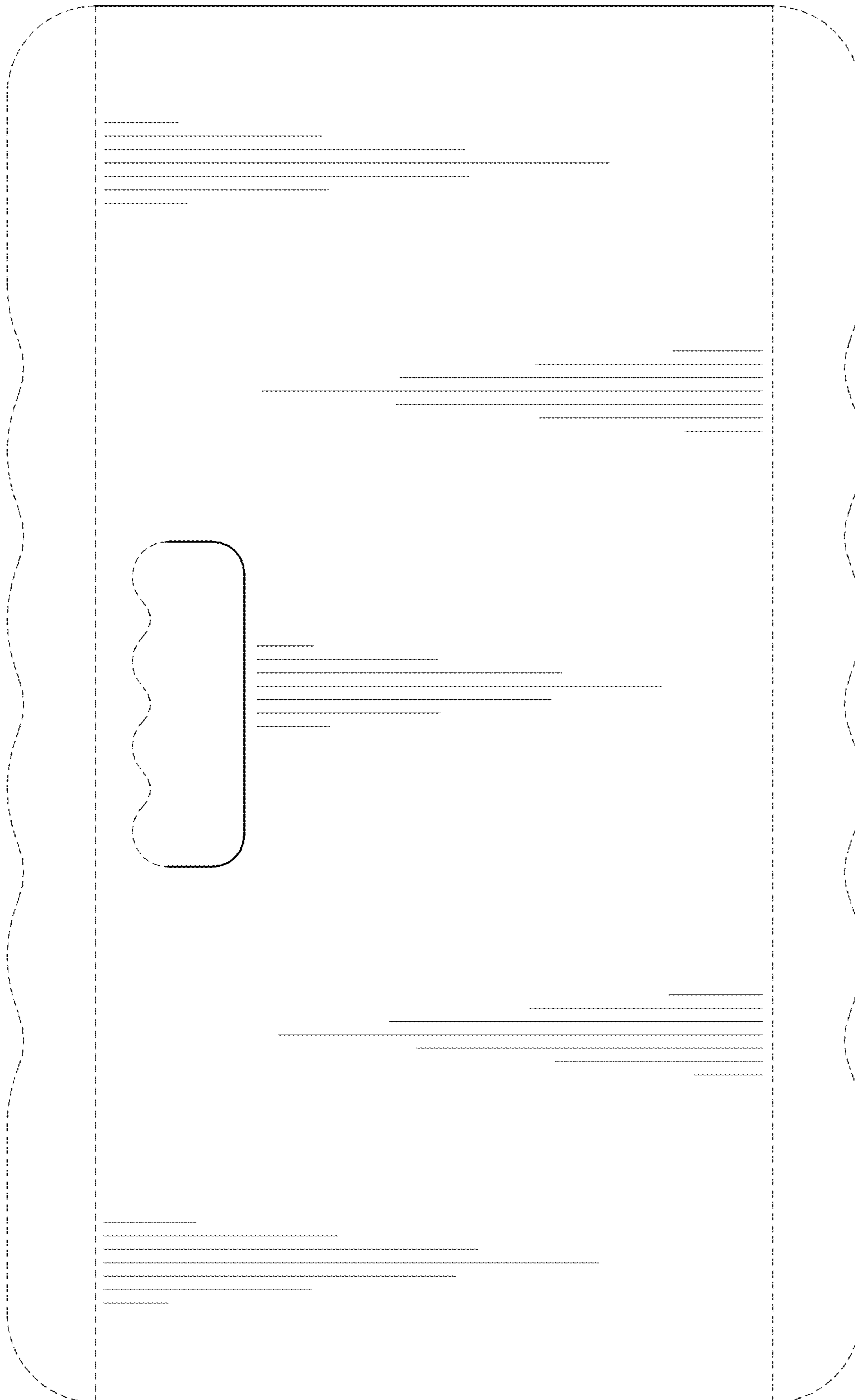

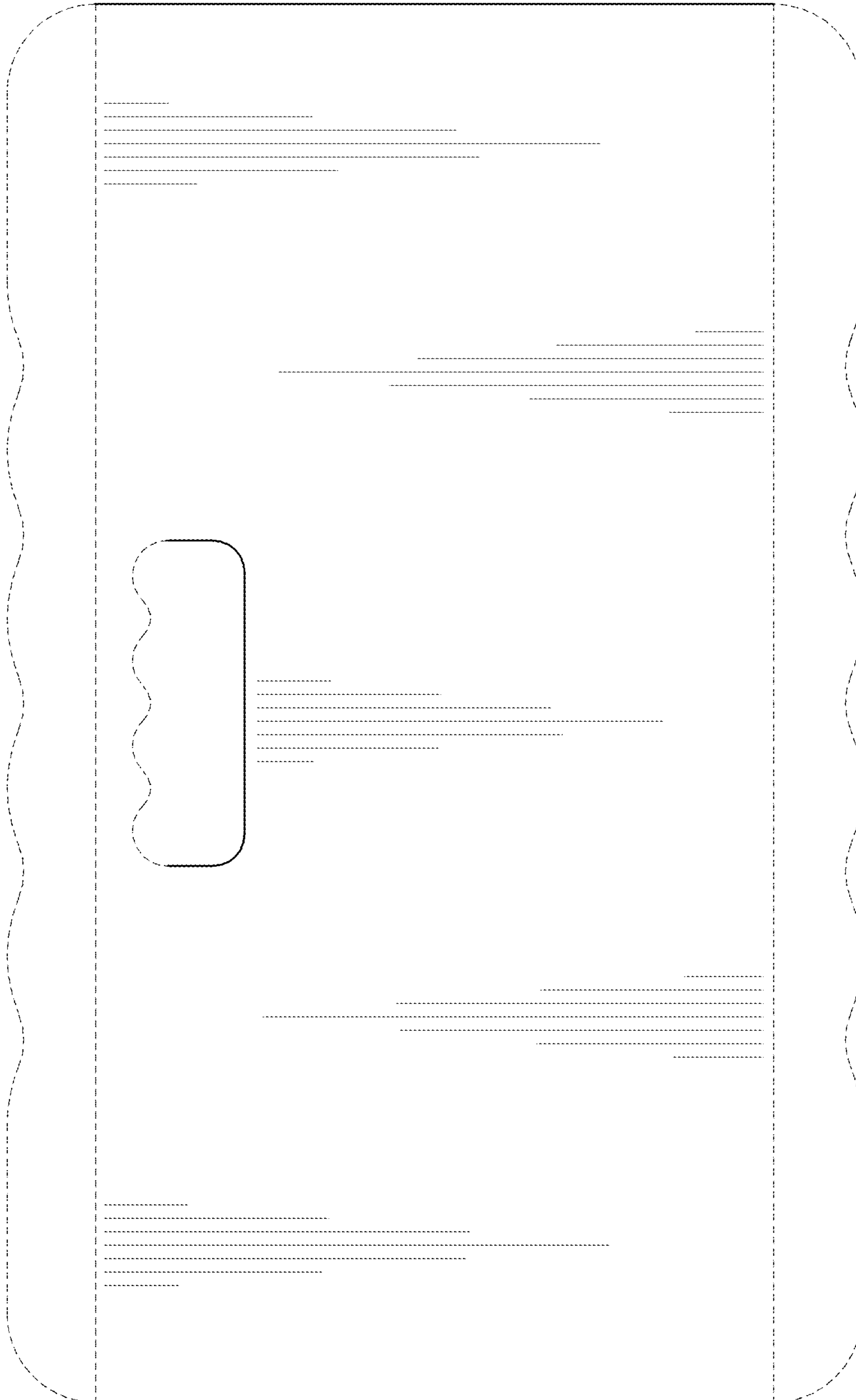

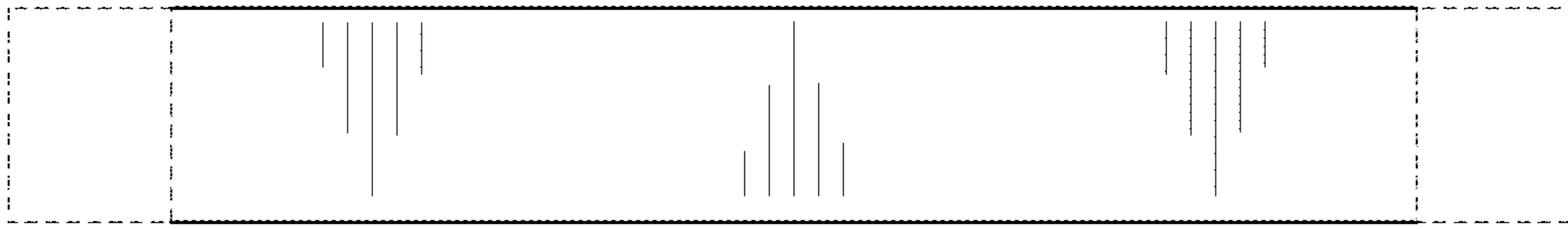

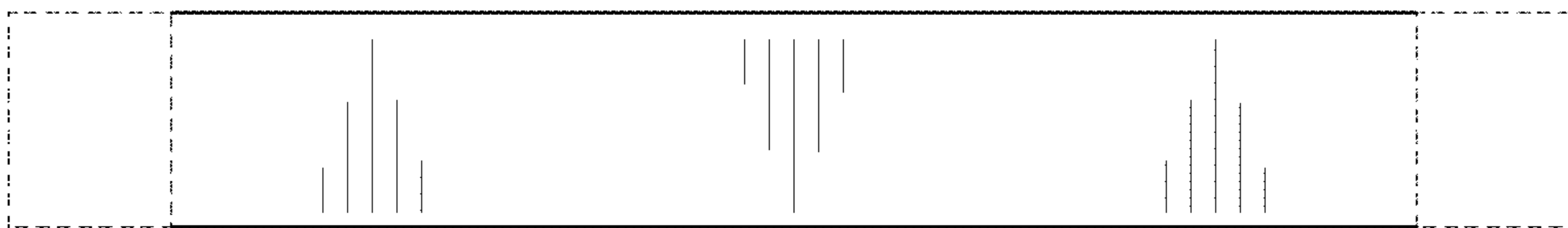
