DESCRIPTION

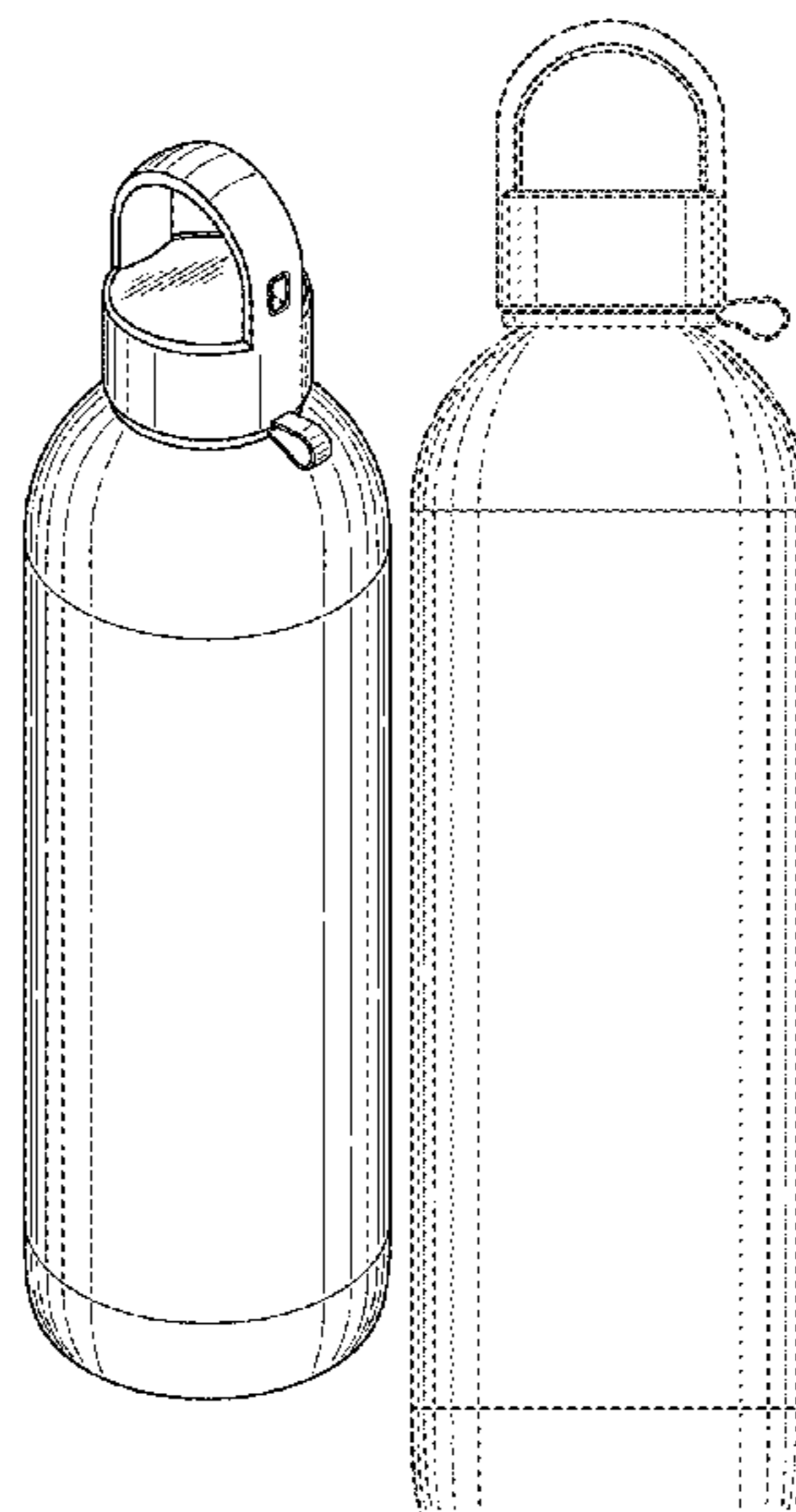
FIG. 1 is a perspective view of a drinking flask showing my new design;

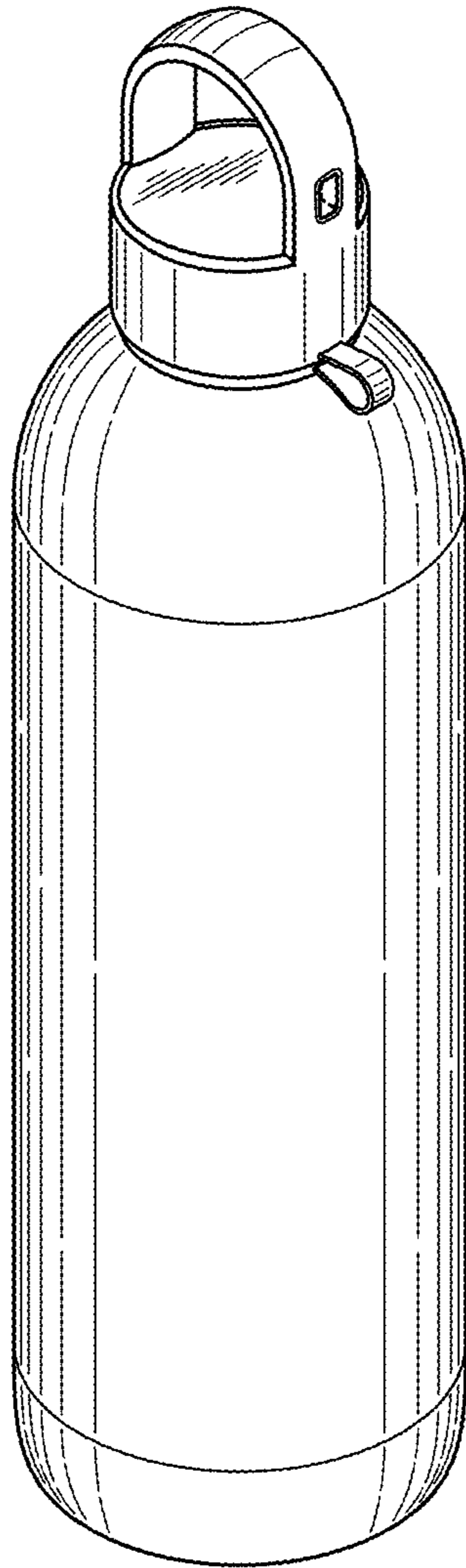

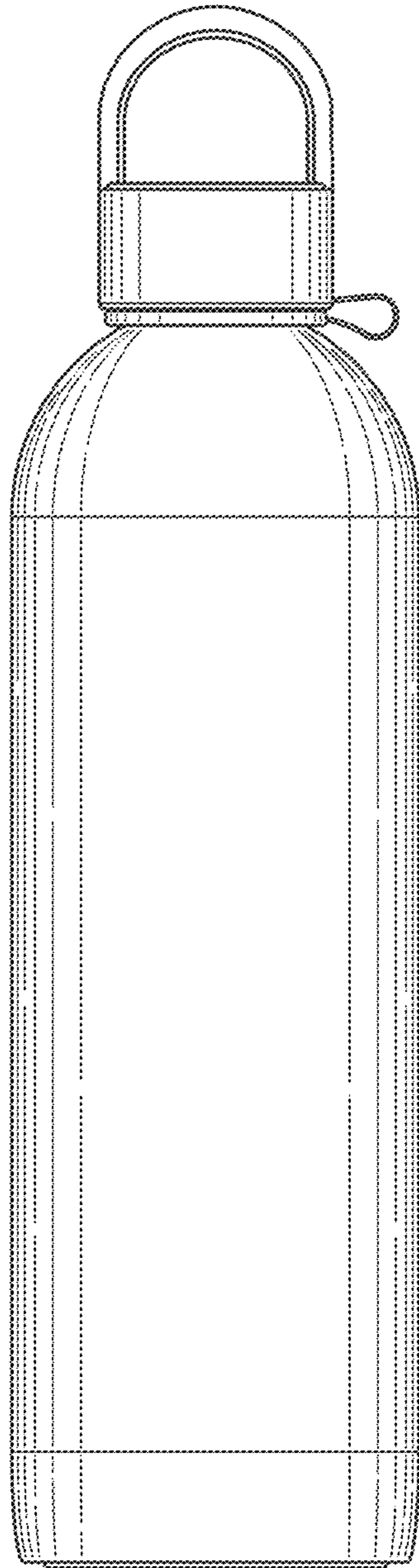

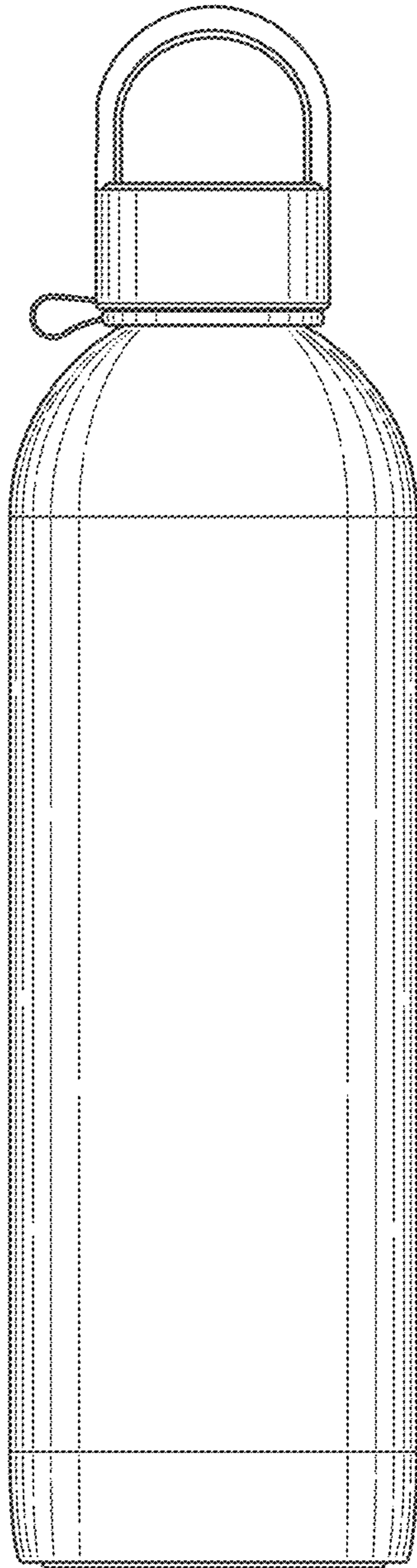

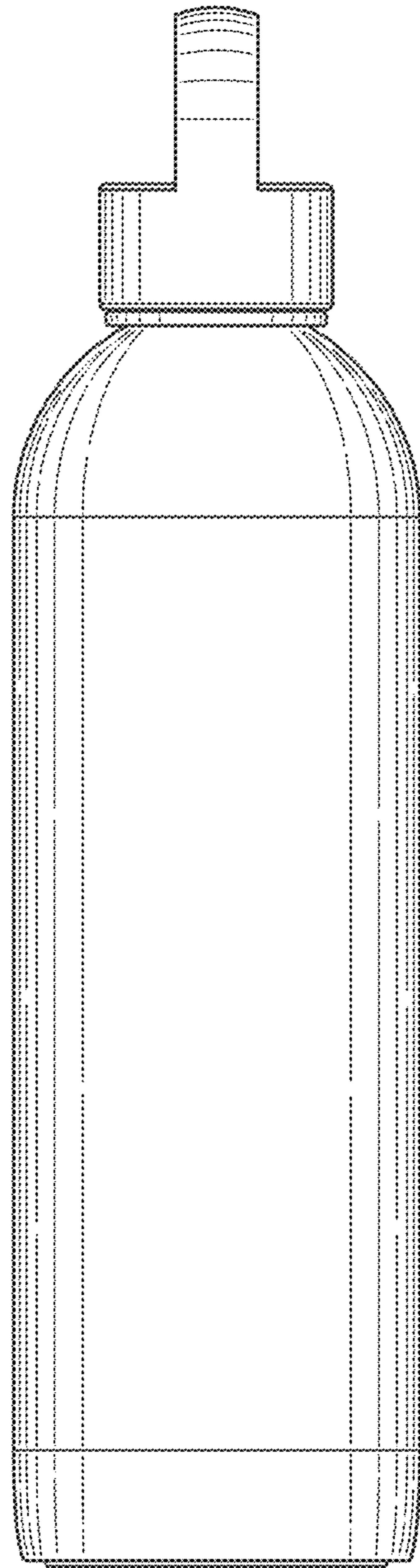

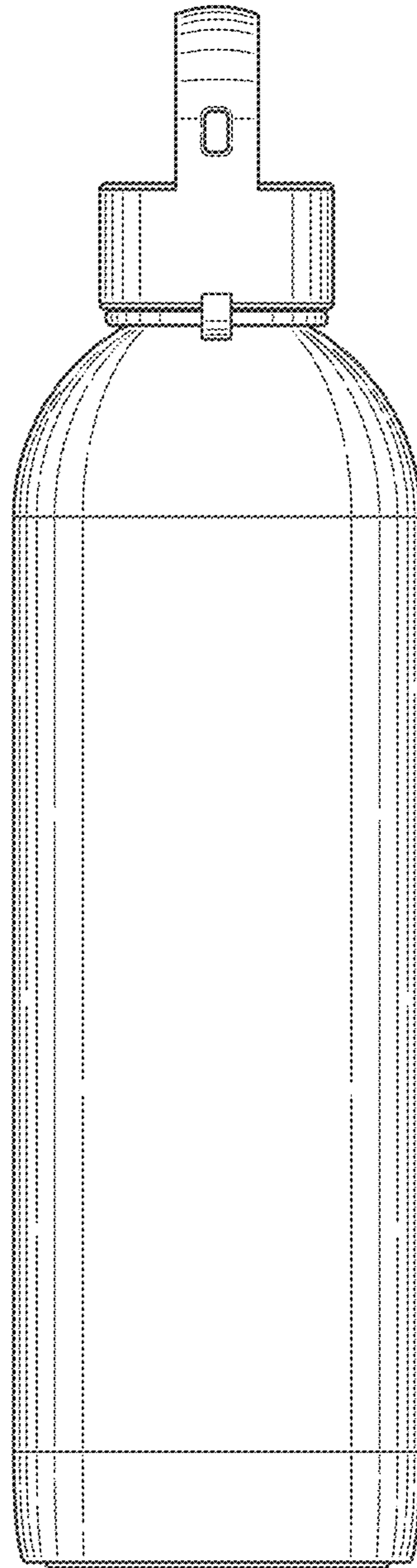

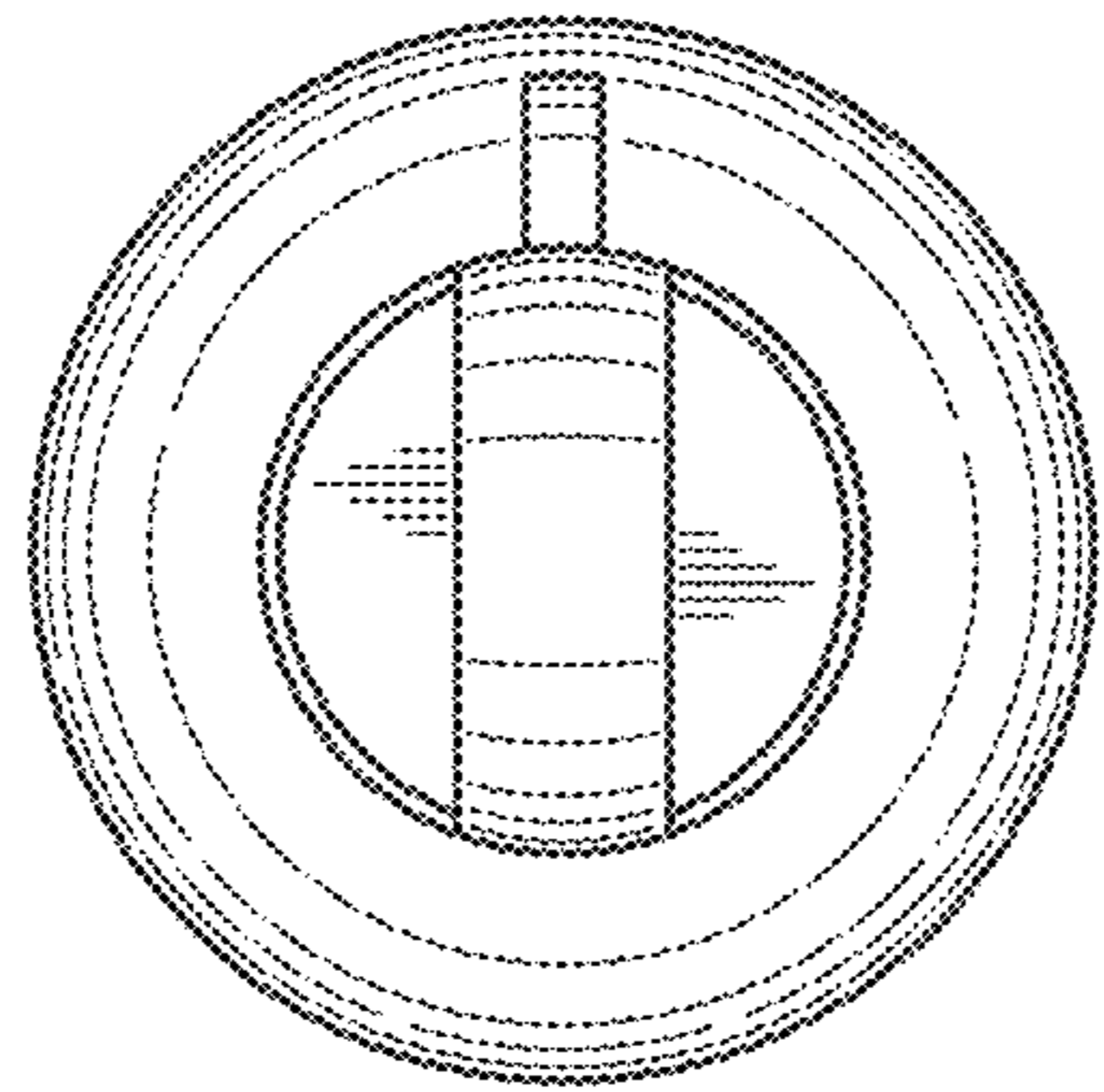

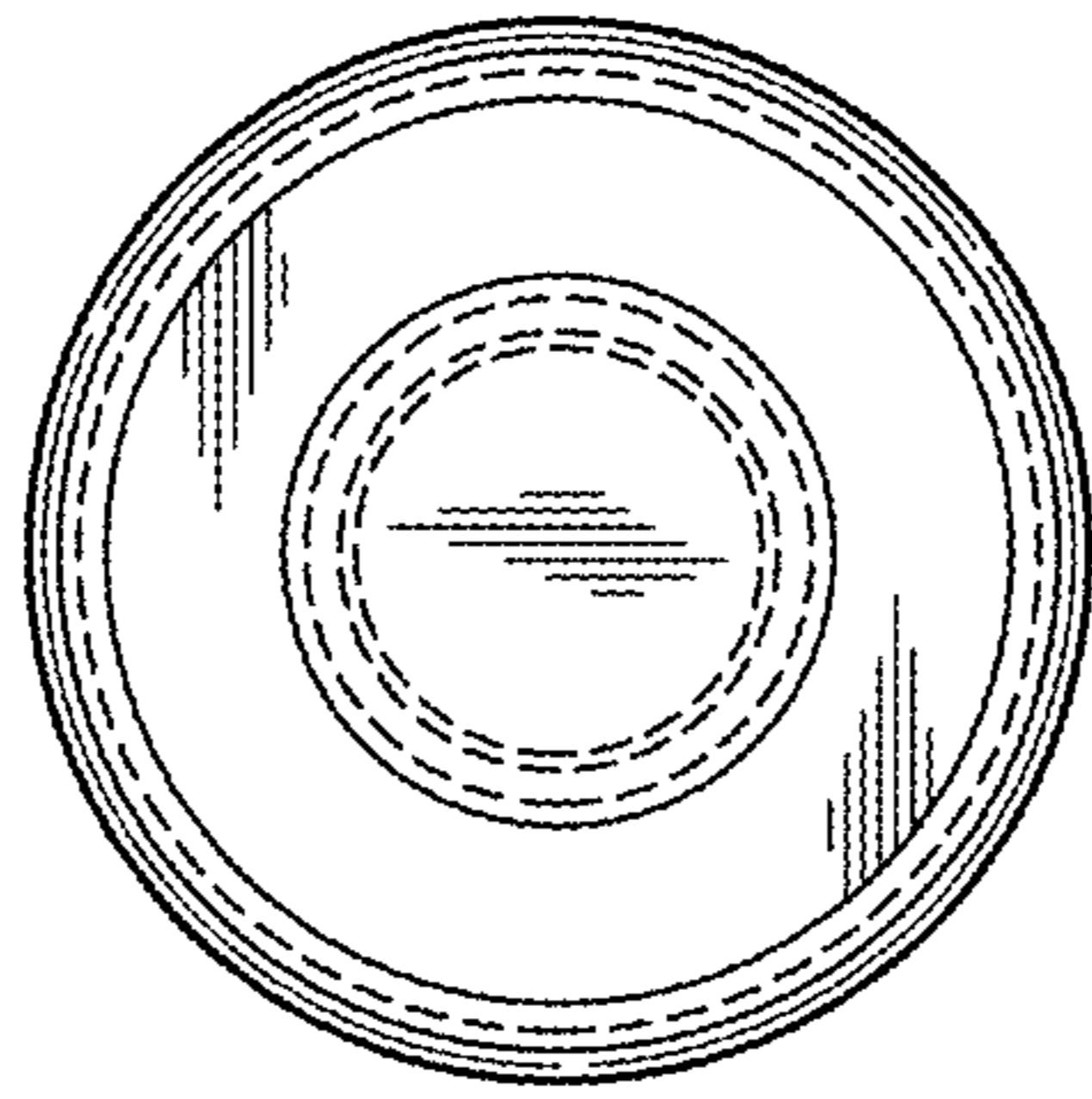
