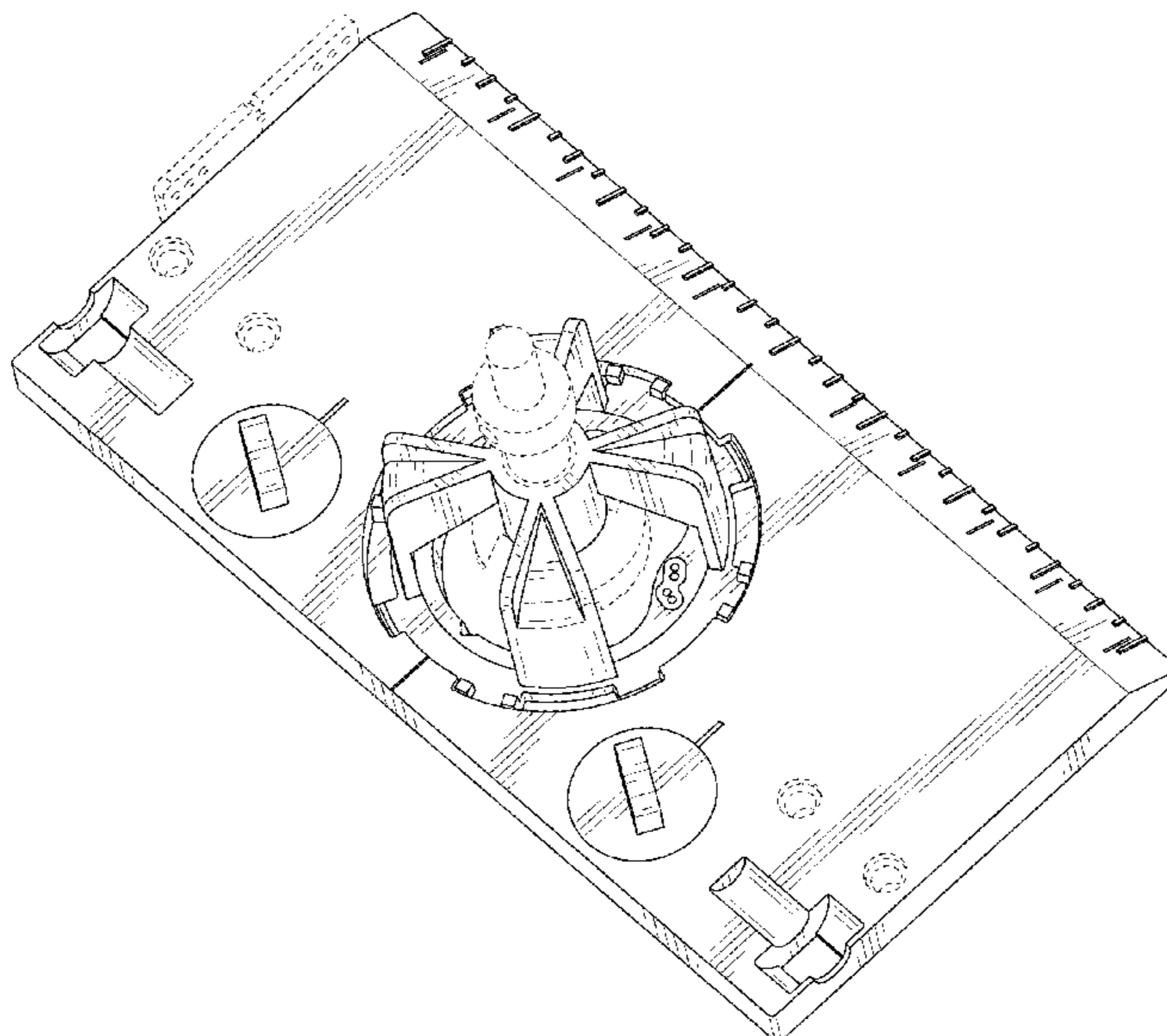
(57) **CLAIM**

I claim the ornamental design for the hinge jig, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the hinge jig;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is a side view thereof showing the side opposite that shown in FIGS. 4; and,  
FIG. 6 is a top view thereof.  
The broken lines shown in the drawings form no part of the claimed design. The bottom of the hinge jig forms no part of the claimed design.

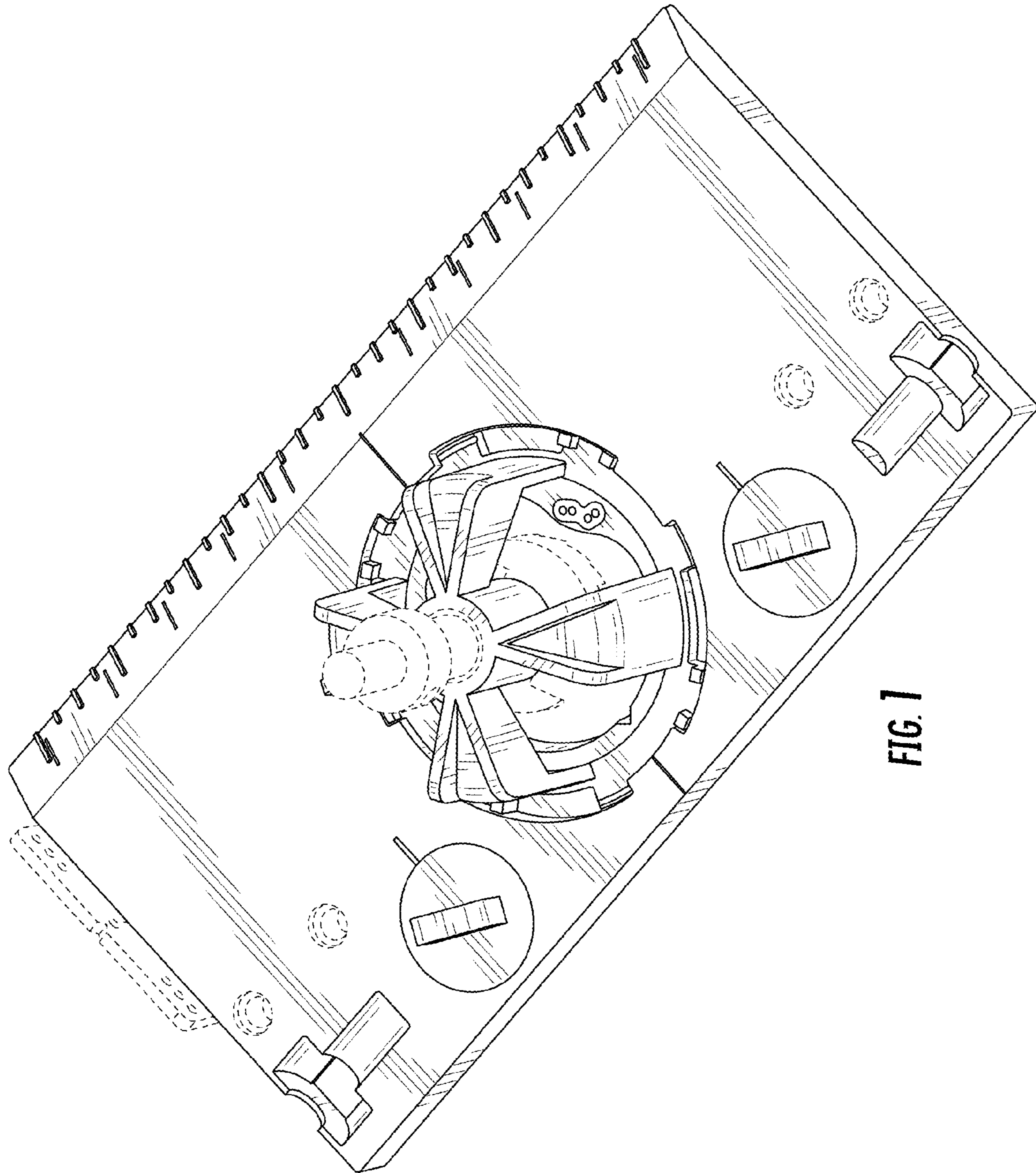

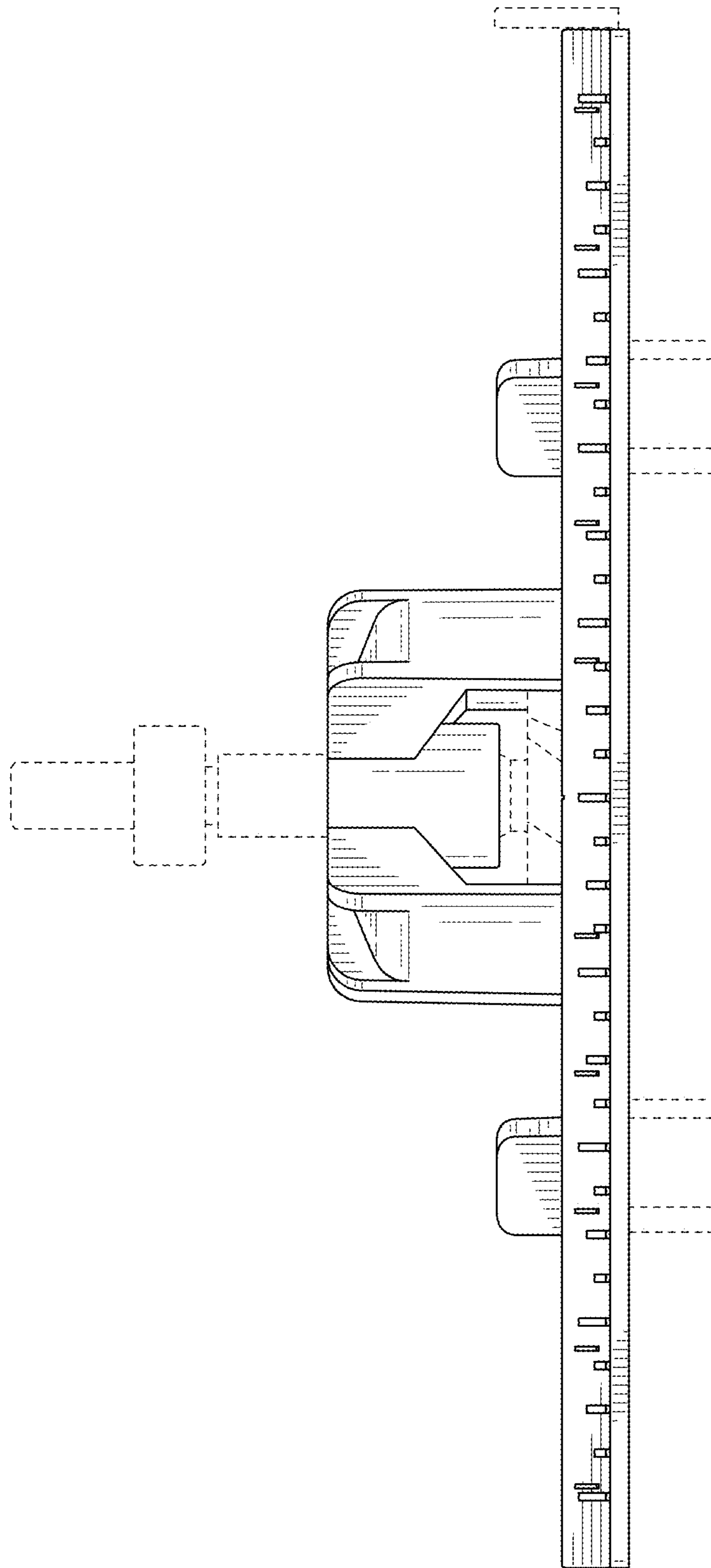

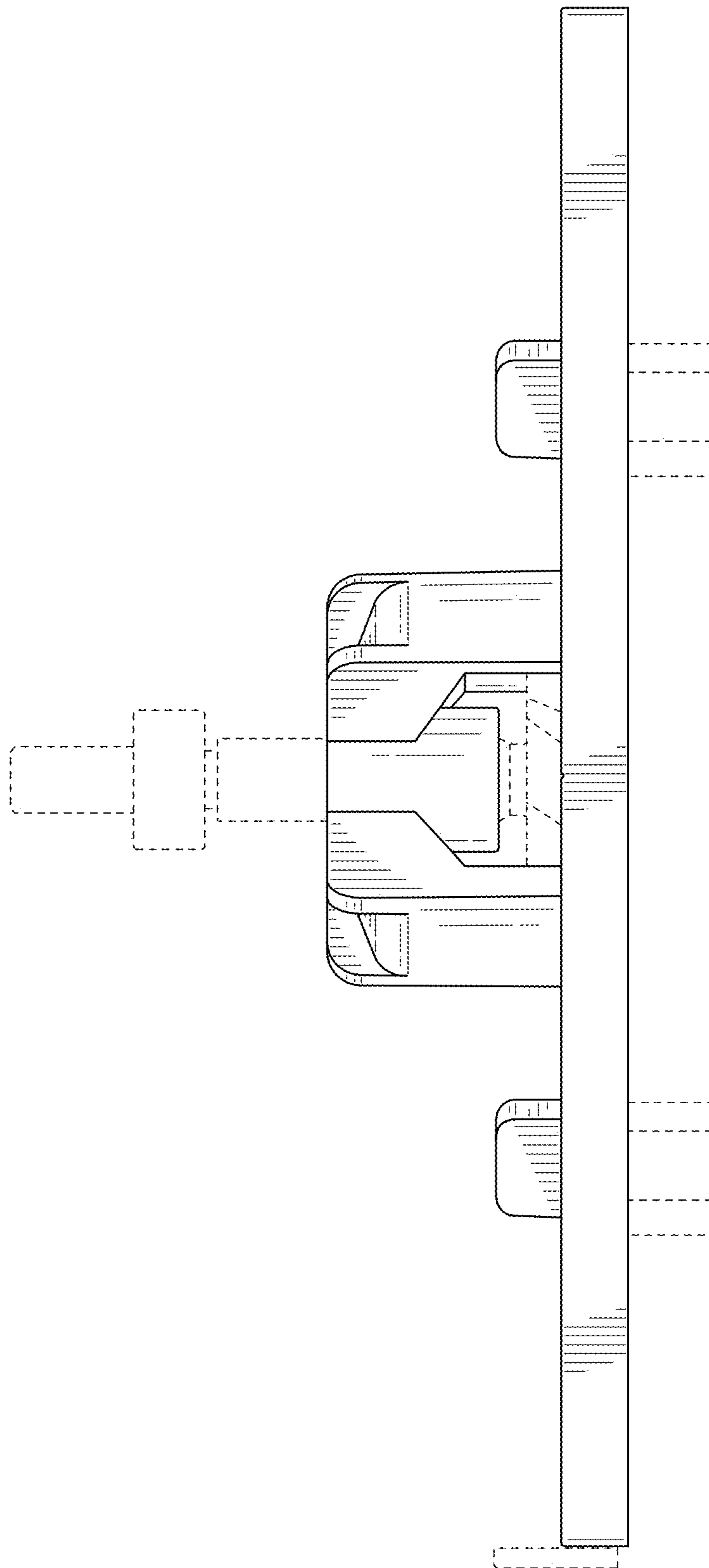
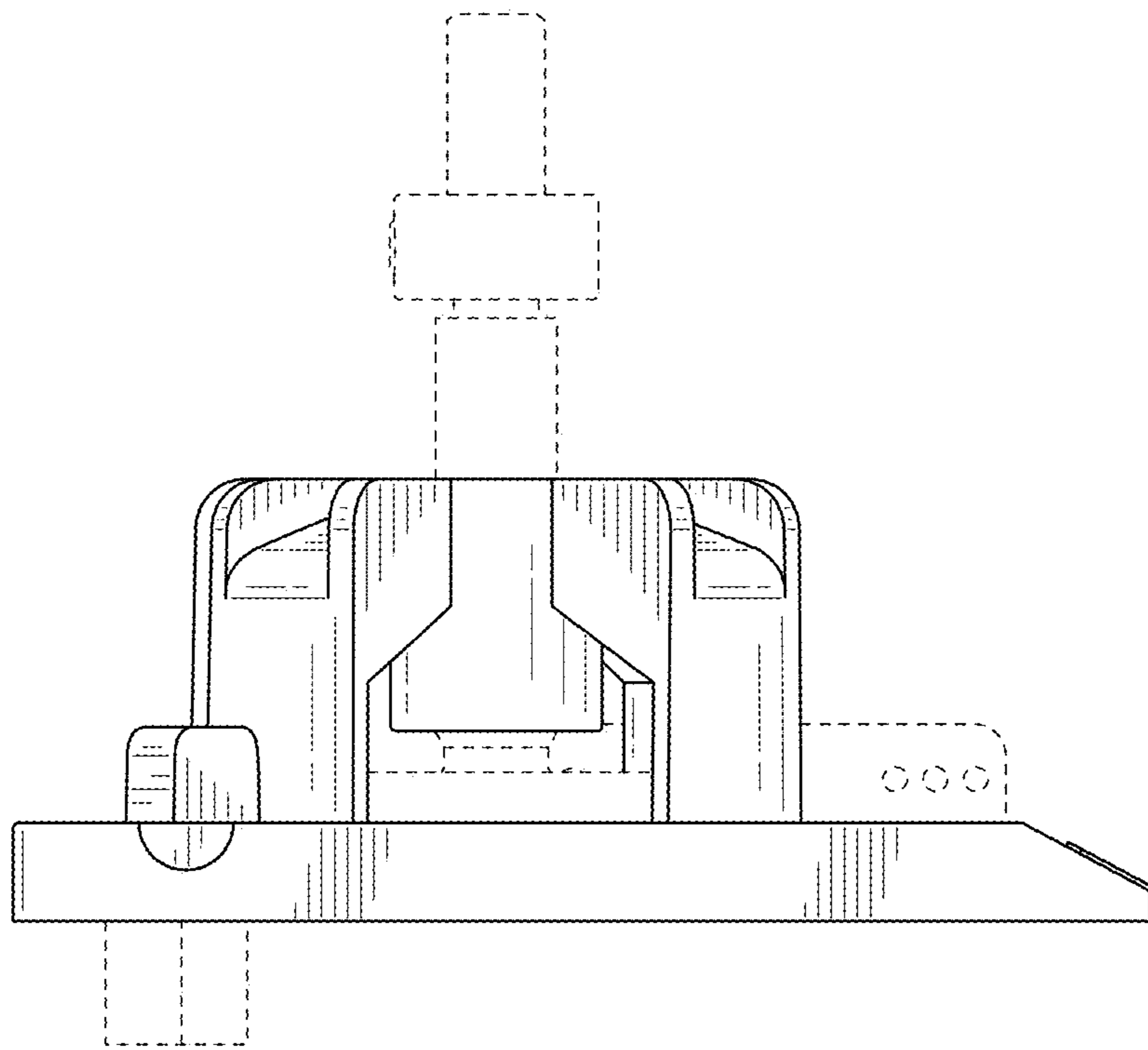
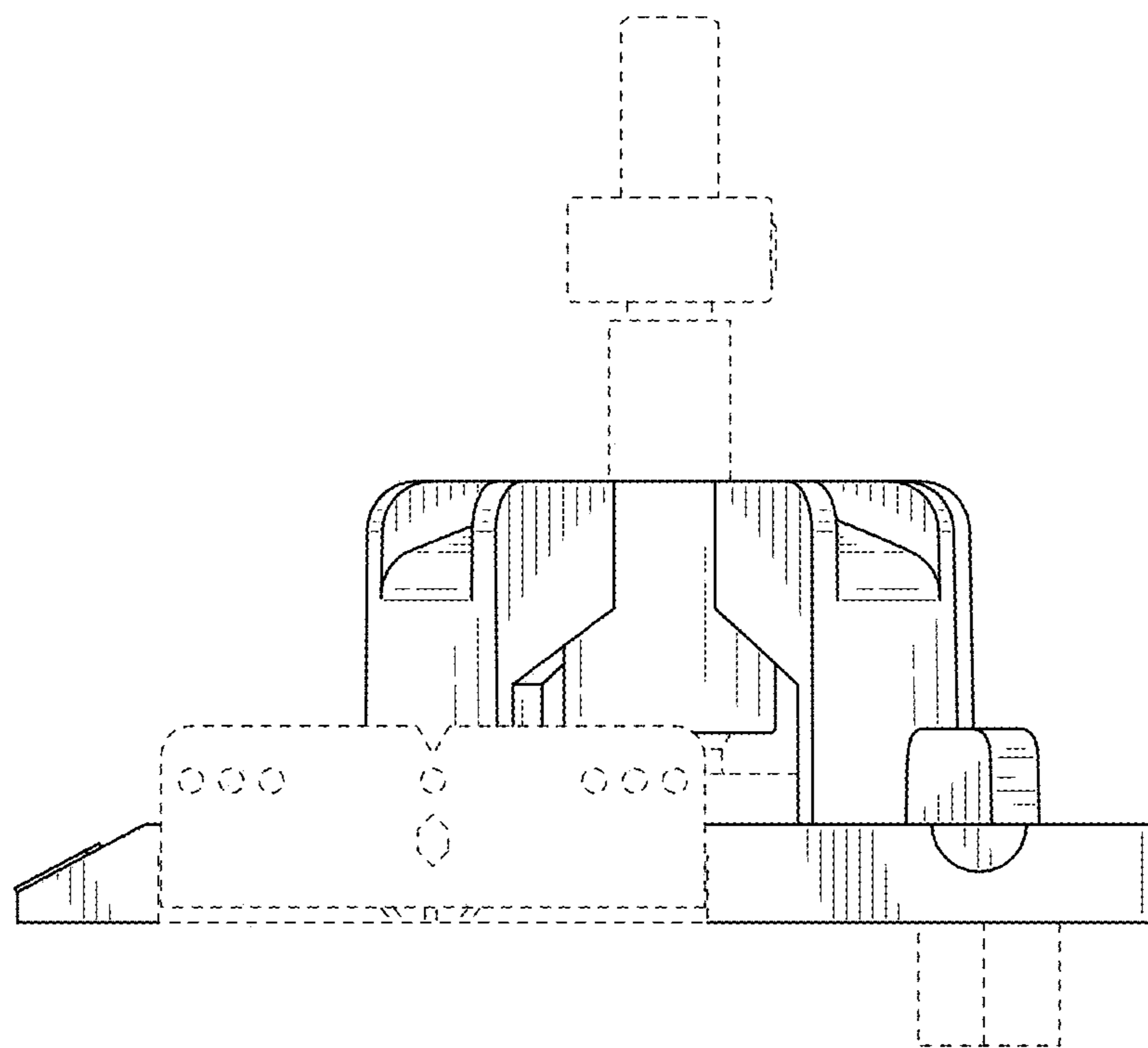

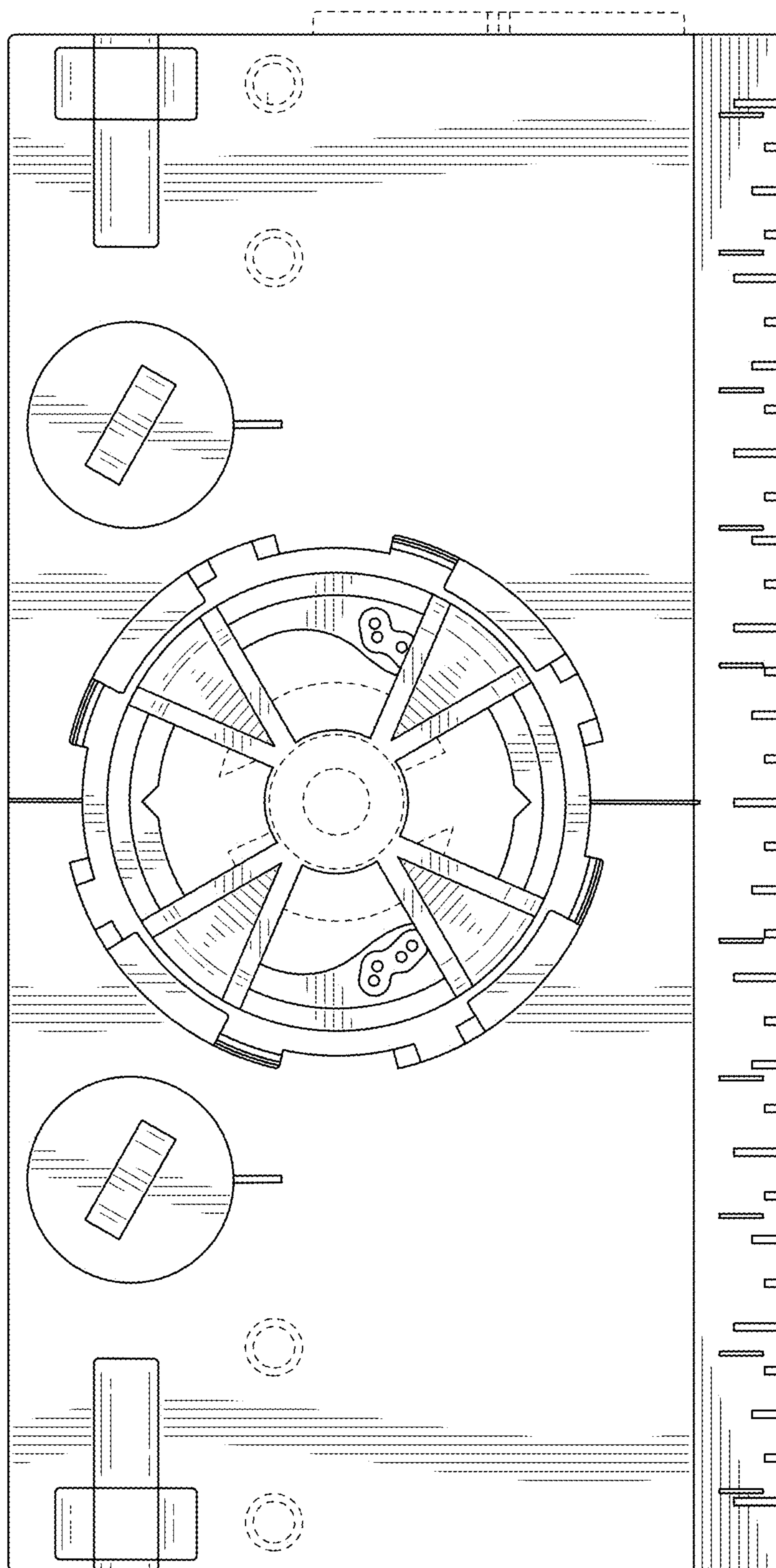
